




English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. The Proficiency Rate for Federal Accountability measures the percentage of students who met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. 













Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.









- The North Hunterdon-Voorhees Regional High School District continues to rank among the top public high school districts in the state of New Jersey and in the United States.
- Students have the opportunity to participate in a wide variety of academic courses, with all subject areas offering an Advanced Placement course, as well as a variety of extra-curricular activities.
- The regional high school district educates students from 12 different municipalities in grades 9-12, making us one of the largest school districts in the state in terms of area.



Mission, Vision, Theme:

The North Hunterdon-Voorhees Regional High School District, a district committed to innovation, personal excellence, high achievement, and community partnership, provides all students with personalized opportunities through a broad spectrum of exemplary educational experiences to develop their fullest potential, to foster lifelong learning, and to become responsible citizens in a continually changing society.



Awards, Recognition, Accomplishments:

North Hunterdon and Voorhees High Schools rank among the best public high schools in the state and in the U.S. Our high schools have been recognized for their Advanced Placement programs. Our district has made great strides towards unifying the student body through the Special Olympics Unified initiative and Unified Sports. Voorhees High School was named a National Unified Champion School in 2018, and recertified in 2022, by Special Olympics for its Unified efforts. Our district has continued to expand its STEM offerings and now houses three four-year academies of the Hunterdon County Vocational School District. About 85% of graduates annually go on to post-secondary education or the military, many advancing to the top colleges and universities in the country, including Ivy League schools.

Courses, Curriculum, Instruction:

The district offers a variety of learning opportunities through College Prep, Advanced, Honors, and Advanced Placement level courses. Many AP and Honors level courses are eligible for college credit through Seton Hall University or Raritan Valley Community College, providing students the opportunity to get a jump start and save on tuition at post-secondary institutions. The district offers various programs for classified students, such as Autism, Multiple Disabilities, Employment Orientation Program, and Preparing for Independent Living Opportunities and Transition (PILOT). The district is a 1:1 mobile device district, meaning every student is provided with a Chromebook to use for school work both in school and at home. Since the pandemic, the district offered tutoring in two ways, 24/7 online tutoring through Tutor.com and one-on-one tutoring with our teachers after school hours virtually.



Sports and Athletics:

Sports Offered: Baseball (Boys), Basketball (Boys & Girls), Cheerleading (Coed), Cross Country (Boys & Girls), Fencing (Boys & Girls), Field Hockey (Girls), Football (Coed), Golf (Boys & Girls), Gymnastics (Coed), Ice Hockey (Coed), Lacrosse (Boys & Girls), Soccer (Boys & Girls), Softball (Girls), Swimming (Boys & Girls), Tennis (Boys & Girls), Track and Field - Spring (Boys & Girls), Track and Field - Winter (Boys & Girls), Volleyball (Boys & Girls), Wrestling (Boys & Girls)

Students at both high schools can choose from a variety of sports during three seasons. Each year, many of our teams and individual athletes succeed at the county, sectional, group, and state levels. During the 2017-2018 school year, Unified Sports were launched at both high schools, which provide an opportunity for students with and without disabilities to play on the same team and compete against other schools in the area. Unified sports that are offered include soccer, basketball, bowling and track and field.



Clubs and Activities:

Our district offers students a wide array of clubs, activities, and intramurals from which to choose throughout the school year. We offer both academic and non-academic clubs, including various honor societies. Our student clubs raise thousands of dollars annually for various charities and collect food donations for local families in need.

Staff and Professional Learning:

There are three full-day staff in-service days during the school year, along with four half-day opportunities. The 2023-2024 Professional Development Plan focused on accelerating learning; examining common assessment results; issues relating to diversity, equity, and inclusion; and social and emotional learning. The in-service time is used to complete mandated trainings, hold department meetings, and take professional development classes. In addition, Faculty and Staff are involved in department professional learning communities to collaborate on goals and initiatives.



Postsecondary Information:

Each year, about 88% of the graduating class moves on to post-secondary education or the military. Graduates attend some of the top institutions in the country. The Counseling Offices at both high schools offer evening programs for parents and students to help them prepare and plan for college. The schools also offer College Fairs as well as Career Fairs annually. All students in grades 9-11 take the PSAT each year. The high schools also offer opportunities for test prep for SAT, ACT, and PSAT.



Student Supports and Services:

The district offers programs for Special Education that include employment orientation, multiple disabilities, autism, alternative learning program, in-class support, Unified Leadership, and Unified sports. Lower-level ML students are given the opportunity to attend a specialized program. At-risk students are assisted with Response to Intervention services. The District contracts with Effective School Solutions to provide a therapeutic level of mental health support. An 8th-grade orientation program assists students with the transition to high school. Most recently, the District started an alternative program called The Lion PRIDE Academy in the 2019-2020 school year for students with severe emotional and behavioral disabilities.

Student Health and Wellness:

Health and wellness educational information is shared throughout the year with parents and students. Topics in 2023-2024 included: Suicide Prevention, Effective Communication for Teens and Adults, Raising Resilient Teens, Underage Drinking, Trends in Drug Use, and Teen Dating Violence. The district placed an increased emphasis on social-emotional learning for students by providing bi-monthly information on mental health, stress & anxiety, methods to deal with mental health, coping skills, stress reduction techniques, etc. The overall goal was to give the students additional tools to use for a more balanced mental health approach. Group & individual counseling are available with the Student Assistance Counselor as well as crisis counseling with Effective School Solutions. Lifelines Suicide Prevention Program included in Health curriculum for freshmen, and reinforced in subsequent years.



Parent and Community Involvement:

Parents have the opportunity to join various organizations at the high schools, such as the PTSA, Music Association, or sports Booster Club. Quarterly meetings are also held of the Special Education Parent Advisory Group (SEPAG). The district communicates with parents regularly using School Messenger. Parents can also check their student's academic progress, grades, and attendance and complete health and sports registration forms through the district's student information system, Aspen. We also encourage parents to attend the various counseling programs offered throughout the school year.



Climate Surveys:

School Safety:

The district continues to focus on addressing and improving its school safety measures. Both high schools have updated security vestibules with enhanced visitor check-in at main entrances. Additional security cameras and electronic locks were installed throughout all buildings in the district. Emergency blue lights were installed inside and outside of high schools to alert of a security threat. In addition, a panic alarm system is operational. Each high school has a School Resource Officer and multiple Class III Security Officers through the local police department. All employees are required to wear ID badges for identification purposes as well as to gain entry to exterior and interior doors with electronic locks. Security system upgraded in 2019 which controls the electronic locks and ID badges; also has door alarm and video surveillance system at security desk. The district uses School Messenger as its notification system for emergencies and school closings.



Technology and STEM:

In regards to technology, the district provides a Chromebook to every student to use for schoolwork both in school and at home. All teachers are provided with a laptop. The district has increased its WiFi access to accommodate the additional devices on the network over the years. Classrooms are equipped with projectors. 3D printers are also available. In regards to STEM, the district has increased its course offerings in the areas of STEM over recent years, from Engineering to Robotics to Architectural Design to Computer Science through Gaming. Students can also take courses at nearby Hunterdon County Polytech. The Hunterdon County Vocational School District offers three four-year academies, all of which are housed in the North Hunterdon-Voorhees Regional High School District.



Attendance:

The district runs regular reports listing the students who have been chronically absent at that point in the school year along with their number of absences. Counselors and administrators follow up with the students to develop a plan to improve their attendance. The district also has support services to assist students with school avoidance issues.

Other Information:

The North Hunterdon-Voorhees Regional High School District educates students from twelve different municipalities and receives students from eleven sending districts. Our district is committed to articulation and meeting with the sending districts to work towards a K-12 curriculum. Articulation meetings are regularly held in the major subject areas, as well as among superintendents. Our school day runs from 7:45 am-2:25 pm with curriculum and instruction time until 3:10 pm. About half of our student body participates in after-school activities and athletics. Our curriculum continues to expand to offer students a variety of learning opportunities to prepare them for college, military, or work after high school. Our fine arts, music, and practical arts courses are among the most popular and are filled each semester. As mentioned previously, we continue to increase our STEM offerings and are proud to partner with the county vocational district to offer students the opportunity to attend four-year vocational academies. The high schools have been recognized by the NJ Department of Education as among the Highest Performing Schools in the state.
