














English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 




















Teachers and Administrators - Level of Education

Teachers take a role in learning and monitoring their growth in relation to district as well as individually-selected goals. The staff has most recently been trained in strategies to support reading skills and differentiation. Professional Learning Communities have been embraced by all teachers.

Facilities:

Old Turnpike School sits on 11 acres in beautiful Hunterdon County. The main building was built in 1969 with additions in 1974 and 1986. The grounds allow for numerous fields and running areas. Over twenty classrooms include four science labs, library, computer center and gym. Tewksbury Elementary School was built in 2005, featuring a full-sized gymnasium, library, computer lab, STEM lab, art room, music room, all purpose room with stage and an extensive outdoor playground with fields.
