







Our new Science program (McGraw Hill - Inspire Science) is being utilized this school year for grades 3-8. Teachers received training on this new program on our first August PD day. We started a new course this year called STEAM to integrate technology with Science, Engineering, Art and Math. This course is offered as a special in grades 4-8. We continue to use Linklt as our In-district benchmarking system. The past 3 years, we provided benchmark assessments in ELA and Math three times a year for grades 1-8. This year we will be adding Science benchmarks for grades 5 and 8. We are now following New Jersey?s MTSS model to meet the needs of all tier levels of learning. Teachers are currently being trained on the new process. Our district was also awarded the NJ High Impact Tutoring grant that we applied for. Students in grades 3-5 who qualified, are receiving tutoring in both Math and ELA. Tutoring runs from September - December.



Two main goals of our district this year in professional learning center around MTSS (Multi-tiered System of Support) and the Nurtured Heart approach. Student achievement is also a yearly goal our district focuses on to continue to support staff in differentiation and meeting the needs of our students.
