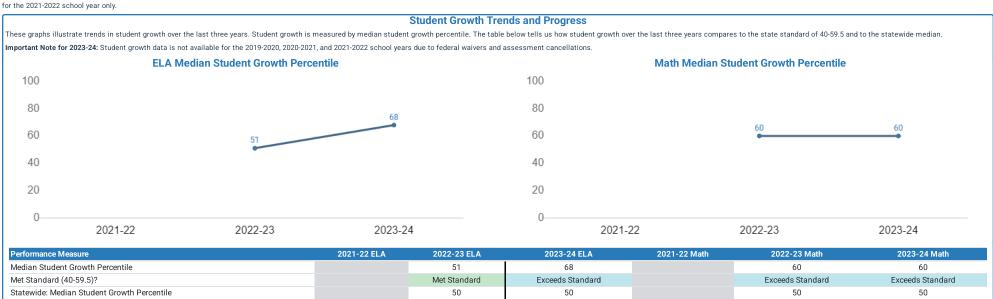

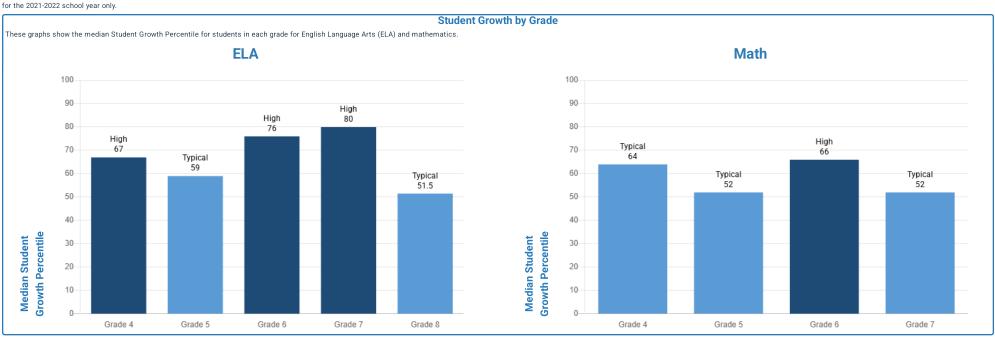

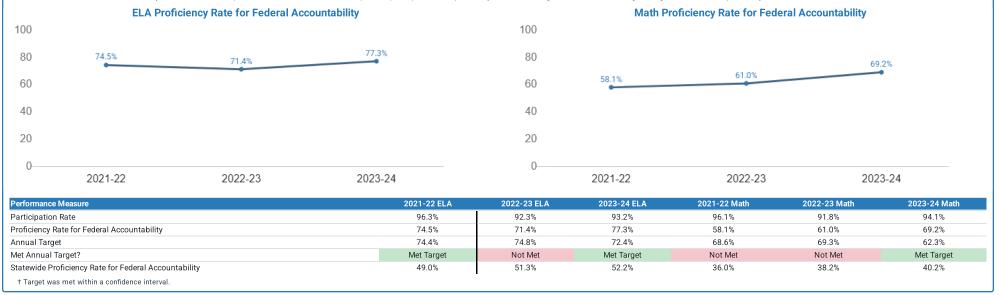

Graduation/Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

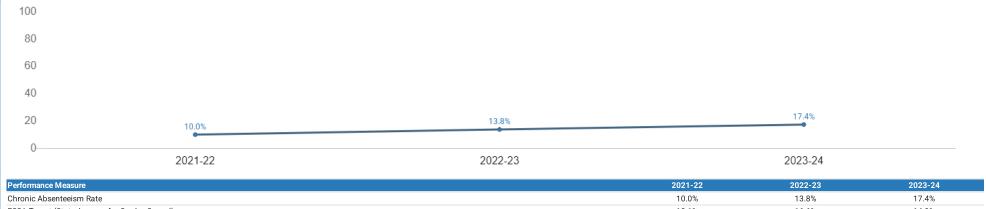

Parent and Community Involvement:

The Princeton Public Schools benefit from extensive parent involvement. Our school-based P.T.O.s and our very active Special Ed P.T.O. work together to provide ideas and resources. Teachers maintain websites on which families can find notices and assignments, and school liaisons ensure communication with families for whom English may not be their first language. Our community partners are numerous and include Princeton University, the Princeton Public Library, the Arts Council, and the local Ys.



Our district includes four elementary schools, one middle school, and one high school. The offical total enrollment is 3,782 students.



The Princeton Public School's full day preschool program is designed to promote active participatory learning process where children make daily choices about their activities and teachers help them cultivate language, fine and gross motor skills, and social skills as they play. Our program adheres to the state high-quality guidelines. We offer general education preschool classes for three and four-year-olds and specialized preschool classes for three and four-year-old students with disabilities both in district and with local private providers. We have a projected enrollment of 102 students and maintain an active wait list for the entire school year.

Our district addressed the impact of Covid-19 utilizing ESSER funds to cultivate safe, healthy classrooms, promote social distancing and upgrade air filtering systems district wide. ESSER also supported a robust after-school program K-12 through small group skill-based instruction and one-to-one, high dose tutoring to help mitigate the pandemic's impact on learning. Additionally, the district utilized ESSER funds to operate a comprehensive summer program that addressed both learning loss and enrichment at all grade levels. Students who were most impacted by the pandemic were prioritized for these programs. ESSER funds also supported the district's work towards a systemic and responsive intervention program including high functioning I&RS teams and the development of a multi-tiered system of support. Mental health supports were included in this work in addition to working with community partners in the field to address both imminent mental health needs, and prevention.
