





Graduation/Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.



The district is 1:1 with devices in grades 1-12. We offer a wide-ranging curriculum for the diverse needs of our students. Tools of the Mind framework is used for Early Childhood and a rigorous standard-based program for grades K-12. Students are assessed using diagnostic and standards-based assessments and results are used to guide instructional practices. Grades K-2 receive ASL as a World Language. MTSS and Extended Learning Opportunities (ELO) are provided daily to target struggling students and enrich learning in grades K-6. High-performing students are also challenged with the S.P.A.R.K. G&T program. Junior High and CHS students are offered tracks, honors, and Advanced Placement (AP) courses. CHS students are exposed to courses that offer paths for all learners, college and career-bound, including AVID, Success Bound, and Kean Scholars. Partnerships with universities provide students opportunities to receive college credit while in high school.

Before and After School Programs:



A comprehensive professional development plan drives our staff learning. The district offers a PD Academy where best practices are shared by Master Teachers. Novice teachers are afforded sustained and ongoing training through mentorship and hired consulting staff.



College and career readiness continues to be a focus for the district. Students utilize SCOIR a digital platform that assists them with post-secondary planning. We aim to create paths for students that lead to individual success. Partnerships with universities enable us to provide dual enrollment courses wherein students earn college credit. Student Supports and Services:

District resources include Pathways-School Based Services Program, Effective School Solutions, providing mental health supports, Child Study Teams, Intervention and Referral Services, Reading Interventionists, Math Interventionists, School-Based Social Workers, a Behavioral Consultant, and specific intervention programs in Response to Intervention. High Intensity programs in English as a Second Language and a Bilingual Punjabi tutorial program support the needs of ML students in mainstream classrooms. Students identified in need of supports for Literacy and Mathematics receive Title 1 services during and after school.



A focus on social and emotional wellness has led to the implementation of programs that support both students and teachers. Professional development on Mindfulness provides teachers strategies to help themselves while educating students on how to deal with trauma or day-to-day stress. Responsive Intervention is also being implemented at the elementary level to further empower students to address their own anxieties and emotional needs. Wayfair, Character Strong and Peer Group Connection are also student leadership programs which help develop students as peer support.



Parent and Community Involvement:

A strong home-school connection is integral to the success of the whole child. Our schools believe in creating opportunities for parents to visit our buildings, meet with teachers, share their perspectives and partake in school events. Parents and community members in Carteret nurture those relationships and work closely to offer our students unique and creative programming. All school main offices have been renovated and designed with new furniture to welcome our school communities. Bathroom renovation projects continue across all schools. The district is committed to addressing all facility needs to provide a safe and conducive space for learning and working.



School Safety is the first priority for Carteret Schools. The district has purchased new high-definition security cameras to replace the older models. The new enhanced system has added features that will assist with safety measures and protocols. Panic buttons have been installed in all buildings and new card-swipe locks have been added at the high school. The district purchased Verkada's visitor sign-in system, an ID security system allowing us to monitor visitors to the buildings. Additional Cameras and Aiphone door buzzers have been purchased to enhance our security protocols. Additional Security Guards have also been hired. Professional development was provided for all guards by a certified law enforcement officials.

Technology enhancements have been made across the district. All Smarboards have been replaced with new enhanced tv monitors. Pre-K and Kindergarten classrooms utilize iPads for digital learning. Chromebooks are available for all Grades 1-12 students to increase student engagement and supplement instruction. All three elementary schools and the middle school have STEM labs titled T.H.I.N.K. Tanks (Teaching Hand-on Inquiry Nurtures Knowledge). These spaces offer innovative experiences for curious minds and furniture designed for learning and exploration.



Carteret was recently awarded \$5.6 million for a new PreK facility. Our PreK program was also given a 4 star rating by GROW NJ for our high quality learning environment, curriculum and family engagement. We also receive funding which enables us to provide the community with full day Pre-K. The district offers services to 3 & 4 yr old students. Our model program continues to be visited by distinguished guests and is often featured in educational magazines and resources.



Carteret Schools addresses chronic absenteeism by offering robust Social Emotional Learning programs, including Character Strong (K-4), Wayfinder (5-8), and Peer Leadership (9-12), alongside emotional support through Pathways, ESS, and Responsive Classroom. To meet diverse needs, we provide afterschool and summer programs, tutoring, research-based interventions, and a visual/performing arts summer program. Our e-sports game room fosters critical thinking and communication skills. Attendance is incentivized through Battle of the Grades, dress-down days, and family gift card raffles. Engaging events such as Hispanic Heritage, Grandparent's Day, and student recognition celebrate attendance and student involvement.
