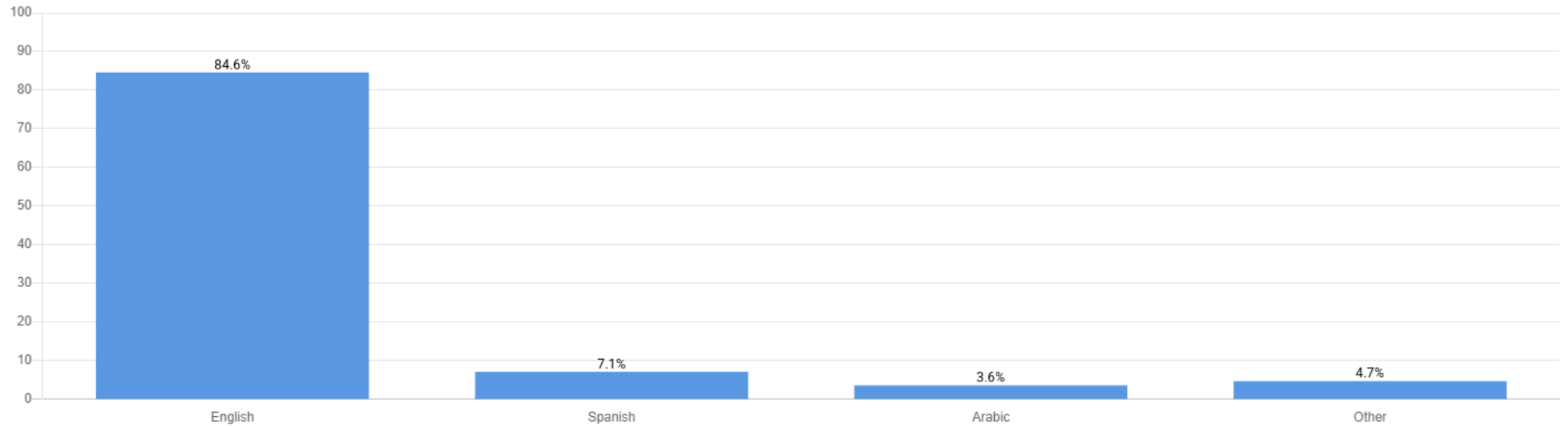

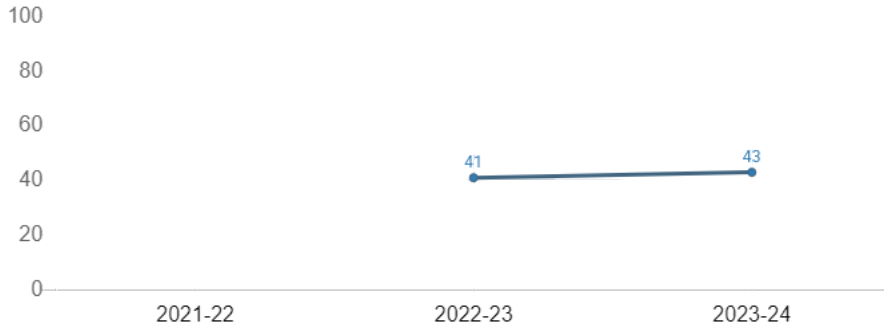

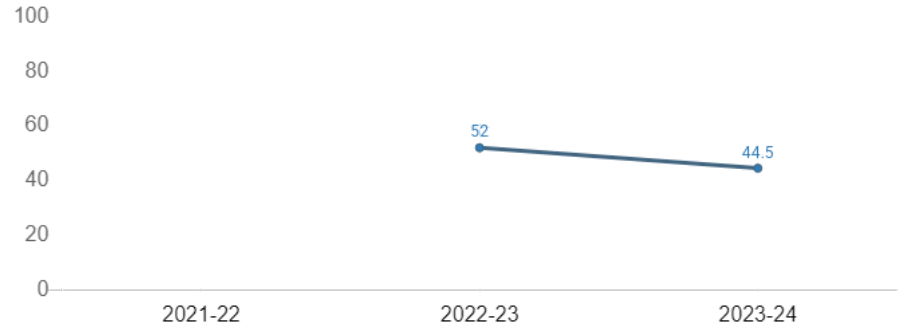

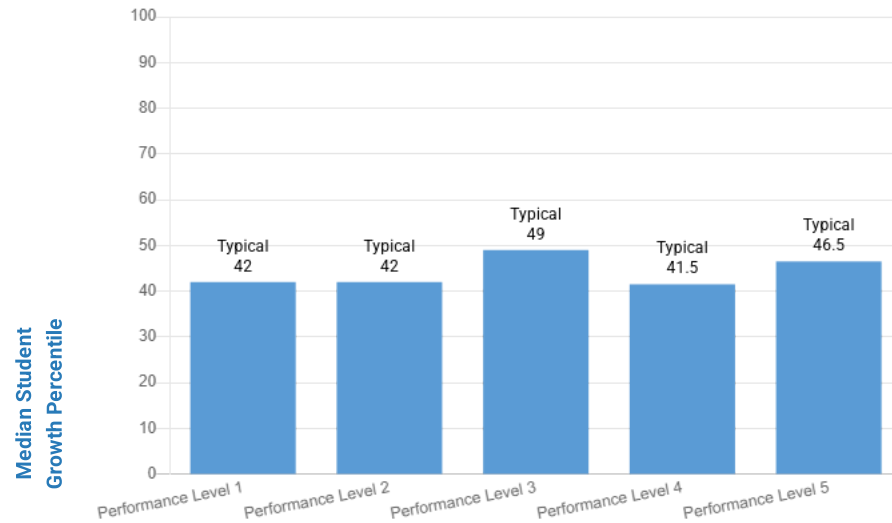

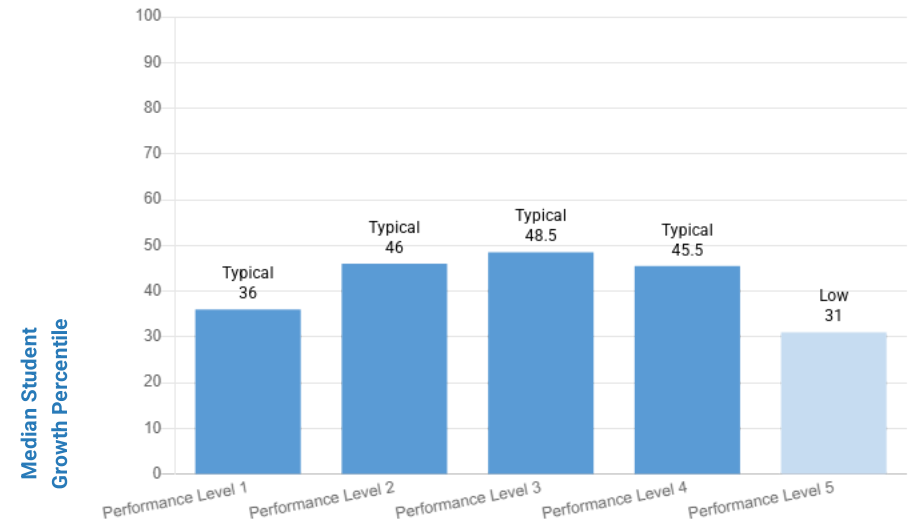

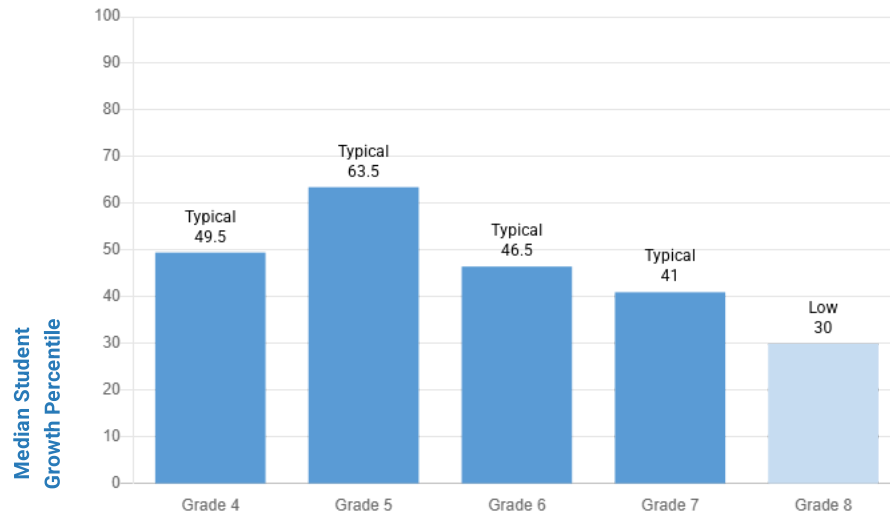

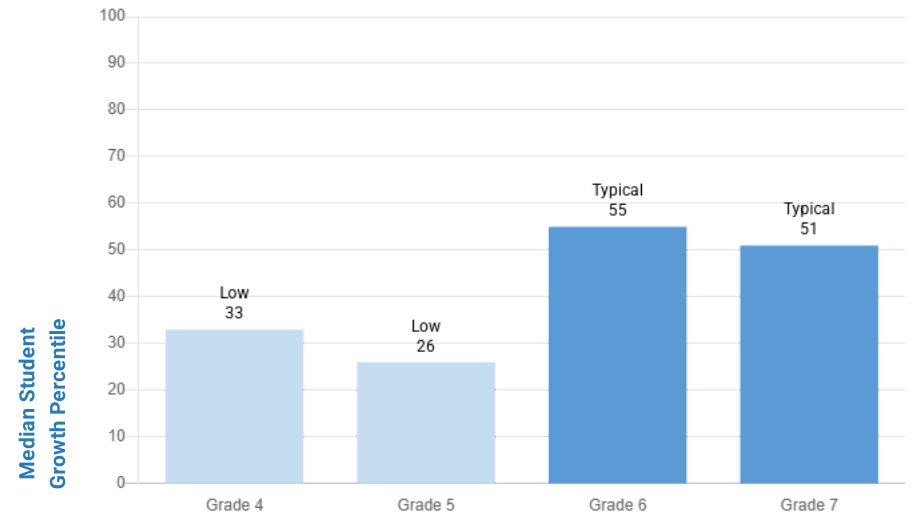

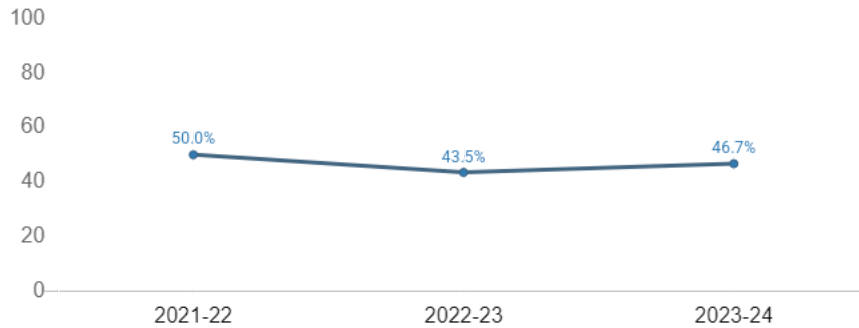

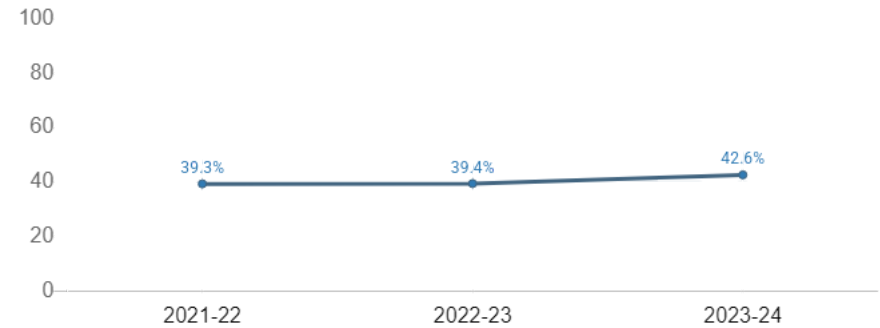
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 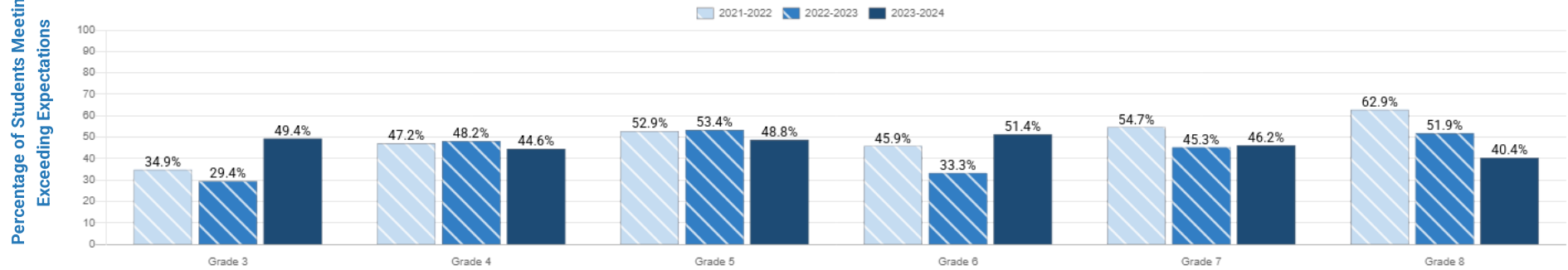

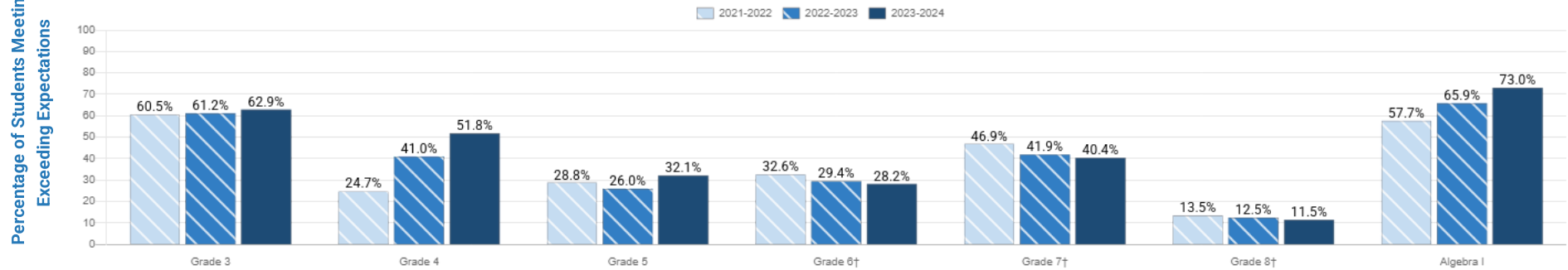

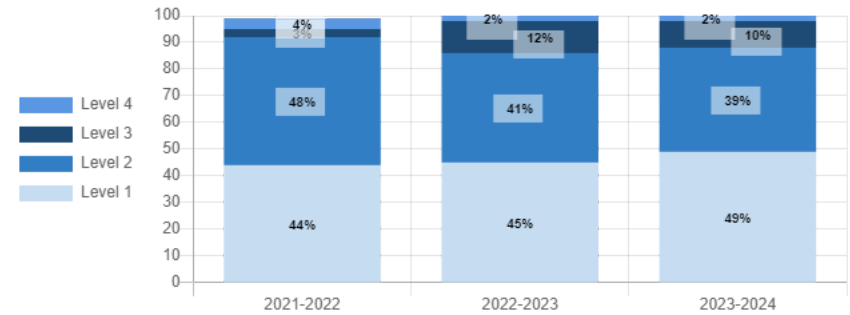

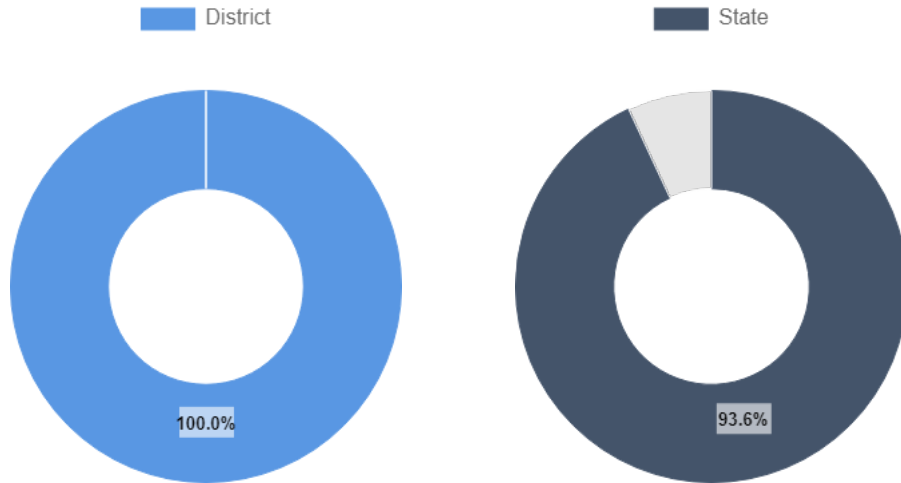

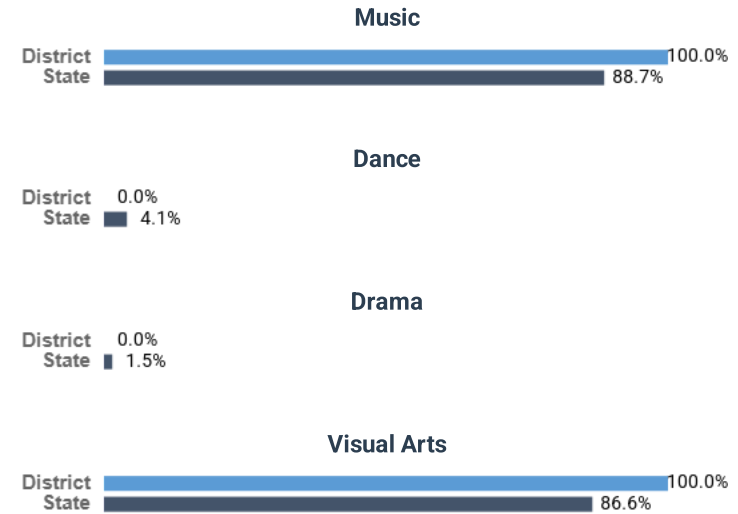

Students enrolled in one or more classes by discipline:



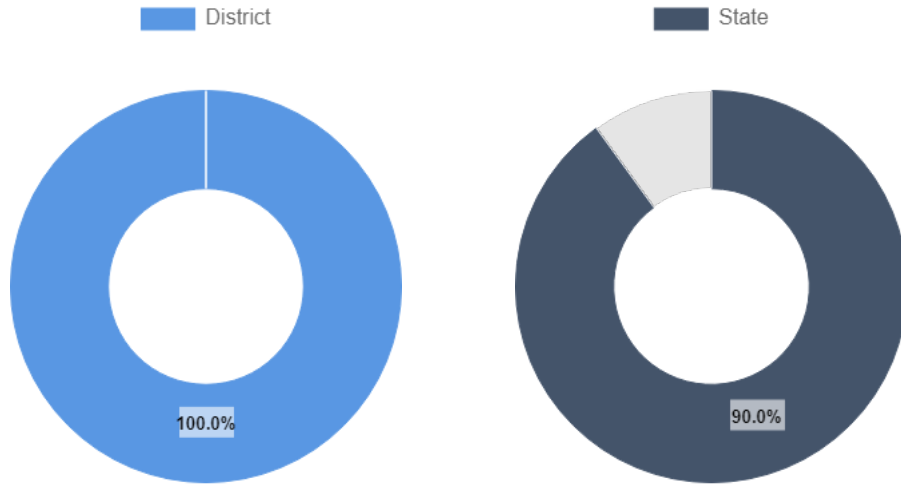

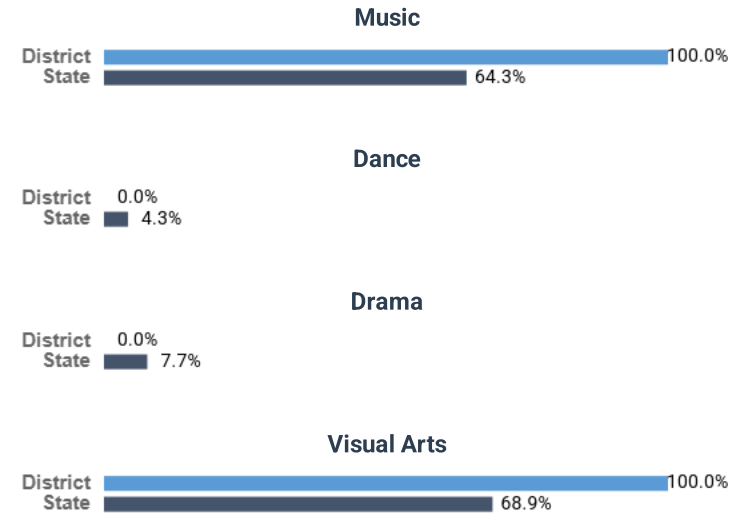

Students enrolled in one or more classes by discipline:

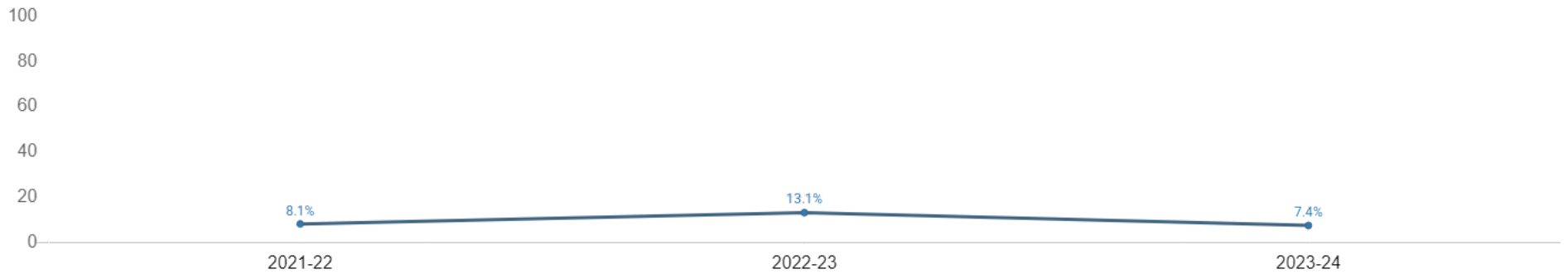

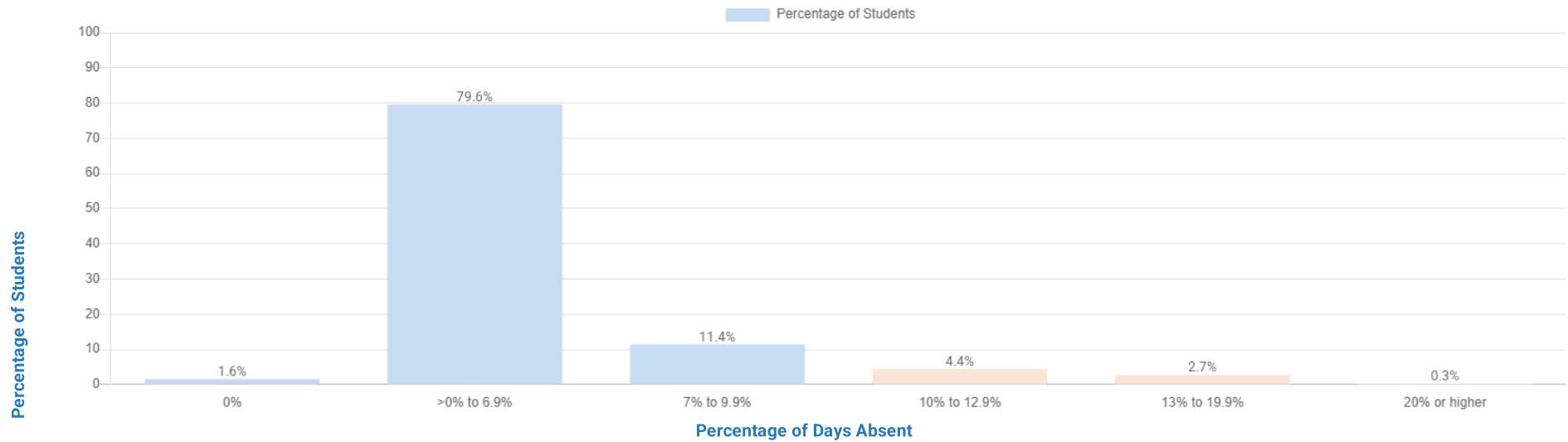

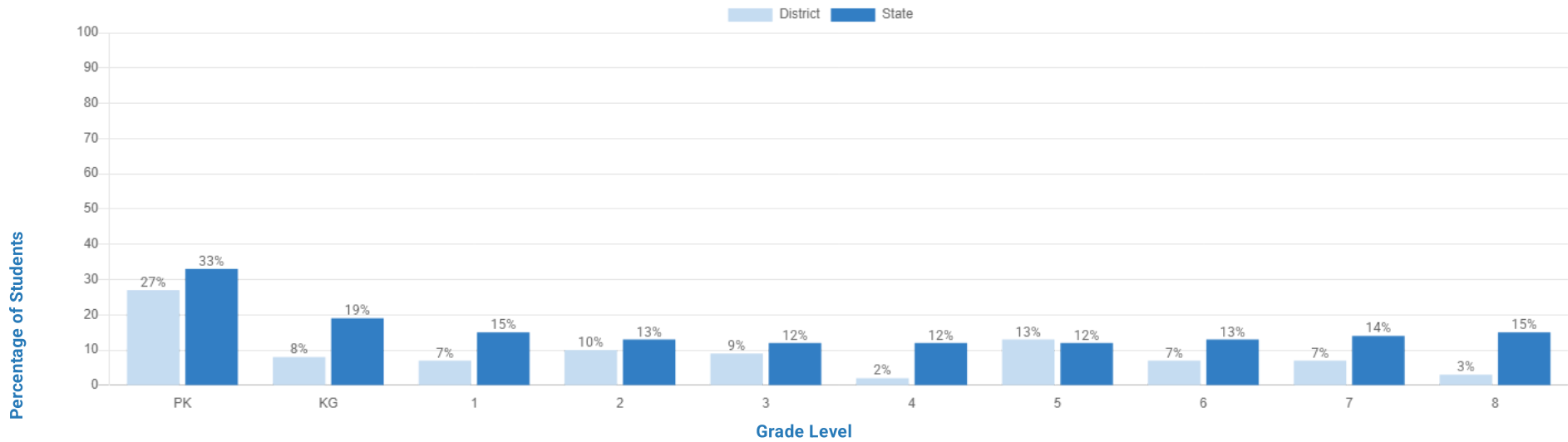

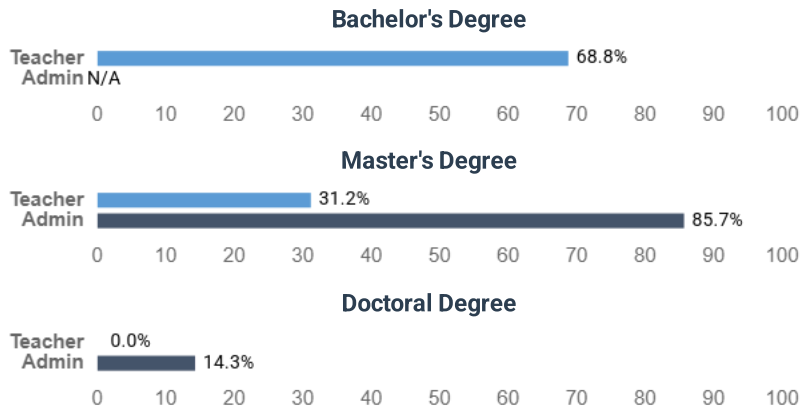

Joyce Kilmer School offers a typical departmentalized program for middle school, with departmentalized instruction in Math and Language Arts for grades 4-5. Scheduling allows for double periods in Math and Language Arts as well as electives in grades 6-8.

Before and After School Programs:

The Right at School program offers before and after school care is available for Milltown school-age children in grades K - 8 and is housed at the Parkview and Joyce Kilmer Schools.



Staff and Professional Learning:

Milltown Mondays center on district and state initiatives while promoting personal and subject-specific development. During these sessions, teachers can collaborate with Resilience Coach Michelle Dickinson, who provides targeted support to address attrition and offer strategies for managing burnout and teacher fatigue. This dedicated approach aims to enhance teacher well-being and effectiveness in the classroom.



Student Supports and Services:

A full-time Child Study Team with an additional School Psychologist/BCBA on staff services all students in the district. Counseling and social emotional learning programs are scheduled in each school. The District continues to incorporate a tiered system of support at all grade levels to ensure college and career readiness. The District focuses on providing each child the least restrictive learning environment to meet their needs as demonstrated in our expansive inclusion program.

Our school is dedicated to promoting health and wellness across all areas of student life through initiatives that support physical, mental, and social well-being. In 2024, we kicked off a Healthy Food Promotion campaign with posters highlighting nutritious choices and a school-wide Healthy Food Resolution to encourage healthier eating. Physical activity is boosted through brain breaks, extra recess for PBIS rewards, and an enhanced field day. We've strengthened wellness programs, expanding Social Skills Groups and Peer Mediation, and promoted student leadership through the Wingman and Knights in Shining Armor programs. Additionally, mental health awareness is fostered through Knight's Den and LEAD lessons. These efforts ensure a supportive and healthy school environment for all students.



Parent and Community Involvement:

The PTO is an active partner in promoting the interests of education in Milltown. PTO volunteers donate time and effort as homeroom parents and in organizing fund raising projects, assisting in the libraries, sponsoring the eighth grade activities, as well as sponsoring school assembly programs. The PTO newsletter is distributed monthly. The district also enjoys productive partnerships with the Milltown Education Foundation, as well as local churches.

Joyce Kilmer School serves approximately 450 students in the district's elementary and middle school housing students in grades 4-8. Milltown Public Schools has an agreement to send students in grades 9-12 to Spotswood High School. The district administrative offices are located at the back of Joyce Kilmer School in a central office building.



School Safety:

Safety and security is a high priority in Milltown Public Schools. A strong partnership between the district administration, school security guards and local police ensures a high level of preparedness and responsiveness in the event of a crisis. Milltown administrators maintain School Safety Specialist certification.
