
















English Language Arts and Mathematics Performance Trends








NJSLA Science Assessment: Grade 5 Summary









Students enrolled in one or more classes by discipline:







Students enrolled in one or more classes by discipline:











Graduation/ Postsecondary

Graduation rates are calculated based on the adjusted cohort graduation rate calculation. Beginning in the 2020-2021 school year, the NJDOE was required to make changes to the methodology used to calculate the adjusted cohort graduation rate for federal reporting and accountability purposes. The United States Department of Education (USED) determined that the NJDOE must only include students who receive a diploma that is fully aligned with the state's standards, meaning they have met the state's graduation assessment requirements, course requirements, and local attendance requirements. This means that students with disabilities who did not meet some or all graduation requirements because of a modifications or exemption in their Individualized Education Program (IEP) may not be counted as graduates in the calculation of the adjusted cohort graduation rate used for federal reporting and accountability purposes. It is important to note that this was only a change to how graduation rates are calculated for federal reporting. It does not affect requirements to earn a diploma or the type of diploma that the state awards to students with disabilities.

As a result of these changes, the NJDOE began calculating two versions of the adjusted cohort graduation rate starting with 2021 graduation rates. The "federal version" aligns with ESSA requirements and USED guidance and is used for federal reporting and ESSA school accountability only. The "state version" continues to use the same methodology used prior to 2021 and reflects all students who received a state-endorsed diploma.

To be included as a graduate in the federal version of the graduation rate, students must have meet state course requirements and local attendance requirements for graduation. Additionally, students must meet the graduation assessment requirements in place based on the year they are graduating, regardless of their graduation cohort. The graduation assessment requirements for the classes of 2022 through 2024 have differed as a result of executive orders in response to the pandemic and new legislation. As a result, the calculation of the federal version of the graduation rate has also changed.

In this section of the reports, the Graduation Rate Trends and Progress charts and Graduation Cohort Profiles (4-Year, 5-Year, and 6-Year), as well as the graduation rates reported in the Summary Reports, reflect the "state version" of the graduation rate. Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Note for 2023-2024: Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.









The district provides supplemental support services for our students, including College Board Test Prep at the High School at no cost to parents. We provide extensive support services to our English Language Learner students and families. Full day, free preschool program. Alternative High School program for credit recovery and student support. Our district offers a one to one device opportunity for Middle and High School students. WiFi internet connectivity services and hotspots are available to families as needed.

During the 2023-24 school year, the district was given the opportunity to participate in a tri-op in ice hockey with neighboring schools East Brunswick HS and Spotswood HS. The district also entered into a co-op with the East Brunswick Magnet School in boys and girls bowling. With these agreements in place and approved by the NJSIAA, our student athletes now had the opportunity to participate in ice hockey at South River HS and those students who attended East Brunswick Magnet School were able to participate in bowling with the students of SRHS. During the 2023-24 school year, we had a successful athletic year as we won GMC Division Championships boys soccer and boys bowling.

Before and After School Programs:

Our 21st Century Program provides extra help and enrichment after school in language arts and math for grades 3-12. Additionally, support and enrichment is offered for preparation for College Board Tests (SAT, ACT). Our ELL students have supplemental instructional support for language development.



Staff and Professional Learning:

The staff is engaged in a variety of professional development activities in and out of district. The district provided 7 half-day, in-district opportunities for professional learning using outside presenters as well as turn-key staff. Teachers attend various out-of-district conferences and workshops focused on refining their teaching. Collegial exploration is encouraged through the use of Professional Learning Communities scheduled throughout the school year. Each department and grade level has the support of a teacher leader who provides coaching, professional development and acts as a liaison who communicates curricular needs.



Postsecondary Information:

66% of the class of 2024 are attending a college or university. Student and family support was provided in the area of post secondary planning and financial aid through parent programs and college and career fairs. 13% of the class are attending a trade school, while the remainder of the students entered the military or workforce directly upon high school graduation.

Academic support instruction is provided daily to struggling students. Students had the opportunity to receive additional instructional support during lunch and help and access period. Intervention & Referral Services focus on intervention strategies for successful student academic and behavioral outcomes.



Student Health and Wellness:

Multiple assemblies are held throughout the year with a focus on health awareness and good habits. Breakfast and lunch are provided to all students. Students are engaged in physical activities appropriate to their age. Our local police department provides programs at all levels related to safety and wellness. Technology and STEM:

All of our schools have access to technology labs and one to one Chromebook devices at all levels. Our teachers use the Google suite (classroom) to enhance instruction. Many of our instructional programs and assessments are technology based. We offer a Robotics competitive program at the Middle School and High School and STEM education in grades K-5. Our Elementary School is equipped with a grant funded STEM lab. Our Middle and High Schools have robotics teams, and our Middle School is engaged in the Girls Who Code program. Drone program is offered at the High School and Middle School.



Early Childhood Education:

The preschool program has expanded this year to 10 preschool classes and three self-contained preschool classes. Free full day preschool is offered to South River children ages three and four.



Attendance:

ESSER funds were used to address learning loss, physical, social, and emotional needs throughout the district. Students received extended day/summer acceleration and remediation services, supplies to optimize learning and daily practices related to physical health, mental health services, web based supplemental instruction, and school day individual/small group academic support instruction. Staff received professional development to address learning loss, intervention services, ELL support, and positive climate building. The district is addressing learning loss through a comprehensive and systematic network of protocols that include periodic collections and analyses of qualitative / quantitative data which lead to scaffolded and customized Tier II and Tier III interventions. Mental health services have been offered to students through enhanced climate building activities, social work, behavior modification services, referral services, and a dog therapy program.
