



#### **English Language Arts Assessment - Participation and Performance**



Based on New Jersey's approved ESSA state plan, NJDOE will identify schools in the following four federal categories every three years:

- · Comprehensive Support and Improvement (CSI): Overall Low Performing:
  - Title I schools with a summative score in the bottom 5% of Title I schools.
- Comprehensive Support and Improvement (CSI): Low Graduation Rate:
  - All high schools with a four-year graduation rate of 67% or less
- Additional Targeted Support and Improvement: Low Performing Student Group (ATSI):
  - All schools with one or more student group with a summative score that would be in the bottom 5% of Title I schools
- · Comprehensive Support and Improvement (CSI): Chronically Low Performing:
  - Title I schools identified as Additional Targeted Support and Improvement; Low Performing Student Group (ATSI) that are identified for three or more consecutive years, i.e., ATSI schools that do not meet exit criteria.

Annually, NJDOE will identify schools in the following federal category:

- · Targeted Support and Improvement: Consistently Underperforming Student Group (TSI):
  - All schools with one or more student groups that missed annual targets or standards for all indicators for two years in a row

For purposes of ESSA accountability, only schools and student groups with data for 20 or more students are included in calculations.

The NJDOE identified schools for CSI and ATSI status in fall 2023 based on data from the 2022-2023 school year, so the NJDOE did not identify schools for CSI or ATSI status based on 2023-2024 school year data. The NJDOE only identified schools for TSI status based on data from the 2023-2024 school year.

Our school has a secure main entrance with an enclosed vestibule and an exterior fence to protect other exterior entrances. An updated security system including a lockdown call button and interior and exterior cameras all aim to further a secure learning environment. A State Police resource officer provides a presence intermittently throughout the week.



We are proud to offer 1:1 devices in all grades Pre-K through 8th. Students in grades Pre-K-1st utilize iPads while students in 2nd-8th grade utilize Chromebooks throughout the day for instruction. All students participate in STEAM activities on a weekly basis. Farmingdale School is equipped with interactive whiteboards in every classroom to facilitate the delivery of lessons and the demonstration of material to students.



Our best practice preschool program provides three- and four-year-olds with a valuable opportunity to develop both academic and social skills. The program employs the Tools of the Mind curriculum which promotes learning through dramatic play and self-regulation. Young learners develop foundational skills which will serve them well in Kindergarten and beyond. Our school offers a full-day program funded by Preschool Expansion Aid from the NJDOE, and is free to Farmingdale families.

Farmingdale School believes consistent school attendance is one of the most powerful ways to prepare children for success-both in school and in life. At the start of each school year, the parent portal provides a letter from the superintendent highlighting the district attendance policy which must be acknowledged by the parent/guardian. Letters are mailed home throughout the school year when student absences begin to accumulate. Parents are contacted personally and meetings are set up to discuss strategies to improve regular attendance in school when their student's absences reach an unacceptable level.
