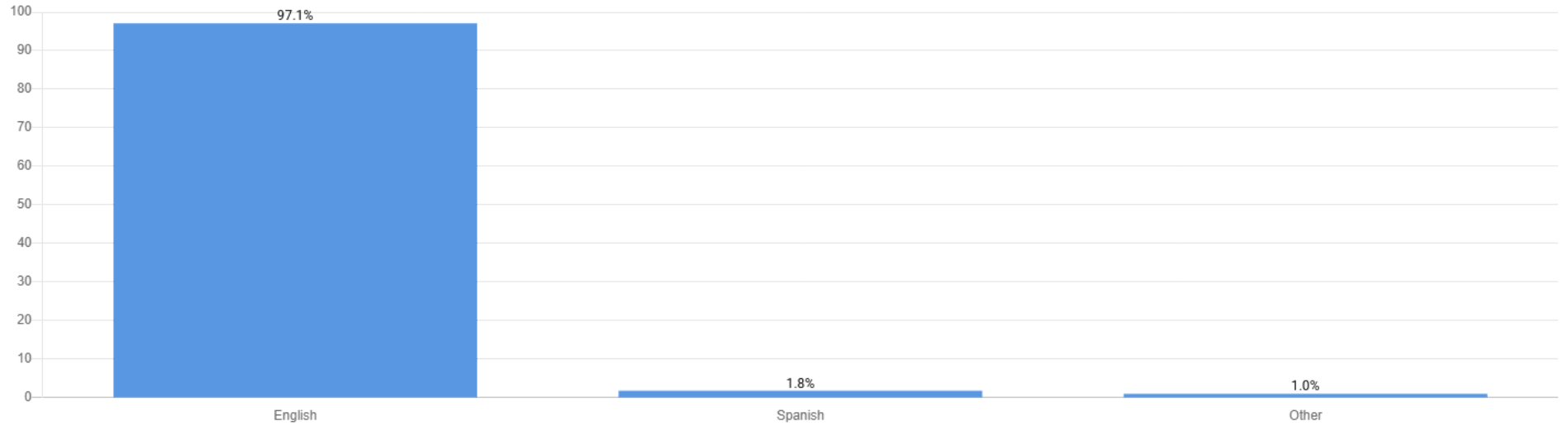

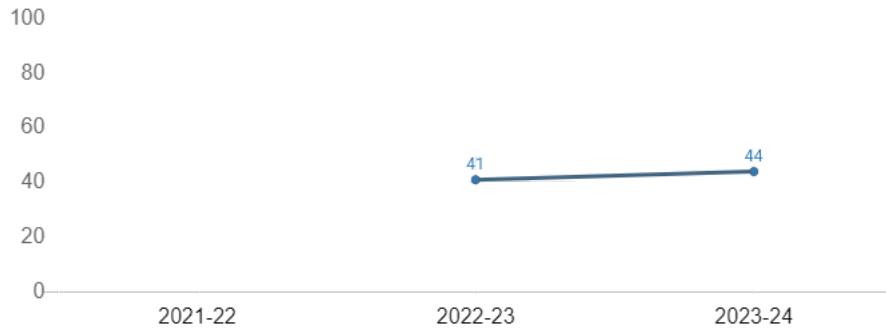

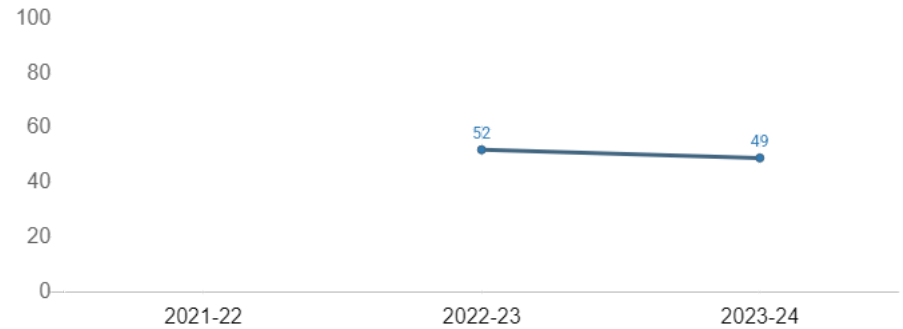

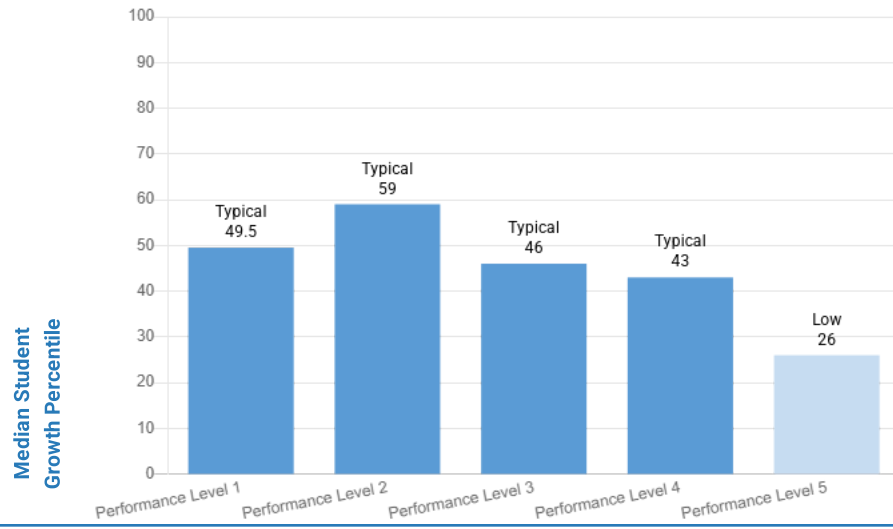

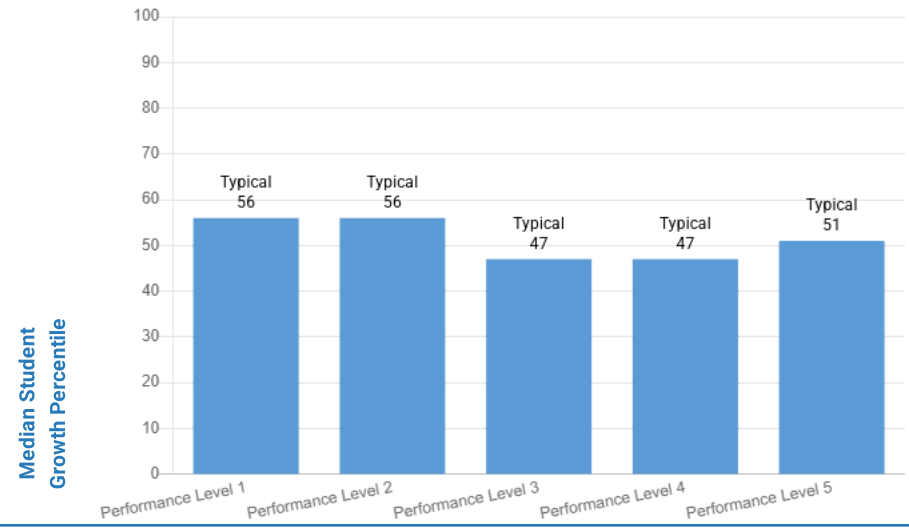

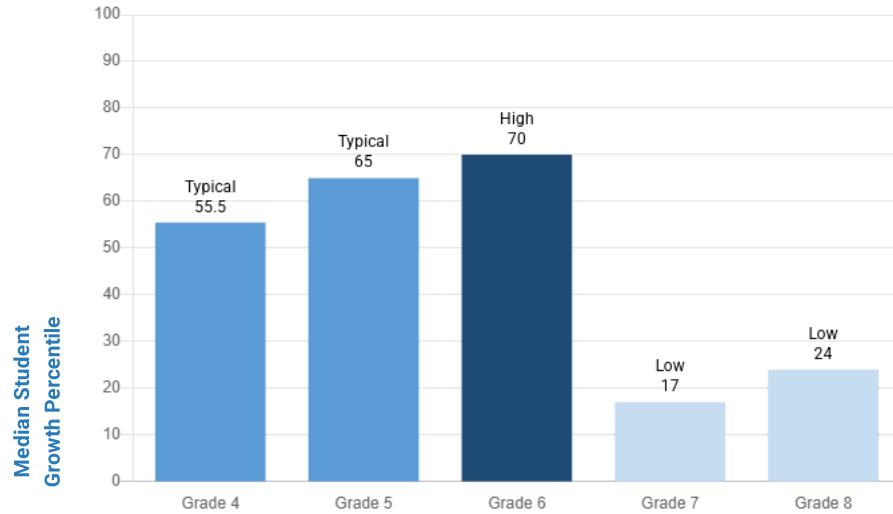

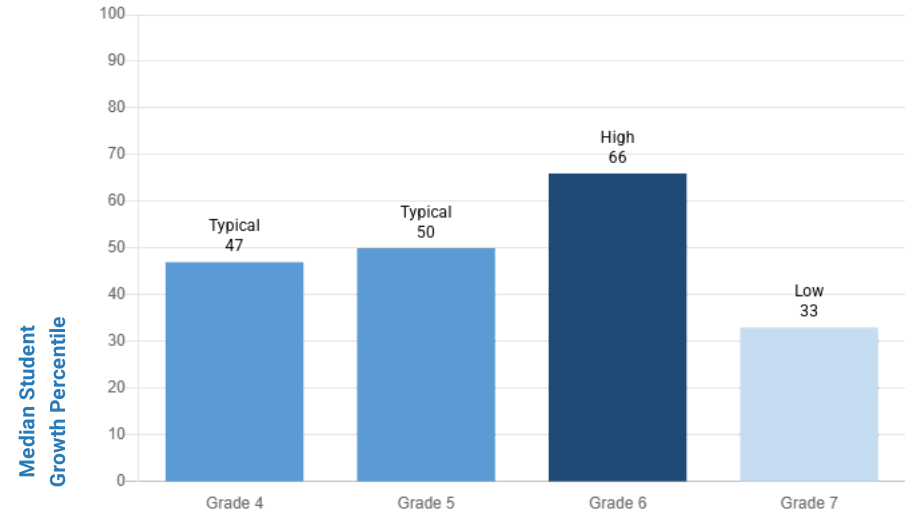

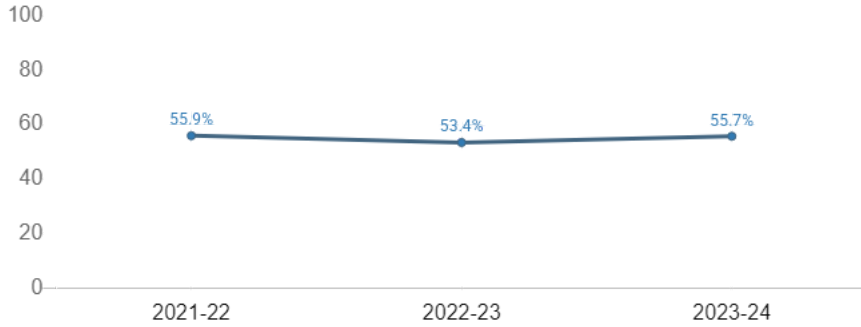

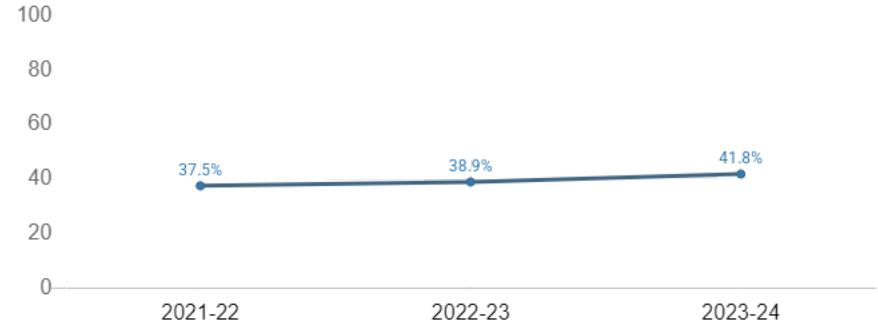
English Language Arts and Mathematics Performance Trends

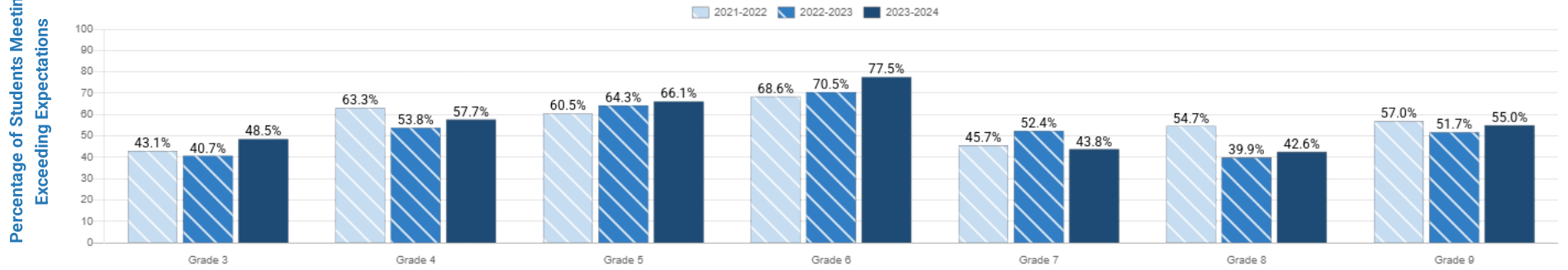

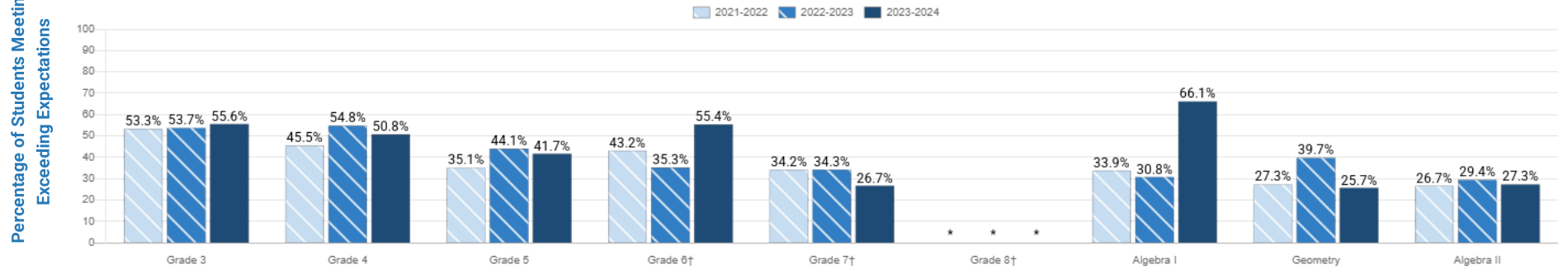

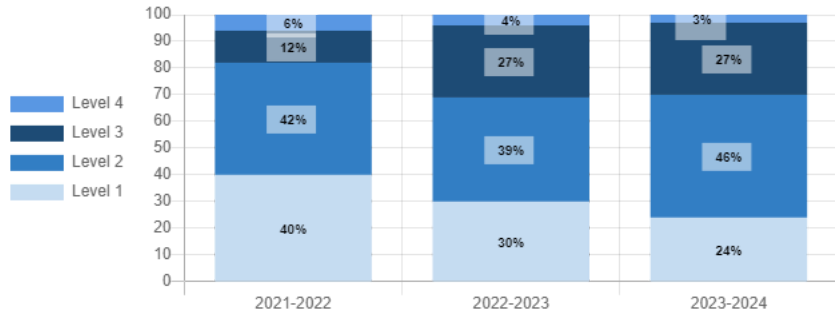

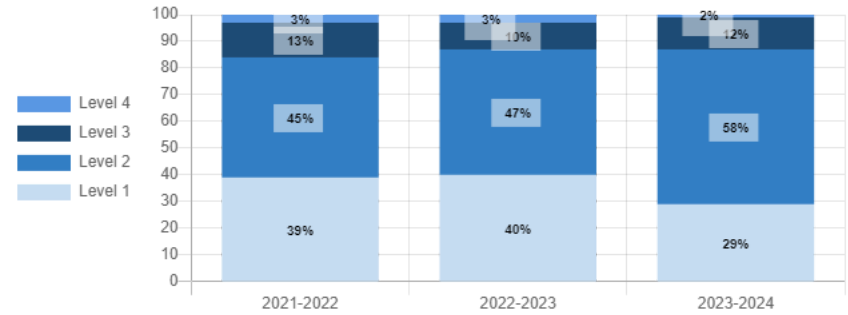
NJSLA Science Assessment: Grade 5 Summary

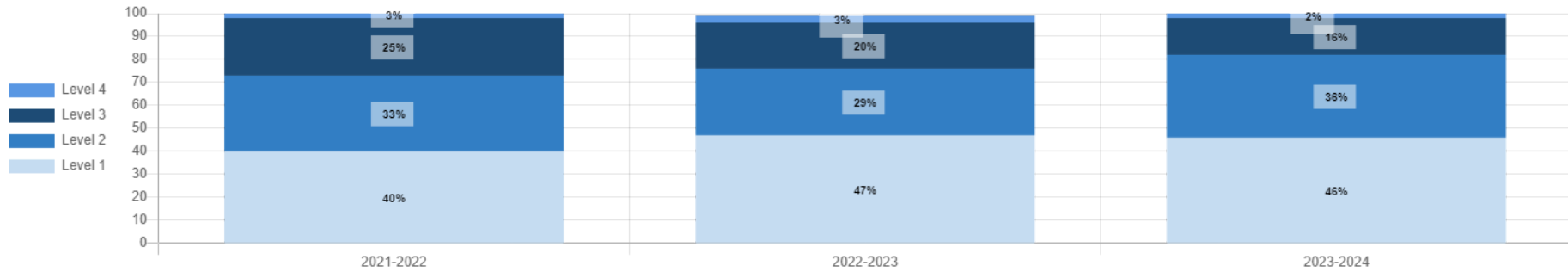

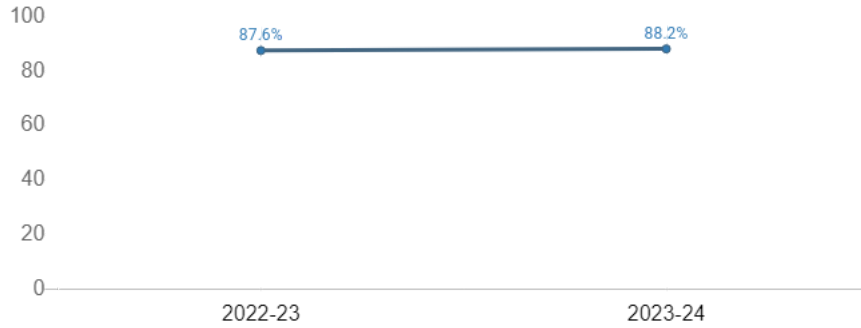

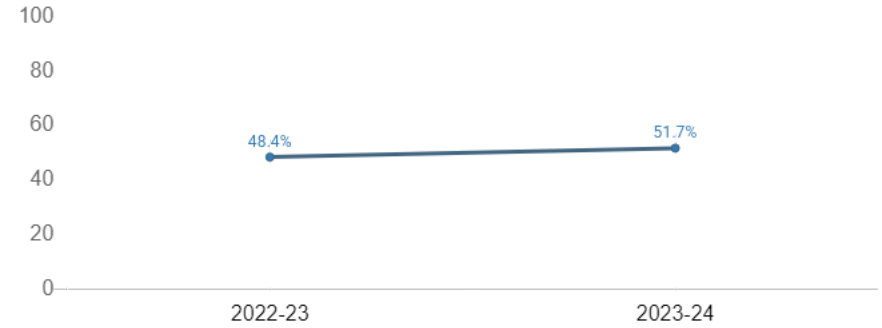

Students taking one or more AP or IB exam

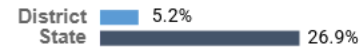


Students with one or more exams with a score of at least 3 on AP exams or 4 on IB exam

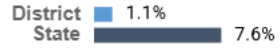

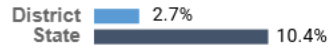
CTE Participants

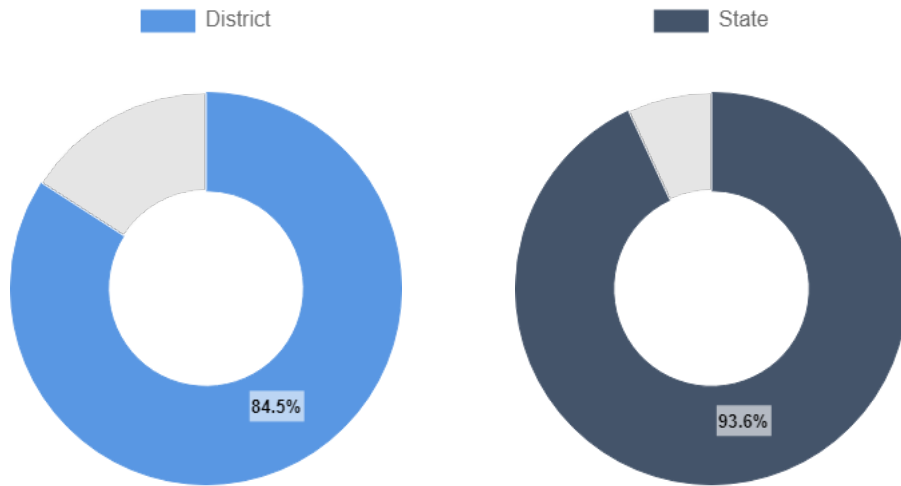

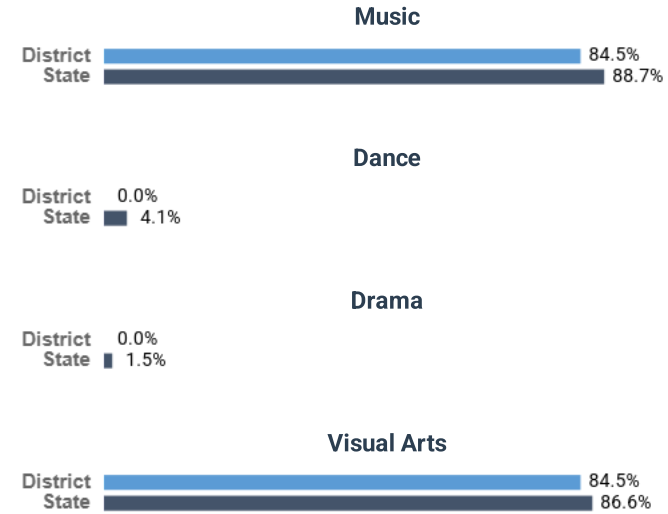

Students enrolled in one or more classes by discipline:



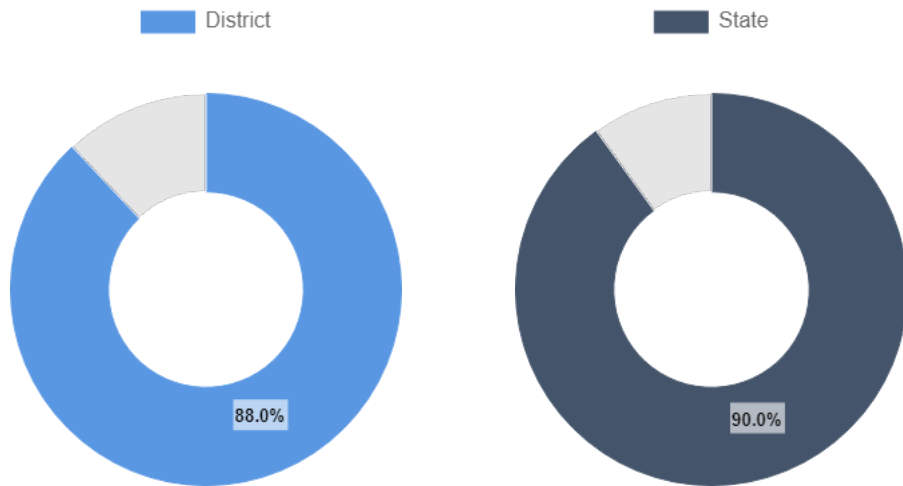

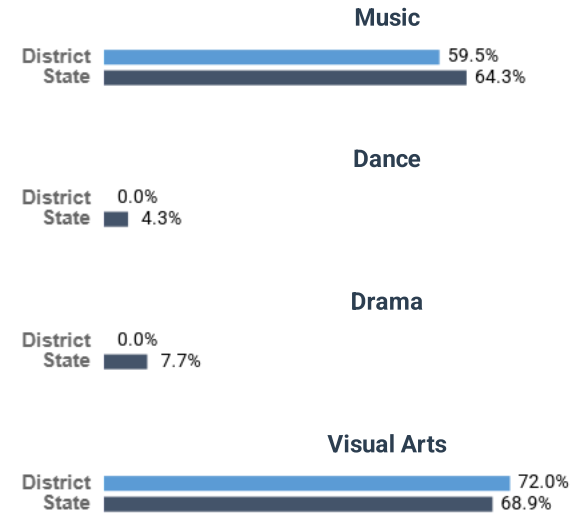

Students enrolled in one or more classes by discipline:



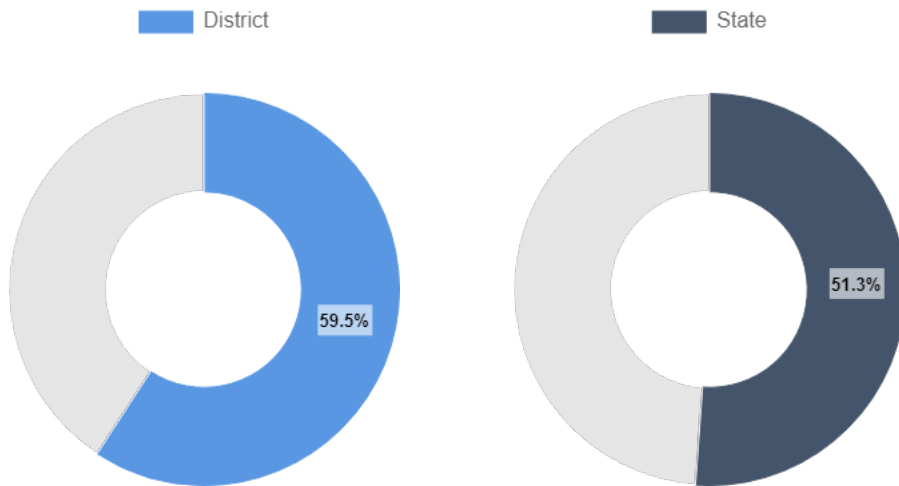

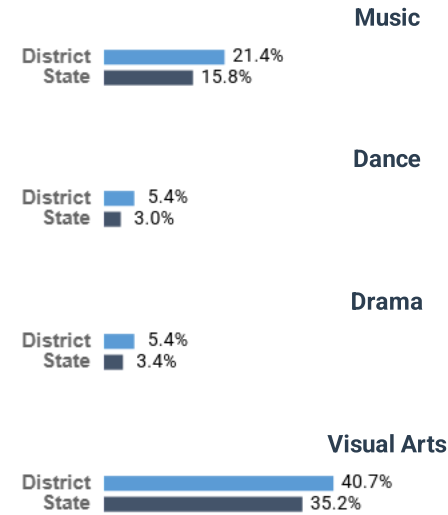

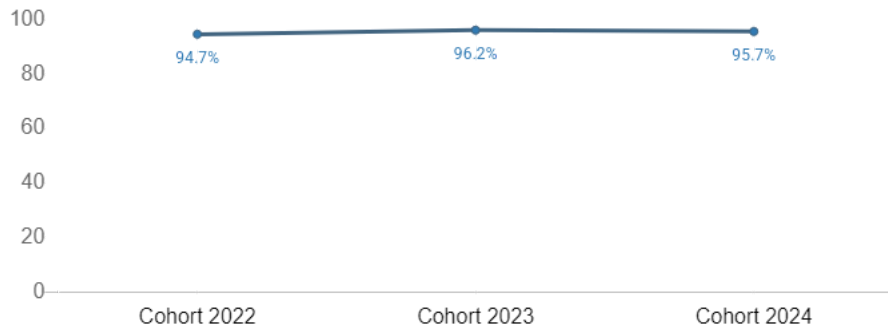

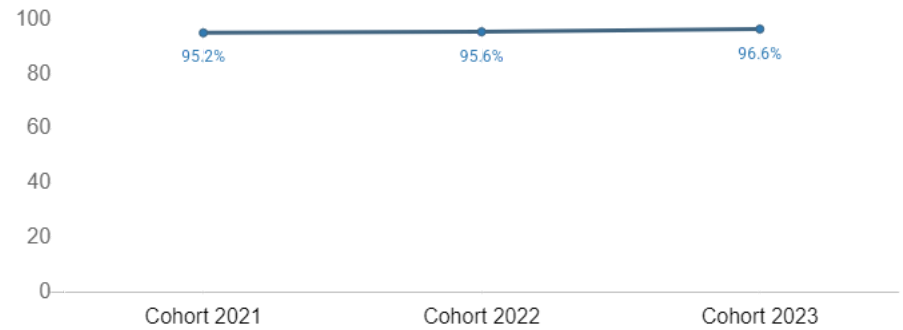

Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

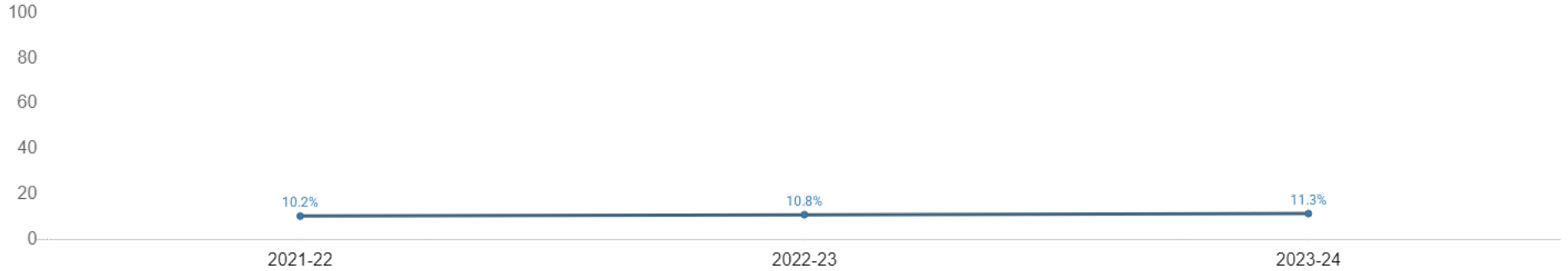

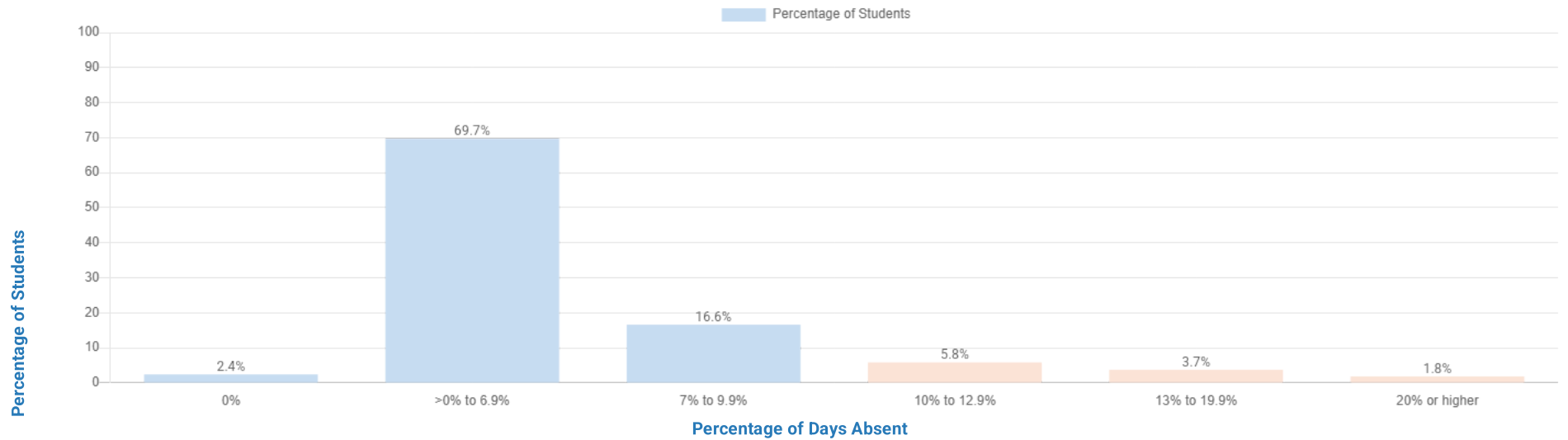

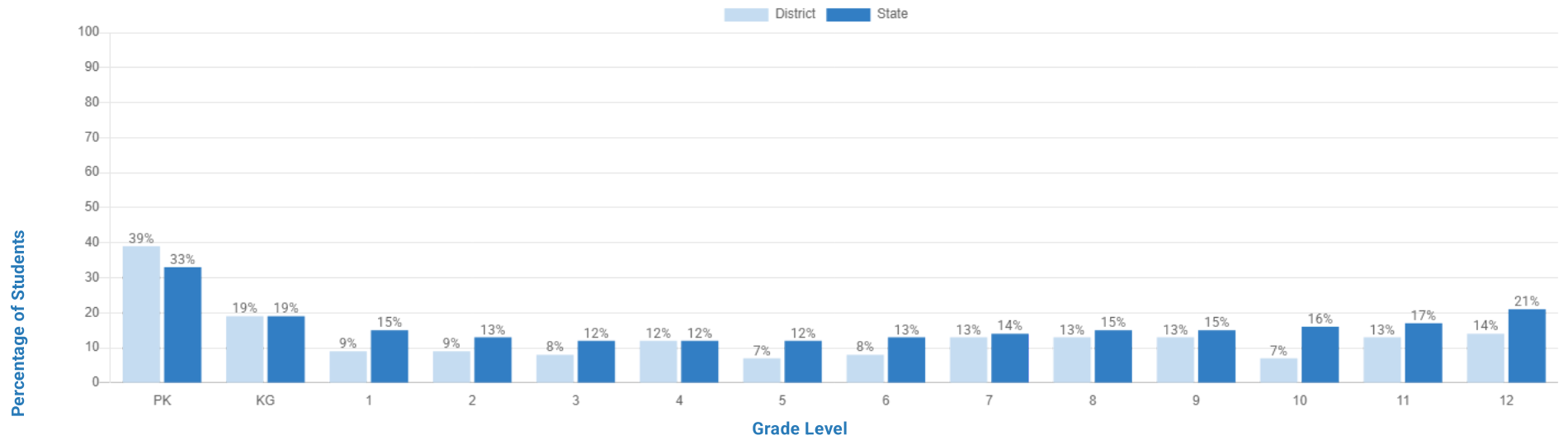

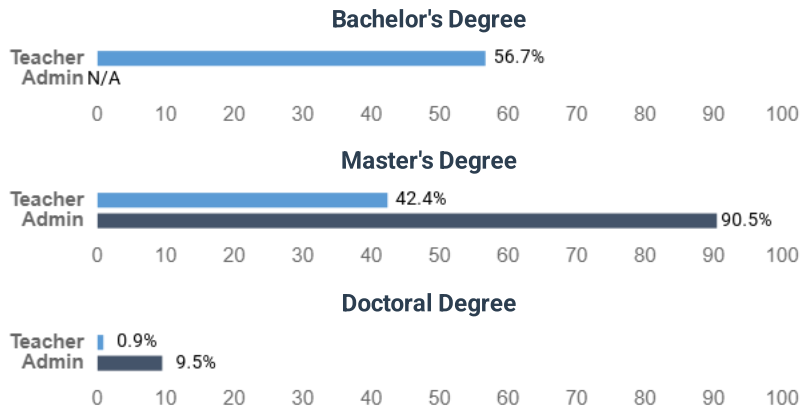

The District has a comprehensive athletic program offering a developmental program at the middle school level and a competitive interscholastic program at the high school level that focuses on good sportsmanship, community service and fair play. Recent championships include the State Sectional Championship in Volleyball, Shore Conference Divisional Championship in Softball, Wrestling and Volleyball. The high school was also chosen as the NJSIAA Shore Conference Divisional Sportsmanship Award winner for 2021-22 and the Monmouth County Sportsmanship winner 2024 in Girls Soccer. The Special Olympics program is highly active in the community and beyond. Multiple sports clinics are held at district facilities. Students also participate in state competitions in bowling, swimming and soccer.

Staff and Professional Learning:

Professional development is one of the core tenets of the Hazlet Township School District. Teachers and staff members are afforded with significant opportunities for professional development. Workshops that provide sustained professional growth are offered throughout the school year in targeted areas to address curricular changes, State requirements, standards, and current educational research on best instructional practices that includes a personalized learning approach to teaching and learning. A strong emphasis on social and emotional learning training and professional development has been incorporated for teachers and staff members in an effort to utilize strategies and resources in daily instruction and teaching.



Postsecondary Information:

Students also benefit from dual-enrollment agreements with Brookdale Community College, Kean University, Seton Hall University, NJIT and Rutgers University that allow qualified high school students to enroll in college courses taught at RHS by college and university affiliated faculty, while simultaneously earning credit toward a high school diploma and a post-secondary degree.



Student Supports and Services:

The Hazlet Township Public School district offers a continuum of special education and related services to over 500 classified students. The district employs eleven Child Study Team members, two Board Certified Behavior Analysts, five speech therapists, and one occupational therapist. In addition, the district utilizes consultants and itinerant services to enhance programming and further meet the needs of our students. Additionally, the district employs nine guidance counselors and each school has a full time nurse. Furthermore, Intervention and Referral Services and English as a Second Language instruction are also provided.

Student Health and Wellness:

Maschio's Food Service, responsible for our lunch program, also serves breakfast. Students are engaged in physical education and elementary schools also have daily recess. Principals coordinate events which include field days, walk-a-thons, and activity competitions to highlight physical activity. There are also programs during the year at these schools to instruct students on proper nutrition and eating habits. Healthier food items are placed in the service line where students can choose them.



Parent and Community Involvement:

All schools except for the high school have active PTOs in their buildings. There are monthly meetings rotated between day and evening times so all community parents can be involved. Many events are offered to raise money to assist the schools purchasing special additions for the students. Hazlet uses a Parent Portal to keep all vested parties informed of their children's academic accomplishments. Updated frequently, parents can stay aware of developments in each school by Facebook, Twitter and Instagram. An active and well-established Special Education Parental Advisory committee works in conjunction with the Special Services Department to provide feedback concerning programmatic and policy decisions.

Facilities:

The district completed a \$43 million referendum in 2020. School building facility updates includes, new heating and air conditioning systems for all of the classrooms in the district, replacing older roofs on many of our schools, new windows for any classrooms that have not been already replaced, bathroom renovations, updating the doors, lighting and ceilings in our classrooms, updating the parking lots and other needed site renovations. The completion of the elementary outdoor learning labs concluded affording students and staff engaging opportunities outside the classroom.



School Safety:

School safety and security committee meetings with members of the Board of Education and the Hazlet Township Police Department are established throughout the year. Ongoing updates and replacements to the security camera systems is part of the district's security strategic plan. Currently, 5 SLEO III officers in the district. Ongoing training and professional development to staff and administrators on security/safety. Team/Culture and Climate Team. Annual school safety and security assessments.



Technology and STEM:

We are a 1 - 1 district for every student, Infusing technology is an initiative for all our students and faculty in Hazlet. Teachers are offered ongoing, job embedded professional development throughout the year and on our two scheduled in-service days. Classroom teachers use smart boards during instructional lessons. Hazlet has a state-of-the-art Makerspace/STEAM Lab in most of the schools in the district.

Sycamore Drive Early Childhood Learning Center offers Preschool a tuition based half day program for 3, and 4 year old"s and full day Kindergarten for those 5 before October 1st. (SD ECLC) is an innovative, nurturing and inclusive community dedicated to educating the whole child. Smart boards, promethean boards, I pads, Chromebooks, document cameras and software such as Mathseeds and Mystery Science enhance learning. Our students, parents and staff work hard individually, as classmates, and as a school community to create a learning environment that maximizes everyone's potential.



Attendance:

The Hazlet Township School District implements a comprehensive attendance program to improve and monitor chronic absenteeism. Building leadership tracks and identifies chronic absenteeism. Interventions are provided for struggling students and consequences are enforced for unexcused absences. Parents are very much involved in the process. The district's early warning system notifies parents or guardians when a student reaches a certain threshold of absences, including phone calls, letters, or scheduled meetings. The utilization of a truancy officer assists building principals by working with families to identify and address potential reasons for absences like transportation issues, health concerns, or family challenges.
