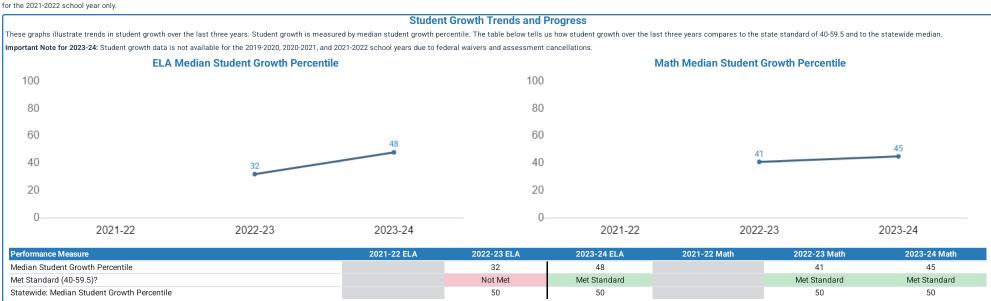

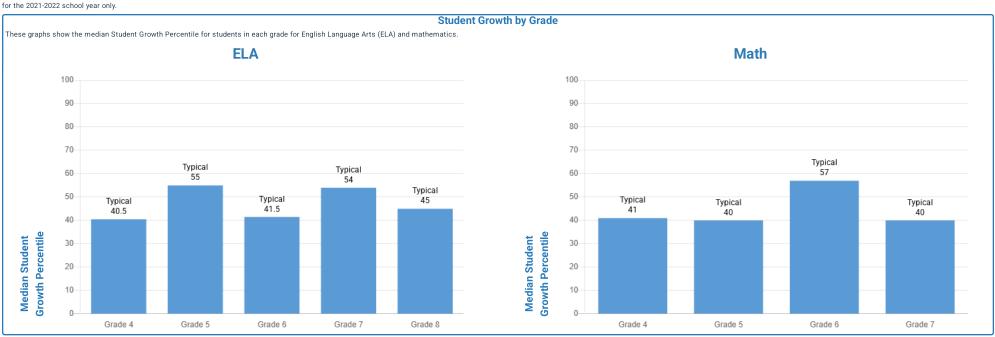

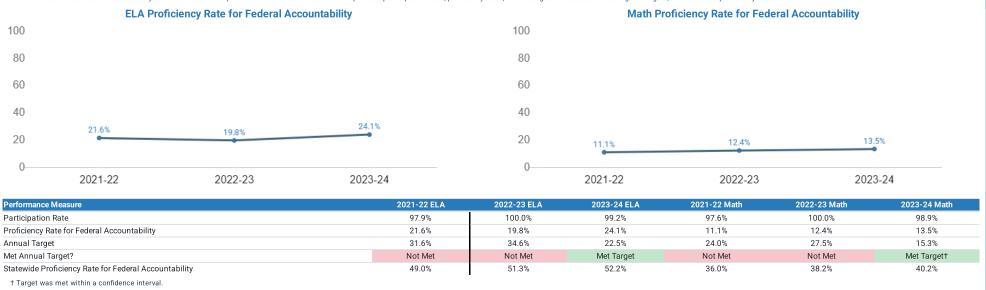

Graduation/Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. 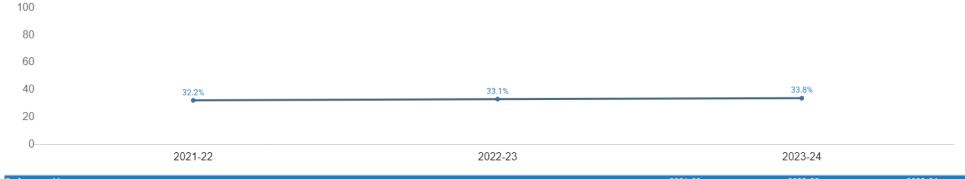

The district has two newly built SDA buildings. Joseph C. Caruso Elementary School opened to students in 2016, and The Keansburg Early Learning Center opened in 2022. This past summer a new HVAC system was installed in both the High School and Middle School. All new furniture was purchased to enhance the learning environment.



The Keansburg School District utilizes and enforces various protocols and procedures to maintain a safe environment for students and staff. School administration works closely with the local police department to provide support, staff training, and student programs around safety and security. Our district also employs Special Class III Officers at each school who assist in the daily protection of the building. In addition, the district has an SRO on staff. Throughout the school year, the staff is trained on the latest safety procedures and drills every month.



Our district offers a full-day preschool program for all Keansburg residents who turn 3- or 4- years of age by October 1st. Any child with an individualized education plan (IEP) can enroll and attend preschool as soon as they turn 3-years old. Each preschool classroom is staffed with at least one teacher and one teacher aide for a maximum of fifteen students.
