














English Language Arts and Mathematics Performance Trends




NJSLA Science Assessment: Grade 5 Summary






Students taking one or more AP or IB exam









Graduation rates are calculated based on the adjusted cohort graduation rate calculation. Beginning in the 2020-2021 school year, the NJDOE was required to make changes to the methodology used to calculate the adjusted cohort graduation rate for federal reporting and accountability purposes. 



This means that students with disabilities who did not meet some or all graduation requirements because of a modifications or exemption in their Individualized Education Program (IEP) may not be counted as graduates in the calculation of the adjusted cohort graduation rate used for federal reporting and accountability purposes. It is important to note that this was only a change to how graduation rates are calculated for federal reporting. It does not affect requirements to earn a diploma or the type of diploma that the state awards to students with disabilities.

As a result of these changes, the NJDOE began calculating two versions of the adjusted cohort graduation rate starting with 2021 graduation rates. The "federal version" aligns with ESSA requirements and USED guidance and is used for federal reporting and ESSA school accountability only. The "state version" continues to use the same methodology used prior to 2021 and reflects all students who received a state-endorsed diploma.

To be included as a graduate in the federal version of the graduation rate, students must have met state course requirements and local attendance requirements for graduation. Additionally, students must meet the graduation assessment requirements in place based on the year they are graduating, regardless of their graduation cohort. The graduation assessment requirements for the classes of 2022 through 2024 have differed as a result of executive orders in response to the pandemic and new legislation. As a result, the calculation of the federal version of the graduation rate has also changed.

In this section of the reports, the Graduation Rate Trends and Progress charts and Graduation Cohort Profiles (4-Year, 5-Year, and 6-Year), as well as the graduation rates reported in the Summary Reports, reflect the "state version" of the graduation rate. Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Note for 2023-2024: Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.











All curricula are aligned to the New Jersey Student Learning Standards (NJSLS) and integrate Computer Science and Design Thinking, Career Readiness, Life Literacies, and Key Skills to ensure all students have equitable access to achieve academically. All curricula are available electronically via the Atlas portal on the district website in accordance with the NJDOE curriculum implementation guidelines. MARSD understands the critical role that ongoing, high-quality embedded professional development plays to foster rigorous teaching and learning and enhance the educational environment and experience for every student, at all levels. Staff is trained throughout the year on topics germane to Social-Emotional Learning, Mental Health, and Wellness, as well as training focused on promoting Diversity, Equity, and Inclusivity.



Postsecondary Information:

The Matawan-Aberdeen Regional School District's Recognizing Educational Achievements and Career Hopes (REACH) Program is designed to prepare special needs students aged 18-21 to be productive citizens in our community. Students have opportunities to participate in structured learning experiences with community partners and a variety of classes focused on transition planning, promoting essential life skills, and overall wellness.

Student Supports and Services:

Counseling, intervention, and integrated social-emotional learning support services are in place to assist and support all students. A Recovery High School was established through a partnership with Right Your Life and Brookdale Community College. The MARSD K.E.Y.S. Academy was created to support students diagnosed with substance use or dependency disorder seeking a sober lifestyle. Also, the district has partnered with Effective School Solutions to offer therapeutic services in the student's natural learning environment. Counseling, intervention, and integrated social-emotional learning support services are in place to assist and support students. The Intervention and Referral Services (I&RS) team works to provide strategies and resources to teachers to support their students. At the elementary level, a Multi-Tiered System of Support (MTSS) provides identified students with targeted support and interventions.



Student Health and Wellness:

MARSD partners with the NJ Mental Health Association to better support students in crisis. The district implements a Suicide Prevention curriculum which is integrated into Health classes at the upper elementary and secondary levels. The district also embeds Social-Emotional Learning supports and mindfulness as part of daily Morning Meetings. District Counselors, Social Workers, psychologists, and other Specialists provide integrated student support and wellness services. The district offers Intervention and Referral Services for students struggling with learning, behavior, social, emotional, and/or health difficulties. The Effective School Solutions program has been initiated at the secondary level to provide individual and small-group services to students in need. The district also operates K.E.Y.S. Academy Recovery High School on the campus of Brookdale CC to provide a rigorous, innovative, and supportive learning environment for students with substance use or dependency disorders.

Facilities:

MARSD has recently undertaken various improvements and replacements throughout all seven buildings. Many schools such as Cambridge Park, Strathmore, and MAMS have had extensive painting on the exterior of the buildings. Last year Lloyd Road and Cliffwood received new playground equipment. The High School has a brand new turf and track field with a multi-use scoreboard. The District purchased a new Central Office that allowed the District to undergo renovations to add ten additional preschool classes. The district is guided by a long-range facility plan.



School Safety:

The safety and security of all students and staff is our district's top priority. Every school is equipped with a visitor security vestibule for the safety of all occupants. The school's Safety & Climate team is composed of administrators, teachers, support staff, and parents. The team meets regularly to review and discuss student and staff safety matters and other aspects of school safety using data and feedback from safety walkthroughs. MARSD takes proactive measures to protect the safety and security of all our students and staff members. The district updates and maintains a comprehensive school safety and security plan designed locally with the help of law enforcement, emergency management, public health officials, and all other key stakeholders. A variety of resources, including checklists, videos, and training, are utilized in the districts plan development.



Technology and STEM:

MARSD is fully one-to-one and provides a district-issued Chromebook to every PreK-12 student. All K-12 students will maintain their own district-issued Chromebook (CB), and carry their Chromebook to/from school each day. Students and teachers utilize an array of educational technology tools, platforms, and online resources to support the integration of science, technology, engineering design, the arts, and mathematics. Digital citizenship and cyber safety are infused into all areas. Science instruction promotes authentic learning and problem-solving using the engineering design process. STEM lessons are taught regularly by homeroom teachers and also monthly by specially-trained teachers for push-in enrichment lessons.
