














English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 




















Teachers and Administrators - Level of Education

We work collaboratively to engage students in learning experiences to inspire and challenge our students. School Safety:

The safety and security of our students remain a priority for Millstone Township Schools. Board of Education Policies and Regulations are strictly adhered to for purposes of maintaining this priority. The Board of Education continues to support a whole-child approach to safety and security by providing resources for facility improvements, personnel, and infrastructure upgrades that support social and emotional learning, mental health, security, and safety. In addition to district personnel, a collaborative working relationship with the state police and the addition of Class 3 security officers, allows a presence in our buildings of law enforcement officers.



Technology and STEM:

Students enrolled in Millstone Township Schools are exposed to a variety of STEM-related programs. From STEM experiences in Elementary to electives for students in middle grades, the district remains committed to providing students with an array of learning experiences. The district's 1:1 initiative is also utilized in a cross-curricular manner, in the majority of subjects for purposes of engaging students in their learning via a technology device, programs, and applications.



Early Childhood Education:

Millstone Township School District offers integrated preschool for children ages 3, 4, and/or 5. The District offers both full and half-day options for families. Unless dictated by a child's individualized education program (IEP), transportation is not provided. Preschool enrollment is tuition-based and limited in availability. Millstone Primary School traditionally holds a preschool information session in February with open enrollment in early March of each school year for interested families.
