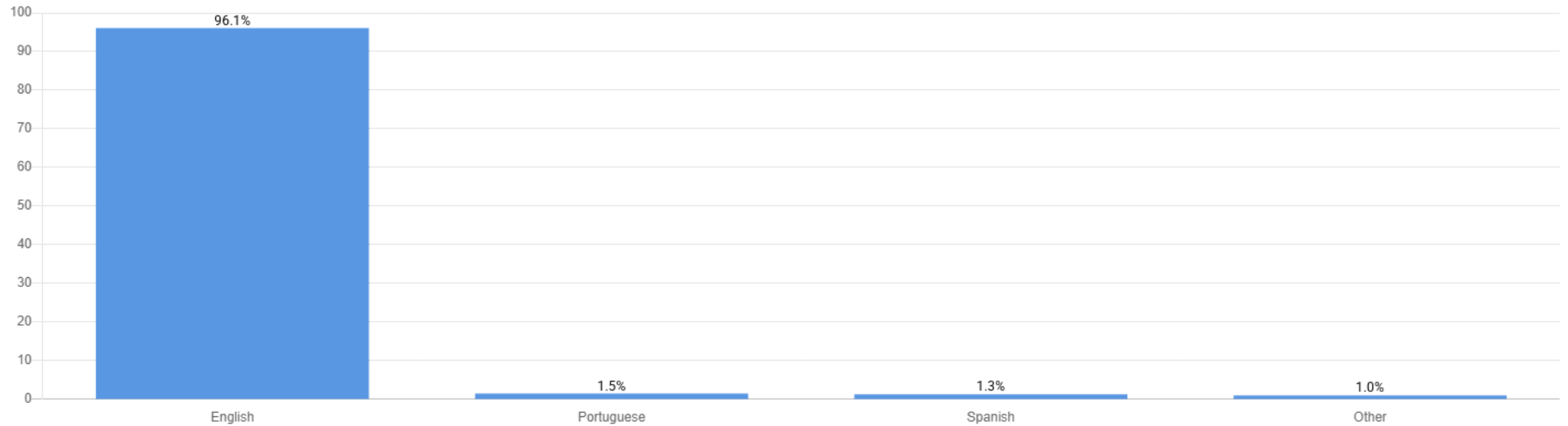

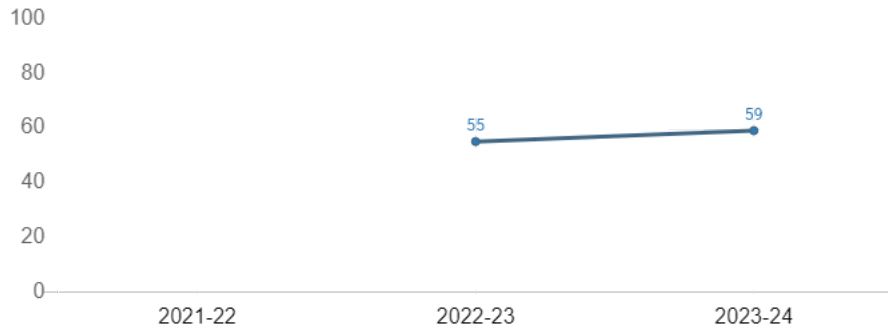

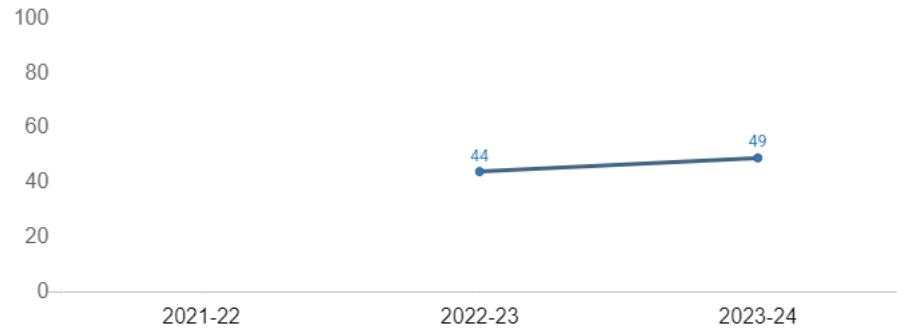

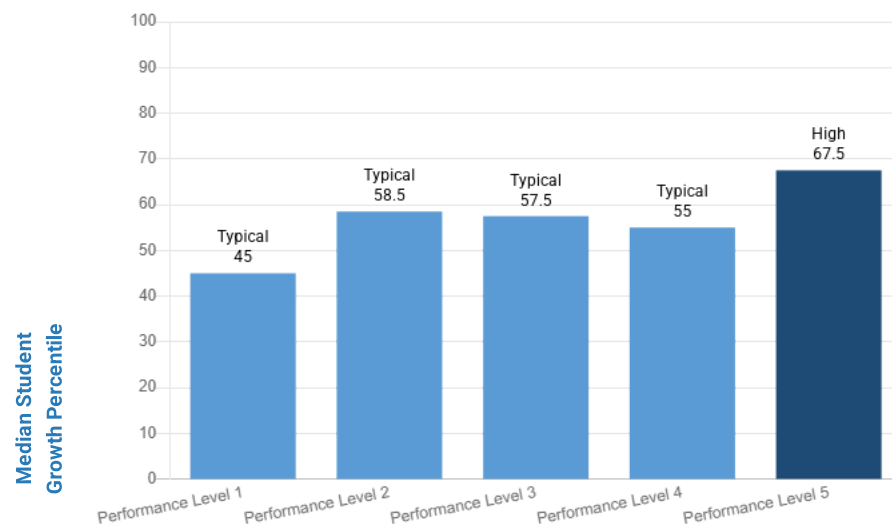

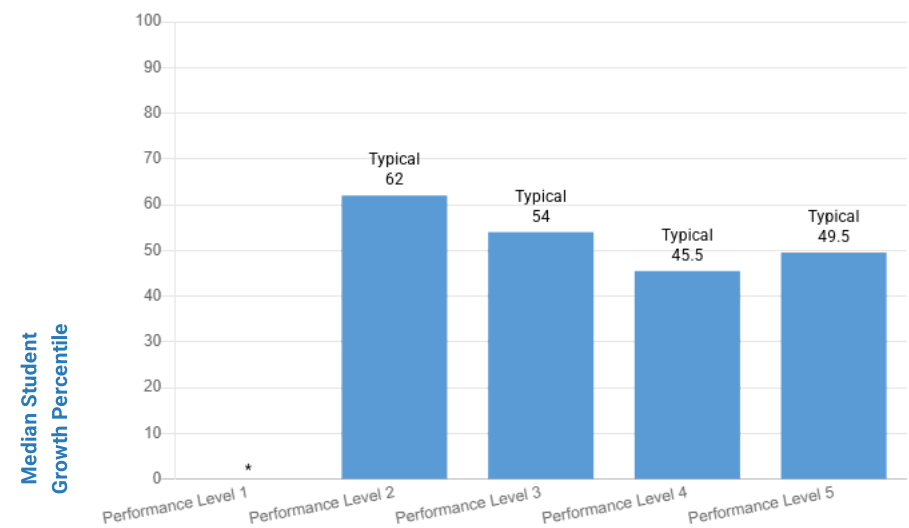

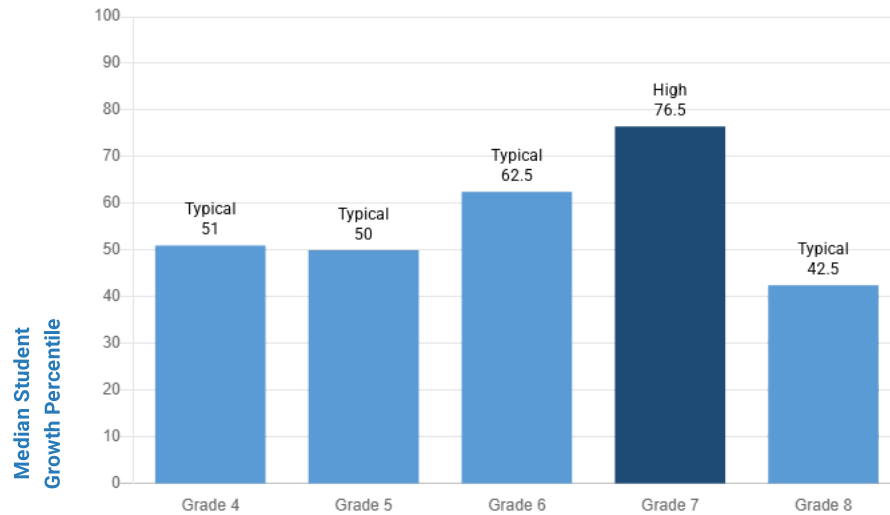

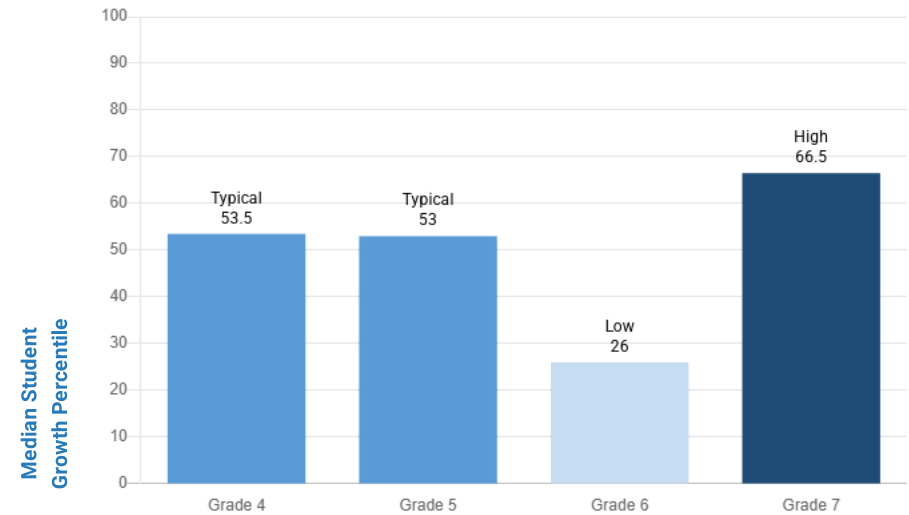

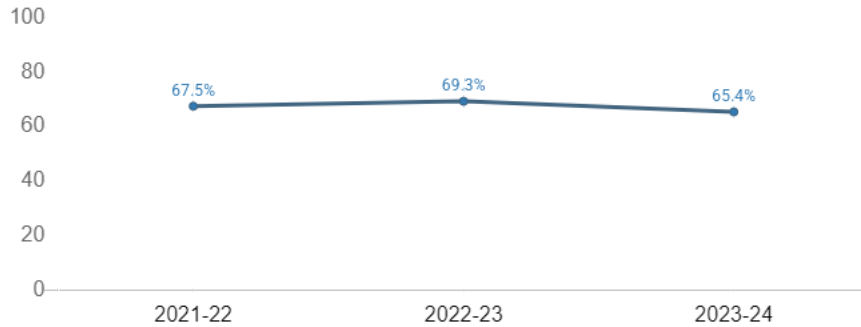

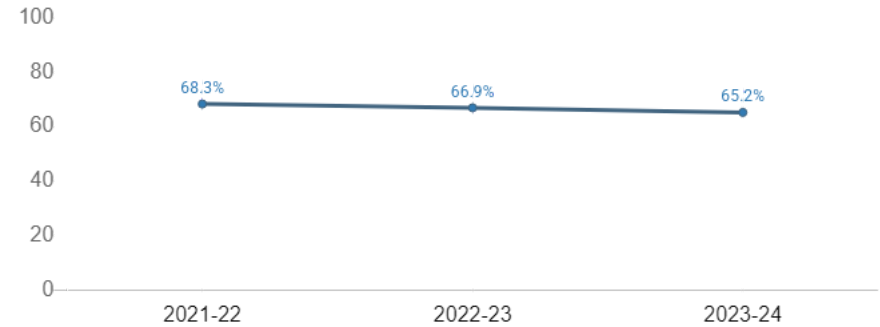
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 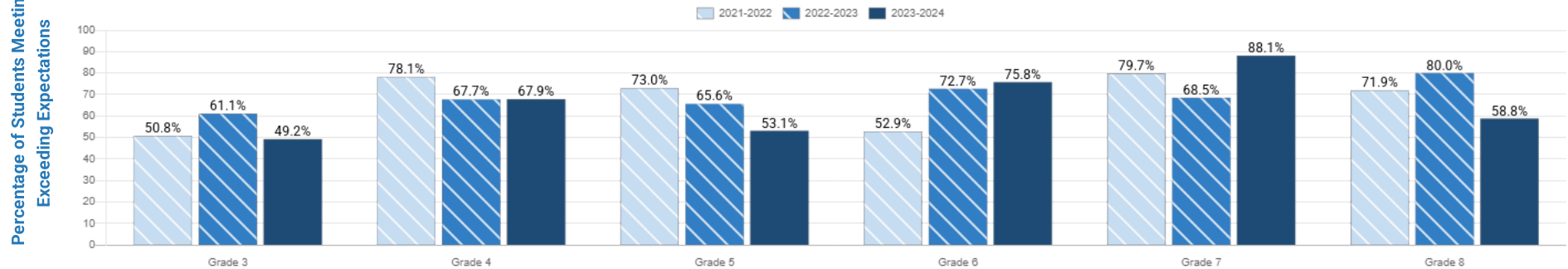

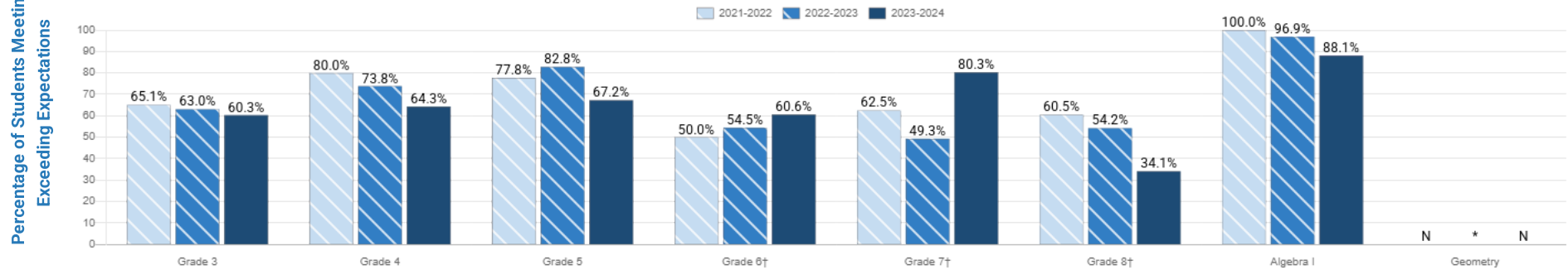

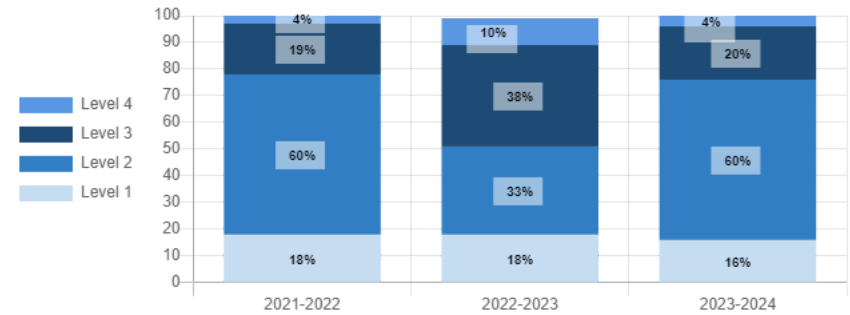

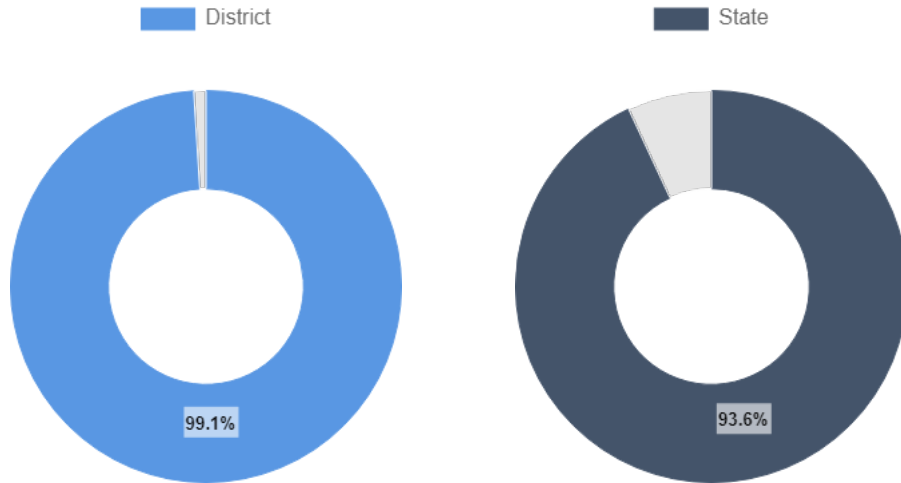

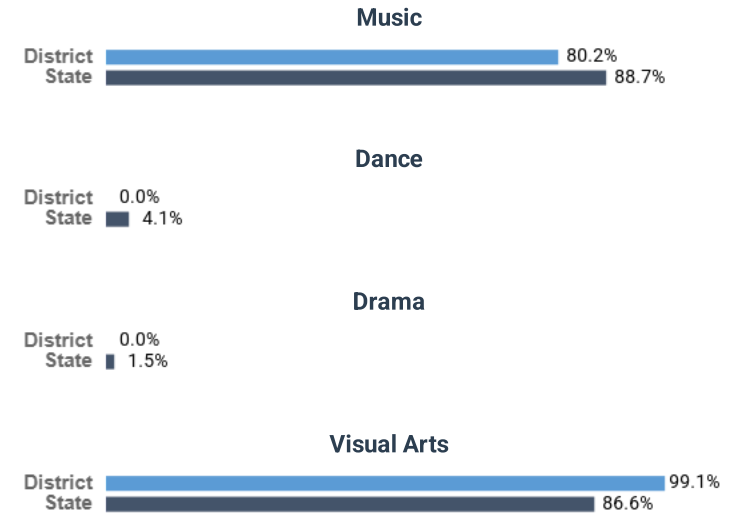

Students enrolled in one or more classes by discipline:



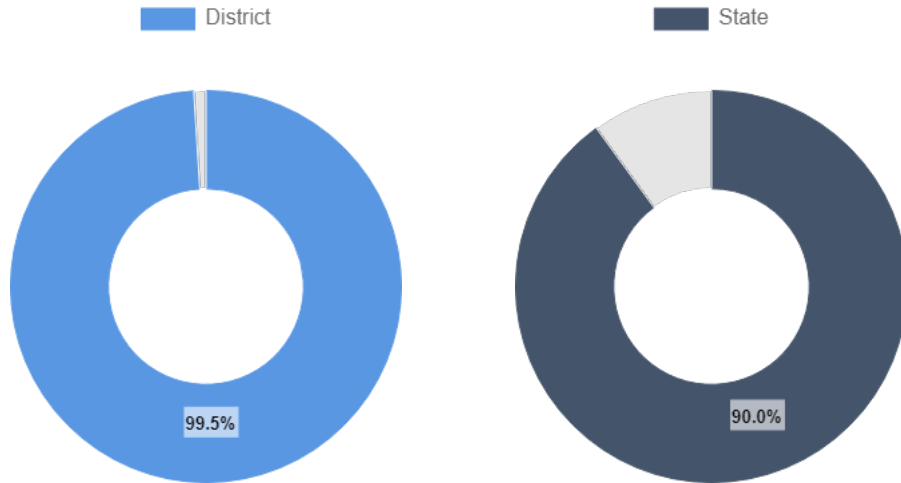

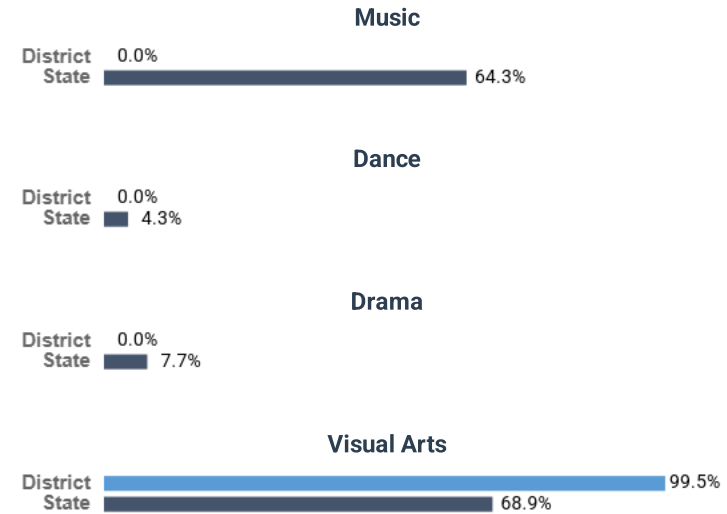

Students enrolled in one or more classes by discipline:

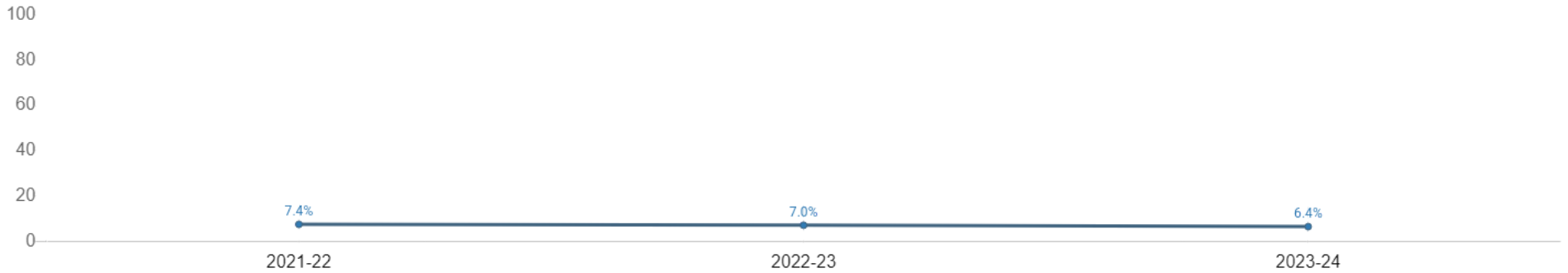

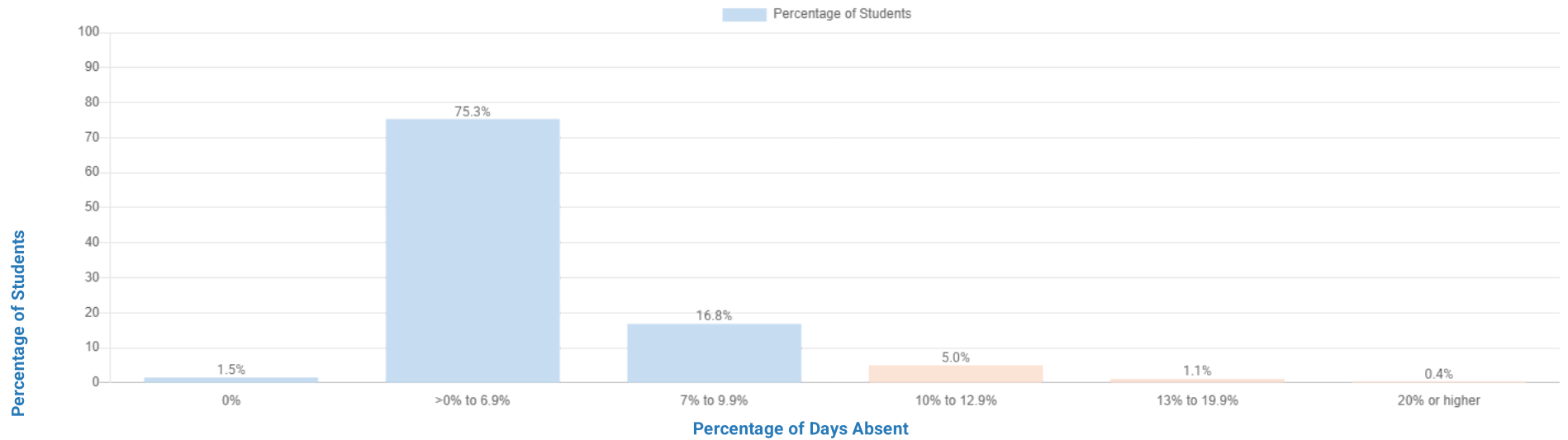

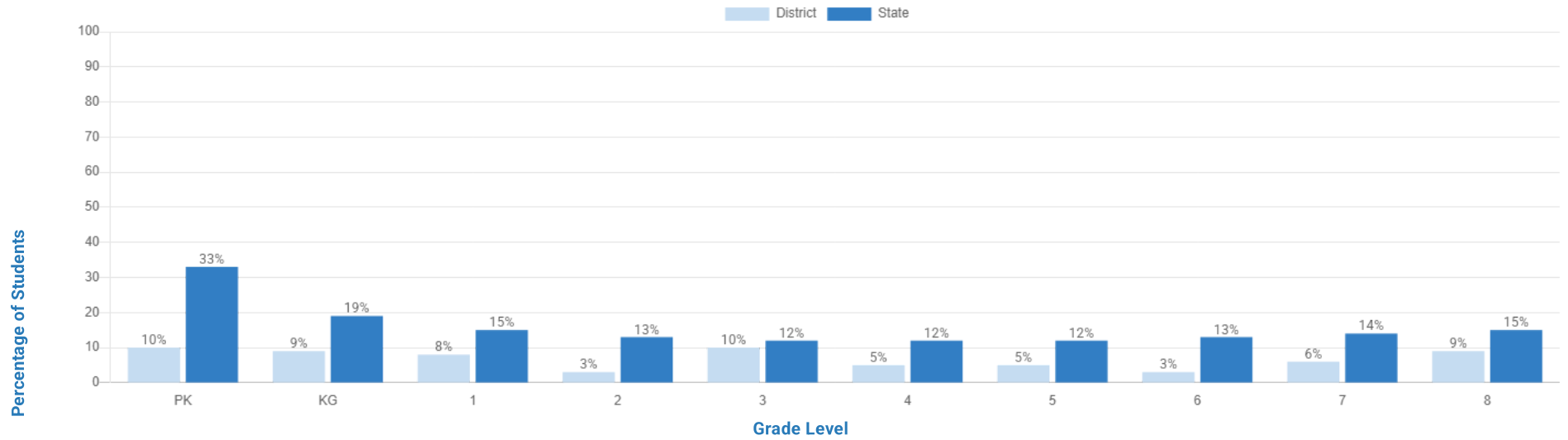

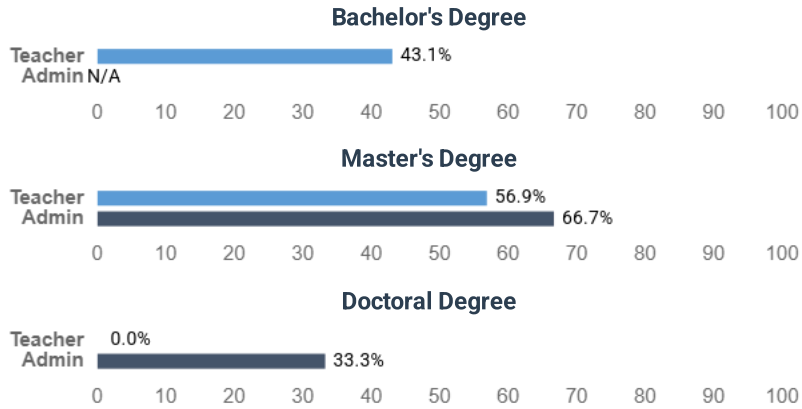

Mission, Vision, Theme:

The Oceanport School District will support students' growth along their educational journey and maximize their academic achievement. Our educational community will work collaboratively to provide an innovative, nurturing, and safe environment with opportunities for ALL learners. Our vision for the Oceanport School District, in collaboration with all stakeholders, is to yield critical thinkers who are resilient leaders of a global society.



Before and After School Programs:

The School-Age Child Care (SACC) program is delivered on-site via Champions Child Care (a division of Kinder-Care). Champions Child Care offers before and aftercare for students from Grades K-5. The Champions morning program begins at 7 a.m. and the aftercare program runs until 6 p.m.



Staff and Professional Learning:

Oceanport's staff of highly qualified teachers continue to grow professionally through both in-district and out-of-district/virtual professional development and through workshops and conferences. We also have an Instructional Coach on staff that provides embedded professional development district-wide. The district also has outside consultants to support initiatives in the district. A special education consultant has been working with the Oceanport staff to support Specially Designed Instruction (SDI) and research-based practices as it pertains to inclusive programming. A literacy consultant has been supporting the implementation of the workshop model at the middle school.

Student Supports and Services:

Each school has an Intervention and Referral Service (I&RS) committee. Identified students qualify and receive targeted intervention instruction and English Language Learner (ELL) programs. Students may also receive accommodations and/or modifications required by the ADA through a 504 Plan. Students who are referred to the Child Study Team may be evaluated to determine eligibility for Special Education services. Students who are found eligible for Special Education and related services are provided with an appropriate array of programs, as per their Individualized Education Program (IEP). Speech, occupational therapy, behavioral services, and physical therapy are also available. Additionally, therapeutic services are accessible to all students through school guidance staff.



Parent and Community Involvement:

The schools are an extension of the community in Oceanport, and include various stakeholders in the educational and decision-making process. An active PTO sponsors multiple activities for students including book fairs and assemblies. The PTO also raises money to fund teacher grant programs that benefit students in all classrooms. The district has an active Special Education Parent Group entitled, "Advocates for Diverse Learners." This parent-led group offers support to parents of diverse learners as well as articulates systemic concerns to district-level administration. The goal is to improve the overall quality of special education district-wide. The district continues to work collaboratively to work on the action steps outlined in the three- to five-year goals in the Strategic Plan. These goals were based on data, both qualitative and quantitative. In addition, the "Charging Ahead" motto continues to be embedded in all communications and events throughout the district.



Facilities:

In 2019, the community voted to approve a 33M dollar referendum to completely update the two sites that make up the Oceanport Public Schools. Projects are expected to be completed in the Summer 2024.

School Safety:

The district employs a School Security Specialist who oversees all drills, security procedures and protocols, and works directly with our Class III Officer and the School Resource Officer (SRO) from the Oceanport Police Department.



Technology and STEM:

Oceanport is a "1:1 district" where all of our students have and use a school-issued Chromebook. The devices are regularly used through center-based activities, enhancing student learning in the content areas, and making experiences fun and engaging for students. Additionally, all classrooms are outfitted with SMART projectors to provide interactive technology opportunities to be embedded in daily instruction. The district offers STEAM courses at both the elementary and middle school levels. All students engage in coding, robotics, and the engineering design process while developing an understanding of how technology is used and how it impacts the world.



Early Childhood Education:

Oceanport offered a tuition-based preschool program for children ages 3 and 4 until January 2024 when the district received the PEA funding from the state. The district then opened two new additional classrooms and provided free preschool services to 50+ Oceanport and Sea Bright residents. The program follows the highly acclaimed and research-based "HighScope" curriculum to prepare students for successful entry into Kindergarten. In addition to the integrated preschool class, Oceanport also offers a preschool disabled classroom for those students found eligible.

Oceanport actively addresses student attendance by sending tiered intervention letters to parents. These letters, which highlight absences and tardies, are first sent home after five days and continue monthly. Each update includes the current count of absences and/or tardies, along with a clearly outlined intervention strategy.
