



Staff



The district encore team will focus on the development of performance based activities and assessments that incorporate STEAM skills.

ELA-We are in year 8 of the English Language Arts initiative. After focusing professional development on reading and writing workshop. During these staff development days teachers analyze student data and work with students across the grade level as they practice new methods of instruction. Math - We are in year 7 of working with our district math consultant. Professional development covers many areas of instructional practices based on needs assessments that take place on a yearly basis. Leadership-30 teachers and 7 administrators participate in a job embedded teacher leadership program. This institute is developmentally intentional as it incorporates adult learning theory, learning-oriented leadership, professional book clubs, and best practices in professional development to support the leadership capacity of informal teacher. STEAM/Science - week long training at the Science Institute learning components.



Student Supports and Services:

Our Schools provide students with support through a multi-tiered system. Younger students are screened for language skills in order to provide appropriate intervention. Students with reading difficulties are served by a Dyslexia Indicators Evaluation Process. Services can include: Leveled Literacy Intervention (LLI) that addresses reading comprehension skills, Wilson Language Training (i.e., Wilson Reading System, Fundations, Just Words) for student's phonological skills, small group math basic skills, and the Linda-Mood Bell evidenced-based programs. Students with IEPs are served through inclass resource settings, special class programs (MD/LLD), and/or pull-out resource replacement. Available school-based therapies: Speech-Language, Occupational, Physical, and Social Skills. The District has a Board Certified Behavior Analyst and each building has a school psychologist and counselor to support students' needs.



Is a Climate Survey Used: Yes; Who is surveyed: Students, Parents, Administrators, Teachers. The Florham Park School District administers a Climate and Culture survey once a year. Each school has a Climate and Culture Committee that reviews the information, reports out to staff the results, and creates action plans to address the areas of need. The district provided two district wide Climate and Culture meetings.
