
















English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 







Students enrolled in one or more classes by discipline:







Students enrolled in one or more classes by discipline:









School Safety:

Rockaway Borough is very proud of its safety initiatives in both school buildings, especially in regard to our collaboration and coordination with local first responders. Our Emergency Management Plan is updated yearly and dictates our practices, procedures and responses pertaining to monthly security drills and protocols. There are security cameras in both buildings along with the outside campus with access to administration as well as the local police through streaming video. To respond to building intruders, the entire staff as well as students have been trained in the A.L.I.C.E. protocol by the Rockaway Borough Police. Starting in 2018-19, the district has also acquired the services of a Class III officer and installed a computerized identification system to screen and monitor school visitors. In the 2022-2023 school an additional Class III Officer was hired, to have one stationed in each school building.

Other Information:

ESSER funding has been instrumental from school year 2021-2022 through 2023-2024. years. Learning loss was addressed with additional targeted intervention programs before school, during school, and after school. Additional Chromebooks were ordered to complete a district wide one-to-one initiative for PreK-8. Professional development has been provided on various topics, including, but not limited to: literacy, mathematics, mental health, NJTSS, safety & security, special education, and other relevant areas. Cleaning equipment and supplies were purchased, and rooms and offices were given hepa-air purifiers. Additionally, the electric was upgraded and all rooms/offices were outfitted with window unit air-conditioners.
