














English Language Arts and Mathematics Performance Trends











Students enrolled in one or more classes by discipline:







Students enrolled in one or more classes by discipline:









Courses, Curriculum, Instruction:

The school prides itself on its rigorous, comprehensive instructional program driven by the New Jersey Student Learning Standards, Next Generation Science Standards and Habits of the Mind interpersonal skills.



Before and After School Programs:

Our school day begins at 7:30 am. A survey concluded that before school care was not needed. An after school program, paid for by parents, is available for students grades K-5. The program included homework help, student provided snack time and various entertaining activities through the YMCA Y-Kids Program and consists of approximately 25 students PK-5th grade.



Staff and Professional Learning:

Teachers are engaged in a multi-tiered professional development program that encourages continued professional growth through in-district training opportunities by school specialists or outside presenters, outside workshop opportunities through ETTC/Stockton, and job embedded collective learning opportunities through PLC team meetings. The goal is to build the capacity of all instructional staff by supporting and fostering sustained professional growth in equitable practices in education. Teachers have common planning times to share their expertise to ensure data driven practices that accelerate learning and coordinate targeted interventions for all levels of students.

Student Supports and Services:

We work collaboratively with neighboring districts to provide services for ML students and special education/related services. Shared contracts allow us to provide services and be fiscally responsible. We have a continuum of services ranging from pre-referral committees such as Multi-Tier Systems of Support, interventions in general education as well as full services for special needs students. All services are based on the individual needs of our students and provided in a fully inclusive school setting.



Student Health and Wellness:

Students participate in 150 minutes of Physical Education and Health each week. Recess is provided twenty minutes daily for 3-6th grade and thirty minutes daily for PK-2nd grade. Breakfast and lunch are served daily. Student Health and Wellness is also supported by the Move This World Curriculum. Move This World is a PK-6th grade social and emotional learning curriculum developed around the SEL standards. Teachers facilitate daily lessons focused on one of the standards. Mindfulness cards are used throughout the day to promote calming techniques. There are also several lessons on bullying prevention with particular attention given to problem solving and healthy relationships.



Parent and Community Involvement:

The strength of this district lies in a resourceful and responsive staff that works in partnership with students, parents, and community organizations, including an active PTA, to meet the needs of all of our children to create a 21st century environment of learning that promotes inspiration, motivation, exploration, and innovation. Our mission statement supports this sense of ownership and a collective responsibility to student growth. Our district is currently paving the way for the future through a strategic planning initiative.

Our computer lab contains state of the art equipment which includes 3D printers and other graphic design products.
