














English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 







Students enrolled in one or more classes by discipline:







Students enrolled in one or more classes by discipline:









Courses, Curriculum, Instruction:

Lavallette Elementary School implements a 1:1 device program, with students in grades 5-8 taking home technology to support at home learning. The district invests in a comprehensive bank of instructional technology platforms that enhance the curriculum and provide deeper classroom instruction. Digital formative assessments allow teachers to benchmark student learning at three critical times during the school year, and to use real-time data to inform instruction. Curriculum includes English Language Arts, Mathematics, Science, and Social Studies daily, as well as rotating special area courses in Art, Music/Band, Health, Physical Education, Technology, STEAM, and World Language (American Sign Language and Spanish). Teachers receive focused professional development designed to support high levels of student engagement and learning, including reading workshop model, effective co-teaching strategies, and brain-based math retention strategies.



Sports and Athletics:

Sports Offered: Baseball (Boys), Basketball (Boys & Girls), Soccer (Boys & Girls), Softball (Girls), Wrestling (Boys & Girls)

Lavallette Elementary School athletes compete in the Monmouth County Athletic league. The Lavallette Elementary School is a "walking" school district. No busing is provided therefore most students either ride a bicycle or walk to school. Students in grades PreK-8 recess daily in addition to weekly Health and Physical Education classes. Lavallette Elementary School is involved in numerous local and national programs related to health and fitness such as the Presidential Fitness Program, Hoops for Hearts and Play 60 NFL. Students participate in a variety of community-based walking trips and use the local environment, including the outdoor learning space, beach, and bay, for academic lessons. Highlighted weeks of wellness include Weeks of Respect and Anti-School Violence, as well as World Kindness Day. Students in Grades K-4 participate in daily Circle of Power and Respect SEL lessons, and students in Grades 5-8 participate in monthly SEL lessons with the school counselor as well as bullying-prevention and digital safety lessons.

School Safety:

Staff are trained on a regular basis on security drills and protocols to ensure the safety of all students. The school campus sits adjoined to the Lavallette Police Department, and the district employs a full time school counselor and school security officer. As per NJDOE guidelines, the district has an assigned school safety specialist.



Technology and STEM:

Lavallette Elementary School implements a 1:1 device initiative, with students in grades 5-8 taking home devices for at-home learning. Our state-of-the-art STEAM Lab is equipped with a hydroponics and aquaponics garden, 3D printers, a laser cutter, robotics, and more. Student learning is founded on the engineering design process, allowing students the safety of making mistakes and learning forward.



Attendance:

As outlined in New Jersey Statute 18A:38-25.1, if 10% or more of the students enrolled in a public school are chronically absent, the school shall develop and present a Corrective Action Plan (CAP) to their local Board of Education. The district's CAP articulates a goal of reducing chronic absenteeism from 20.9% in the 2022-23 school year to no more than 10% in the upcoming school year and beyond, using evidence-based practices, action, and activities to improve and maintain regular school attendance.
