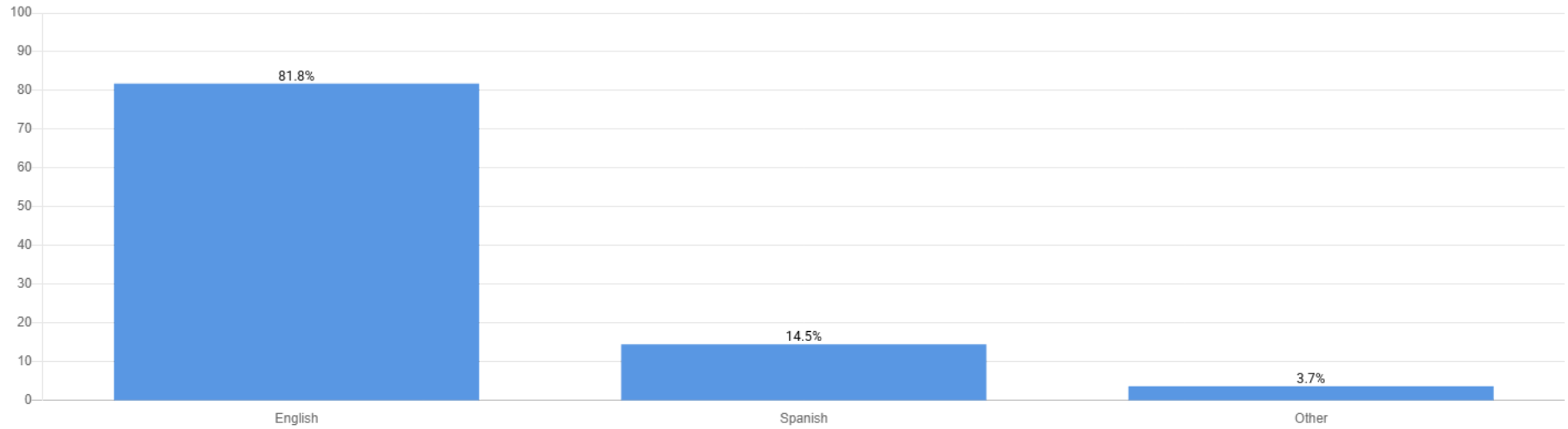

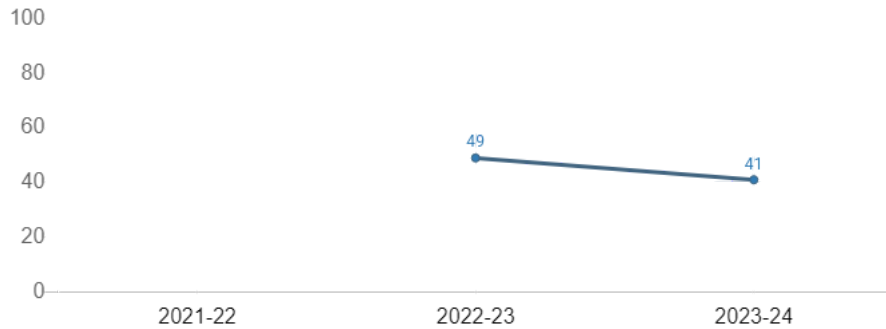

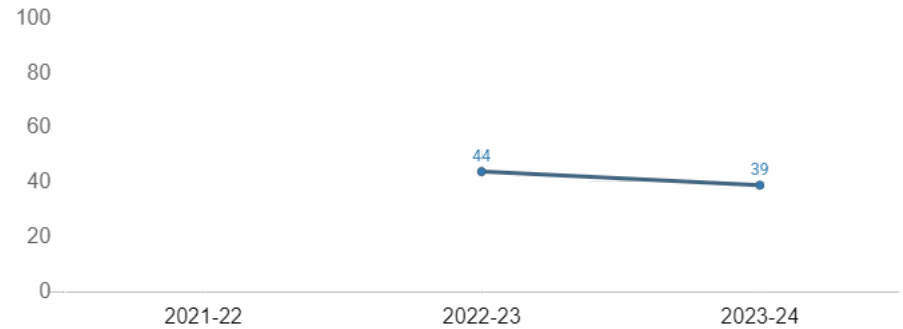

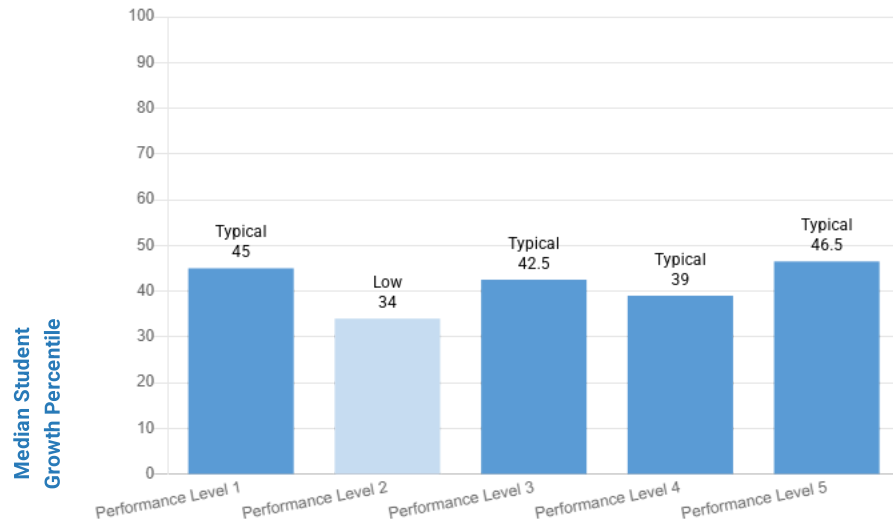

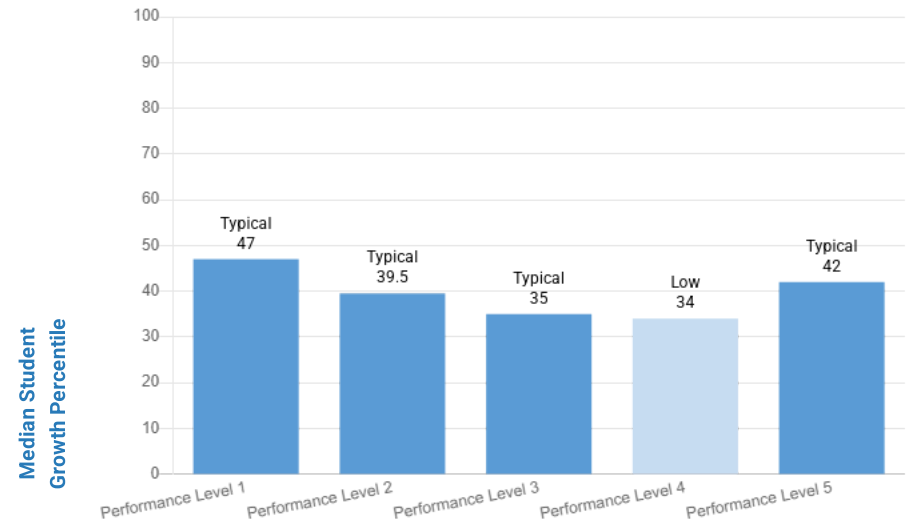

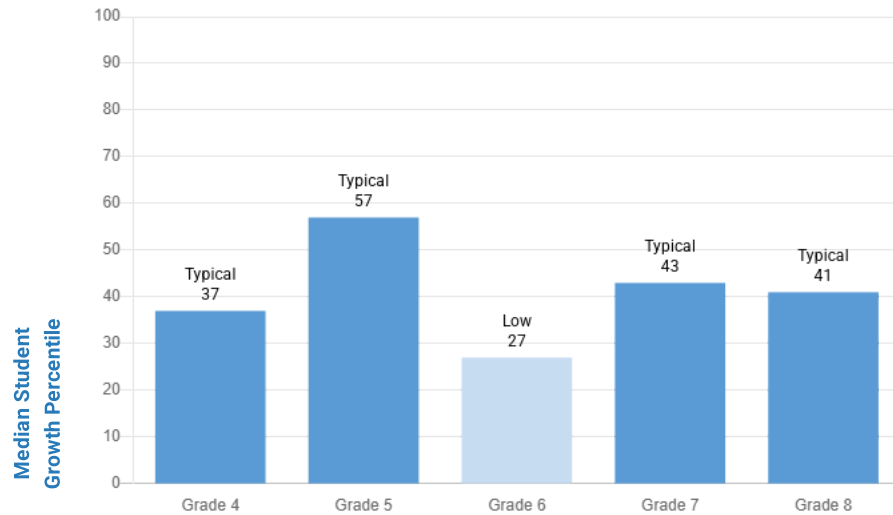

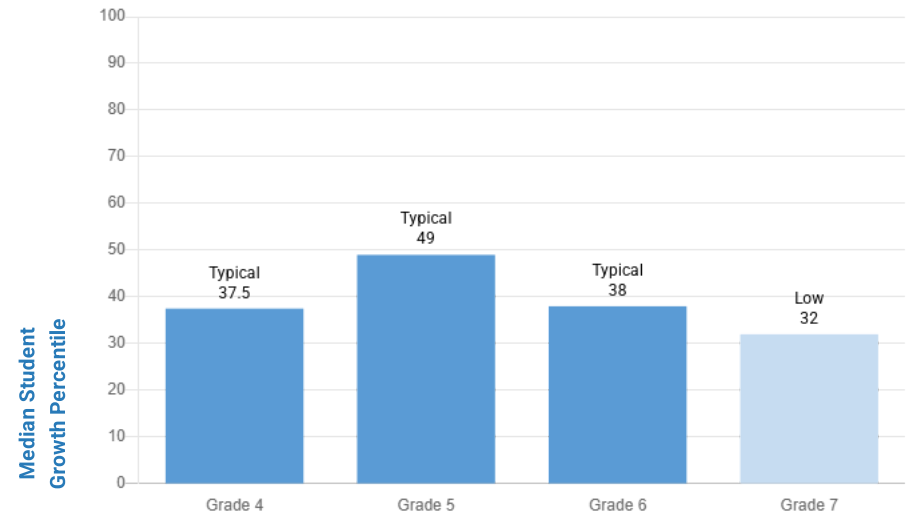

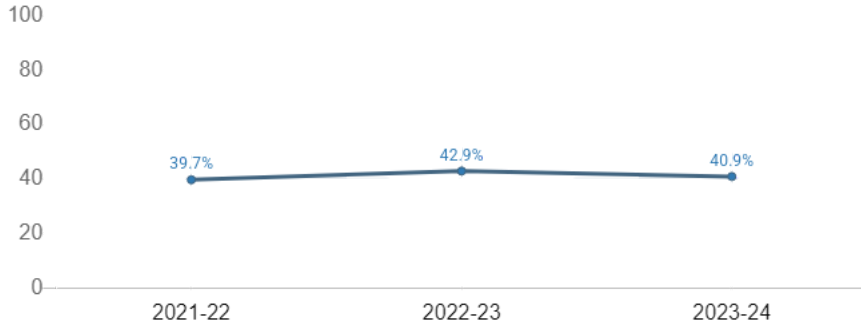

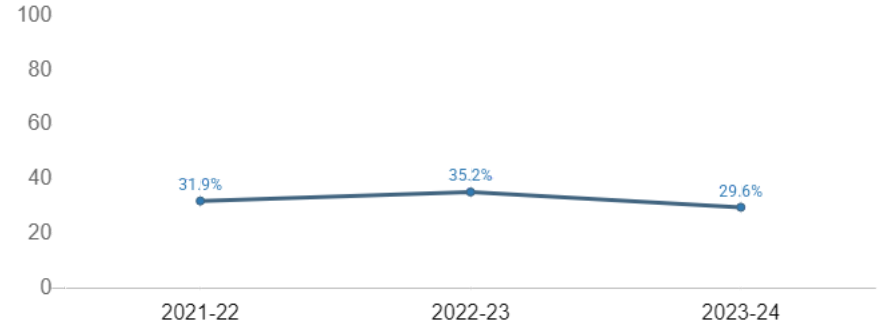
English Language Arts and Mathematics Performance Trends

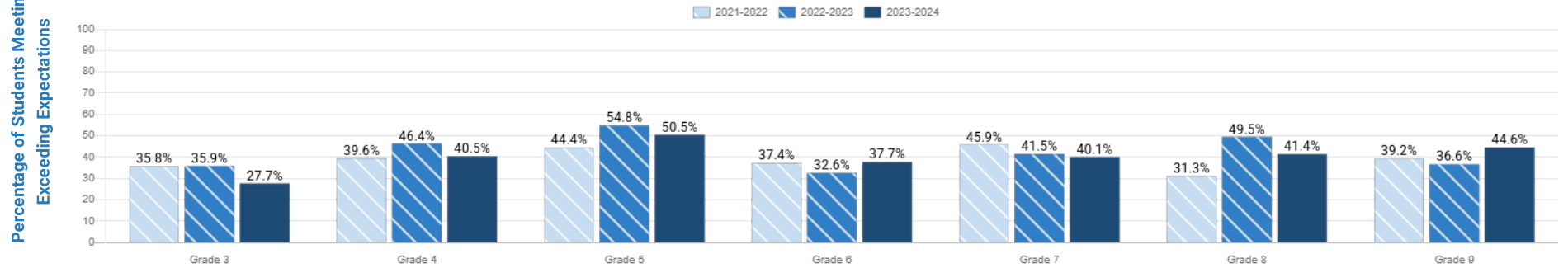

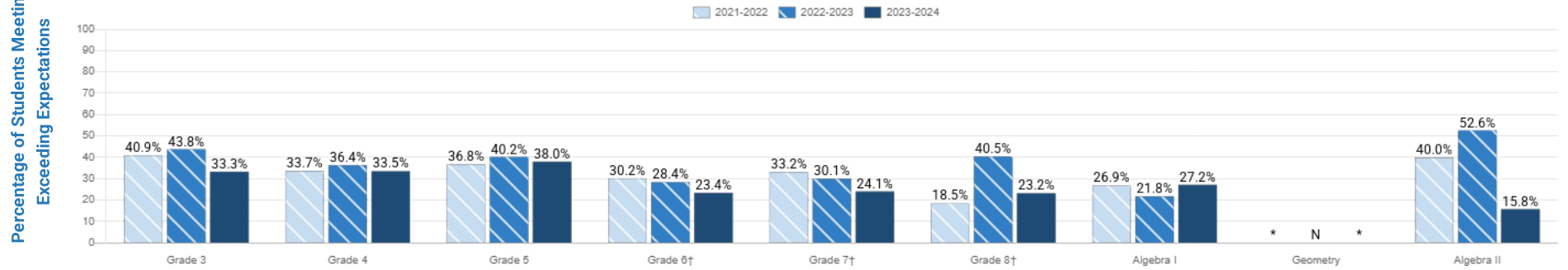

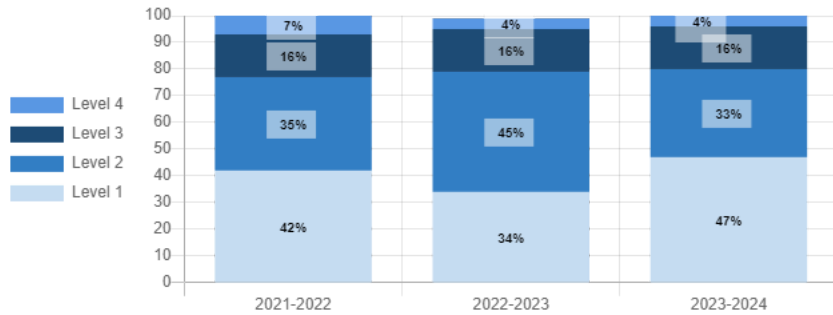

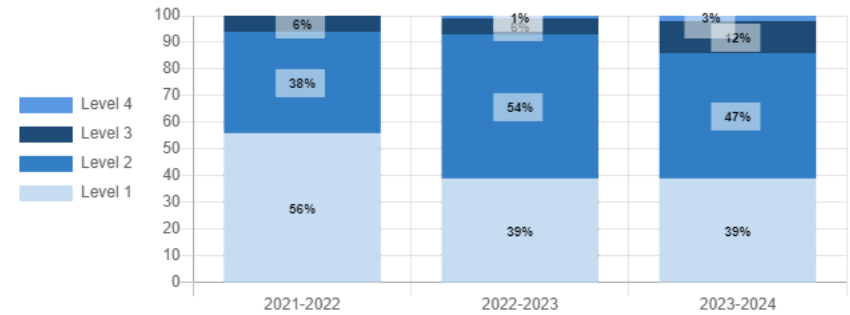
NJSLA Science Assessment: Grade 5 Summary

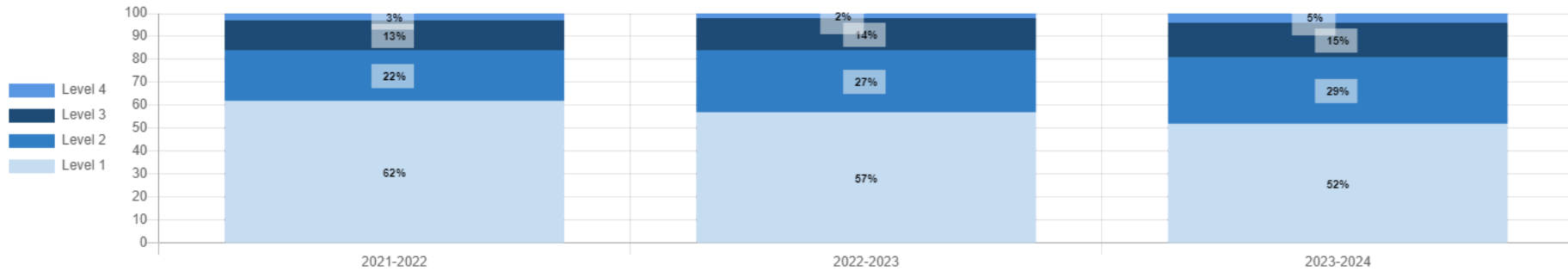

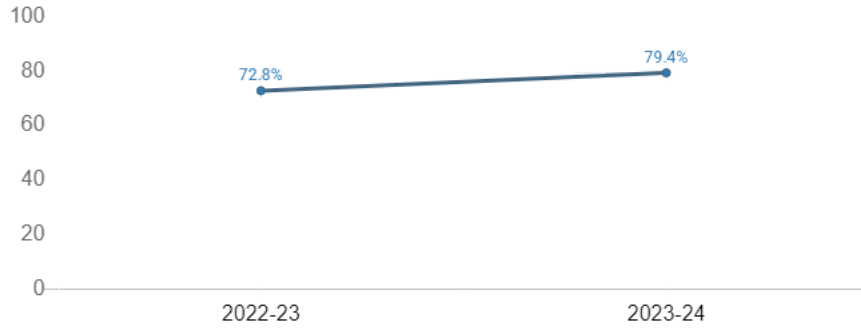

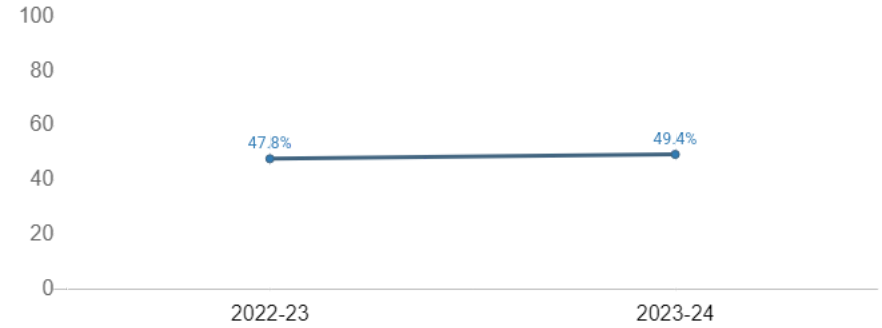

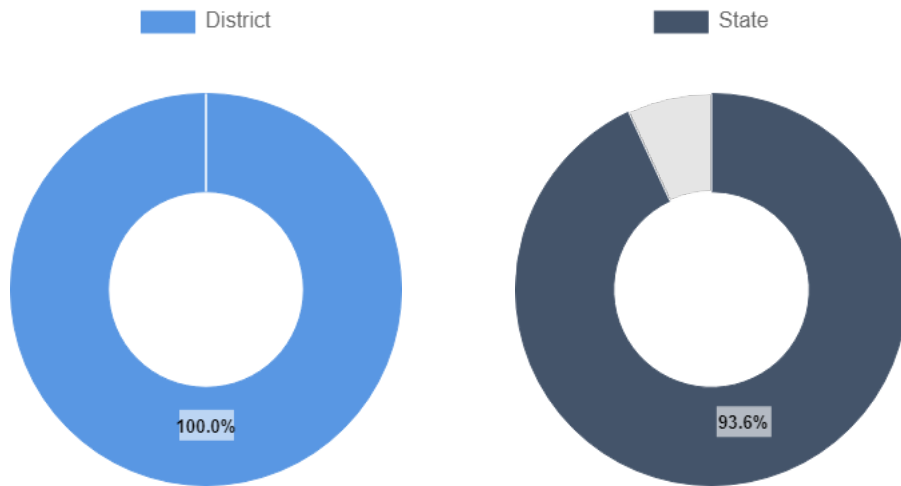

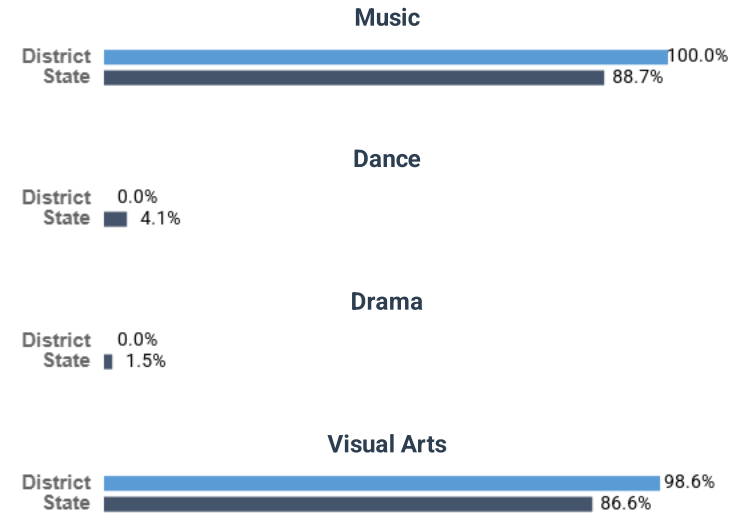

Students enrolled in one or more classes by discipline:



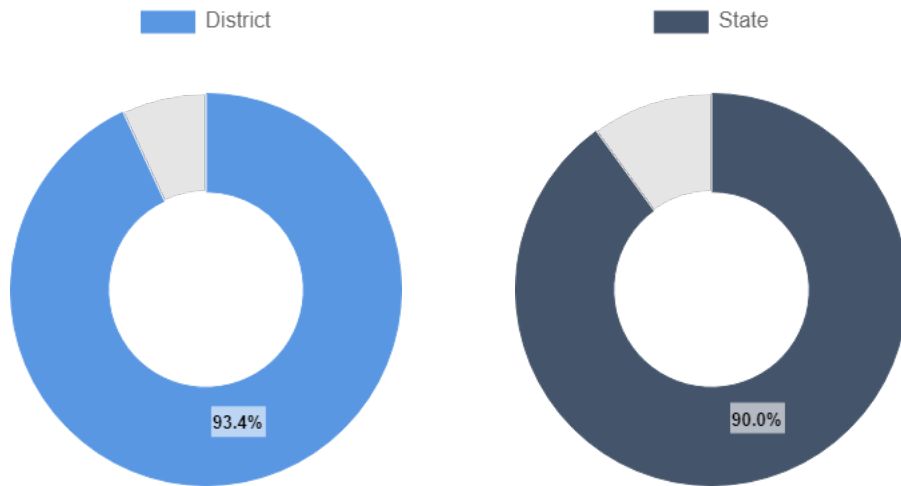

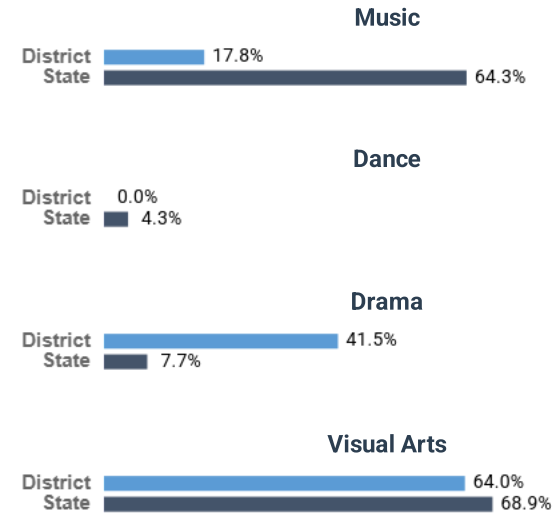

Students enrolled in one or more classes by discipline:



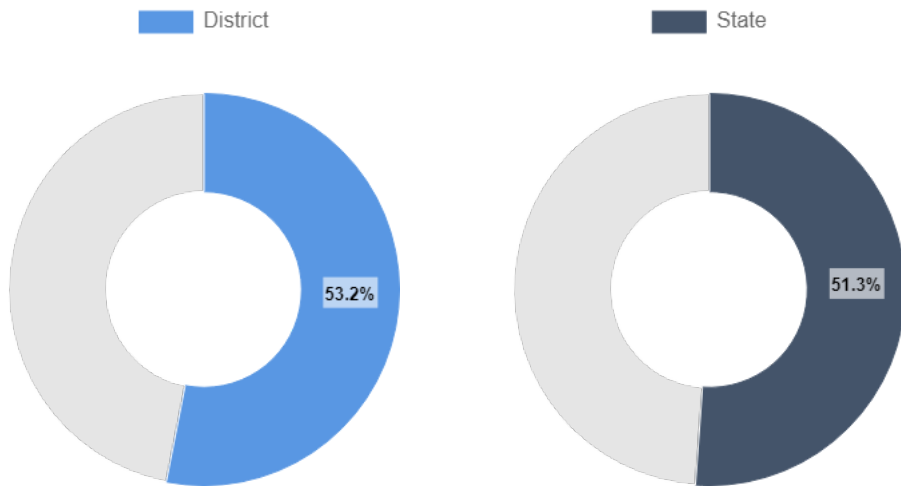

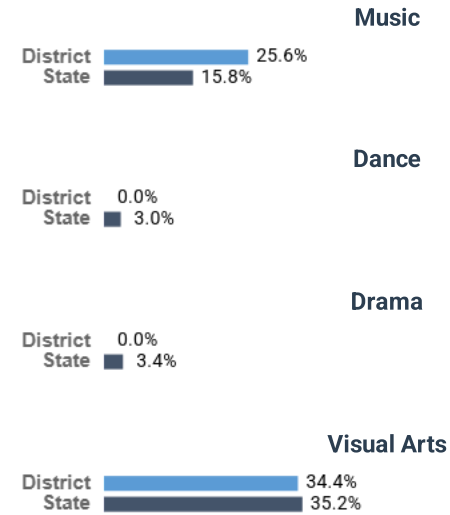

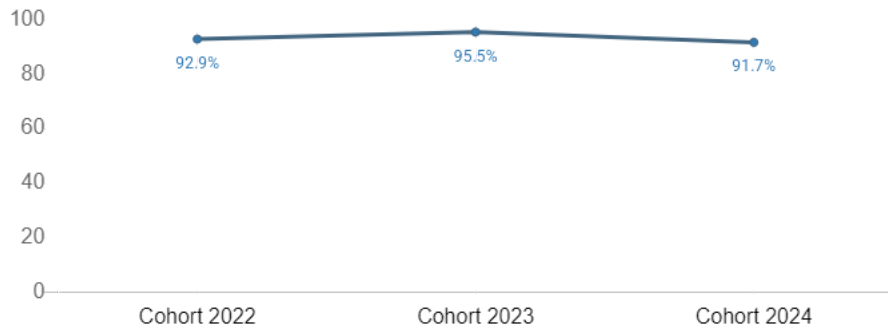

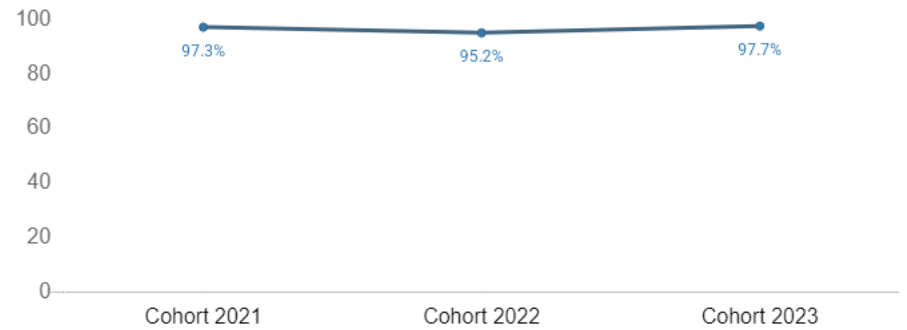

Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

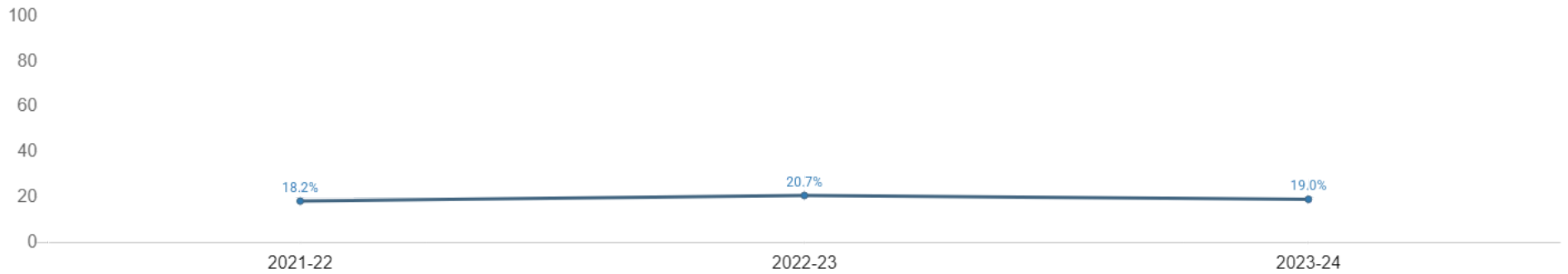

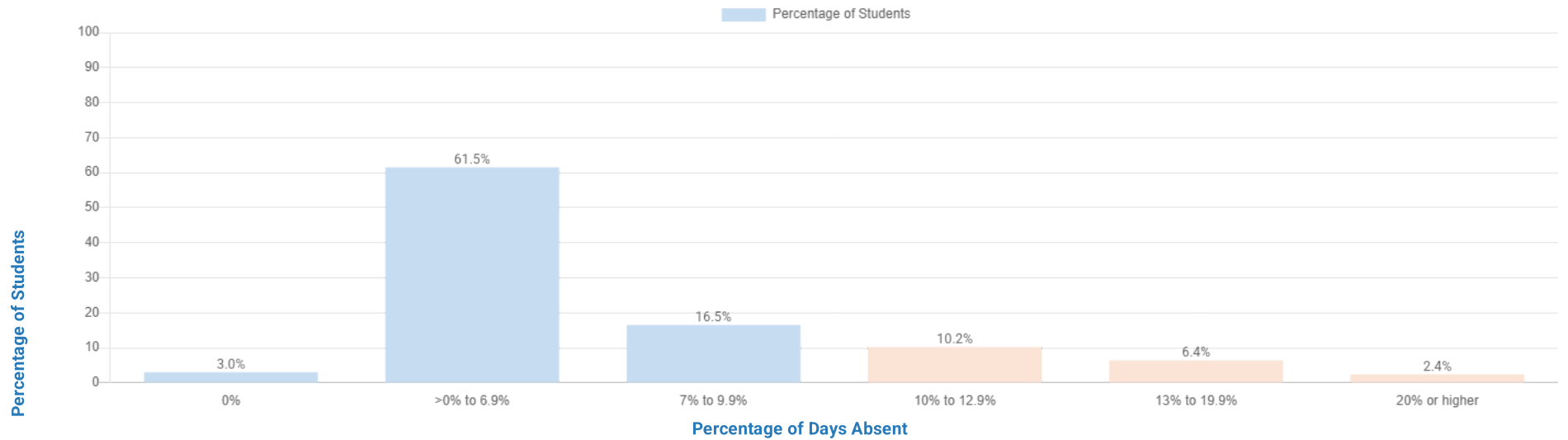

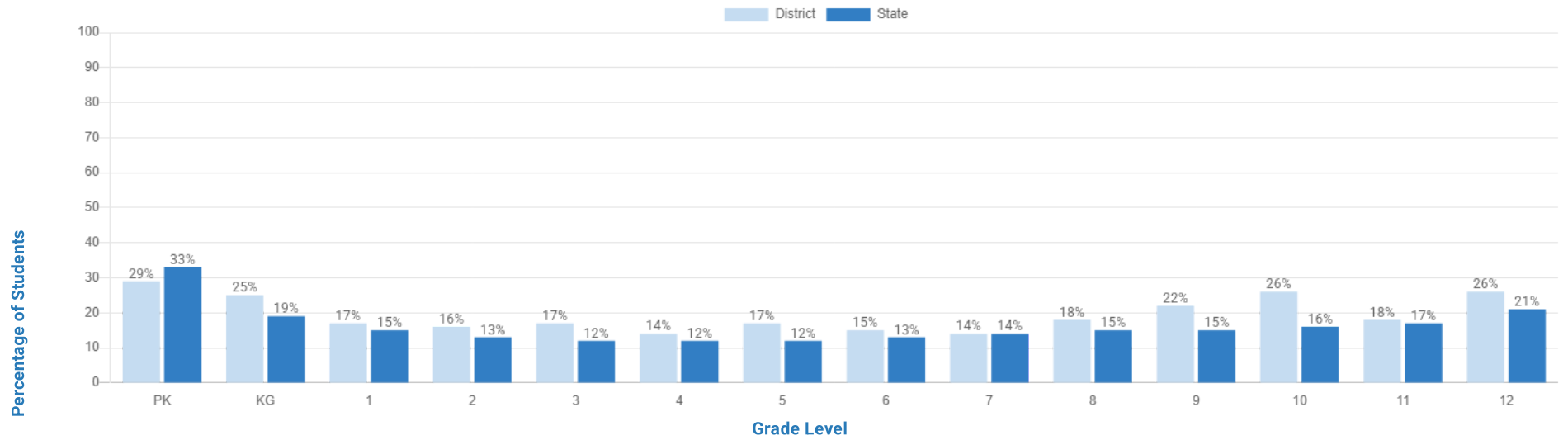

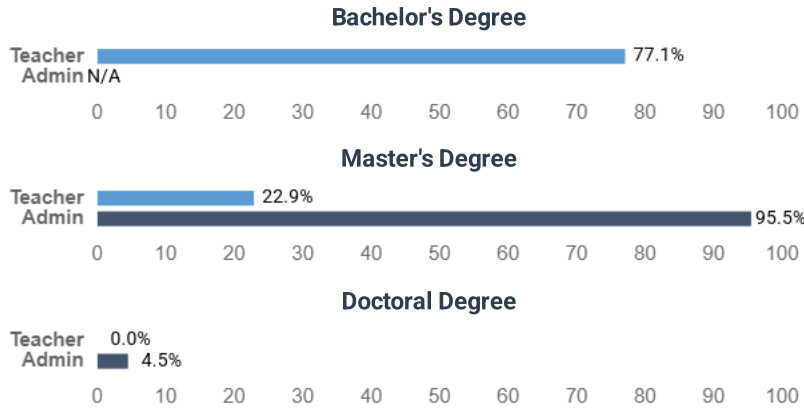

Our excellence in instruction has been recognized as multiple teachers have been named Ocean County's Teacher of the Year. A District staff was presented with The College Board AP Computer Science Female Diversity Award. Manchester Township was named to the AP National Honor Roll.



Courses, Curriculum, Instruction:

We are pleased to collaborate with the Manchester Township Police Department to implement the Interactive High School Opiate Awareness Program, #NotEvenOnce, to inform students about the dangers of opiates before they leave for college or enter the work force. The ultimate goal is to educate students about opiate abuse and provide them with tools they need to make better decisions. Students at the high school have opportunities to participate in a variety of high-level and special-interest courses, including specialized pathways and academies. We continue to expand our dual-enrollment opportunities with higher-education partners around the county and state. Students that demonstrate proficiency in two or more languages have the ability to earn the NJ DOE Seal of Biliteracy. At the middle school STEM opportunities continue to be a major focus, including genius hour. The roll out of our preschool program continues to be a success.

In addition to all the clubs and sports programs, the students in the Manchester Township School District volunteer and participate year round in numerous programs to give back to the community. Events held raise money for the American Heart Association, food and holiday help for needy families. We have also offered SEL family nights.



Before and After School Programs:

The Ocean County YMCA will operate the Y-Kids Program for preschool through eighth grade students at the Whiting, Ridgeway and Manchester Township Elementary Schools and the Manchester Township Middle School. Their program includes increased hours for parents with a starting time as early as 6:30 a.m. The Y-Kids Program also includes homework time, structured free play, a Book Club and nutrition program that provides a healthy breakfast before school and a healthy snack after school.



Staff and Professional Learning:

Our PK-12 staff are highly-trained and receive comprehensive professional development program to focus on student-centered learning and differentiated instruction to meet the needs of all students. Professional Development is conducted district-wide for staff throughout the year using workshops, in-services and Professional Learning Communities. A staff needs assessment was conducted and as a result, social emotional student and staff training, and the use of data to inform instruction was included in this years PD. Staff were also provided an opportunity to participate in sensitivity training, Sheltered Instruction, and explore a culturally responsive classroom. Professional Development is critical for our staff to enhance educator effectiveness and to assist our teachers as they strive to improve student performance and achievement. All new staff members were trained in TESA (Teacher Expectations & Student Achievement), a diversity, equity, and inclusivity training.

Parents and community members are encouraged to play an active part in the Manchester Township School District. They receive district information through our website, Facebook page, the television channel, Twitter and our newsletter. Parents receive information on student progress through an online parent portal and Google Classrooms. We reach out to our senior communities through various school clubs and activities. Many of our senior citizens volunteer to mentor our students. Our students and staff also support programs such as Helping Hands for Hunger and Kevin's Kids, which are programs that assist needy families during the holidays.



Facilities:

Our district serves 3,000 students and is comprised of three elementary schools, a middle school and a high school. We also operate the Regional Day School in Jackson, a school for students with special needs.



School Safety:

Safety continues to be a priority in all of our schools. A new phone system has been installed in classrooms and offices throughout the District. The District continues to expand our video surveillance capabilities at all schools, as well. We continue to utilize the Share 911 communication system. This system allows for immediate and developing direct communication between staff, administrators, police and emergency responders. Additional training and review of all emergency drills is completed in cooperation with the Manchester Township Police Department. All of our schools have security vestibules, ballistic film, supervised entrances with approved access and video equipment. Additionally, all staff is trained in response procedures in the event of an emergency. Through the cooperation of the Manchester Police Department we have a SRO based in the High School and three Class III officers throughout the district in addition to two district-funded security guards.

Technology and STEM:

We continue to provide our students 1:1 Chromebooks in grades K-12, as well as equipping classrooms with interactive flat panels and projectors. Additionally, funds provided by our Education Foundation have been used to create mobile STEAM labs in each of our elementary schools. Professional development has been provided to staff to further expand the use of technology in the classroom. We have added an instructional technology coach to work with staff to provide support to elevate and enhance classroom instruction.



Early Childhood Education:

The Manchester Township School District offers a high quality early childhood program offered at no cost to residents of Manchester Township. We offer a full day preschool program for three and four year old children through the Preschool Expansion Aid (PEA) funding. All preschool classrooms utilize Creative Curriculum which focuses on the development of the whole child. The key components of Creative Curriculum entail using various strategies such as art, theatre, performing arts, field trips, guest lectures, observation and reflection, experiments, nature walks, and using multimedia.
