

















### NJSLA Science Assessment: Grade 5 Summary

















## Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.









The district's induction program and educator evaluation systems have established a standard of teaching excellence in our schools, which outside agencies and groups have frequently recognized. District staff members consistently earn recognitions such as New Jersey's Exemplary Educator Award, the W!se Gold Star Teacher Award, and the WRAT and WJRZ Teacher Who Rocks Award. Point Pleasant Borough High School was named to the Advanced Placement Program (AP) School Honor Roll, earning Bronze distinction. Our teachers are often selected to share their expertise with their peers at national conferences and symposiums, such as the AMTNJ, NJAMLE, AMLE, NJSBA, and NJPSA Conferences. These achievements are a testament to the quality of our educators.

The Boys Cross Country team finished with a 7-0 record, claiming the B-South title and winning the Central Jersey Group II State Championship. Coach Decker was also the Shore Track Coaches Association Coach of the Year. Girls Cross Country won the B-South Division with a 7-0 record. Field Hockey had a record of 21-2, claimed the A-South Divisional title, became Shore Conference Champions, and won the South Jersey Group II State Sectional. Also, Coach Carr earned the NFHS Field Hockey Coach of the Year award and was the APP All-Shore Coach of the Year. The Football team won the Colonial Division Championship with a 9-2 record. Girls Soccer had a 13-2-2 record and won the B-South Division title. Girls Indoor Track became the Ocean County Relay Champions. Girls Spring Track won B-South and became Ocean County Champions. The Softball team won the B-South Public School Division title and became Ocean County Tournament Champions. The Baseball team became B-South Divisional Champions.



### Clubs and Activities:

Point Pleasant Borough High School students can join 32 diverse clubs; many are involved in more than one. Student Council is a highly active group that promotes community service, holding annual blood and food drives to help our community. We also have competitive clubs such as Forensics, Quiz Bowl, Competition Band, and Chorus groups. These clubs have earned many impressive accolades, which shows how involved and talented our students are. Memorial Middle School also offers clubs through their generous PTO, such as STEM, cardio, newspaper, photography, cooking, and trivia. All middle school students are eligible to join. At the elementary level, we support chorus and band programs as well as Think Tank and Voyager. We are proud to be able to offer these co- and extra-curricular activities to our students.



### Before and After School Programs:

At the elementary level, we offer Voyager & Think Tank enrichment classes managed by our elementary staff. These programs are centered on curriculum acceleration, mastery of content, strengthening higher-level thinking skills, and developing interactive relationships. These programs also aim to facilitate the optimal development of each student's intellectual and creative talents. The Panther Academic Workshop (P.A.W.) Program is an after-school program for our middle school students offered through Title I funds. Our middle school staff coordinates this program, which is geared to support learners in grades 6-8. For the 2023-2024 school year, the District offered before and after-school tutoring district-wide to help students who were determined to be in need of additional support.

### Staff and Professional Learning:

The Point Pleasant Borough School District incorporates a comprehensive Teacher Induction Program for new staff members. Teachers review effective instructional practices, technology applications, and peer observations in these monthly professional development sessions. Though the induction workshops focus on supporting new staff members, tenured staff members are welcome to attend and are encouraged to present new learning techniques. All our staff members have opportunities to attend workshops both in- and out-of-district. We have had multiple teachers present at state and national conferences. Our professional development focused on the key areas of Mindfulness and Mental Health, Mathematics, Literacy, Science, and Inclusivity. Teachers have opportunities to plan together based on what they learned. All schools provide staff input through committees and surveys to help develop ongoing professional learning opportunities.



### Postsecondary Information:

91% of our graduating students attend a post-secondary institution, while the remaining students enlisted in the military or workforce. Students received post-secondary planning lessons and tools through school counseling sessions, college visits, and tools such as SCOIR. Students took career and college readiness exams, including the SAT, PSAT, Accuplacer, and Advanced Placement. We partnered with outside resources to provide students and families with information about College Pathways, financial aid, college application processes, career inventory tools, and dual enrollment. Students continue to enroll in AP and Dual Enrollment courses to earn college credit while in high school. We are proud to have our graduates accepted to institutions such as University of Massachusetts (Amherst), Purdue University, Penn State University, Pepperdine University, New York University, Culinary Institute of America, Fordham University, Boston University, and Embry-Riddle Aeronautical University.



### Student Supports and Services:

Our schools' Intervention and Referral Services committees work with grade-level counselors, team members, and parents to identify and support students struggling academically, behaviorally, or emotionally. Our Child Study Team consists of an LDTC, social worker, and psychologist to provide a complete, individual educational plan for children with special needs. Basic Skills & Study Skills classes provide learners with additional strategies & techniques to meet their learning goals. Our Panther Academic Workshop Program is an after-school homework support initiative that assists students needing additional help. Dedicated staff members are also here to support our population of Multilingual Learners. The District continues to provide counseling services through our partnerships with YMCA and NJ4S Compass tiered services. The initiatives create a comprehensive support system that positively impacts our students' lives.

### Student Health and Wellness:

As per our Wellness Policy, Point Pleasant Borough Schools promotes healthy living standards. While we encourage exercise and healthy eating, our students are also provided with mental health resources and are encouraged to reach out for assistance if needed. We strive to provide our students with the most current information and the best opportunities to lead an active, healthy lifestyle. As always, the district strives to provide a safe and healthy learning environment for all our school district community members.



### Parent and Community Involvement:

Each of our schools has a Parent Teacher Organization (PTO) and a district Special Education Parent Advisory Committee (SEPAC). These parent-led organizations help students tremendously with support and funding for class trips, grants, scholarships, and donations to school programs. We also have parent booster groups that help the extracurricular activities remain active and competitive. These groups also help to connect the community by holding events such as the Town-Wide Garage Sale and annual Craft Fairs. Additionally, the Pt. Pleasant Education Foundation for Excellence, a town-based group, assists the schools with donations and provides staff with grant opportunities. The Foundation also recognizes ten student leaders and the District's Teachers of the Year at their annual Hall of Fame celebration.



### Facilities:

The District completed multiple facilities projects in addition to annual maintenance projects. At the elementary schools, unit ventilators with air conditioning were replaced, and the controls and BMS system were updated. Sinks were installed in classrooms to support the upcoming Pre-K program. Additionally, new swings were added at Ocean Road School. Memorial Middle School's computer lab was renovated into a new STEAM lab, allowing for more hands-on, collaborative, and critical thinking opportunities for students. The High School's business labs received upgraded floors, new furniture, and a fresh coat of paint. Security blinds were added to classroom windows. All gyms had the floors refinished, and new serving lines were installed in the cafeterias. Athletic fields received annual maintenance, including the turf field being sanitized, decompressed, and GMAX tested. We continue to add security cameras throughout the District to help ensure the safety of students and staff.

### School Safety:

Our district takes several measures to ensure the safety of our students. There is a police officer stationed at each of our four schools. All school doors are locked during the school day, and visitors can only enter through the main office by appropriate staff. All staff members, substitutes, and visitors must wear an identifying, school-issued lanyard. Security cameras are located inside and outside the buildings, with emergency strobe lights on the outside. We use an instant alert system to send emails, phone calls, and/or text messages to notify parents/students of emergencies. Additionally, our school safety maps are shared with the local law enforcement agency to better protect our students and staff in a crisis. Finally, the District hired an 11-month District Security Officer who focuses relentlessly on the safety and security of our buildings, students, and staff.



### Technology and STEM:

The district has added several layers of protection for its students and network security. We implemented Beacon, part of our content filtering system, to help detect if a child searches, creates, views, or interacts with online content that could be related to the safety and security of the students and the schools. We added Go Guardian's Parent App, allowing parents and guardians to view their child's history, pause the internet, block specific websites, and schedule internet availability on their home network while using a district-issued laptop. The district implemented new network security standards, such as two-factor authentication for all staff, security scanning across the network infrastructure for positional vulnerabilities, a new firewall, and additional hardware to monitor and shape network traffic. To foster digital learning and collaboration, students in grades 6-12 received district-provided Chromebooks, and all K-5 classrooms received sets of Chromebooks.



### Early Childhood Education:

We offer two types of programs for preschool-aged children. There are three Preschool Disabled classes for children classified by the Child Study Team. These classes are provided by local funds and are two and one-half hours long. There is one general education class in which parents pay tuition. Students with disabilities are integrated into this class, which is two and one-half hours long.

The chronic absenteeism rate for Point Pleasant Borough Schools is below 10%, meaning the vast majority of our students are in attendance on a consistent basis. Research shows that chronic absenteeism is a significant contributing factor to low academic achievement, while regular attendance at school increases a child's chances of success in school and in life. Through School Climate Committee work, positive behavior supports, social-emotional learning, and ongoing engagement with families and the community, the District works to encourage regular attendance and make school a place that is supportive and welcoming.
