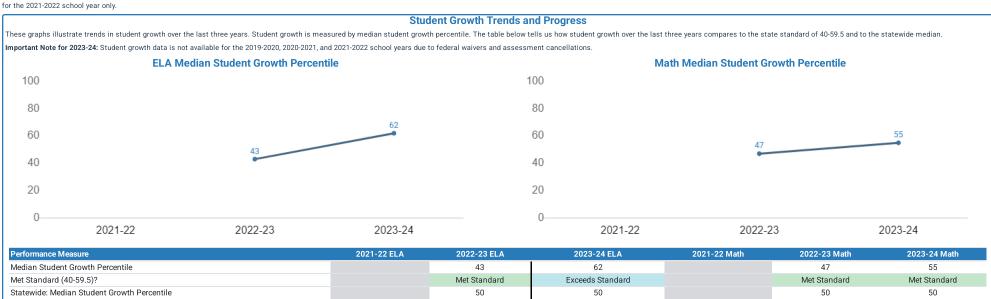

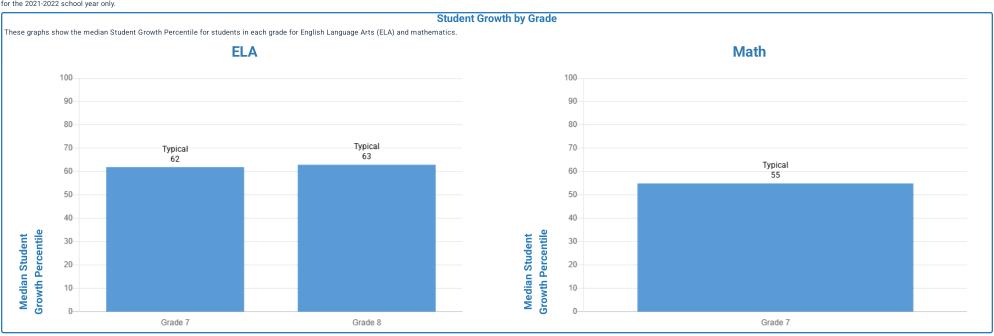

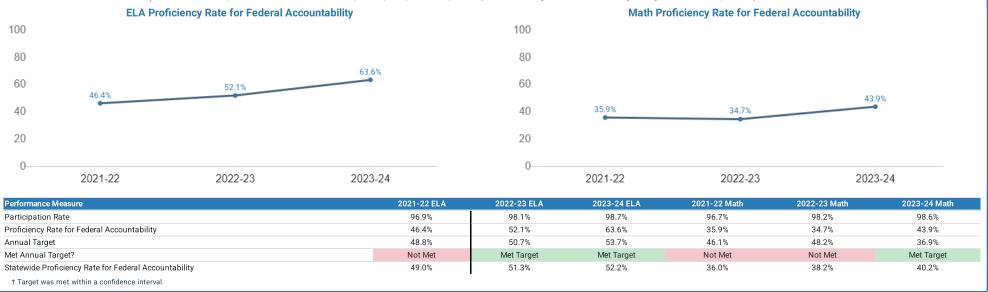

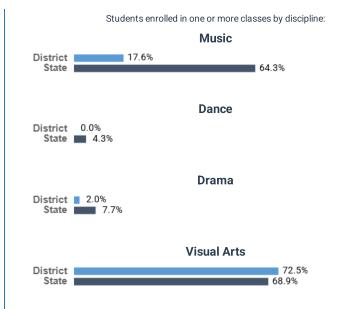

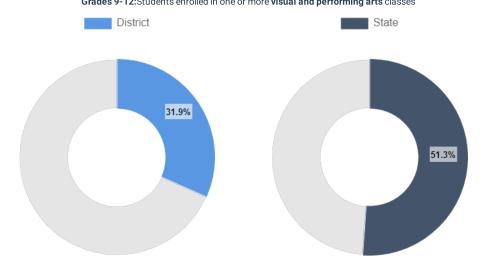

Graduation/Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Sertain scolleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Note for 2023-2024: Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.

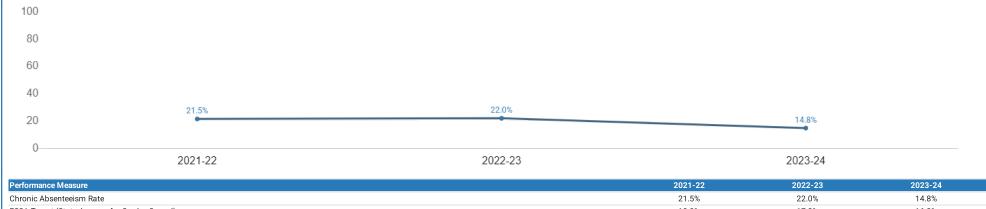

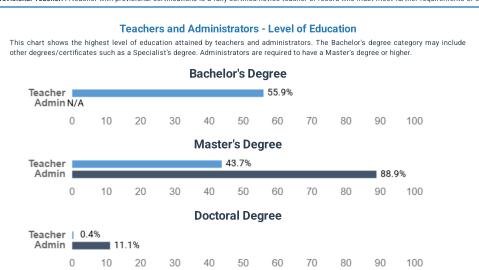

Students are offered a wide range of resources to prepare for their future. Guidance counselors monitor academic progress and guide students through the post-secondary planning process. Students utilize college and career software to assess individual aptitudes and interests, explore careers and manage the college application process. As an outcome Southern graduates attend many of the most prestigious universities in the country. Military Academy appointments are commonly awarded to members of the Senior Class and it is not uncommon for multiple appointments to be awarded. From the Class of 2024, 55% went on to a four-year college, 17% went on to a two-year college, 11% went on to a business/trade/technical school, 2% went into the military and 14% joined the full-time workforce.



Student Supports and Services:

The Southern Regional School District offers a multi-tiered system of supports for students in grades 7-12. A multidisciplinary team partners with families to develop an action plan to address students' learning, behavior and/or health needs. The action plan is monitored and modified to address the barriers to learning. This system is designed to coordinate resources to meet the individual needs of students and provide the necessary interventions to promote success.



The Southern Regional School District supports the health and wellness of students through curricular and extracurricular programs. All students complete a comprehensive health and physical education program. Students have access to nursing services to address their individual health needs. The District maintains medical records, offers physical exams, conducts health screenings and provides staff training to promote the health and wellness of our student population. Additionally, the District's two Mental Health Interventionists connect students and families in crisis with local support agencies and track the progress of students through the referral and placement process.

Parent and Community Involvement:

Parent and community involvement are lynchpins to the District's sustained success. Parents have various opportunities for formal involvement through a wide range of groups. Community involvement includes long established affiliations with the Rotary, Kiwanis, Lions, Southern Ocean Medical Center, Jetty, and the Causeway Family of Dealerships. A key indicator of the vibrancy of community involvement is the Local Scholarship Program which is made up of 344 local community donor groups that awarded 299 students from the Class of 2024 \$988,656 worth of scholarships.



The District consists of a middle school and a high school. The middle school contains grades seven and eight. The high school consists of grades nine through twelve. The high school is organized around the house concept; a 9-10 House and an 11-12 House. The Board of Education takes great pride in maintaining all of its buildings in the most pristine of conditions while also presenting 21 natural turf playing and practice fields that are envy of all those who visit



The Southern Regional School District has developed a comprehensive approach to improve student attendance. Faculty members foster a welcoming atmosphere by offering a variety of extracurricular activities that engage students beyond the school day. Administrators communicate clear attendance expectations during orientation and grade-level meetings at the start of the year. To ensure timely communication, automated phone calls notify parents when students are absent or late. Parents of students who miss 10% of school days receive monthly letters emphasizing the importance of regular attendance. Assistant principals and counselors work with chronically absent students to set attendance goals and monitor progress. Meetings with parents and students address barriers to attendance and develop improvement strategies. Additionally, students with poor attendance patterns may be paired with a faculty mentor to create individualized attendance improvement plans.
