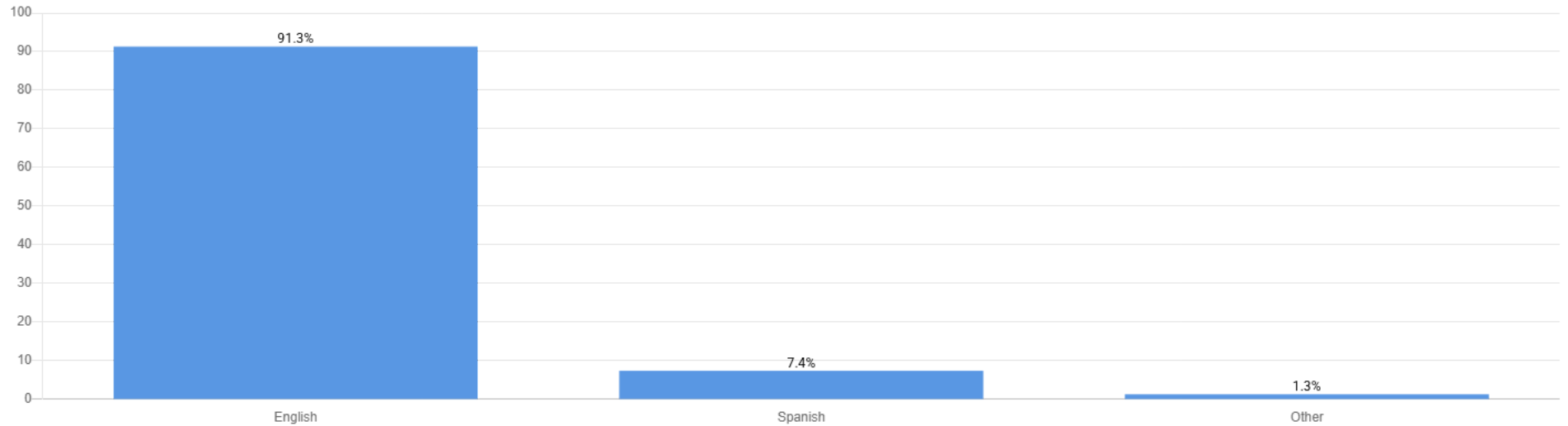

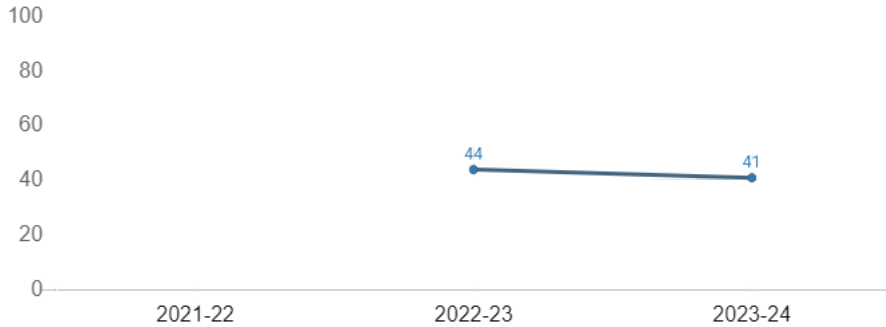

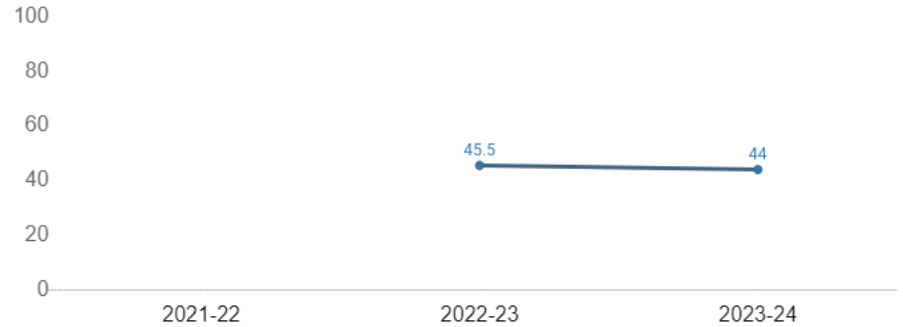

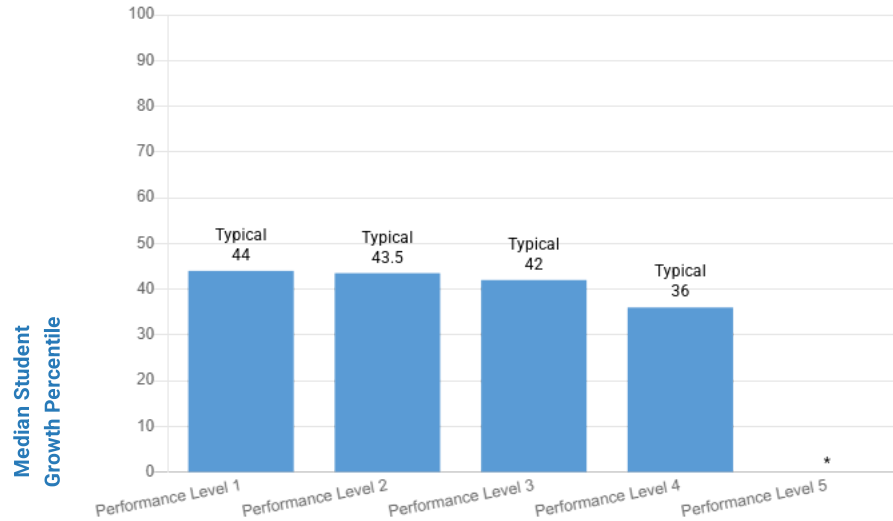

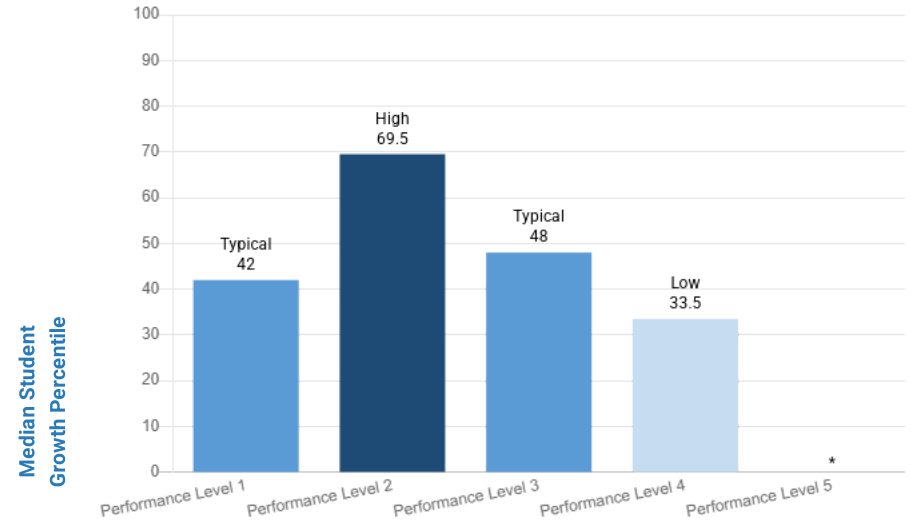

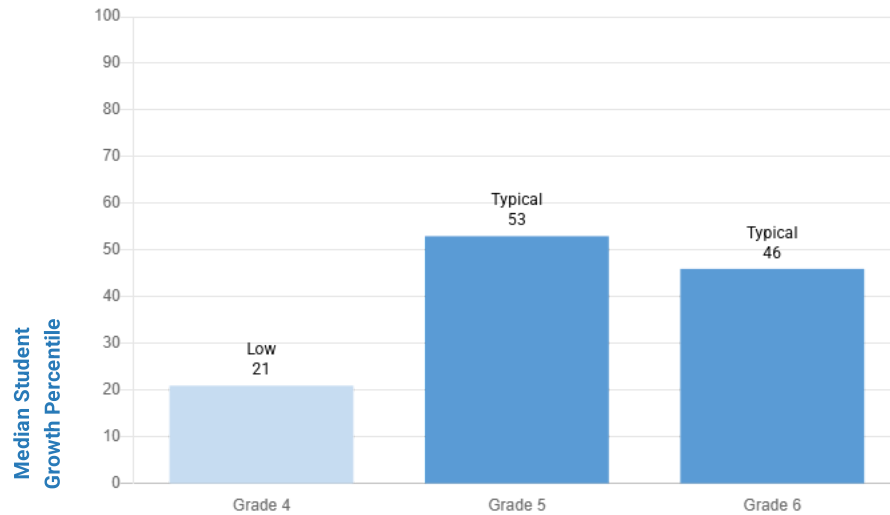

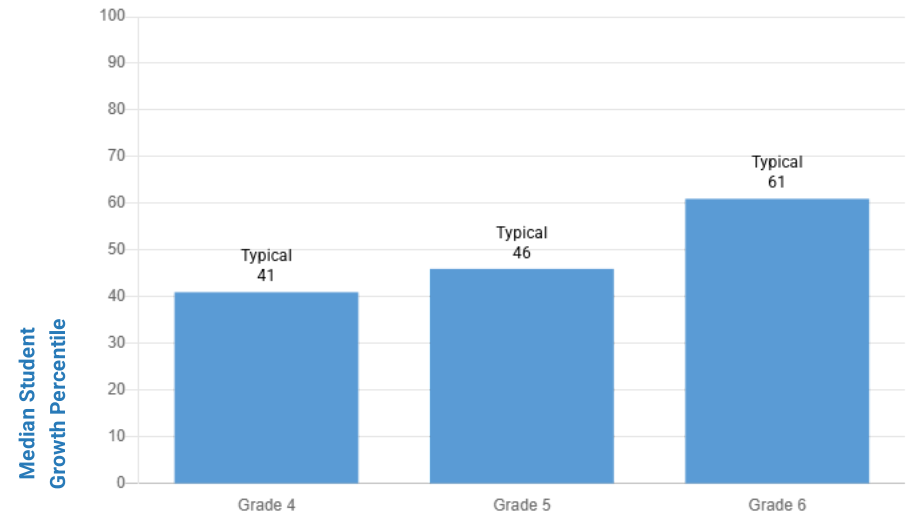

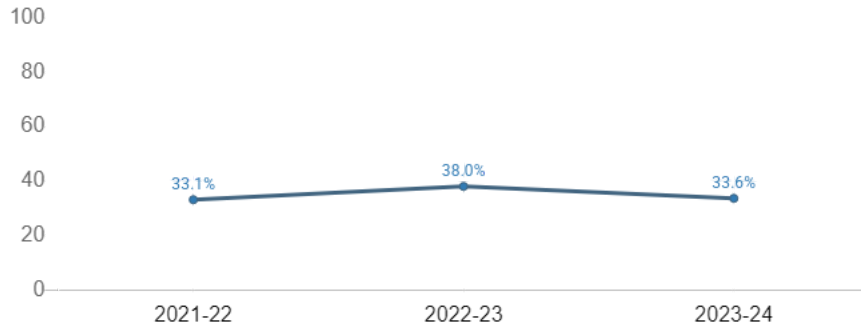

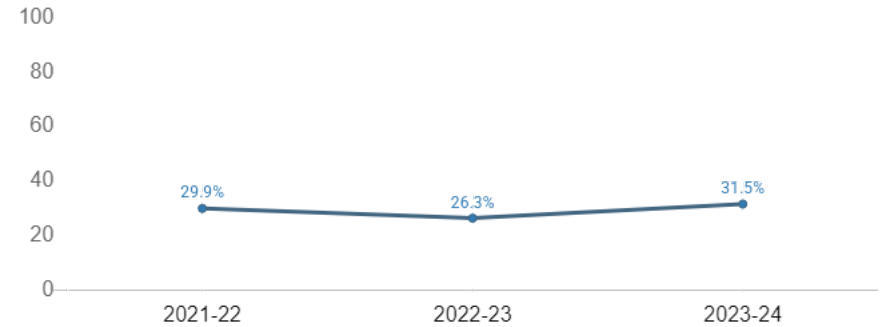
### English Language Arts and Mathematics Performance Trends

### English Language Arts Assessment - Participation and Performance

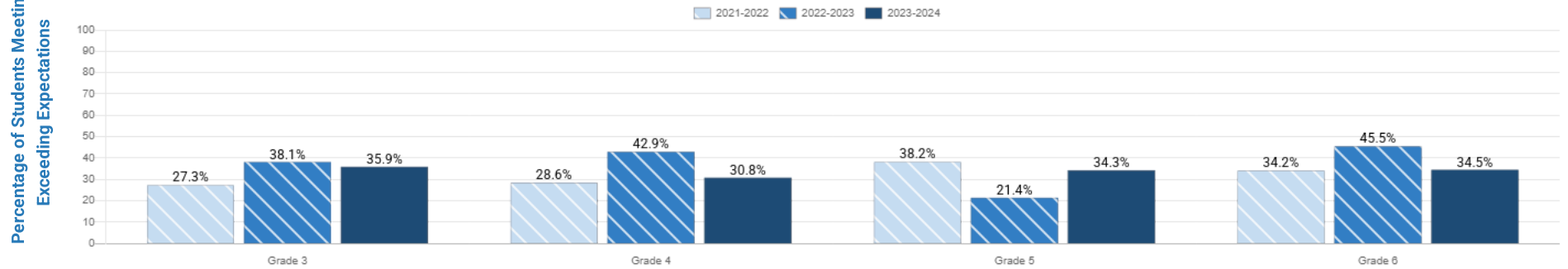

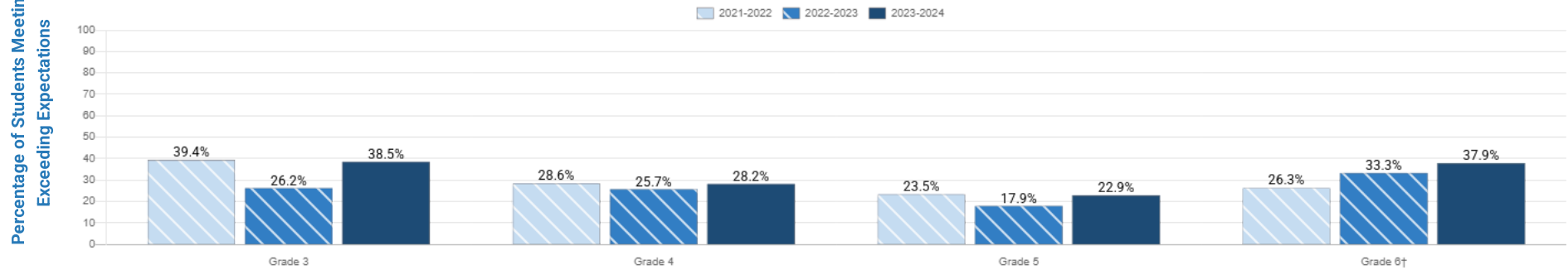

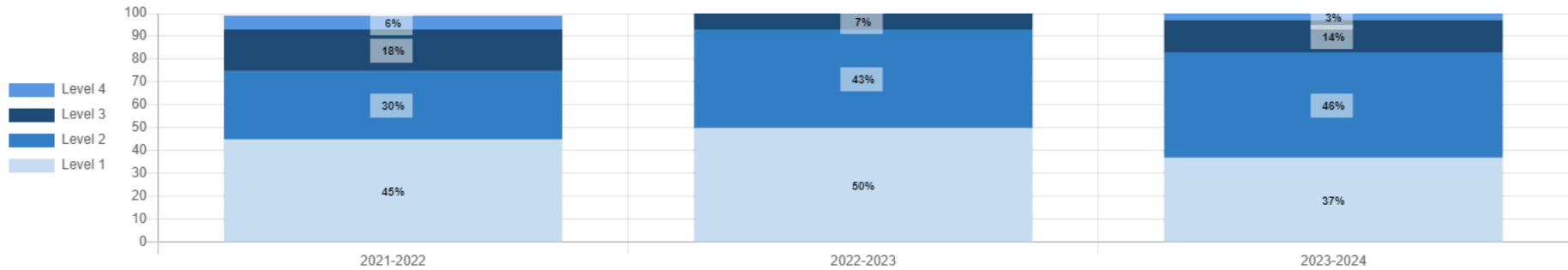

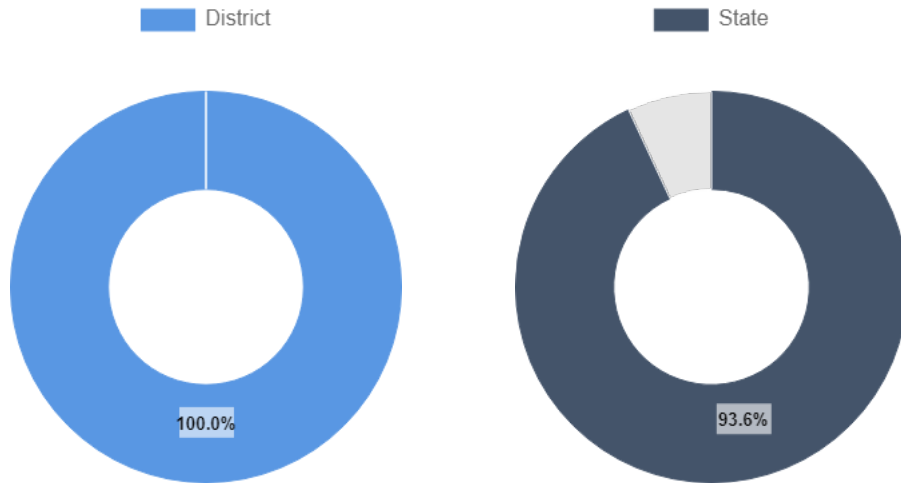

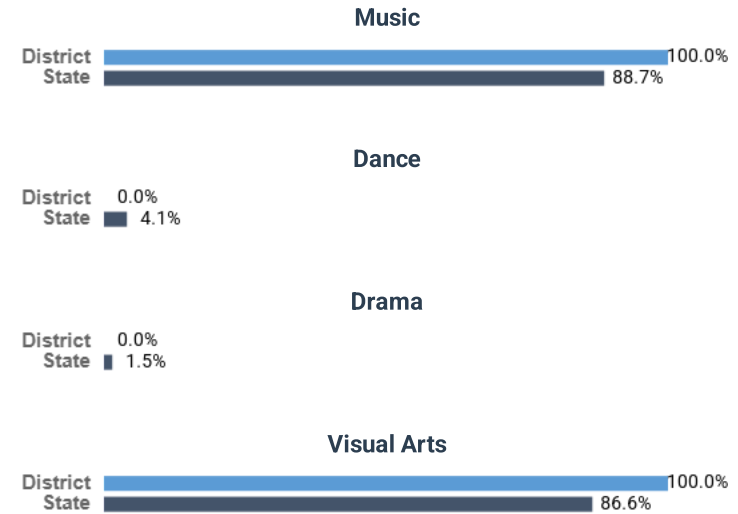

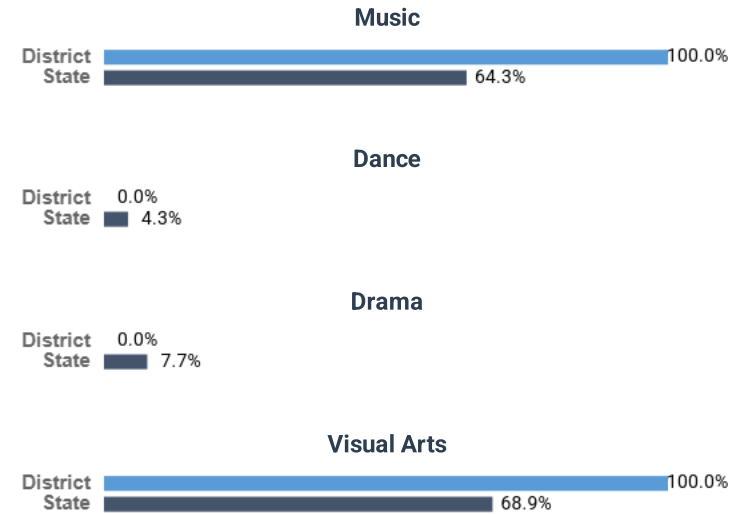

**Students enrolled in one or more classes by discipline:**

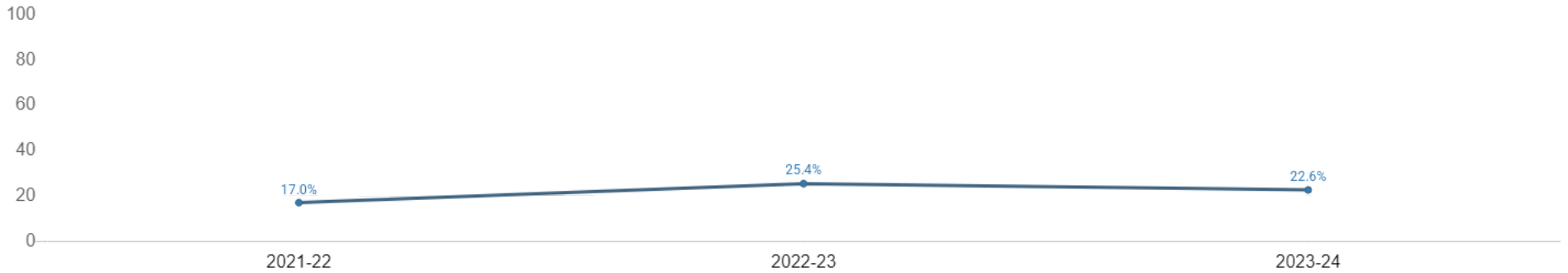

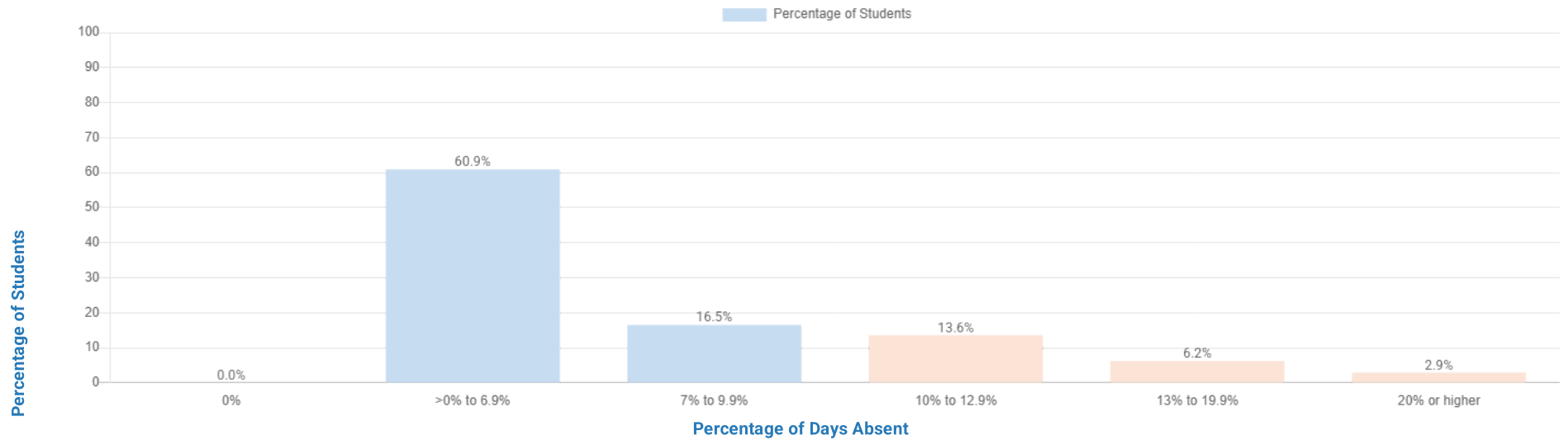

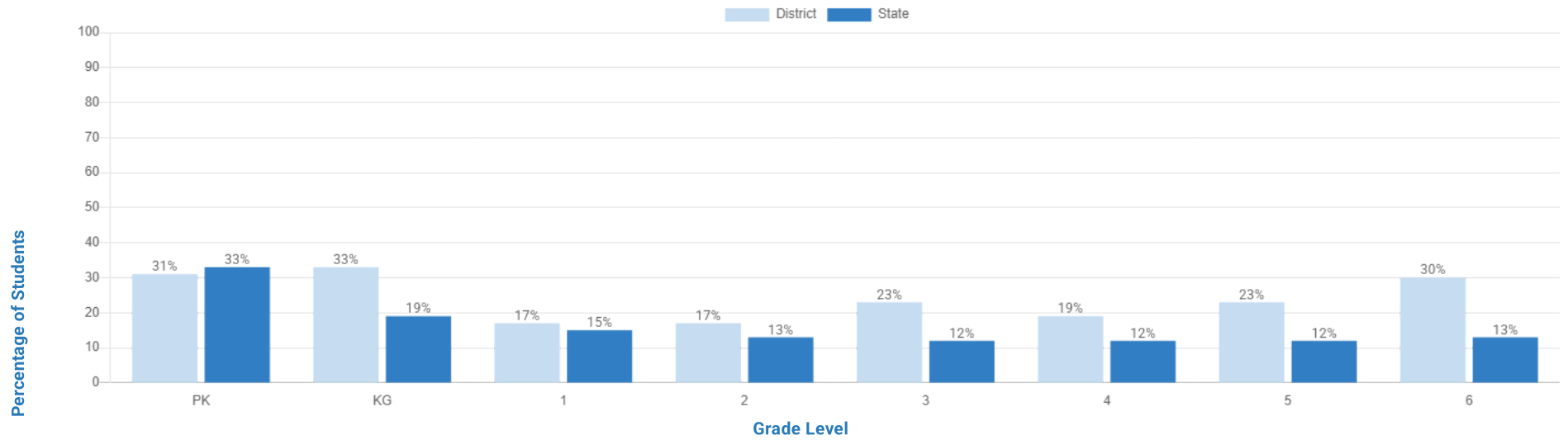


## Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.

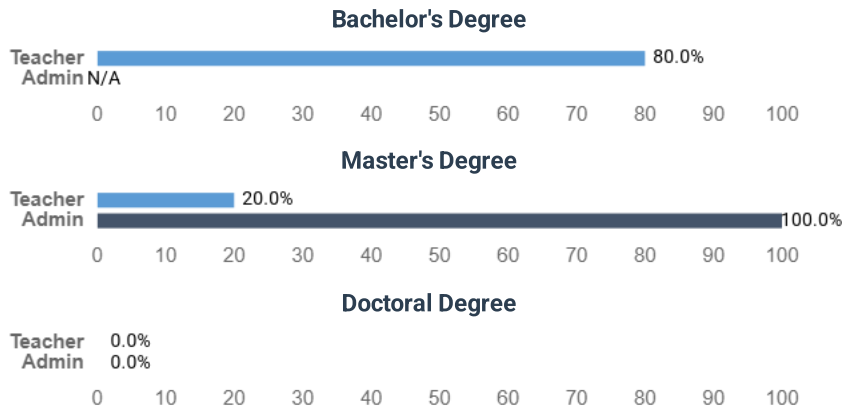

**New Jersey's Every Student Succeeds Act (ESSA) Accountability System** New Jersey's school accountability system identifies schools in need of comprehensive and targeted support as required by the Every Student Succeeds Act (ESSA). Based on New Jersey's [approved ESSA state plan](#), NJDOE will identify schools in the following four federal categories every three years:

### Courses, Curriculum, Instruction:

Tuckerton Elementary School provides 1:1 devices for all students (Chromebooks 1st grade - 6th grade; iPads Kindergarten) so that all our students have access to 21st Century Learning. We focus on instilling a love of reading into our students in order to enhance their broad literacy skills, through school wide literacy based activities and programs. Our instructional program is characterized by a strong emphasis on literacy and math skills and carefully integrated programs in science and social studies. TES Preschool utilizes Creative Curriculum which is a play based curriculum that focuses on mathematics, literacy, language, social emotional, physical and cognitive development that is age appropriate for our youngest learners.



### Clubs and Activities:

TES offers a wide range of academic and high interest after school clubs including Newspaper Club, Art Club, Garden Club, Writing Club, Academic Assistance, Sports Clubs, and Student Council. Students in grades 3-6 may participate in band and chorus. Our sixth grade students may join the Safety Patrol.



### Before and After School Programs:

Academic Assistance is offered as an after school intervention program to assist with academic development for K-6 students. The district provides an extended day child care program through Right At School for all students Prek through 6.

### Staff and Professional Learning:

Our staff participates in professional development opportunities in addition to facilitating workshops on technology, curriculum content, and instructional strategies, beginning in the summer months and continuing throughout the year. Grade level PLCs are scheduled bi-weekly, during the school day, providing for horizontal articulation and collaboration. Our Preschool staff participates in professional development geared toward Preschool Learning Standards, Creative Curriculum, TPOT, and ECERS. They are encouraged to seek out and attend out of district professional learning that is geared towards their PDPs. All Preschool staff members have NJCCIS accounts and have the opportunity to take free professional development geared towards our curriculum, TPOT and ECERS.



### Student Supports and Services:

Students are provided tiered support services, Child Study Team, LIEPs, Intervention and Referral Services, PIRT, Reading Intervention Services, Behavioral Intervention Services, Basic Skills, and Title 1 Services. Supplemental resources include school counseling. Enrichment activities are provided to support students and challenge higher achievement goals.



### Student Health and Wellness:

Tuckerton Elementary offers a before-school Breakfast Program, Physical Education and Health classes, daily recess time allotted for students, and classroom brain break/movement breaks. Additionally, TES partners with various community groups and programs that promote good dental health and vision. Mindfulness and SEL activities are integrated into the school day. TES is a Nurtured Heart Approach school.

### Parent and Community Involvement:

Tuckerton Elementary School's Community Parent Involvement Specialist (CPIS) provides parents with community resources and has built a great rapport with local agencies. The Early Childhood Advisory Council helps students transition from home to preschool, preschool to kindergarten, and work together as a community to plan events for our preschool - third grade students. The PTA works collaboratively with school staff and families to create engaging experiences and promotes community involvement. Family engagement events/activities focus on enriching student learning and promote parent involvement. Assembly programs are featured throughout the year. OnCourse Connect parent portal is accessible through our school website.



### Climate Surveys:

The results are compared to the previous year's data and used to improve our climate and culture. ### Facilities:

Each classroom in Tuckerton Elementary School is equipped with ActivPanels. School assemblies, concerts, and musicals are performed in our gymnasium/multi-purpose room. Our STEAM lab features a Lego wall and 3D printers. We have a music room with ample space for band and chorus rehearsals, an Art/ World Language Room and 2 designated playground areas for preschool and K-6 students.

### School Safety:

Tuckerton Elementary School has a full time School Resource Officer. Our main entrance has a remote locked door/video system that is opened only after checking identification of each visitor. Classrooms are secured by a key fob lock system and the main office is equipped with a panic alarm. Monthly fire drills and held and bus evacuations are held twice a year. Monthly security drills are conducted following state procedures and communicated to parents at the conclusion. All staff and volunteers are trained in safety and security procedures. The district has two certified School Safety Specialists on staff, A School Safety Team, and A Crisis/Threat Assessment Team.



### Technology and STEM:

Tuckerton Elementary provides 1:1 ipads for preschool and Kindergarten. Teachers follow NJ's Division of Early Childhood's recommendations for limited screen time. First - Sixth grade students have 1:1 chromebooks. TES has a STEAM lab and teacher. Students go to the STEAM Lab twice per week to participate in hands on collaborative problem solving activities. The lab experience is coordinated between the classroom teacher and STEAM teacher.



### Early Childhood Education:

Tuckerton Elementary receives PEA funding for 4 general education preschool classrooms that follow NJ Preschool Learning Standards and have implemented Creative Curriculum. TES is registered with Grow NJ Kids. Preschool Instructional Coaches coach the teachers on curriculum implementation and the PIRS specialist focuses on coaching the teachers in The Pyramid Observation Tool (TPOT) which focuses on the social emotional needs of the students.
