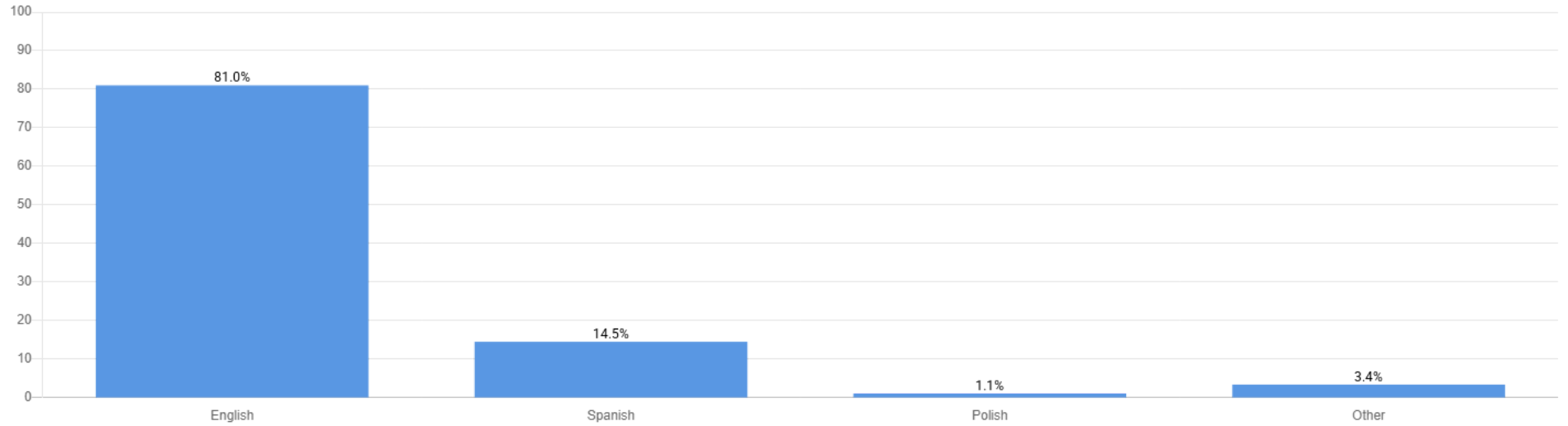

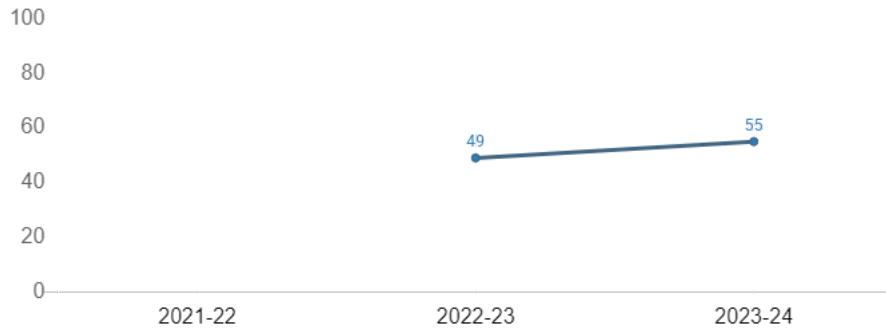

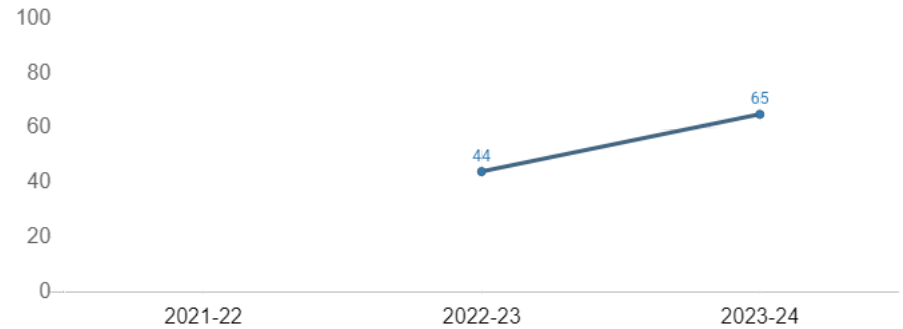

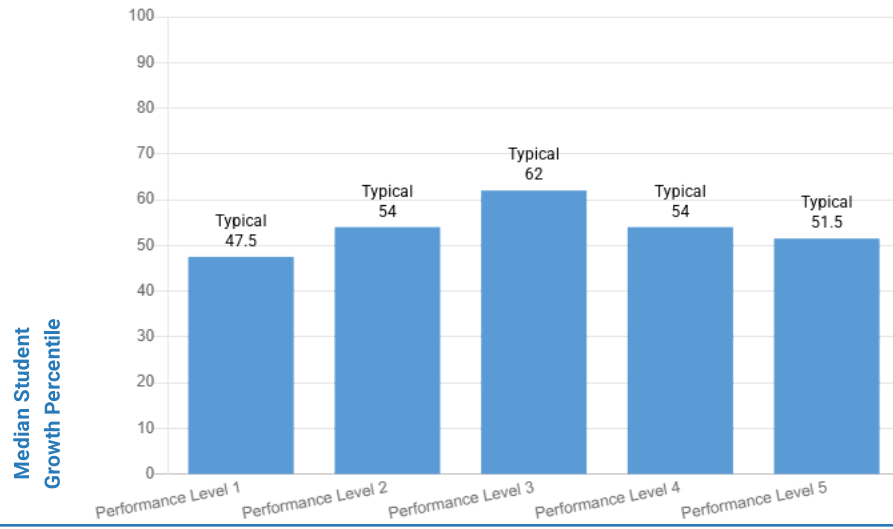

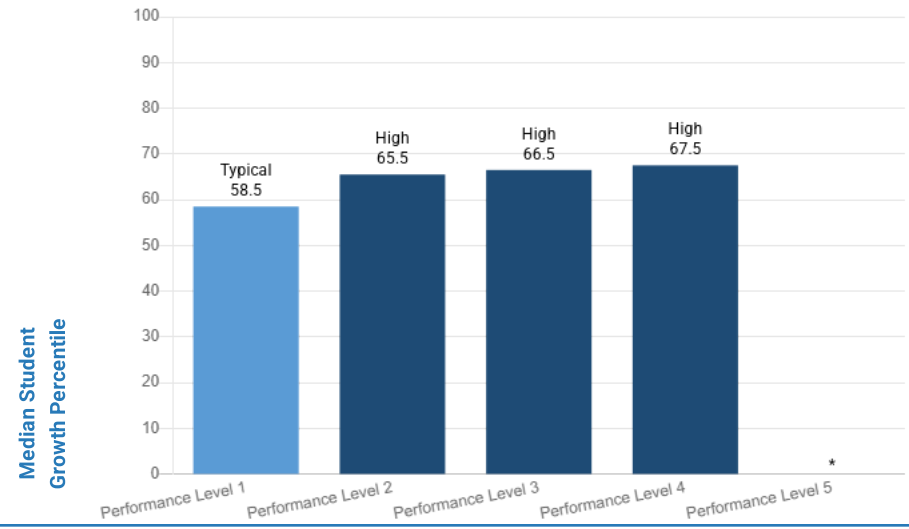

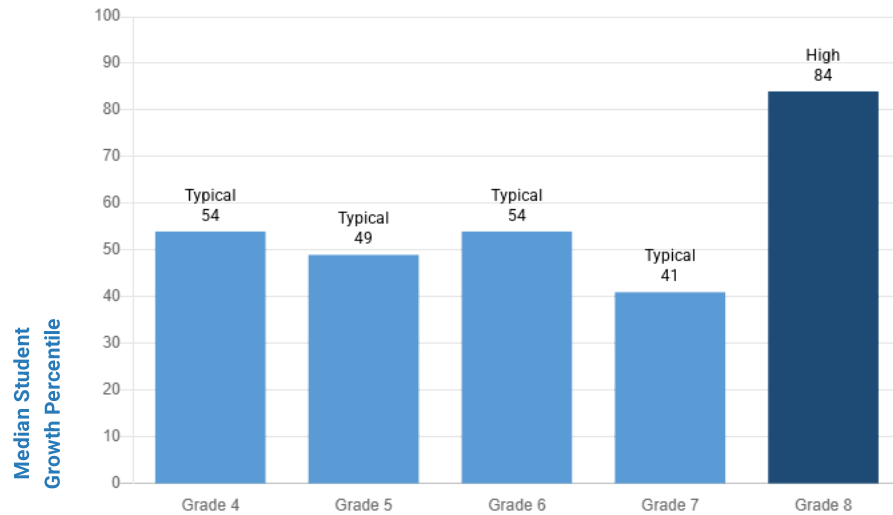

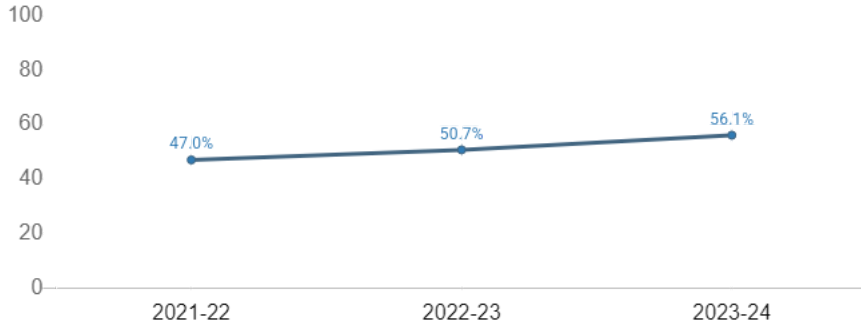

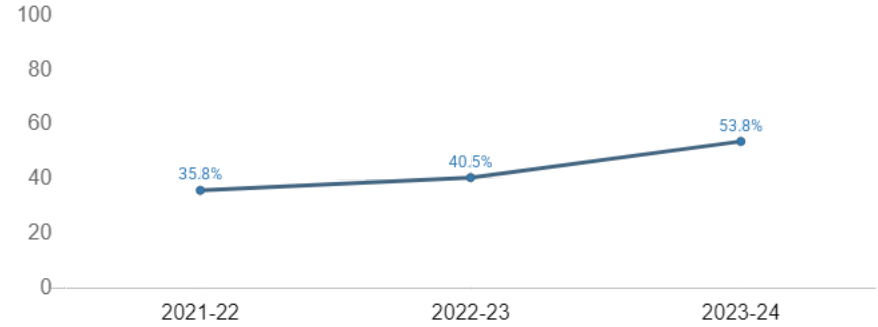
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 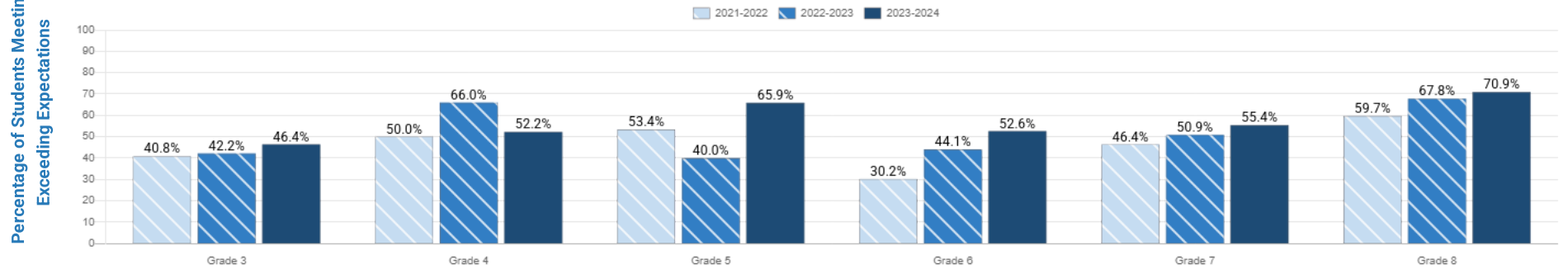

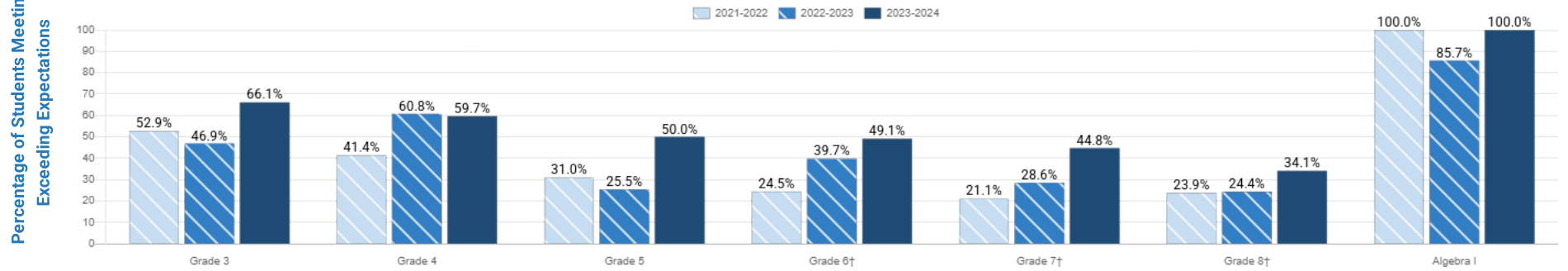

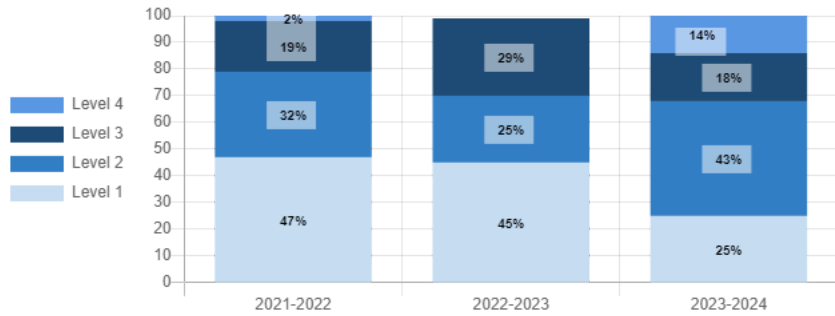

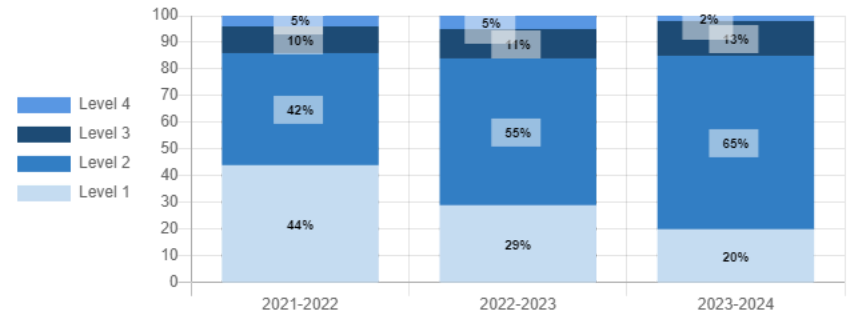

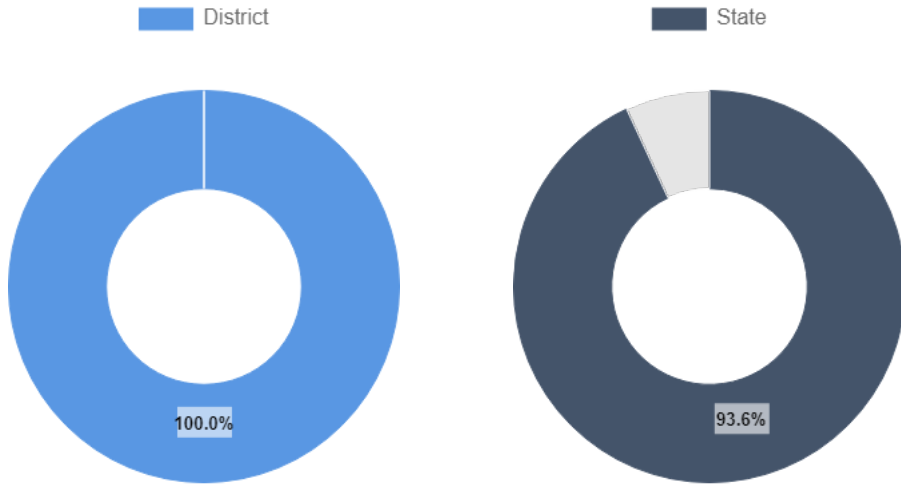

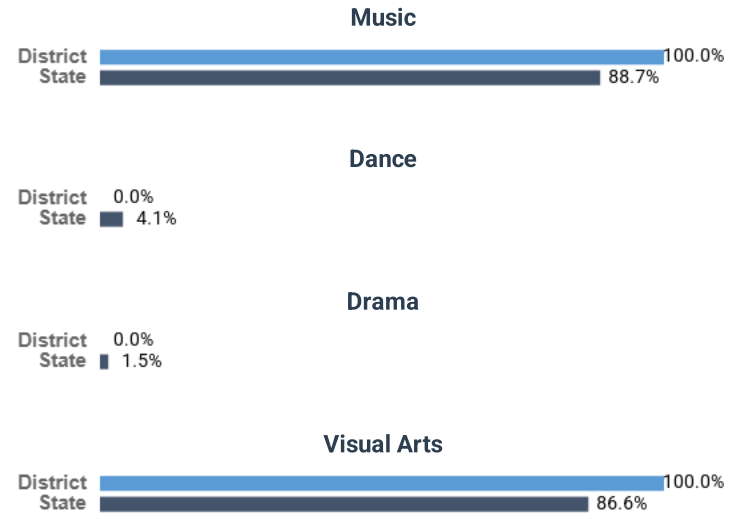

Students enrolled in one or more classes by discipline:



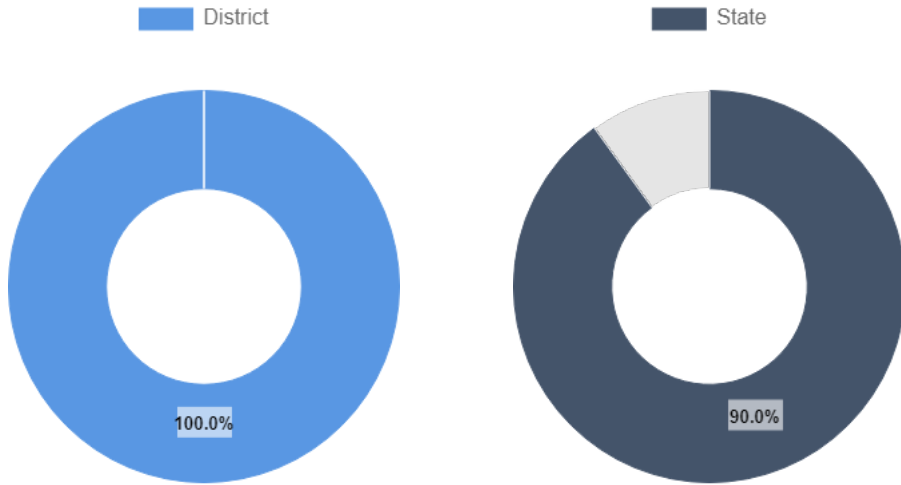

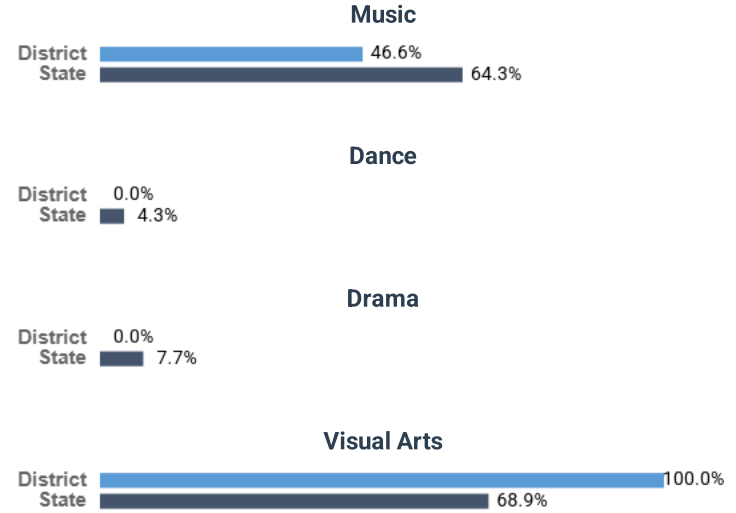

Students enrolled in one or more classes by discipline:

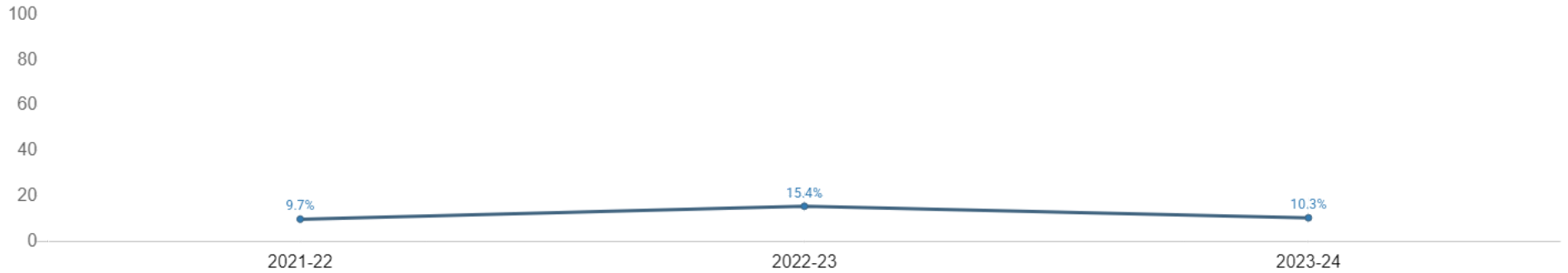

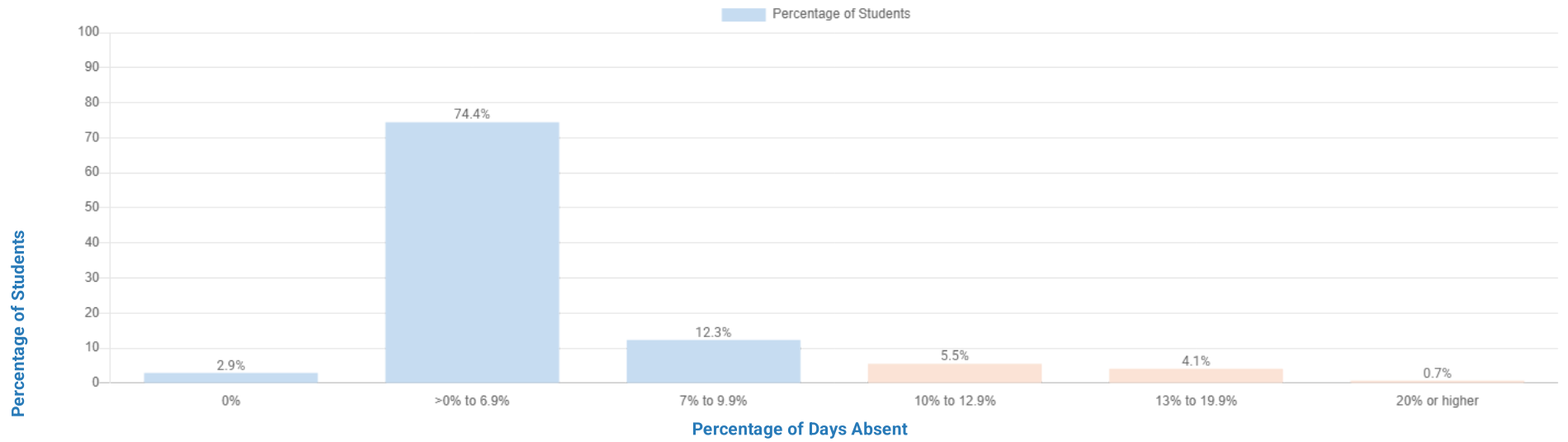

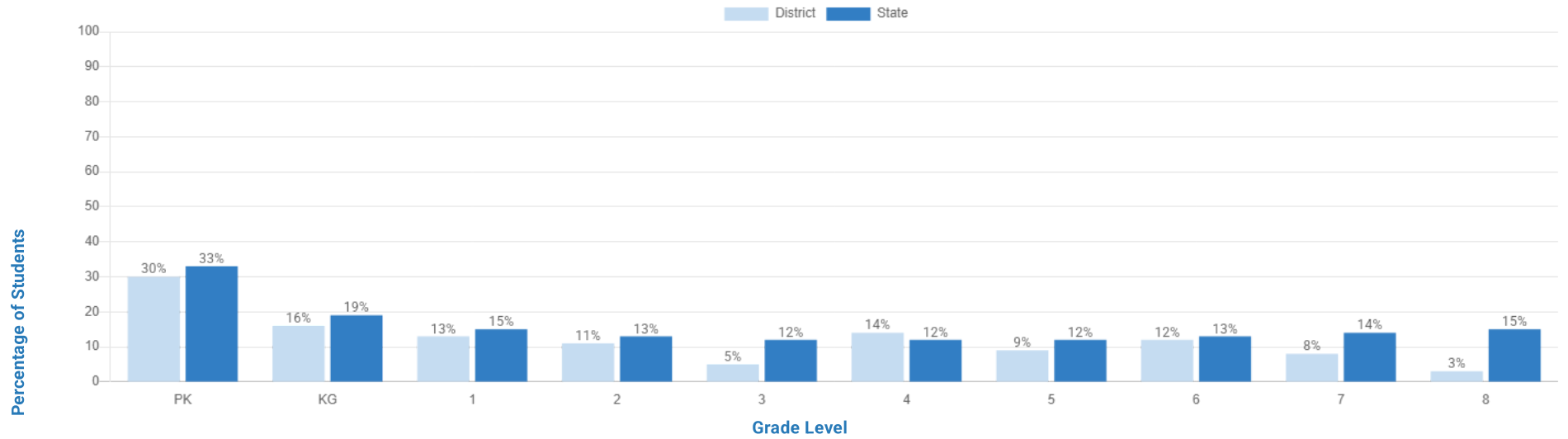

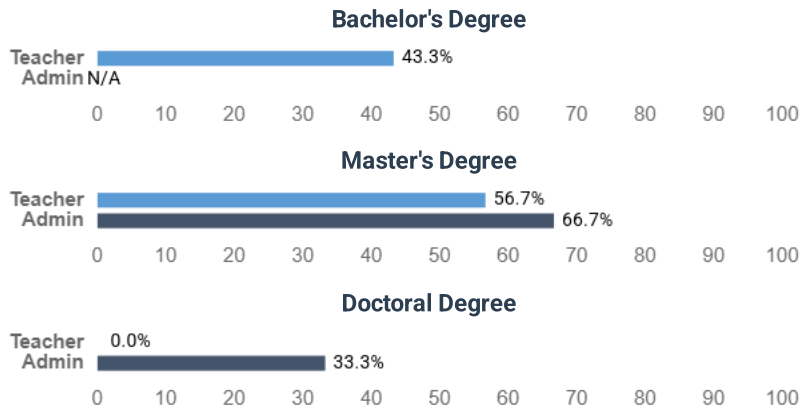

The district has also expanded its Universal PK program, now serving 111 students, saving residents \$2.3 million. * New district website as well as communication app for parent notifications and classroom to parent contacts.

Courses, Curriculum, Instruction:

* Academic Achievement: WTB curricula was expanded. 15 new electives like robotics and sports journalism, unique for NJ. NJSLA scores have improved since 2021, and new reading and math support roles have been added. Over \$500,000 was invested in revising curricula across various subjects. Facilities: Upcoming large-scale improvements, with recent projects including renovations of the WTB Library and Science Lab, plus new offices and therapy spaces.
* Communication: Enhanced family engagement through forums, math nights, and the new Bloomington App.



Student Supports and Services:

Bloomington Schools offer a full array of student support services to all students. Students who are English Language Learners meet daily with a certified ELL teacher who supports them in their acquisition of English. RTI Committees are active in all 3 schools and consist of a multidisciplinary team. Interventions are documented and data collected to determine effectiveness. Section 504 Committees determine eligibility for services within general education for those students who qualify. A range of modifications and accommodations are designed to help the student meet success. Special Education services are determined by an IEP team which includes a School Psychologist, multiple Social Workers, LDT-C, and Speech and Occupational therapists who are on staff. A full range of special education services are available based on each child's individual needs. Our counseling staff is available to support students who are experiencing difficulties that impact them in school.



Student Health and Wellness:

The district provides time for recess for grades PK-8. Teachers incorporate brief, physical activity breaks into the school day to establish an environment that promotes regular physical activity throughout the school day. All schools participate in a walk-a-thon each year, as well as after school dances for the middle and upper elementary grades. Breakfast programs are available in all schools, and nutritional guidelines are posted in all cafeterias. All schools participate in field day activities each year. Grade 8 students play volleyball against the teachers each year, and all middle grades are involved in a pep rally with relay races. Students in K-4 utilize yoga and brain breaks throughout the day. The district has established a District Wellness Committee which will meet 4 times a year to plan activities including School Wellness Week and address the district's wellness goals.

Parent and Community Involvement:

Bloomington has an active Parent Teacher Association (PTA) with strong membership among both parents and staff. Some of the programs that the Bloomington PTA has sponsored include: Book Fair, End of Year Parties, Holiday Shoppe, School Agenda books, Walk-A-Thon, Cultural Arts Assemblies, Family Fun Day, Scholarships, Trep\$, and Trunk or Treat. Additionally, the District has a Special Education Parent Advisory Group (SEPAG) which meets formally every month. As part of the district preschool program, the district has a staff member serve in the Parent Community Involvement Specialist position. Each month, parent programming is offered by the district administration and professional staff.



Technology and STEM:

Bloomington School District has technology instruction from kindergarten to eighth grade by certified teachers. The District's mission is to instill global digital awareness in an ever-changing technological world. Bloomington School District offers after school elementary STEM workshops through grants and incorporates hands-on STEM lessons in our curriculums. In 2022, the district replaced all technology in the classrooms to bring us up to date with state of the art technology. Bloomington School District has a 1:1 Chromebook initiative for all students.
