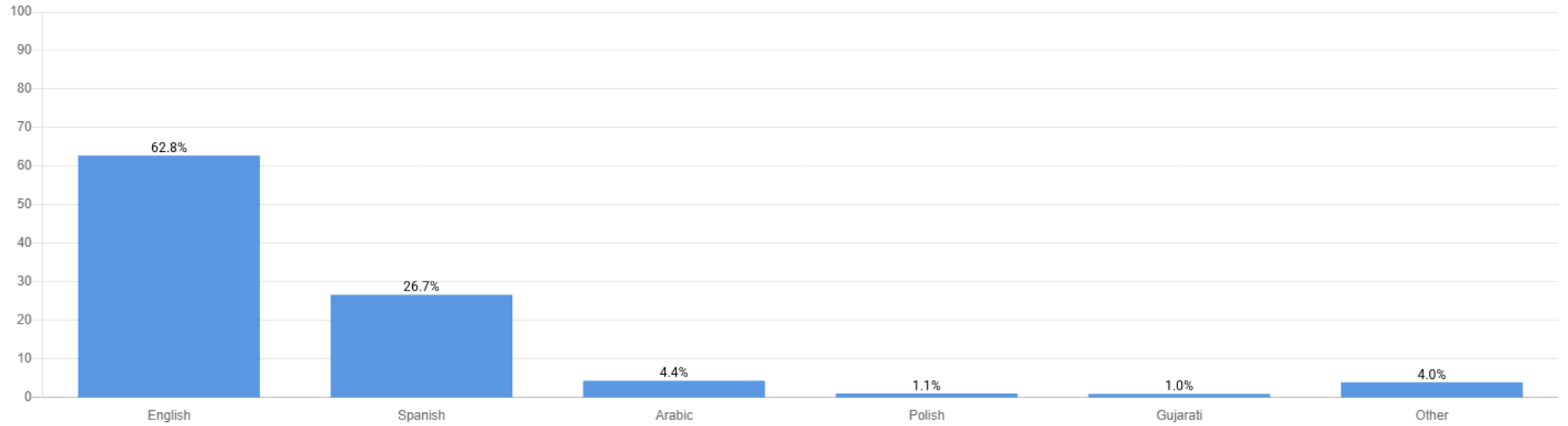

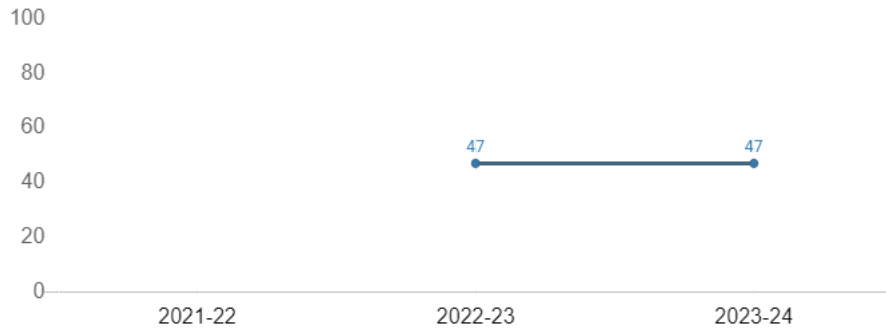

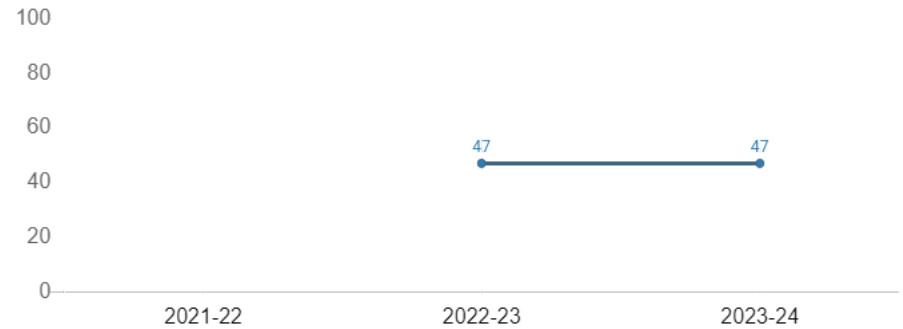

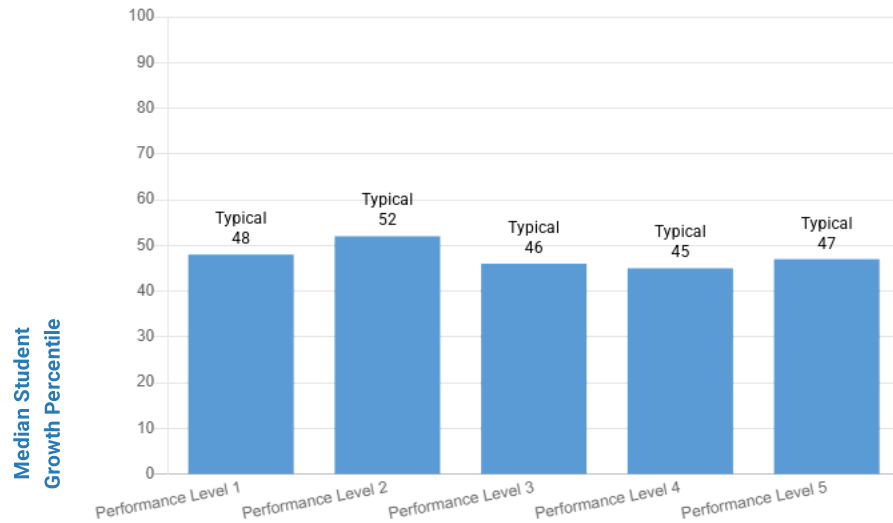

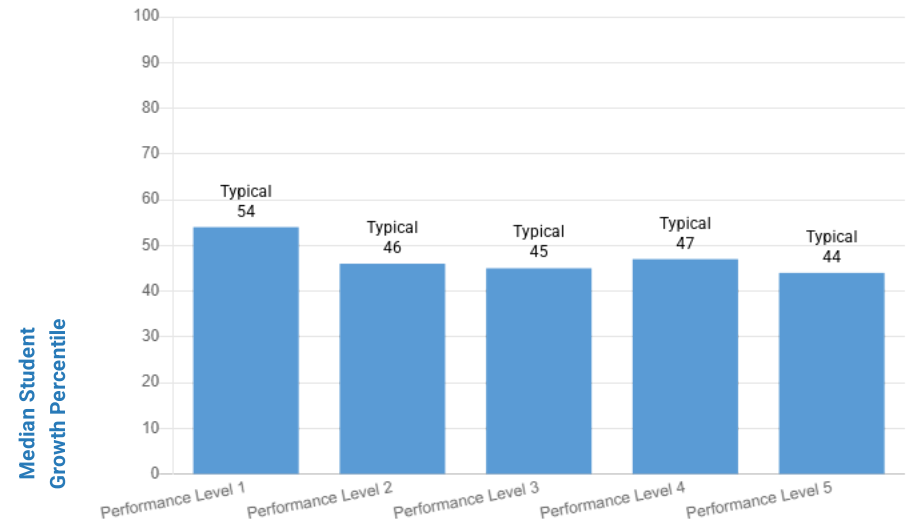

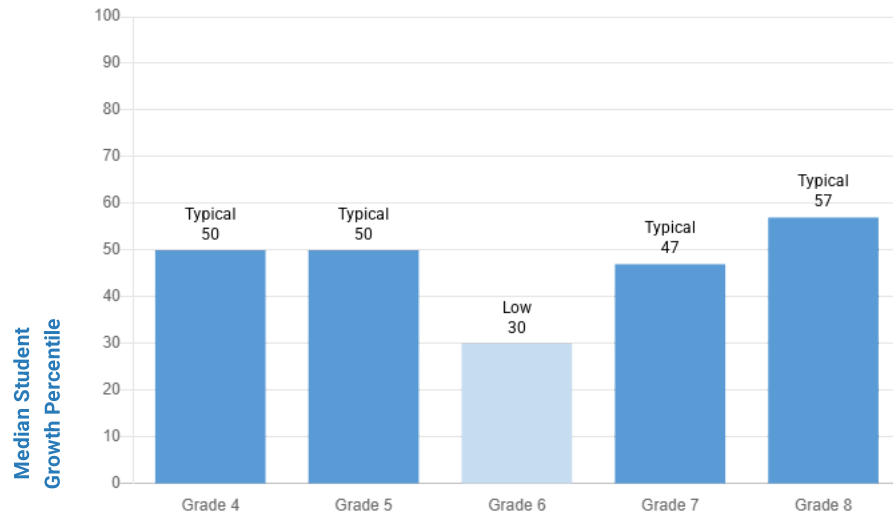

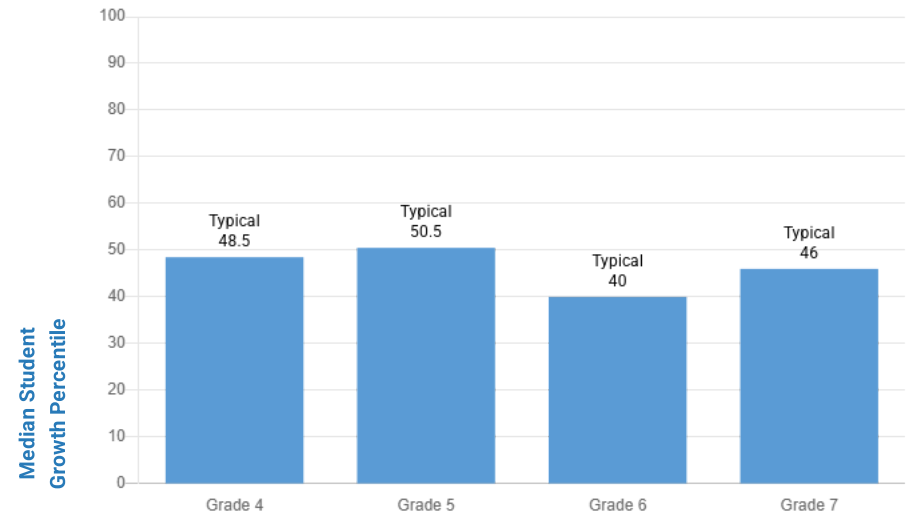

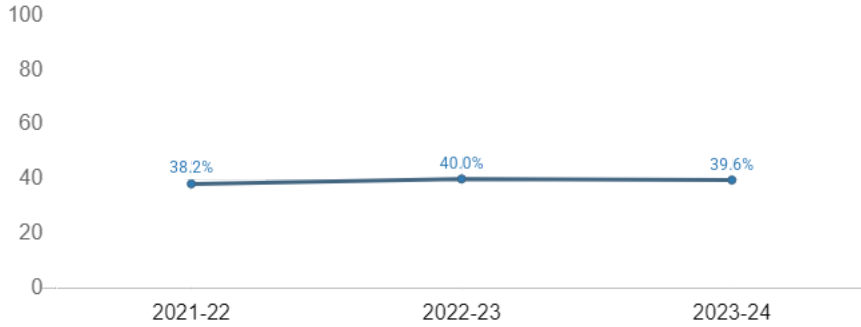

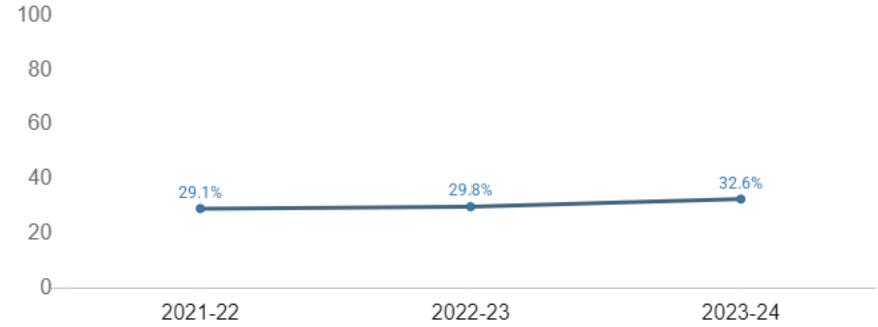
### English Language Arts and Mathematics Performance Trends

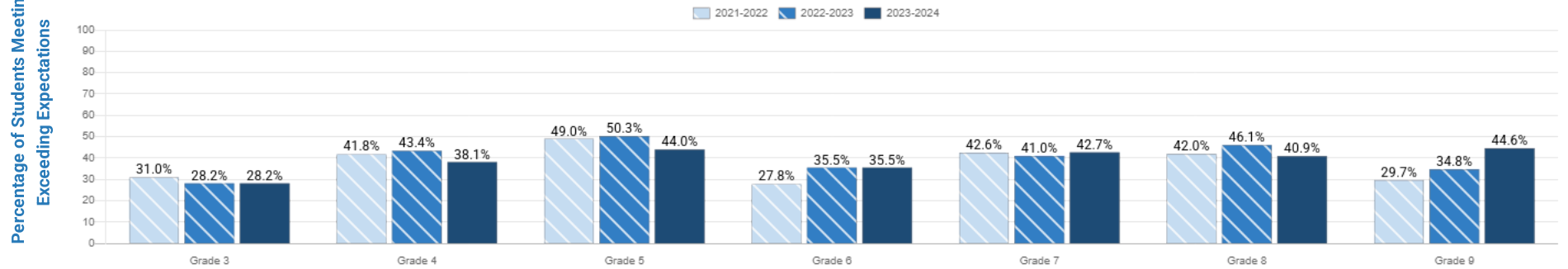

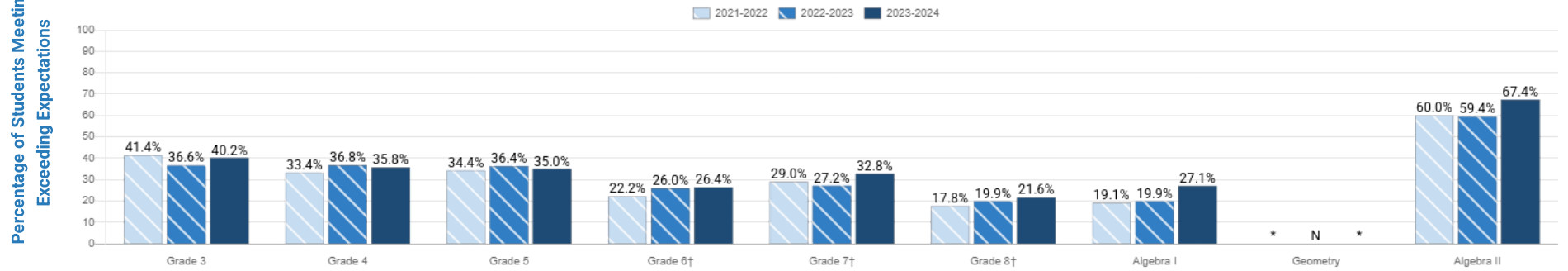

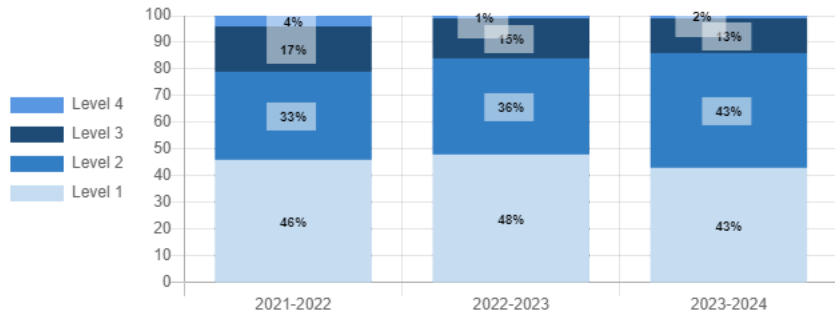

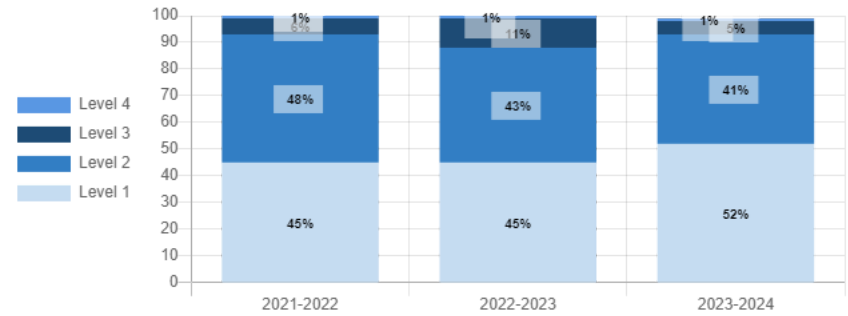
### NJSLA Science Assessment: Grade 5 Summary

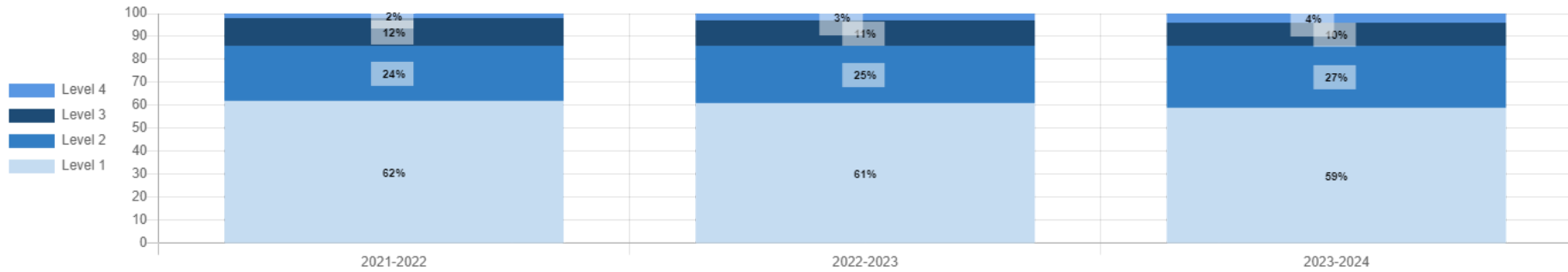

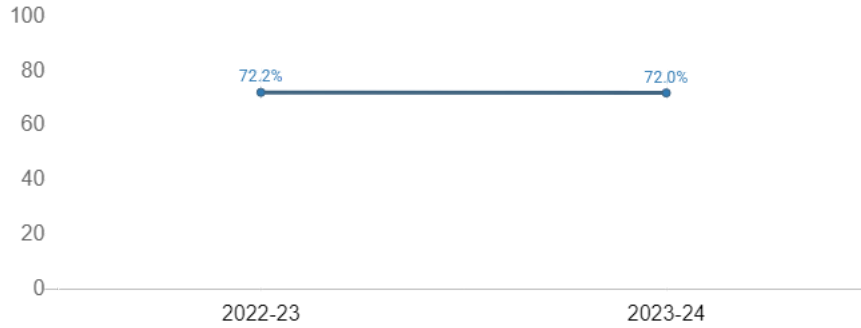

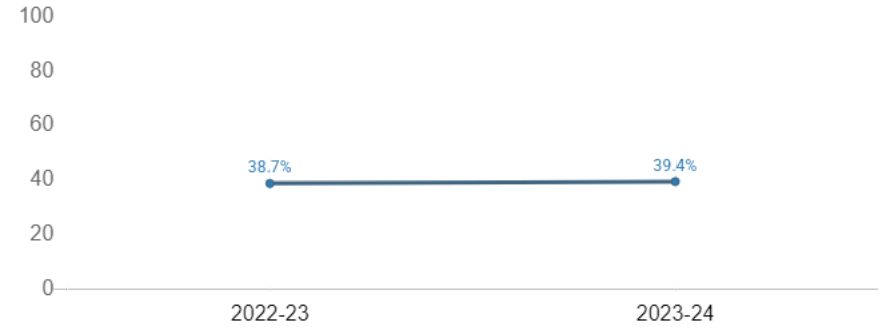

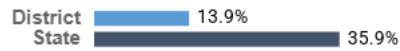

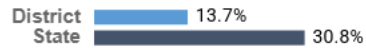

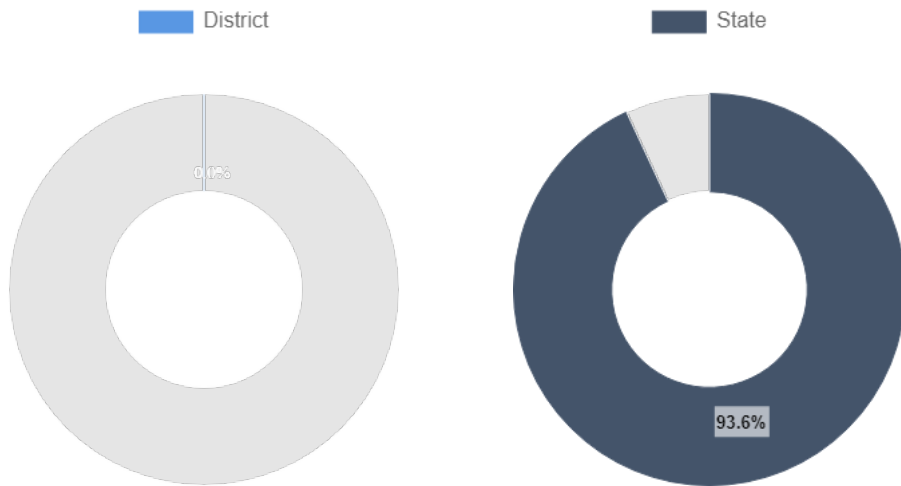

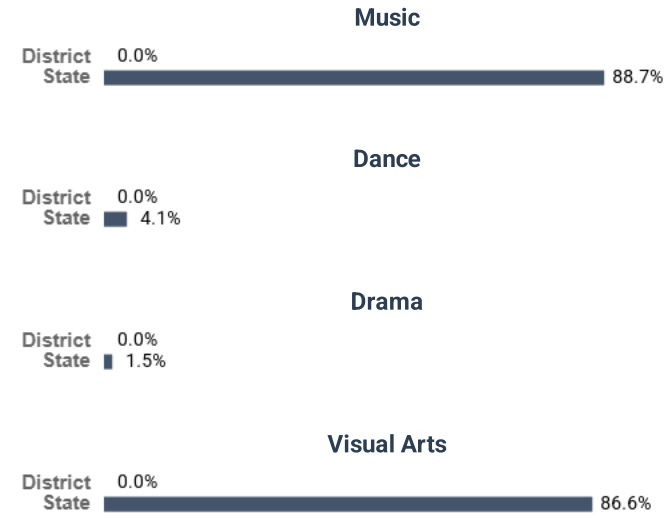

**Students enrolled in one or more classes by discipline:**



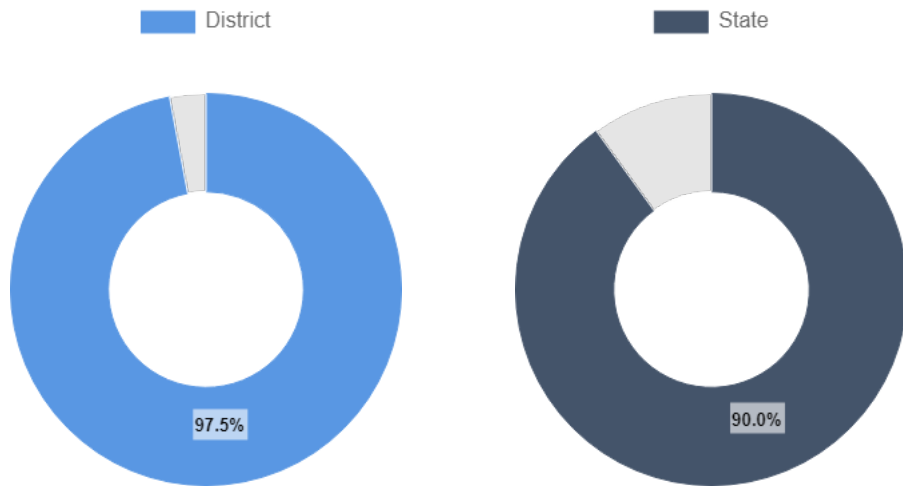

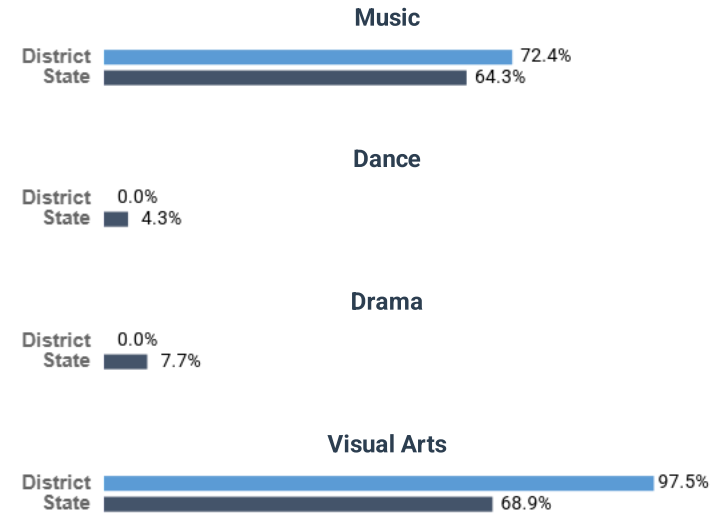

**Students enrolled in one or more classes by discipline:**



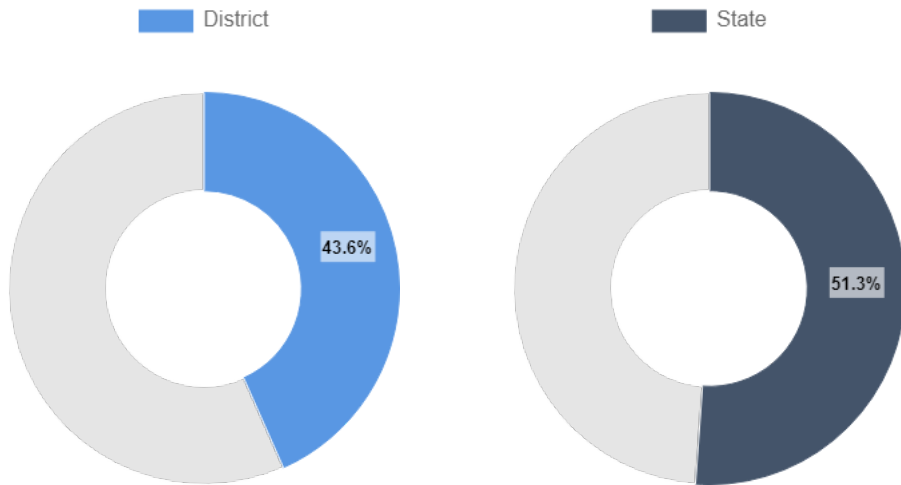

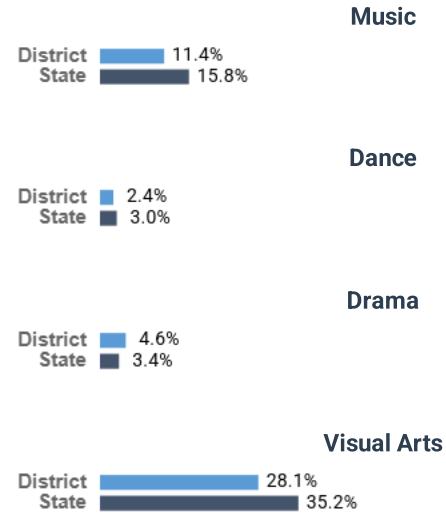

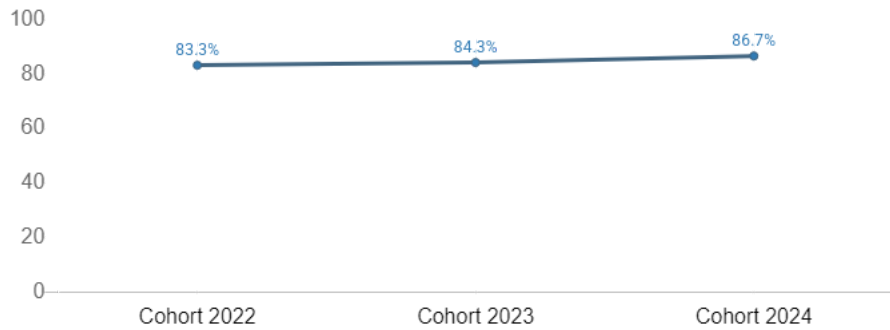

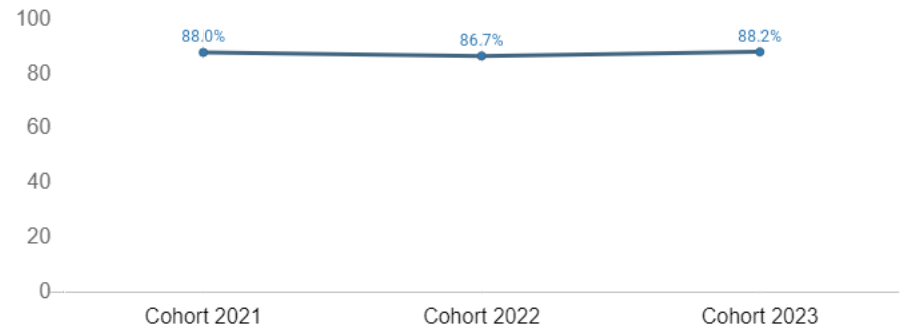

## Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

**Note for 2023-2024:** Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.

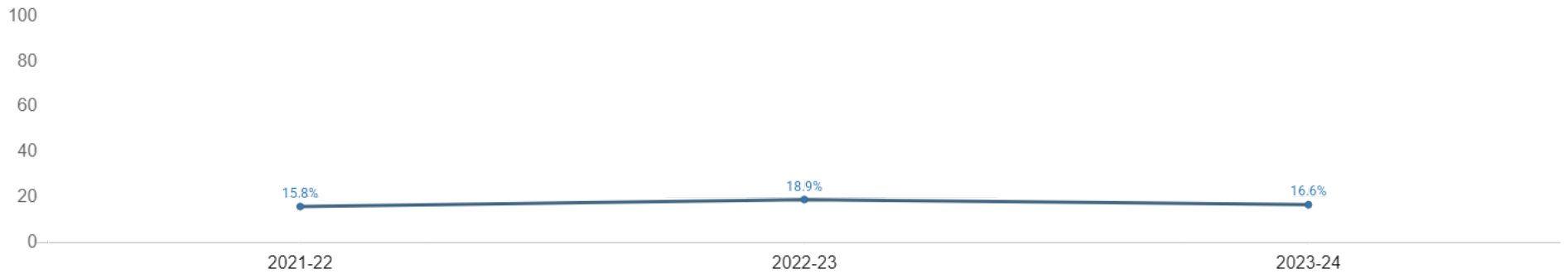

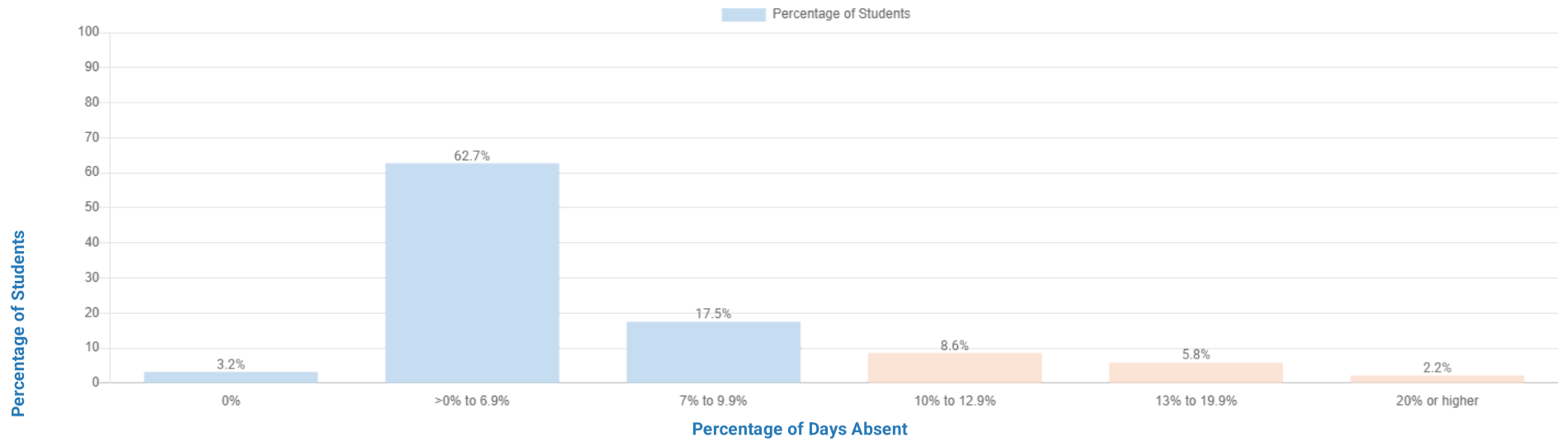

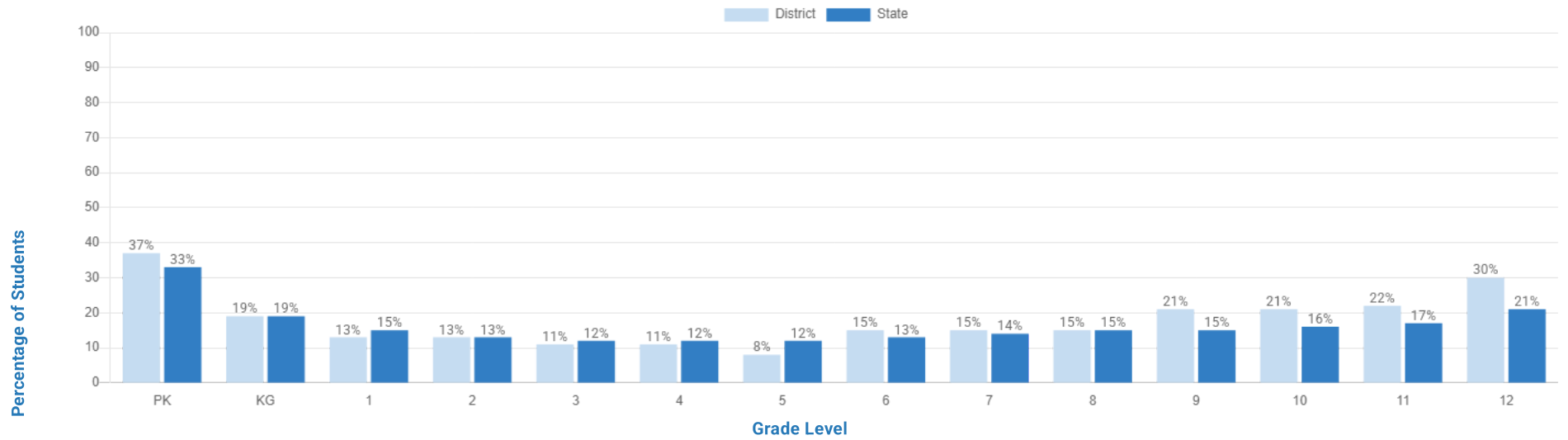

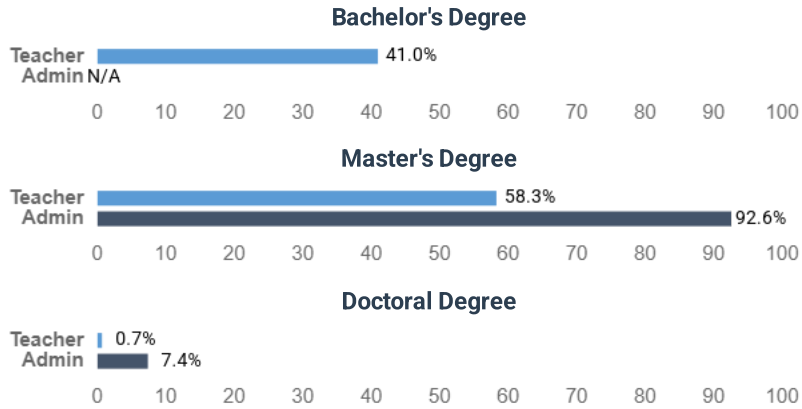

### Courses, Curriculum, Instruction:

Balanced Literacy, Science of Reading based interventions, literacy skill building across all curricular subjects, constructivist Math, hands on Science and Arts integration across the curriculum provide a rich academic foundation. Technology is infused throughout the school district through Google Workspace, Promethean Boards, Chrome Books and a menu of state of the art applications that facilitate learning and seamless integration of technology in instruction. Each of these initiatives teaches critical thinking for all students and encourages active student engagement throughout the school day rounded out with robust extracurricular and varied sports offerings to address the whole child. Students can showcase their talents in language with the Seal of Biliteracy, through participation in sports, visual and performing arts programs and many co-curricular activities. We provide our students an excellent education to prepare for success in a complex global economy.



### Staff and Professional Learning:

Clifton Public Schools have a strong emphasis on professional learning communities. District wide professional development plans are informed by school level improvement committees (SciPs). Professional Learning Communities meet to deepen teacher understanding of topics such as using data to inform instruction, specialized reading techniques, sharing best practices, looking at students' work, and examining content-based benchmarks. As a district, we encourage and support our staff to continue to be lifelong learners.



### Postsecondary Information:

Clifton offers many AP courses as well as part time and full time dual enrollment programs with Montclair State, Fairleigh Dickinson, Felician, William Paterson, Passaic Community College and an Associates Degree option with Bergen County Community College. The district offers PSAT testing to all 10th and 11th graders at no cost to students. 46.7% of graduates go on to 4 year colleges, 21.1% to 2 year schools and 10.8% to other post secondary schools. The class of 2024 earned \$5,493,548 in four year scholarships.

### Student Health and Wellness:

Clifton Public Schools provides a comprehensive physical education and health program for PreK-12 coupled with breakfast and lunch nutrition programs to address the physical needs of the whole child. Daily recess takes place in all schools PreK-5. Nursing services serve as a conduit to appropriate medical care.



### School Safety:

Clifton Public Schools prioritizes safety and security. At least one school security specialist is assigned to each school building to ensure compliance with local and state regulations specific to school security. Continued collaboration with local police and fire, NJDOE Office of School Preparedness and Emergency Planning as well as the TSA ensures student safety thru comprehensive assessment, plans, drills and technology. In addition to the physical security, Clifton Public Schools has adopted the PBSIS program to address the whole child in developing, communication, teaching and reinforcing specific academic, behavioral and health and safety expectations. We also implemented an anonymous report system to identify any suspicious activity related to Violence, Vandalism and Substance Abuse (VVSA) along with incidents of HIB. Each school reinforces district procedures and invites multidisciplinary collaboration via building based Safety Security and School Climate committees.



### Technology and STEM:

Clifton Public Schools are committed to 21st Century Learning, Technology and STEM. Leveraging 1 to 1 devices, all curriculum allows for in-person, hybrid or fully remote instruction. Technology is embedded across all curricular areas at all grades. Classes have access to interactive, whiteboards, document cameras, computer programs, labs and media-makerspace centers. Hands-on STEM activities are embedded in Science and Math classes beginning in Preschool and culminating in a high school STEM pathway. Numerous programs, clubs and activities emphasize STEM and technology language.

### Early Childhood Education:

Clifton Public Schools offers 2 preschool program options: preschool for children with special needs and a state-funded preschool program. The free preschool program for children with special needs assists children ages 3 to 5 who have special needs. If eligible, there are inclusive opportunities within the state-funded preschool program. In addition, self-contained classrooms are also available throughout the preschool program. The free full-day, high-quality state-funded preschool program is available for income eligible 3 and 4 year-olds. Limited spots are available for non-income eligible 3 and 4 year-olds on a first come, first serve basis upon completion of the registration process. With a strong relationship with Head Start and a growing list of private providers, our state-funded preschool program currently consists of 40 fully inclusive classrooms, located in eleven locations throughout the district taught by a certificated preschool teacher with a teaching assistant.



### Attendance:

The district has strategically funded instructional and behavioral interventions and support, as well as wrap around programs to address learning differences. High dosage tutoring has been implemented where possible and a comprehensive summer school program was offered to at-risk students across the district K through 12 to provide supplemental language arts, math and stem enhanced instruction. With a strong focus on student mental health, nurtured heart training has been expanded to many staff members and counseling and special education services have been expanded. Additional intervention teachers, counselors, social workers and behaviorists have been hired to address behavioral and developmental delays resulting from interrupted education.
