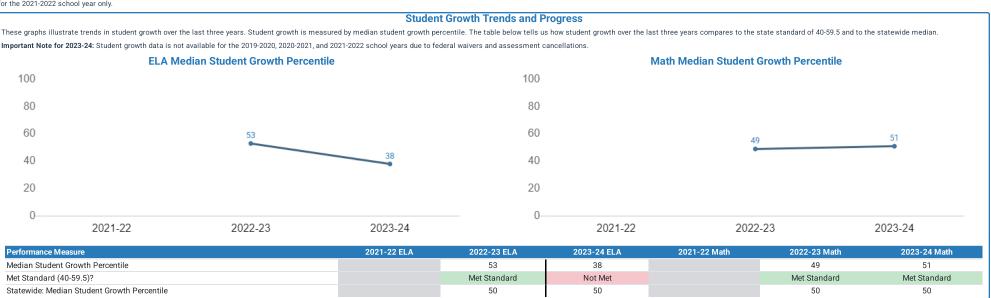

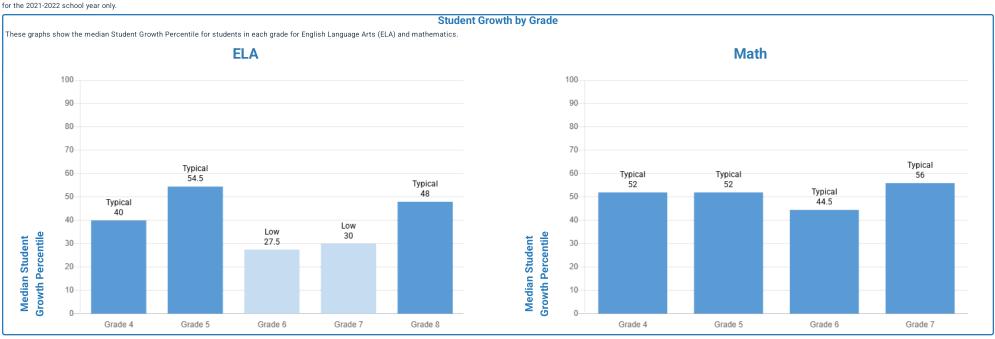

Staff

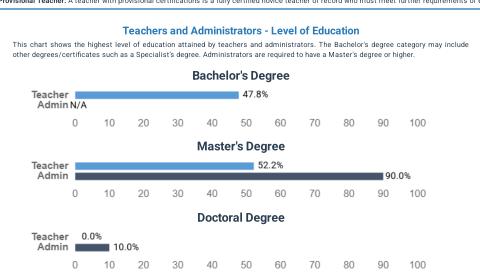

Courses, Curriculum, Instruction:

The Woodland Park School District Curriculum includes: Integrated Language Arts, Math, Science, Social Studies, Art, Music, Physical Education, Health, Technology, Gifted & Talented, ML, Basic Skills and World Language. The school district utilizes the following programs to support the implementation of the curriculum and the NJDOE Standards: Readers and Writer's Workshop, Ready Classroom for Math, McGraw-Hill for Social Studies, HMH for Middle School Science and Discovery Education for K-5. The Science, Social Studies and Math Programs have online components for student use at home. Students are provided with enrichment opportunities throughout the school day through the use of integrated technology and STEM opportunities.



The Woodland Park Preschool Program offers a State-funded Preschool Program. We are funded by PEA and eligible children are defined as resident, general education three- and four-year-old children. We include the elements as set forth by code N.J.A.C. 6A:14-4.2(a) for the implementation of a high-quality preschool program. The Woodland Park Preschool Program ensures the inclusion of preschool children with disabilities in general education settings. The program consists of a six-hour comprehensive educational program. The class size is not greater than 15 children. The Woodland Park Preschool Program does not contract with private providers or Head Start. However, we do collaborate with the Passaic County Head Start program. We do not have a wait-list in our program.
