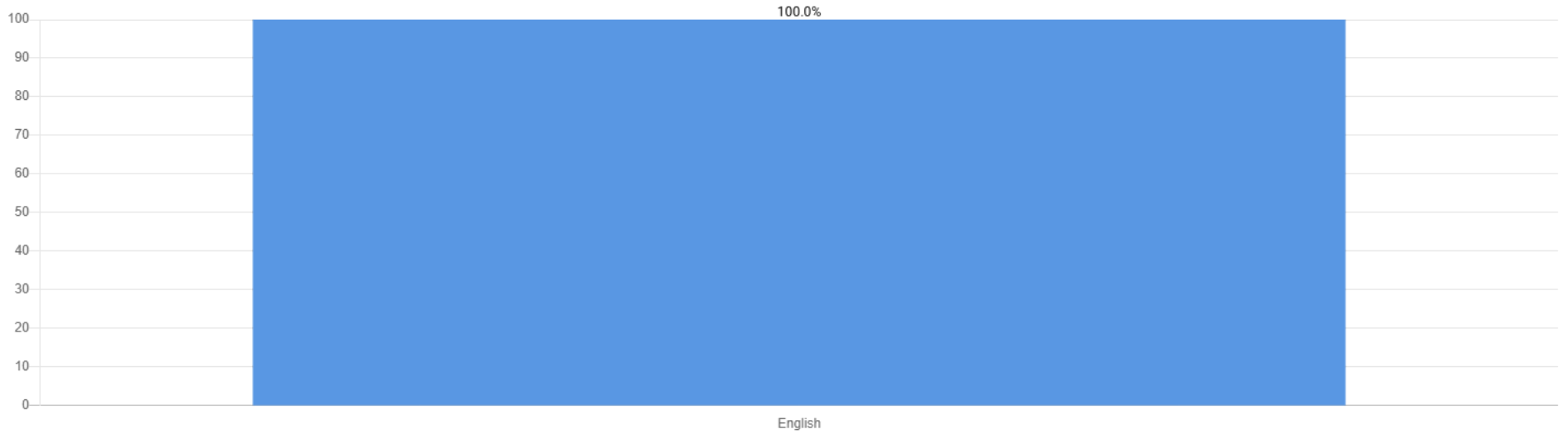

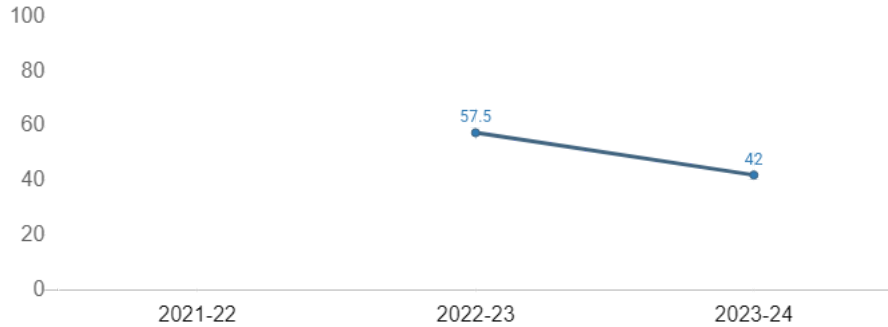

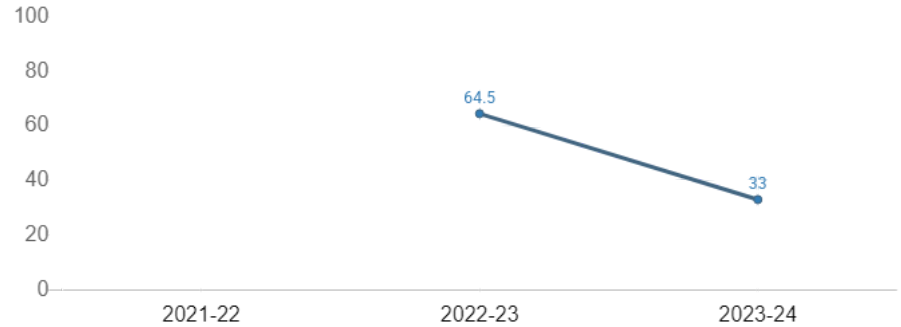

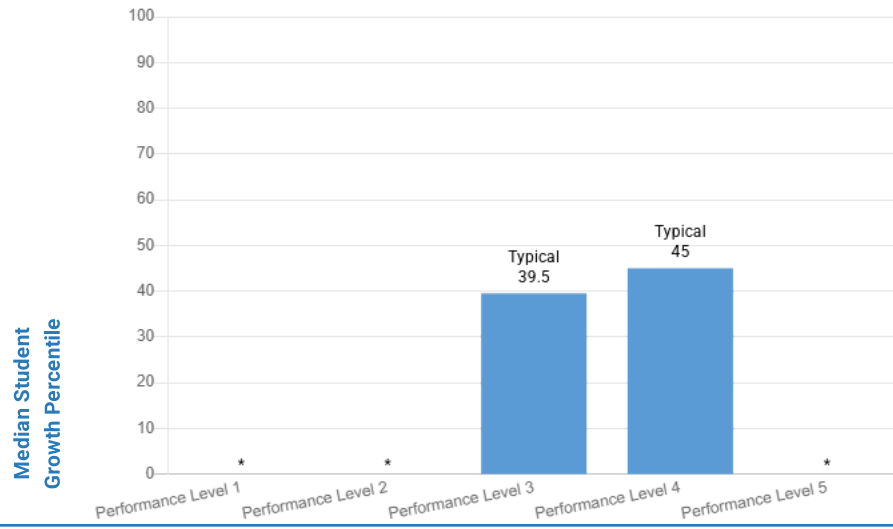

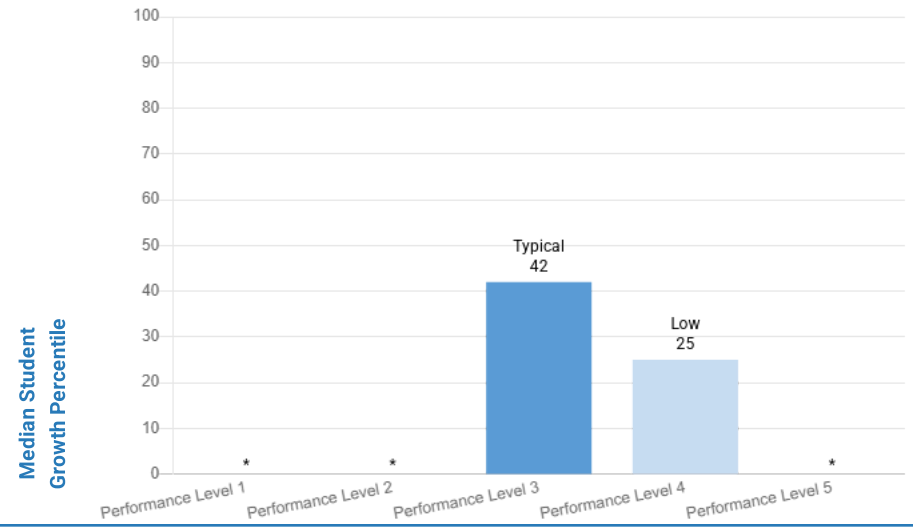

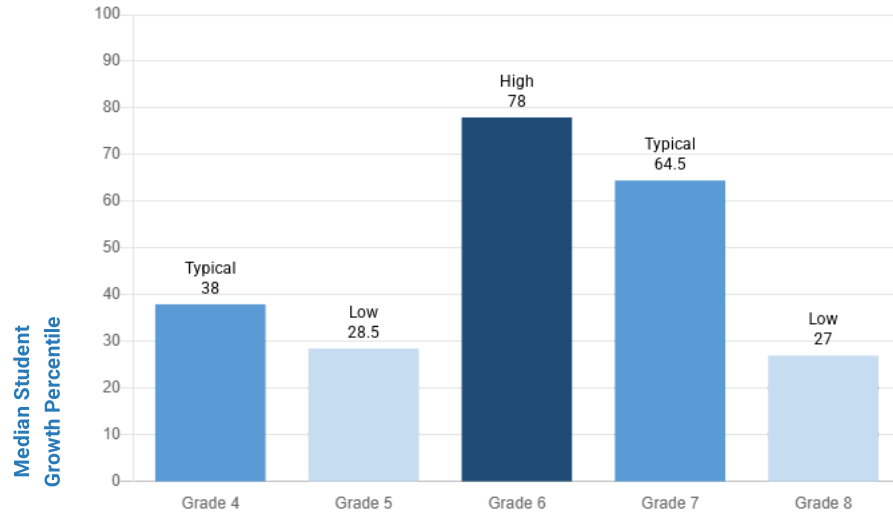

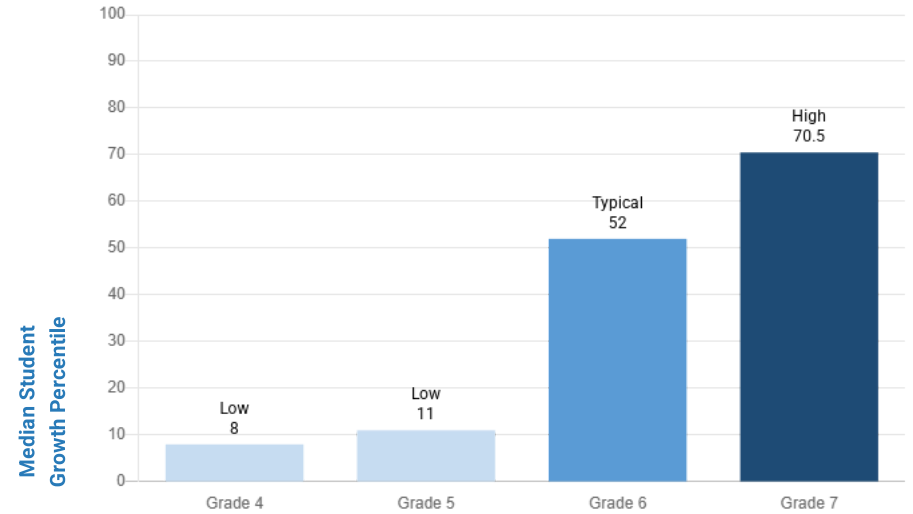

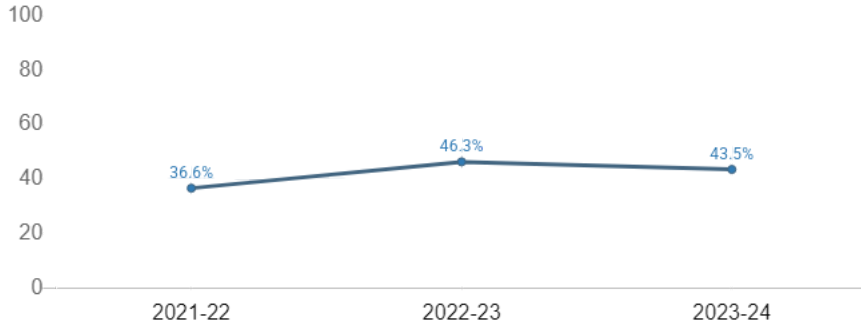

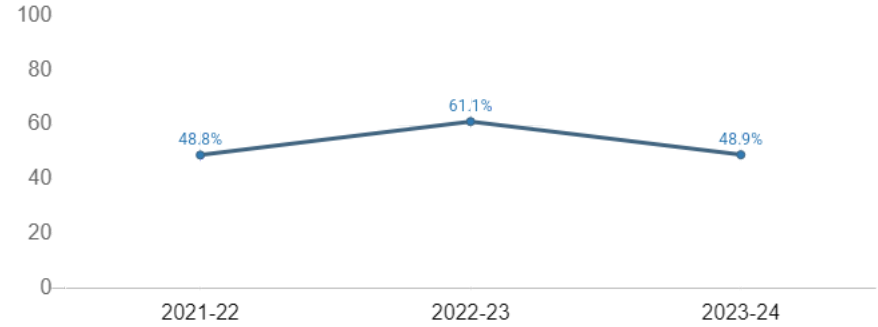
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 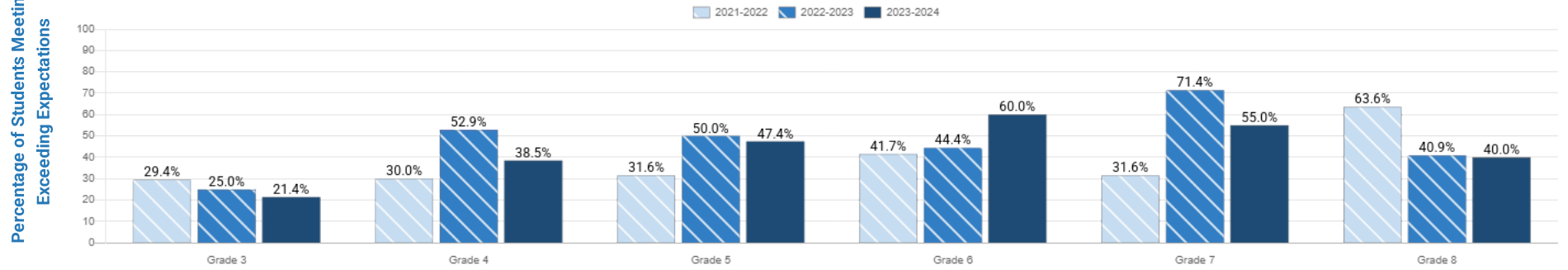

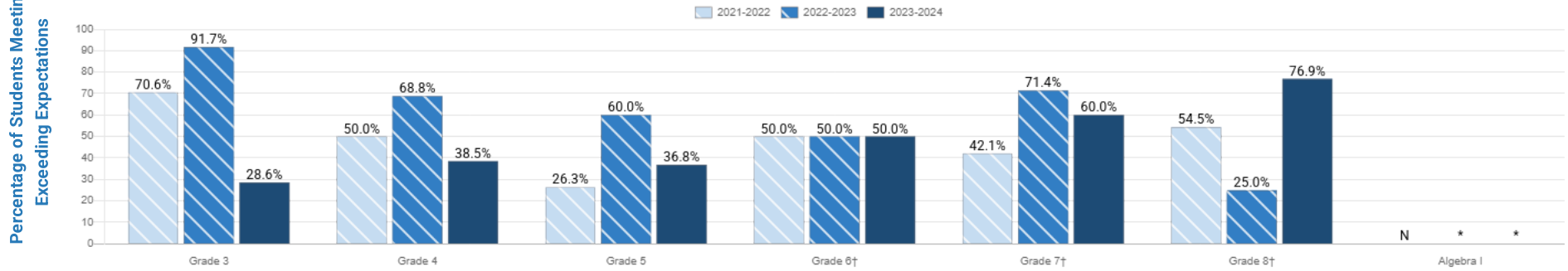

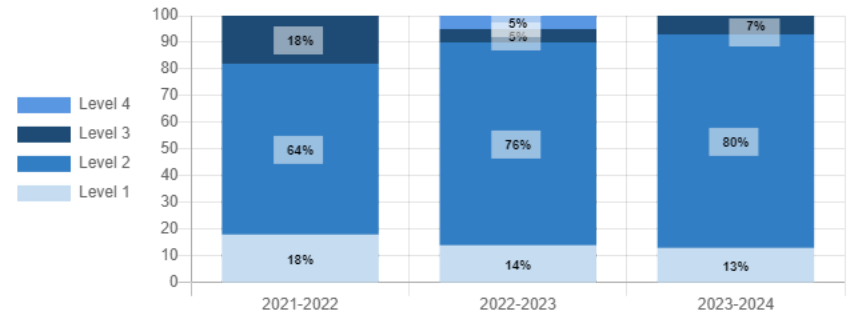

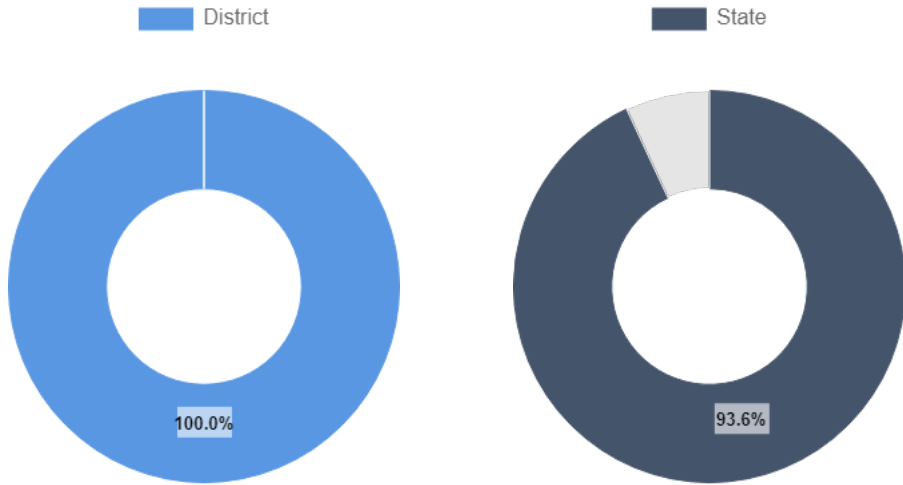

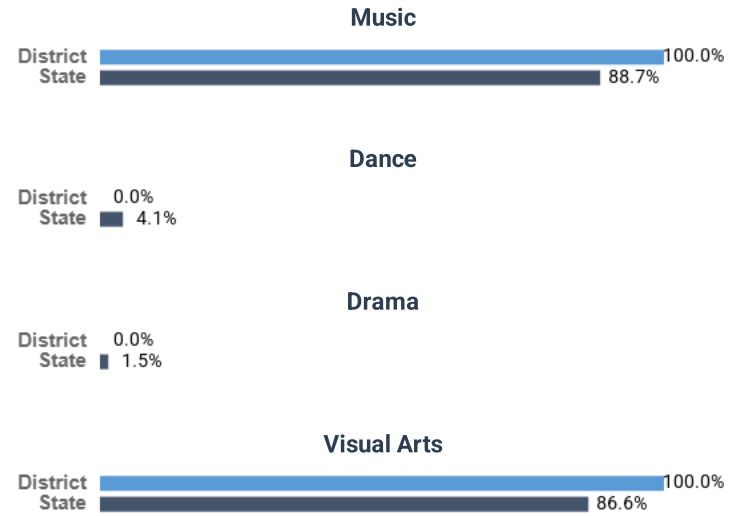

Students enrolled in one or more classes by discipline:



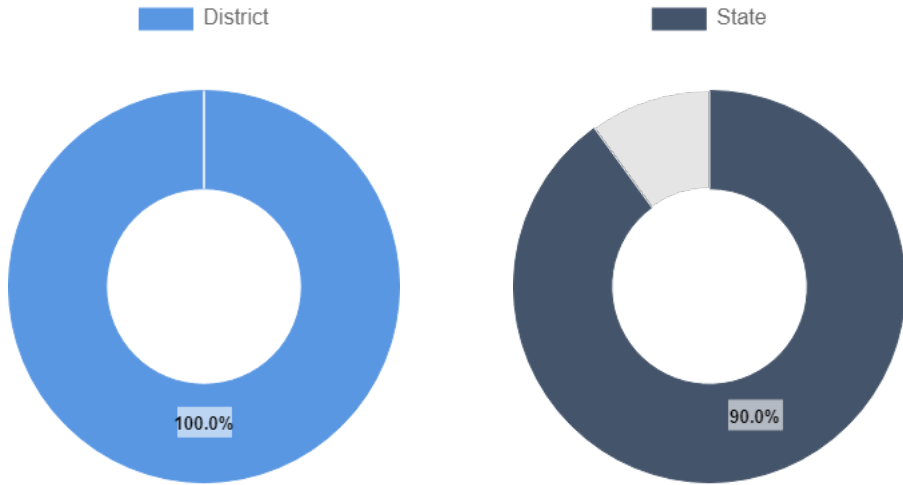

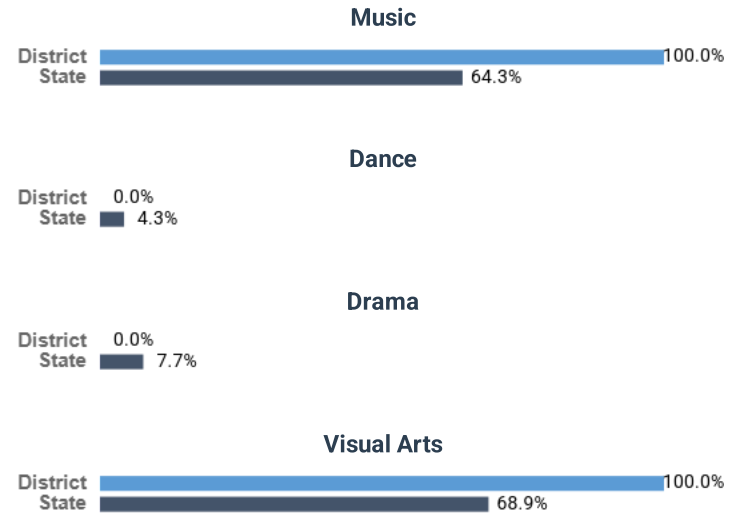

Students enrolled in one or more classes by discipline:

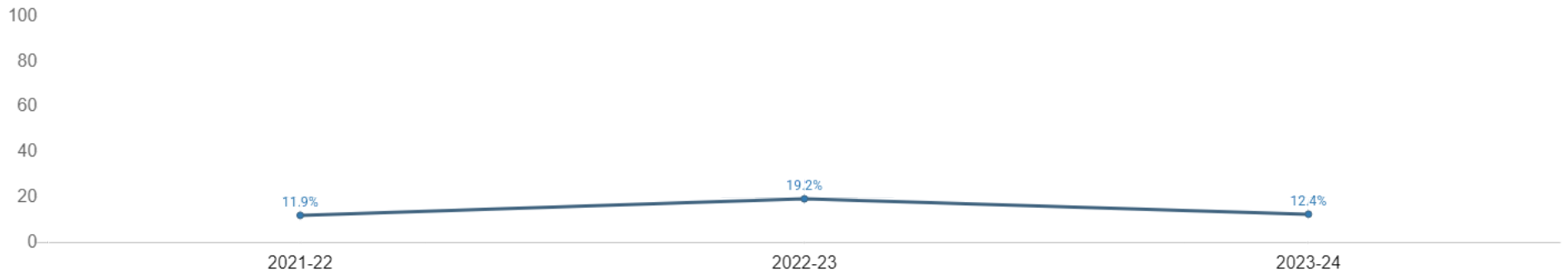

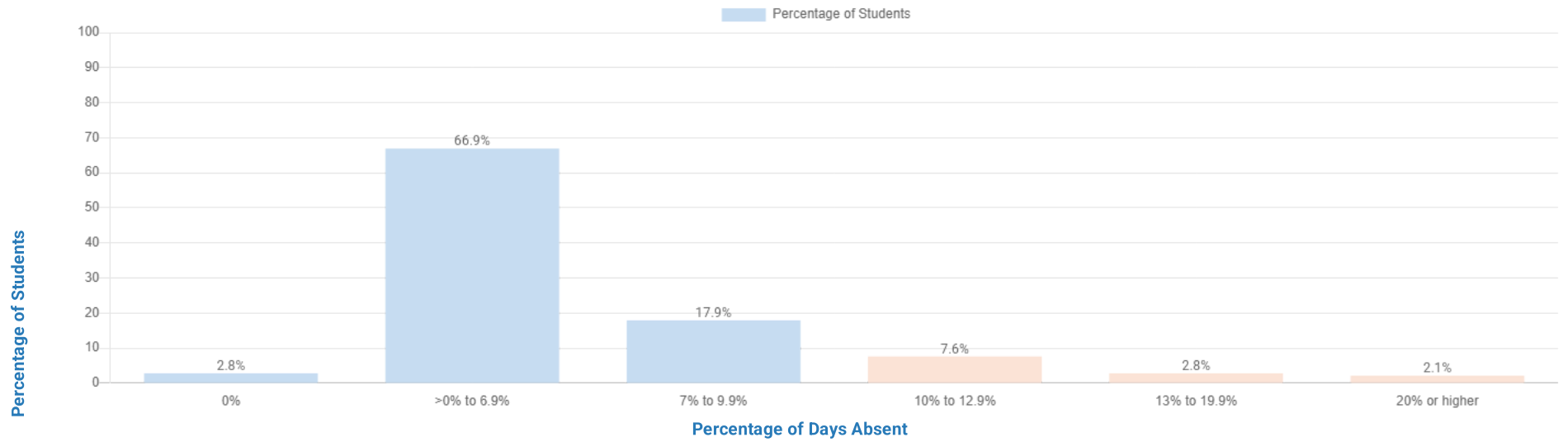

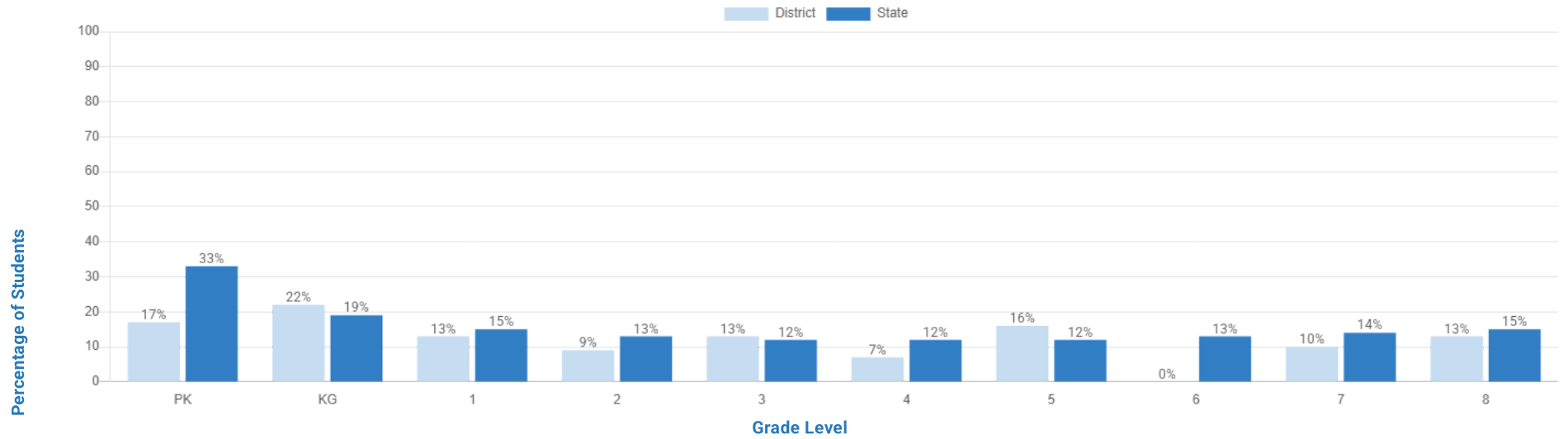

Courses, Curriculum, Instruction:

The Lower Alloways Creek School District is committed to providing a standards-based, student-centered learning environment. Our educational approach is enhanced by 1:1 technology and innovative programs such as Boost Reading, IXL, i-Ready, Raz-Plus, Newsela, Flocabulary, and Sarah's Spanish. We have implemented new, research-based curricula in English Language Arts, including Amplify CKLA for grades K-5 and Common Lit 360 Pro for grades 6-8. This year, we also adopted Amplify Science for grades K-8, empowering students to think critically and engage in scientific inquiry through interactive investigations. Our district prioritizes the use of diverse materials and resources to ensure all students see themselves reflected in their learning experiences, fostering a more inclusive community. Additionally, staff will receive training in the Nurtured Heart Approach this year, aimed at building healthy relationships with students and developing strategies for enhancing self-regulation skills.



Sports and Athletics:

Although we do not have school affiliated sports teams, the township offers a variety of sports our students can play. Many of the teams use our facilities and their victories are celebrated within our school community.



Clubs and Activities:

LAC offers a variety of clubs and activities including Yearbook, Walking Club, Math Showcase, Science Fair, Girls that Code, Yoga/Mindfulness, Student Council, and National Junior Honor Society. Our students participate in Salem County's Ag Day and Junior Achievement.

Before and After School Programs:

LAC offers homework center four days a week for students in grades 3-8 with a certified teacher. We also offer a morning and afternoon Latchkey program five days a week to all students.



Staff and Professional Learning:

The LAC teachers and staff fulfill all mandated training as required by the New Jersey Department of Education. This year, professional development encompasses topics such as increasing attendance, managing challenging student behaviors, and implementing new programs including Amplify CKLA, Common Lit 360 Pro, and i-Ready. Additional training included Nurtured Heart Training, Handle with Care, Junior Achievement/Biz Town, trauma-informed practices, CPR training, and coaching for Amplify CKLA. Monthly Professional Learning Communities (PLCs) facilitate discussions aimed at enhancing teaching effectiveness and student performance. Future training will focus on artificial intelligence and technology. Staff also participate in the Salem County Professional Development Day to explore mental health topics and workshops that can benefit their students. Finally, staff are encouraged to pursue further professional development workshops aligned with their instructional goals.



Student Supports and Services:

Our school utilizes a comprehensive Multi-Tiered System of Support (MTSS) to enhance academic success for all students through three intervention tiers. In Tier 1, we provide high-quality, evidence-based instruction to every student daily. For those who need extra help, Tier 2 offers targeted interventions via Intervention and Referral Services (I&RS), where students receive focused support and are monitored monthly. Teachers assist Tier 2 students in small groups daily, while a Reading Specialist conducts progress monitoring using mCLASS (DIBELS 8 Universal Screener) and provides more explicit instruction. If Tier 2 interventions are insufficient, students may advance to Tier 3 for more intensive support or referral to the Child Study Team for evaluation. Our flexible MTSS framework ensures tailored support for each student's unique needs. Additionally, we provide weekly tutoring sessions through Varsity Tutors for students struggling academically.

Student Health and Wellness:

At LAC School, students engage in a comprehensive wellness program aligned with New Jersey's standards. They participate in physical education thrice weekly and health class once a week, led by a certified instructor. The curriculum, guided by state learning standards, is complemented by the school nurse's initiatives, including dental fluoride treatments and education on epilepsy and diabetes. The cafeteria manager ensures all meals meet New Jersey Healthy Schools guidelines, offering nutritious and appetizing options for students and staff. Elementary students also benefit from daily 30-minute recess periods, promoting a well-rounded approach to physical health and well-being throughout the school community.



Parent and Community Involvement:

The LAC PTO is a dynamic group of dedicated parents and educators who gather monthly to enhance our school community through various engaging events. These include Trunk or Treat, themed dances, school assemblies, field trips, and Field Day, all aimed at fostering school spirit and family connections. To keep parents informed, we utilize multiple communication channels such as our website, Facebook, email updates, and Remind text messages. Parents can also monitor their children's academic progress via the OnCourse parent portal. The GROW Committee, consisting of teachers and administrators, meets monthly to encourage positive behaviors, improve attendance, and increase parental involvement. They organize fun events like the annual Color Run and Thanksgiving flag football game, creating an inclusive environment where students look forward to learning while building community pride and involvement in our school.



Facilities:

The Lower Alloways Creek School District features a single, beautifully maintained building thanks to the diligent efforts of our building and grounds supervisors who ensure timely and relevant upkeep. Fully air-conditioned, the facility has undergone numerous upgrades since the onset of the COVID-19 pandemic, enhancing the learning environment. Our school boasts a cafeteria, a gymnasium equipped with a stage for performances, an expansive library, a science lab, a sensory room, and an art room. Spanning several acres, our grounds support physical education, daily recess, sporting events, community playground access, and host various community events throughout the year. To maintain a healthy environment for our students and showcase our school's beauty, high-traffic areas are sanitized multiple times daily by our dedicated custodial staff.

School Safety:

The LAC school and district had a School Safety audit with the New Jersey Department of School Preparedness and Emergency Planning. The representatives from the NJDOE were very impressed with our safety plans, entry vestibule, safety procedures, practices, and drills. Additionally, they noted how detailed our emergency response plans were including how we would communicate with the school community, county agencies, and emergency responders. The Chief School Administrator and Supervisor of Buildings and Grounds maintain the School Safety Specialist certification to ensure the school and district are aware of any new guidance to ensure the safety and well-being of all students and staff.



Technology and STEM:

The Lower Alloways Creek School is dedicated to leveraging advanced technology and innovative programs to enhance educational outcomes. Our 1:1 Chromebook initiative for students in grades K-8 ensures that all learners have access to essential digital resources. In February, we equipped every teacher with a new Promethean Board, significantly boosting student engagement and participation. Daily, educators utilize a variety of supplemental technology programs, including Boost Reading, IXL, i-Ready, and Newsela, which provide formative assessment data and instructional content aligned with our curriculum and the NJSL. Last year, we revised our curriculum across all subjects to integrate technology effectively. We are also committed to offering professional development workshops focused on emerging technologies such as artificial intelligence. Additionally, our district continues to support the Girls Who Code club, which empowers young women by exploring STEM careers and projects.



Early Childhood Education:

The Lower Alloways Creek School District proudly received the Preschool Expansion Grant, enabling the establishment of two preschool classrooms for children aged three and four. Operating within a traditional school schedule, these classes welcome students at 8:05 AM and dismiss them at 3:05 PM. Our dedicated preschool educators employ the Creative Curriculum, a research-based framework that equips young learners with essential skills in reading, writing, and mathematics through engaging, hands-on activities. This comprehensive approach not only nurtures cognitive development but also fosters social-emotional growth, ensuring that our students transition into kindergarten more prepared than ever. The LAC School District is committed to the success of our preschool program, reflecting our belief in building a strong educational foundation for every child.

LAC is taking a comprehensive approach to combat chronic absenteeism through a multi-faceted Corrective Action Plan (CAP). Teachers and administrators have participated in an "Increasing Attendance" workshop, while the GROW Committee meets monthly to develop incentives and improve the school environment. A dedicated committee of teachers and parents has been formed to address attendance issues and find solutions. The district's strategy emphasizes positive, non-punitive methods, aligning with The Nurtured Heart Approach. Key components of the CAP include referring chronically absent students to Intervention and Referral Services (I&RS) and gathering parental input through surveys to understand the root causes of absenteeism. This holistic approach aims to create a school culture where students are motivated to attend regularly, combining community engagement, professional development, and data-driven interventions to boost attendance rates and foster a positive learning environment.
