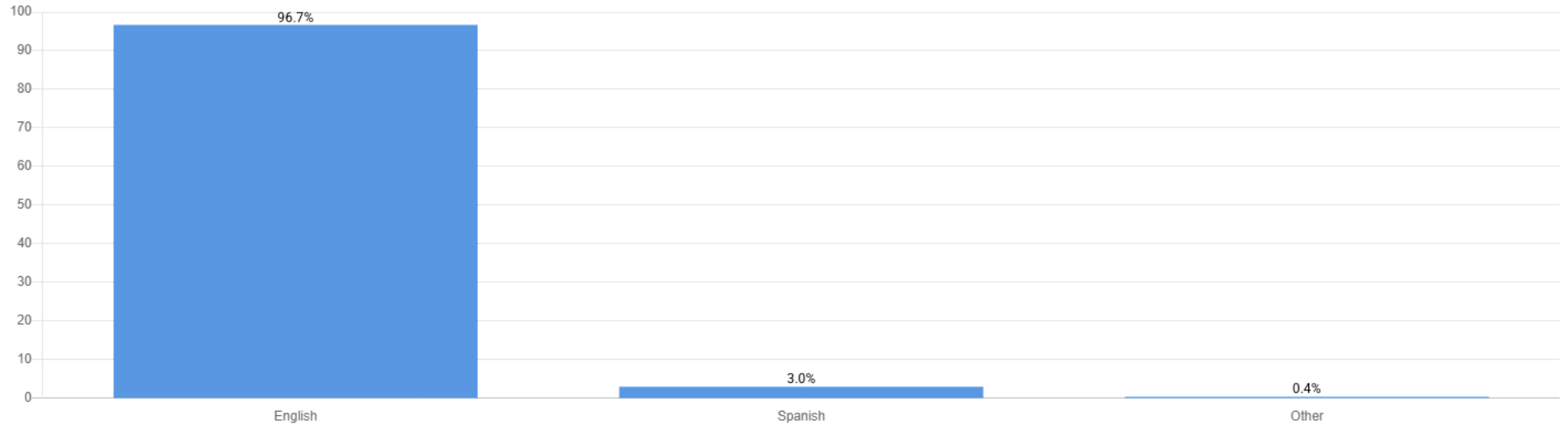

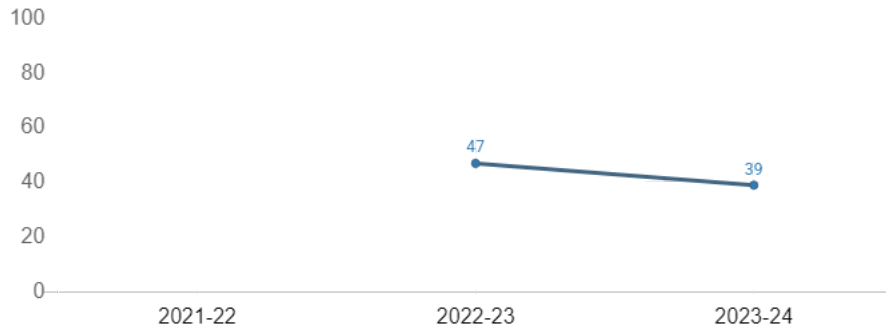

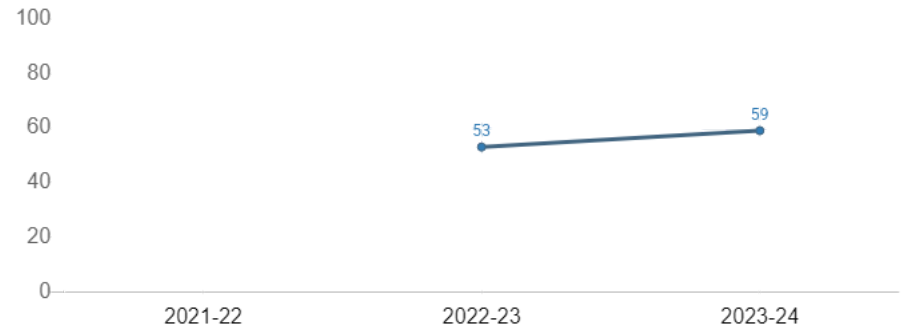

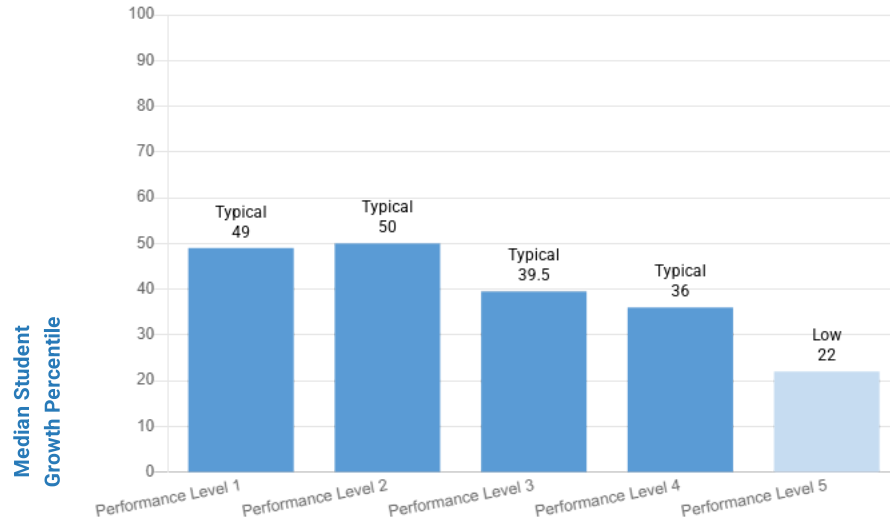

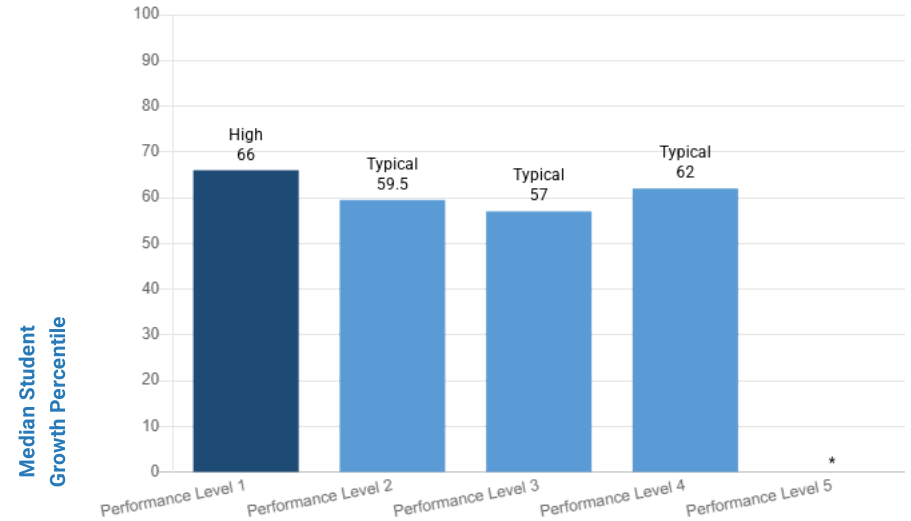

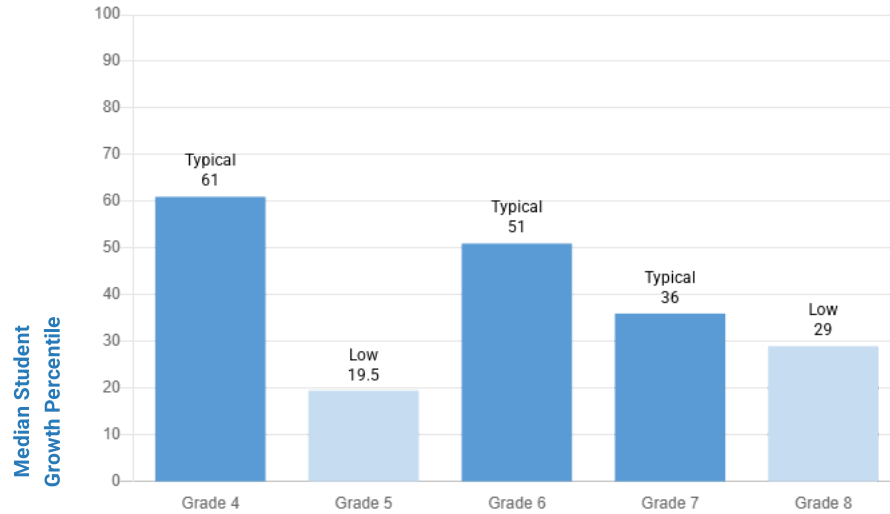

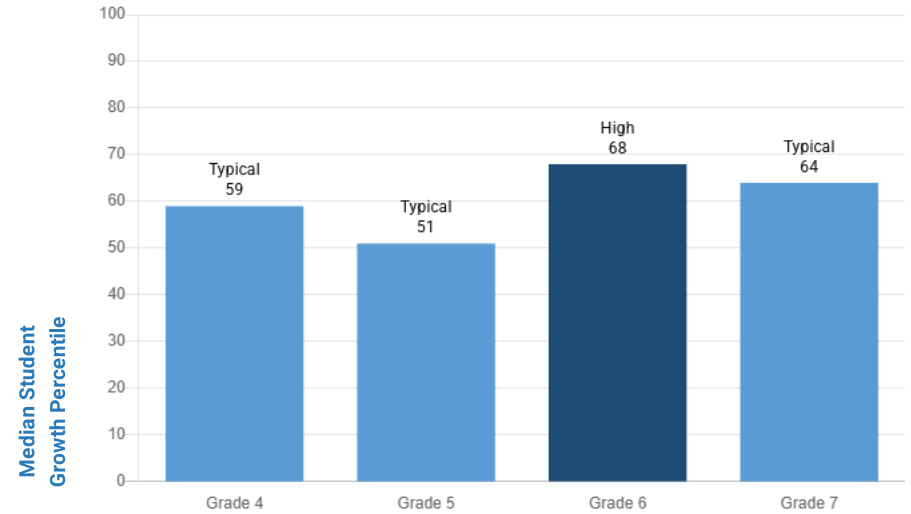

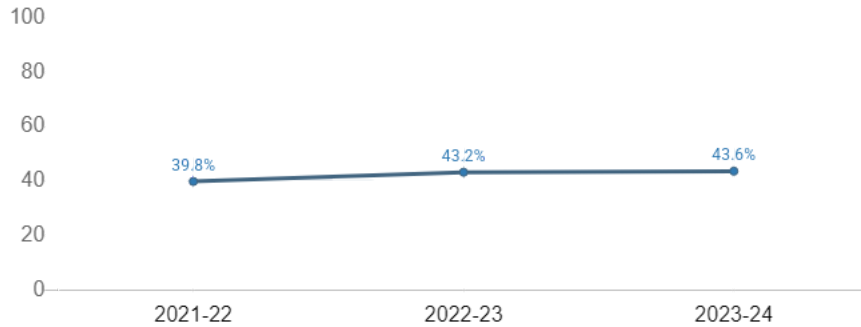

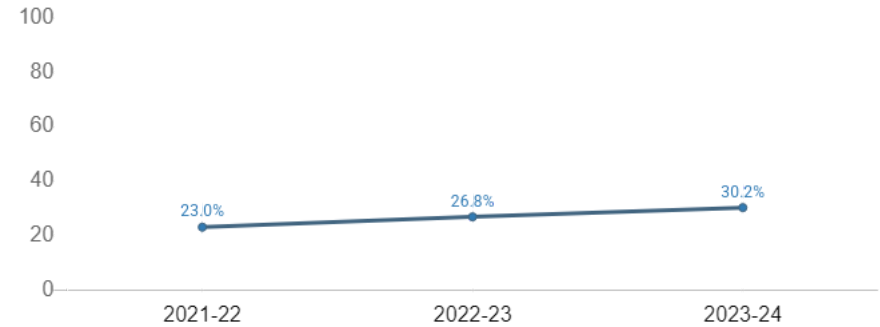
English Language Arts and Mathematics Performance Trends

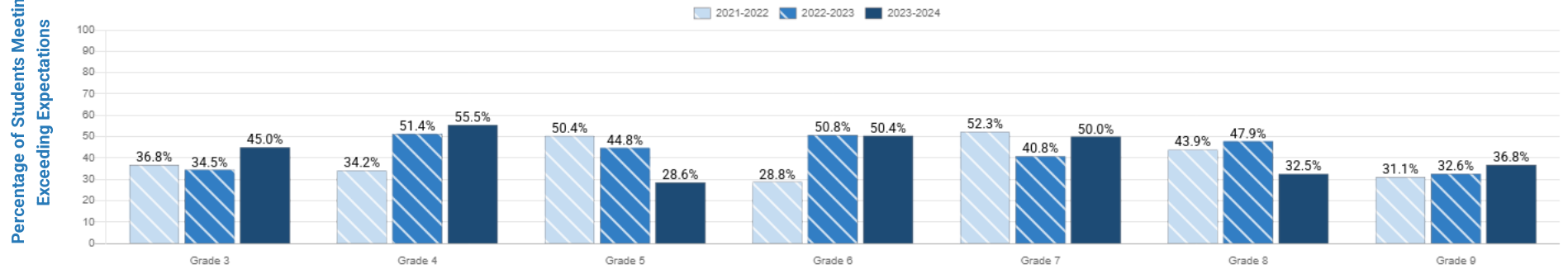

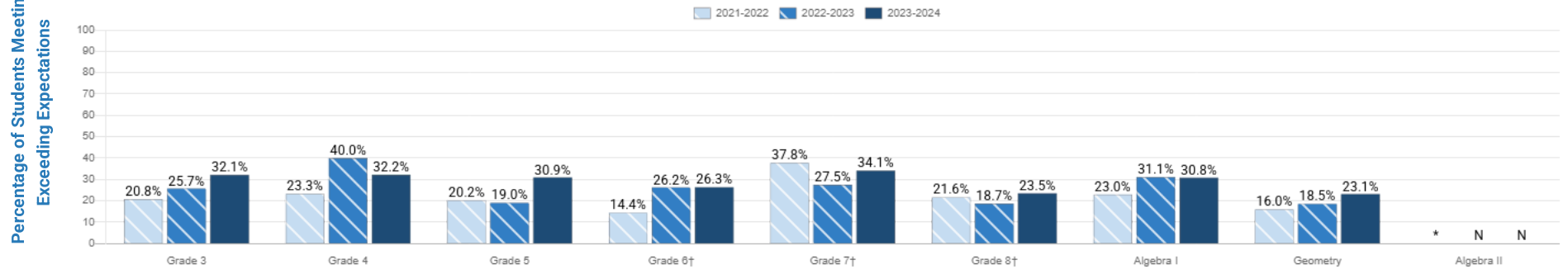

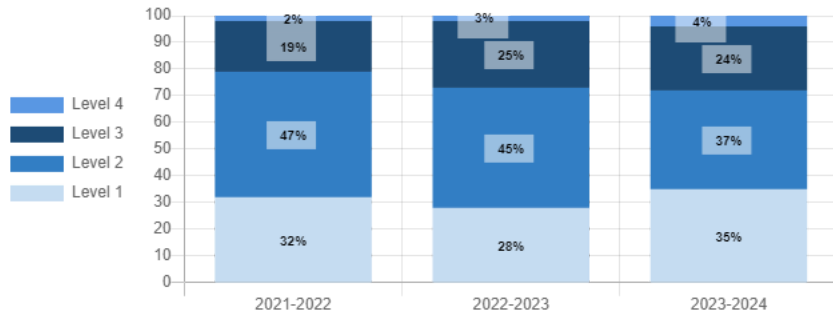

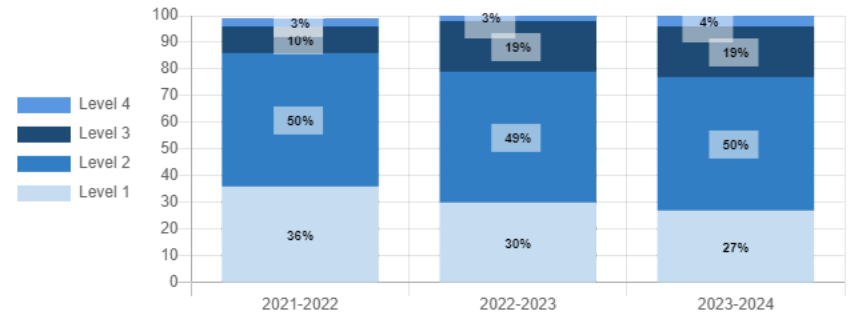
NJSLA Science Assessment: Grade 5 Summary

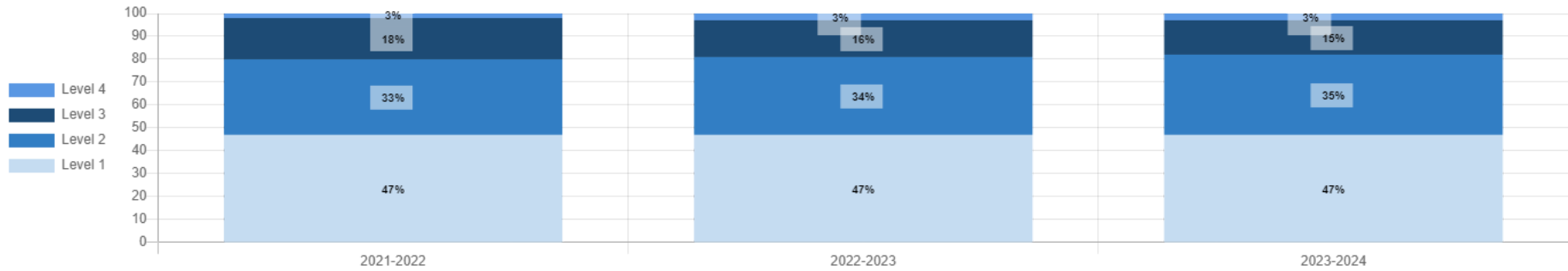

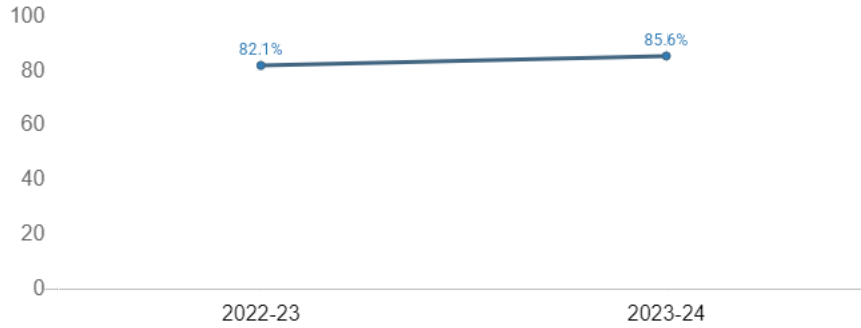

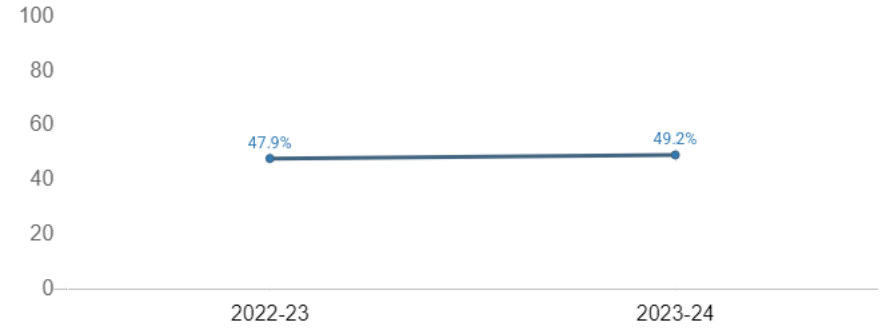

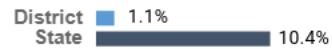

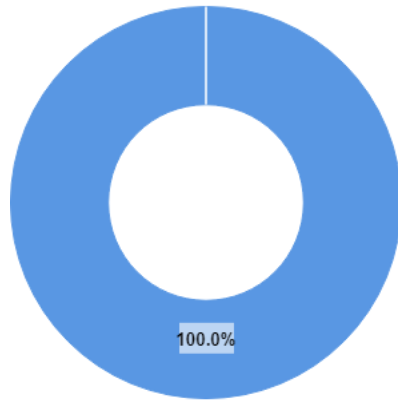

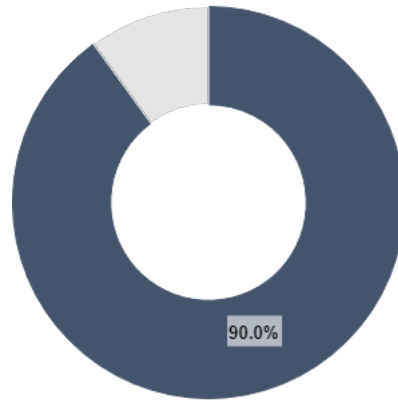
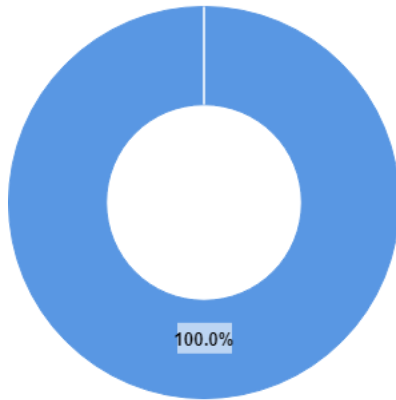

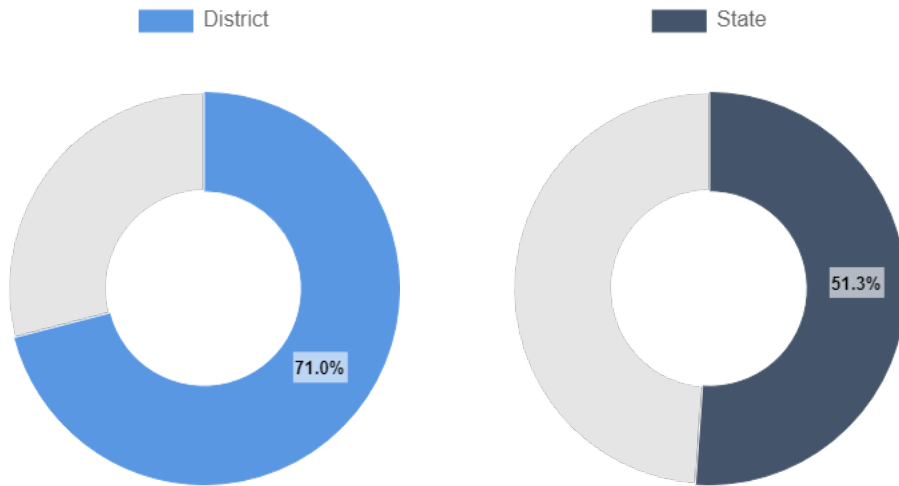

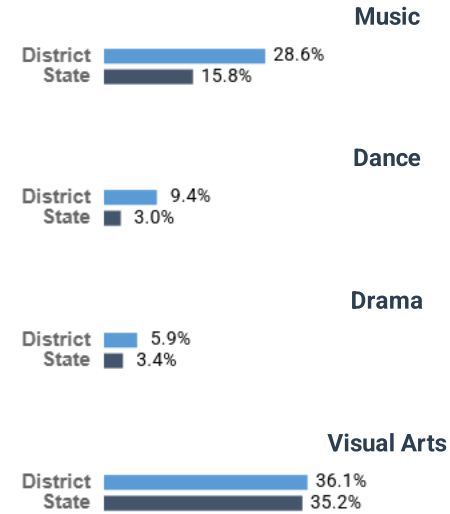

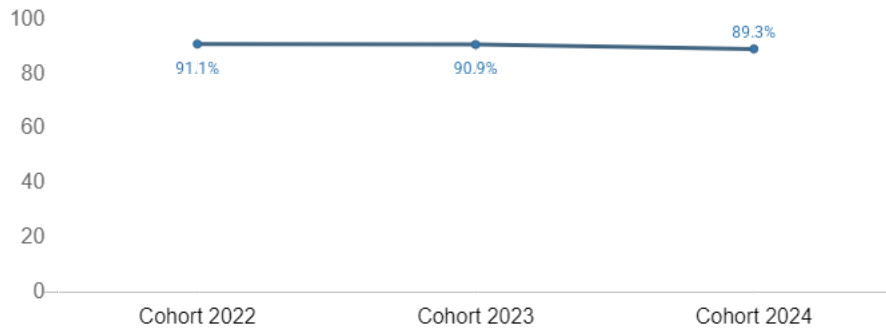

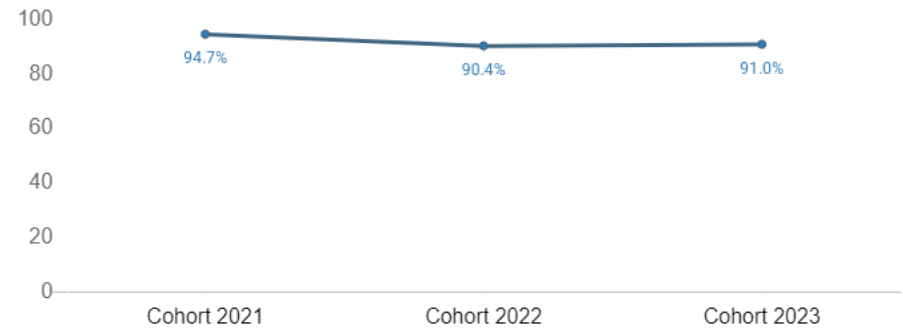

Graduation/ Postsecondary

Graduation rates are calculated based on the adjusted cohort graduation rate calculation. Beginning in the 2020-2021 school year, the NJDOE was required to make changes to the methodology used to calculate the adjusted cohort graduation rate for federal reporting and accountability purposes. The United States Department of Education (USED) determined that the NJDOE must only include students who receive a diploma that is fully aligned with the state's standards, meaning they have met the state's graduation assessment requirements, course requirements, and local attendance requirements. This means that students with disabilities who did not meet some or all graduation requirements because of a modifications or exemption in their Individualized Education Program (IEP) may not be counted as graduates in the calculation of the adjusted cohort graduation rate used for federal reporting and accountability purposes. It is important to note that this was only a change to how graduation rates are calculated for federal reporting. It does not affect requirements to earn a diploma or the type of diploma that the state awards to students with disabilities.

As a result of these changes, the NJDOE began calculating two versions of the adjusted cohort graduation rate starting with 2021 graduation rates. The "federal version" aligns with ESSA requirements and USED guidance and is used for federal reporting and ESSA school accountability only. The "state version" continues to use the same methodology used prior to 2021 and reflects all students who received a state-endorsed diploma.

To be included as a graduate in the federal version of the graduation rate, students must have met state course requirements and local attendance requirements for graduation. Additionally, students must meet the graduation assessment requirements in place based on the year they are graduating, regardless of their graduation cohort. The graduation assessment requirements for the classes of 2022 through 2024 have differed as a result of executive orders in response to the pandemic and new legislation. As a result, the calculation of the federal version of the graduation rate has also changed.

In this section of the reports, the Graduation Rate Trends and Progress charts and Graduation Cohort Profiles (4-Year, 5-Year, and 6-Year), as well as the graduation rates reported in the Summary Reports, reflect the "state version" of the graduation rate. Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Note for 2023-2024: Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.

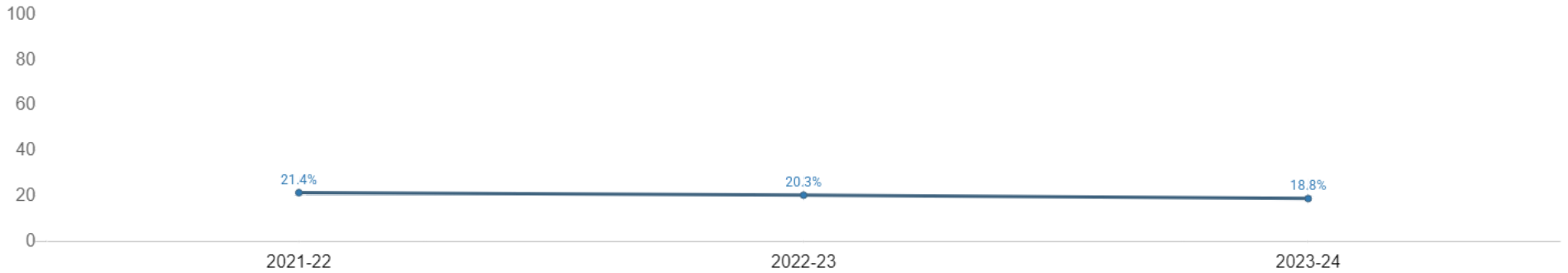

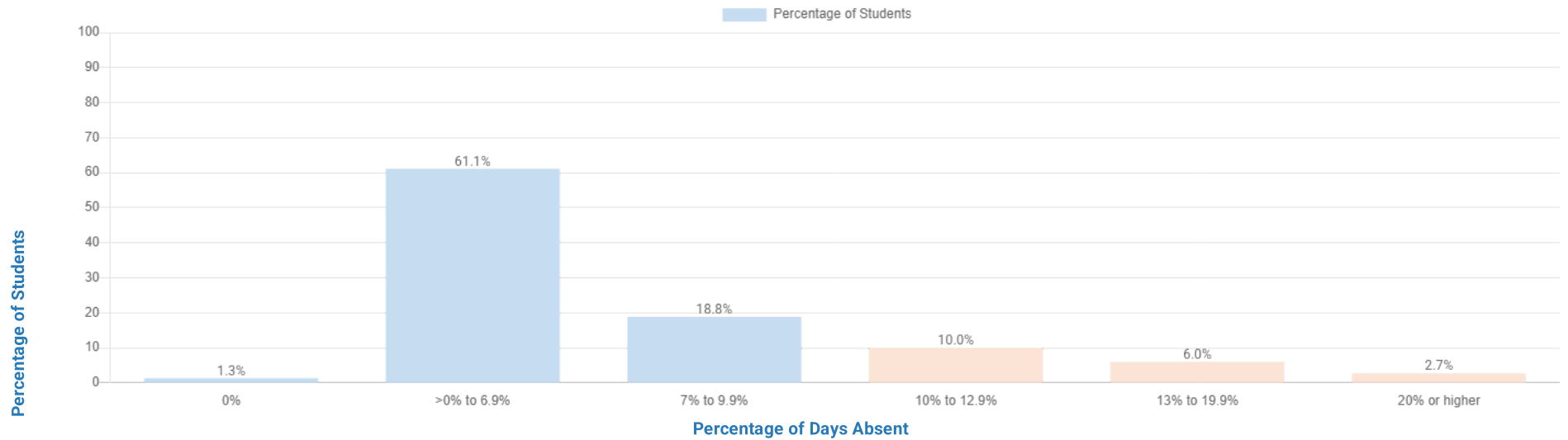

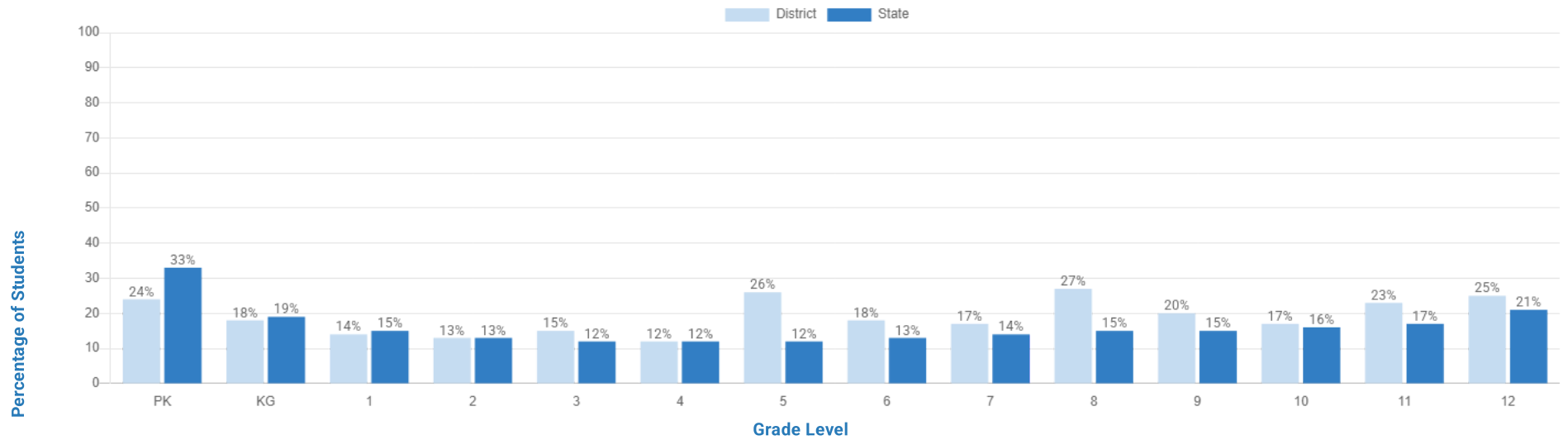

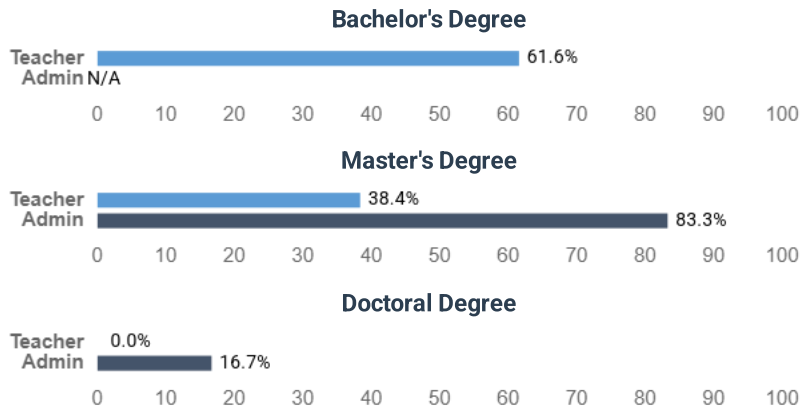

Accountability

New Jersey's Every Student Succeeds Act (ESSA) Accountability System New Jersey's school accountability system identifies schools in need of comprehensive and targeted support as required by the Every Student Succeeds Act (ESSA). Based on New Jersey's [approved ESSA state plan](#), NJDOE will identify schools in the following four federal categories every three years:

- **Comprehensive Support and Improvement (CSI): Overall Low Performing:**
 - Title I schools with a summative score in the bottom 5% of Title I schools.
- **Comprehensive Support and Improvement (CSI): Low Graduation Rate:**
 - All high schools with a four-year graduation rate of 67% or less
- **Additional Targeted Support and Improvement: Low Performing Student Group (ATSI):**
 - All schools with one or more student group with a summative score that would be in the bottom 5% of Title I schools
- **Comprehensive Support and Improvement (CSI): Chronically Low Performing:**
 - Title I schools identified as Additional Targeted Support and Improvement; Low Performing Student Group (ATSI) that are identified for three or more consecutive years, i.e., ATSI schools that do not meet exit criteria.

Annually, NJDOE will identify schools in the following federal category:

- **Targeted Support and Improvement: Consistently Underperforming Student Group (TSI):**
 - All schools with one or more student groups that missed annual targets or standards for all indicators for two years in a row

For purposes of ESSA accountability, only schools and student groups with data for 20 or more students are included in calculations.

The NJDOE identified schools for CSI and ATSI status in fall 2023 based on data from the 2022-2023 school year, so the NJDOE did not identify schools for CSI or ATSI status based on 2023-2024 school year data. The NJDOE only identified schools for TSI status based on data from the 2023-2024 school year.

Our students are recognized each month at our Board of Education Meetings. The students are recognized for showing P.R.I.D.E. (Patience, Respect, Integrity, Diligence, Empathy), which is our District's motto. Each year, our District participates in the Governor's Educator of the Year Program. Staff members are nominated and recognized for their commitment to the education profession.



Courses, Curriculum, Instruction:

Our K-12 programs offer a comprehensive curriculum to meet the needs of our student learners and to promote the academic and personal growth of each child. The District strives to build learners who embrace both a design-thinking and growth mindset as well as become creative, collaborative problem-solvers and leaders. The District implements an RTI framework at the K-8 levels in order to provide both intervention and enrichment in the following areas: STEM, Visual and Performing Arts, Literacy, and Math/Financial Literacy. The District has expanded its STEAM offerings in grades K-12 through its partnership with Project Lead the Way. The high school offers five programs of study pathways: Health Science and Medicine, Engineering (STEM), Information Technology, Business, and Education. The high school is also a host site to our Exercise Science and Kinesiology, Dance, Theater, and Visual Arts Academies.

Before and After School Programs:

The Pittsgrove Township School District offers a School Age Child Care (SACC) Program both before and after school. The SACC Program services approximately 180 children from Norma, Elmer, and Olivet Elementary Schools and the Pittsgrove Township Middle School. The SACC Program promotes the PRIDE motto of the school as well as continues the vision of building students who are problem-solvers, design-thinkers, and leaders.



Staff and Professional Learning:

The Pittsgrove Township School District supports and encourages the professional growth of its staff members. Both full and half-day staff professional development (PD) days are used for training, curriculum work, and collaboration to accomplish district and school goals. Staff also facilitate in-house professional development through PLC sessions and/or workshop sessions. Staff members are also afforded opportunities to attend out-of-district professional development workshops. Teachers also engage in peer observation programs within the district. The administrative team engages in professional growth with a leadership coach.

The District encourages parent and community involvement and views parents/guardians as our partners in education. The District has a CPIS (a Community Parent Involvement Specialist) that supports the home and school connection at the Preschool level as well as organizes and hosts the Early Childhood Advisory Council meetings for parents of students in grades PreK-4. The CPIS hosts a series of parent workshops throughout the school year. Our community has an active Parent Teacher Organization (PTO), which assists in supplementing funds for field trips/field day activities and other school improvement projects. In addition, we have a Special Education Parent Advisory Group (SEPAG), which meets several times during the school year. The District holds numerous events and activities throughout the year to promote parent and community involvement.



Climate Surveys:

The District has active school climate teams as well as has established a district Equity Committee that work to create, administer, and analyze the survey data from students, parents/guardians, teachers/staff, and administrators to work toward a more equitable school experience.

By taking a proactive approach and having plans in place to keep students and staff safe, we have preventative and protective measures to stop an emergency from occurring or reduce the impact of an incident. Armed School Security Specialists provide security monitoring throughout our school day and after-school activities. Our district is equipped with state-of-the-art security surveillance and communications systems. Drills are conducted as required, and additional efforts are planned and practiced to respond to emergencies, if ever needed. School safety is a shared responsibility - staff, students, parents, and the entire community. Students and staff are trained to report any safety issues or concerns.

Technology and STEM:

Our vision for blended learning is that strategic, purposeful instruction is supported through educational technology, and that we achieve the vision of ALL-ED (all learners learning every day). Blended learning increases differentiation, personalization, engagement, and relevance. We want to build self-directed, independent learners. A blended learning classroom focuses on the student and provides an increase in choice, path, pace, time, and direction for learning. The District utilizes and implements the Project Lead the Way curriculum/programs for grades 5-12. Students are exposed to various interdisciplinary modules and courses that empower students to adopt a design-thinking mindset, and students are engaged in projects and challenges in the areas of computer science, engineering, and biomedical science. Through this STEM pathway, students are building their skill set to be creative, collaborative problem-solvers.



Early Childhood Education:

Norma Elementary School offers a free state-funded inclusion preschool program for three-year-old and four-year-old children in our community. Our program starts at 8:00 a.m. and ends at 2:00 p.m. with a maximum allowable class size of 15 students. The Pittsgrove Township School District also has partnered with a private provider (Firm Foundations) to open more classrooms to Pittsgrove residents through the free state-funded preschool program.
