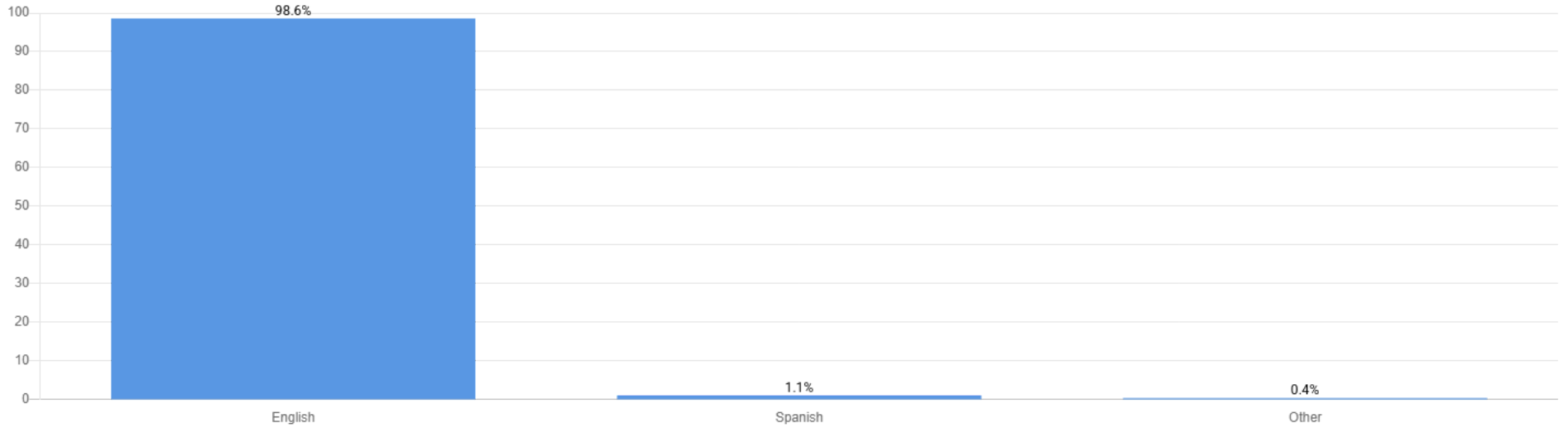

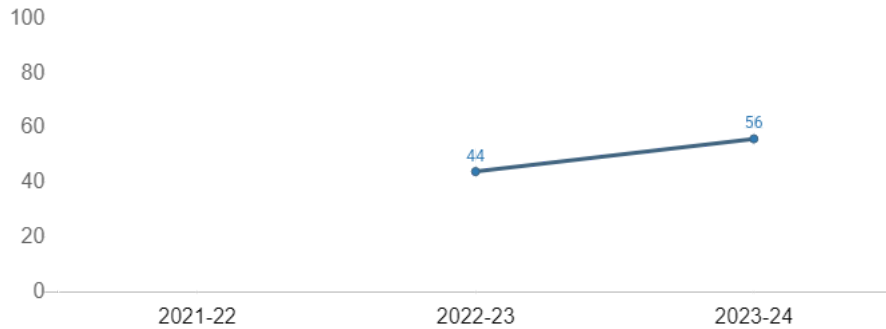

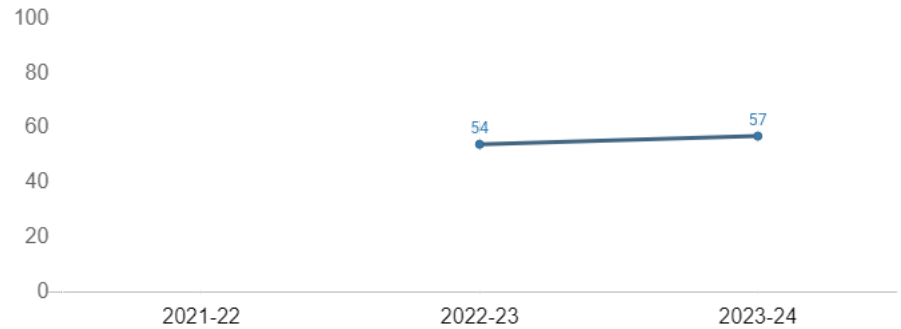

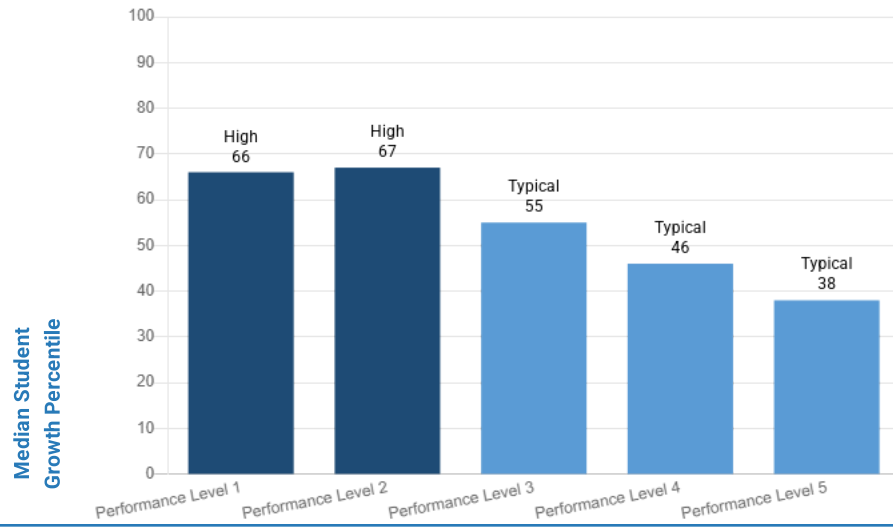

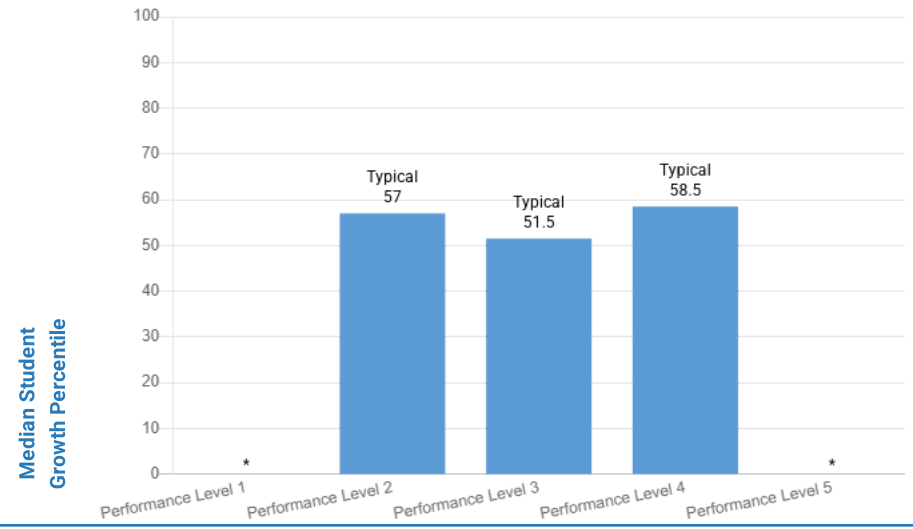

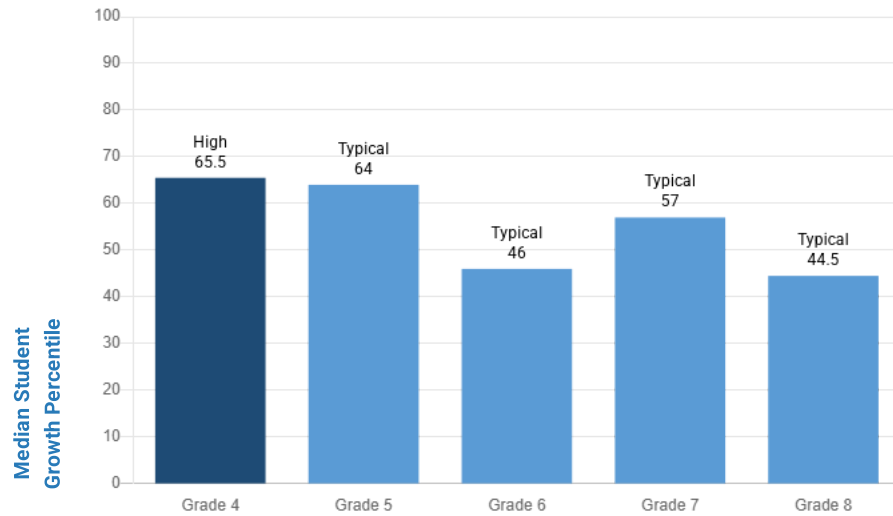

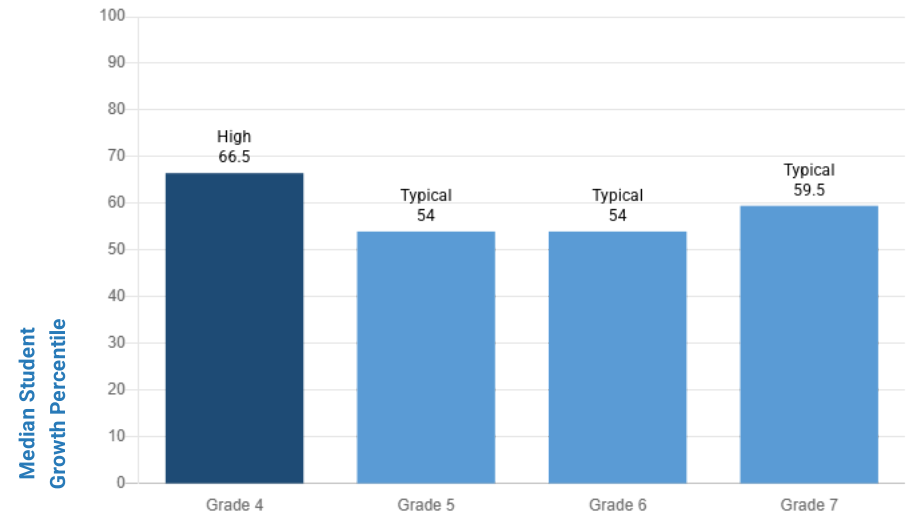

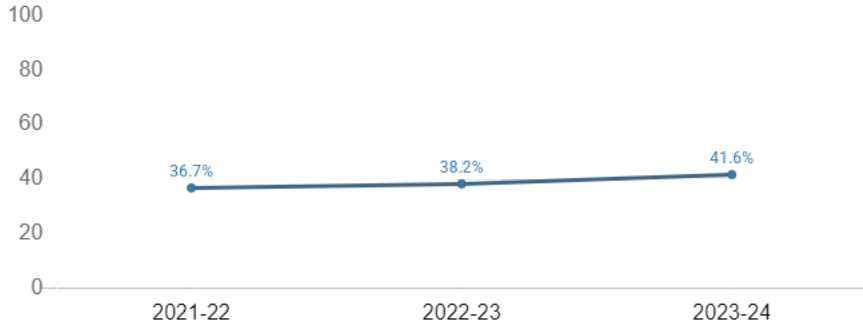

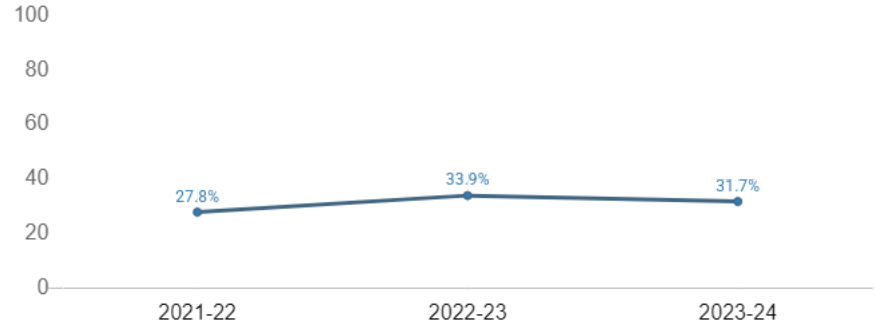
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 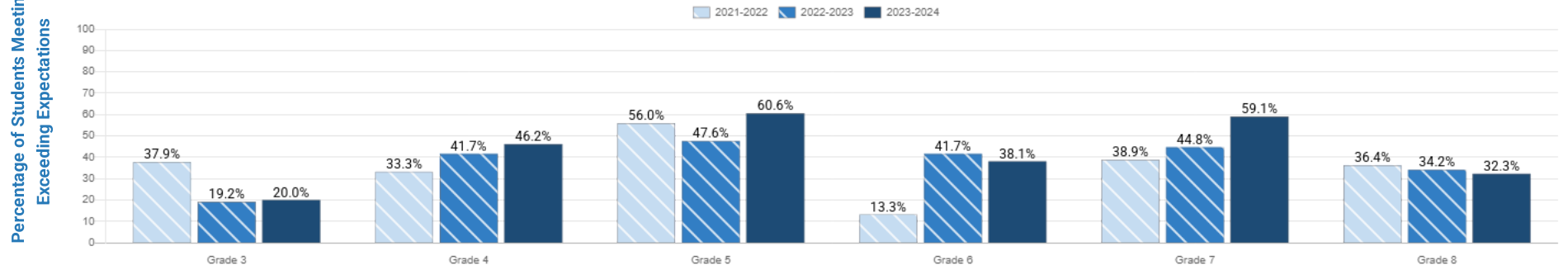

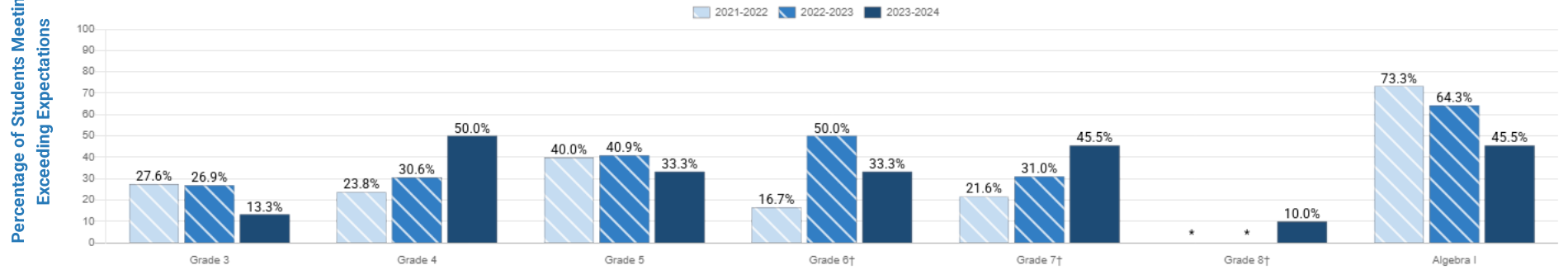

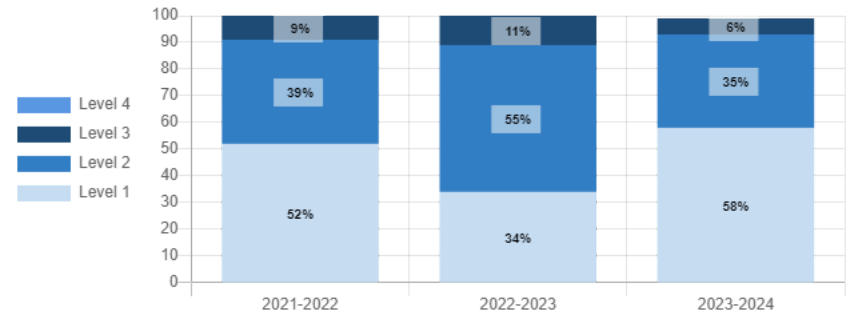

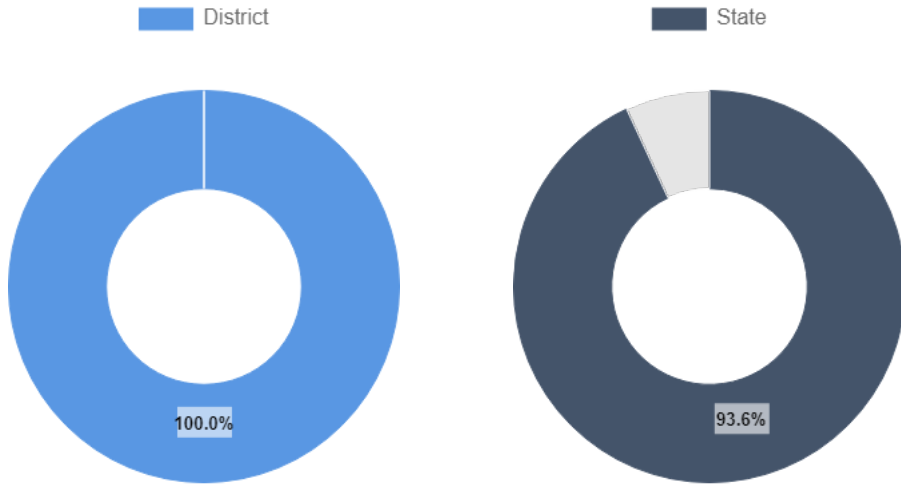

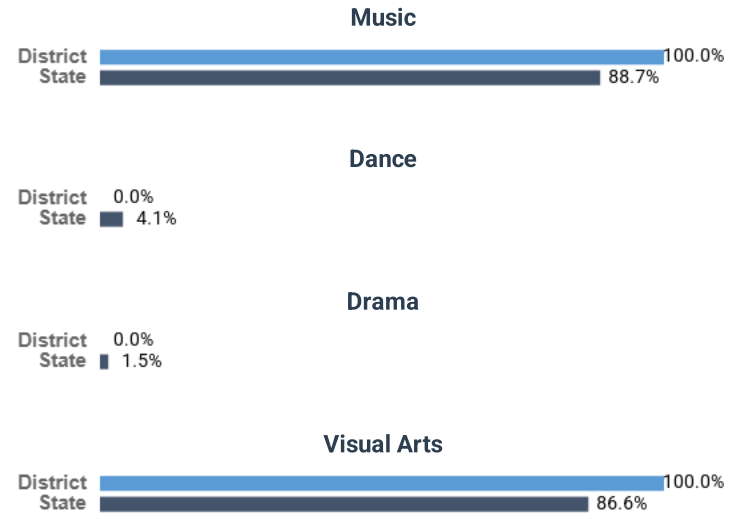

Students enrolled in one or more classes by discipline:



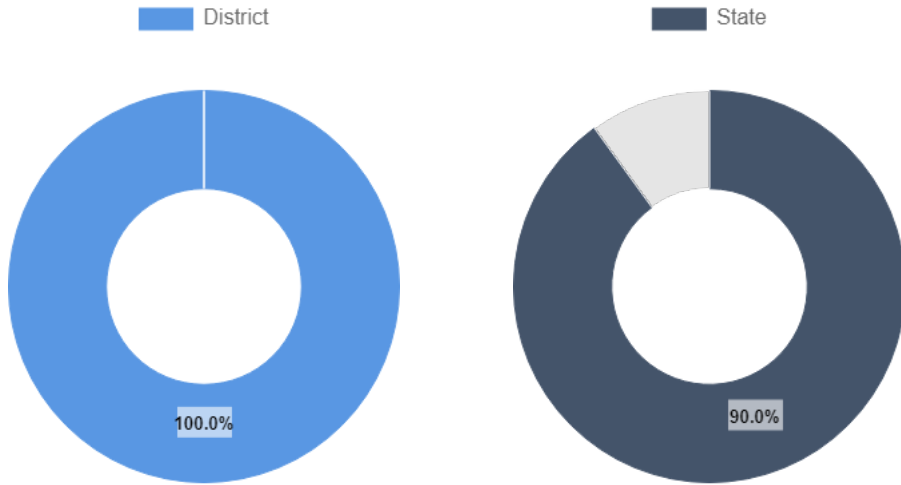

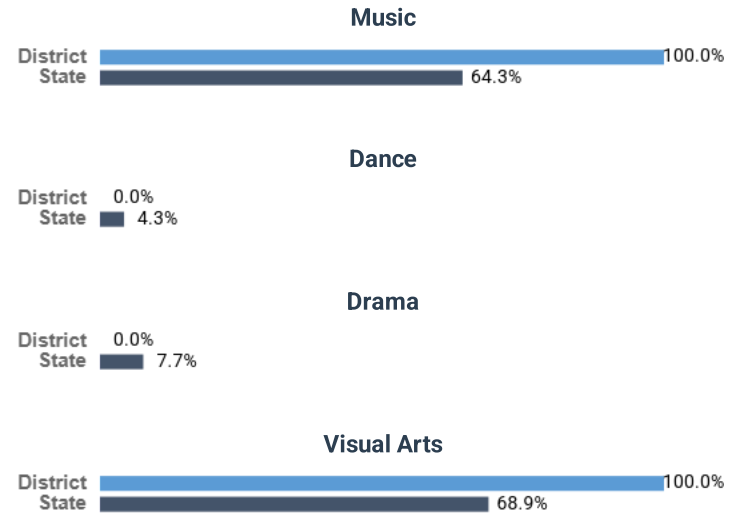

Students enrolled in one or more classes by discipline:

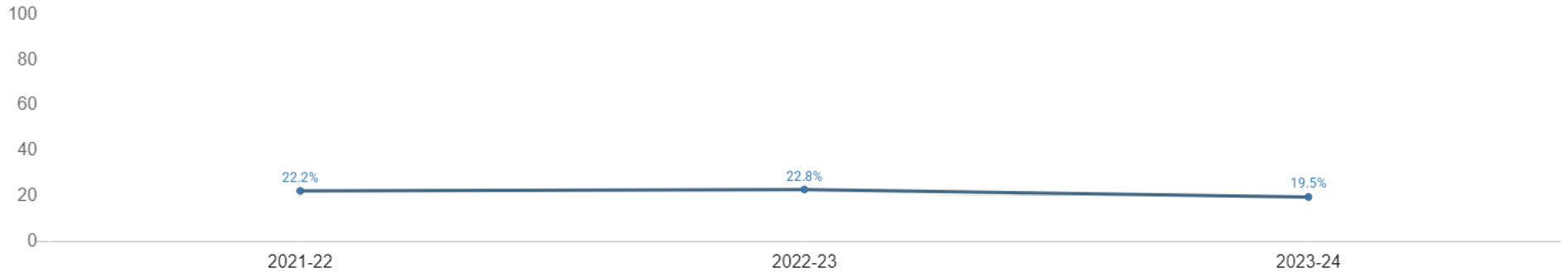

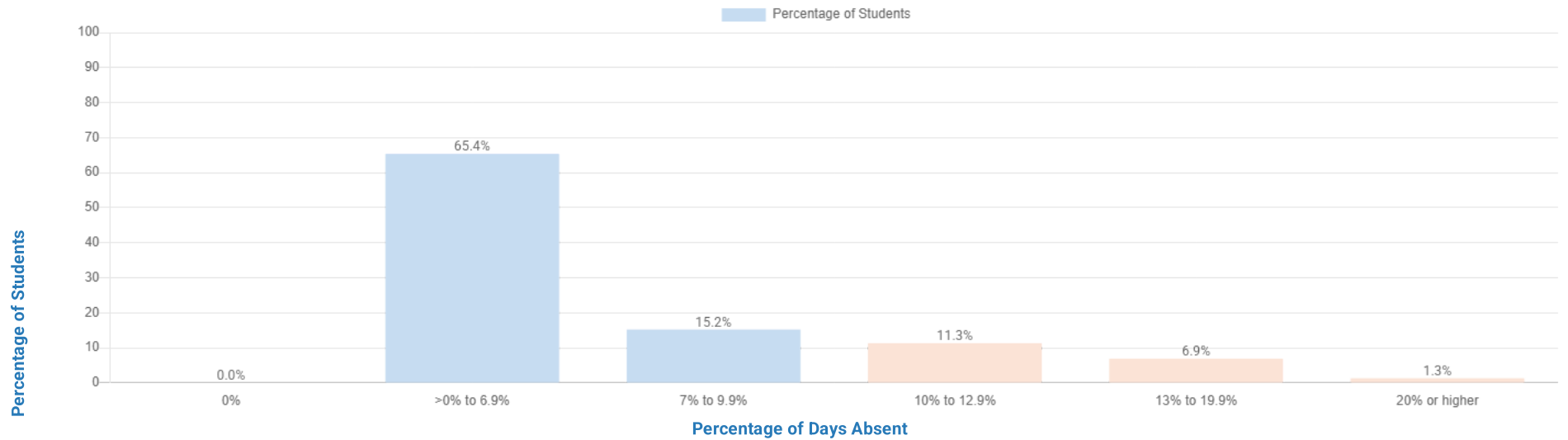

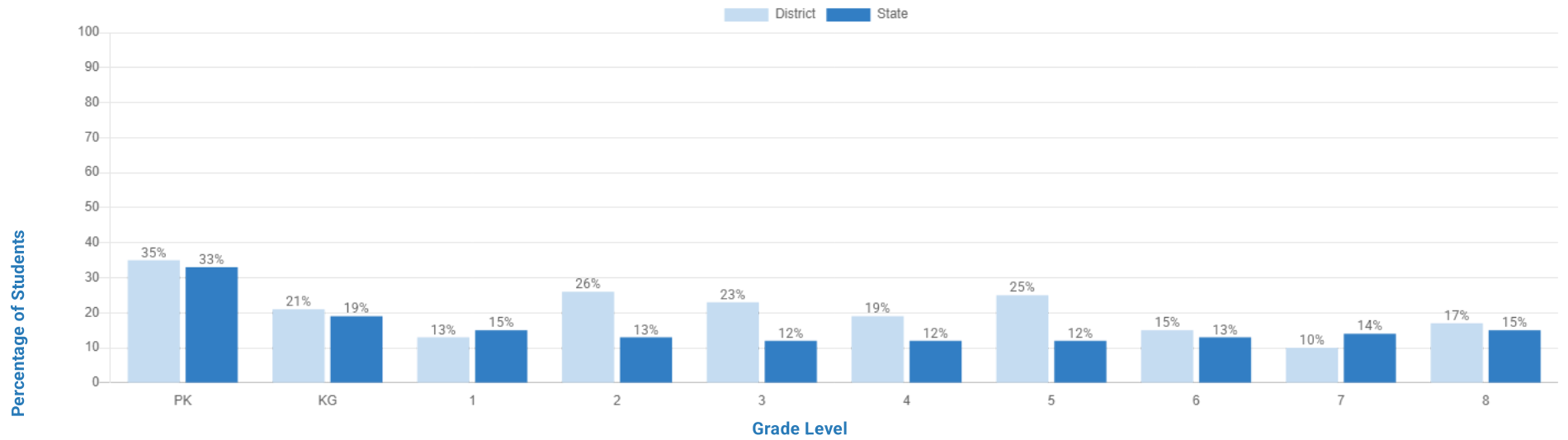

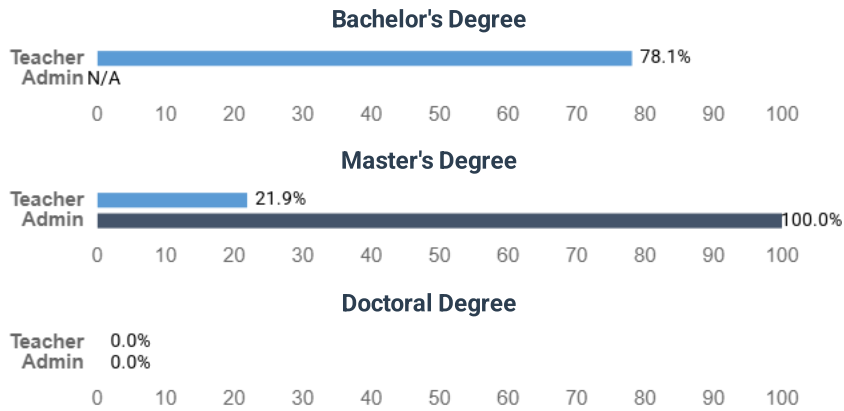

Facilities:

The building was built in 4 sections: 1928, 1950, 1980, 2001 We have a Library, one iPad cart, art room, multi-purpose room, and music room. The entire building has air conditioning. Our facilities are well-maintained and the district has already benefited from the solar panel purchase and installation (2012). Each classroom has a SMART Board as well as other technological devices for our students and staff to utilize. The carpeting has been removed in most parts of the building and replaced with vinyl flooring.



School Safety:

The district takes all necessary steps to ensure the safety and well being of both the students and staff. The district holds monthly crisis and fire drills. The district has updated the camera system which is clearer and more accurate. The district has installed a vestibule for added security, and well as new steel doors to replace glass doors. The district uses the PBSIS program and a student peer mediation program to promote a healthy and safe environment. Administration partners with the county law enforcement agencies to ensure we are following all guidelines and safety procedures. Administration participates in ongoing training on school safety and security.

Technology and STEM:

The district's 1-1 technology initiative (grades 1-8) and iPads (K) allows our students to access electronic texts in math, science, social studies and health. Students in grades PK - K utilize iPads with applications that reinforce skills taught in the classroom. Each classroom has a SMART Board as well as other technological devices for our students and staff to utilize. We offer an after school culture club program where STEM activities are taught. There is a family STEAM night each spring. The district also has a mobile iPad cart.



Early Childhood Education:

The district's Early Childhood program is a full day program that runs from 8:20 AM to 3:00 PM. For this school year, there are students in each of four Early Childhood classrooms. We were able to expand from three to four classrooms with the addition of a neighboring school's students when we were awarded the preschool expansion grant. The program uses the Creative Curriculum.

Other Information:

The district's school day begins at 8:30 AM and goes until 3:00 PM. The school has one or two classes in each grade level, depending upon student numbers. Grades six through eight are departmentalized and the students switch classes. Students in grades four switch classes for science and social studies and grade five for math, science and social studies. Students in grade Pre Kindergarten through third stay with the same teacher throughout the day for all subjects/themes. Communication to all stakeholders is done through the district's website, which gets updated regularly. The district sends a weekly ConnectEd message (email and text) to all stakeholders in both English and Spanish. This message goes over all important news and events for the upcoming weeks. Teachers also use Classroom Dojo and Remind 101 to communicate to parents. The district is a Choice School currently with 36 seats. There is usually a waiting list for Choice Students. The district does not accept tuition students since it is a Choice District.
