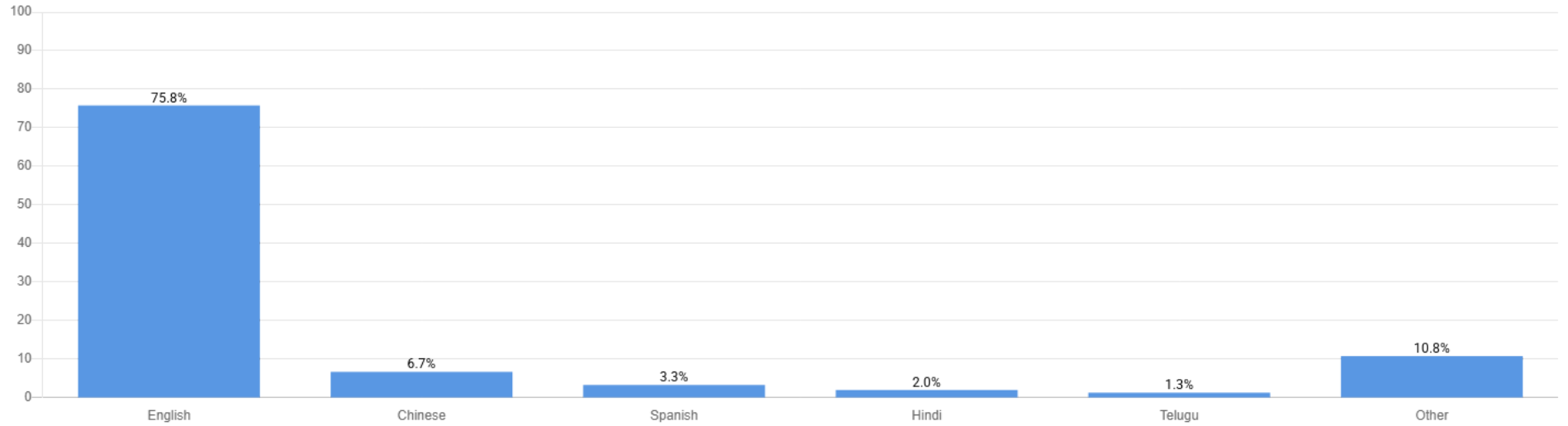

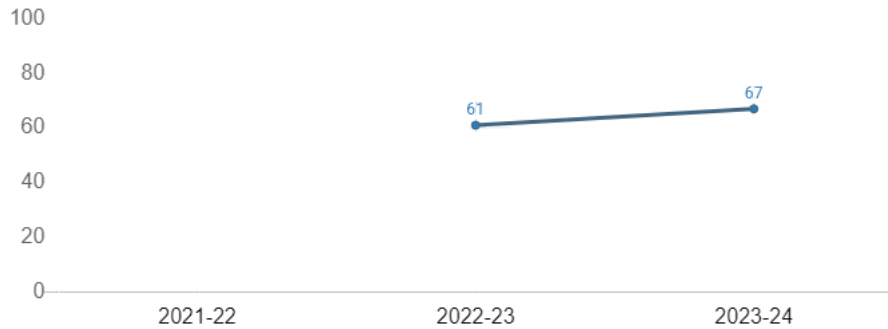

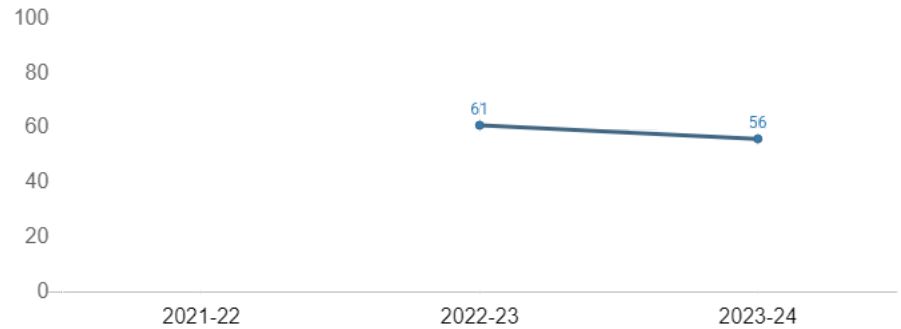

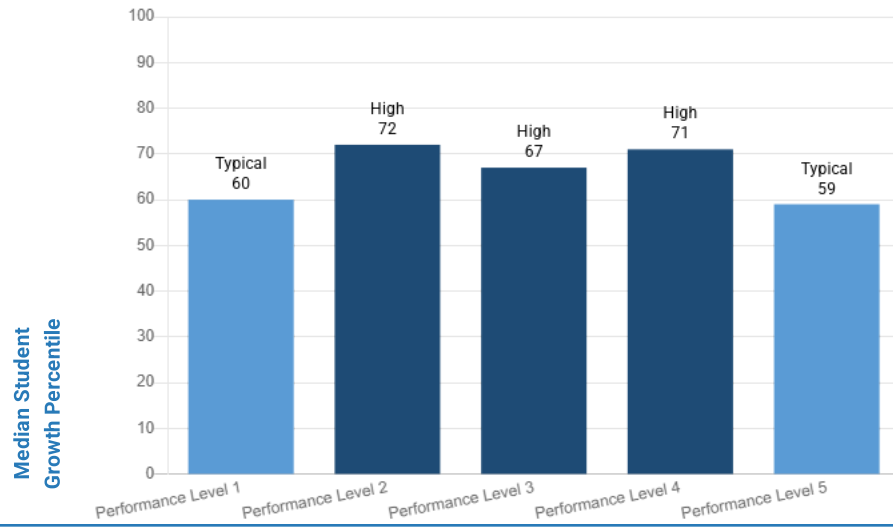

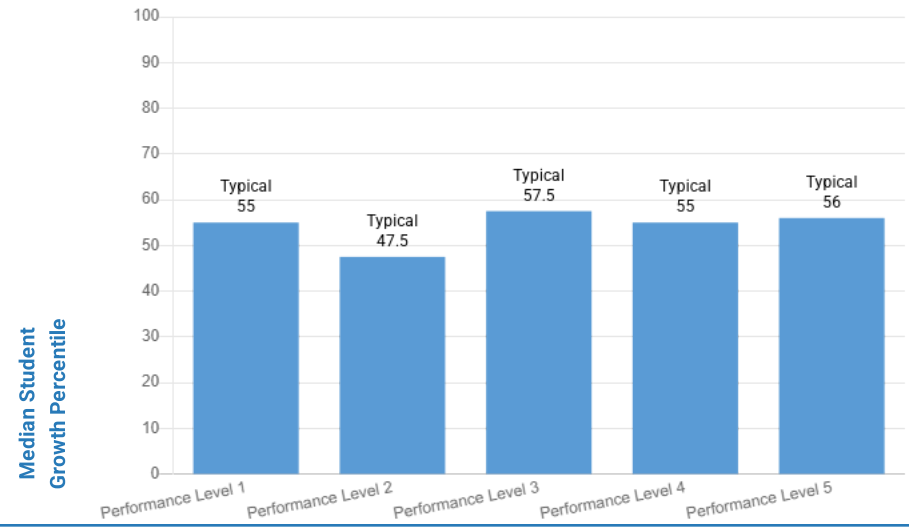

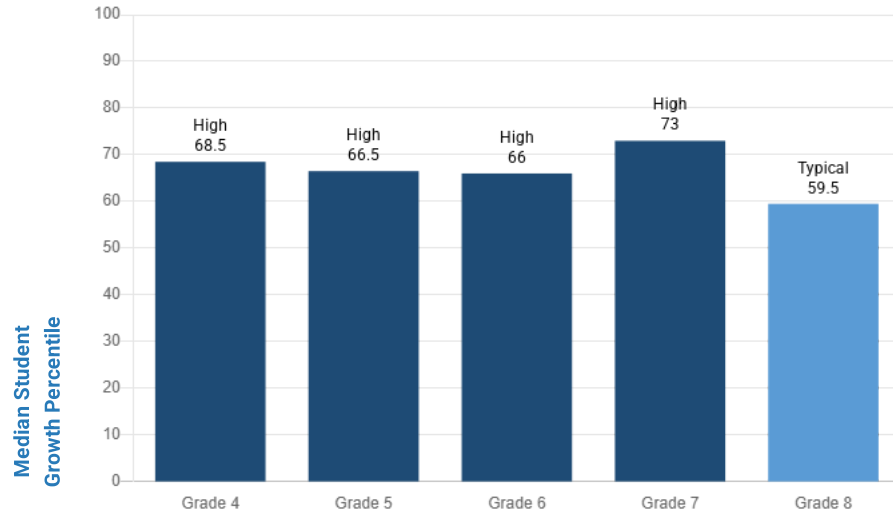

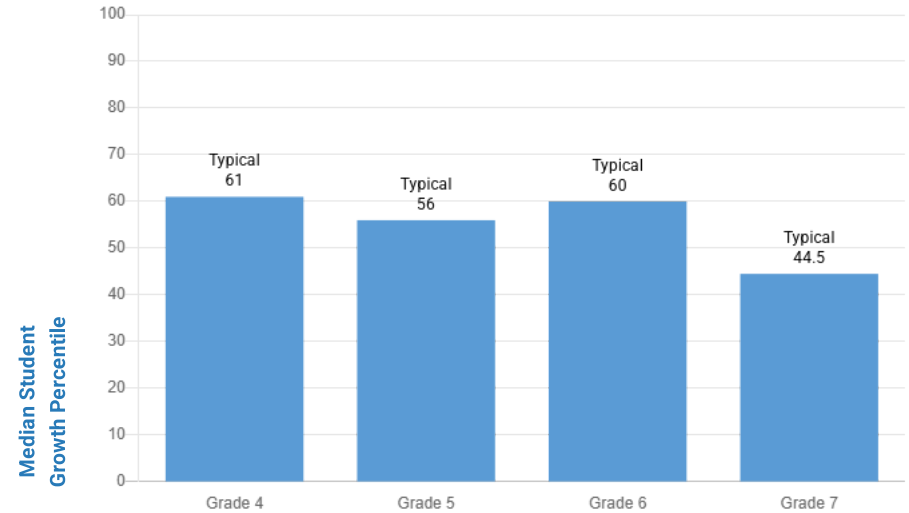

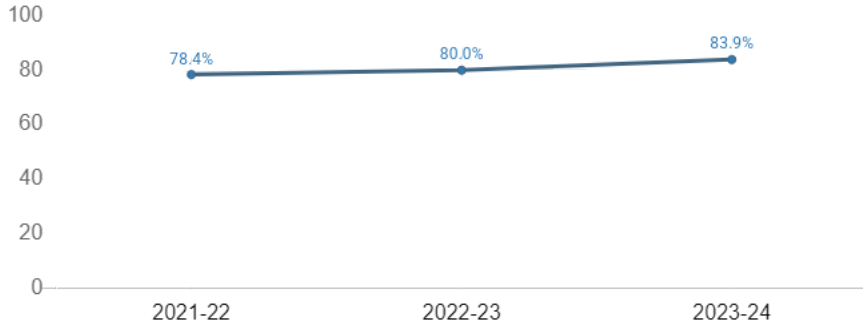

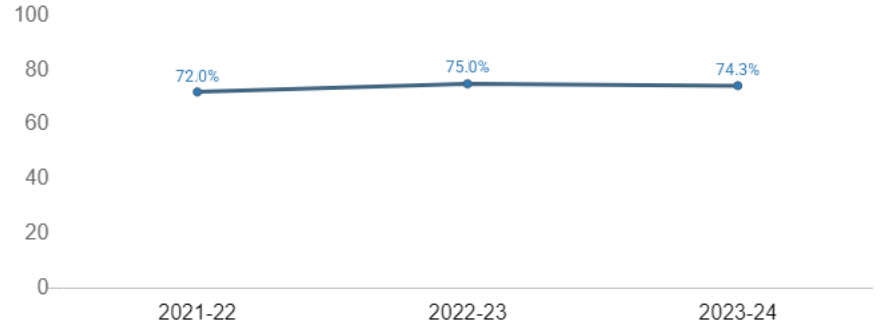
### English Language Arts and Mathematics Performance Trends

### English Language Arts Assessment - Participation and Performance

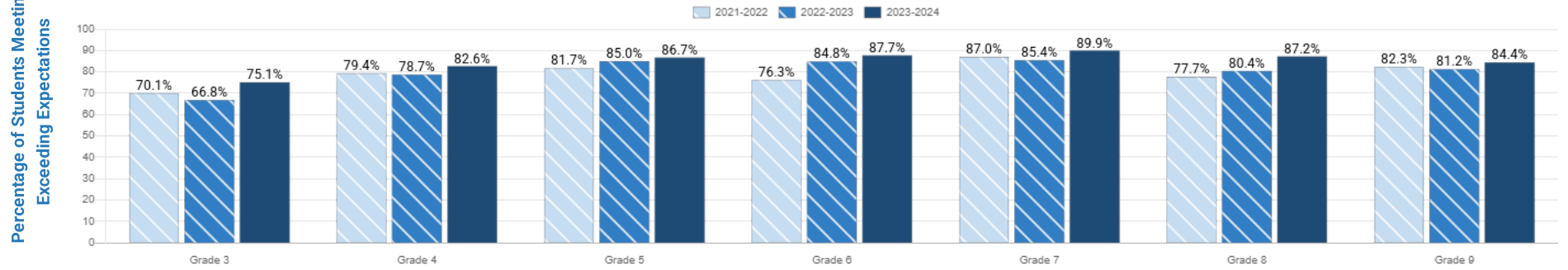

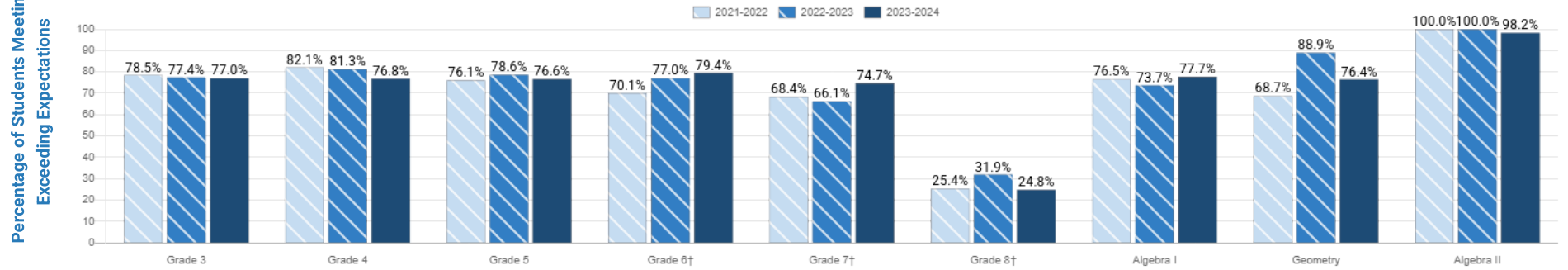

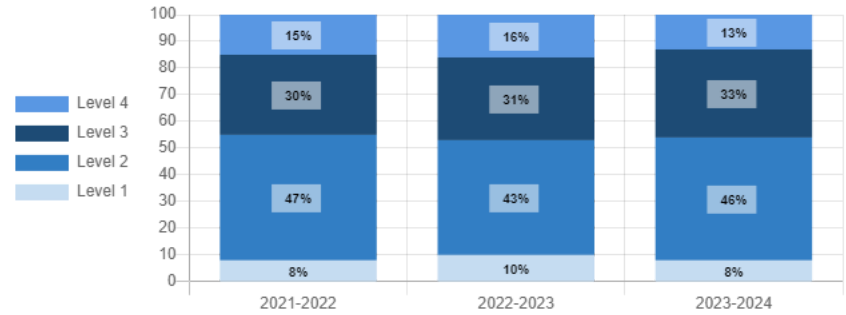
### NJSLA Science Assessment: Grade 5 Summary

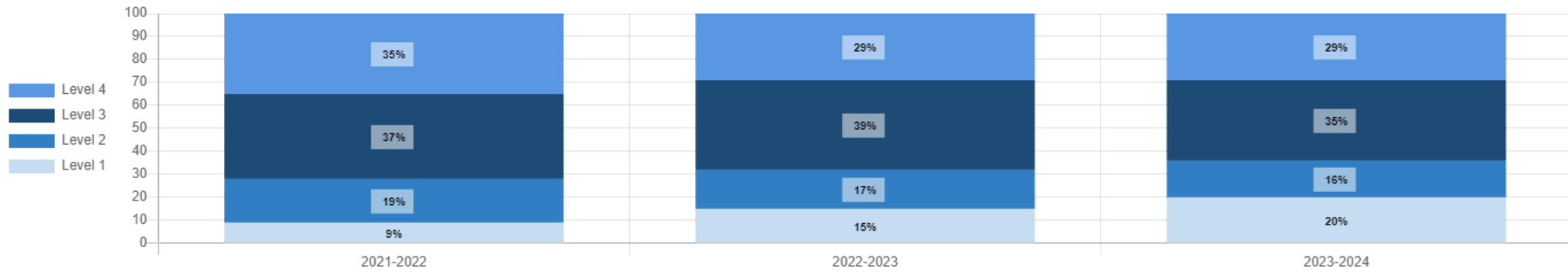

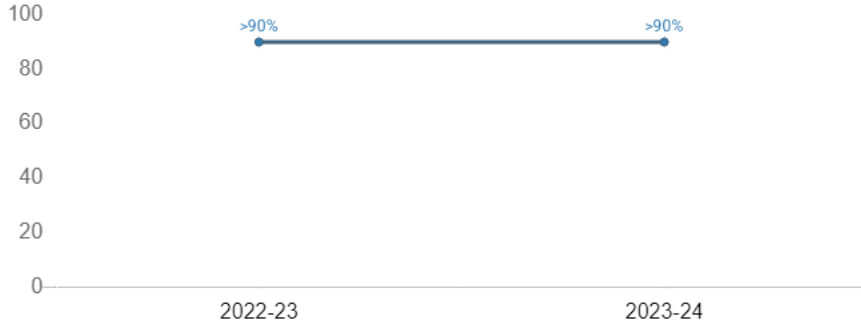

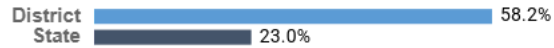
#### Students enrolled in one or more AP or IB course



#### Students taking one or more AP or IB exam

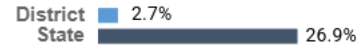


#### Students with one or more exams with a score of at least 3 on AP exams or 4 on IB exam

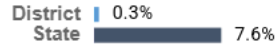

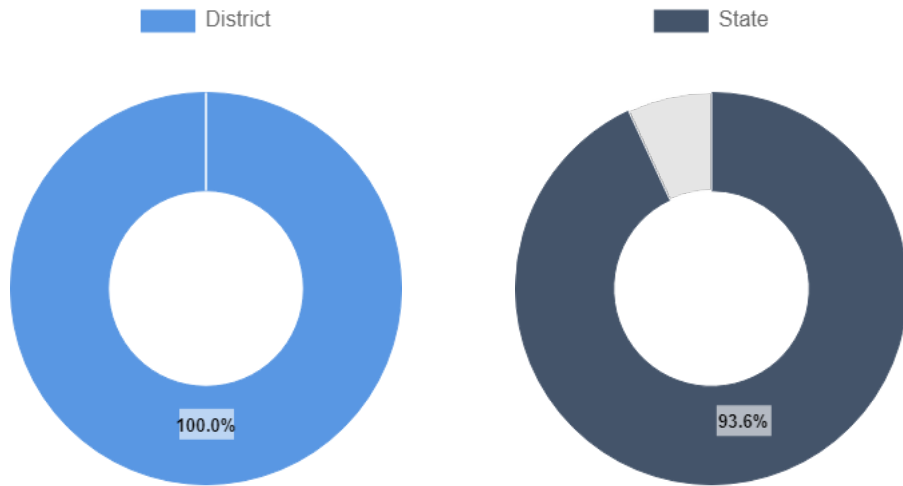

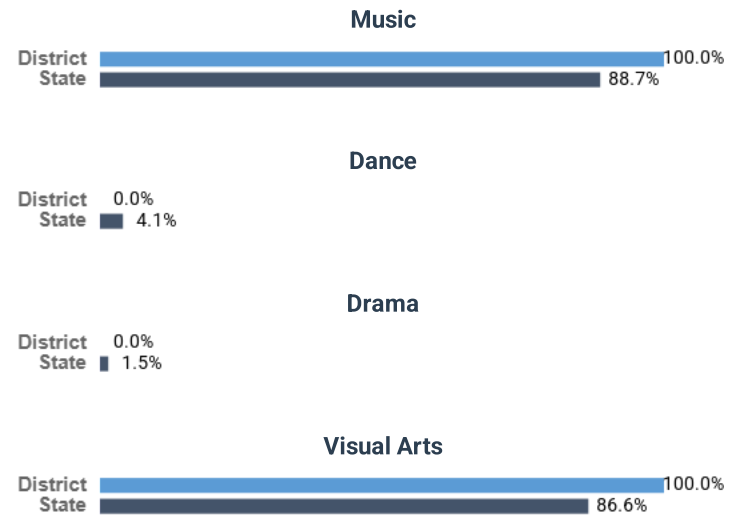

**Students enrolled in one or more classes by discipline:**



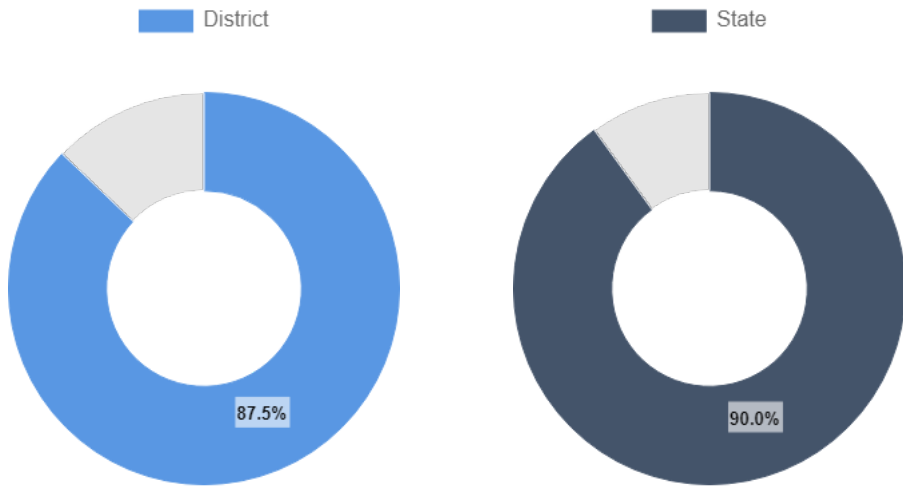

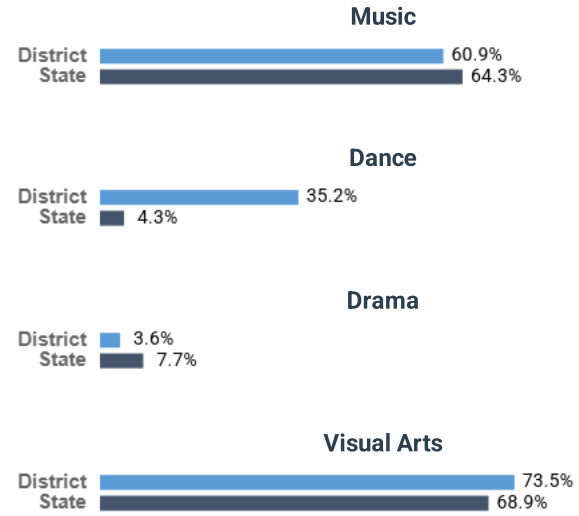

**Students enrolled in one or more classes by discipline:**



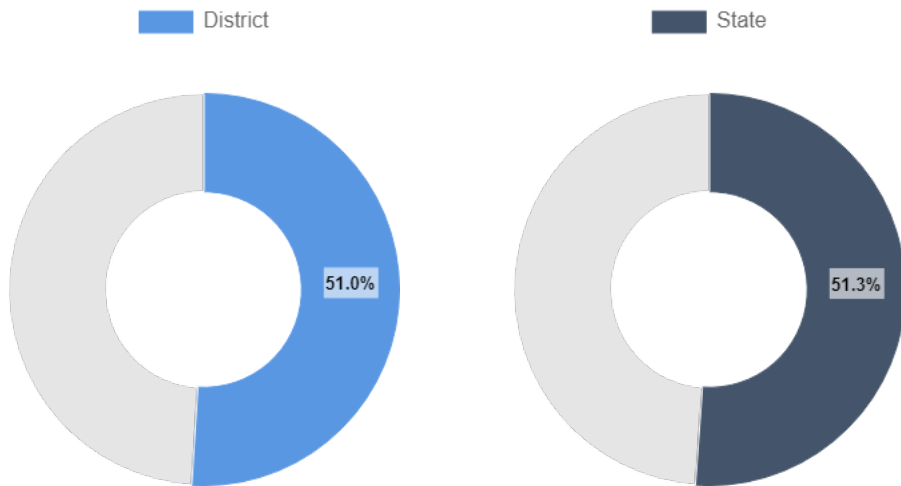

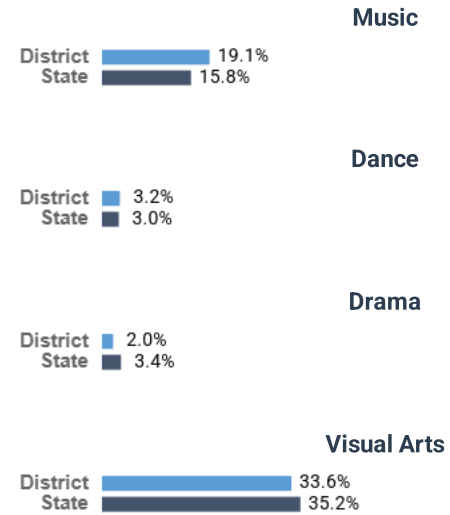

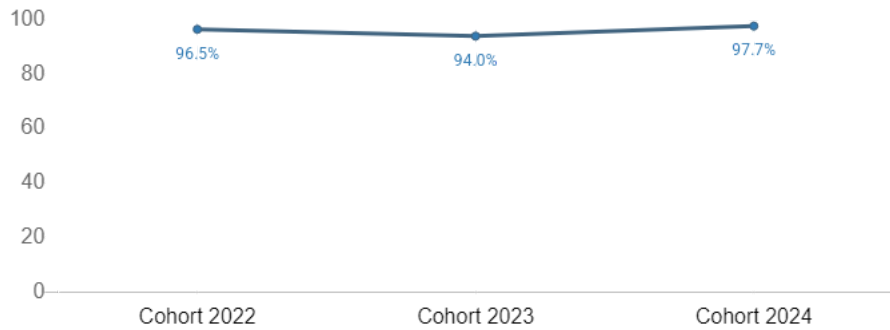

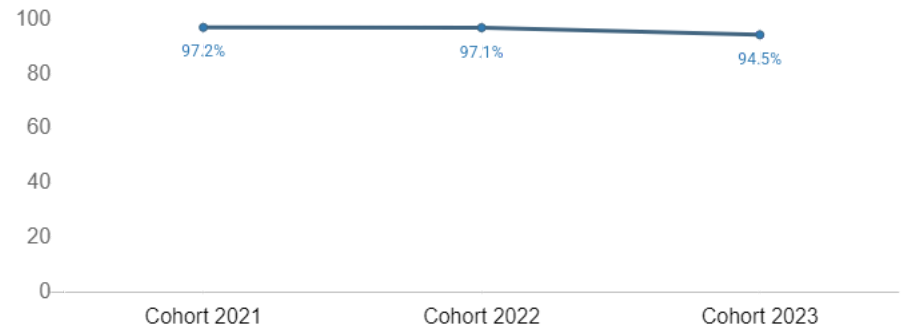

## Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

**Note for 2023-2024:** Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.

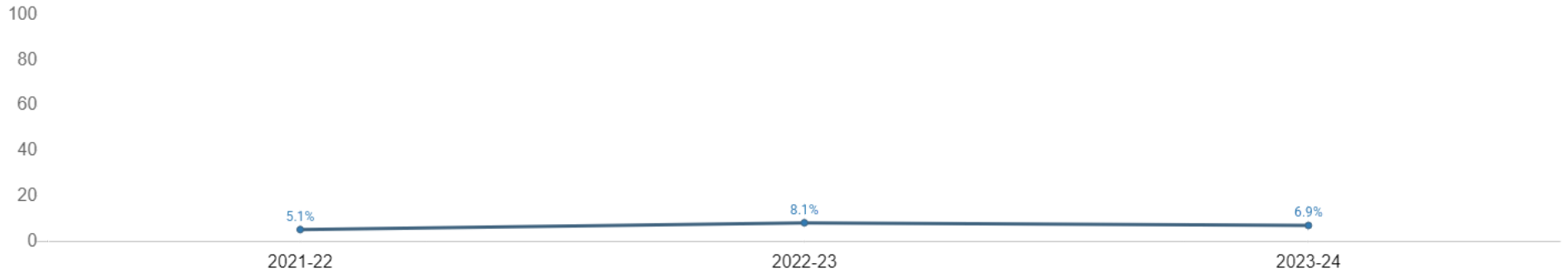

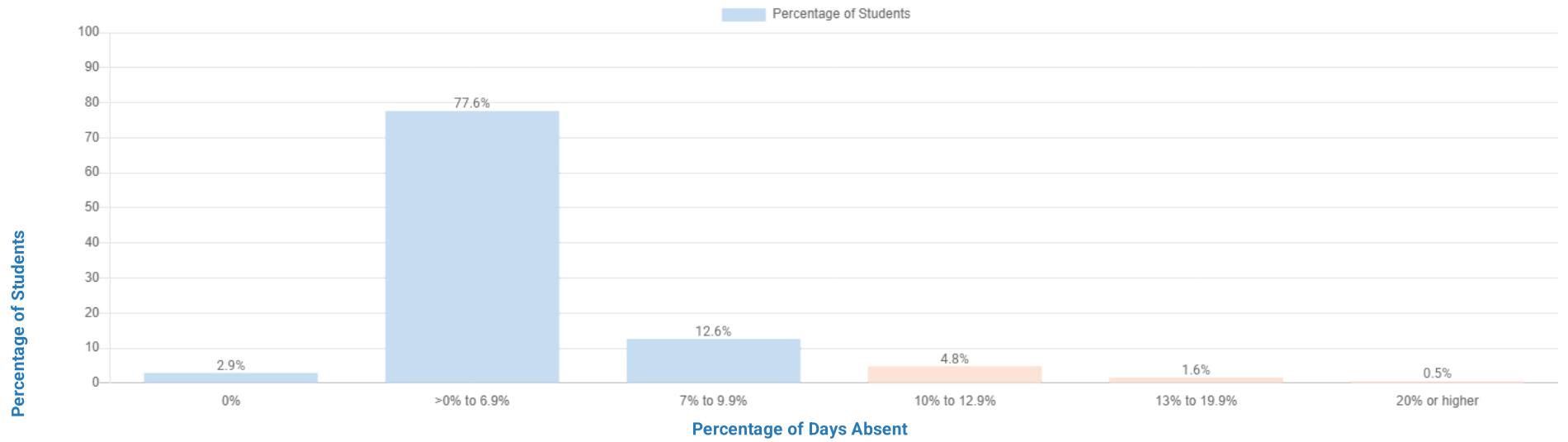

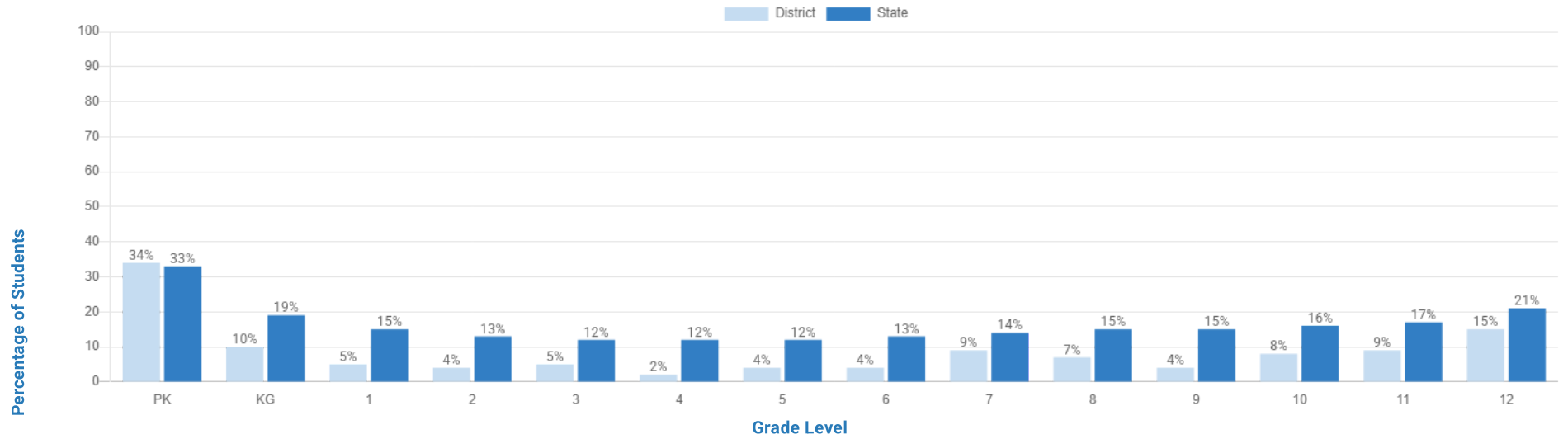

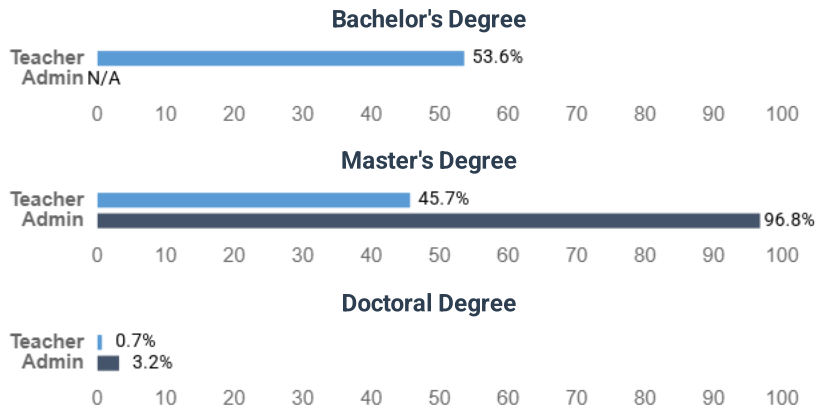

During the 2023-2024 school year the district expanded opportunities through: tutoring and academic supports, the Senior Pathways program, additional resources for multi-language learners and a focus on wellness and positive school climate and culture.

### Clubs and Activities:

The district runs a multitude of elementary, middle and high school level clubs and activities for students after school which are largely district funded however some are pay-to-play. The district partners with a parent organization to co-sponsor a middle school athletics program and the district fully funds a comprehensive high school athletic program.



### Before and After School Programs:

The district runs before and after school care programs for students through eighth grade and also provides a variety of tutoring opportunities as targeted interventions after school.



### Staff and Professional Learning:

Our professional development program focused on supporting our district mission, strategic plan and our district goals: 1) Emphasis on wellness opportunities for staff. 2) Instruction on suicide prevention. 3) Training on executive functioning. 4) Elementary focus on standards based report card and new math program. Our staff participates in our home grown professional development academy offering dozens of courses that are both in person and virtual. Virtual meetings have provided for increased collaboration through regular articulation meetings (K-5) and Professional Learning Community meetings (6-12). At faculty, department and grade/course/team meetings, teams engage in discussions about classroom strategies targeted towards the achievement of our goals. The district also sets a budget for staff to attend conferences, training and graduate course programs.

### Postsecondary Information:

There were 438 graduates in the Class of 2024, and 96% continued their education beyond high school. Students matriculated to 4 year colleges/universities at a rate of 91%, a 2 year school at a rate of 4%, and the remaining 5% pursued other pathways including employment, military service, apprenticeships, and/or a gap year.



### Student Supports and Services:

Students are supported by 19 School Counselors and 3 full-time Student Assistance Counselors across all six schools. Counselors deliver teaching modules addressing the social/emotional development, character education, post-secondary preparedness, and academic supports to support students across the district. Additionally, support structures through group counseling and individual counseling are provided. Students are also supported by fully staffed school nursing offices, school psychologists, social workers and case managers. Many of the case managers will meet with students regularly on an individual basis to address any ongoing social/emotional issues.



### Parent and Community Involvement:

The district partners with school PTOs, PEC (Parents of Exceptional Children) and SEPAC (Special Education Parent Advisory Council) and also hosts BT Connect meetings which are town hall style meetings on special topics. Additionally the district regularly surveys the community on major initiatives and program evaluations.

### Early Childhood Education:

The Bernards Township offers a full day and a half day preschool program. The full day program services students with the most intense behavioral needs utilizing the principles of Applied Behavior Analysis. The Half Day Program is an integrated program that educates special needs and typically developing children. The programs encourage children to explore their world through movement, art, science, literacy, math, music, dramatic play, and sensory activities. Students participate in whole group activities, small groups with teachers, and gain independence as they follow the routines of the class. Learning activities are based upon the New Jersey Department of Education's Preschool and Teaching Learning Expectations and are responsive to the individual needs and abilities of each child. Special needs preschoolers are those identified by the Preschool Child Study Team and found eligible for special education and related services under the NJ Administrative Code.
