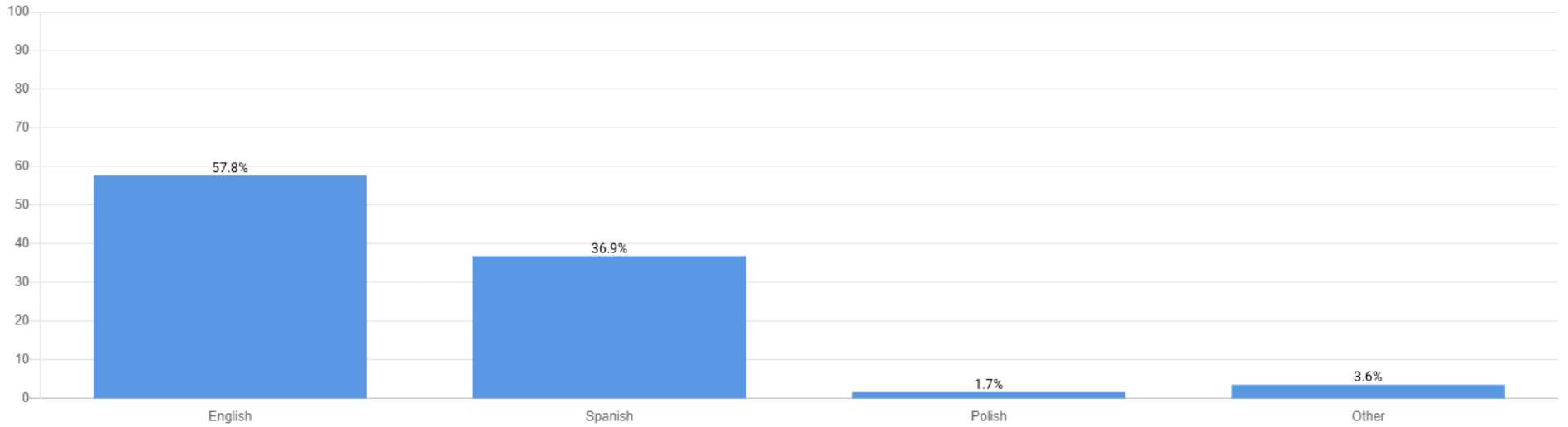

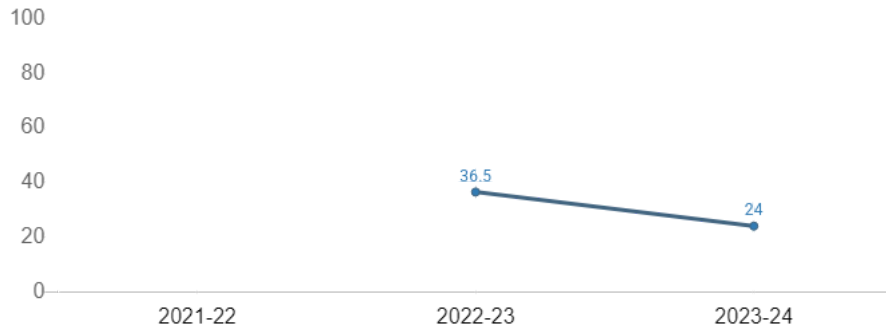

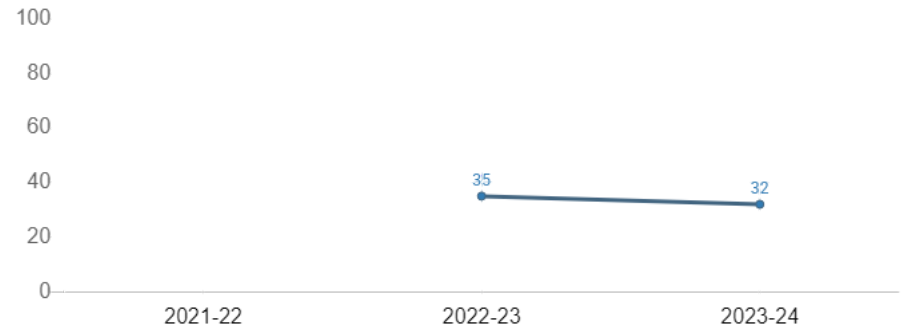

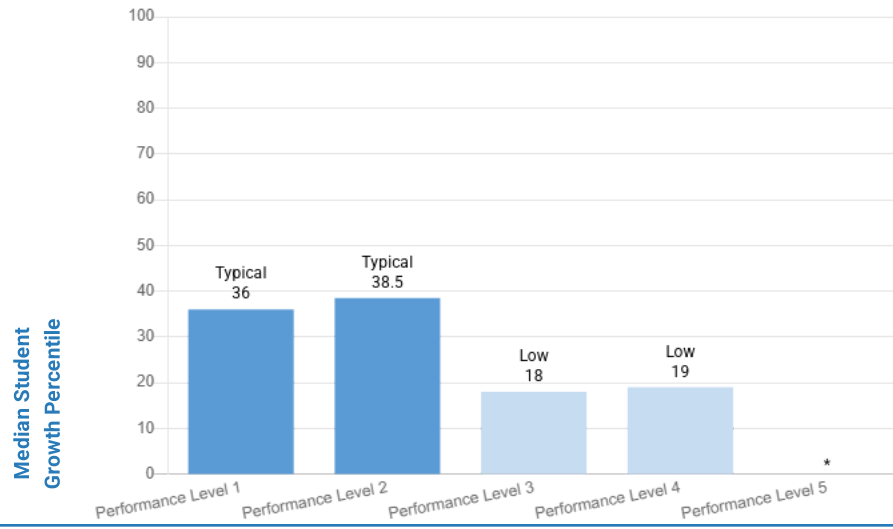

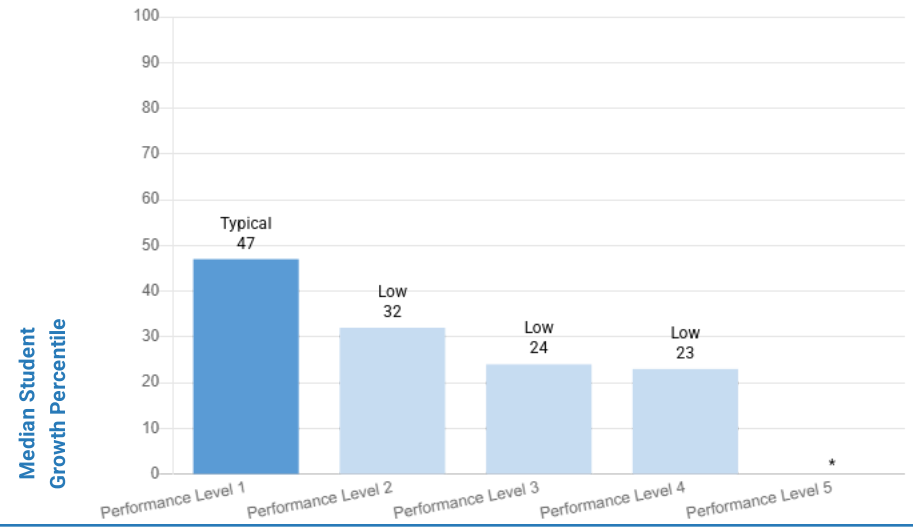

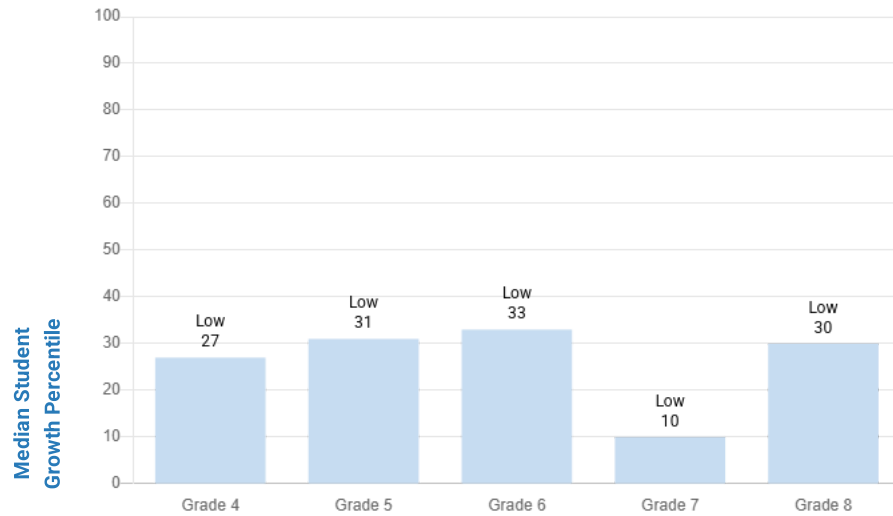

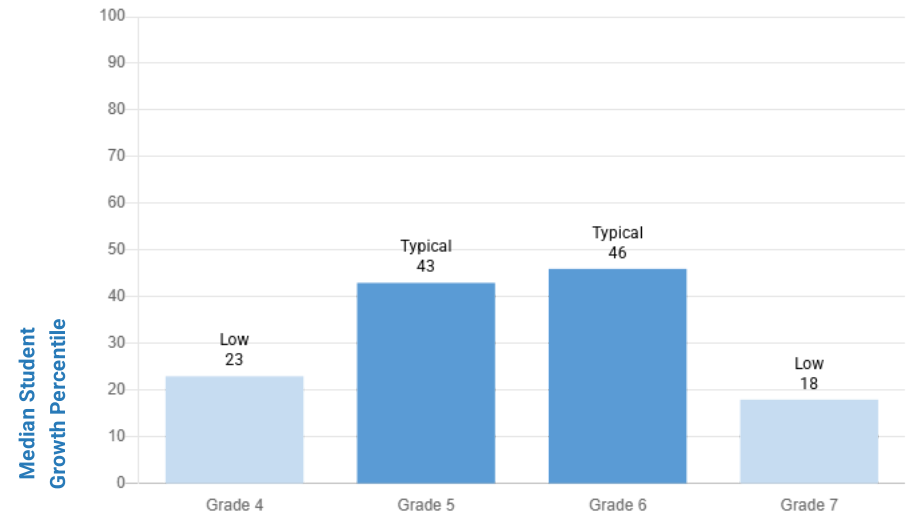

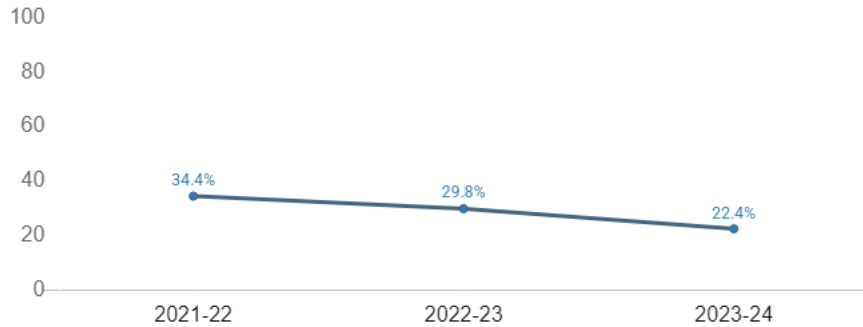

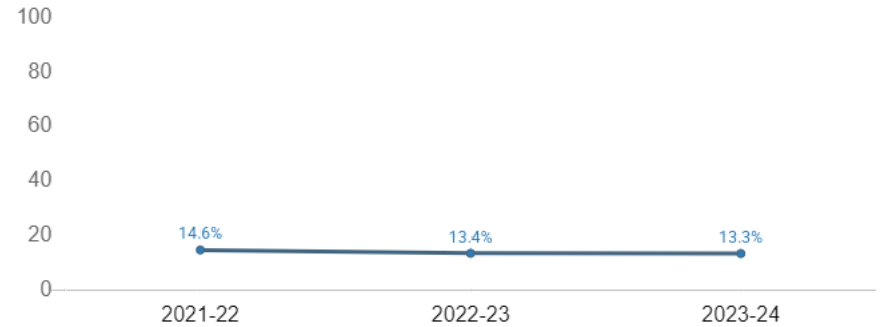
### English Language Arts and Mathematics Performance Trends

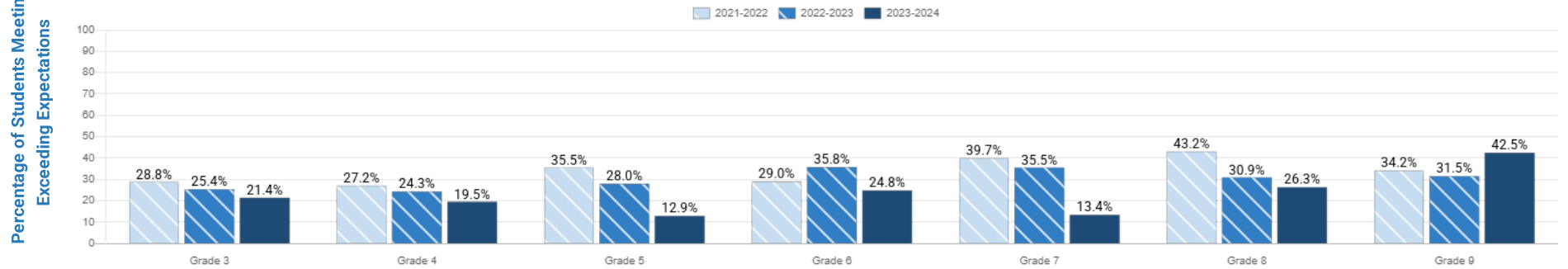

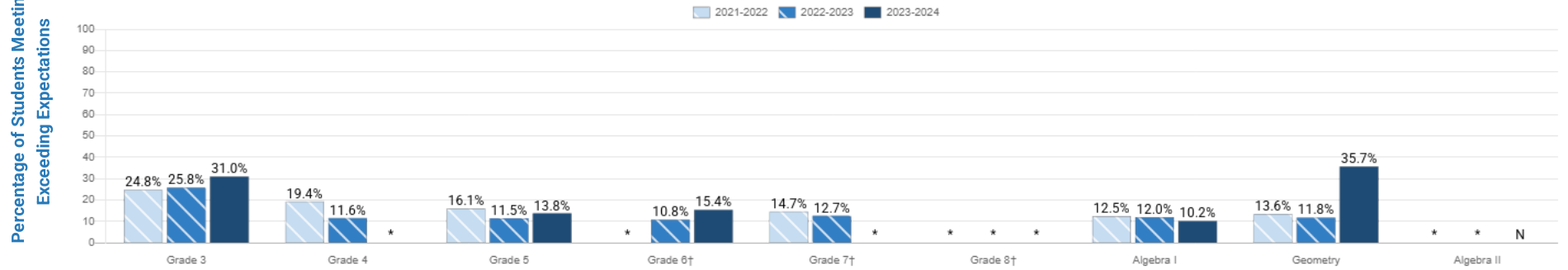

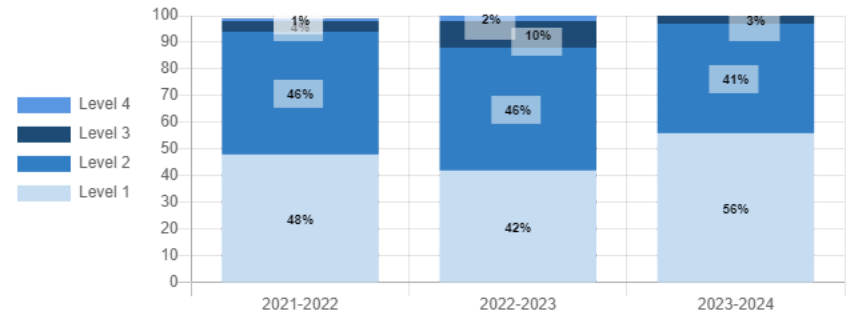
### NJSLA Science Assessment: Grade 5 Summary

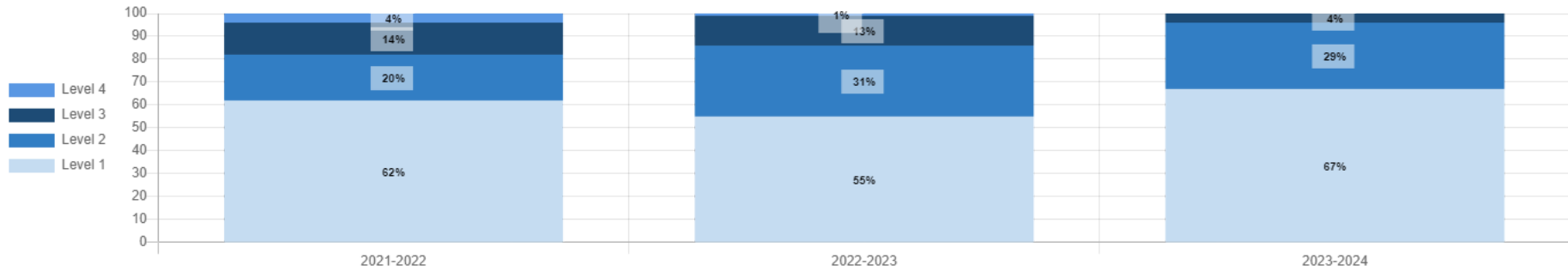

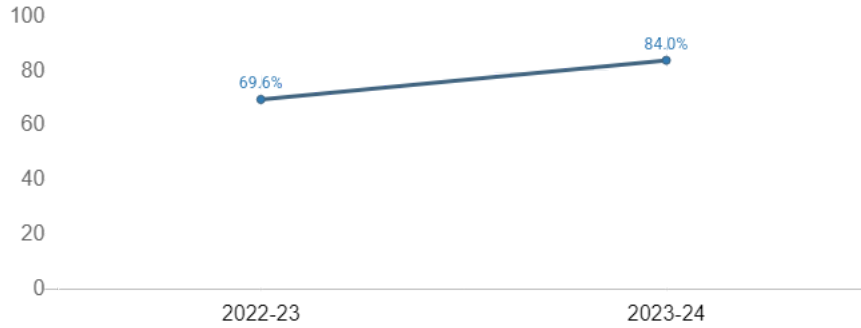

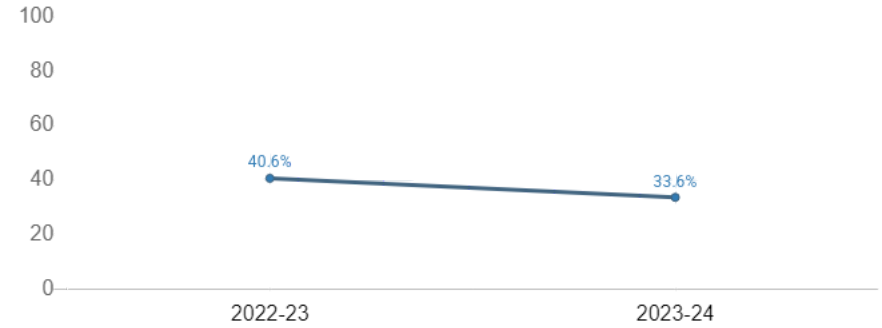

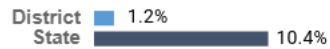

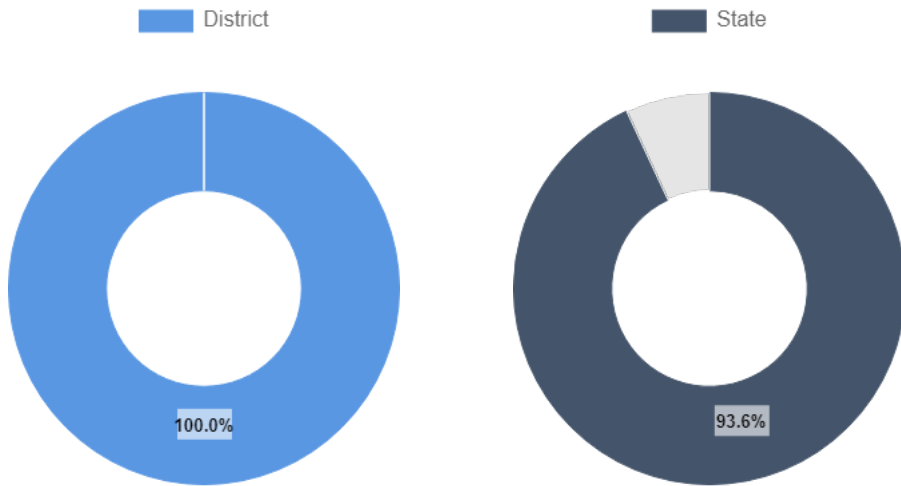

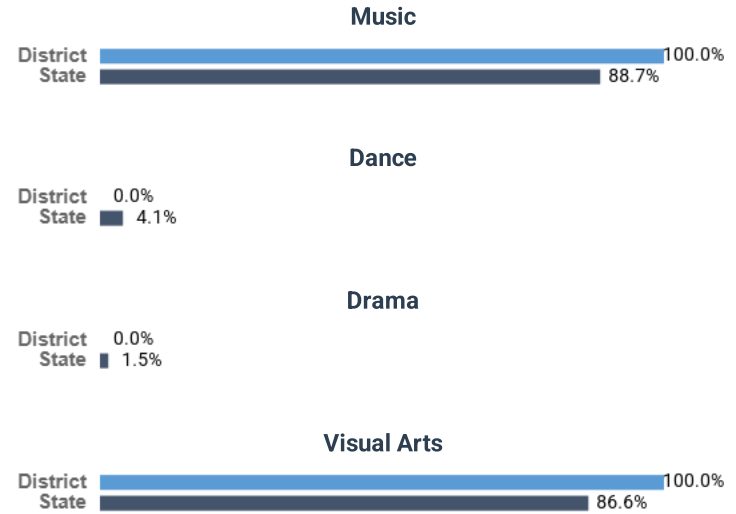

**Students enrolled in one or more classes by discipline:**



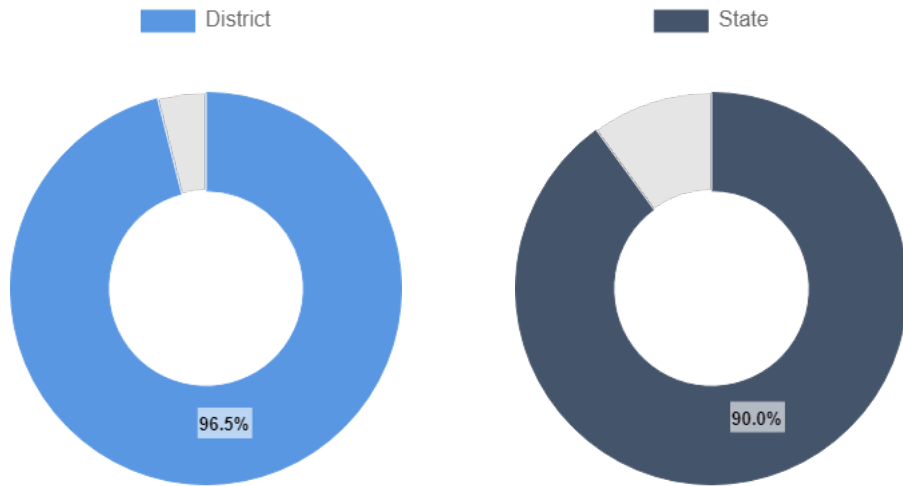

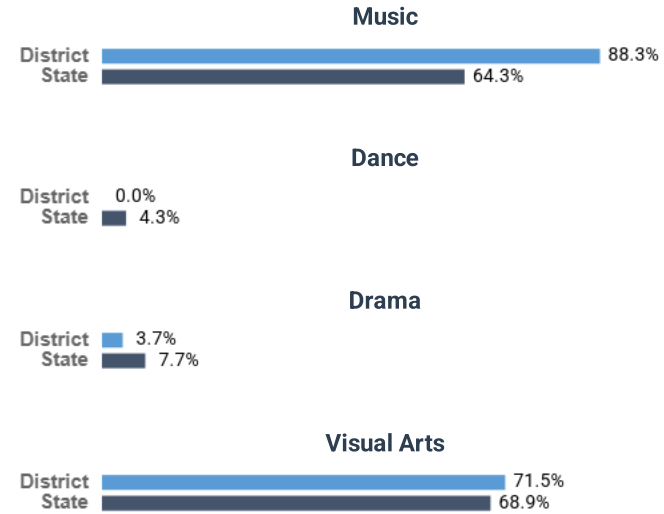

**Students enrolled in one or more classes by discipline:**



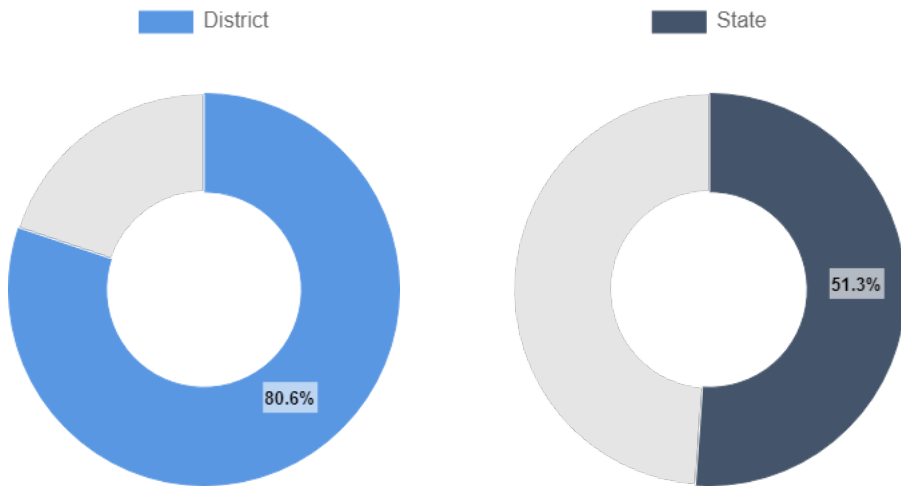

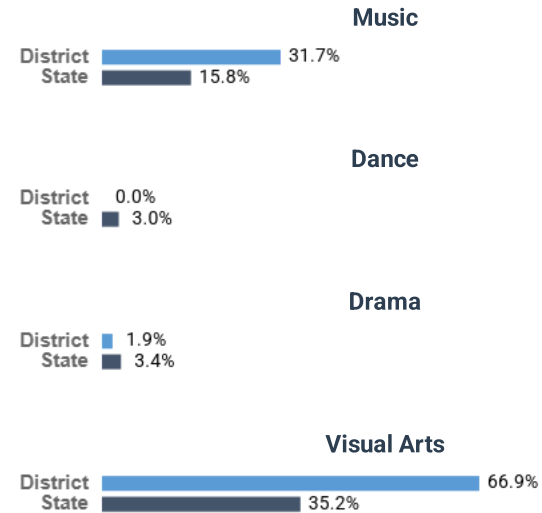

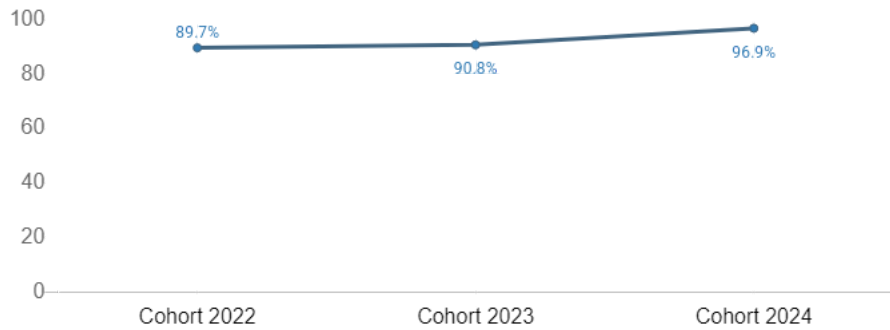

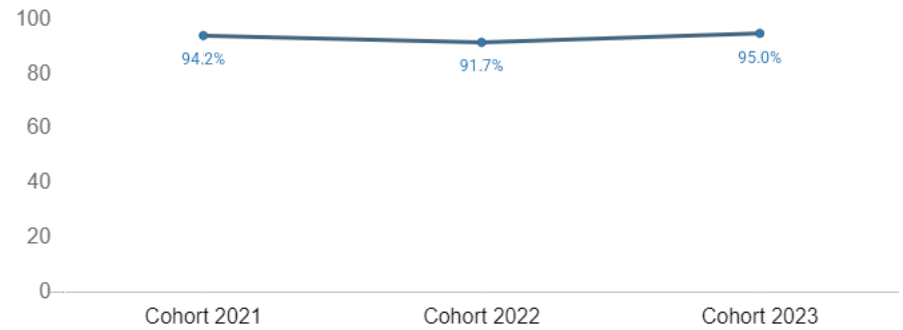

## Graduation/ Postsecondary

Graduation rates are calculated based on the adjusted cohort graduation rate calculation. Beginning in the 2020-2021 school year, the NJDOE was required to make changes to the methodology used to calculate the adjusted cohort graduation rate for federal reporting and accountability purposes. The United States Department of Education (USED) determined that the NJDOE must only include students who receive a diploma that is fully aligned with the state's standards, meaning they have met the state's graduation assessment requirements, course requirements, and local attendance requirements. This means that students with disabilities who did not meet some or all graduation requirements because of a modifications or exemption in their Individualized Education Program (IEP) may not be counted as graduates in the calculation of the adjusted cohort graduation rate used for federal reporting and accountability purposes. It is important to note that this was only a change to how graduation rates are calculated for federal reporting. It does not affect requirements to earn a diploma or the type of diploma that the state awards to students with disabilities.

As a result of these changes, the NJDOE began calculating two versions of the adjusted cohort graduation rate starting with 2021 graduation rates. ## Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

**Note for 2023-2024:** Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.

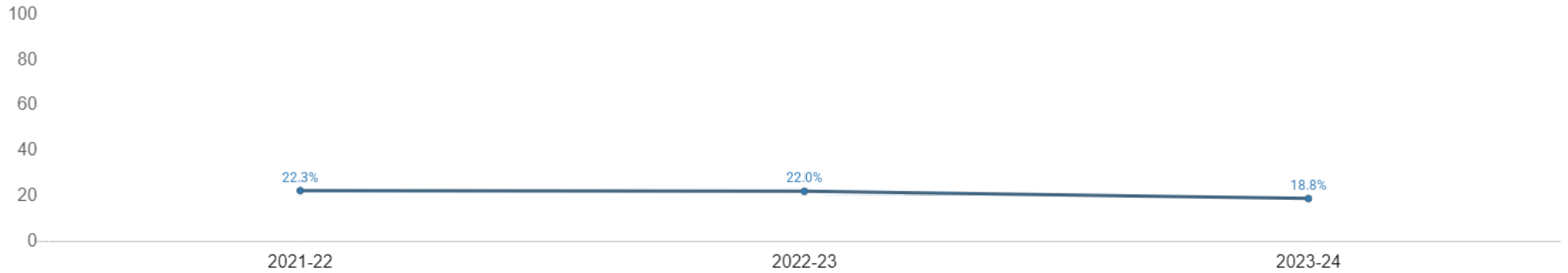

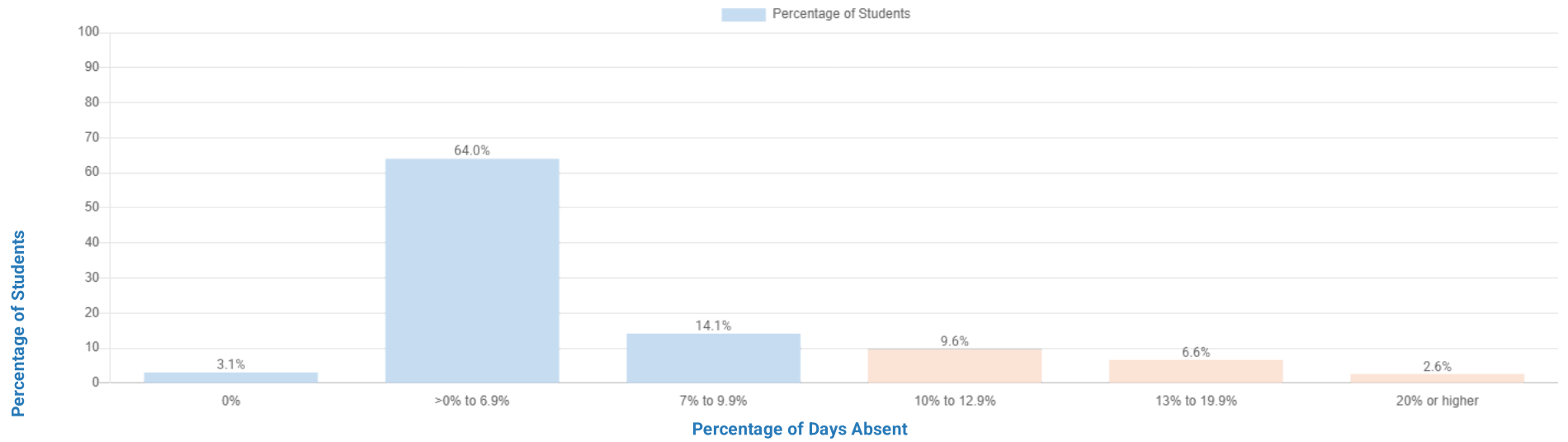

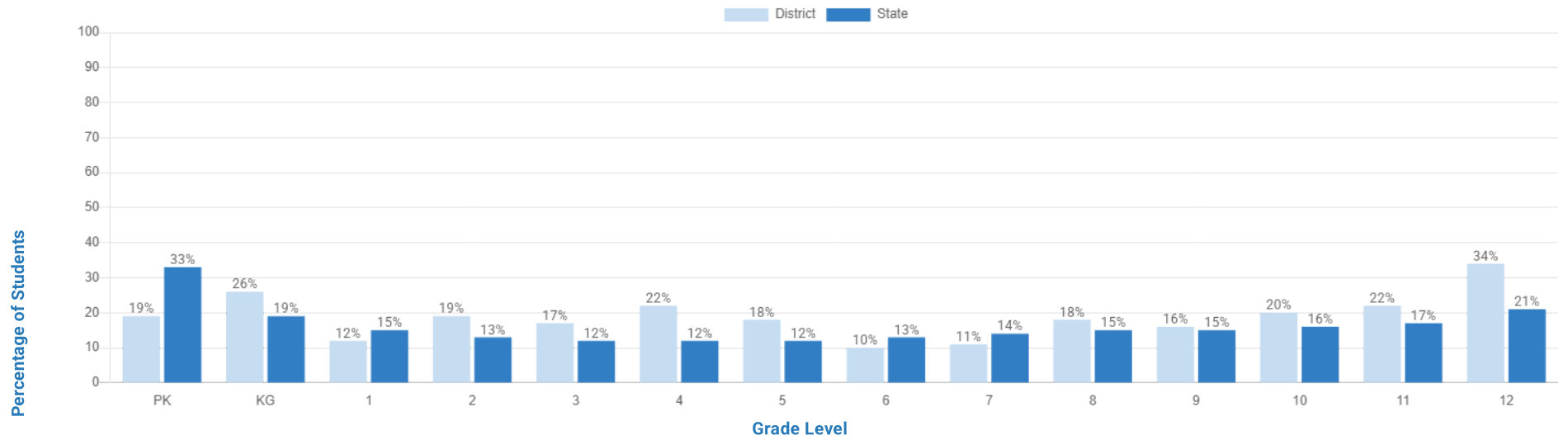

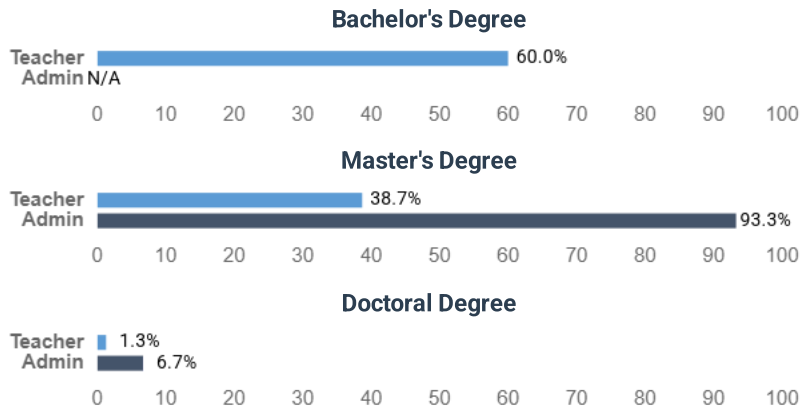

## Accountability

**New Jersey's Every Student Succeeds Act (ESSA) Accountability System** New Jersey's school accountability system identifies schools in need of comprehensive and targeted support as required by the Every Student Succeeds Act (ESSA). Based on New Jersey's [approved ESSA state plan](#), NJDOE will identify schools in the following four federal categories every three years:

- **Comprehensive Support and Improvement (CSI): Overall Low Performing:**
  - Title I schools with a summative score in the bottom 5% of Title I schools.
- **Comprehensive Support and Improvement (CSI): Low Graduation Rate:**
  - All high schools with a four-year graduation rate of 67% or less
- **Additional Targeted Support and Improvement: Low Performing Student Group (ATSI):**
  - All schools with one or more student group with a summative score that would be in the bottom 5% of Title I schools
- **Comprehensive Support and Improvement (CSI): Chronically Low Performing:**
  - Title I schools identified as Additional Targeted Support and Improvement; Low Performing Student Group (ATSI) that are identified for three or more consecutive years, i.e., ATSI schools that do not meet exit criteria.

Annually, NJDOE will identify schools in the following federal category:

- **Targeted Support and Improvement: Consistently Underperforming Student Group (TSI):**
  - All schools with one or more student groups that missed annual targets or standards for all indicators for two years in a row

For purposes of ESSA accountability, only schools and student groups with data for 20 or more students are included in calculations.

The NJDOE identified schools for CSI and ATSI status in fall 2023 based on data from the 2022-2023 school year, so the NJDOE did not identify schools for CSI or ATSI status based on 2023-2024 school year data. The NJDOE only identified schools for TSI status based on data from the 2023-2024 school year.

- The Manville School District is a PreK-12 District of approximately 1800 students. The district has four schools and works with community partners to provide preschool.
- The Manville School District believes in the success of all students. Focusing on inclusive education provides opportunities for all students to succeed and graduate ready for college or career.
- Our preschool program, part of the NJ Preschool Expansion Grant, serves approximately 150 preschool students in ten classrooms.

The Manville School District offers a full spectrum of classes. Inclusion of all students is a significant focus, and instruction is designed to expose every child to the New Jersey Standards for Learning. Systematic phonics instruction is used to support our youngest learners. As students learn to read, they are exposed to diverse texts and encouraged to support their ideas with evidence. In writing, the district has partnered with The Writing Revolution to provide strategies for writing across all content areas. In math, students are taught to explain their thinking to prepare for higher-level math classes. At the High School, various AP classes, concurrent enrollment partnerships with local colleges and universities, and electives prepare students for their next steps after graduation.

Professional learning is offered to staff through workshops, department meetings, common planning time, and embedded coaching throughout the year.



### Postsecondary Information:

Approximately 74% of MHS graduates pursue post-secondary education (48% go to four-year and 26% to two-year institutions). The remaining 26% seek military careers, employment, or business/trade school. The 2024 graduates attended 30 unique post-secondary institutions and military academies. Thirty-three percent of the students graduated with the Seal of Biliteracy.



### Student Supports and Services:

The Department of Special Services oversees many programs and services that help support all learners from Pre-K through 21. Students who qualify for Special Education receive programs that reflect the least restrictive environment in which they can succeed. Programs include placement in the general education environment with support, in-class resource centers, pull-out resource centers, self-contained classrooms, and out-of-district placements. Additional related services include Occupational Therapy, Physical Therapy, Counseling, Speech Therapy, and Extended School Year Programs. The district is committed to providing equitable educational experiences for all students and has been awarded the NJIP Systemic Change Grant in both the Middle School and the High School.

The district provides a full-time nurse in each school. These nurses help maintain students' wellness by conducting regular screenings and maintaining medical records. When students are ill or injured, the nurses provide care as needed. In addition to physical health, the district partners with organizations to support students' mental and social-emotional health. These organizations include Rutgers UBHC and Campfire Kids. The district is also the recipient of the PBSIS and MTSS Grants.

### Early Childhood Education:

The Manville School District is a part of the NJ Preschool Expansion Grant. We currently provide full-day, inclusive, early childhood programming in ten classrooms. We also have a full-day preschool disabled program. Manville works with three community partners to provide these services.
