





## Graduation/Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Note for 2023-2024: Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.



Staff and Professional Learning:

The district supports teachers through an in-district professional development institute, four full-day/six partial professional development days annually, and regularly scheduled horizontal and vertical articulation sessions. The district stays connected to universities through a partnership with Columbia University's Advancing Literacy. Many teachers continue to pursue advanced degrees under the district's tuition reimbursement program.



**Parent and Community Involvement:** 

In Fall 2021 the district engaged the community in devising a 3- to 5-year Strategic Plan, as the 2017 plan had sunset. This mechanism is used to identify long term goals, which are used to inform annual budgets, staffing, and administrative decisions. Over the last two decades the district's educational foundation, Somerset Hills Education Foundation (SHEF), has enhanced students' learning experience through a large number of enrichment programs, grants, and educational projects. In addition, the Home/School Association at each school plays an integral part of funding projects and teacher support. Parent informational programs are offered in math, ELL, guidance, and reading. Parent Portals are available to see student grades, class assignments and student attendance.



The Somerset Hills School District continues to maintain and enhance our facilities. Recently, the district updated and expanded its building level security. Bernards High School's media center is state-of-the-art, and the district recently created a recess space for middle school students that capitalizes on the natural surroundings of the campus.

The district partners with local law enforcement and three Class III Special Law Enforcement Officers (SLEOs) are on campuses on a daily basis. The district partners with local police and county colleagues to ensure best practice in regards to security.



The district launched a 1-to-1 intiative in September 2020. All students K-12 have access to the Chromebooks/ipads (depending on the grade), and WiFi hotspots are provided as needed to ensure connectivity is not an issue for any SHSD student.



District schools reopened in September 2020 with both purely-virtual/fully-remote and hybrid models of instruction. The district's published reopening plan provides a comprehensive picture of all aspects of the reopening plan and the steps taken to ensure the safety of students and staff throughout the COVID pandemic. Full-day in-person instruction was offered on a staggered basis for different student populations at each school, and by May 2021 all schools offered in-person instruction for full days to all.
