
















English Language Arts and Mathematics Performance Trends

English Language Arts Assessment - Participation and Performance






NJSLA Science Assessment: Grade 5 Summary








CTE Participants





Students enrolled in one or more classes by discipline:







Students enrolled in one or more classes by discipline:







Graduation/ Postsecondary

Graduation rates are calculated based on the adjusted cohort graduation rate calculation. Beginning in the 2020-2021 school year, the NJDOE was required to make changes to the methodology used to calculate the adjusted cohort graduation rate for federal reporting and accountability purposes. 



Graduation/ Postsecondary

Graduation rates are calculated based on the adjusted cohort graduation rate calculation. Beginning in the 2020-2021 school year, the NJDOE was required to make changes to the methodology used to calculate the adjusted cohort graduation rate for federal reporting and accountability purposes. The United States Department of Education (USED) determined that the NJDOE must only include students who receive a diploma that is fully aligned with the state's standards, meaning they have met the state's graduation assessment requirements, course requirements, and local attendance requirements. This means that students with disabilities who did not meet some or all graduation requirements because of a modifications or exemption in their Individualized Education Program (IEP) may not be counted as graduates in the calculation of the adjusted cohort graduation rate used for federal reporting and accountability purposes. It is important to note that this was only a change to how graduation rates are calculated for federal reporting. It does not affect requirements to earn a diploma or the type of diploma that the state awards to students with disabilities.

As a result of these changes, the NJDOE began calculating two versions of the adjusted cohort graduation rate starting with 2021 graduation rates. The "federal version" aligns with ESSA requirements and USED guidance and is used for federal reporting and ESSA school accountability only. The "state version" continues to use the same methodology used prior to 2021 and reflects all students who received a state-endorsed diploma.

To be included as a graduate in the federal version of the graduation rate, students must have meet state course requirements and local attendance requirements for graduation. Additionally, students must meet the graduation assessment requirements in place based on the year they are graduating, regardless of their graduation cohort. The graduation assessment requirements for the classes of 2022 through 2024 have differed as a result of executive orders in response to the pandemic and new legislation. As a result, the calculation of the federal version of the graduation rate has also changed.

In this section of the reports, the Graduation Rate Trends and Progress charts and Graduation Cohort Profiles (4-Year, 5-Year, and 6-Year), as well as the graduation rates reported in the Summary Reports, reflect the "state version" of the graduation rate. Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Note for 2023-2024: Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.









Before and After School Programs:

Somerville Public Schools offers a variety of enrichment opportunities for our students before and after school. Examples include: Chorus (4-5), Jazz Band (6-8), Comfort Club (6-8), Robotics (9-12), Academic tutoring activities, enrichment courses in the middle school, and internship opportunities with local businesses.



Staff and Professional Learning:

The District prioritizes aligning professional development with teacher needs and district goals, ensuring sessions are meaningful and practical. In continuing to address the needs of the whole child, Positive Behavioral Interventions and Supports (PBIS) protocols are in place to strengthen students social and emotional development. Our non-traditional high school program (MAPS) continues to thrive and has served as a model program that other districts have emulated.



Student Health and Wellness:

Somerville Public Schools believes in prioritizing the health and wellness of all students. Each school employs non-Child Study Team psychologists who service both general education and special education students through whole- and small-group settings. Programming takes place throughout the year and supports mental health initiatives and promotes positive decision making among students.



Parent and Community Involvement:

Stakeholders are informed about district updates through various online platforms and the parent portal. Board of Education meetings are accessible on the district's website for those unable to view them via local cable or livestream. Partnerships with parents, community members, local educational institutions, and businesses are valued to support students in reaching their full potential. Climate Surveys:

Surveys of varying scope are administered throughout the school year, both to gauge overall climate or to solicit feedback on a particular issue/topic. Stakeholders can complete the survey at their convenience. Survey results are used to gain insights to the areas of need, per school and formulate action plans to attend to the areas of need.



Facilities:

The district follows a comprehensive long-range facilities plan to address capital needs, supported by a financial strategy for funding improvements. Ensuring adequate space, maintaining safe buildings, and optimizing building system functionality are priorities to promote a secure and effective learning environment. Recent enhancements include upgrades to heating, ventilation, and cooling systems, the installation of automated temperature controls, and partial roof replacements at Van Derveer Elementary School and Somerville High School. Additionally, the high school's three turf fields are maintained on a staggered refresh cycle to support long-term fiscal stability.



School Safety:

Somerville has partnered with local law enforcement to become the first Somerset County District to adopt the Standard Response Protocol. All safety drills are conducted in concert with the Somerville Police Department and post-drill debriefing sessions serve to inform needed modifications to safety protocols. Investments in building infrastructure have also been made to serve these needs. Behavior Threat Assessment Teams have also been assembled as per State mandates.

Technology and STEM:

Offerings include Coding and Robotics (K-2), STEM and Coding (3-5), Animation and Game Design, 3D Modeling and Design, Computer Science for Makers, Digital Design, Broadcasting, and AP Computer Science Principles, Computer Science Courses, Cybersecurity, Game Design, Advanced Game Design (9-12). All classrooms have interactive Clear Touch smart boards to support a 1:1 Chromebook program for all PK-12 students. Teachers utilize Google Classroom and several vetted educational platforms to integrate technology that supports student learning goals.



Early Childhood Education:

Seven full-day preschool classes support our youngest learners. Full time students attend school from 8:15-2:15 which includes lunch and nap time. A lottery system is used for enrollment. The Preschool Program is funded by the PEA grant. Creative Curriculum is utilized in all of the preschool classes and we employ a Preschool Instructional Coach to continue to grow and support the program.



Attendance:

To monitor and improve attendance, the schools in District use a variety of approaches including but not limited to: monthly updates to families, one-on-one meetings with students, emphasizing attendance importance in class discussions. Families are notified of excessive absences, prompting intervention plans with administration.
