



Schedules are set with the best interests of the students in mind. Green Hills School continuously leverages technology to improve student learning, enhance teaching practices and offer its students in grade K-8 a more personalized learning experience to meet their needs and their interests. A 1:1 chromebook initiative is implemented throughout the district. In addition, Green Hills School offers programs in STEM education, Design Thinking, Robotics and Coding to all students in K-8. We are a NJDOE School of Choice and presently have 52 students attending from various towns throughout Sussex and Warren Counties. Additionally, we developed and implemented a standards-based report card for grades K-4.
