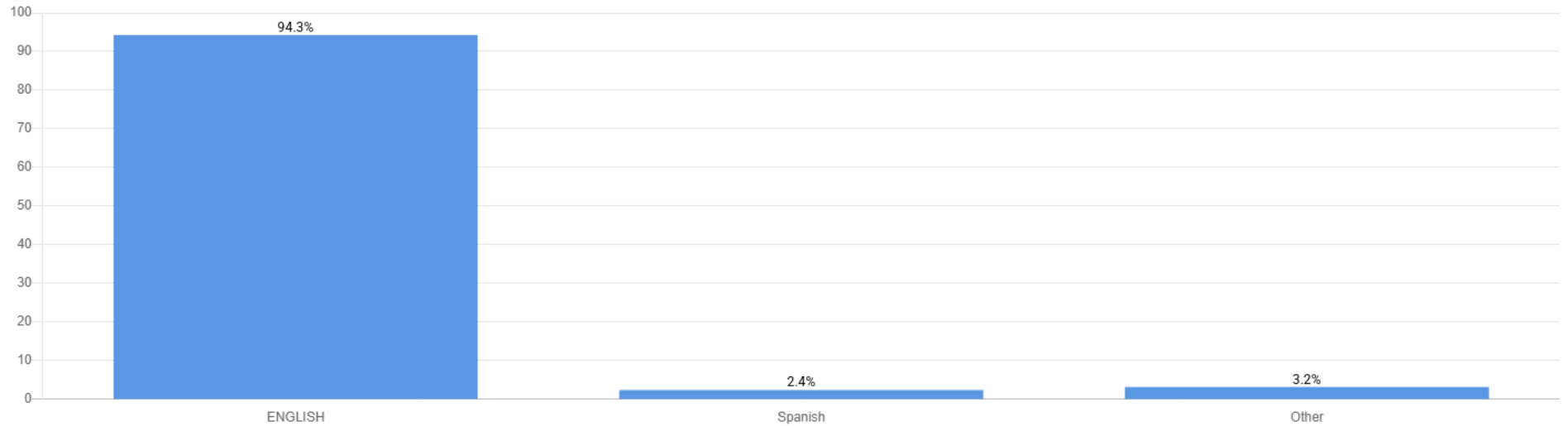

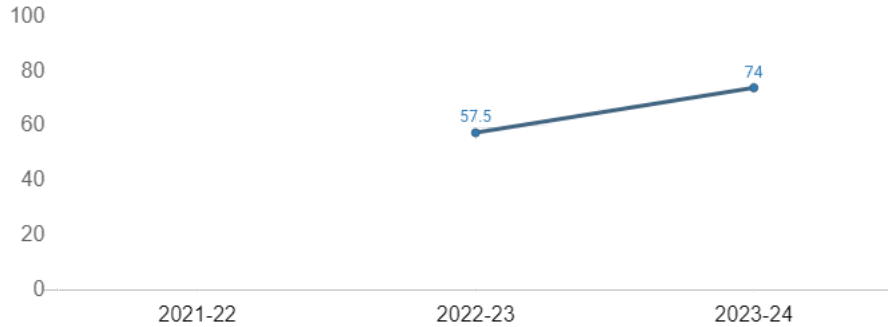

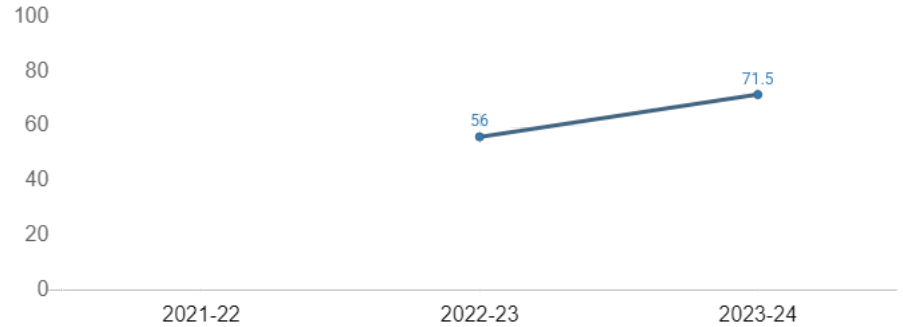

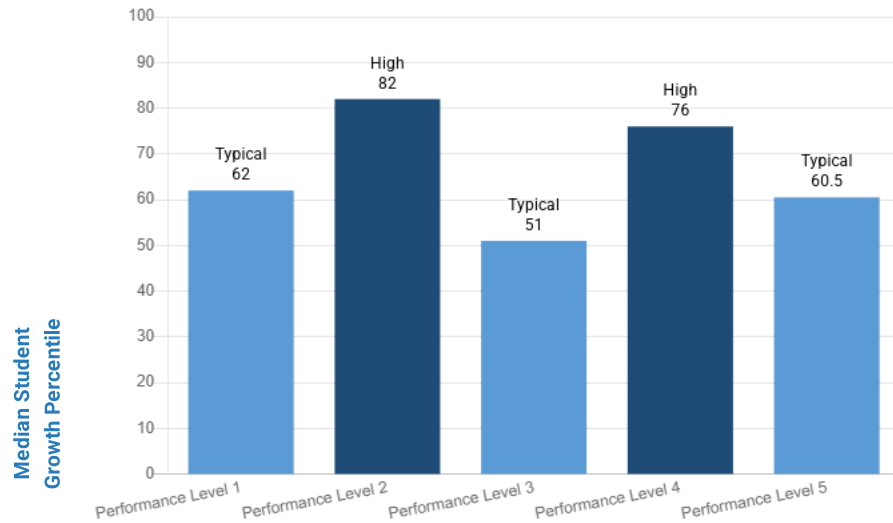

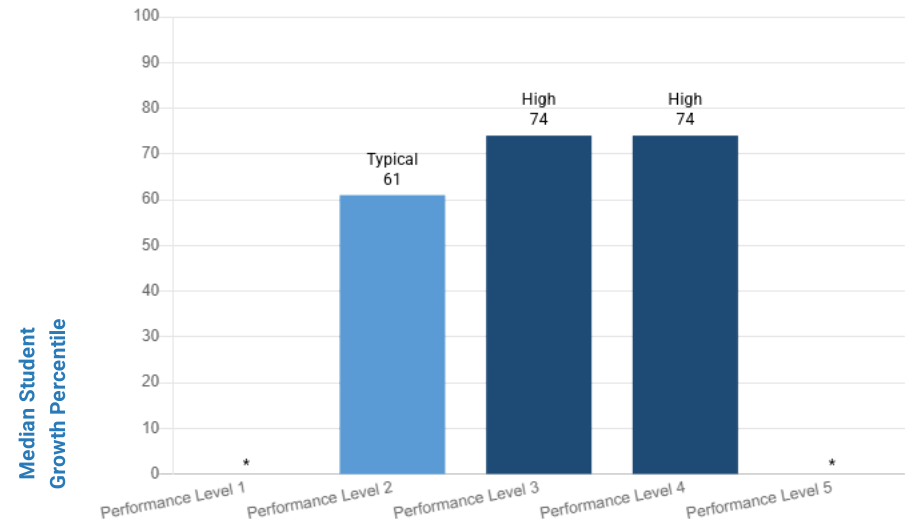

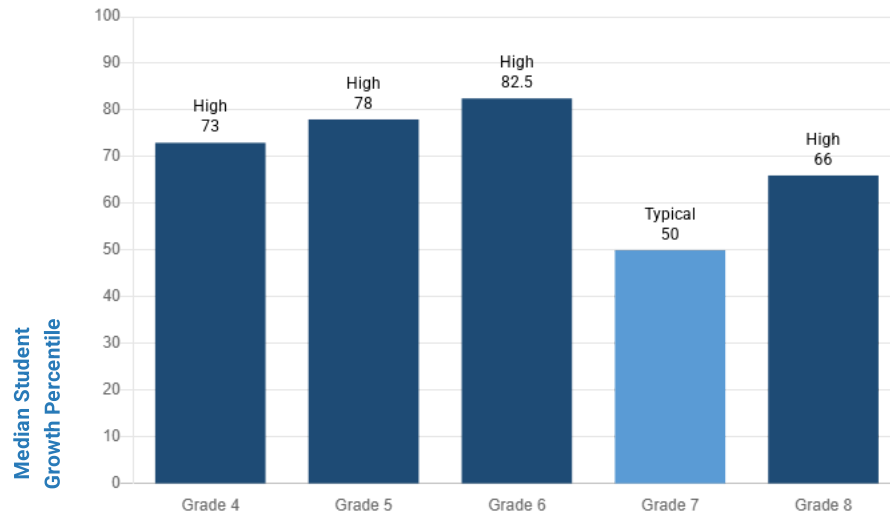

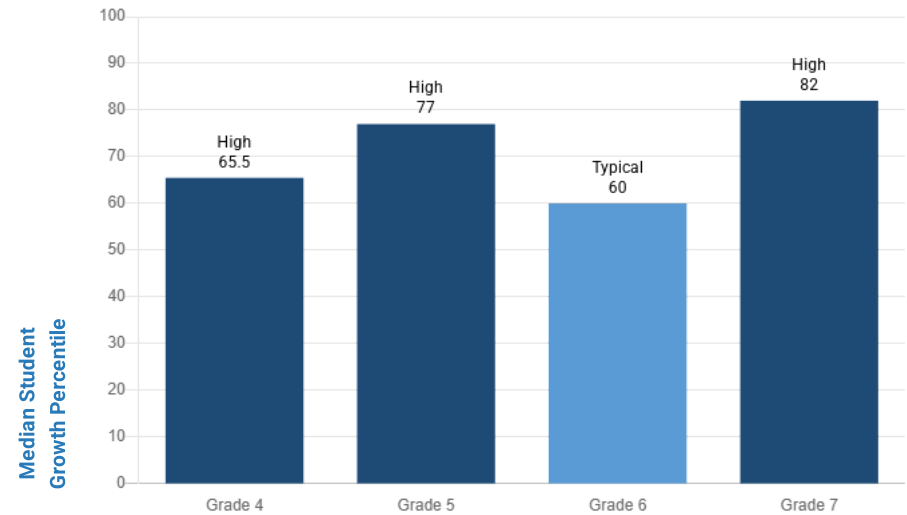

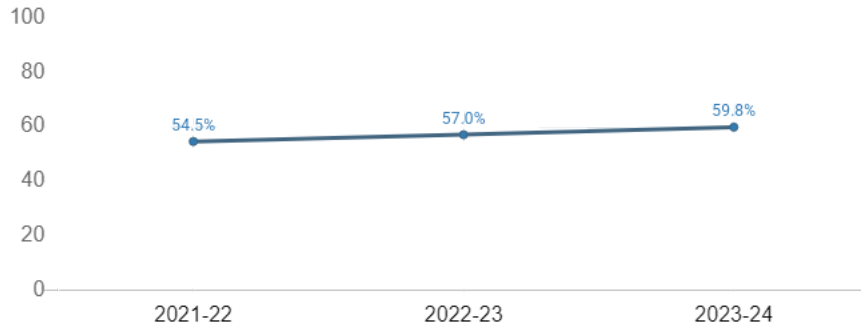

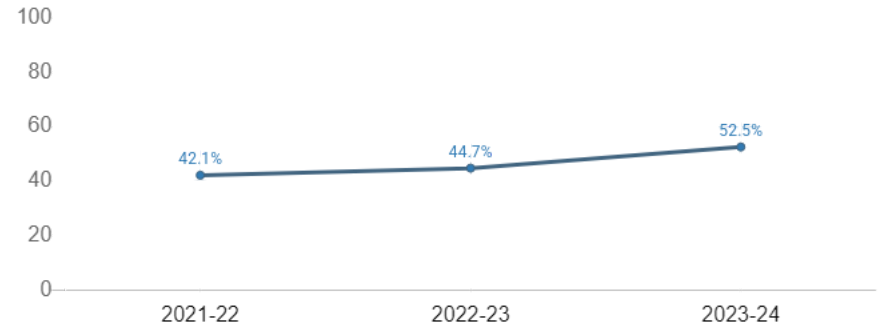
English Language Arts and Mathematics Performance Trends

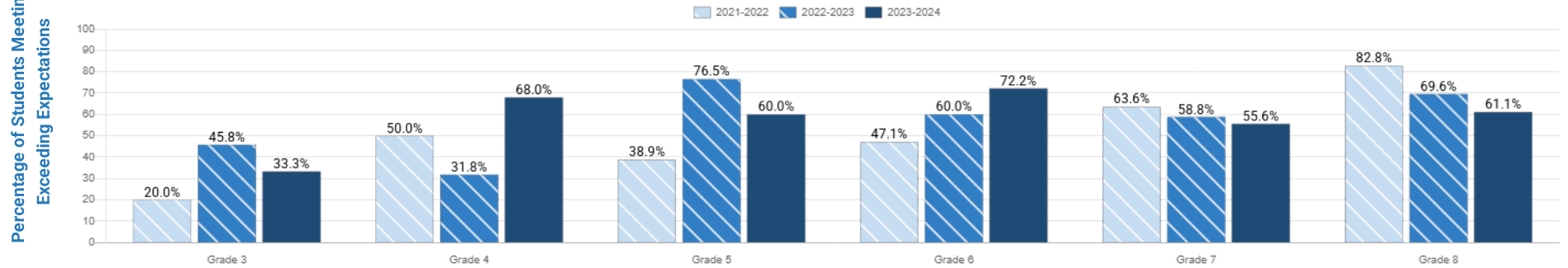

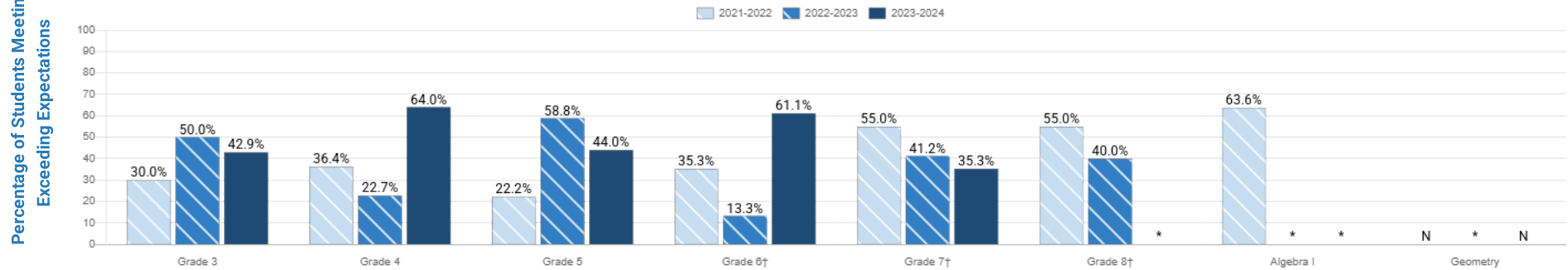

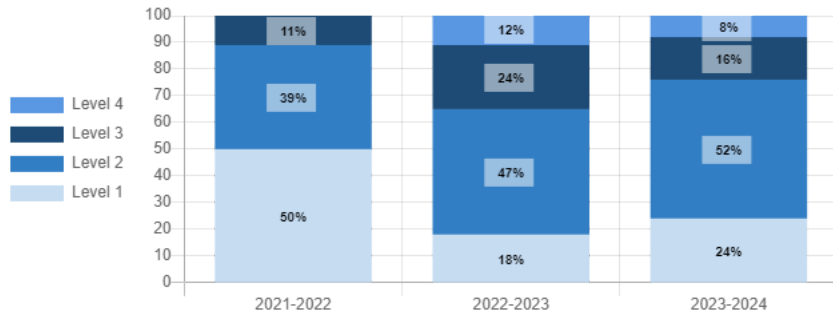

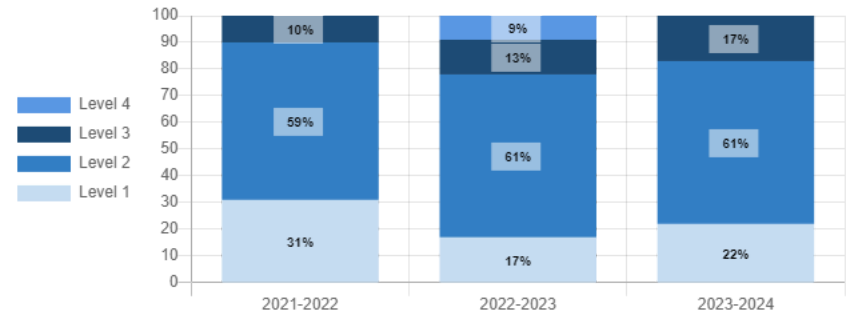

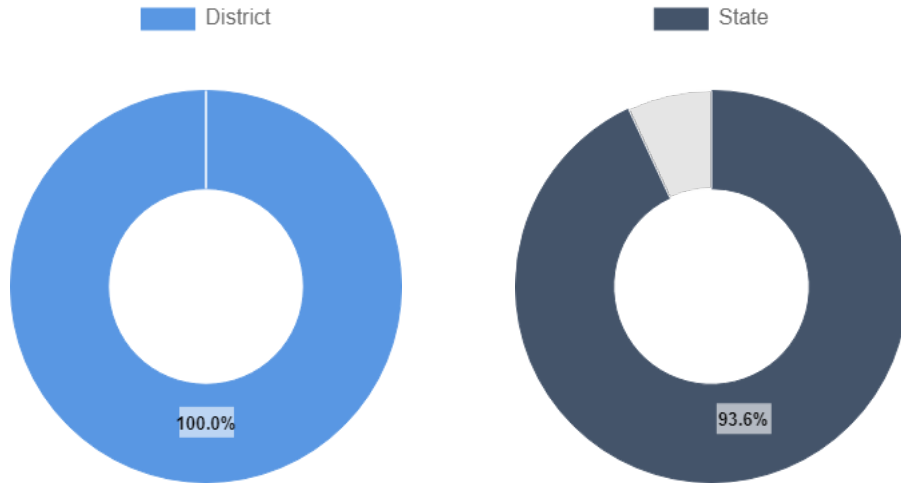

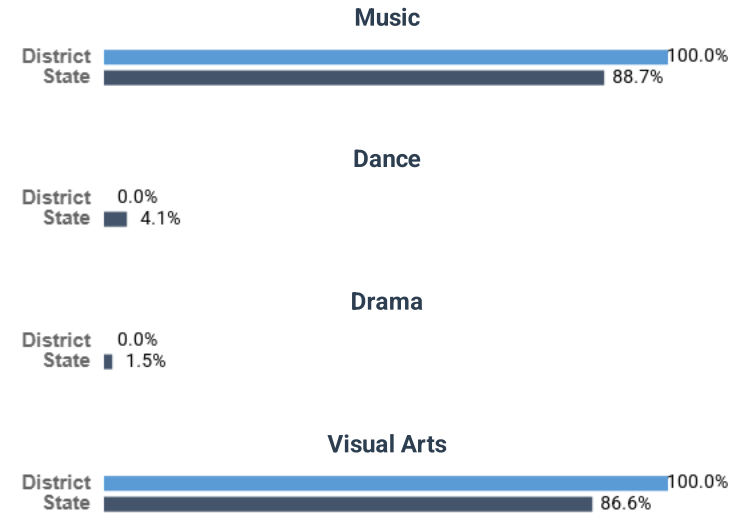

Students enrolled in one or more classes by discipline:



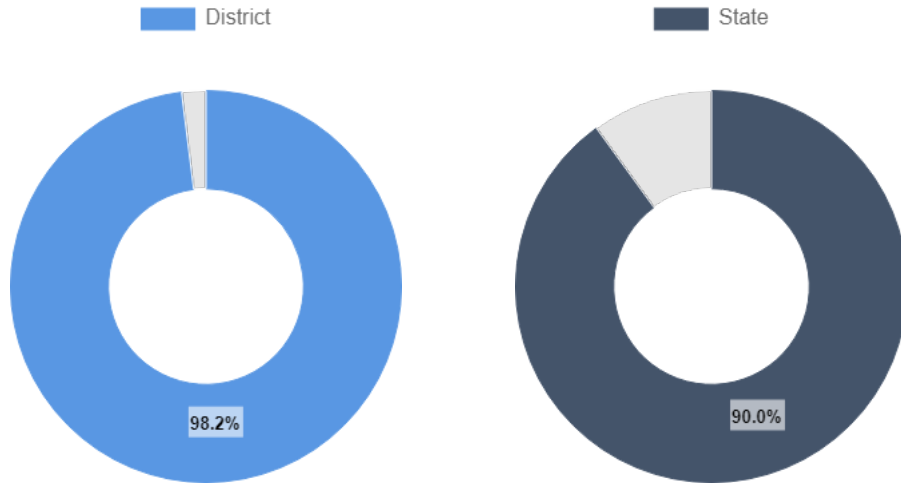

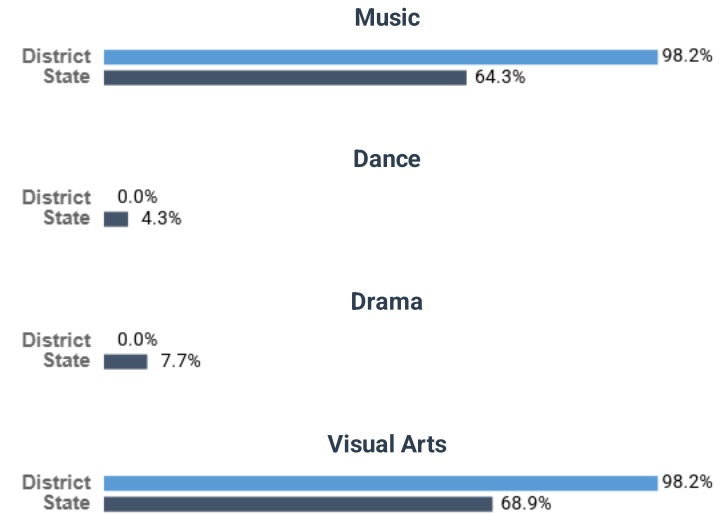

Students enrolled in one or more classes by discipline:

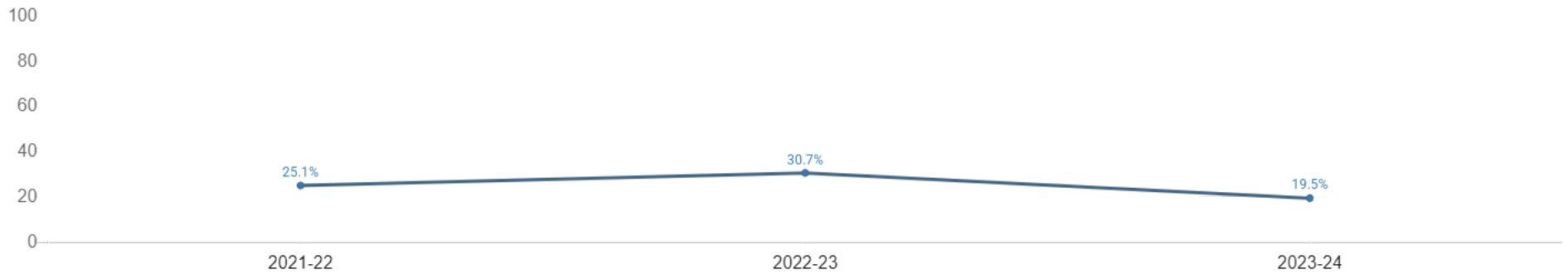

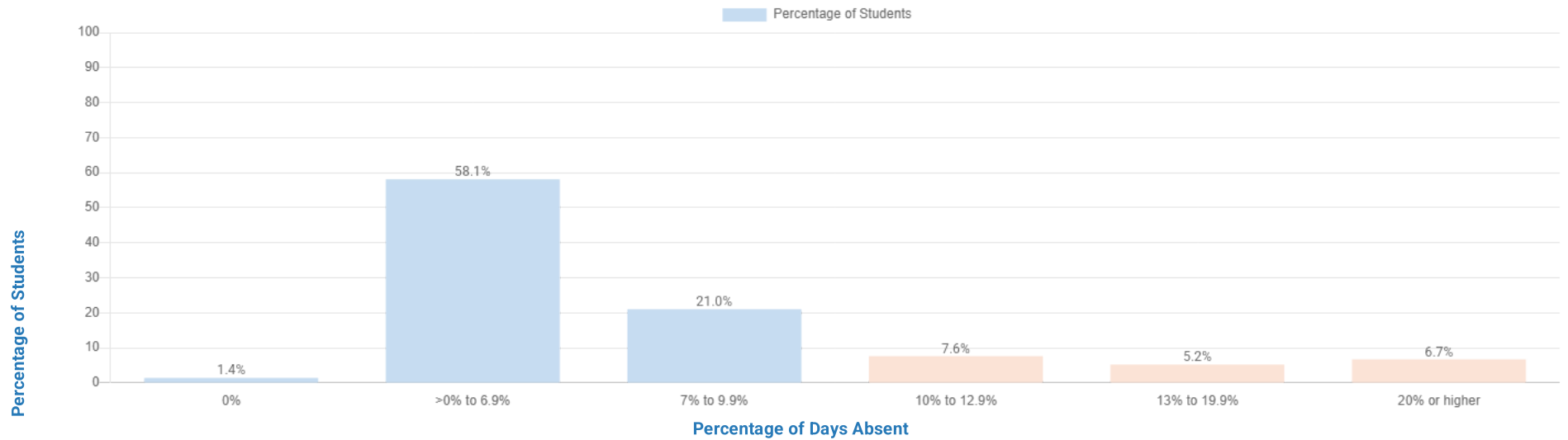

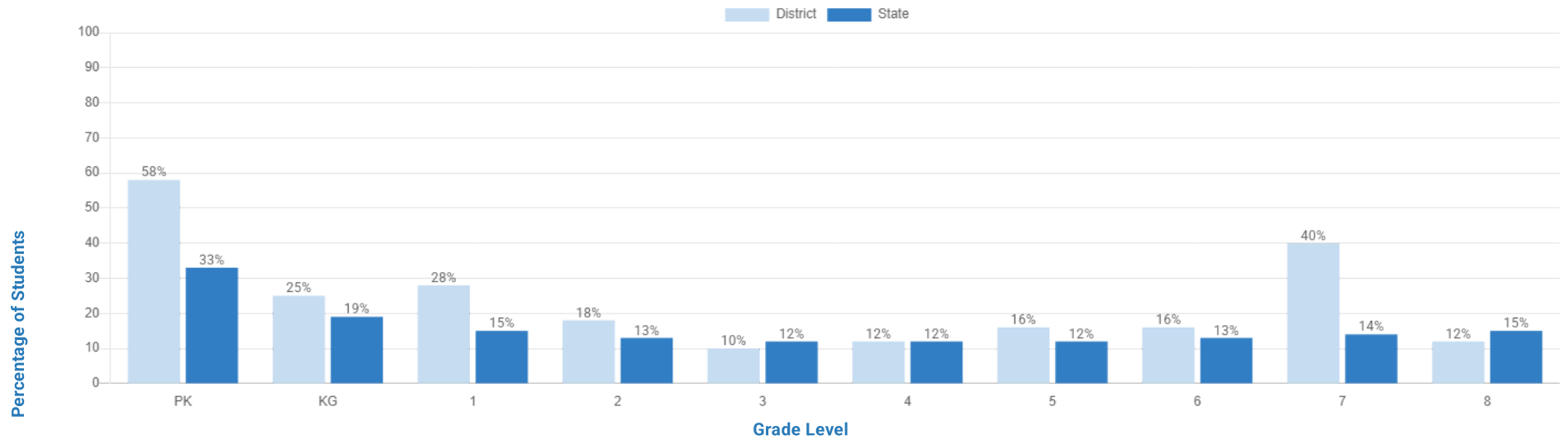

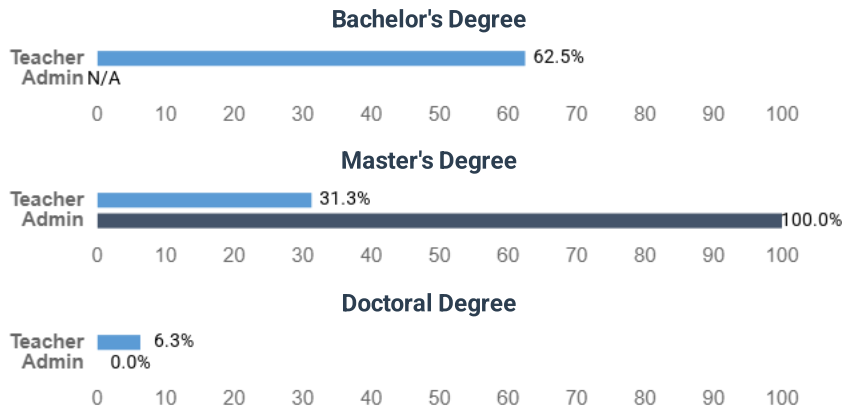

Our campus provides an enriching environment for students to learn and grow with sections of the school that date to 1912, a recently voter approved referendum will allow for necessary updates to our school inclusive of new roof for the school, updated student restrooms, new windows and doors, HVAC updates, as well as updates to our 1900 building to allow for more instructional classrooms. Hallways are lined with child created art as well as museum-quality artwork. Outside students have two playgrounds and a large ballfield that are regularly used. In 2022, we opened a preschool playground to support our youngest learners.

Hamburg School regularly hosts school safety and security meetings where staff and local law enforcement come together to discuss best practices in keeping our school safe and secure. BOE members and parents are invited to participate in these meetings.



Technology and STEM:

Students are exposed to a fully integrated curriculum where technology and STEAM type activities are integrated in all content areas. The school has 3D printers, laser printer, poster printer, robotics, VR hardware available for our students. The Hamburg School also has 1:1 technology Chromebooks for every student.

A Master Teacher is now employed to support the ongoing needs of this program.
