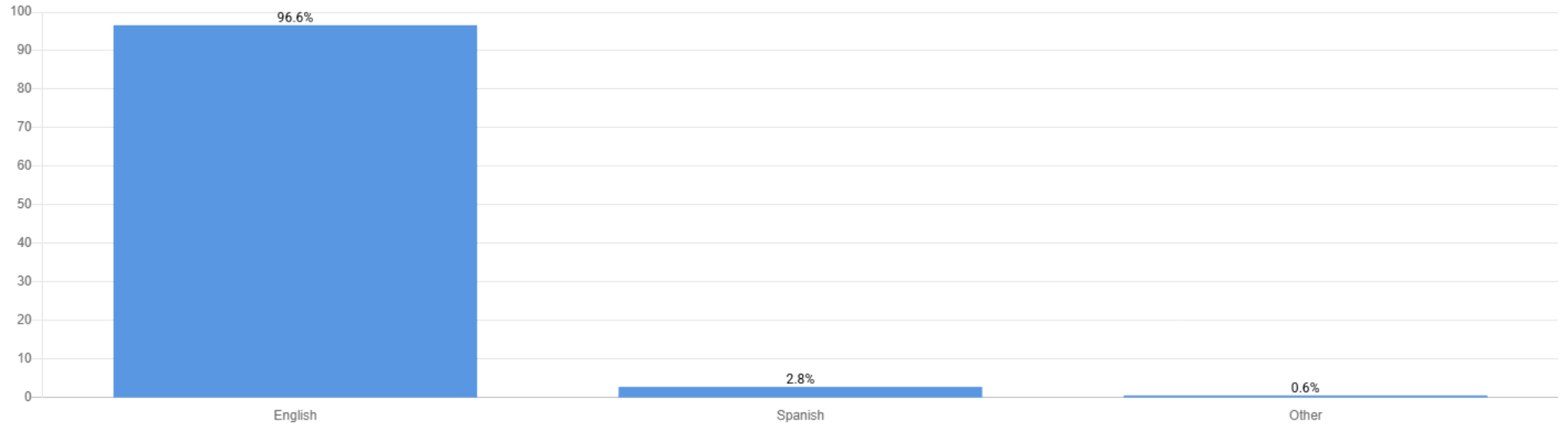

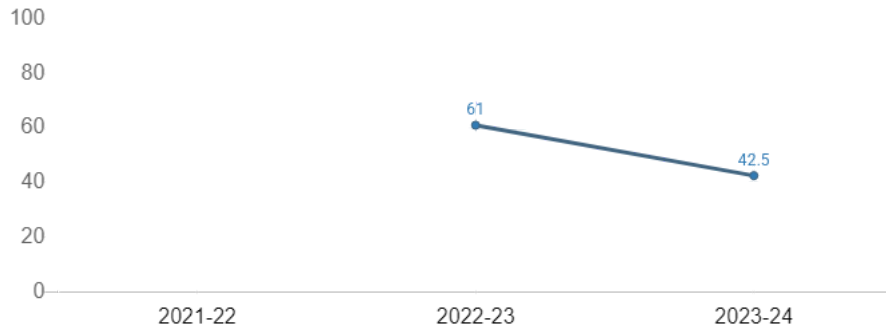

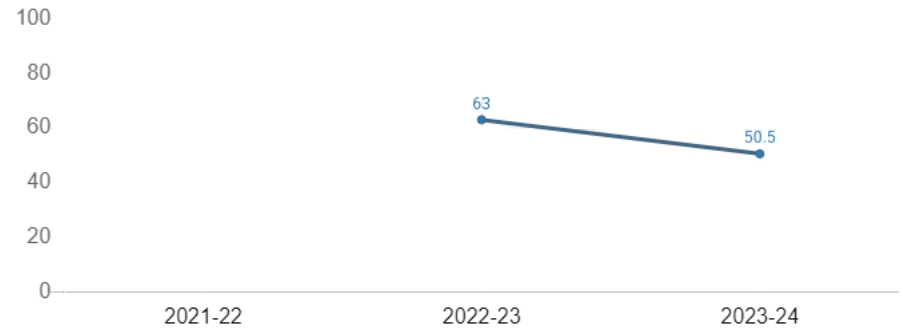

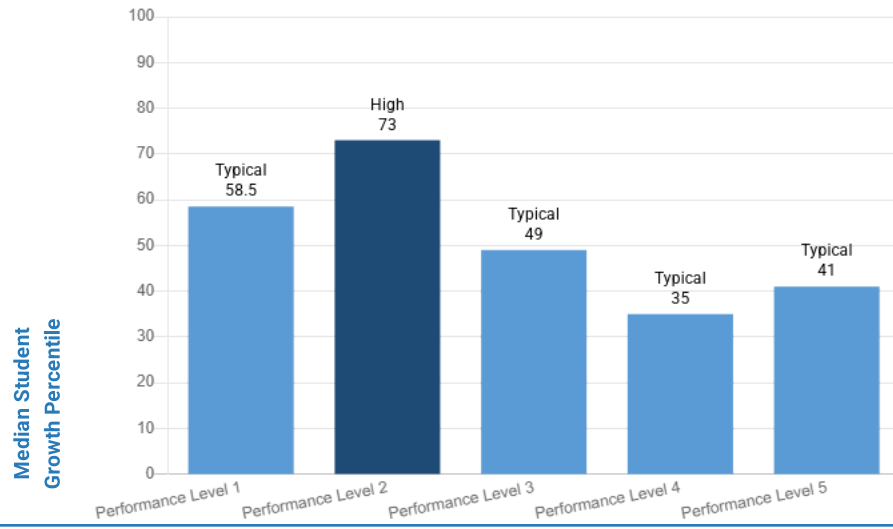

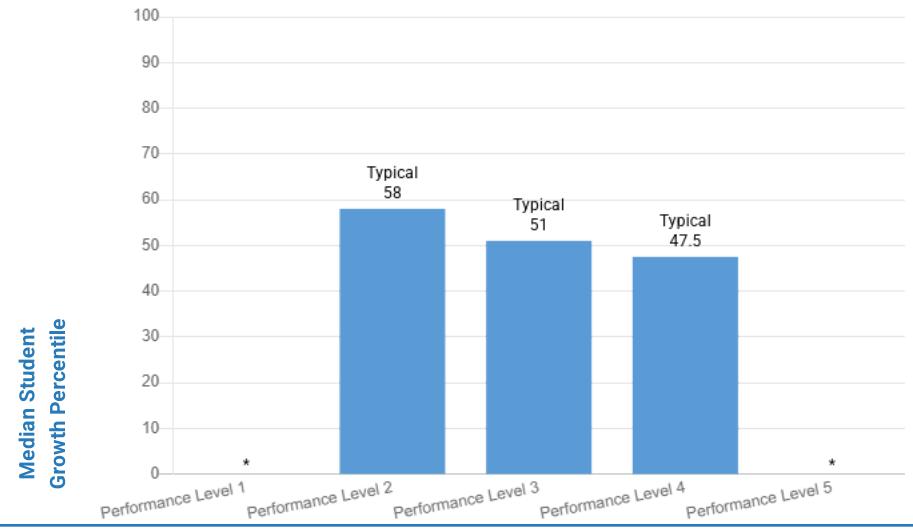

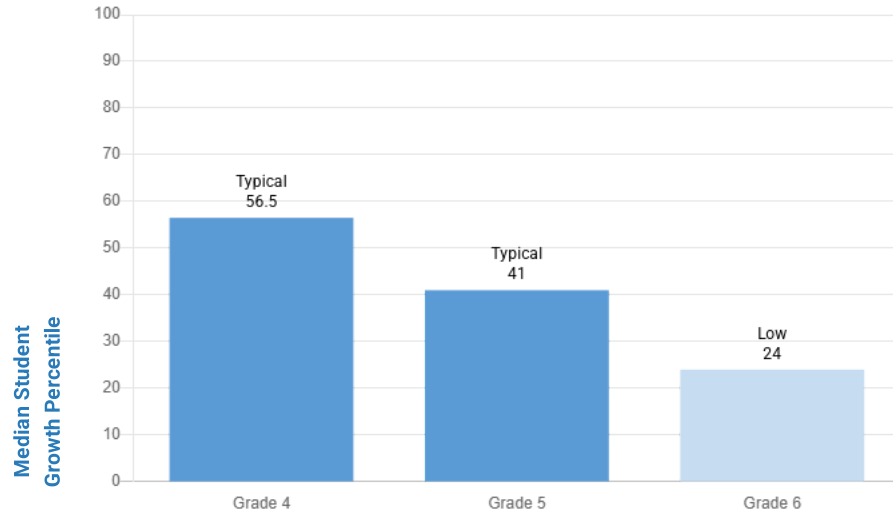

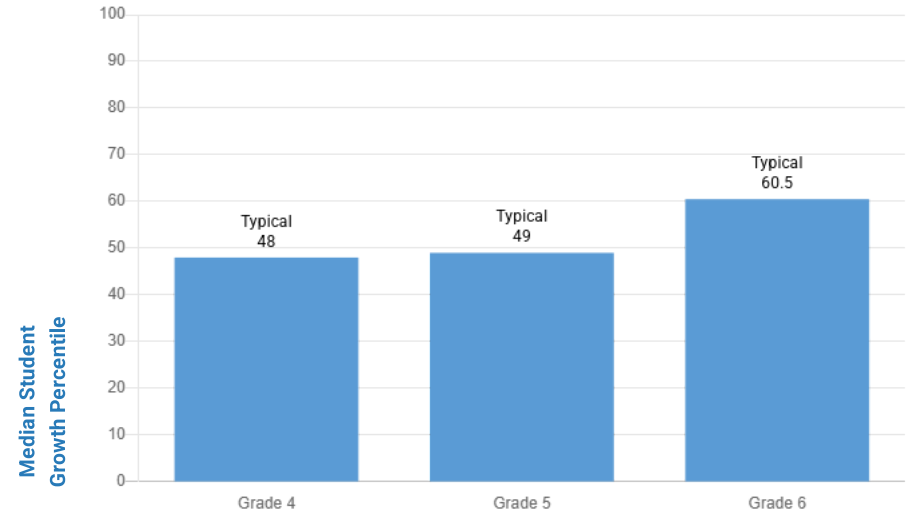

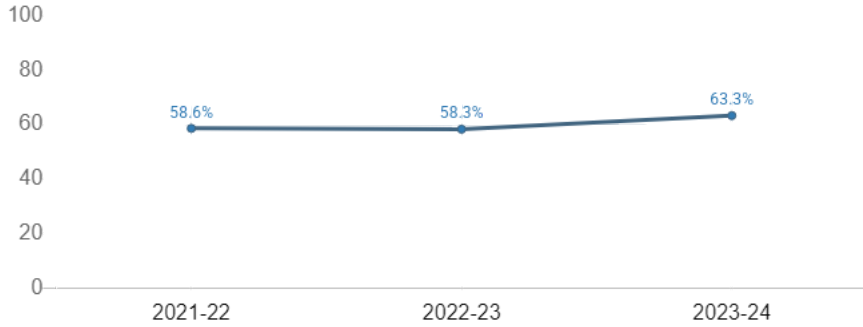

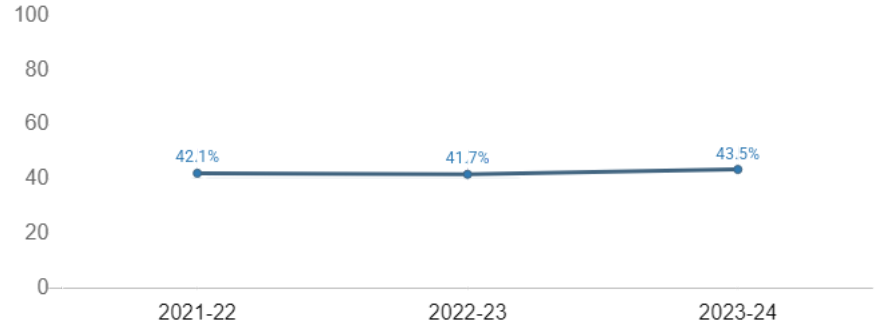
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. The Proficiency Rate for Federal Accountability measures the percentage of students who met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. Student are considered to have met or exceeded expectations if they score at Level 4 or 5 on the NJSLA or at Level 3 or 4 on the DLM.

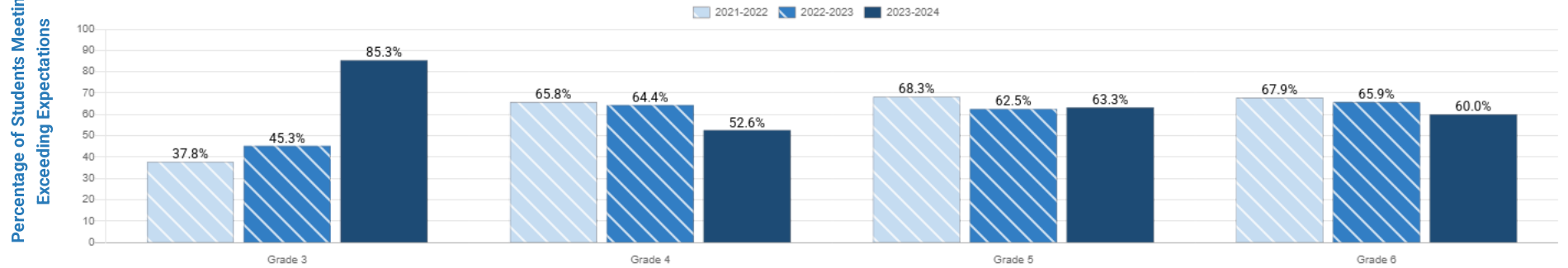

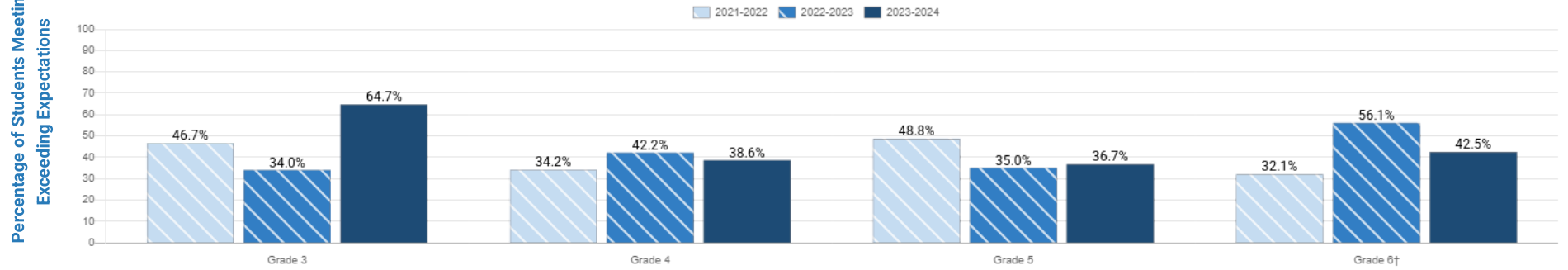

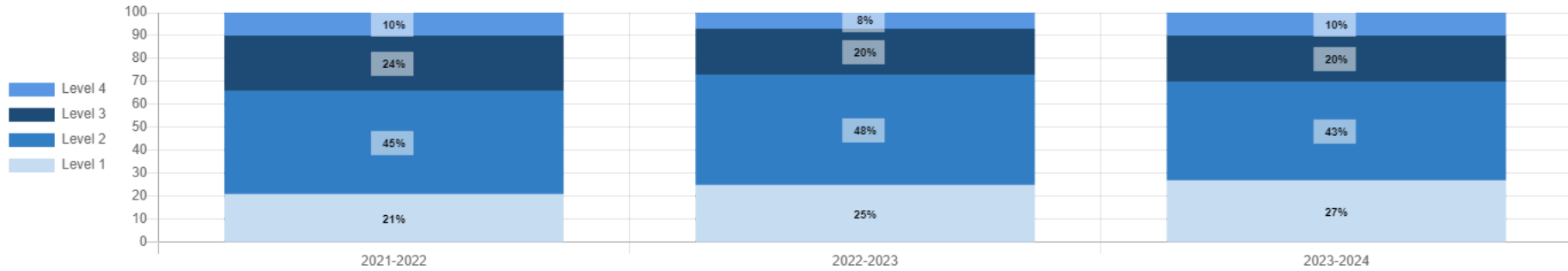

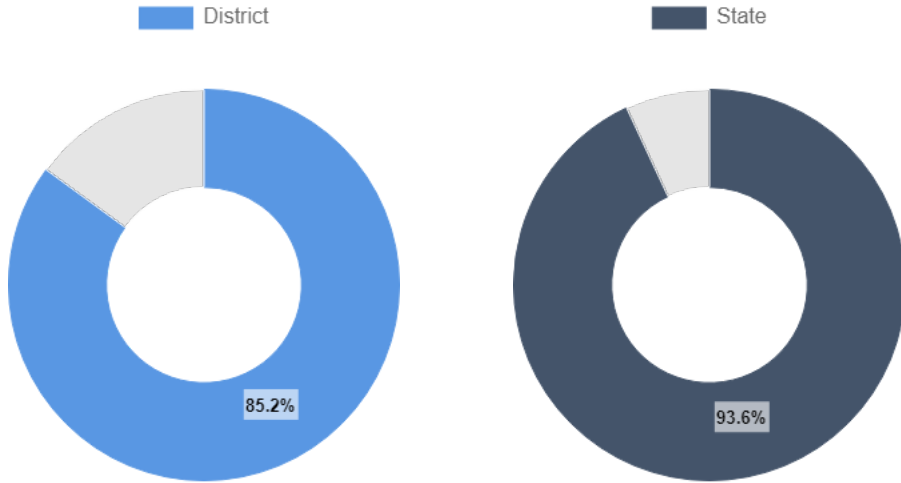

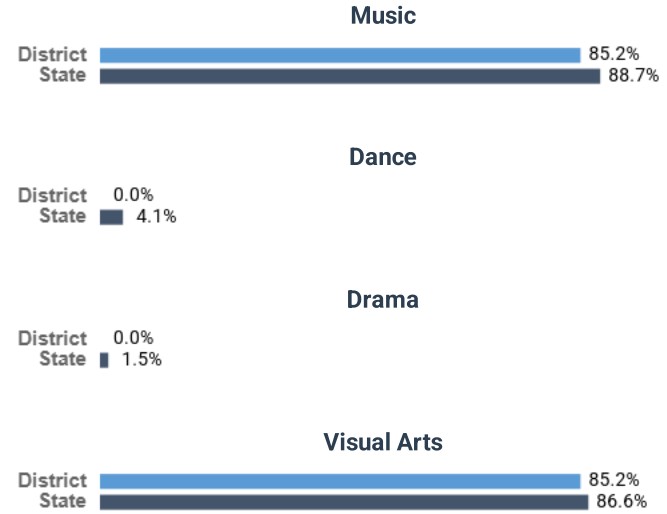

Students enrolled in one or more classes by discipline:



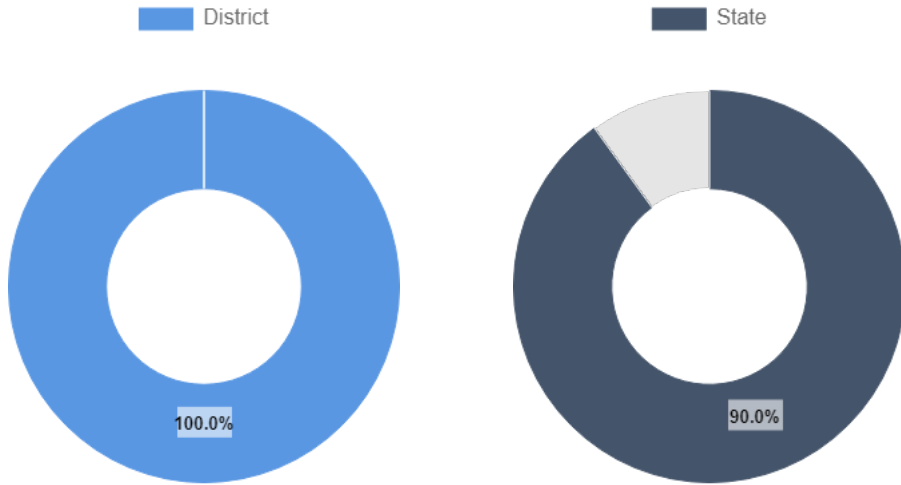

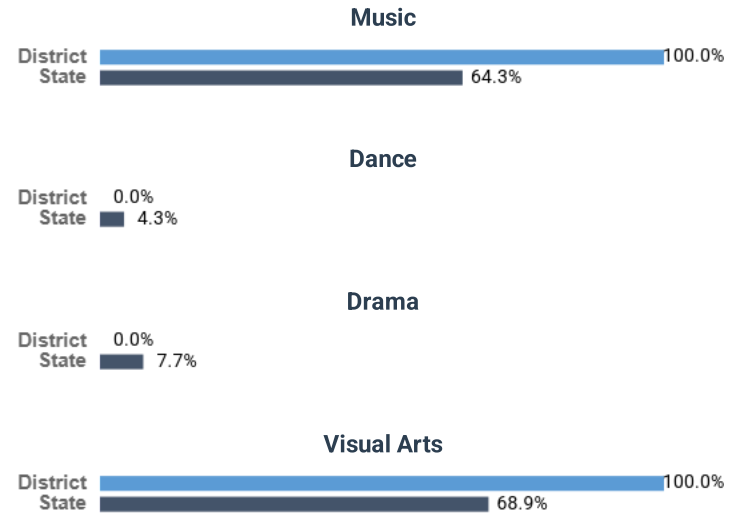

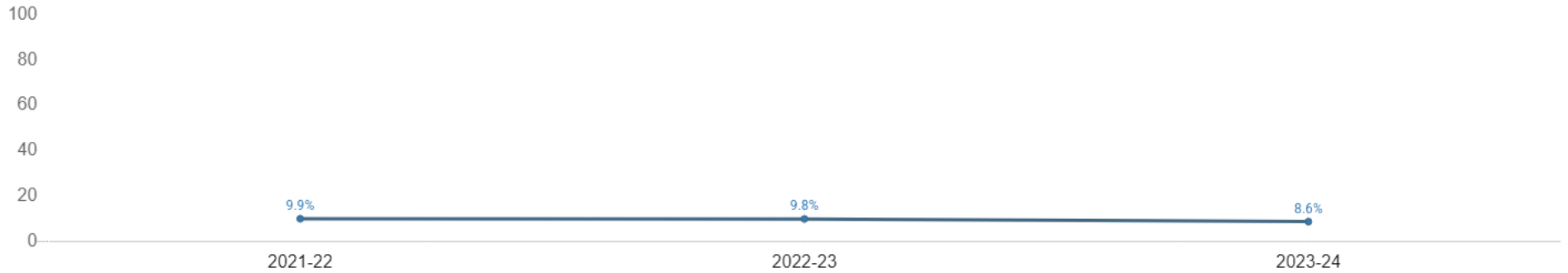

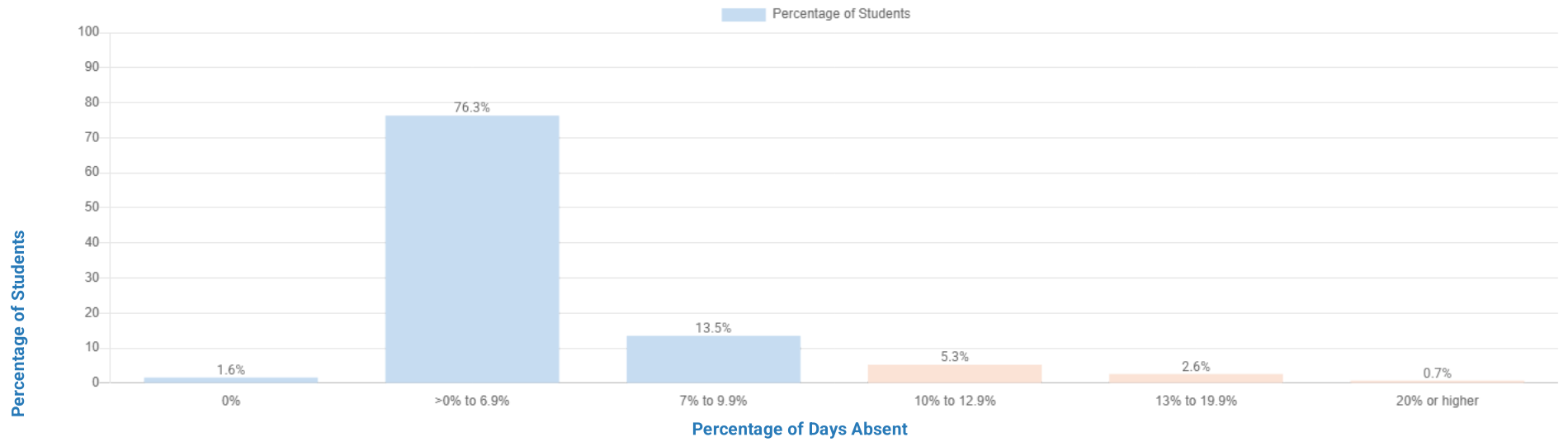

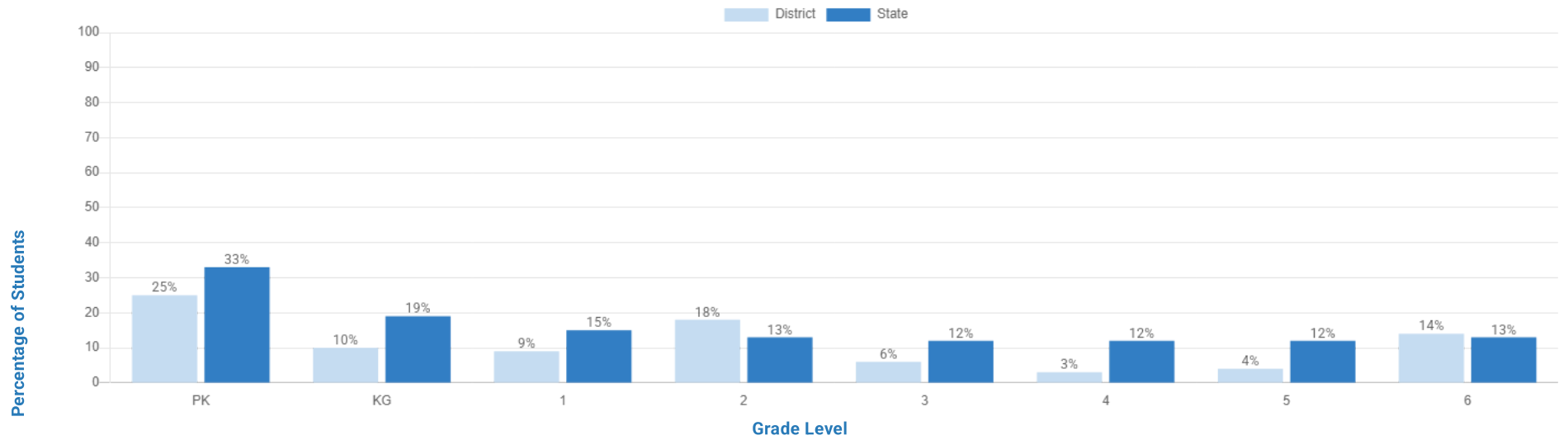

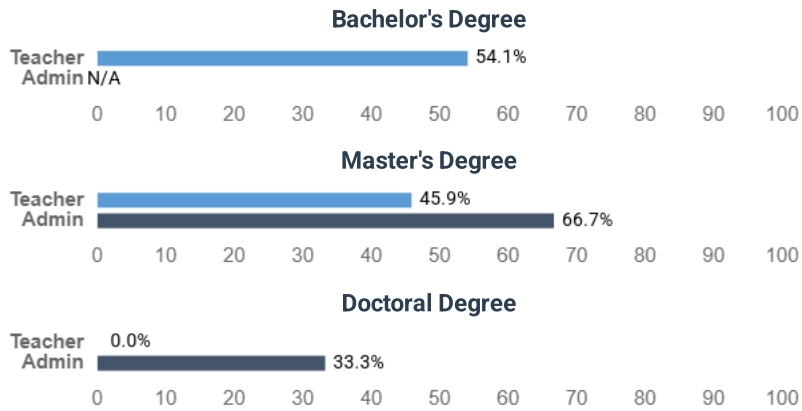

- McKeown School provides a welcoming and comfortable academic environment. Average class size is 18 students. McKeown is a safe and secure building with updated security and video surveillance.
- There is a focus on the individual student needs and our staff is highly trained to address learning issues that may be experienced by our students. We are a ?high performing? school district.



Mission, Vision, Theme:

To provide each child with varied educational experiences, while emphasizing individual student academic growth, through community support in a nurturing and stimulating environment in order to develop life-long learners who are productive citizens.



Awards, Recognition, Accomplishments:

We are a ?high performing? school district in the heart of the Kittatinny Mountains. A Pre Kindergarten - 6th grade students at McKeown Elementary School assisted the SCMUA-Walkill River Watershed Management Group with the installation of a rain garden on the school's property. The design was created by Rutgers Cooperative Extension Water Resources Program and covers 3,800 square feet, the largest rain garden that Rutgers has installed in New Jersey. Annually, the rain garden captures, treats, and infiltrates over 500,000 gallons of stormwater runoff. Students continue to maintain the garden through science classes and a summer environmental camp. Hampton Township S.D. is a ?high performing? school district as determined by the triannual district monitoring by the New Jersey Department of Education process (QSAC) completed in the 2022-23 school year.

Courses, Curriculum, Instruction:

All course curricula for PreK - 6 grade levels are aligned to meet NJ Student Learning Standards and Next Generation Science Standards and are developed to meet the needs of our students and our school community. The school participates in the Kittatinny Curriculum Consortium to update and meet all curricular standards and the district focuses on early intervention and utilizes a diverse number of intervention strategies for struggling students. The district updated the Math curriculum during the 23-24 school year and is in the process of updating ELA. McKeown has a STEM and computer technology program for the students of McKeown.



Sports and Athletics:

McKeown School works together with our local recreation committee to provide students opportunities to be actively engaged in the pursuit of a safe and healthy lifestyle. Many of the local township teams utilize the school facilities and grounds as the home base for their activity. This includes but is not limited to soccer, wrestling and basketball. Water safety instruction is provided to students in grade 4 utilizing the indoor pool facilities at Kittatinny Regional High School. We also take part in the annual Jump for Heart activities. A Wellness Committee plans and implements health related activities and challenges for students and staff throughout the school year.



Clubs and Activities:

Students in grades 4-6 perform in winter and spring vocal concerts. Students may also elect to participate in instrumental music beginning in grade 4. Instrumental musicians also participate in school performances. A district level band and chorus is open to students through a try-out process. A vocal music group, Chorale, is open to students in grades 4-6 who meet tryout criteria. Chorale meets weekly, after school, throughout the school year and has several performances. After school for students who wish to participate includes TREPS, eSports, Lego Club, FF Robotics, Craft Club, Coin Club, SEEK, Yearbook Club, Interact Jr., Fitness Club and Board Games. The traditional McKeown spring talent show is held at the end of the school year.

Before and after school care is provided by the YMCA for students in grades K - 6. After school activities vary, but are inclusive of tutoring, Response to Intervention and numerous clubs sponsored by the school and organized/conducted by the staff at McKeown.



Staff and Professional Learning:

Faculty and staff attend professional development as needed in various areas of the curriculum. Programs also include workshops on school safety, Readers/Writers Workshop, Orton Gillingham, Response to Intervention, Renaissance training, EnVision Math, CPR, technology, Dyslexia, Science programs and intervention services



Student Supports and Services:

The McKeown Child Study Team is staffed with a CST coordinator, School Social Worker, LDTC and School Psychologist. Speech, Occupational Therapy and Physical Therapy are provided to students who have an identified need for services. We employ the contracted services of behavioral interventionist, ABA trained consultants and numerous other community based support services for our school and families. The Hampton Township S.D. has utilized available ESSER funds to close gaps in technology, provide students with extra academic support after school and bring in guest speakers to address topics such as social behaviors. Renaissance testing software has been incorporated this year to provide additional data to pinpoint areas of improvement. After school remediation programs are also implemented. Hampton has also provided summer programs to supplement instruction in Math and English Language Arts.

Student Health and Wellness:

All students participate in health classes weekly. The L.E.A.D. program is provided to all grade 5 students through the Sussex County Sheriff's Dept. Grade six students attend an annual anti-bullying summit in the fall. Various proactive education activities are provided throughout the school year for all grade levels including anti bullying education, drug and alcohol awareness and social emotional learning programs. Students enjoy participating in a Jump Rope for Heart campaign each year. A Wellness Committee plans and carries out a number of health and wellness activities throughout the school year.



Parent and Community Involvement:

The Parent Teacher Association is active at McKeown School. The PTA provides a number of family activities each year to support projects during the school year. The Hampton Township Foundation provides funding for various project throughout the year. Parents and students participate in a toy and food drive during the holiday months. Parents of sixth graders join together to plan and carry out grade six promotions activities which takes place in June.

Facilities:

McKeown Elementary School, built in 1974, is a one story, PreK - 6 building located on 19.27 acres. The school features an open spaced media center, has a cafeteria, gymnasium, computer lab and STEM lab facilities. An upper grade wing was built in 1992 and many areas of the school have been upgraded to meet the needs of the 21st century learner. We have undertaken a massive HVAC renovation project over the last 2 years and this will continue for the next 3-5 years. The building has renovated classrooms, improved the common areas gym/cafeteria, developed a STEAM program and a dedicated STEAM room and instructor and have upgraded all Instructional Technologies in the building. We are a Google based Chromebook 1 to 1 initiative school with interior and exterior WiFi services. The school features an open spaced media center, has a cafeteria, gymnasium, computer lab and STEM lab facilities.



School Safety:

School safety is a high priority. The school monitors the buildings and grounds through an indoor and outdoor camera system. Raptor/Lobbyguard technology monitors all visitors and staff daily. Routine practice of two or more safety drills are held monthly. We have recently upgraded our video surveillance system increasing our video camera coverage and we have completed a full fire alarm system upgrade in the 2022 year.



Technology and STEM:

McKeown school incorporates 1:1 Chromebooks for all students in grades K-6 for in school use. The school also has a Mac computer lab. A STEM teacher works with the classroom teacher to provide students with innovative, research based activities to promote communication, collaboration and creativity. Students participate in solar sprint competitions each spring. Grants for the STEM program have been provided by JCP&L, Toshiba, CenturyLink, Thor Labs and Weiss Markets.

Early Childhood Education:

Students in the district at age 3 who require early intervention may be referred to our Child Study Team and may qualify for our full day preschool program. Beginning in late 2024 Universal Preschool Funding for three, general education preschool classrooms were made available for children ages 3 and 4 in our district for the 2024-2025 school year. The expansion of this program is underway for an additional class during the next school year. All Hampton Township residents who have preschool aged children may register and a lottery is held in early spring to determine the final roster of students.



Attendance:

After school tutoring is scheduled annually for students in need of additional academic support. Various summer school programs are available during June and July. Summer camps also take place at McKeown including STEM, science camp and art camp.
