














English Language Arts and Mathematics Performance Trends
















Climate and Environment









Mountainside's ELA program encompasses a blend of 95% phonics/word study and the Teachers College Readers Writers Program. Through the use of these programs, students at all grade levels utilize an integrated reading and writing program. Students participate in hands-on learning opportunities throughout all academic areas including math centers, exposure to STEM projects, integrated science labs in middle school, and regular infusion of technology. Advanced academic courses are offered at the middle school level through honors and high school level classes.

The services take place onsite within both buildings.

Our district is committed to professional learning across the curriculum. Teachers are provided with both in-district and out-of-district opportunities to attend professional development workshops that align with their instructional areas. In addition, teachers meet weekly in their professional learning teams to ensure continuity and to collaborate regarding program and student learning. The district has incorporated the use of Reading and Math Specialists to provide further instructional guidance and support for teachers and individual students. Mountainside Schools also works closely with Berkeley Heights to enhance curricular alignment for student programming to ensure similar academic experiences prior to their attendance at Governor Livingston High School.



Student Supports and Services:

Mountainside School District employs a full time Child Study Team, along with related service providers to support our special needs students. The district incorporates a variety of instructional programs for identified students including integrated pre-school classes. IR&S teams at each school meet monthly to support students throughout the year. Our basic skills program (AIM) provides both pull out and push in services and monitors students' progress. Parents are integral members in the decision making process. The district also employs math and reading specialists to support academic instruction for students and staff.

Student Health and Wellness:

Mountainside incorporates various Social Emotional Curriculum programs to support the students at all grades. Staff has been provided with professional development and resources to implement the programs District-wide. In addition, each school has full time counselors and nurses available to meet with students and staff in order to assist with individual needs. For the 2024-2025 school year, Mountainside has contracted with an outside mental health provider to assist with providing on-site mental health support for students, staff, and families.



Parent and Community Involvement:

Our parent and community groups are extremely supportive and raise money to provide enrichment activities and grants for our students. In particular we are grateful to our PTO and the Watts Foundation for funding many school projects. Our parents and community members provide an endless source of volunteers for all aspects of our programming and we appreciate their dedication and support.

Facilities:

With the passage of a previous referendum we were able to update both of our schools with new roofs, new heating & air conditioning systems, new phone & security systems, and new technology infrastructure. At Deerfield there are new windows & doors, hallways, floors, lighting, and a new media center.



School Safety:

We work closely with the Mountainside Police Department, the Westfield Regional Health Department, and other local agencies to provide a healthy, safe, secure, and protected school environment. In the past years, we have upgraded our physical plant with additional security cameras, swipe cards, and gates. Additionally, Mountainside utilizes the support of a School Resource Officer and Class II Officers to enhance security for students and staff. All district safety plans are regularly evaluated and updated as necessary.



Technology and STEM:

Mountainside School District utilizes a secure wifi environment. Chromebooks, projectors, and document cameras are utilized on a daily basis at all grade levels to enhance instruction and student learning. Students at all grade levels are provided with 1:1 technology use. All students in grades K-2 at Beechwood Schools participate in a HAMSTER related arts class which is centered on STEM activities. Deerfield School has a dedicated STEM lab which includes 3D printers, robotics equipment, and video editing equipment. Additionally, all students in grades 6-8 can participate in after-school Robotics and Coding Clubs.

Early Childhood Education:

Mountainside Schools participates in Child Find in order to assist students with needs at an early age. Fully integrated preschool classes are offered for students with needs. A limited number of slots are also available for students aged 3-4 to attend on a tuition basis.



Attendance:

Mountainside School District utilizes evidence-based practices to improve student attendance and maintain a chronic absenteeism rate below 10%. Attendance is closely monitored and brought to parents' attention when exceeding certain thresholds. A meeting with parents and school administration is set up to develop a plan for improved attendance should a student exceed 10 absences. The attendance policy is shared with all parents and reviewed within the context of how chronic absenteeism can negatively impact student growth and development. Community education and communication efforts include discussion at Parent meetings, Back-To-School night presentations, school newsletters, and individually for families exceeding thresholds set by district policy.
