
















English Language Arts and Mathematics Performance Trends








NJSLA Science Assessment: Grade 5 Summary









Students enrolled in one or more classes by discipline:







Students enrolled in one or more classes by discipline:











Graduation/ Postsecondary

Graduation rates are calculated based on the adjusted cohort graduation rate calculation. Beginning in the 2020-2021 school year, the NJDOE was required to make changes to the methodology used to calculate the adjusted cohort graduation rate for federal reporting and accountability purposes. The United States Department of Education (USED) determined that the NJDOE must only include students who receive a diploma that is fully aligned with the state's standards, meaning they have met the state's graduation assessment requirements, course requirements, and local attendance requirements. This means that students with disabilities who did not meet some or all graduation requirements because of a modifications or exemption in their Individualized Education Program (IEP) may not be counted as graduates in the calculation of the adjusted cohort graduation rate used for federal reporting and accountability purposes. It is important to note that this was only a change to how graduation rates are calculated for federal reporting. It does not affect requirements to earn a diploma or the type of diploma that the state awards to students with disabilities.

Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.









Accountability

New Jersey's Every Student Succeeds Act (ESSA) Accountability System New Jersey's school accountability system identifies schools in need of comprehensive and targeted support as required by the Every Student Succeeds Act (ESSA). Based on New Jersey's [approved ESSA state plan](#), NJDOE will identify schools in the following four federal categories every three years:

- **Comprehensive Support and Improvement (CSI): Overall Low Performing:**
 - Title I schools with a summative score in the bottom 5% of Title I schools.
- **Comprehensive Support and Improvement (CSI): Low Graduation Rate:**
 - All high schools with a four-year graduation rate of 67% or less
- **Additional Targeted Support and Improvement: Low Performing Student Group (ATSI):**
 - All schools with one or more student group with a summative score that would be in the bottom 5% of Title I schools
- **Comprehensive Support and Improvement (CSI): Chronically Low Performing:**
 - Title I schools identified as Additional Targeted Support and Improvement; Low Performing Student Group (ATSI) that are identified for three or more consecutive years, i.e., ATSI schools that do not meet exit criteria.

Annually, NJDOE will identify schools in the following federal category:

- **Targeted Support and Improvement: Consistently Underperforming Student Group (TSI):**
 - All schools with one or more student groups that missed annual targets or standards for all indicators for two years in a row

The Department of Special Services is dedicated to the provision of diagnostic and educational services to students with disabilities. The department determines these services and programs through various mechanisms such as assessment, eligibility criteria, and demonstrated educational need, while providing them within the least restrictive environment. Parental input is always encouraged throughout these processes. Ongoing monitoring of student progress by district staff is essential to ensure appropriate placement and programming. 
Facilities:

The New Providence School District is in the midst of installing HVAC in all educational spaces in each school, and in the high school auditorium. In addition, each school is now outfitted with flexible, modernized classroom furniture to meet the needs of our current and future students. We completed facility improvements related to our STEM curriculum, enrollment, aged infrastructure, and school security. The highlights of our facility improvements include a state of the art media center at our HS/MS, new STEM classrooms at the high school and both elementary schools, and new security vestibules at all district schools. We continue to upgrade our school facilities to provide our students with a 21st Century learning environment.



School Safety:

Our School District is committed to providing a safe and supportive environment for students and staff. We prioritize safety through effective protocols, emergency plans, and regular drills. We also work closely with local law enforcement and emergency services to ensure a quick, effective response if and when an emergency arises. Additionally, we use technology, including security systems and monitoring tools, to enhance the safety of our schools. Each school is outfitted with a School Resource Officer, security vestibules, new door locks, strobe light features, and 3M safety and security window film along exterior windows to provide for a safe learning environment for all students.

NPSD developed Academic, Learning Acceleration, and Mental Health Support programs to assist our students. After-school and summer Academic Programs focus on providing struggling learners with additional instruction and help. The programs provide academic support using small groups and individual instruction designed to assist students in strengthening skills. Eligibility is determined by need using various Class and State Assessments as well as admin/teacher input. The Learning Acceleration program focuses on enrichment activities in STEM, The Arts, and Family Engagement. After-school clubs, small group instruction, individualized attention, and Family Nights are also used. NPSD offers Mental Health Support for both students and staff through professional development, integration of the Second Step Grades K-5 curriculum and Spanish-Speaking Counselors. With this assistance we are providing our staff and students tools to raise their awareness.
