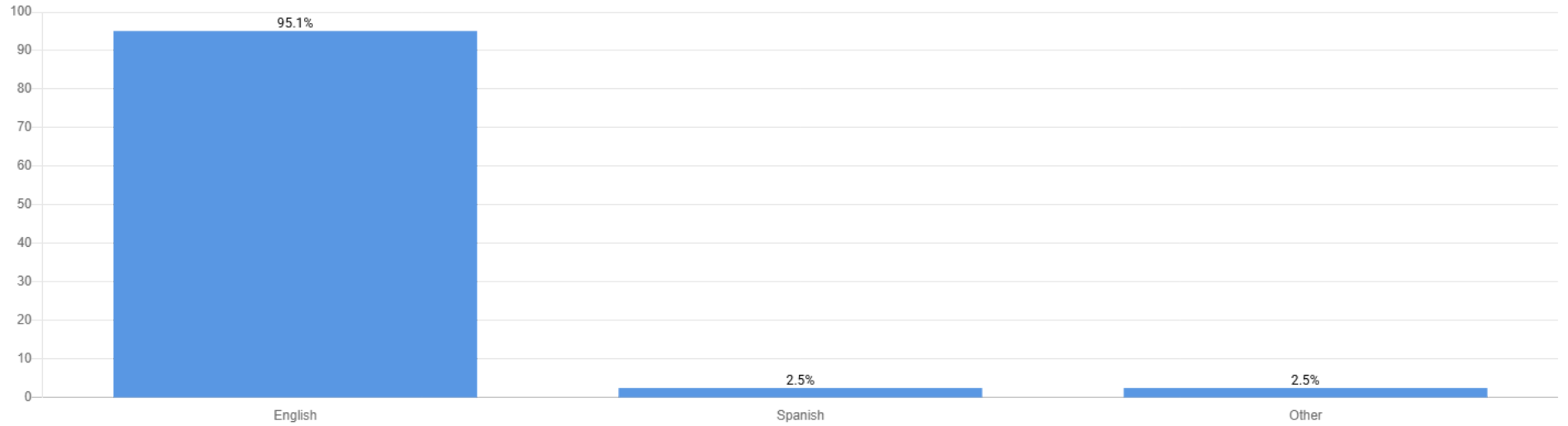

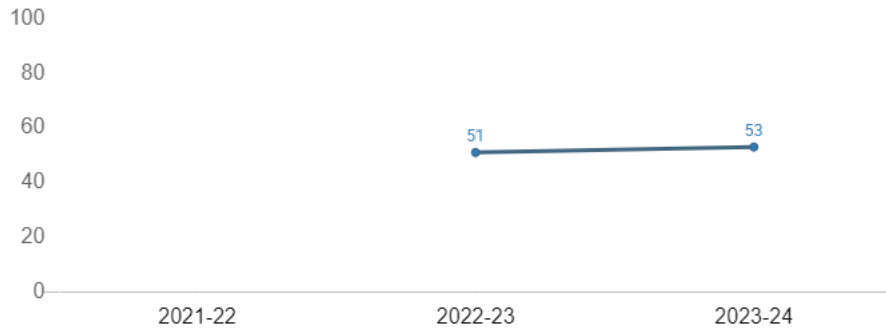

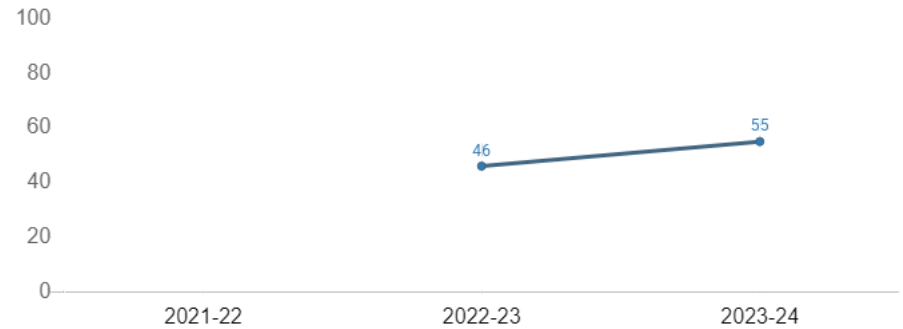

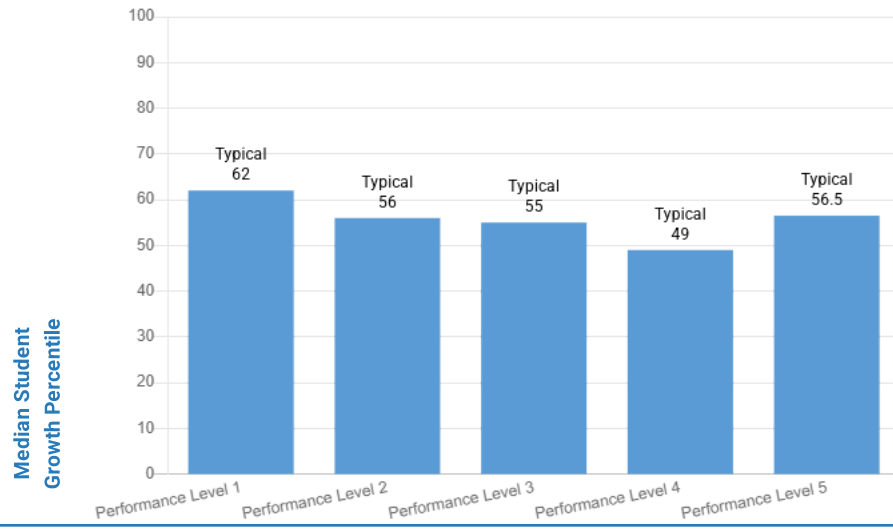

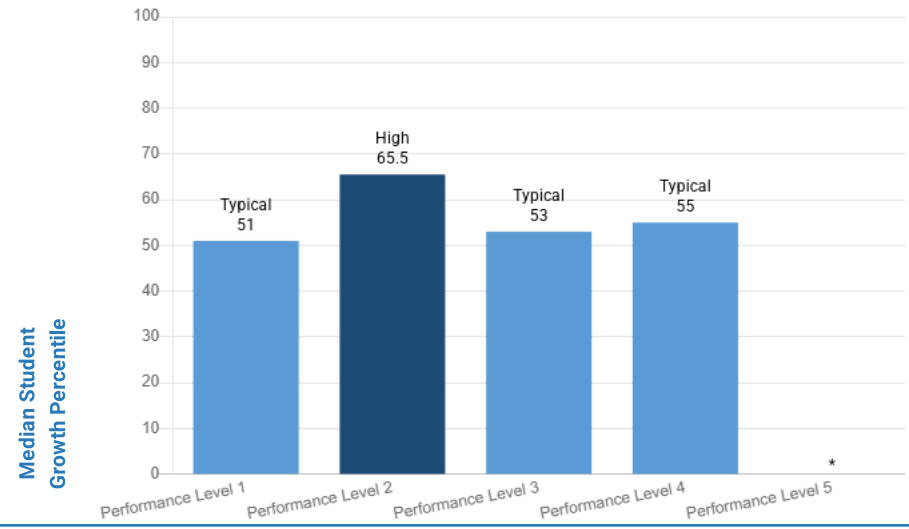

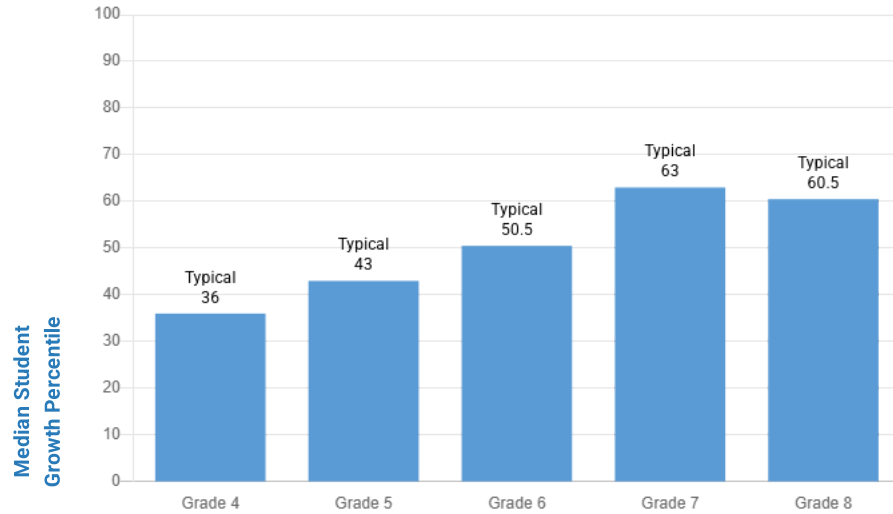

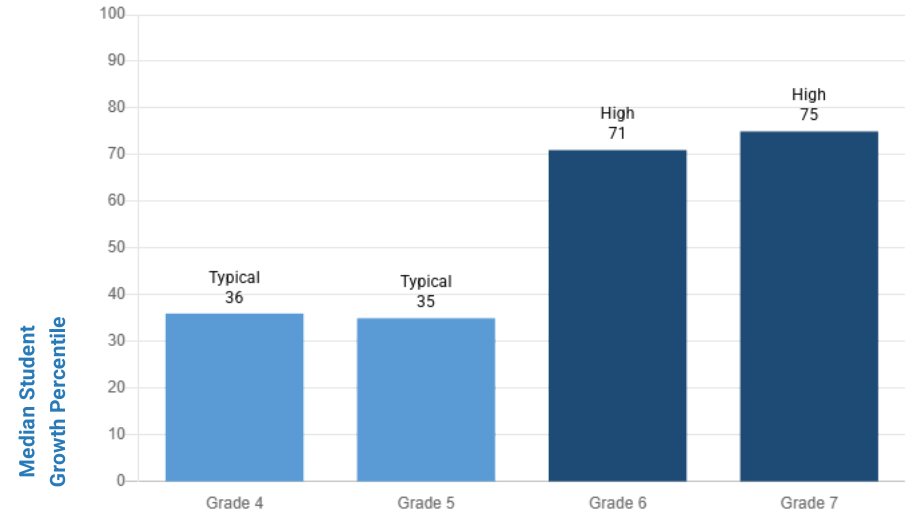

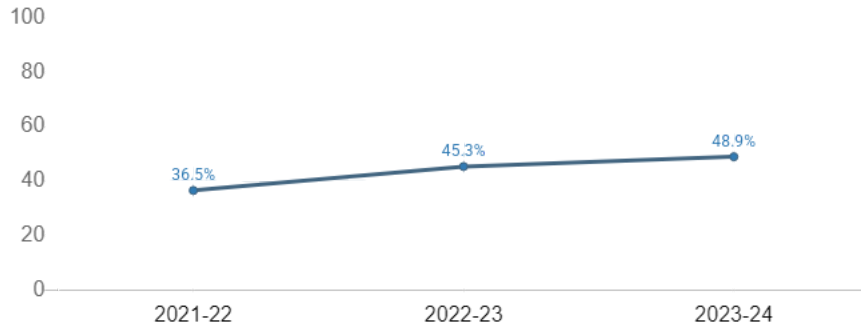

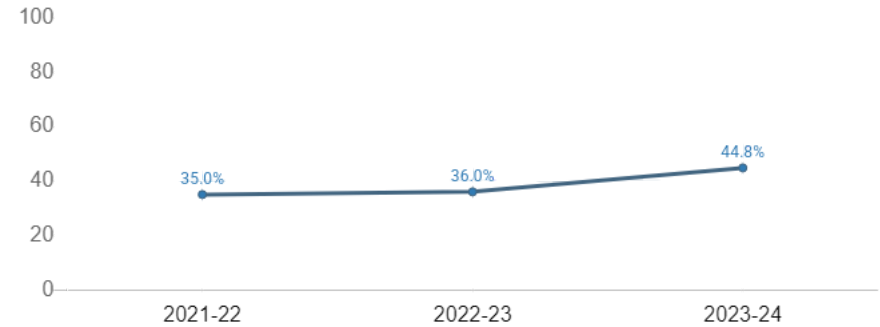
English Language Arts and Mathematics Performance Trends

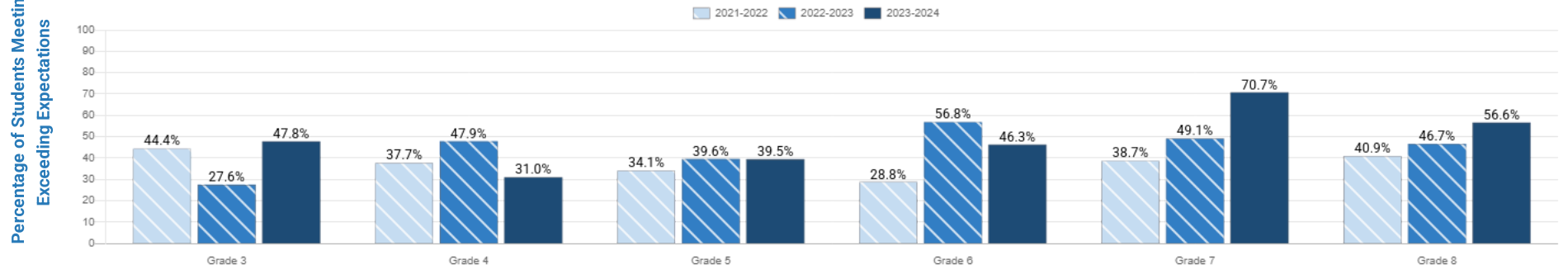

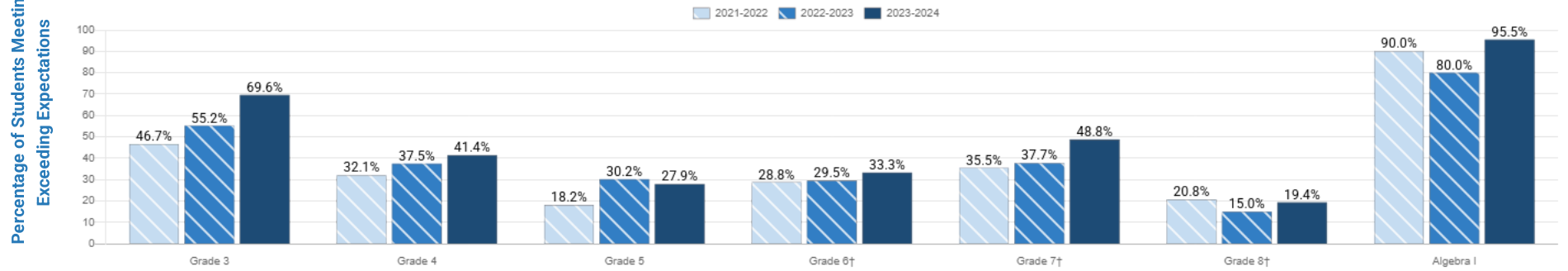

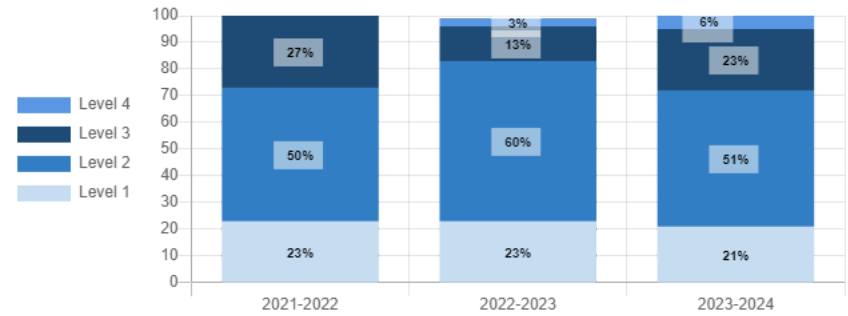

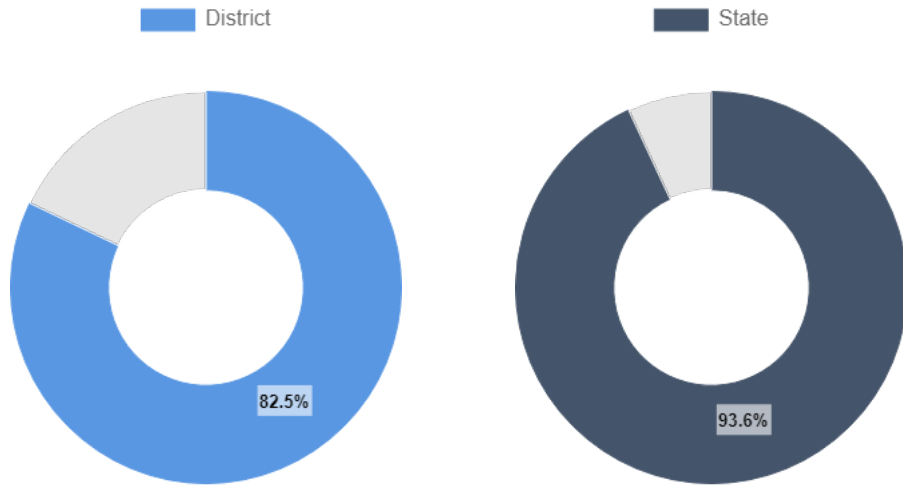

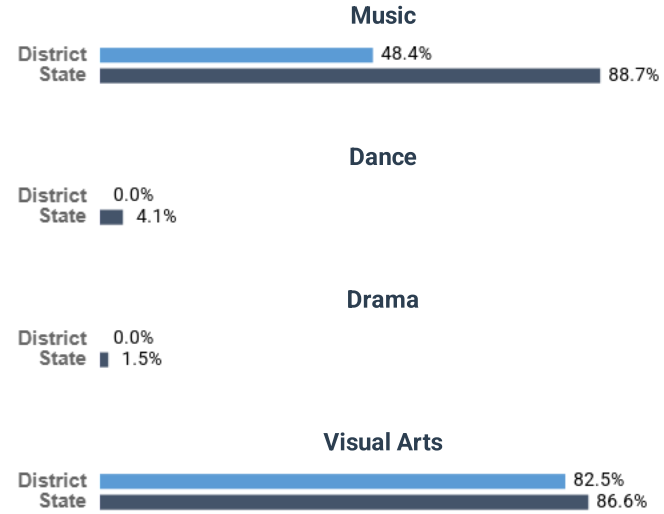

Students enrolled in one or more classes by discipline:



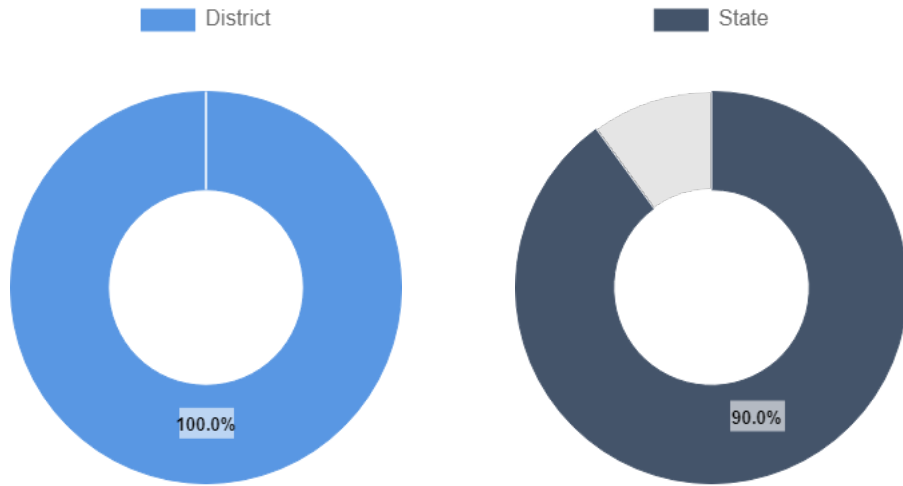

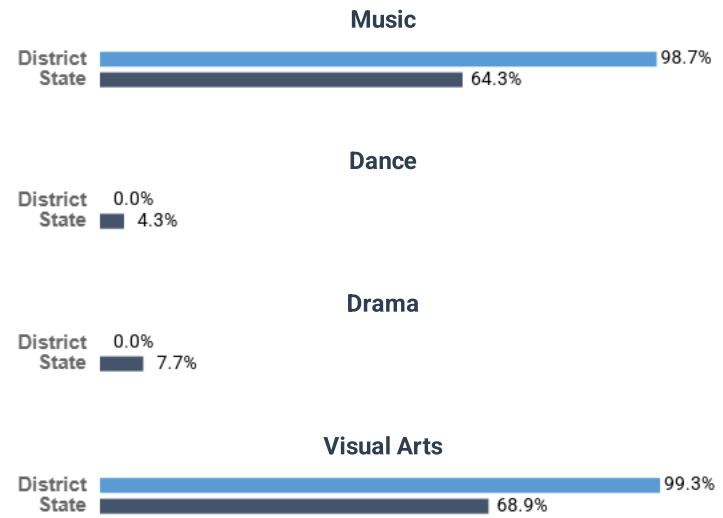

Students enrolled in one or more classes by discipline:

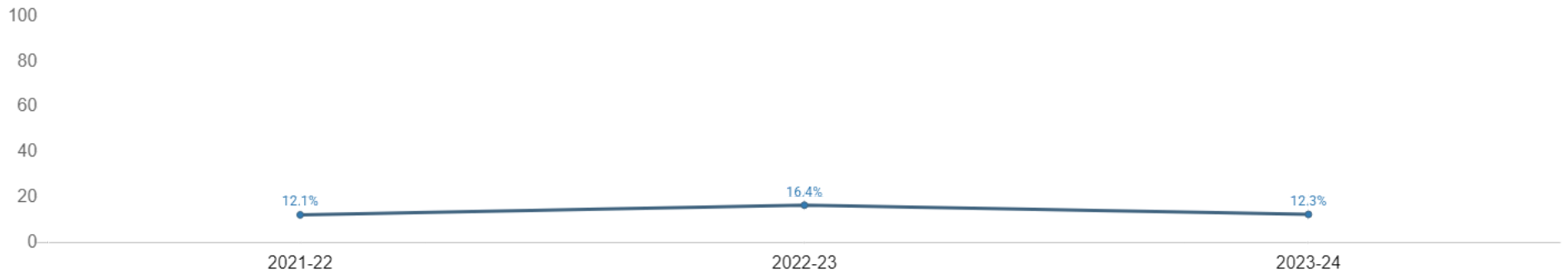

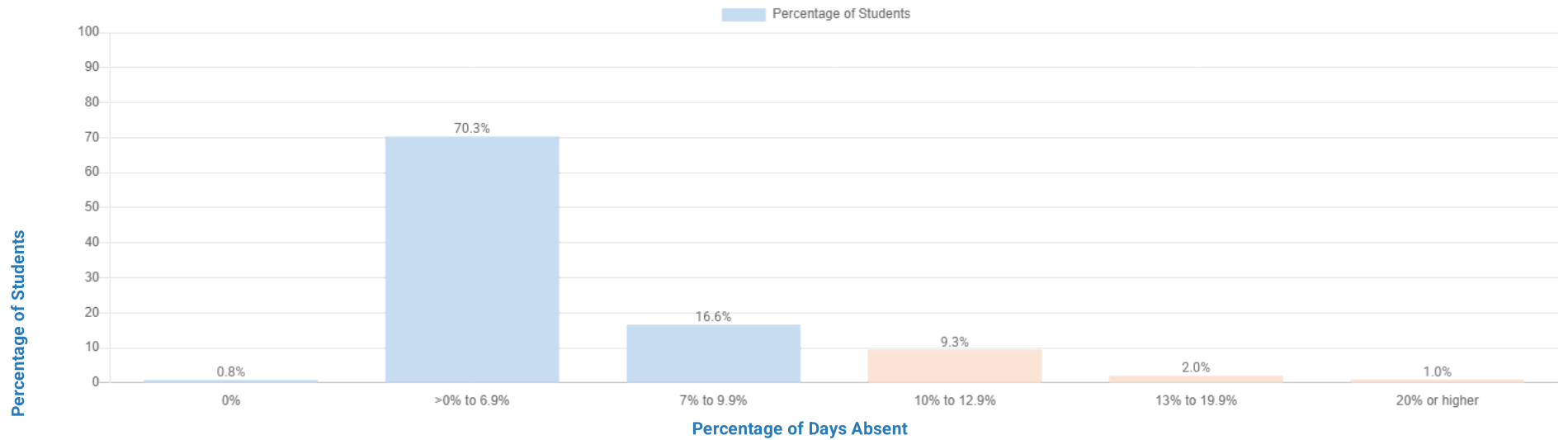

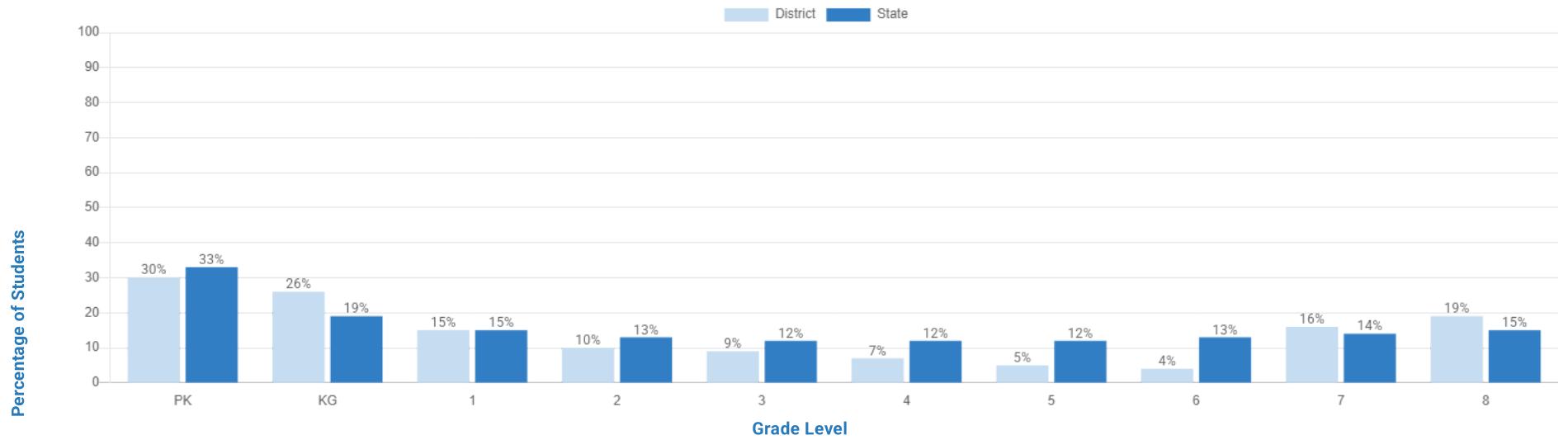

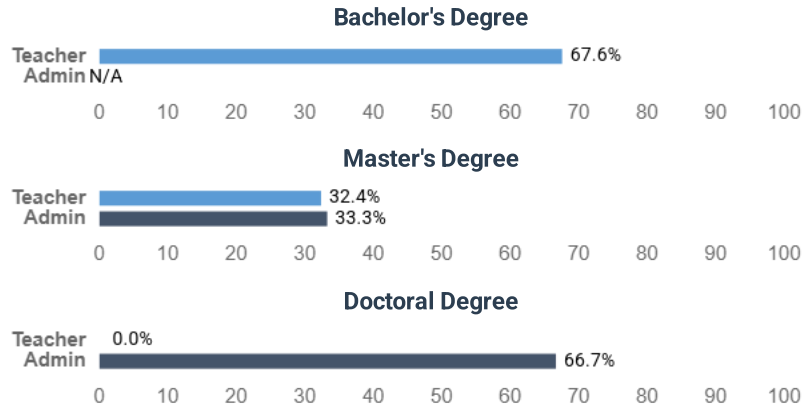

The Allamuchy Township School District offers a rich and broad range of extra-curricular activities to its student body. These activities are organized and supervised by qualified members of the school staff, and financed by the board of education as part of our school community's goal of involving as many students as possible in the complete, wholesome development of well-rounded personalities. Students enrolled in the school can look forward to availing themselves of the opportunities these activities provide for such growth: 8th grade fundraising events, band, chorus, yearbook publishing, National Junior Honor Society, Trep\$, battle of the books, chess, Lego Club and many more. Our Jumpstart/AMP program & Homework Club allows for our at-risk students to participate in additional LA and math practice with the assistance of a teacher.



Before and Aftercare programs are located at the Mountain Villa School for all students. Rutherford Hall and the local YMCA facilitates the program for approximately 25-30 of our students. Both AM/PM sessions offer opportunities for students to complete homework, get assistance, build friendships, and have fun.



Professional development takes many different forms in the Allamuchy Township School District. It is critical that our staff stay abreast of current trends, mandates, and best practices. A PLC-based model will continue to enable our district to take advantage of the knowledge of teacher leaders and to deliver training in efficient, meaningful ways during faculty meeting times. Learning teams or grade level teams are also employed to immerse staff members in a topic and turnkey their new learning to the rest of the staff. Our paraprofessionals are also a learning team that participate in trainings on professional development days. We are a Professional Development School in partnership with Centenary University, providing substantial and meaningful opportunities for professional learning through relationships with university professors, having pre-service teachers in our classrooms through observations and the clinical internship, and enhancing summer enrichment programming.

We have developed a new RTI system, allowing for more individualized instruction and f data collection and analysis to see growth in our at-risk students. Each student that is brought to the team is discussed. Then, goals are developed, and benchmarks are created. Student, staff, and parents are on the same page working to achieve the same goal. Changes, adaptations or exits from the program can occur based on the analysis of the data.

Community members, families, students and staff adhere to safety protocols and best practices established to keep our students safe. We continue to be a part of the Warren County Security Task Force, discussing and implementing best practices for school safety. A School Resource Trooper from the New Jersey State Police has been a great addition to the district and conducts the LEAD program for our 6th grade students.



Technology and STEM:

Technology and STEAM activities are integrated into interdisciplinary lessons in a variety of classrooms. Outdoor classrooms at both school buildings support these activities and enable our students to explore and inquire about the environment around them. Our libraries are transitioning to Makerspace environments, enabling students to tinker and create. We promote technology use through one-to-one chromebook devices in grades 3-8, and iPads and other devices extend our students' experience with educational tools in all elementary classrooms. Students in grades 4-7 participate in a STEAM special class to spark interest in STEAM fields and encourage our students to be creators so they can thrive in a complex, fast-moving and rapidly changing technical world.
