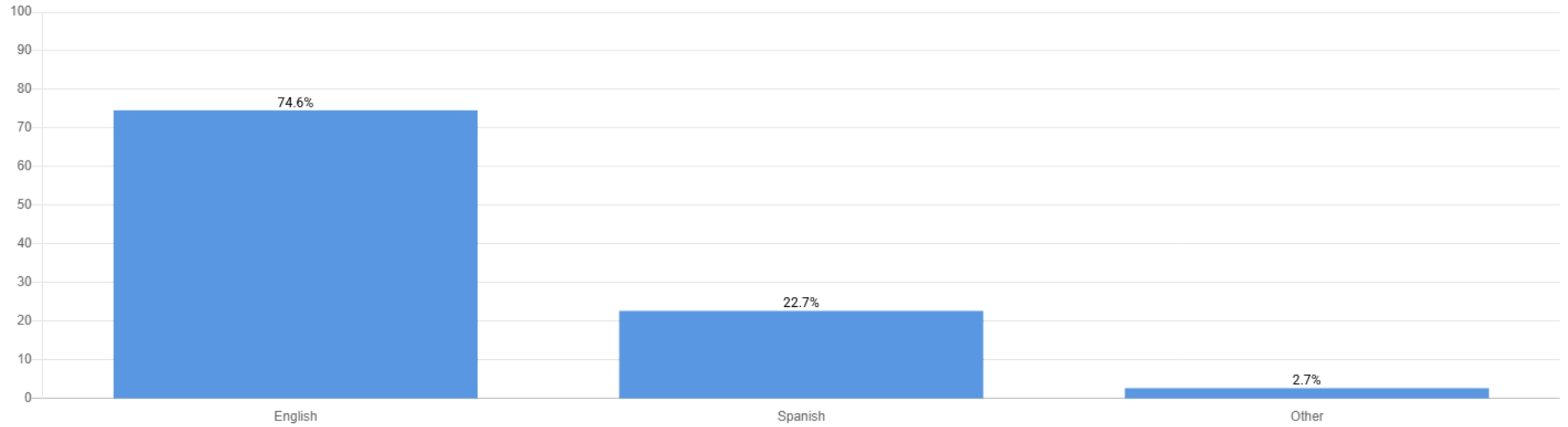

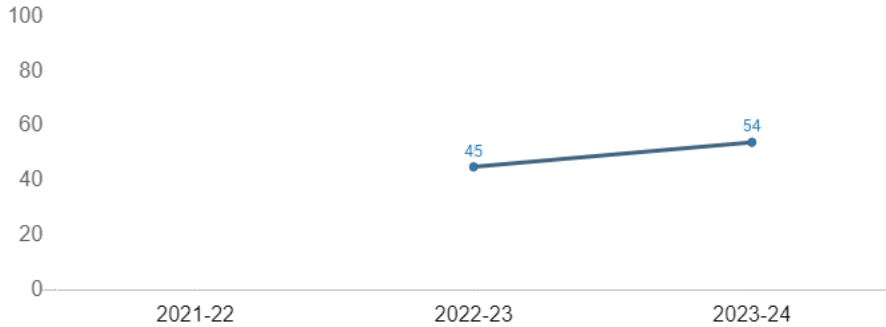

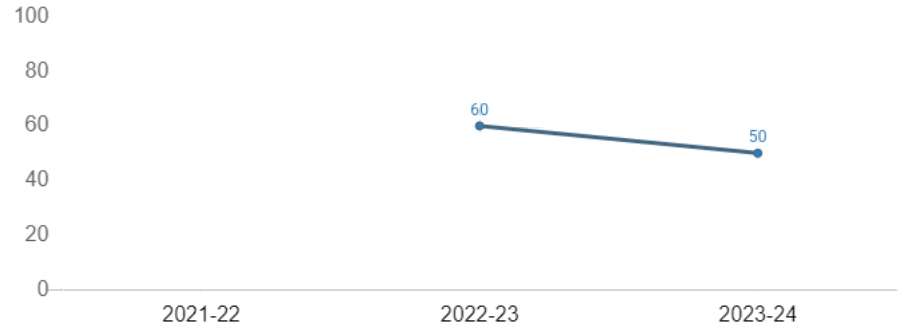

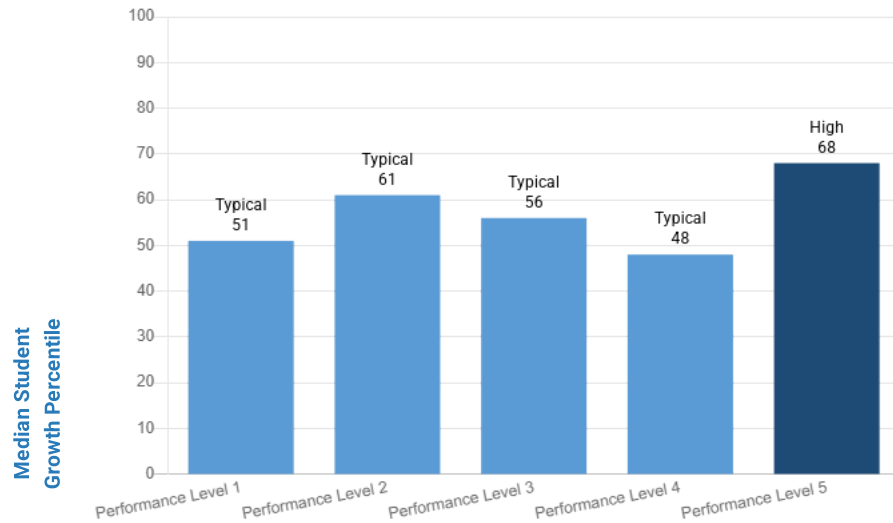

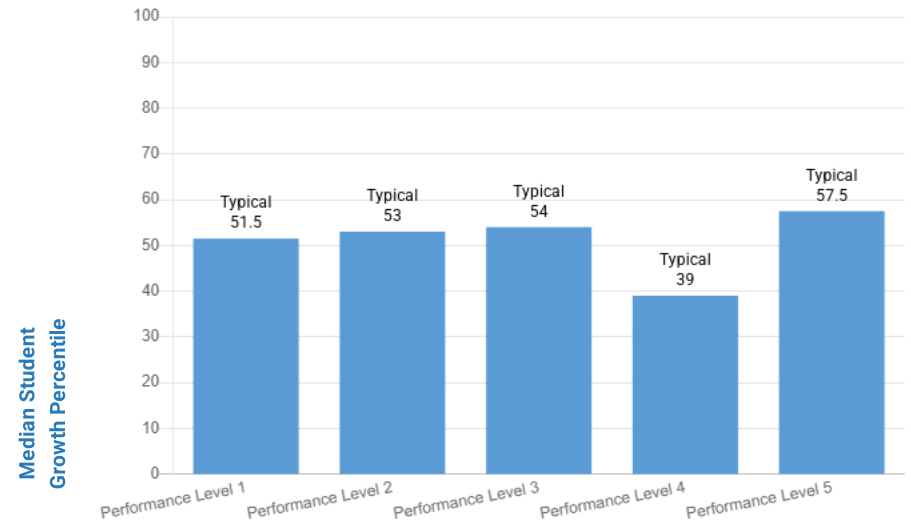

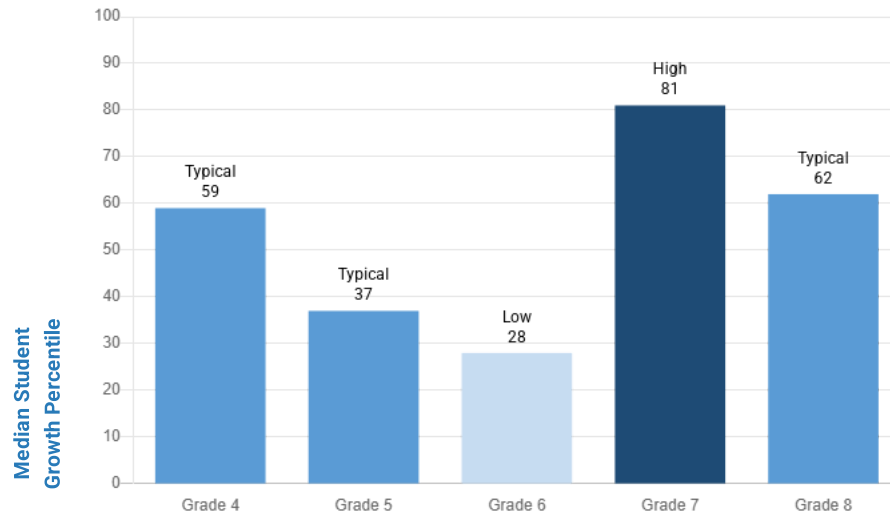

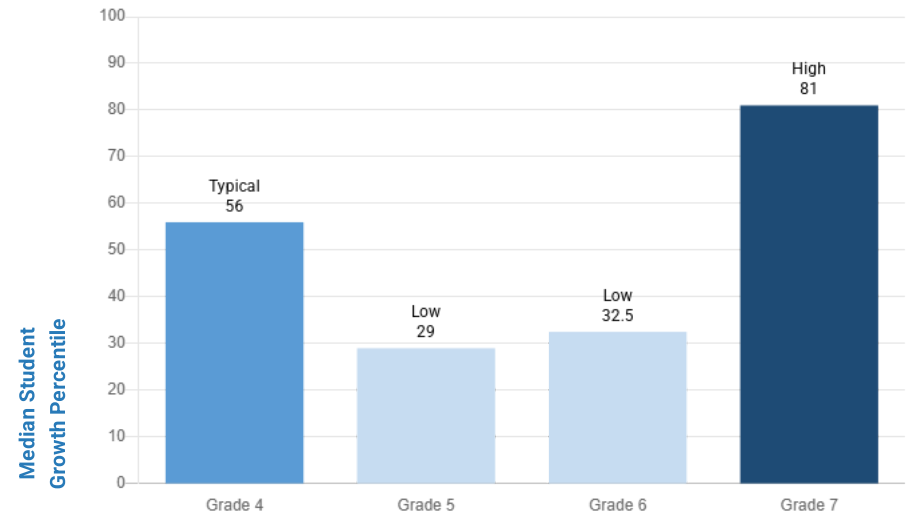

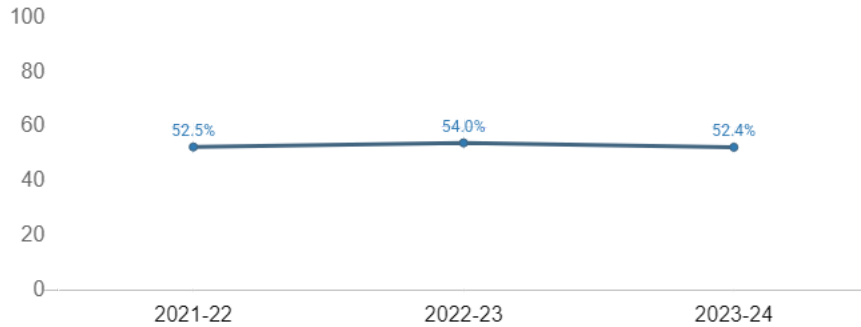

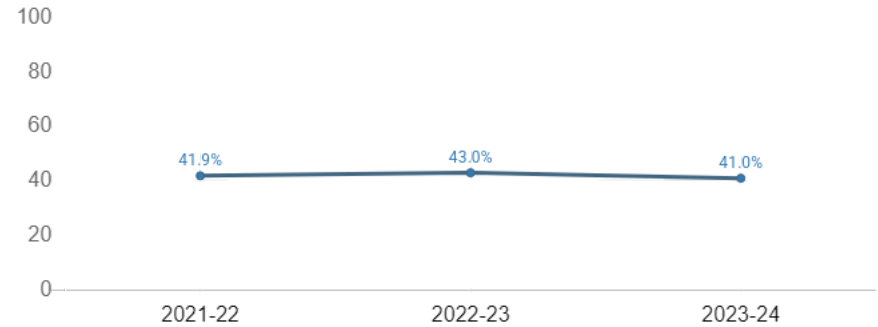
### English Language Arts and Mathematics Performance Trends

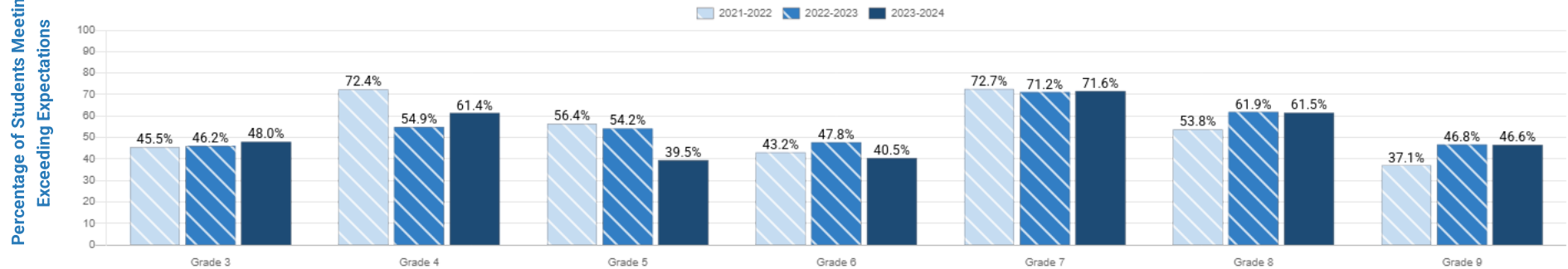

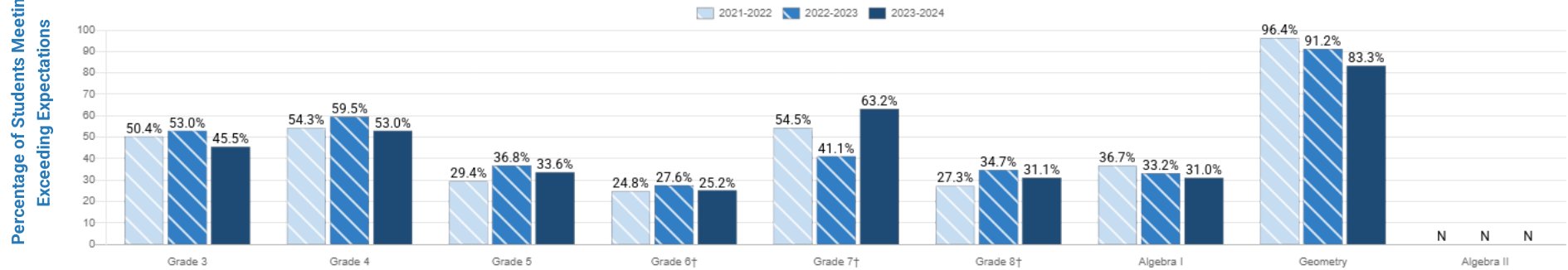

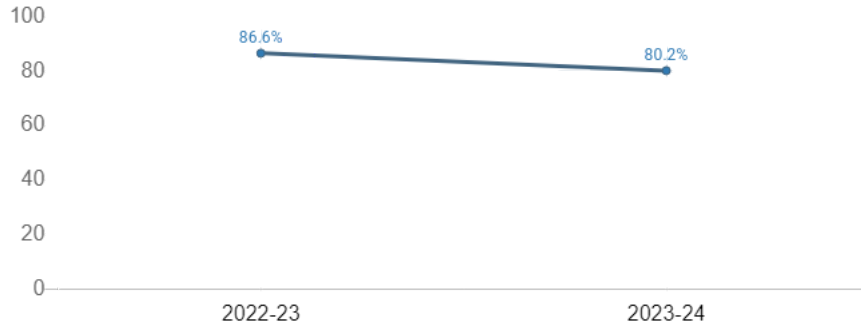

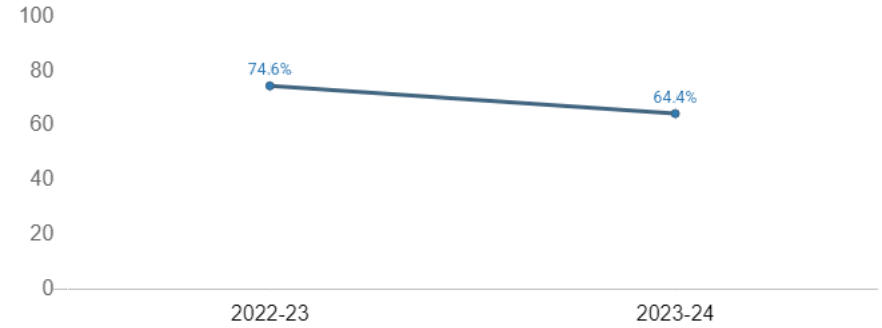

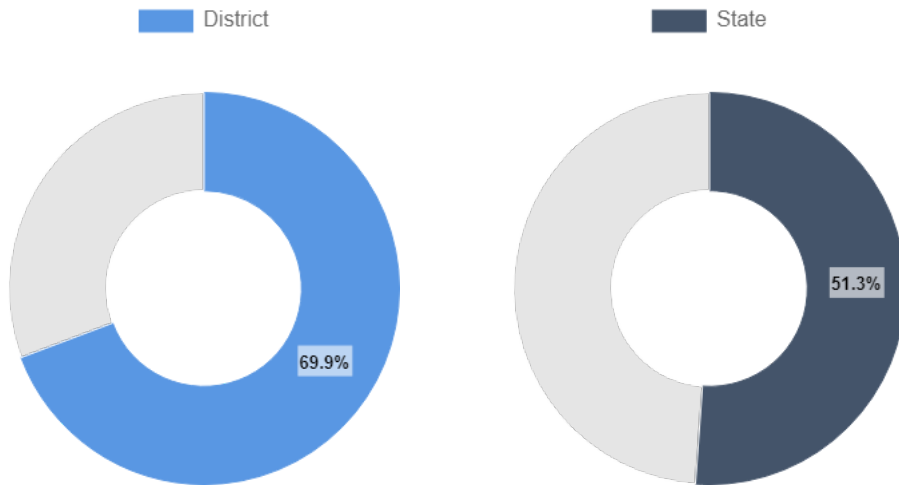

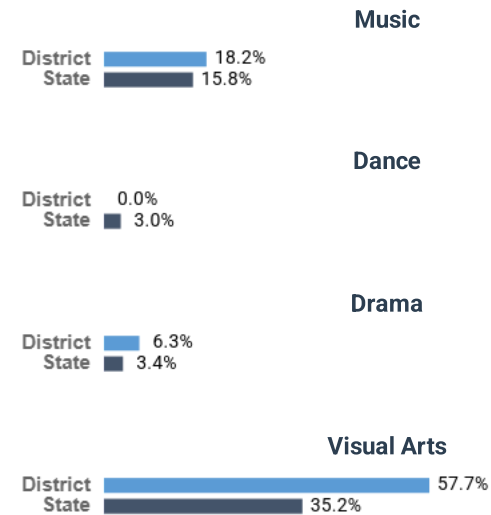

Graduation rates are calculated based on the adjusted cohort graduation rate calculation. Beginning in the 2020-2021 school year, the NJDOE was required to make changes to the methodology used to calculate the adjusted cohort graduation rate for federal reporting and accountability purposes. The United States Department of Education (USED) determined that the NJDOE must only include students who receive a diploma that is fully aligned with the state's standards, meaning they have met the state's graduation assessment requirements, course requirements, and local attendance requirements. This means that students with disabilities who did not meet some or all graduation requirements because of a modifications or exemption in their Individualized Education Program (IEP) may not be counted as graduates in the calculation of the adjusted cohort graduation rate used for federal reporting and accountability purposes. It is important to note that this was only a change to how graduation rates are calculated for federal reporting. It does not affect requirements to earn a diploma or the type of diploma that the state awards to students with disabilities.

As a result of these changes, the NJDOE began calculating two versions of the adjusted cohort graduation rate starting with 2021 graduation rates. The "federal version" aligns with ESSA requirements and USED guidance and is used for federal reporting and ESSA school accountability only. The "state version" continues to use the same methodology used prior to 2021 and reflects all students who received a state-endorsed diploma.

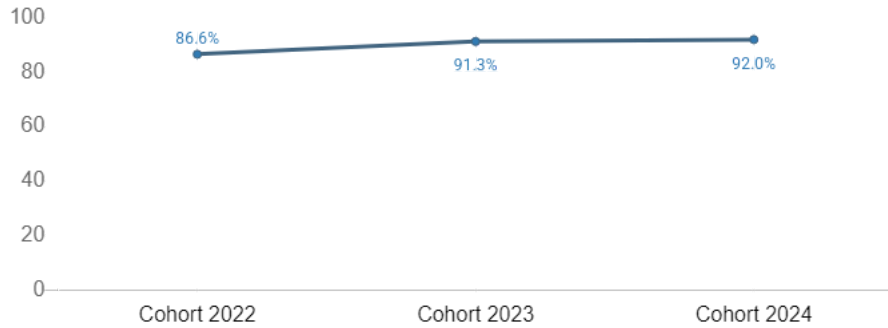

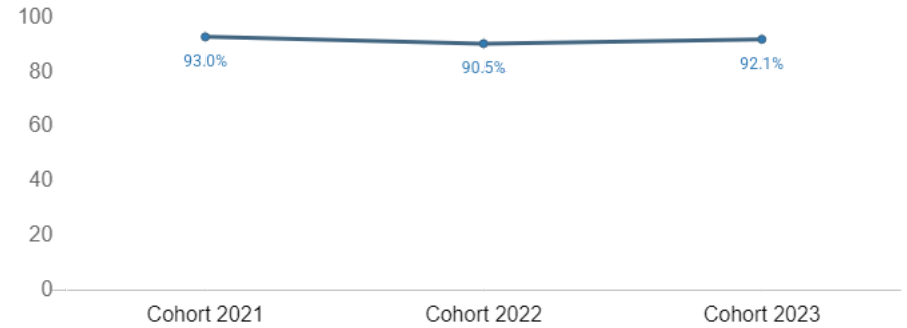

## Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

**Note for 2023-2024:** Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.

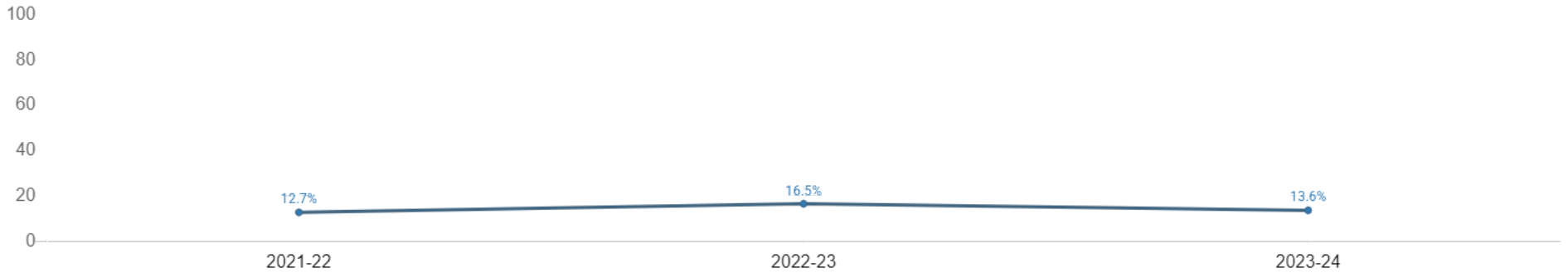

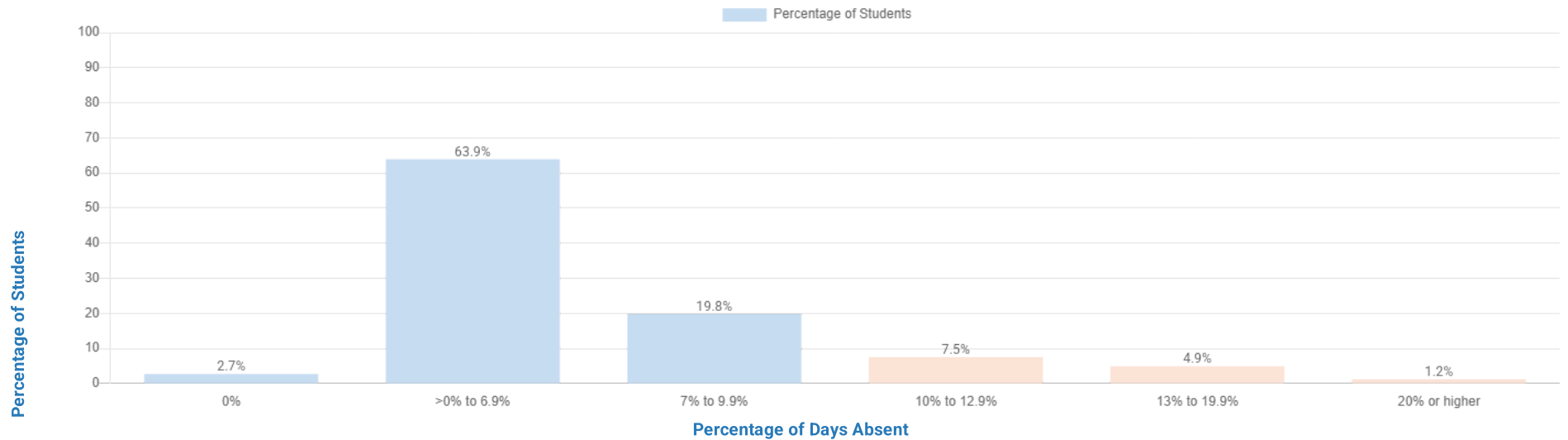

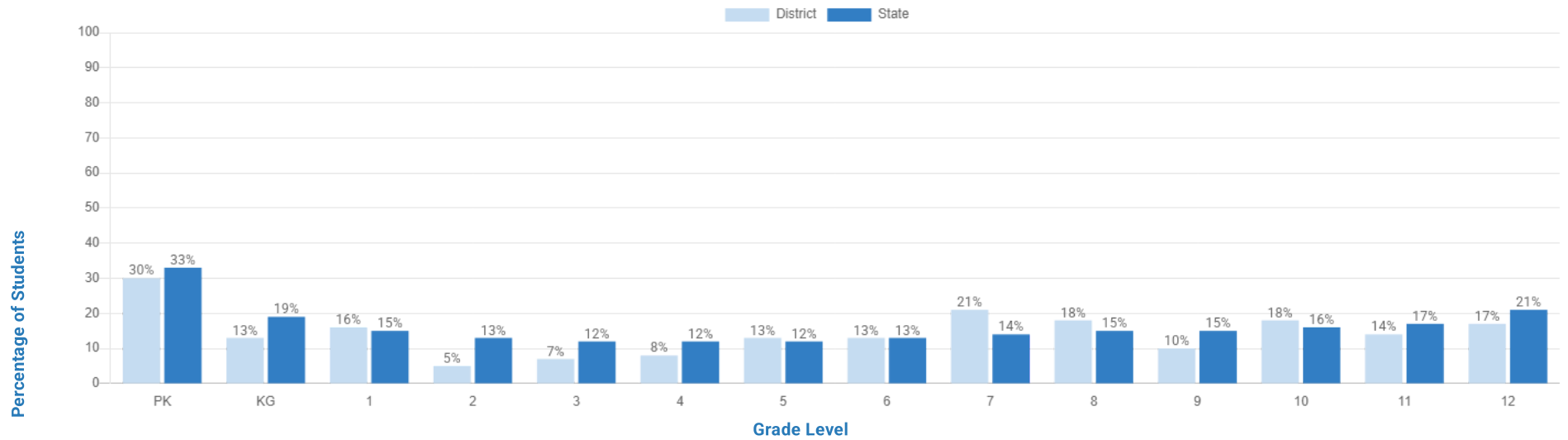

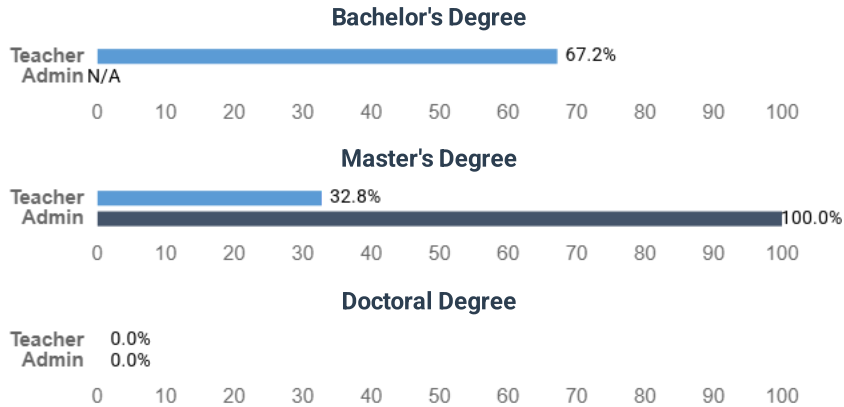

**New Jersey's Every Student Succeeds Act (ESSA) Accountability System** New Jersey's school accountability system identifies schools in need of comprehensive and targeted support as required by the Every Student Succeeds Act (ESSA). ### Mission, Vision, Theme:

Building on tradition and success, the mission of the Hackettstown Public School District is to educate and inspire students through school, family, and community partnerships so that all become positive, contributing members of a global society, with a life-long commitment to learning. It is the expectation of this school district that all pupils achieve the New Jersey State Learning Standards at all grade levels.



### Courses, Curriculum, Instruction:

The District continues to implement a comprehensive preK-12 curriculum across all subject areas, incorporating interdisciplinary connections alongside intervention and enrichment opportunities with the use of instructional technology. It offers a range of support services, including multi-tiered interventions, inclusive special education, a Multilingual Program (with bilingual, sheltered instruction, and newcomer structures), and Basic Skills Instruction. Enrichment includes a Gifted and Talented program (K-8), and Accelerated, Honors, and AP courses (7-12). In partnership with WCCC and Centenary University, students can access over 30 dual enrollment courses at little to no cost. STEM, Fine & Performing Arts, Social/Emotional learning, and World Languages/Culture are integrated into elementary courses, with interdisciplinary connections and elective options expanding at the secondary level to support holistic student development.

### Staff and Professional Learning:

The Hackettstown School District is committed to providing research-based, & impactful professional learning opportunities for all staff. The District organizes EdCamp professional learning days, during which teachers & administrators host sessions & choose the learning opportunities they wish to attend. These days emphasize collaborative experiences & collective learning tailored to the specific needs of educators. Sessions have a focus on social-emotional learning, student engagement, assessment strategies, & incorporating artificial intelligence (AI) in educational settings. Additionally, the district will be bringing in pedagogical experts & speakers to supplement the EdCamps in areas such as special education, teaching strategies, & MTSS. Staff are also learning how to effectively use AI tools in ways that enhance teaching & learning, as well as how to guide students in the ethical & responsible use of AI for academic purposes through mini-professional development sessions.



### Student Supports and Services:

Student support services are delivered through a variety of programs, including multi-tiered interventions, inclusive special education, multilingual education, and counseling, available before, during, and after the school day. Multi-tiered interventions tailor instruction to meet student needs, with increasing levels of intensity. The inclusive special education program integrates academic support with related in-house services such as Learning Consultants, Social Workers, Psychologists, and various therapists (Occupational, Physical, Speech), as well as a Behaviorist. All instructional staff are trained in Sheltered Instruction to enhance the multilingual program, which offers educational pathways for English language learners through bilingual, ESL, and Newcomer courses. The counseling program fosters character development and social-emotional learning through individual, small group, and whole group sessions, collaborating with Effective School Solutions for additional support.



### Student Health and Wellness:

The District prioritizes Student Health and Wellness by collaborating with both in-District resources (Nursing, Counseling, Related Services, Title I, and ML programs) and external partners (ESS, NJCAP, local churches, police and fire departments, and food pantries) to address foundational needs like safety, security, and physiological health. Character, social, and emotional development are embedded across all curricula, working closely with the Counseling program. In partnership with School Nursing and Counseling, nutritional guidance is integrated into food services and the Comprehensive Health and Physical Education curriculum. The District ensures students participate in daily physical activity through courses, recess, and movement "brain breaks." Additionally, K-4 schools continue to enhance their outdoor playgrounds and created an indoor sensory hallway to support wellness.

## Parent and Community Involvement:

The District promotes strong parent, guardian, and community engagement while enhancing communication between instructional staff and families. Committees such as CR, PD, CEP, and Behavior Threat Analysis include parent/guardian and community members, and forums on Curriculum, Technology, ESS, SE, Title I, and ESL meet regularly. A Districtwide PTO and secondary-level Booster Clubs further support co-curricular activities. The District partners with local government, including the Mayor, Town Council, Police, Fire Department, and BID, as well as WCCC and Centenary University for events like CTE programs, Dual Enrollment, and honors recognitions. Communication with multilingual families is improved through the Indus Translation Service, and District and school websites, along with social media, are regularly updated. Parents/guardians can also monitor student progress via Google Guardian and the Realtime Parent Portal, ensuring open communication channels remain strong.
