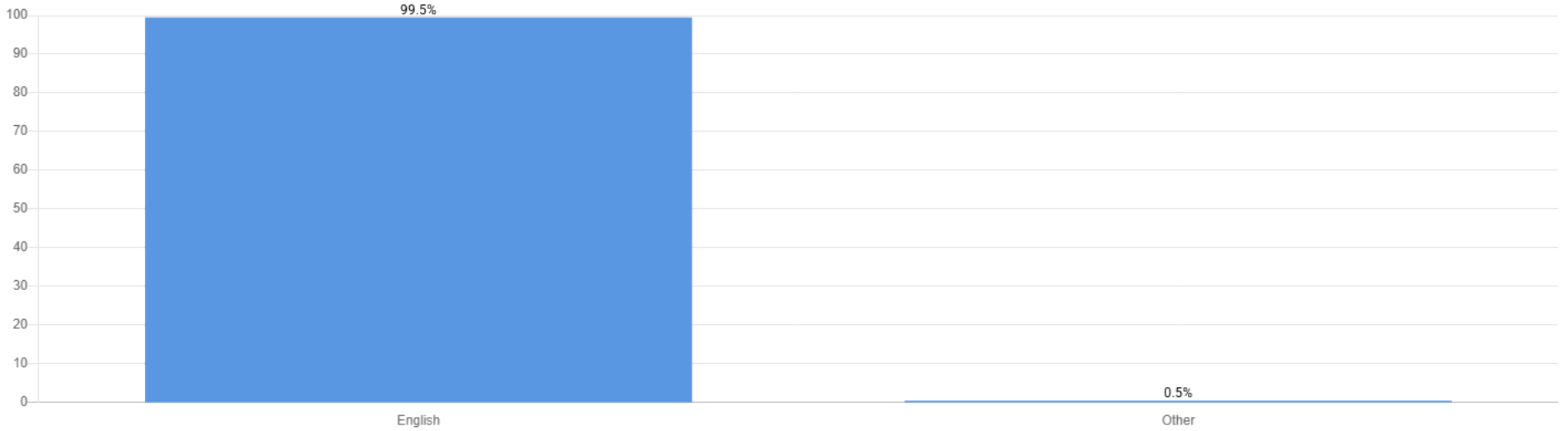

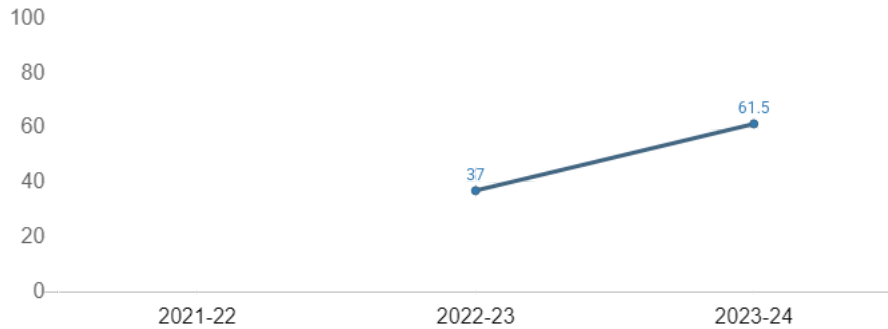

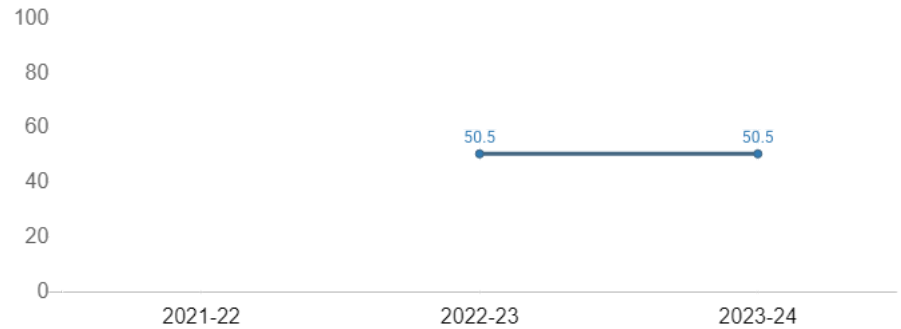

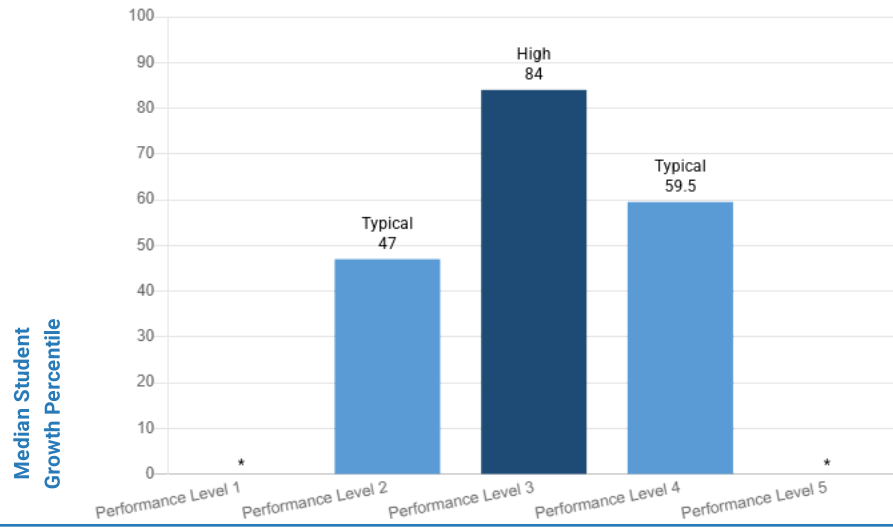

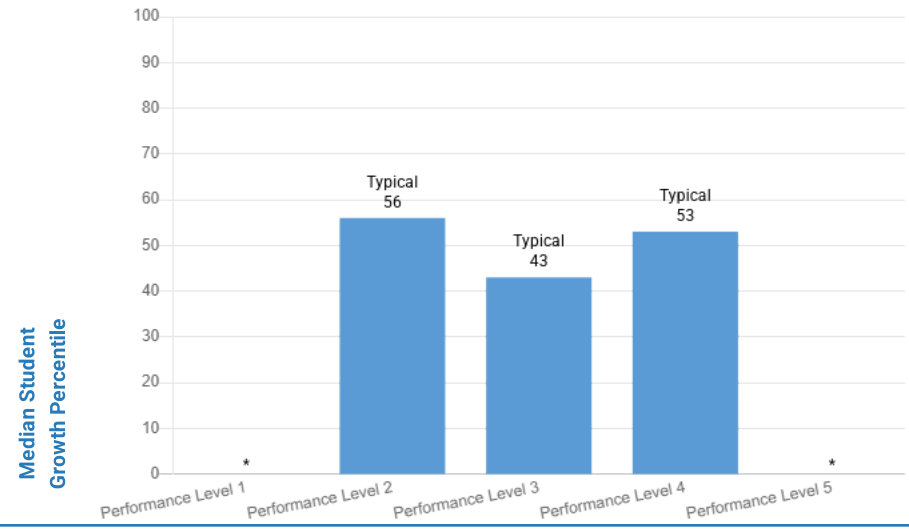

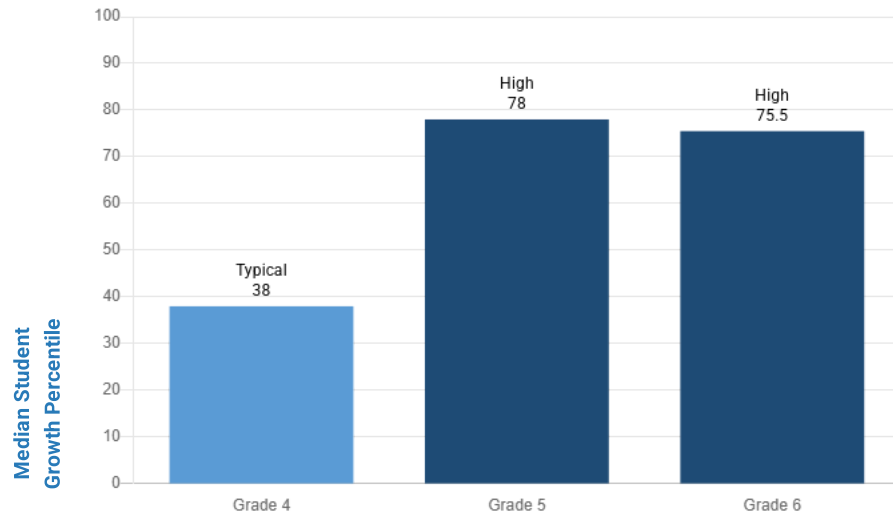

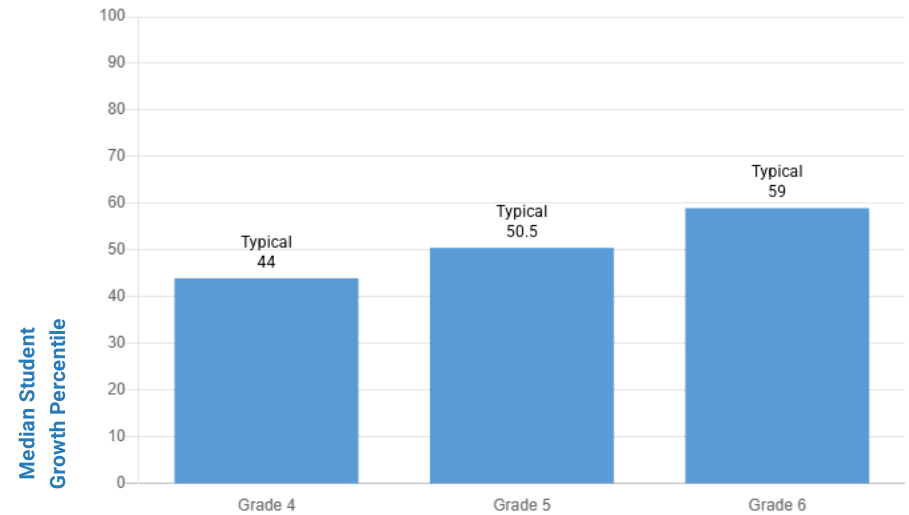

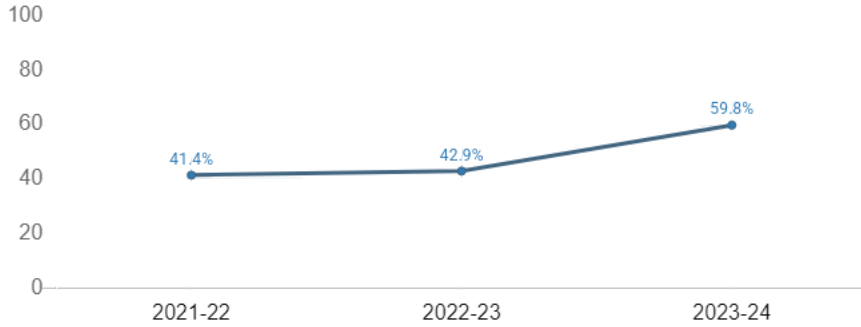

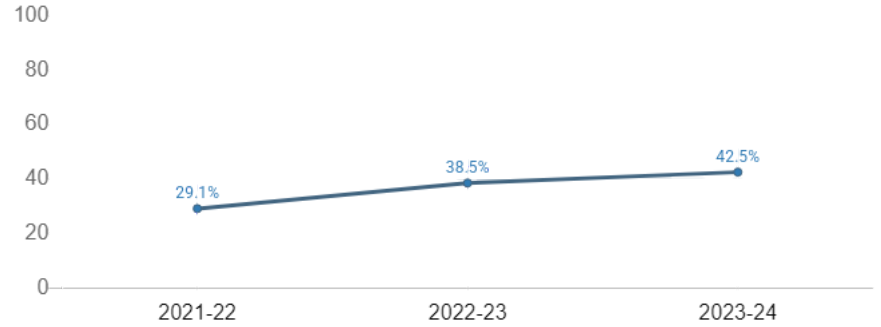
### English Language Arts and Mathematics Performance Trends

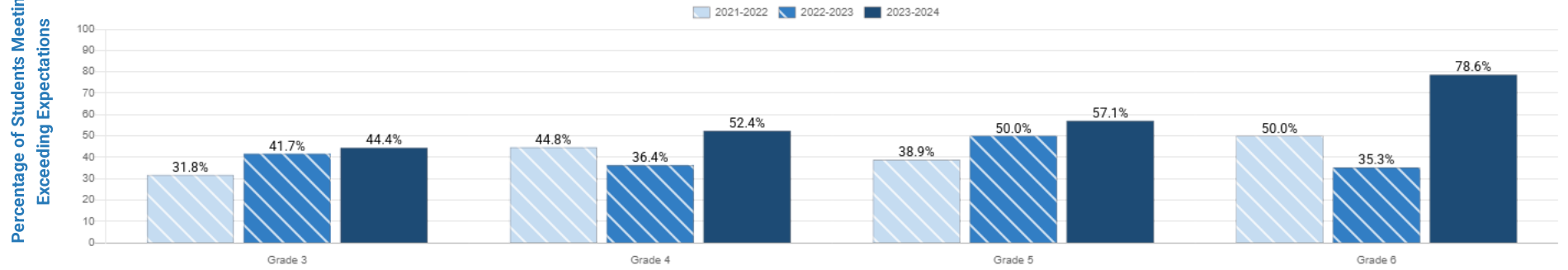

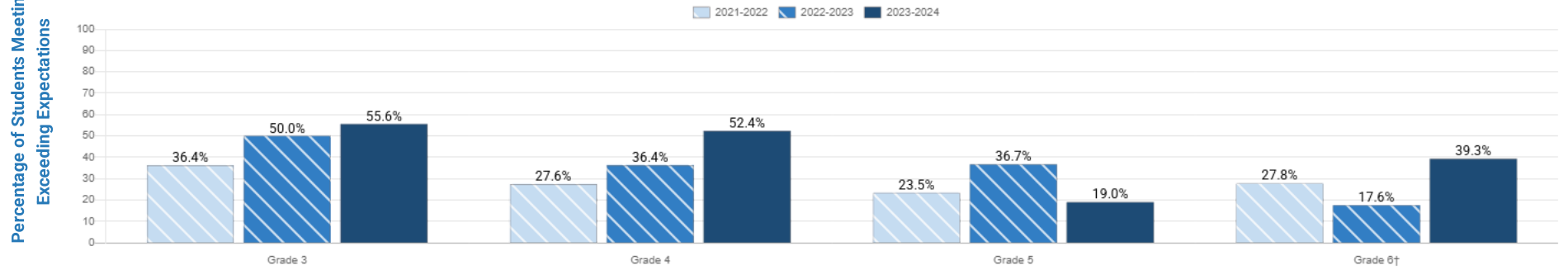

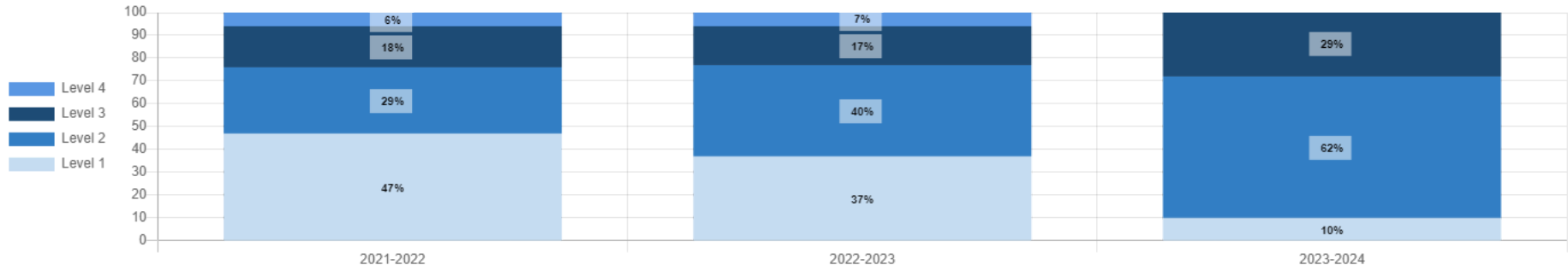

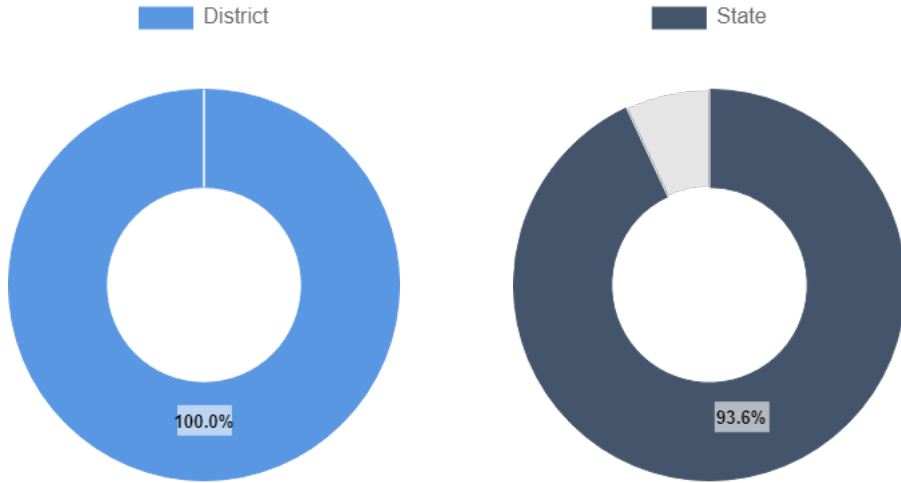

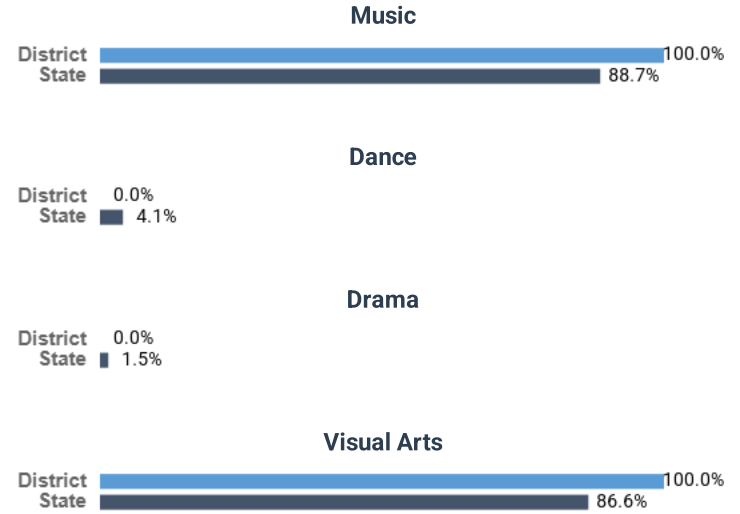

**Students enrolled in one or more classes by discipline:**



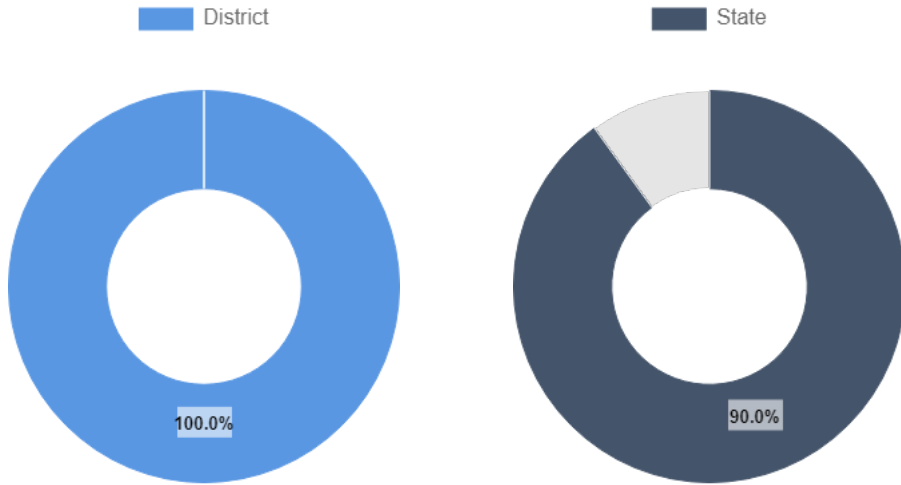

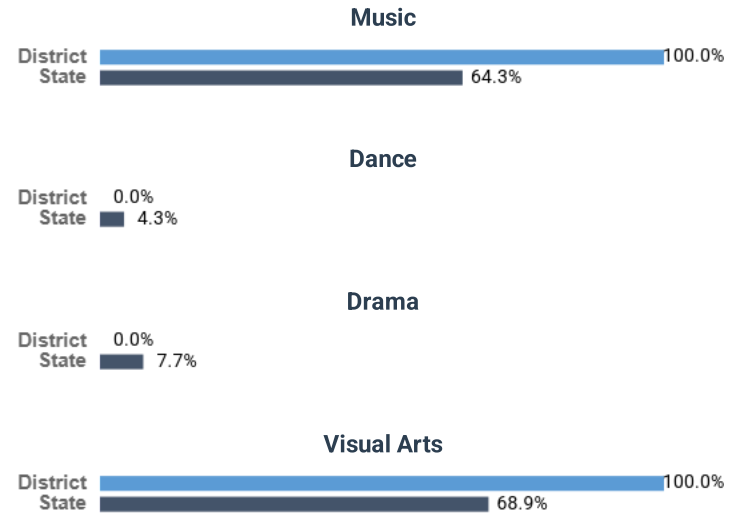

**Students enrolled in one or more classes by discipline:**

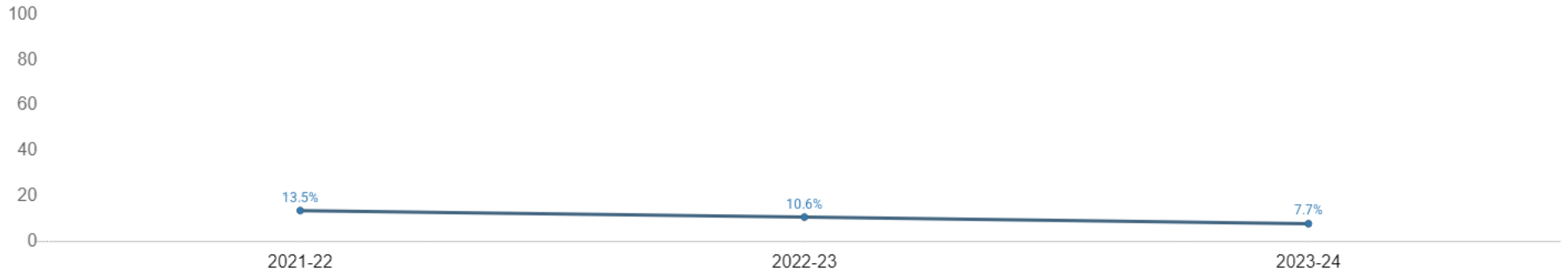

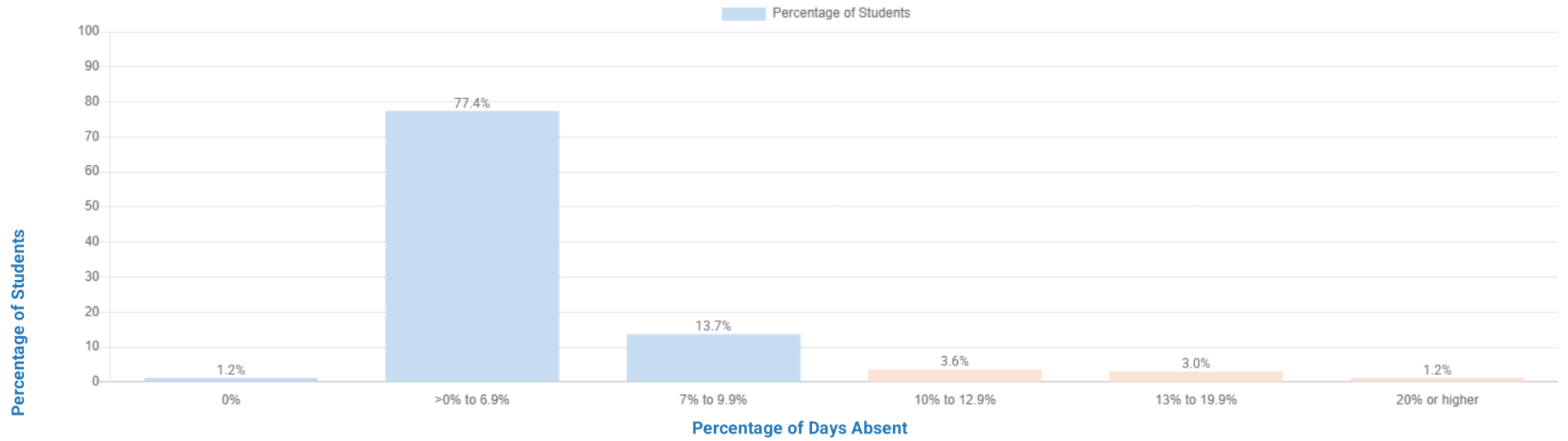

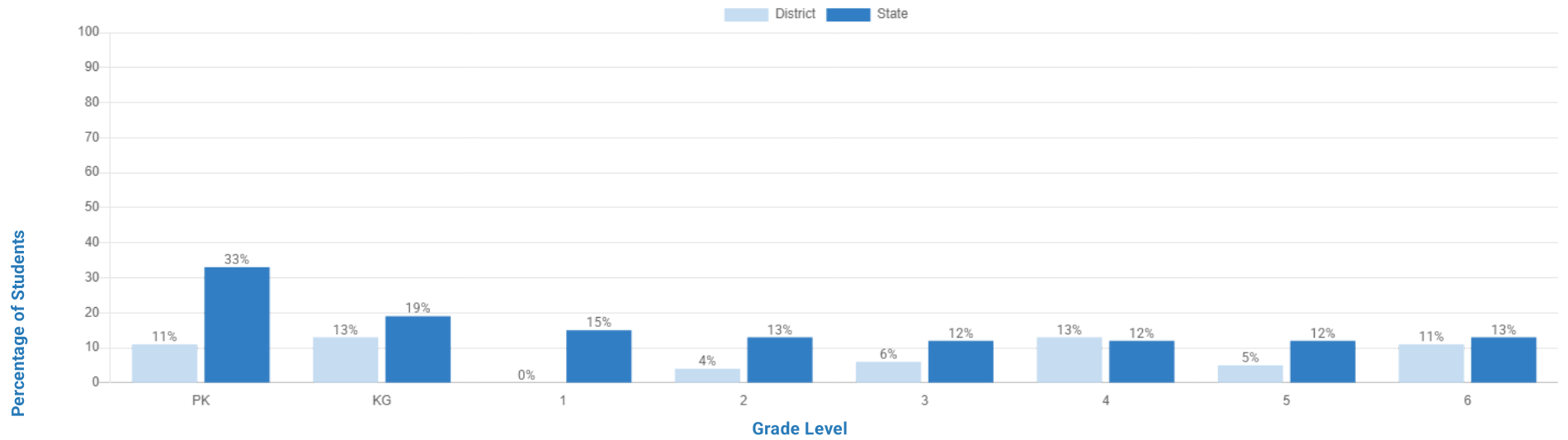

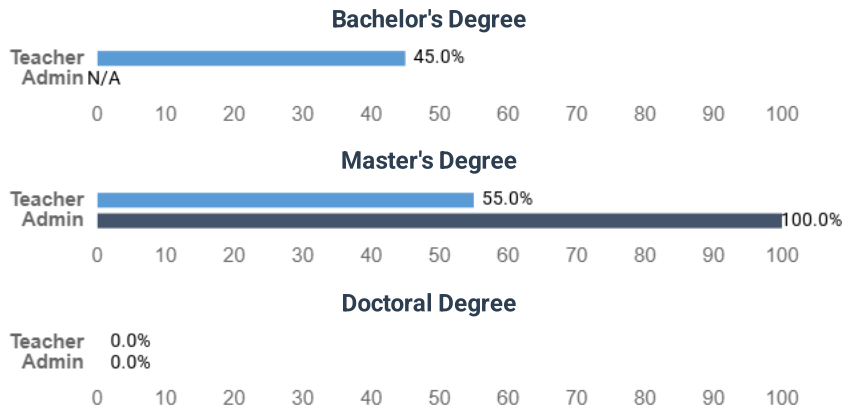

- Technology is intertwined into each day of student learning. Our students have access to 1:1 technology for use in the classroom. Grades PK-1 utilize iPads and Grades 2-6 utilize Chromebooks.
- We continue to participate in the SJFS program and hold bronze certification active through 2026. We received a \$10,000 grant in 2023-2024 for a project titled "Sustainability Through the Seasons."
- In 2023-2024 we partnered with outside resources to bring in educational programming to enhance student learning. These organizations are located in our county and surrounding area.



### Mission, Vision, Theme:

We are committed to provide an engaging, comprehensive education aligned with the New Jersey Student Learning Standards in a healthy, safe and nurturing environment in which all students are encouraged to be critical thinkers and self-advocates. Instilling a passion for learning will inspire and guide students to become responsible and compassionate citizens in a constantly changing world. Students have the opportunity to achieve their maximum academic potential both here and in their future education while developing confidence, competence and character.



### Awards, Recognition, Accomplishments:

At KTES, we believe in recognizing our students and staff for their accomplishments. For the 23-24 school year, we continued with our On Track citizenship program. This program highlighted two students per month with Knowlton Knight awards based on displays of good character and citizenship. Students are consistently recognized through contests, community service and competition placements. Our district also participates in the Governor's Educator of the Year program to recognize staff. Teachers are also invited to present at Board of Education meetings so that all the great teaching they are doing can be showcased. Grant recipients are also recognized publicly.

### Student Supports and Services:

Supplemental instruction in reading and mathematics in grades 1-3 is provided by one of our RTI teachers. This program is designed for students who need individual/small group instruction with extra reinforcement. The instructors provide direct instruction through either a push in or replacement program depending on need. Struggling learners in grades 4-6 are provided with interventions at increasing levels of intensity to accelerate their rate of learning through our RTI program. Small group or individual instruction is offered to classified students in the areas in which they experience difficulty. Students identified for this service are given support by our resource center teacher in the resource center classroom with a replacement program. Our school counselor and school psychologist have both individual and groups sessions planned with students.



### Student Health and Wellness:

Promoting the health and wellness of students is a priority at our school. During the course of the day, students participate in physical education, health education, movement activities and brain breaks. We offer a breakfast program to students as well as a Physical Fitness Club and Amped, a before-school running/walking club. We participate in Sustainable Jersey for Schools and were awarded a grant. Our school garden provides opportunities for both physical activity and learning about nutrition and sustainable living.



### Parent and Community Involvement:

We encourage parents to take an active interest in their child's education here at school. Parents are encouraged to join the PTA or become a school wide volunteer. Opportunities are created for parents and community to get involved in school projects and events throughout the year. Our parent community volunteered their time to assist with book fairs, school pictures, planting and garden maintenance and serving on various committees.

For 23-24, we offered one session of a high quality, comprehensive and fun filled preschool program which was attended by 18 students. The program was taught by a dual certified Early Childhood/Special Education Teacher.
