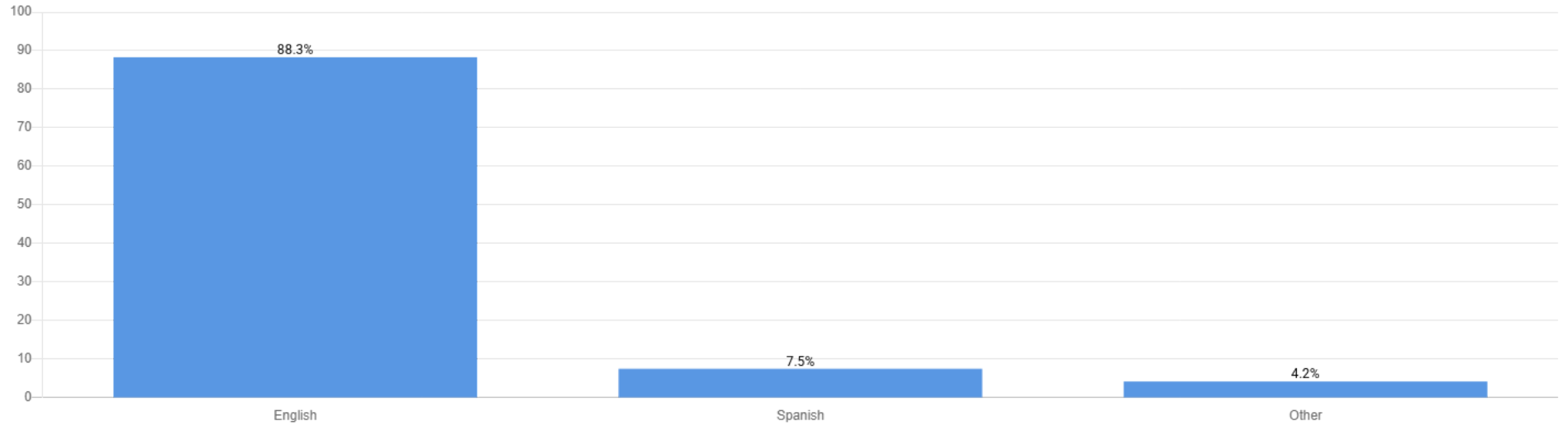

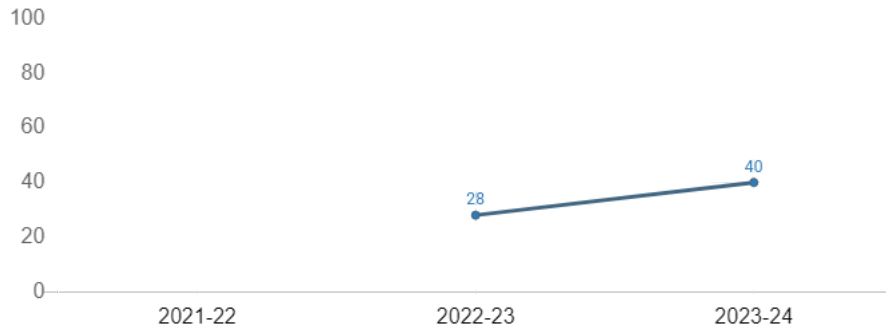

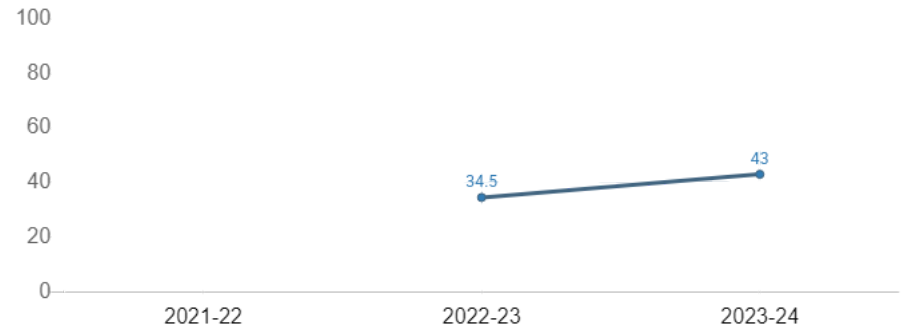

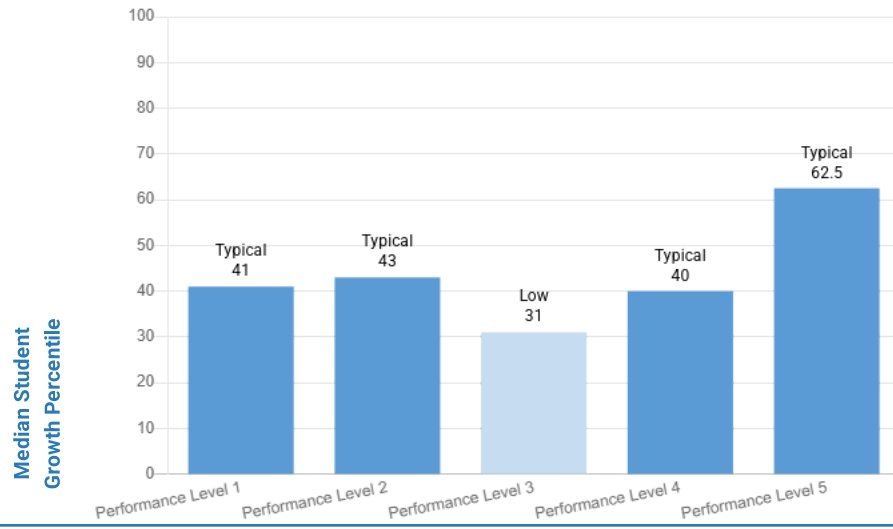

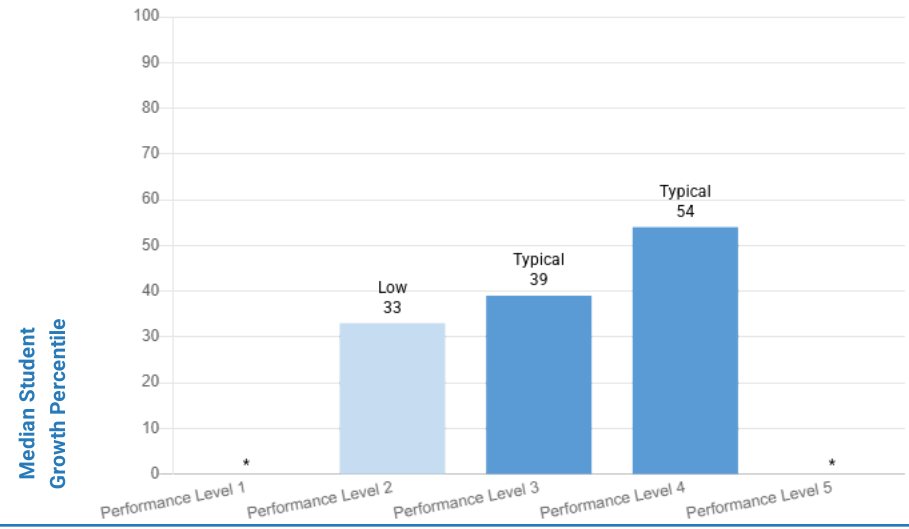

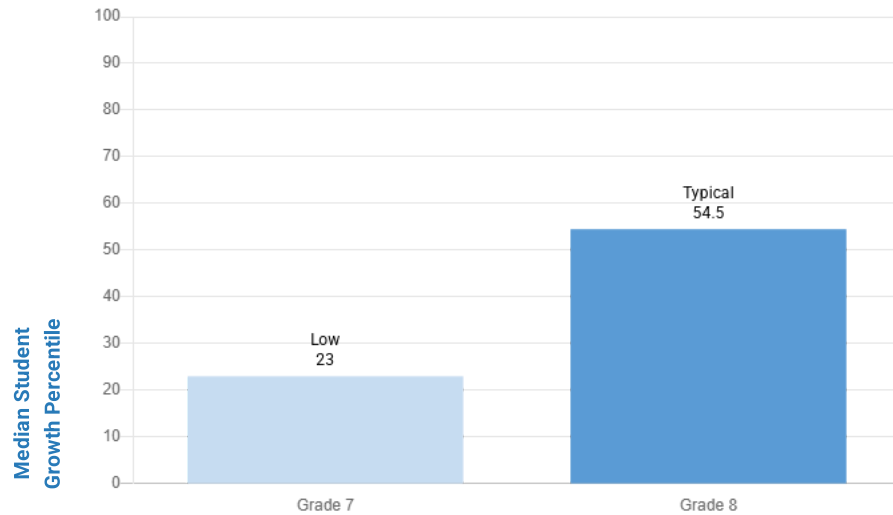

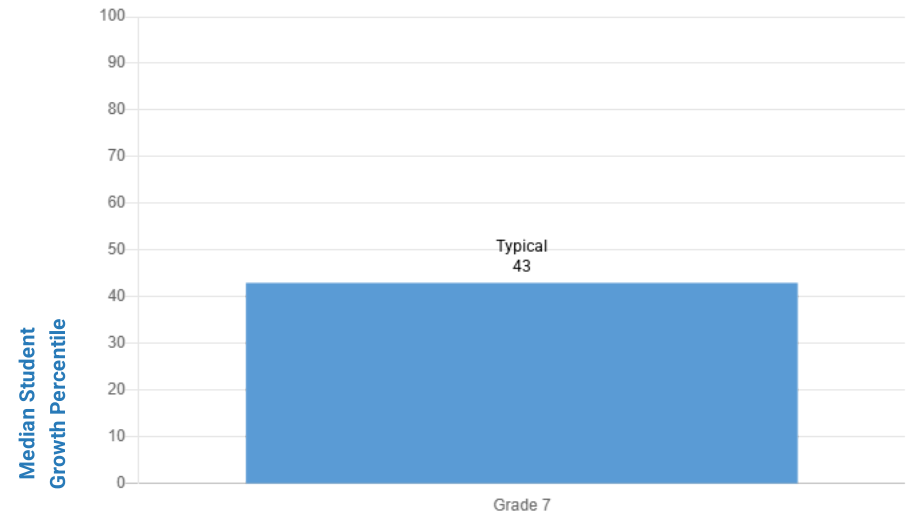

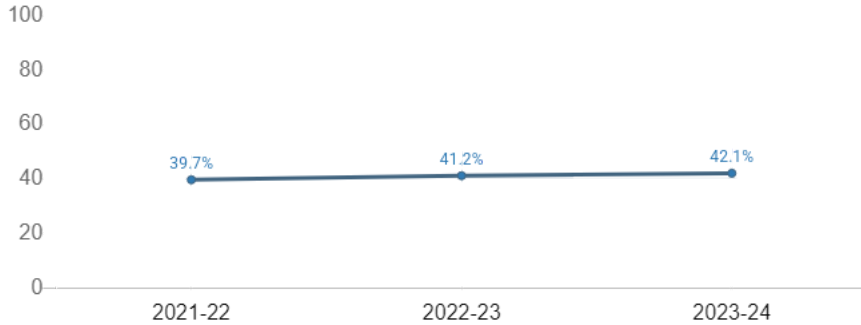

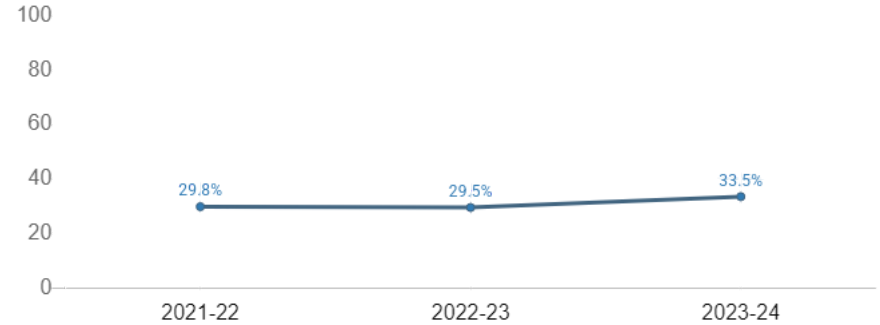
### English Language Arts and Mathematics Performance Trends

### English Language Arts Assessment - Participation and Performance

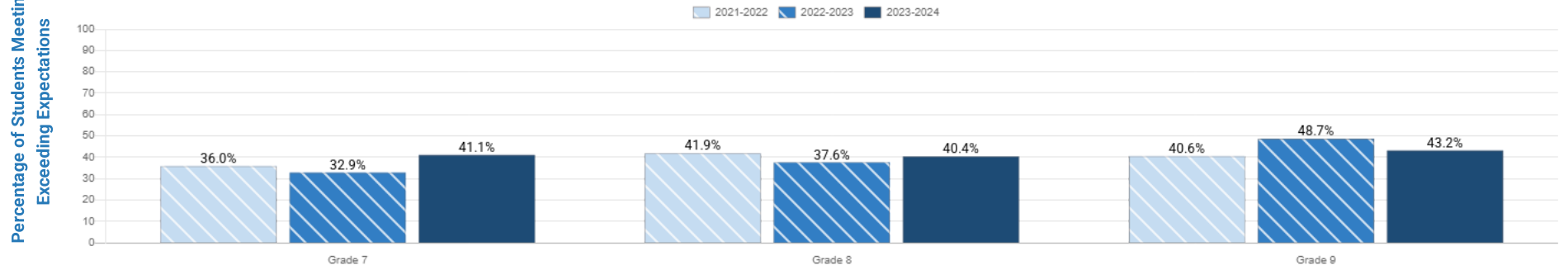

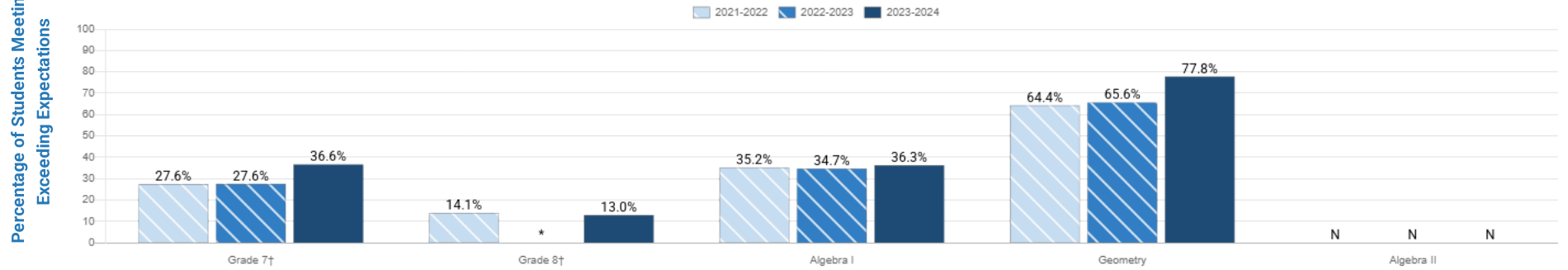

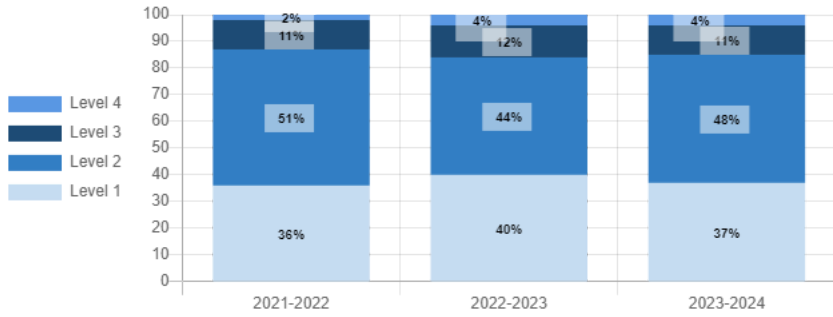

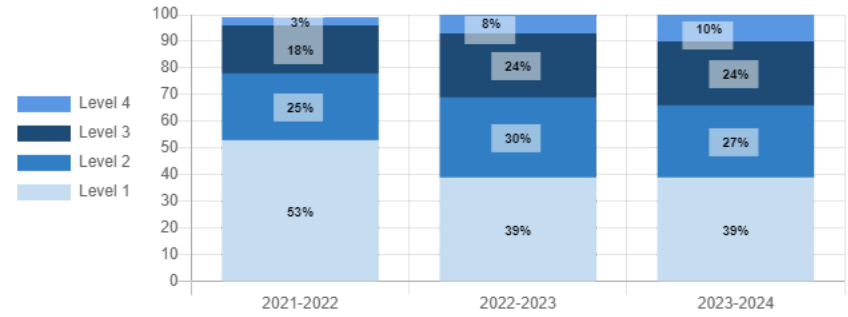
**NJSLA Science Assessment: Grade 8 Summary**

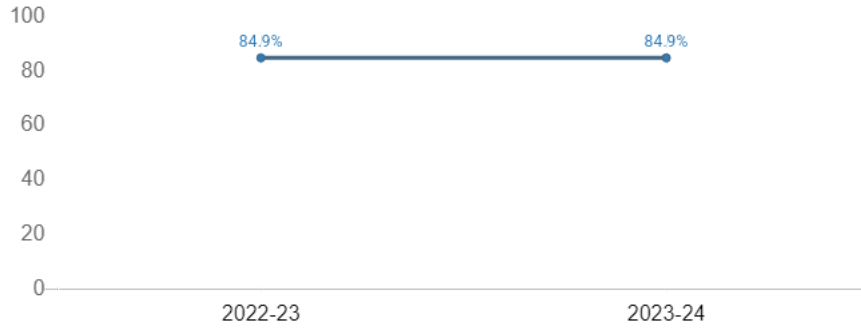

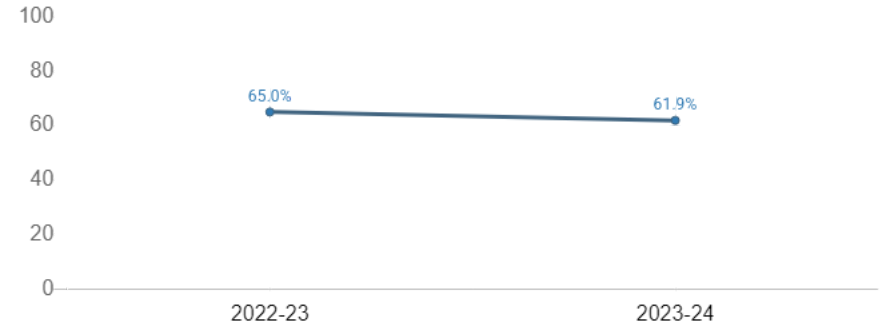

#### Students taking one or more AP or IB exam

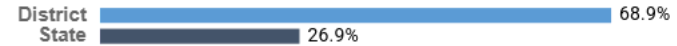


#### Students with one or more exams with a score of at least 3 on AP exams or 4 on IB exam

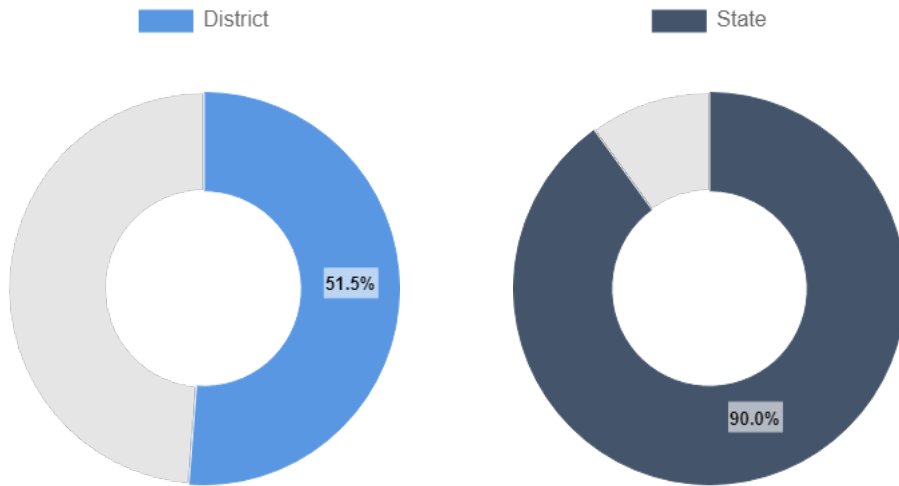

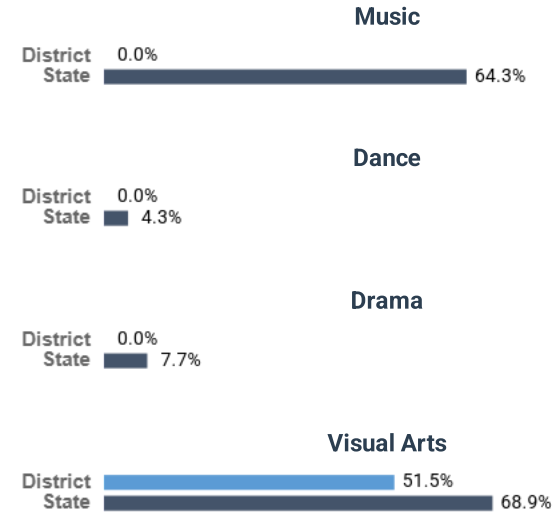

**Students enrolled in one or more classes by discipline:**



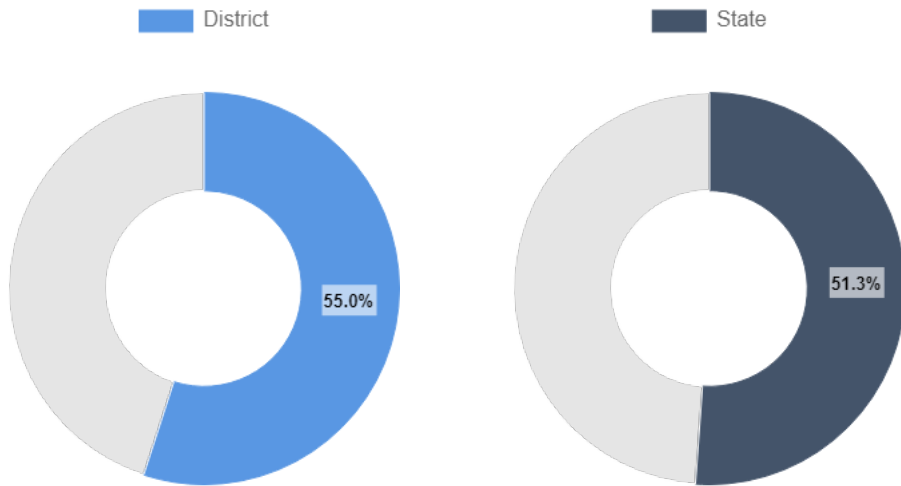

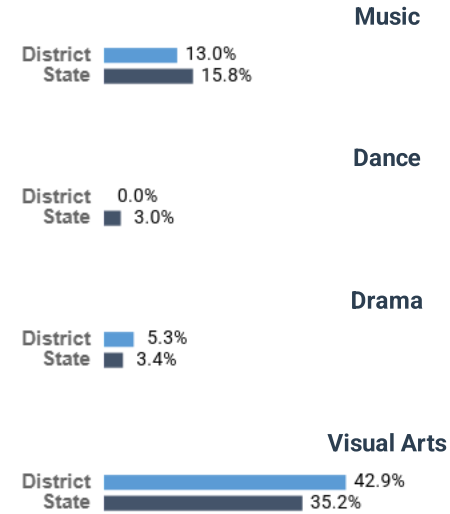

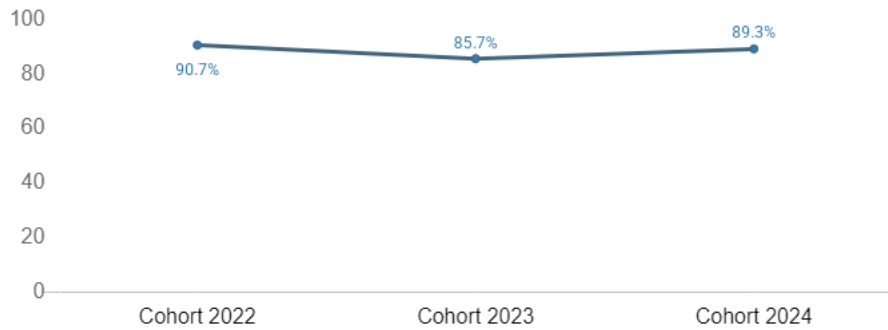

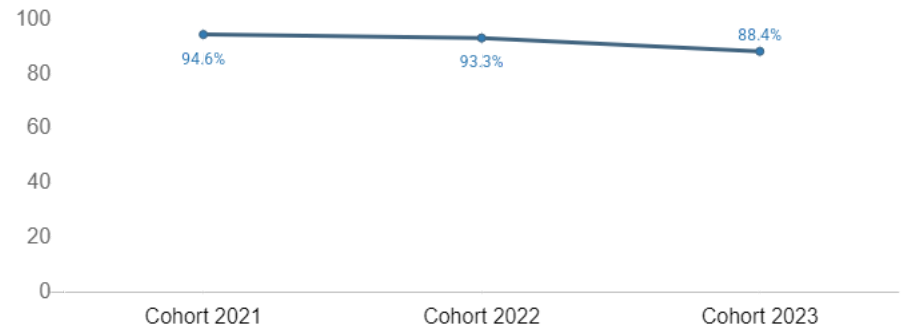

## Graduation/ Postsecondary

Graduation rates are calculated based on the adjusted cohort graduation rate calculation. Beginning in the 2020-2021 school year, the NJDOE was required to make changes to the methodology used to calculate the adjusted cohort graduation rate for federal reporting and accountability purposes. The United States Department of Education (USED) determined that the NJDOE must only include students who receive a diploma that is fully aligned with the state's standards, meaning they have met the state's graduation assessment requirements, course requirements, and local attendance requirements. This means that students with disabilities who did not meet some or all graduation requirements because of a modifications or exemption in their Individualized Education Program (IEP) may not be counted as graduates in the calculation of the adjusted cohort graduation rate used for federal reporting and accountability purposes. It is important to note that this was only a change to how graduation rates are calculated for federal reporting. It does not affect requirements to earn a diploma or the type of diploma that the state awards to students with disabilities.

As a result of these changes, the NJDOE began calculating two versions of the adjusted cohort graduation rate starting with 2021 graduation rates. The "federal version" aligns with ESSA requirements and USED guidance and is used for federal reporting and ESSA school accountability only. The "state version" continues to use the same methodology used prior to 2021 and reflects all students who received a state-endorsed diploma.

To be included as a graduate in the federal version of the graduation rate, students must have meet state course requirements and local attendance requirements for graduation. Additionally, students must meet the graduation assessment requirements in place based on the year they are graduating, regardless of their graduation cohort. The graduation assessment requirements for the classes of 2022 through 2024 have differed as a result of executive orders in response to the pandemic and new legislation. As a result, the calculation of the federal version of the graduation rate has also changed.

In this section of the reports, the Graduation Rate Trends and Progress charts and Graduation Cohort Profiles (4-Year, 5-Year, and 6-Year), as well as the graduation rates reported in the Summary Reports, reflect the "state version" of the graduation rate. ## Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

**Note for 2023-2024:** Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.

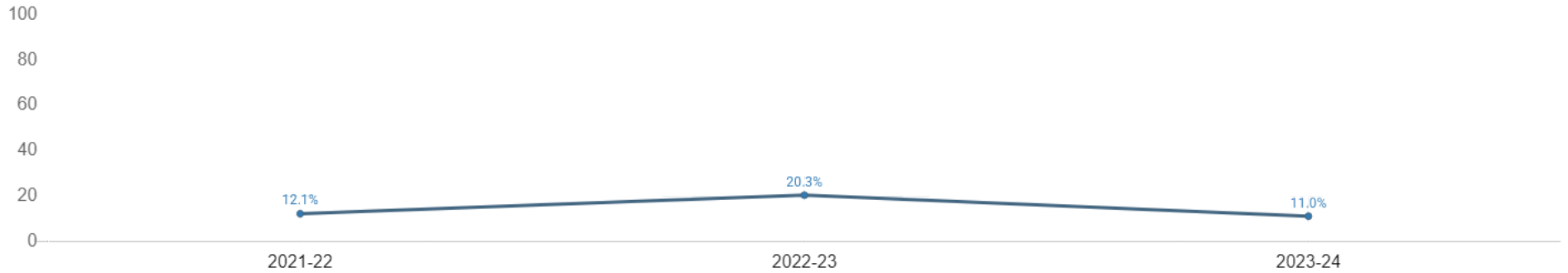

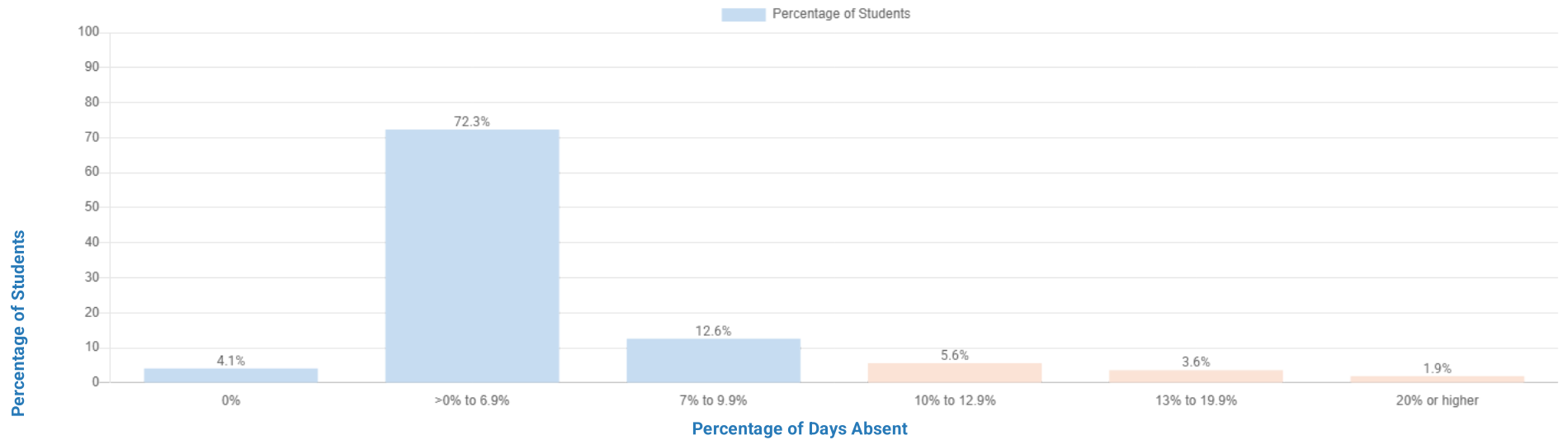

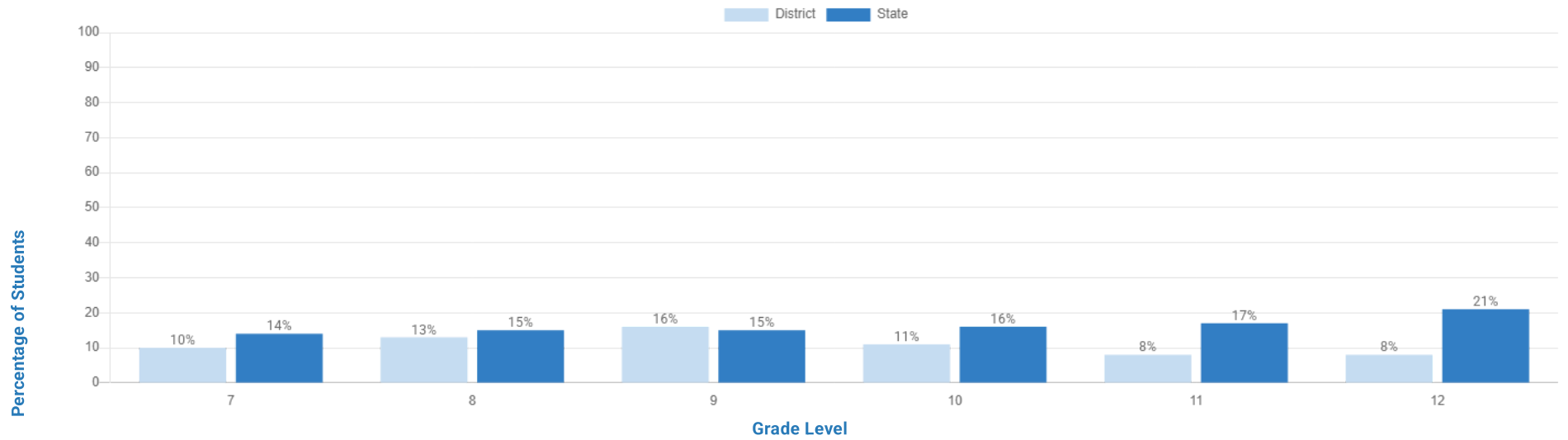

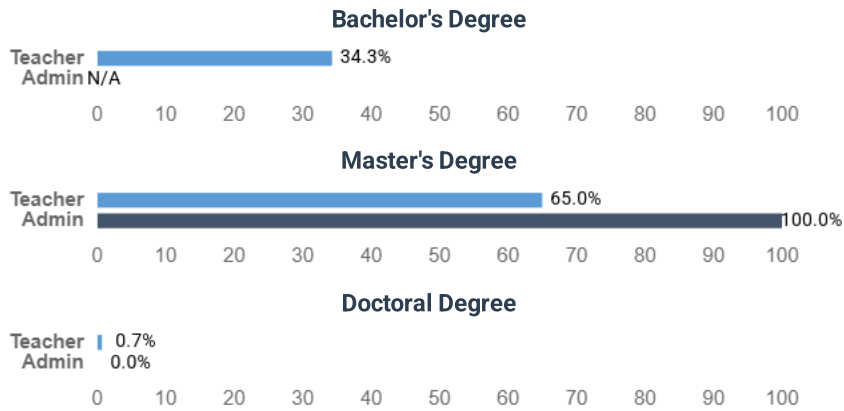

**New Jersey's Every Student Succeeds Act (ESSA) Accountability System** New Jersey's school accountability system identifies schools in need of comprehensive and targeted support as required by the Every Student Succeeds Act (ESSA). Based on New Jersey's [approved ESSA state plan](#), NJDOE will identify schools in the following four federal categories every three years:

- **Comprehensive Support and Improvement (CSI): Overall Low Performing:**
  - Title I schools with a summative score in the bottom 5% of Title I schools.
- **Comprehensive Support and Improvement (CSI): Low Graduation Rate:**
  - All high schools with a four-year graduation rate of 67% or less
- **Additional Targeted Support and Improvement: Low Performing Student Group (ATSI):**

### Courses, Curriculum, Instruction:

We offer a full range of educational services and courses to meet the needs of our students. The Middle School offers several exploratory programs in STEM, music, world languages, and arts, along with core academic classes. The High School's programs are rich with Honors, Advanced Placement, and Dual Enrollment courses, along with several career pathways. Our pathways programs have been expanded to better support our students for life beyond Warren Hills. We offer a Concurrent Enrollment program in collaboration with Centenary University, Rutgers University, Delaware Valley College and Dual Enrollment with Warren County Community College. We utilize the Accredited CASE program through Rutgers University to support and advance our Agriculture program. Our courses and curriculum are continually reviewed and revised in order to enable students to teach their fullest potential and to ensure that they are prepared for college or career after graduation.



### Sports and Athletics:

Warren Hills offers a comprehensive sports program, competing in the Skyland Conference against teams in Warren, Hunterdon, Somerset and Sussex Counties. We operate under the supervision of the New Jersey State Interscholastic Athletic Association (NJSIAA), competing in North II, Group III for most athletic competitions. We offer 24 varsity and sub-varsity athletic teams.



### Clubs and Activities:

We offer a total of 37 clubs and activities to enrich our student's lives at both the Middle School and the High School. Our clubs are annually recognized at the state and national level. Our clubs and activities range from agriculture to computer science to the environmental rights club.

### Before and After School Programs:

School-Based is an independent organization that operates within both school buildings, offering services before and after school. This program provides opportunities for students to complete homework, get assistance, and spend time with friends who are also in the School-Based program. Our High School offers an AM Resource time to provide students with additional opportunities to receive academic support. The Middle School has revised their bel schedule to include the What I Need (WIN) period at the end of the day. The WIN period includes our MTSS program as well as peer tutoring and academic support to enhance student achievement and growth. Also, MS students can take advantage of our Homework Club that meets after school for additional academic support.



### Staff and Professional Learning:

Through Professional Learning Communities (PLC's), our staff collaborate, communicate, analyze student data, and make decisions on best practices. A wide variety of professional development is offered throughout the year, and staff are afforded the opportunity to choose the direction of their professional growth. We offer in-district and out-of-district professional development opportunities for faculty and staff. Most recently, in an effort to focus on Social Emotional Learning for students, staff and the community, the district has established a Mental Health Team to provide programs and resources to better support our community. Also, our district is partnering with SEL4NJ and St. Elizabeth's University on a Culture and Climate Improvement Initiative. Recent professional development offerings included Differentiation of Instruction, Effective Instructional Strategies in Mathematics, use of flat panel monitors and AI in classroom instruction.



### Postsecondary Information:

Each year, approximately 85% of our graduates go on to pursue college degrees, with many gaining acceptance into some of the most prestigious and competitive institutions. In addition to those who choose four-year colleges, many graduates opt for smaller colleges, community colleges, technical schools, apprenticeships, or military service. Notably, graduates from our business program are highly sought after by local and regional employers, reflecting the strong demand for their skills in the workforce.
