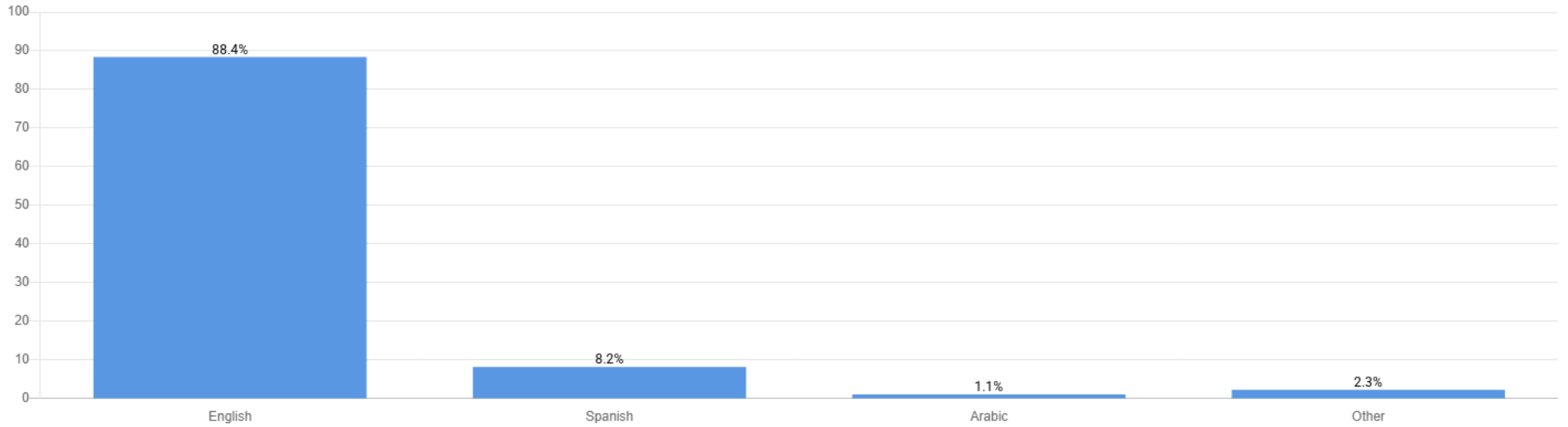

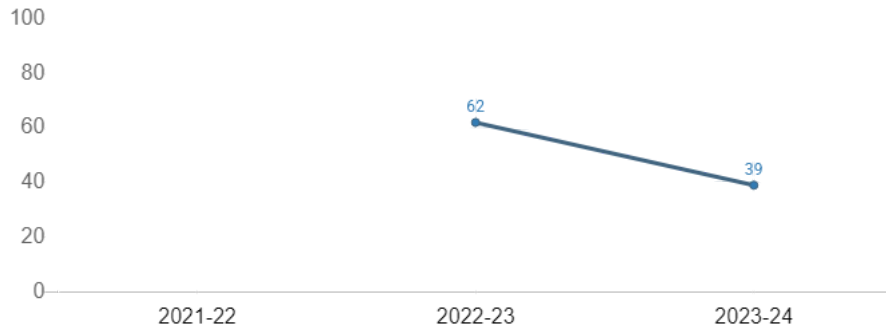

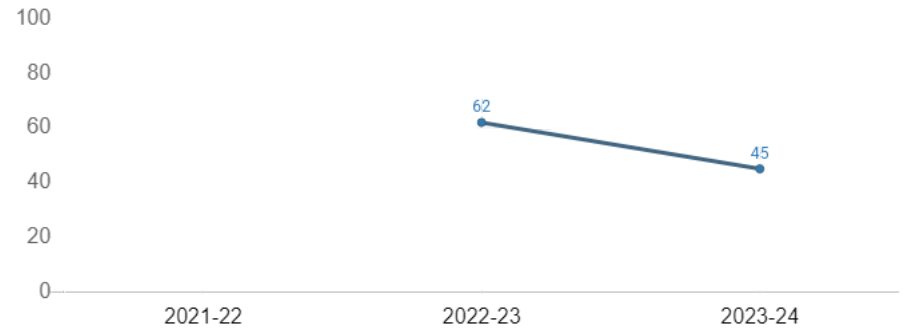

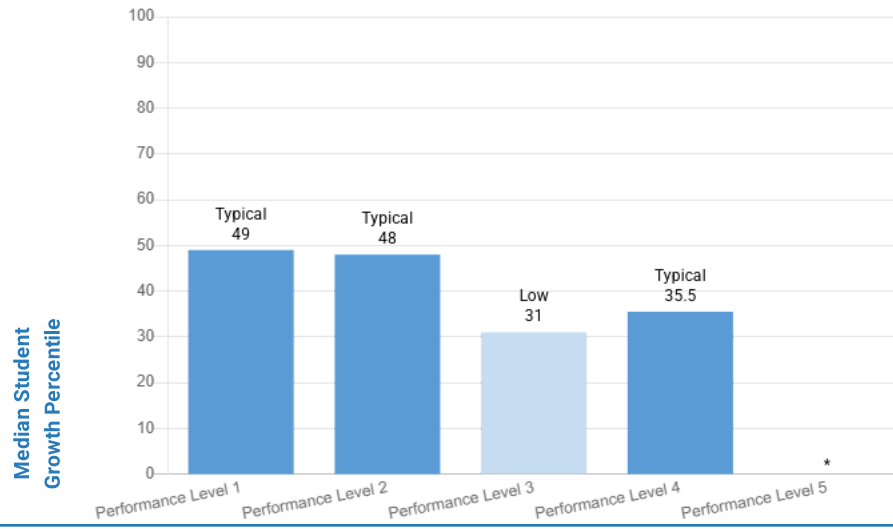

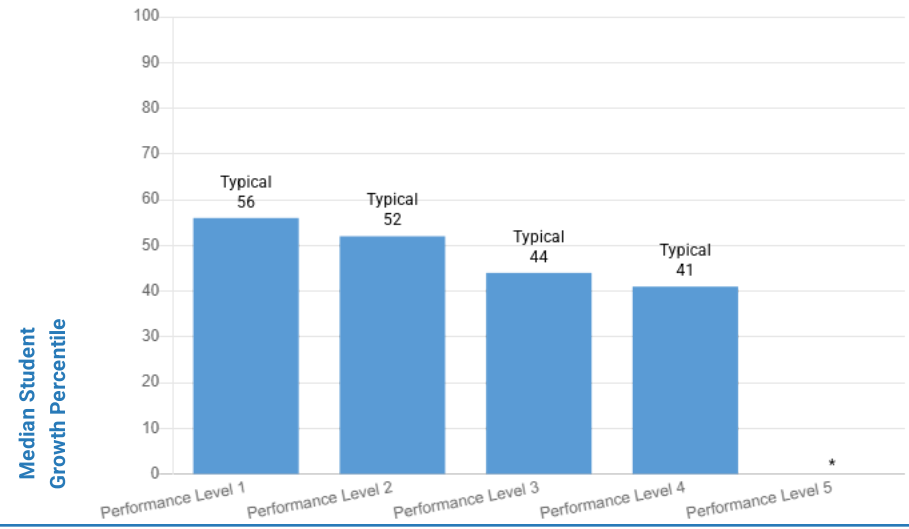

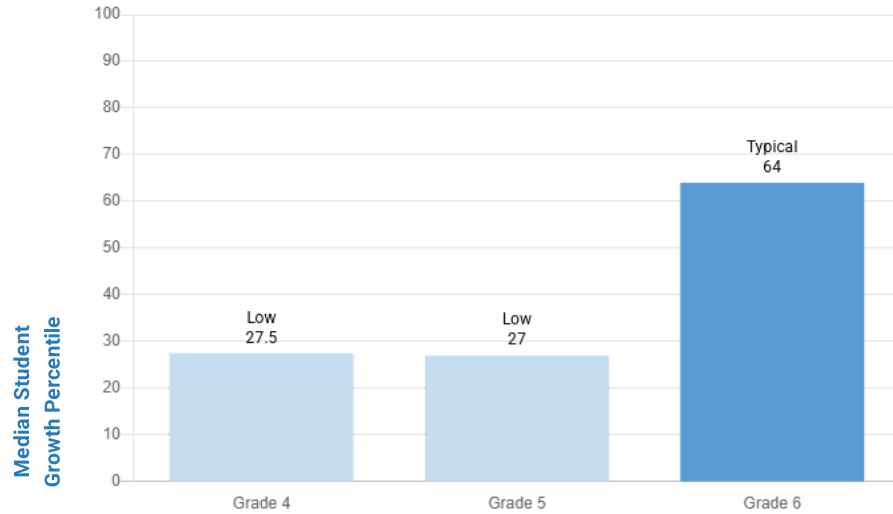

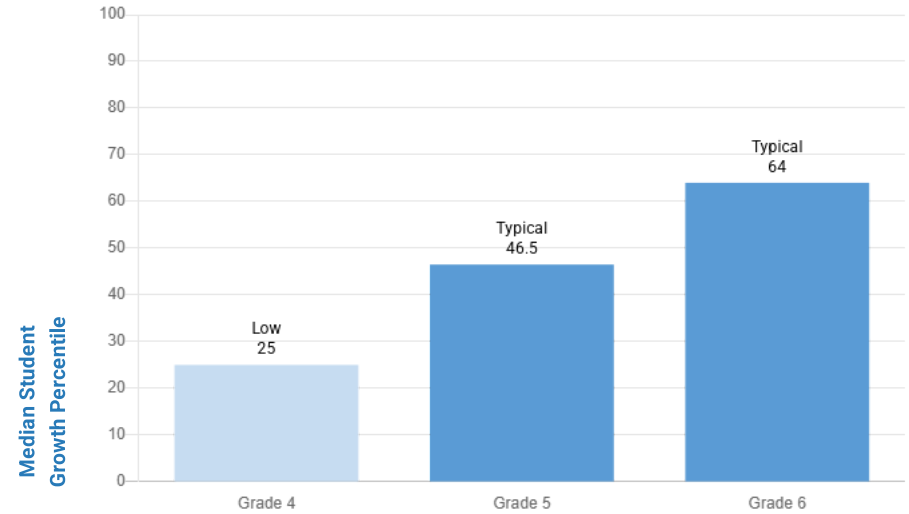

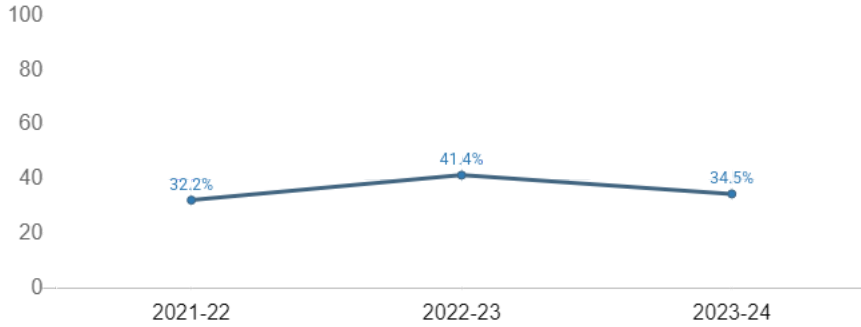

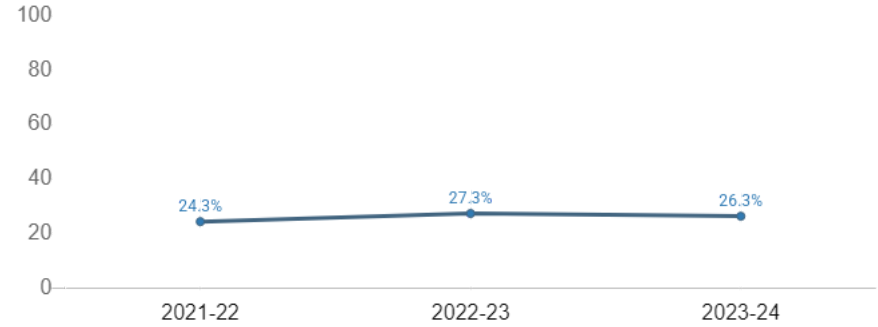
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 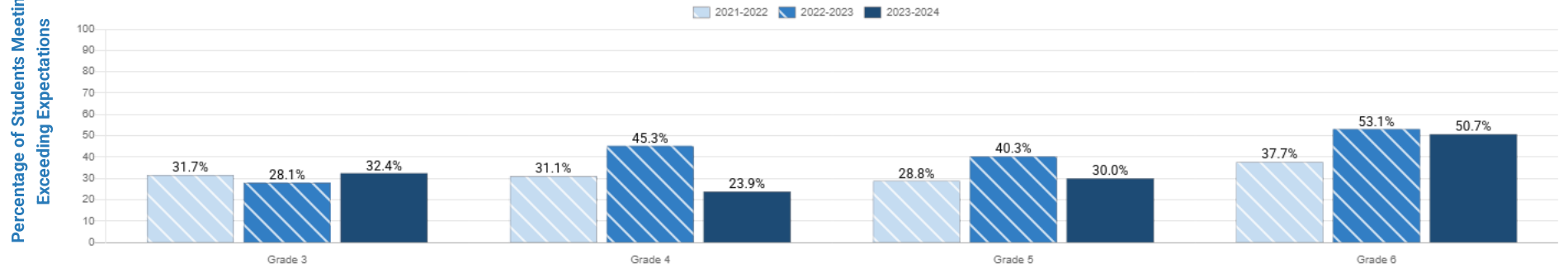

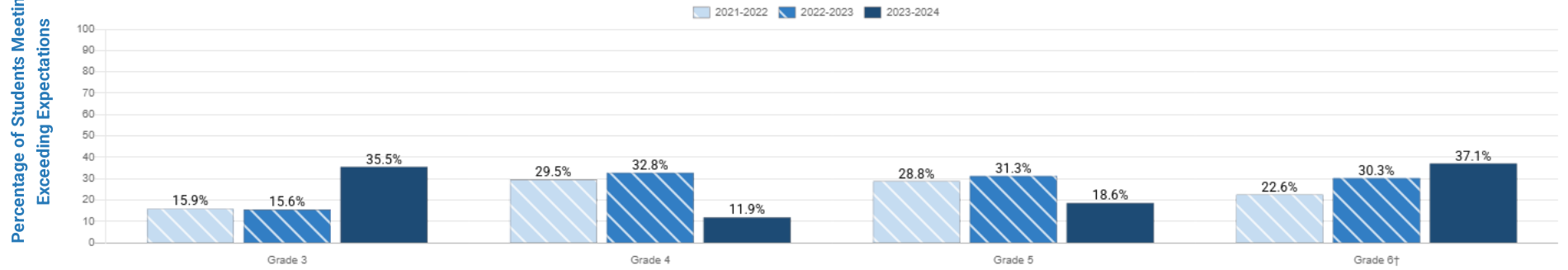

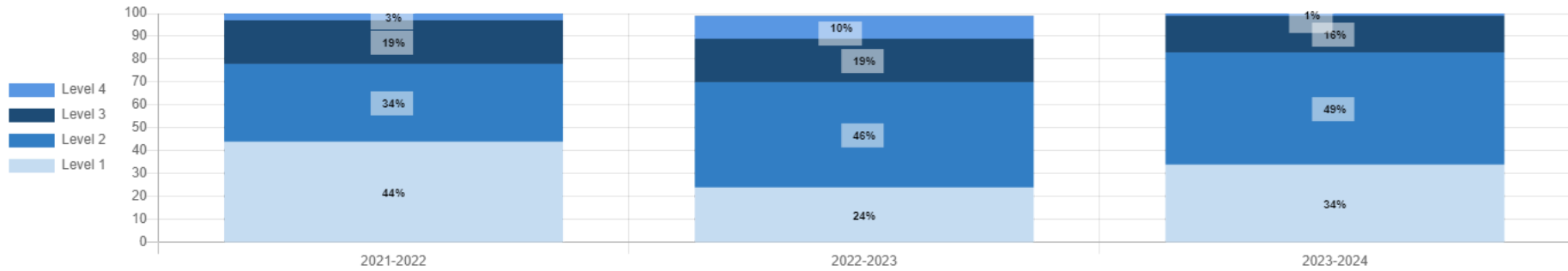

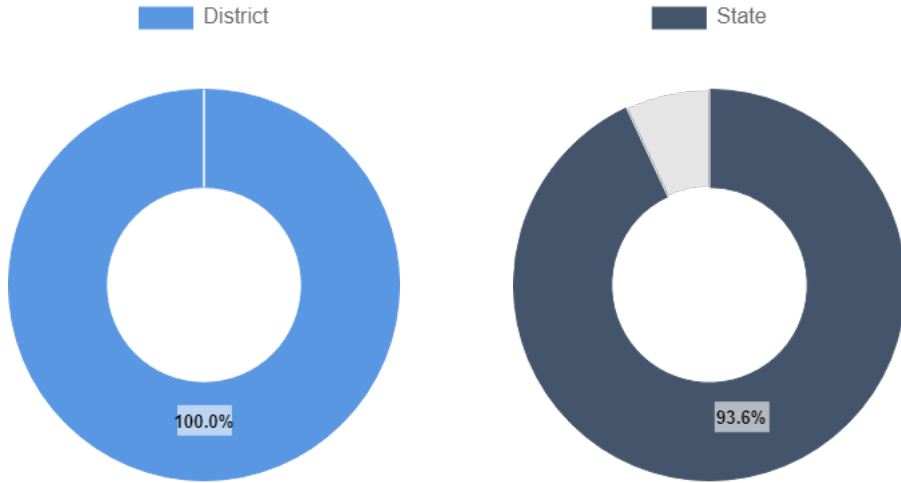

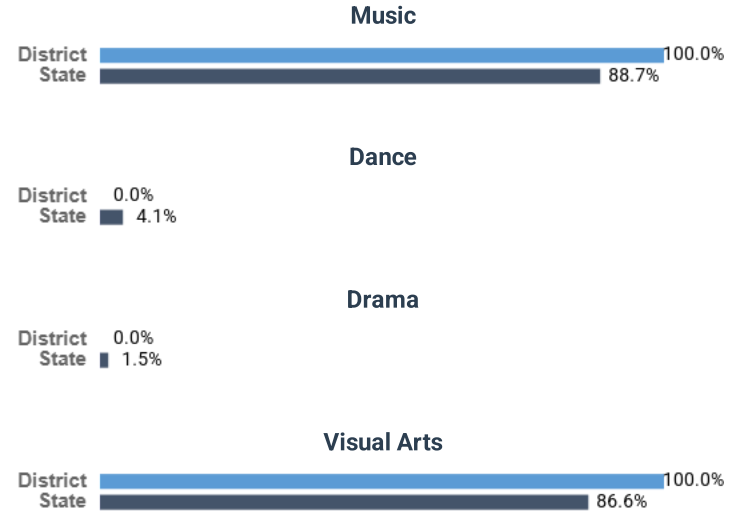

Students enrolled in one or more classes by discipline:



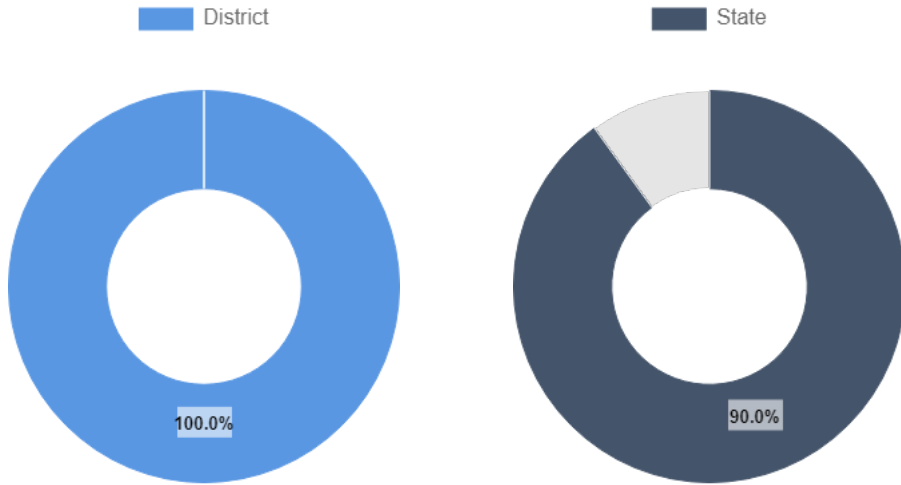

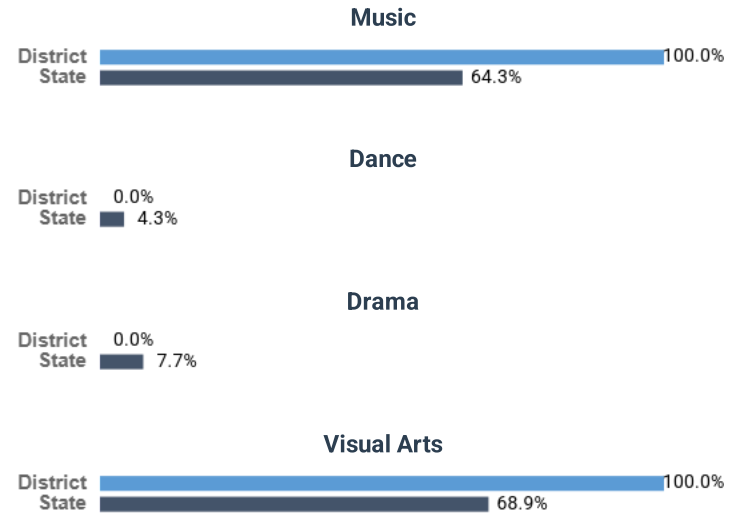

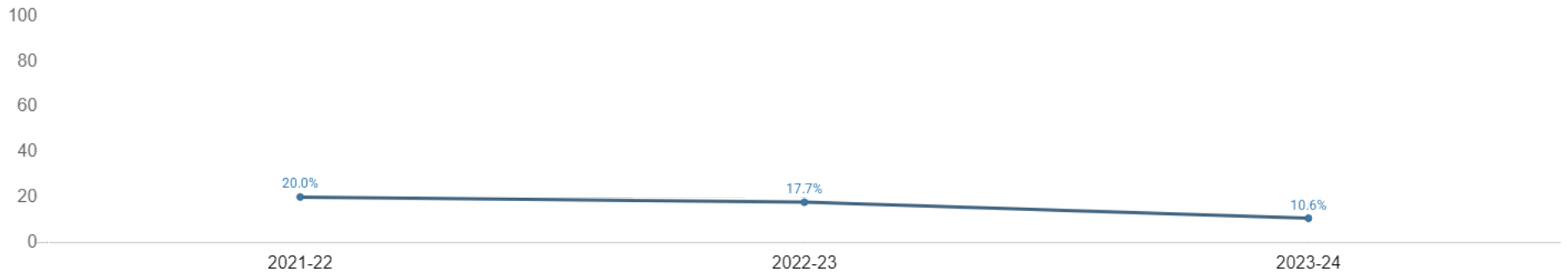

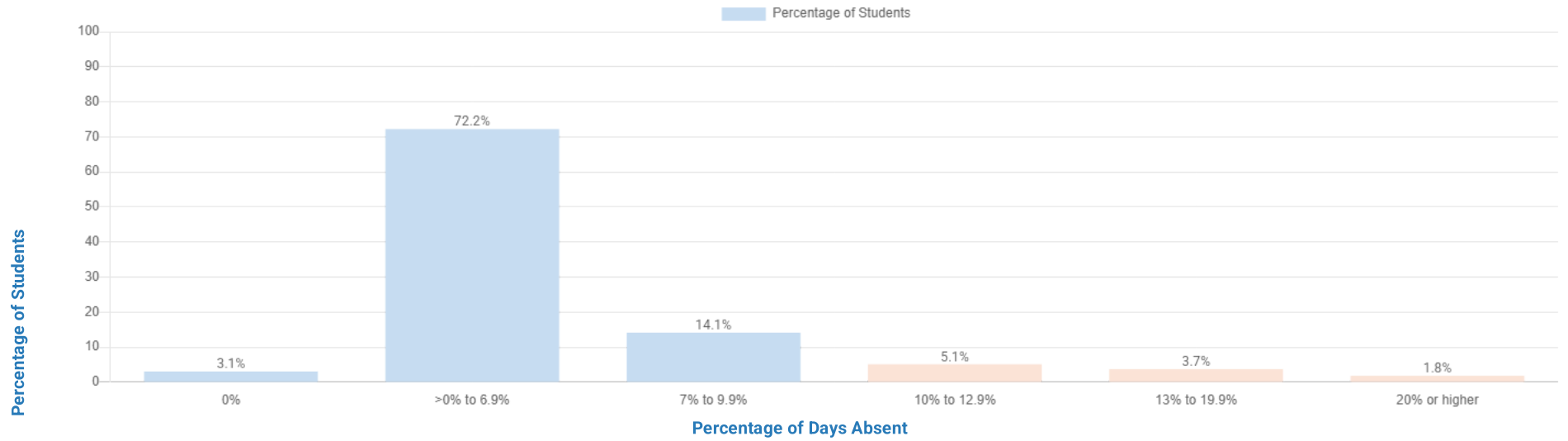

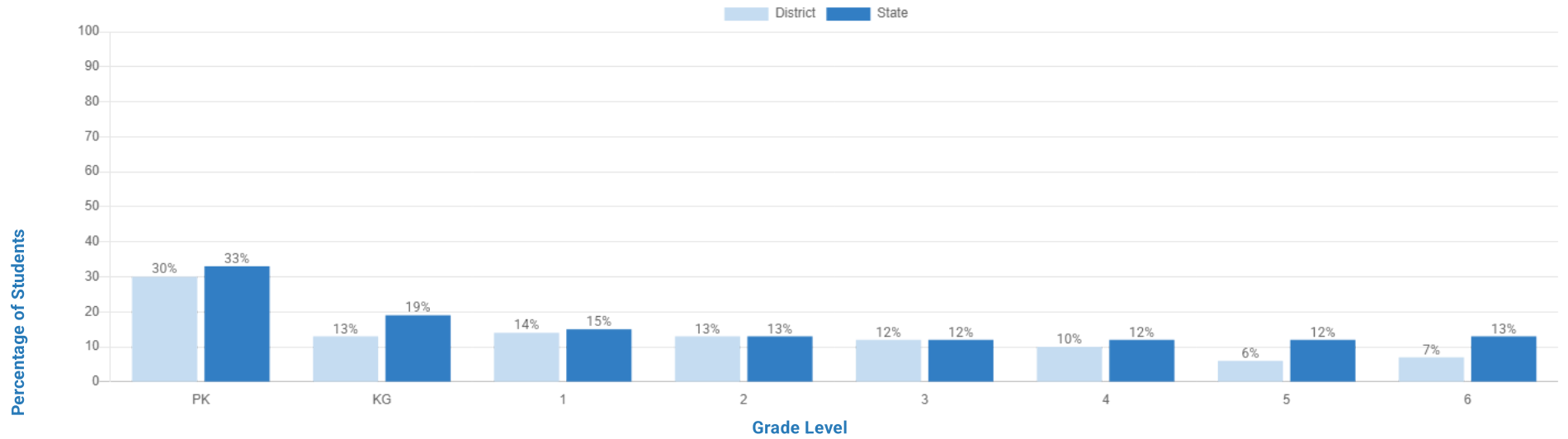

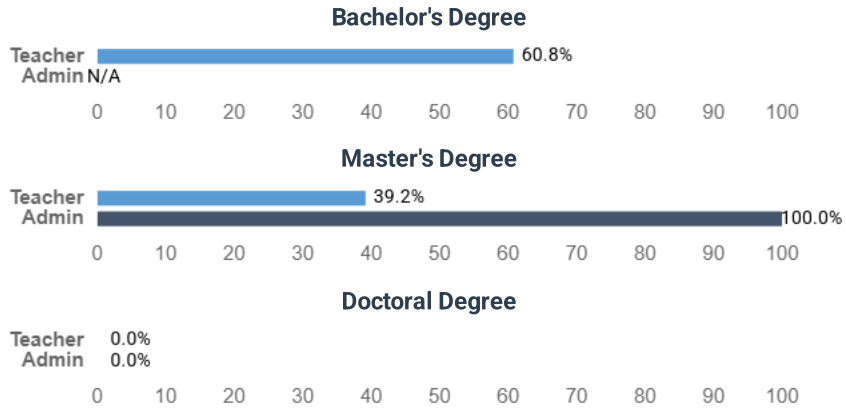

Washington Borough School District delivers standards-based instruction across Science, Social Studies, World Language, Visual and Performing Arts, English Language Arts, and Mathematics. The 1:1 technology initiative provides digital access for students, with smartboards in every classroom. The K-6 Gifted and Talented program offers STEAM enrichment and project-based learning. Through the After-School Homework Club and New Jersey Tiered System of Supports (NJTSS), the district provides comprehensive academic support to ensure all students achieve their potential through evidence-based practices.



Clubs and Activities:

The Washington Borough School District enriches student learning through diverse before and after-school programming. The clubs include Battle of the Books, STEAM, Reading, Student Council, Drama, Choir, Band, Battle of the Minds, Instrumental Music, Garden Club at the Karen Nash Memorial Butterfly Garden, and Knitting Club. These programs foster a supportive environment that enhances academic achievement through technology-integrated experiences. The Washington Borough School District implements the New Jersey Tiered System of Supports (NJTSS/MTSS) framework, utilizing Request for Assistance and Intervention & Referral Services (I&RS) processes to support student success. The comprehensive Child Study Team includes a full-time school psychologist, social worker, counselor, learning disabilities teacher consultant, and Coordinator of Social-Emotional and Behavioral Support. This team collaborates to implement preventative measures and positive behavioral interventions while fostering students' social-emotional well-being. Through systematic data collection and analysis within the tiered intervention framework, the district identifies and provides targeted academic and behavioral support services for students needing additional assistance.



Student Health and Wellness:

Washington Borough School District fosters student health and wellness through comprehensive community engagement initiatives. The programs include PBSIS Random Acts of Kindness, Buddy Bench Program, Red Ribbon Week for drug prevention, and annual Week of Respect activities. The district partners with the Warren County Prosecutor's Office and local law enforcement for internet safety education, while implementing district-wide social-emotional learning to enhance character development and academic achievement. Additional student support includes Peer Leaders programs at both Memorial and Taylor Street Schools and the Big Brothers Big Sisters Mentoring program.

Technology and STEM:

Memorial School's annual spring STEAM Fair highlights the district's commitment to science, technology, engineering, arts, and mathematics education. The district's 1:1 technology initiative provides personal devices for all K-6 students, with Smart Board technology and Wi-Fi accessibility throughout both buildings. The Library Media Center incorporates comprehensive digital literacy instruction, while the Gifted and Talented program offers advanced opportunities in coding, robotics, and engineering design thinking. STEAM instruction is integrated across the K-6 curriculum through inquiry-based learning experiences and innovative project work, including agricultural learning opportunities at the Karen Nash Memorial Butterfly Garden, fostering critical thinking and real-world connections.



Early Childhood Education:

The Washington Borough School District offers a comprehensive full-day preschool program at Taylor Street School from 8:15AM-2:15PM, with an extended day option until 2:45 PM available at no cost to families through PEA funding. With small class sizes averaging 12 students, the program provides an optimal learning environment for young children's development. Following Creative Curriculum guidelines, the program focuses on developing essential early literacy and foundational skills through engaging, play-based learning experiences. Students participate in daily activities designed to enhance both fine and gross motor skills, setting a strong foundation for future academic success. The program currently has immediate openings for enrollment, providing an accessible early education opportunity for district families committed to early childhood development.



Attendance:

The Washington Borough School District's Ready to Learn Initiative provides early morning supervision starting at 7:40 AM at both Taylor Street and Memorial Schools. This program ensures students begin their day with proper nutrition through free hot breakfast for eligible students, while others may bring or purchase breakfast. The initiative has successfully improved student attendance and reduced tardiness rates across both buildings, demonstrating the district's commitment to supporting student wellness and academic readiness. By providing this structured morning environment, students arrive prepared to engage in their academic lessons with proper nutrition and a smooth transition into the school day.
