







Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

The Class of 2024 consisted of 550 graduates with 79% pursuing further education. 55% pursued four-year colleges; 24% pursued two-year colleges; 6% pursued Career/Technical Schools; 4% Military Enlistment, and 11% School-to-Work. The class was awarded at total of \$18.4 million in grants and scholarships. EHTHS offers separate evening events, Financial Aid Night and College Information Night, which assist families with the financial aid and college application processes. Our school also administers the PSAT, during the school day, for all 10th and 11th grade students at no cost to the student.

Student Supports and Services:

EHTHS provides extensive supports for students with a Child Study Team that includes two school psychologists, two social workers, a learning disabilities teacher consultant, and a certified BCBA. EHTHS also provides a comprehensive school counseling program including Student Assistance Coordinators, a community Youth-Based Service program, as well as two Intervention & Referral Services Teams covering two grade levels each. EHTHS has implemented CARES (Concentration on Academics Restorative Exercise and Self), an SEL based program focused on student reflection and improving behavior.



EHTHS offers a before school breakfast program. Health & Wellness education is delivered through a comprehensive Health & Physical Education curriculum that includes aerobic training, weight training, and aquatics. Medical care is provided by a nursing suite staffed by three certified school nurses. EHTHS has adopted the P.A.W.S. (Pets Aiding in the Wellbeing of Students) program which uses certified therapy animals (dogs) to increase social and emotional well-being of students through positive interactions, relationship building and the modeling/implementation of coping skills.



Parent and Community Involvement:

EHTHS offers an extensive menu of STEAM coursework, including multiple HN and AP courses in Computer Science. Our curriculum features courses in Engineering Design using CAD, Robotics Engineering, STEAM 2.0, Web Design, Electrical Engineering and Technology, Networking and PC systems, Aviation, Digital Design, Intro to Game Design, and Cybersecurity. Additionally, EHTHS boasts an Innovation, further enriching students' hands-on learning experiences. The high school offers Computer Science, hardware and programming courses and students can extend their learning through after-school programming opportunities such as our Coding and Esports Club.



EHTHS offers two preschool classrooms as part of the district's preschool expansion initiative. Students in our child development program, many of which have postsecondary goals in Early Childhood education, have an opportunity to work with the teachers and students in preschool classroom setting. Program collaboration is implemented by certified staff from our Family & Consumer Science Department, preschool staff, and their respective supervisors.

EHTHS utilizes a modified, rotating block schedule with instructional periods of 55 minutes, six times per day. Total enrollment is approximately 2300 with a full-time certified staff of over 230, many holding advanced degrees. EHTHS offers four cohort academy programs: a Medical Science Academy, the Academy of Law and Business, Culinary Academy, and the Communications Academy, as well as designated STREAM Tracks and Air Force JROTC. Dual credit is offered through partnerships with Stockton University and Atlantic Cape Community College. A half-day Senior Option program is available to students that may want to pursue School-to-Work or college course opportunities. An Option Two program, for senior students who would like to fulfill graduation requirements in a non-traditional manner, is also available.
