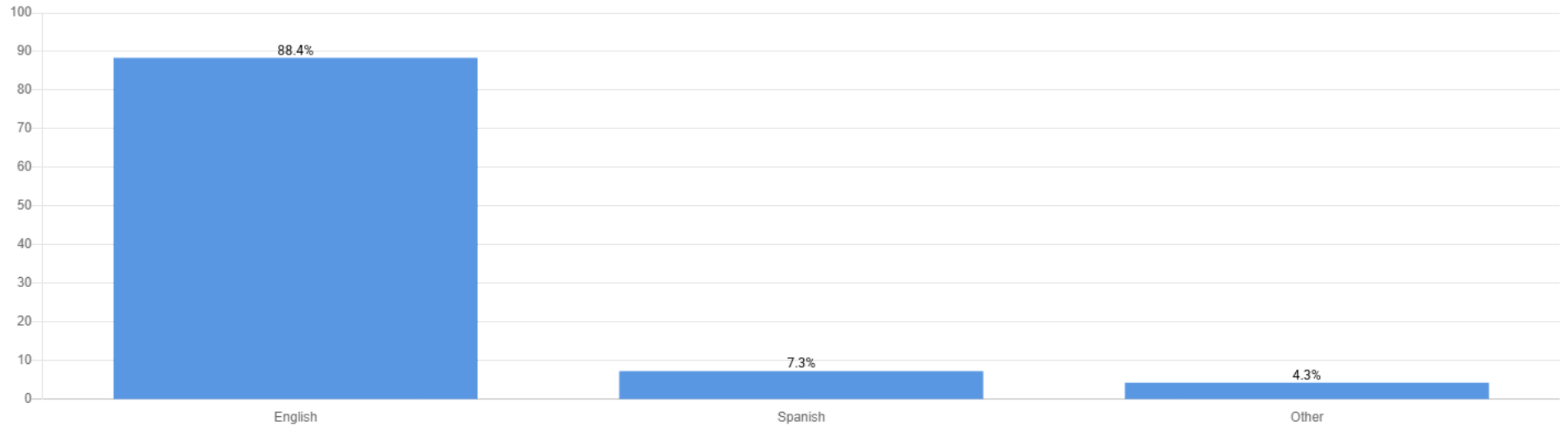

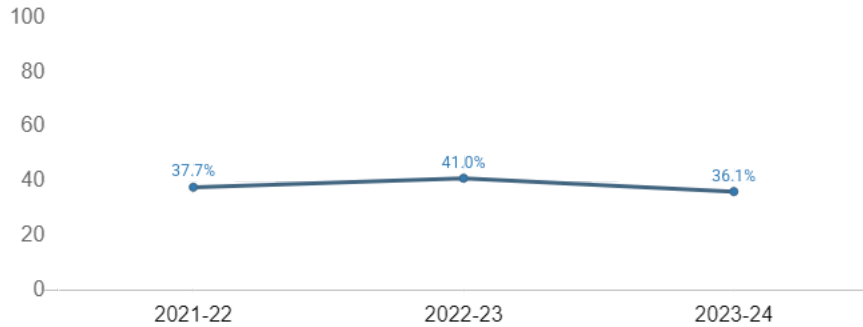

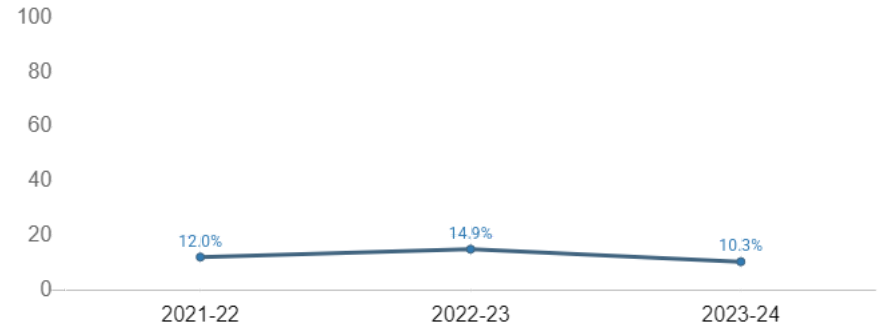
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. The Proficiency Rate for Federal Accountability measures the percentage of students who met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. 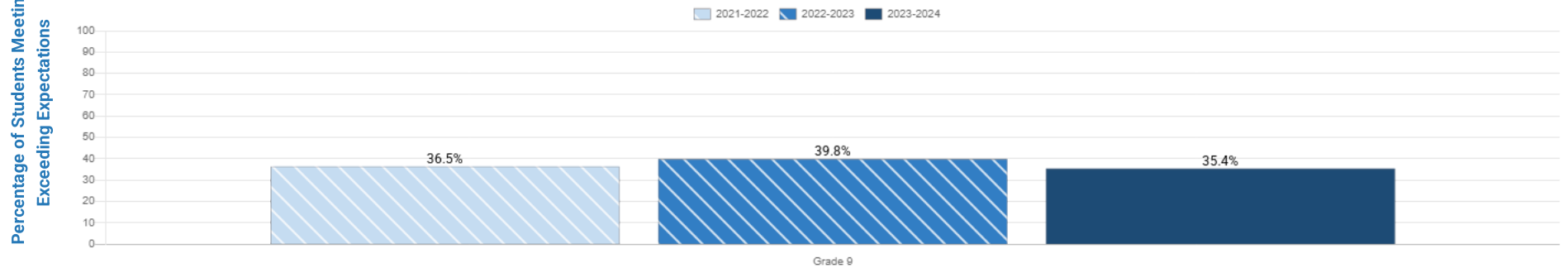

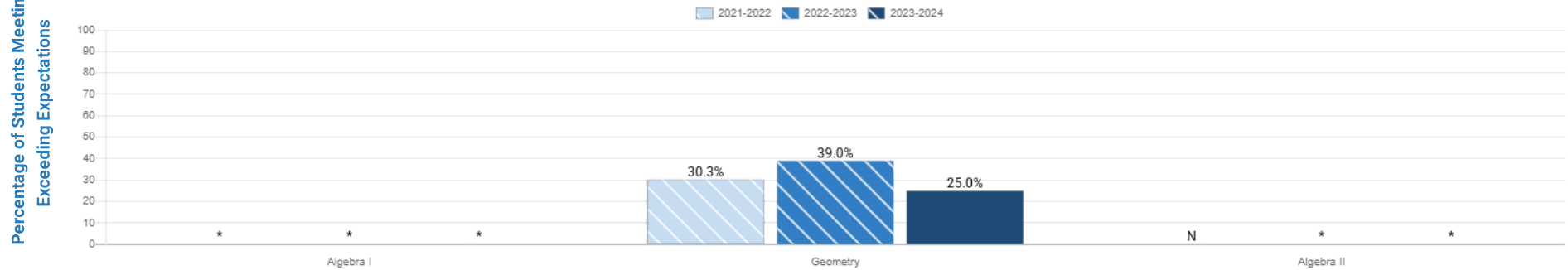

Students in sixth grade who were enrolled in Algebra I course were required to take both the Algebra I and Grade 6 mathematics assessment. The results of their Algebra I assessment are not included in these results but will be reported when the student is in grade 9.

The results of their Geometry assessment are not included in these results but will be reported when the student is in grade 9.

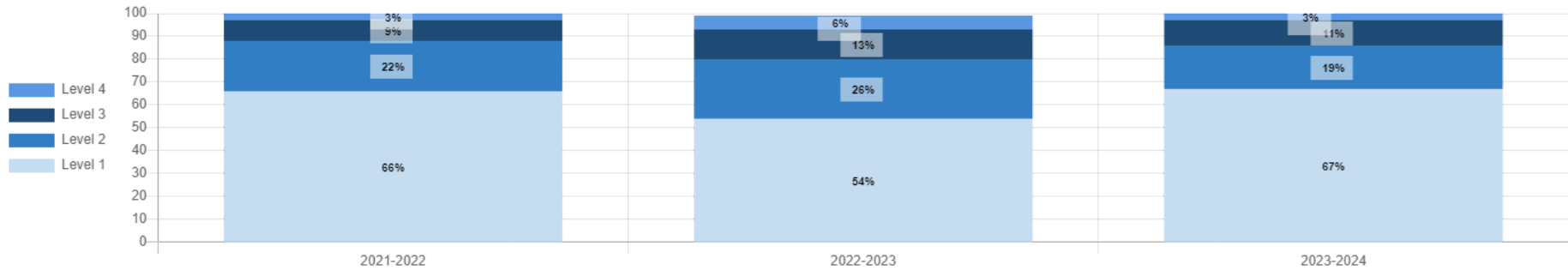

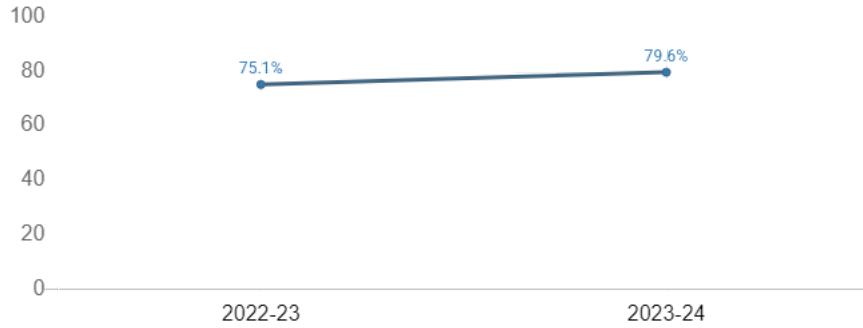

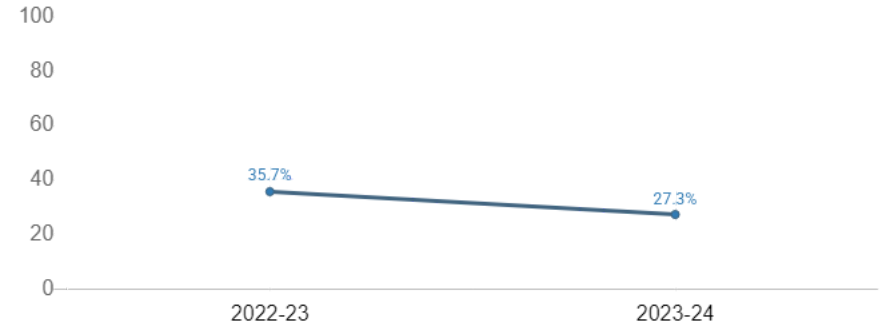

Students taking one or more AP or IB exam

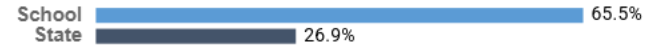

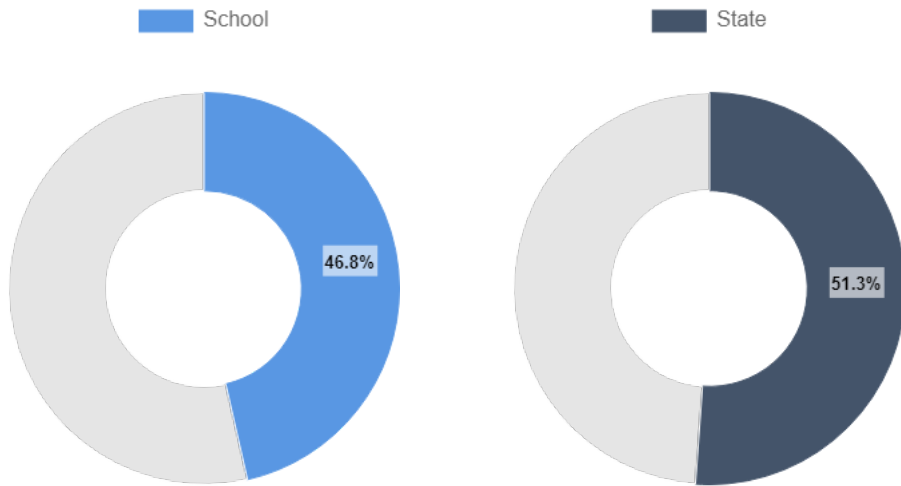

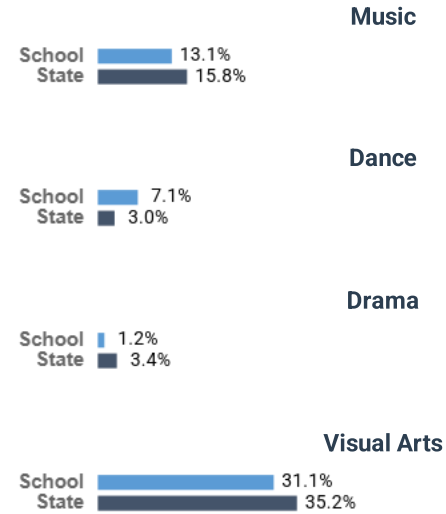

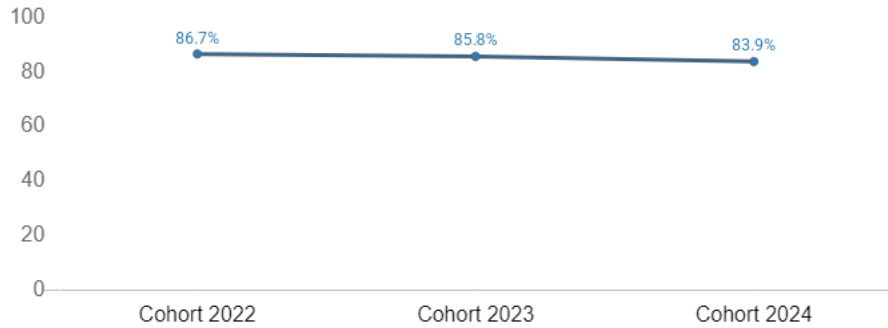

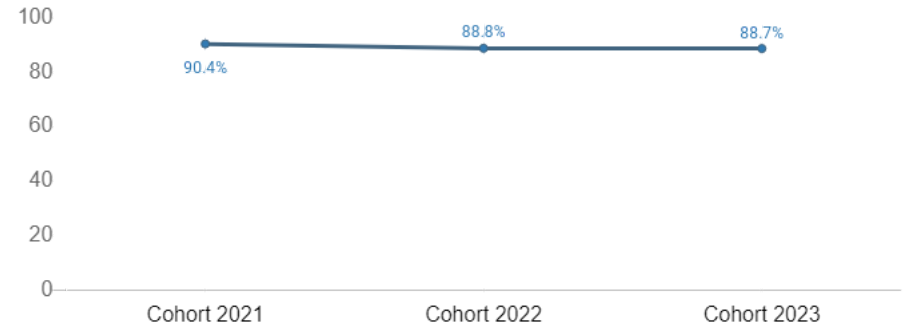

Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

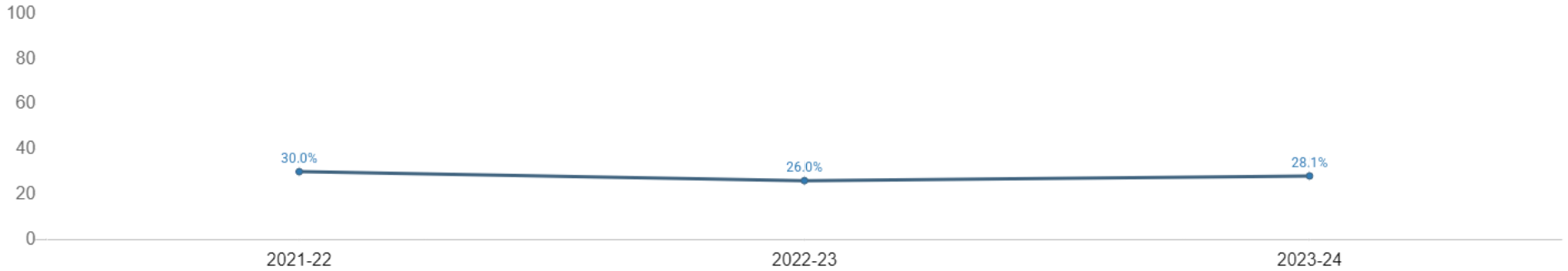

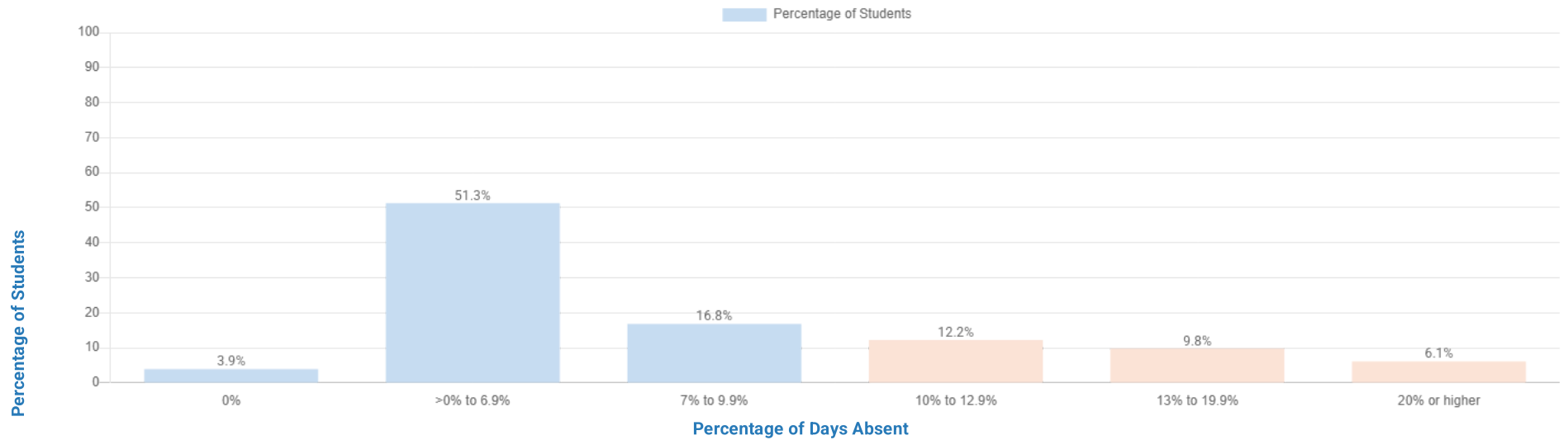

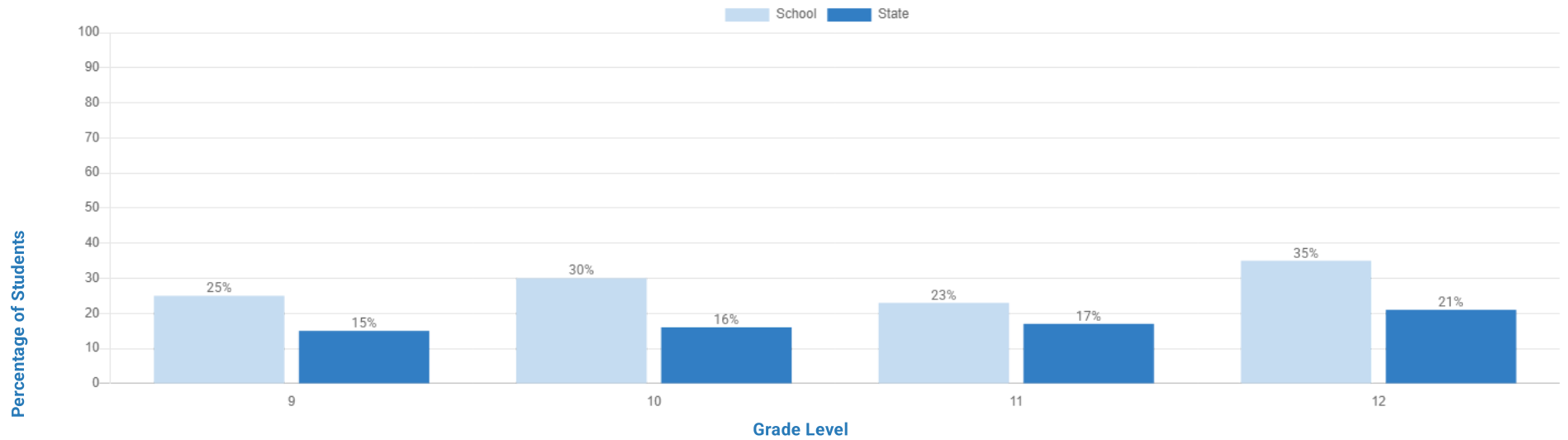

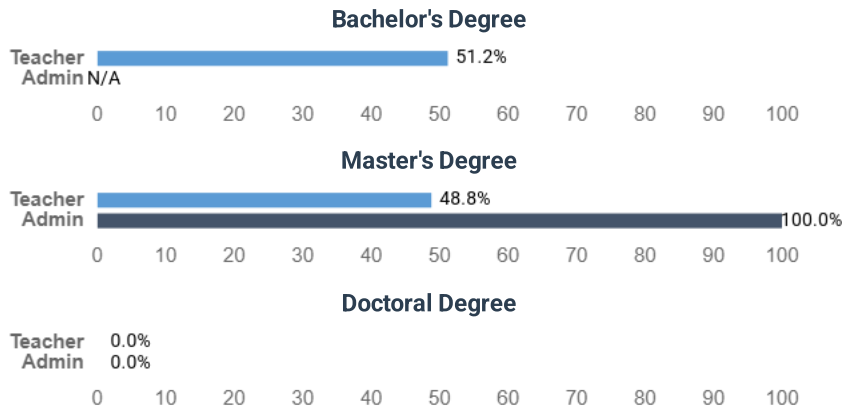

- The Greater Egg Harbor Regional High School District offers six Magnet Programs. Oakcrest High School offers Biomedical Science and Digital Communications.

The Greater Egg Harbor Regional High School District is an inclusive community with a dedicated staff of educators creating spaces in classrooms, cafes, gyms, stages, and fields that our students know they belong in. This creates students who are empowered to move into that space and perform openly and confidently; no student should be standing outside, looking in.



Awards, Recognition, Accomplishments:

During the 2023-24 school year, students participated in 237 enrolled in AP Courses and 122 took the AP exam. 63% were eligible to receive college credit. The College Board awarded 9 students with AP Honors, 1 AP Scholar with Honors, 3 AP Scholars with Distinction. Nine students graduated with the NJDOE Seal of Biliteracy Certificate and three students earned their Associates Degree from Atlantic Cape Community College. This year, the drama program performed CLUE and are gearing up for a production of Mean Girls. Our business students were awarded champions of the NJ State Stock Market Game for 5 consecutive years. Our Marching Ambassadors won their 7th straight Region Championship and 6th NJ State Tournament of Band Champions. Project Lead the Way is one the nationally recognized and certified STEM providers that support our curriculum in the Engineering and Biomedical Magnet Programs. Students have the opportunity to earn college credits while participating in select courses with dual credit agreements to area Universities and Community Colleges. We offer high quality CTE Programs that provide work based learning experiences for post-secondary career pathways. Our Visual and Performing Arts Programs enhance academic achievement, and social-emotional development through the mediums of visual and theater arts, music and dance.

Our student-athletes have been awarded multiple athletic scholarships to Division 1 schools. Oakcrest is proud to have had recent graduates play in the NFL, MLB, and a High School National Champion in Javelin.



Clubs and Activities:

We offer over 40 different clubs and activities for our students and an additional 27 athletic teams. Our award-winning music and performing arts programs include Dance, Choir, Band, Marching Band, Drama and Musical Productions. Our Multicultural Interest Club and our STAR Program (Students Talking About Racism) seeks to enrich the school's cultural awareness through social and educational activities that enhance experiences and build community. Our commitment to extracurricular learning is showcased during "Falcon Time," a component of our school-wide zero period in which students can engage in meaningful social, emotional interactions, get extra help or take up a new hobby that may lead to a new club or activity. E-sports, community service, cooking and chess are just a few of the pursuits attracting large crowds of students during this innovative class period.

Before and After School Programs:

Oakcrest HS opens the library for use before and after school hours. Additionally, we also offer "breakfast before the bell" which is free for all students. Zero Period allows students an opportunity to get academic help as needed, explore career options, and build relationships with peers and staff. Zero Period is an optional time for students prior to the start of the academic day. We have seen a very positive impact on relationships, and the ability of students to make up work and get extra help as needed.



Staff and Professional Learning:

Learning is at the heart of all we do in the GEHRHSD. To help ensure teaching and learning occur at the highest levels, our educators engage in a cycle of continuous learning that includes use of data to determine student and educator learning needs, identification of shared goals for student and educator learning, professional learning to extend educators' knowledge of content, content-specific pedagogy, how students learn, and management of classroom environments. This year, we continue to focus on aligning professional learning and support to the New Jersey Student Learning Standards, the (NGSS), and English Language Learner Frameworks, including the Literacy Standards for Science, History/Social Studies and the Technical Subjects-in all content areas. In addition, we continue to focus on refining and creating new courses and pathways in the Career Technical Subjects (CTE) as well as working with our post-secondary partners including local colleges and universities.



Postsecondary Information:

67% of the Class of 2024 attended college, 25% attended a career or trade school, and 2% enlisted in the military. We host an annual College Fair with over 100 colleges/universities, technical schools and the United States Armed Services. Our Guidance Department hosts events that aid students in college searches, applications and completion of the FAFSA. We host Instant Decision Days with multiple colleges/universities. All students have the opportunity to take the PSAT and SAT at no cost. We serve as a testing site for the SAT and assist students with procuring reduced or waived fees for the SAT, AP and ACT exams. Graduates in the Class of 2024, were accepted to over 100 different colleges/universities from Vanderbilt University, Rensselaer Polytechnical Institute, Florida Gulf Coast University, and North Carolina A&T State University to name a few. The most common college acceptances were Rowan University, Stockton University, and Rutgers Universities.

Student Supports and Services:

Learning is fostered through the development of skills that enable students to function effectively in a changing society. Instruction is developed on the firm belief that every student can learn. Our district offers academic enrichment courses and after school supports for struggling learners. Students with disabilities are enrolled in courses based on their Individualized Education Program (IEP). All courses follow the General Education College Prep Curriculum with use of modifications and adaptations on an individual basis. English Language Learners rapidly progress in English language acquisition through highly structured course delivered by a caring and committed staff of educators. Counselors work collaboratively to support the learning process and promote academic achievement and social wellbeing with consideration of student ability and learning style. Counselors regularly monitor students' courses and accumulation of credits to ensure they are meeting graduation requirement



Student Health and Wellness:

Greater Egg Harbor Regional understands the importance of physical and mental health and wellness. Our students receive a Health and Wellness curriculum that includes Teen Mental Health First Aid, Goal Specific Fitness, Movement for a Healthy Lifestyle, and Sports Medicine. Our district works in collaboration with local agencies to provide a comprehensive system of support. We are proactive in educating students about Mental Health and Suicide Prevention by implementing an Emotional Health and Suicide Prevention Curriculum. All Teachers and Administrators at Greater Egg receive training in Mental Health Youth First Aid, a public education program that introduces participants to the unique risk factors and warning signs of mental health problems in adolescents and teaches of the importance of early intervention to help an adolescent in crisis or experiencing a mental health challenge. We offer the Adventure Network Ropes Program.



Parent and Community Involvement:

Our Oakcrest Parent Advisory Committee (O-PAC) meetings are held three times a year. Parents sit on our Title 1 Community Advisory, Special Education Advisory (SEAC), Project Lake Day Committees, and booster clubs for all athletic and performing arts programs. Our website and social media promote upcoming events, list organizations, house informative, staff web-pages, and provides access to our student-management system: Genesis. Through Genesis, parents can review student assignments, grades, attendance, discipline, and more. We host annual financial aid and college planning information sessions workshops that assist parents with completing and submitting the FAFSA. All of our sport teams are required to complete at least one community service, and all our activities work to build positive relationships within our community. We also host a podcast in which the community can get a closer look at the people, projects and new initiatives in and around not only Oakcrest High School.

Facilities:

Built in 1960, Oakcrest High School has undergone at least six additions and renovations, with the most recent being completed just last year - with a new, top-notch synthetic turf field, gymnasium, PAC improvement to lighting and sound, Tennis Court, Track, and paving around the building. Five years ago - in another project, Oakcrest received new locker rooms and lavatories, new HVAC/air conditioning units in all classrooms, upgrades to technology and electrical grids, new security cameras, new lighting, and new student lockers.



School Safety:

Creating and maintaining a safe environment for all students and staff is our district's highest priority. We have armed school resource officers in each school as well as security personnel scheduled during the day, after school, and evenings. We have a new video surveillance camera system linked to our police departments, and promote a positive relationship with law enforcement through walk-thrus and shared programs. Technology has recently been put in place for students to anonymously report their concerns to school administrators. In addition, we have a security application that immediately locks down our schools in the event of a school emergency with INSTANT notification to police. Secured kiosks requiring ID were added to the main school entrance to provide a security screening on each visitor before they are permitted to enter the building. Most importantly, we include students and staff in our ongoing dialog following security drills to further refine school safety procedures.



Technology and STEM:

STEM (Science, Technology, Engineering and Mathematics) offerings in our schools are unique interdisciplinary experiences for students. The Magnet Programs offer a comprehensive suite of courses arranged into several pathways of learning such as Engineering, Environmental Science, Biomedical Science, Homeland Security and Public Safety, and Computer Science and Network Technology. Up-coming 9th grade students that apply to the Magnet Programs will commit to a four-year program of study that requires additional STEM coursework yet is flexible enough to allow for non-STEM electives. Students are immersed in coursework that requires the use of sophisticated technology, integrated projects, professional mentorships, and community service projects while participating in the program and after school clubs. Graduates of the Magnet Program go on to continue their education and research at some of the most prestigious colleges and universities across the country!

The GEHR District has utilized federal and state funding provided through ESSER and ARP/ESSER to benefit our entire student populations. Within our buildings, upgrades and renovations to HVAC and technology infrastructure totaled more than \$7 million. Additional monies were specified for after-school and evening tutoring, as well as summer enrichment and learning acceleration programs. Finally, the District has committed to providing for staff and student mental health and emotional well-being with the provision of non-duplicated Tier 1, Tier 2, and Tier 3 counselors in each building.

The AtlantiCare Teen Center's mission is to assist students in individual and group counseling options. Our CST provides assistance to students with disabilities, and the Effective School Solutions Program assists students with academic and social/emotional support. Our school counselors meet in group and individual settings as they work collaboratively with teachers to monitor growth and progress of each and every student. Our PRIDE program, currently in its 2nd year, emphasizes the core cultural pillars of "Patience, Respect, Integrity, Determination, and Empathy." Daily, positive PRIDE messages are provided and announced every morning. This year's theme revolves around the acronym H.E.A.R.T.: Humility, Empathy, Acceptance, Respect, and Teamwork. This school-wide, year-long initiative focuses on social/emotional healing, growth and development. The central focus is aimed at training staff and school caregivers to exhibit the change they wish to see exhibited in our students.
