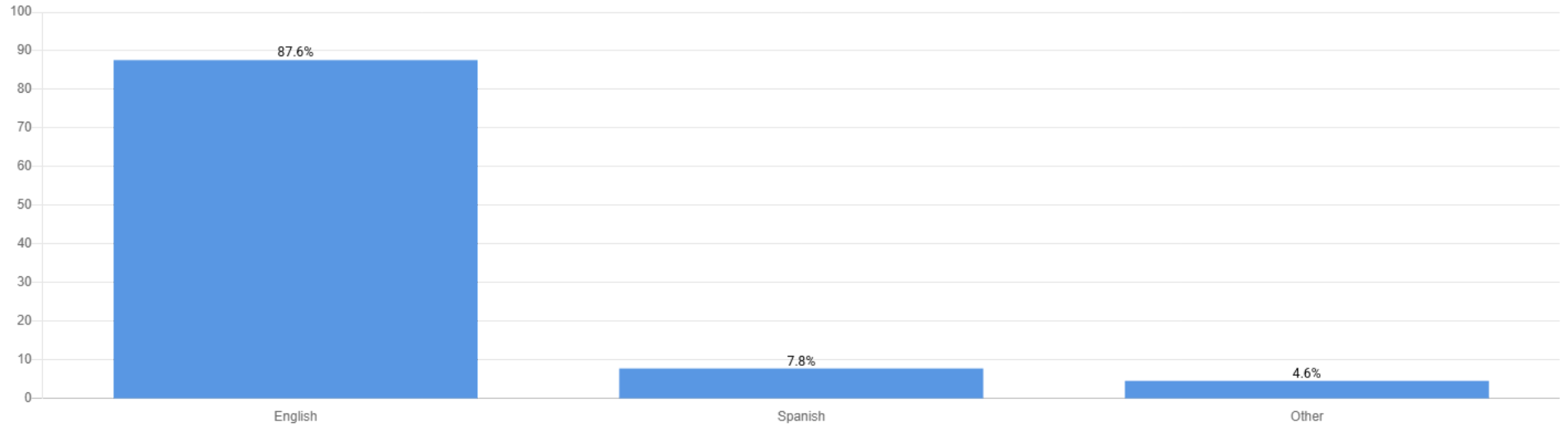

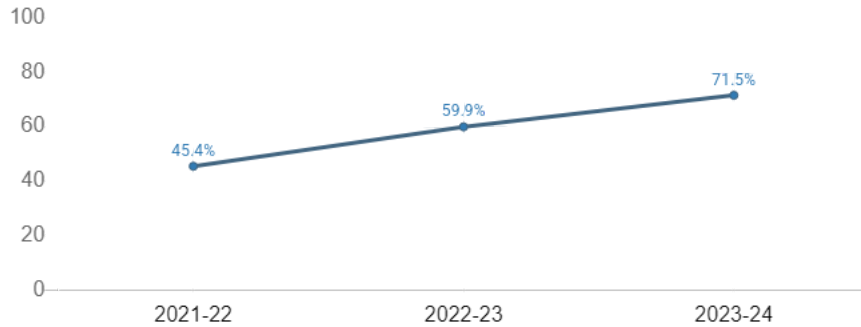

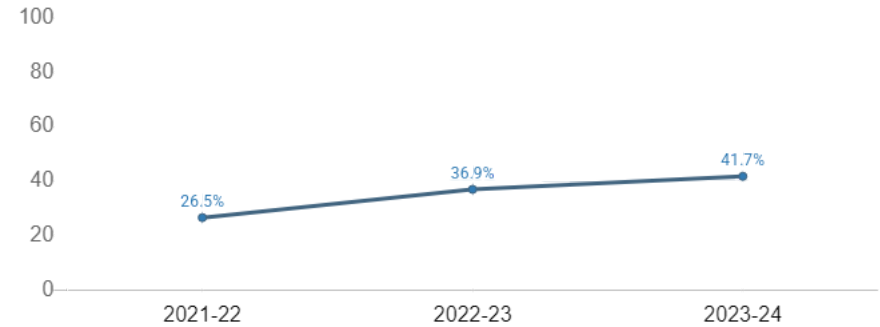
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. The Proficiency Rate for Federal Accountability measures the percentage of students who met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. 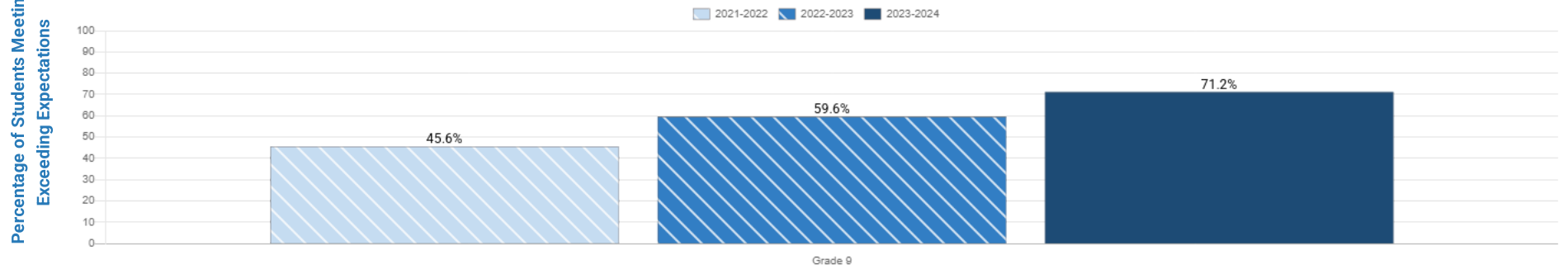

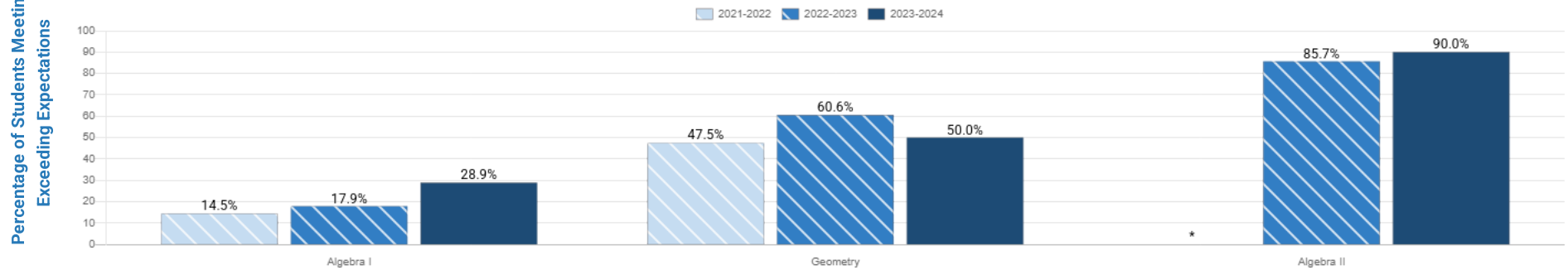

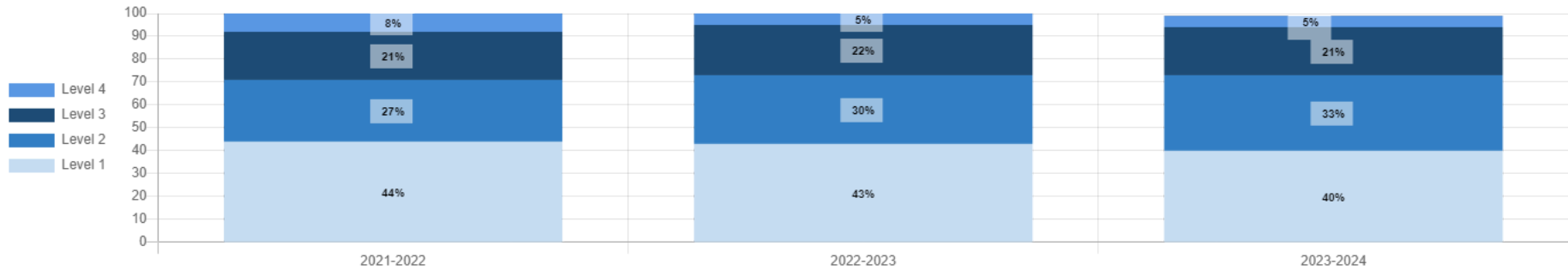

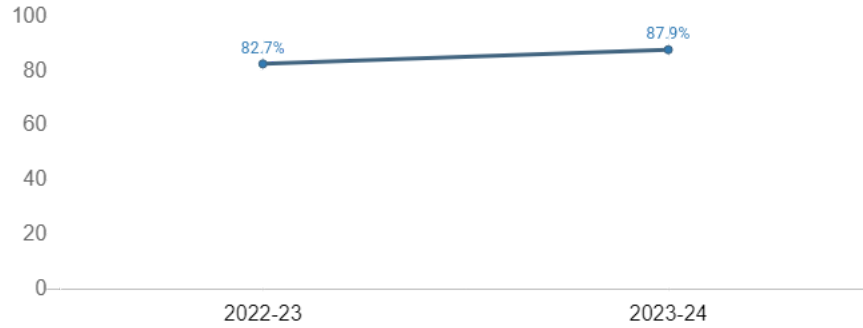

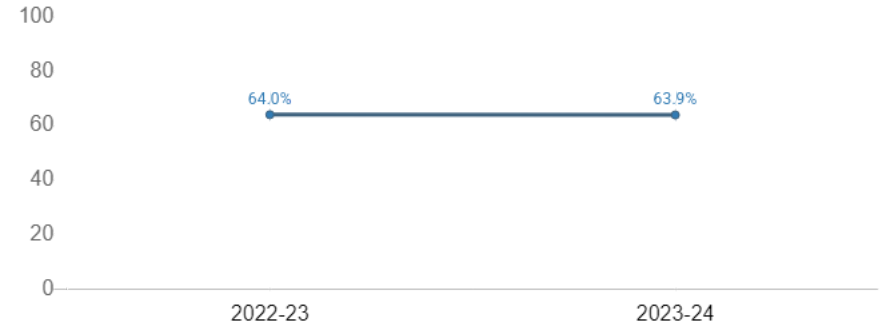

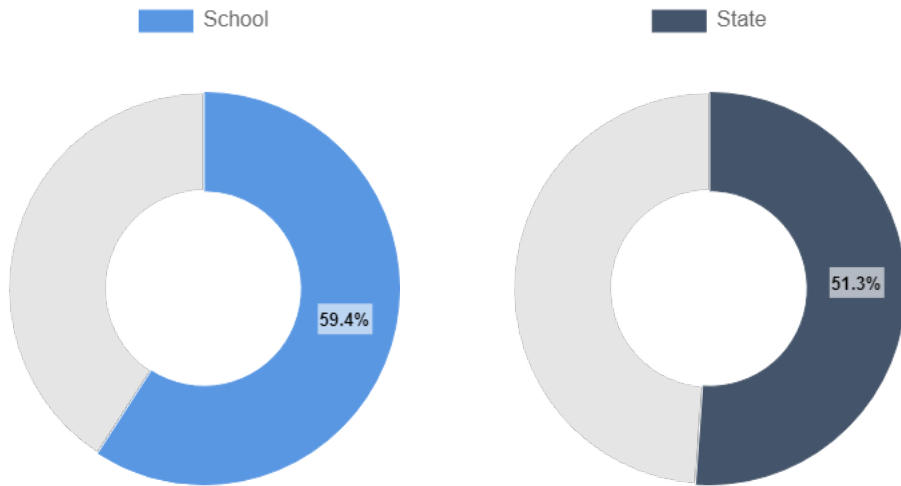

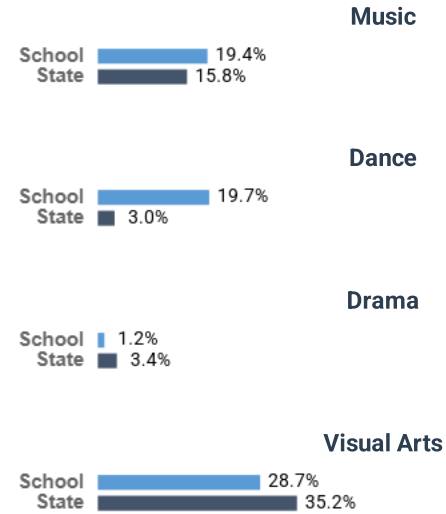

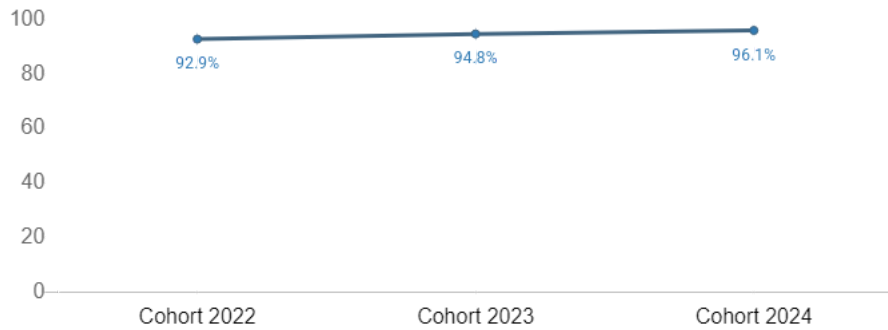

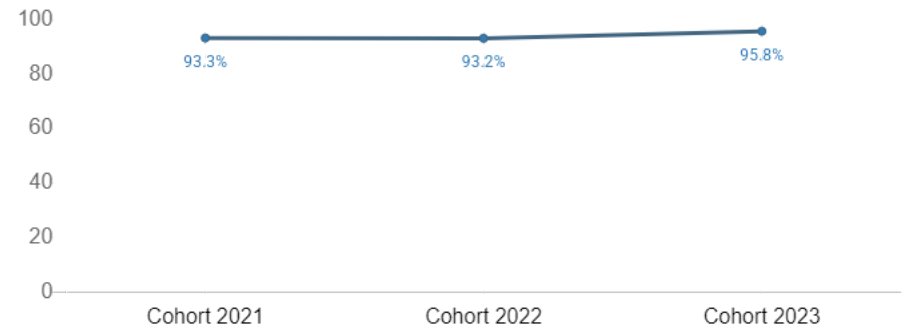

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

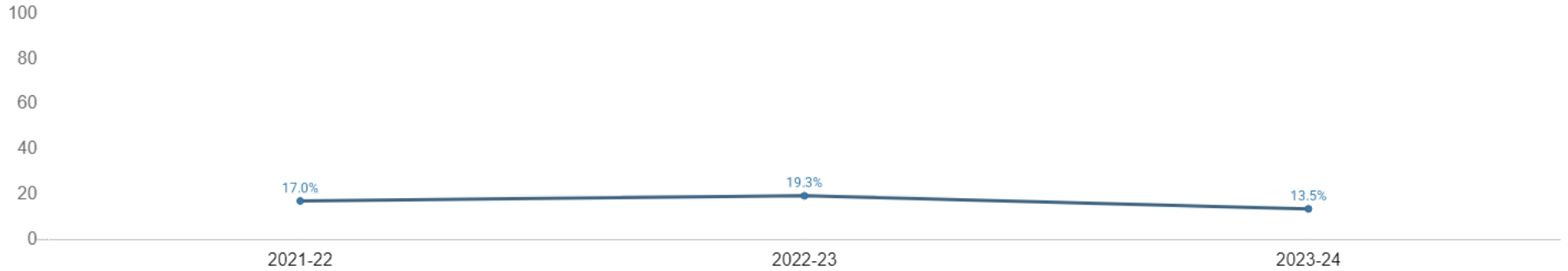

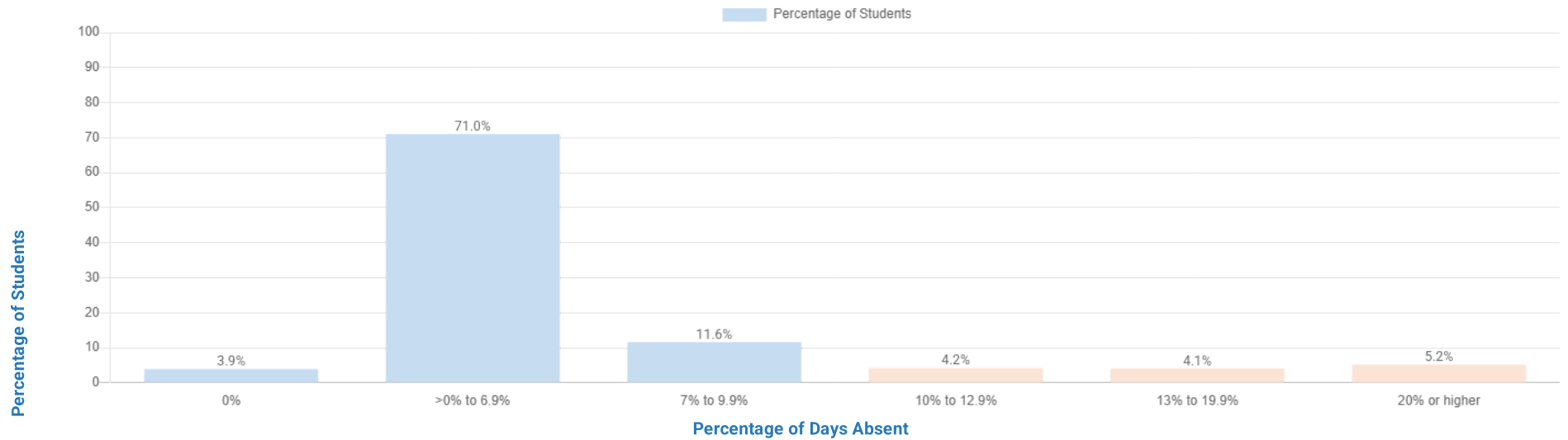

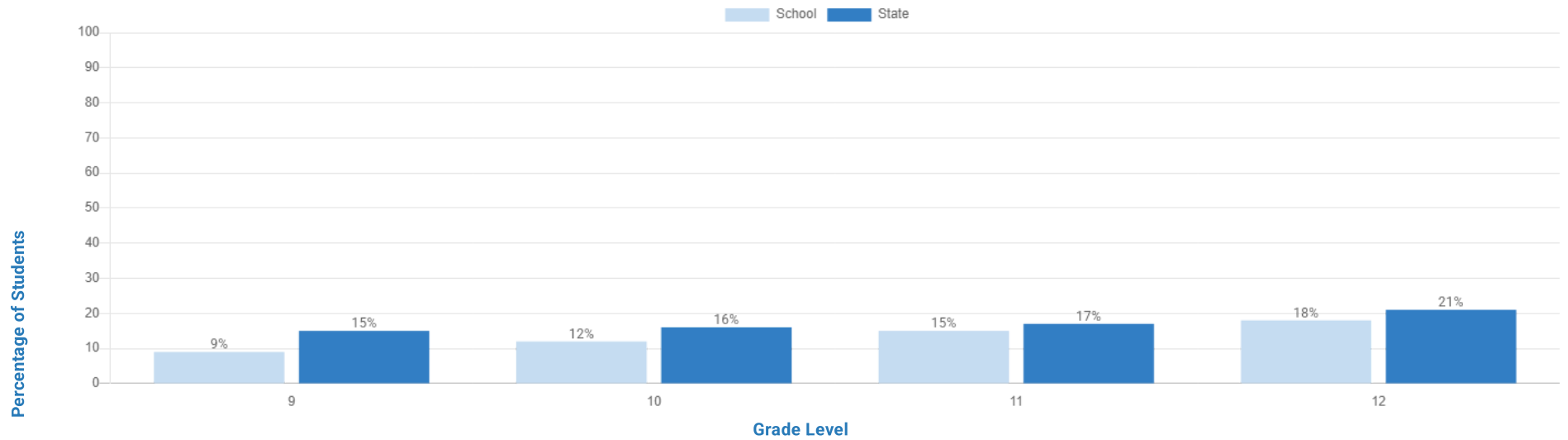

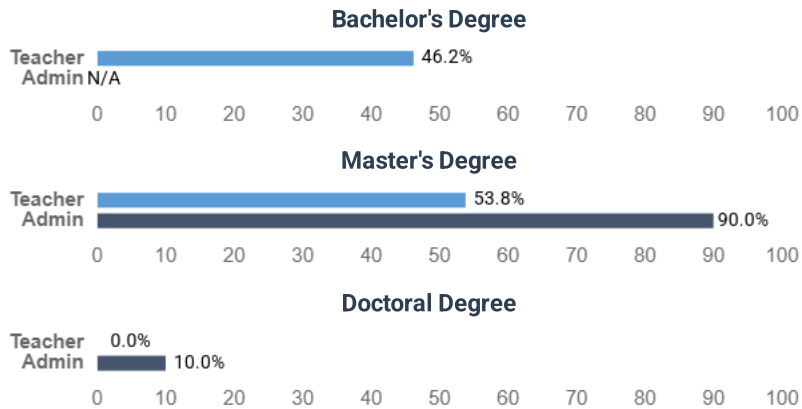

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Courses, Curriculum, Instruction:

Advanced Placement exams in 28 subjects. Overall, 71% of the tests resulted in grades of 3 or higher, and 136 students were recognized as AP Scholars, scoring 3 or higher on 3 or more AP tests. Additionally, Mainland had 13 students earn the AP Capstone Diploma. Mainland does not report class rank but does recognize students for academic achievement using a cumulative weighted GPA. In 2024, over 50% of our graduates had a weighted GPA of 4.0 or higher. In addition, MRHS offers more than 25 dual enrollment courses with colleges/universities.



Sports and Athletics:

Mainland Regional High School teachers are available each morning before school for additional support for students who may need time outside the school day from 7:25 - 8:00 AM. They are also able to provide more time on content after school hours by appointment.



Staff and Professional Learning:

Mainland Regional High School believes that quality Professional Learning that supports the goals of our Strategic Plan, as well as the core mission of the school, are the best way to provide an exceptional scholastic environment that exceeds the New Jersey Student Learning Standards. In order to prepare our staff to meet the needs of all students in a globally connected society, we continue to implement evidence-based learning strategies as part of our use of Solution Tree's PLC@Work framework. This research-based process will help us build efficient, collaborative teams to improve student learning outcomes. Our Professional Development Plan includes instructional best practices, building capacity in the use of digital tools such as the Microsoft 365 and AI, to support student learning.



Postsecondary Information:

Mainland Regional High School is a destination high school for students and parents due to the success of our post-secondary planning support and programs. We are proud that 70% of the Class of 2024 enrolled in a four-year college or university with an additional 9% enrolling in a two-year college bringing the total percentage of students enrolling in college to 79%. The remaining 21% enrolled in a career and technical school, entered the workforce, or enlisted in the military. Our college acceptance rate for the Class of 2024 was over 80% and students were accepted to over 150 different institutions of higher education, including some of the most selective colleges in the country. Our school offers the ACT and SAT throughout the school year. We administer the PSAT to all sophomores and juniors each school year. MRHS hosts an Instant Decision Day for 12th grade students that resulted in more than 120 college acceptances and over \$5 million dollars in scholarships.

Student Supports and Services:

MRHS's "Economic Toolkit" for stakeholders contains information on free/reduced lunch, college testing and application fee waivers, AP testing, scholarships, and academic tutoring. The Toolkit also includes links to health and social services offered to County residents including discounted prescription and dental cards. MRHS's Child Study Team (CST), Student Assistance Counselor (SAC), Intervention & Referral Services Team (I&RS), Social Emotional Learning Coordinator, Homelessness Liaison, Wellness Team, and School Counseling Department work in concert to support the diverse needs of students. In addition, the High School's instructional schedule provides an academic support period (MTSS) for students.



Student Health and Wellness:

The Wellness Team at Mainland Regional High School provides support to all students. They offer in-school support addressing social, emotional, academic, and behavioral needs. The team collaborates closely with Child Study Team Case Managers to tailor assistance for students with Individualized Education Programs (IEPs) and serves as case managers for those referred to Intervention and Referral Services (I&RS). They also ensure thorough documentation of counseling services and consultations, actively participate in professional learning communities, and serve as McKinney-Vento liaisons to address the needs of homeless students. The Wellness Team's goal is to foster a healthy, inclusive school environment by balancing wellness support with academic priorities.



Parent and Community Involvement:

The Mainland Regional Education Foundation (MREF) annually holds the "Community Counts" event to recognize a community member from each sending District whose actions and efforts have had a positive impact. In addition, the High School's parent-driven After-Prom brings the school and community together to provide a safe post-prom party for students. The Infinite Campus parent-portal provides access to student's information such as grades, assignments, attendance and important District messages. We also provide our families with multiple presentations and workshops on topics related to post-secondary planning, such as, financial aid, the college search, college applications, career and technical schools, and military options through the School Counseling/Guidance Department. In addition, many parents/guardians are involved in booster groups/parent organizations that support our extra-curricular and athletic programs.

Facilities:

Mainland Regional High School is a one building campus that was completely renovated in the past decade and now boasts instructional technology in every classroom and a state-of-the-art wireless network. Our building includes a modern aquatic center and spacious weight room in addition to the updated traditional social and academic spaces in the building. The building is air conditioned, and the air ventilation system has been updated to meet the standards for healthy and clean air. In response to the Covid-19 pandemic, we have equipped the building with hand sanitizers, sneeze guards, disinfectant wipes and our maintenance staff engage in daily enhanced cleaning and disinfectant cleaning practices.



School Safety:

Mainland Regional High School has a Class III Linwood Police Officer on staff as well as a School Safety Specialist that directs full and part-time security staffing for events. The District's School Safety Specialist also oversees the implementation of the District's safety and security procedures. In addition, the District has a Safety and Security Advisory Committee, comprised of local members of law enforcement, that review and make recommendations to the High School's Safety and Security Procedures. The High School also has a security vestibule, access control system, security cameras and a security alarm system.



Technology and STEM:

Mainland Regional High School utilizes the Microsoft 365 for Education platform and our SIS, Infinite Campus, as the backbone to our digital learning experiences. We are also a Certiport Testing Center, allowing us to provide opportunities for students to earn industry-valued credentials across multiple disciplines. We continue to expand our offerings in this area, with the addition of classes such as Bike Tech, AI, and Gaming Concepts. In order to continue to advance the use of technology here at Mainland, the District is fully 1:1 with every student and teacher being provided a district owned device. Every classroom has an Epson projector. Numerous clubs offer STEM activities outside the school day as well.
