
















English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 

Mathematics Assessment - Participation and Performance

This table shows performance on statewide assessments for mathematics both overall and by student group. It includes the results of students taking both the NJSLA and DLM. NJSLA results include students taking end-of-grade assessments in grades 3 through 8, as well as end-of-course assessments (Algebra I, Geometry, Algebra II) in middle school and high school. High school mathematics assessment results include all results for Algebra I and Geometry and/or Algebra II results only for students who took Algebra I in middle school and who are enrolled in their first high school mathematics course that corresponds to an end-of-course assessment. Students who were enrolled for less than half a school year are excluded from performance results. Student are considered to have met or exceeded expectations if they score at Level 4 or 5 on the NJSLA or at Level 3 or 4 on the DLM assessment.







Students enrolled in one or more classes by discipline:











Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Courses, Curriculum, Instruction:

Beginning with a strong foundation for our Math and Language Arts programs, adhering to teaching the state standards, we also offer Gifted and Talented, electronic text availability, consistent teacher support through Remind and Class DoJo, strong parent communication and access to multiple online academic supports. We provide ongoing progress monitoring and individualized goal and growth tracking not only for the core content, but most supported areas.



Clubs and Activities:

IntraMural Sports is offered, in addition to Garden Club, Art Club, STEAM Club, and Mathletes.



Before and After School Programs:

All students are offered daily participation in the Student Assistance Child Care program, for before-school care and after-school care, which includes physical activity and access to technology. In addition, the Community Education program offers all students classes for Cooking, Karate, Theater, Dance, Art, and Invention.

Staff and Professional Learning:

Professional Development opportunities were offered all staff during site in-service days. Staff identified specific personal areas of weakness for growth and professional development. Articulation occurred weekly on Team and Grade Levels, in addition to both horizontal & vertical school grade articulation, for discussing ideas and for sharing and tracking student growth and development. The School Improvement Panel reviewed teacher observations and made recommendations for further Prof Dev, which at this time includes additional training on instructing students from varying cultures & its impact on their academics and growth. Applicable teachers & staff members also attended their conferences supporting their specific jobs (Guidance, Nurses, CST).



Student Supports and Services:

Our English Language Learners are supported individually 40 minutes daily, for all content areas, including Language Arts. Basic Skills students receive full support and targeted remediation for entire Math and Language Arts classes. Classified students receive all applicable supports and interventions, including OT, PT, Speech, Counseling, and social/emotional support. The New Jersey Tiered System of Supports program allows for the documentation of student need, applied tiered interventions, growth and academic goals, tracking documentation, and progress monitoring. Consistent conversations about students allows for ongoing altering of programming, as needed. Teachers consistently provide homework and tutoring supports, above and beyond the classroom. Our BCBA is also available to teachers for the development and tracking of behavior charts and learning growth programming.



Student Health and Wellness:

Students are provided healthy choices in breakfast, lunch, and snacks. These choices have been reviewed & revised with input from parents, students, professionals (Chef), NutriServe, & staff. Students receive outside recess daily, classroom brain breaks, class & grade-level activities, physical education classes, & other forms of physical activity per day & week. New this year is a preschool playground to supplement the sensory room with equipment designed to allow students to receive a rich sensory diet on a daily basis through inclusion in the classroom curriculum. We have a student-driven managed garden, & two courtyards managed by the students, with sensory materials and walkways. We participate in AtlantiCare Healthy activities, such as monthly walks, bike to school, green mustache, cooking videos, & much more. Also, we complete the Student Health Index yearly.

The Parent and Teacher Organization provides parents and community members to be involved in supporting the children of the community. In addition, parents and community members can volunteer in the school Library, STEAM Lab, Book Fair, Holiday Shoppe, classroom, and the school, after attending a Visitor and Volunteer Training. Classrooms have partnered with community members and business. The organization visits the classrooms, explaining their town business, and partnering for class and student activities. Community Members are also participating and are active members in the school: Wellness Committee, Safety Committee, School Culture and Climate Committee, School Improvement Panel, Early Childhood Committee, Teacher of the Year Committee, Garden Club, Art Club, and much more.



Climate Surveys:

Is a Climate Survey Used: Yes; Who is surveyed: Students, Parents, Teachers. Surveys were developed in collaboration with the Rutgers School Improvement Project (SCIP). Following administration of the surveys, adjustments were made in consultation with SCIP to better address school needs.



Facilities:

Our school was built in 1998. The Northfield Community School is a one building campus that houses the Northfield Community Elementary School on the first floor and the Northfield Community Middle School located on the second floor. The Library, STEAM Lab, Art Room, Music Room, Gymnasium, Sensory Room, Magnetic Wall, Lego Wall, Sensory Walls, Duplo Wall, Wall of Gears, Creative Workshop, Lock Wall, Gardens, and 2 Courtyards are located on the ground floor. The building is air conditioned and underwent an HVAC upgrade in the summer of 2024 to improve performance and efficiencies.

School Safety:

Student safety is of the utmost importance. When a child enters the school, they need to feel cared-for and safe. Our school Safety Committee meets 3-4 times per year, and includes all community stakeholders. All doors are locked at all times, there is the police-recommended one main entry into the school, with a sign-in procedure with photo and ID check. All staff members wear their school-issued ID at all times. Students are well-trained on emergency procedures. Our required School Safety Drills are conducted monthly. In addition, our School Climate Committee works on student interactions and positive student behavior, character development, and social skills. Parent communication is re-enforced and parents are involved in safety decisions.



Technology and STEM:

All lessons incorporate technology. Each classroom has a SmartBoard/Epson/Smart TV, in addition to each child having access to their 1-1 ChromeBook, iPads, and Streaming laptops. Hotspots are also provided to homes, as are most technology needs to the students and families. Students receive STEAM Lab instruction in a highly-stocked classroom. The program includes engineering, coding, robotics, and Art structure. We have dozens of coding robots, drones, and jumping robots. We offer a before-school and after-school robotics and coding class. The students are offered the opportunity to enroll in competitions for coding, design, Lego, and structures.



Early Childhood Education:

Our Community PreSchool programming, for 3 and 4 year-olds, funded through PEA, is full-day, offering a program with small class sizes, a highly qualified teacher, a strong curriculum, an individual classroom aide, creative and an abundance of classroom and individualized materials, progress monitoring, screenings, and strong parent communication.

ESSER funds were utilized to support the instructional programs as permitted by grant rules. Examples of use of funds to address learning loss includes the offering of afterschool tutoring in language arts and math for grades K-8 and throughout the summer. Mental health supports were also offered throughout the summer with the availability of counselling for students in all grade levels.
