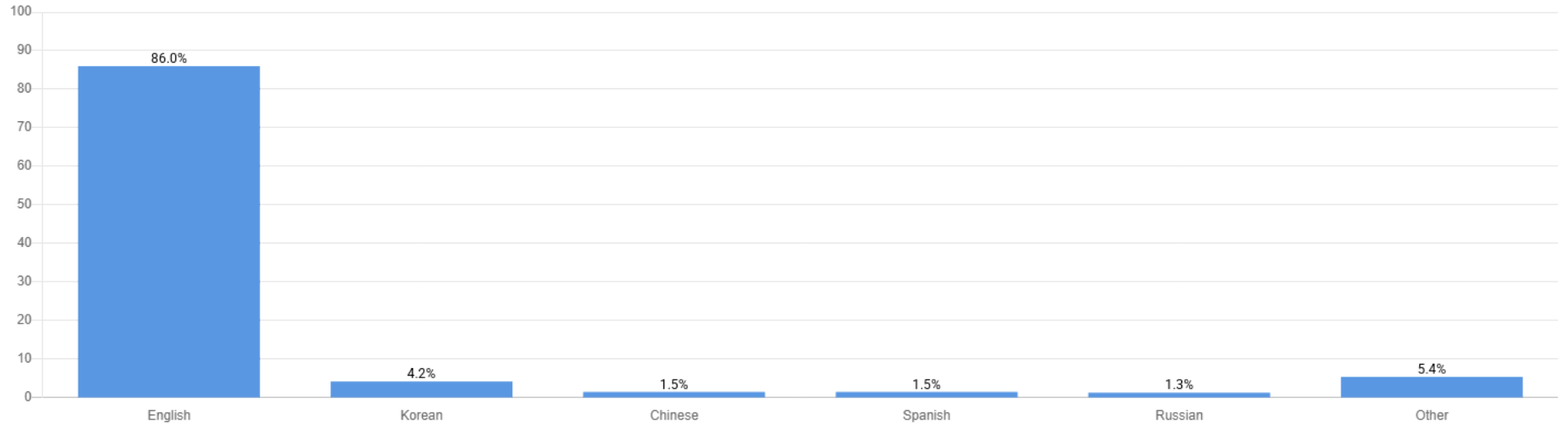

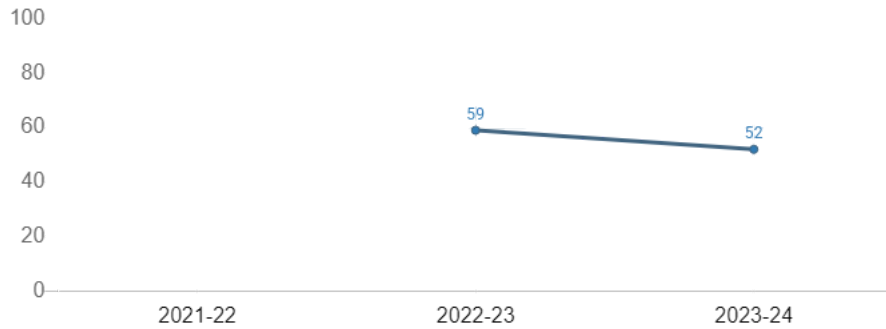

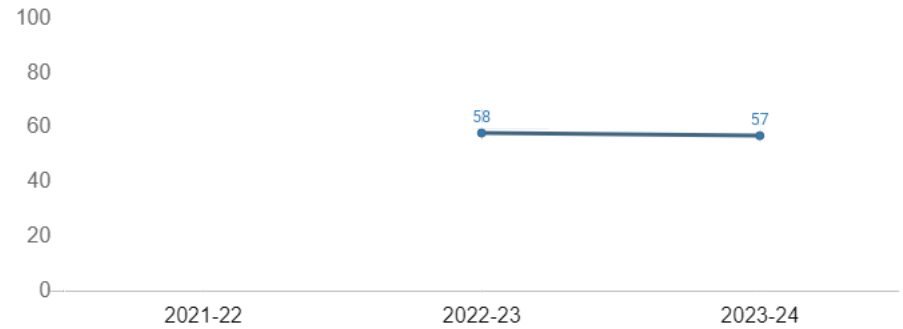

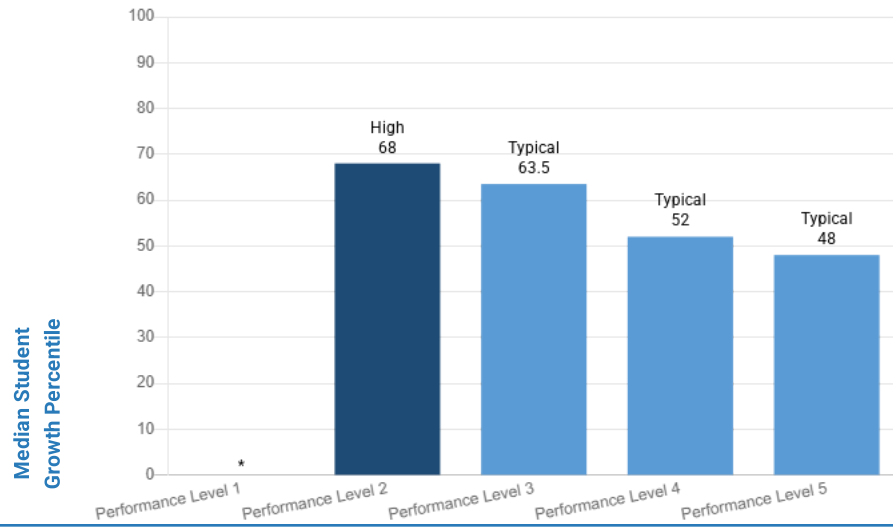

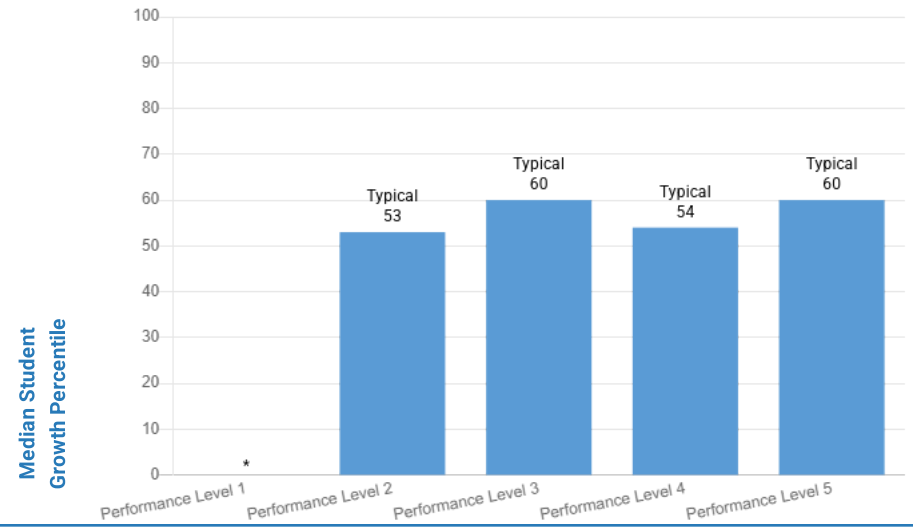

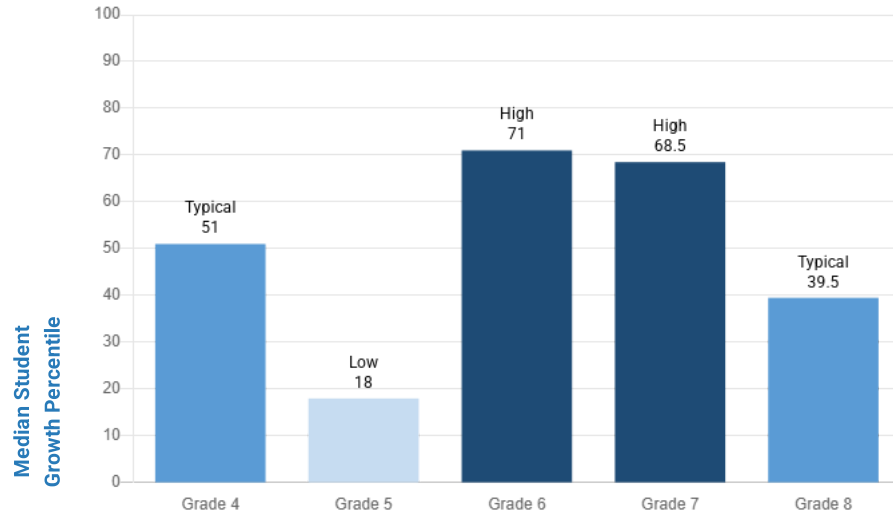

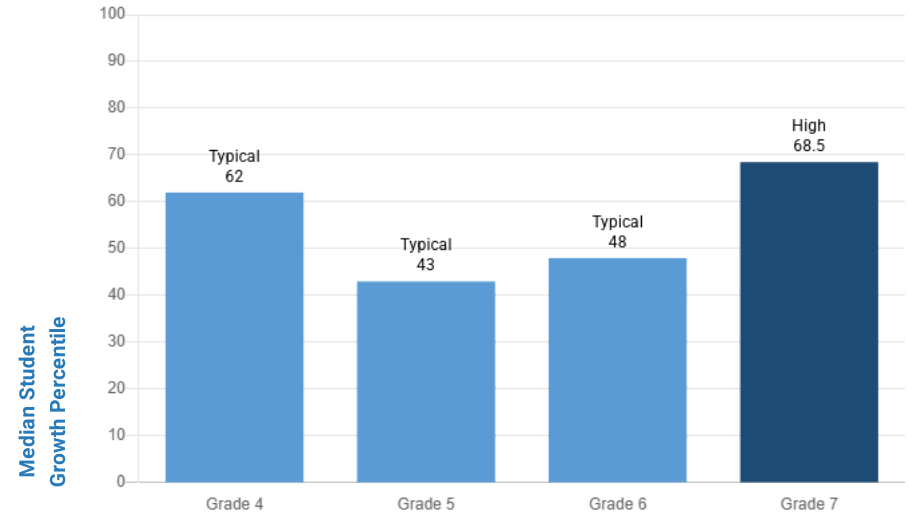

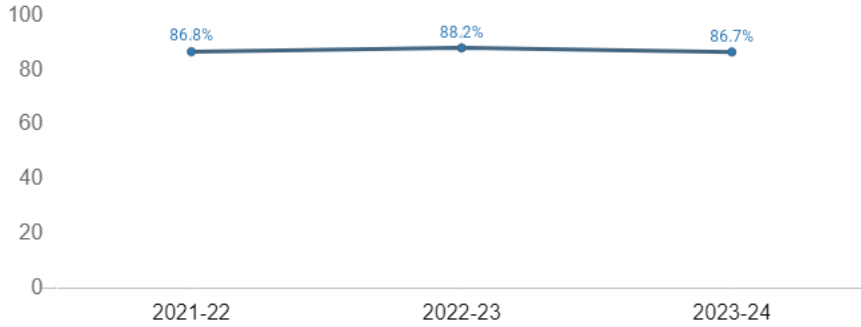

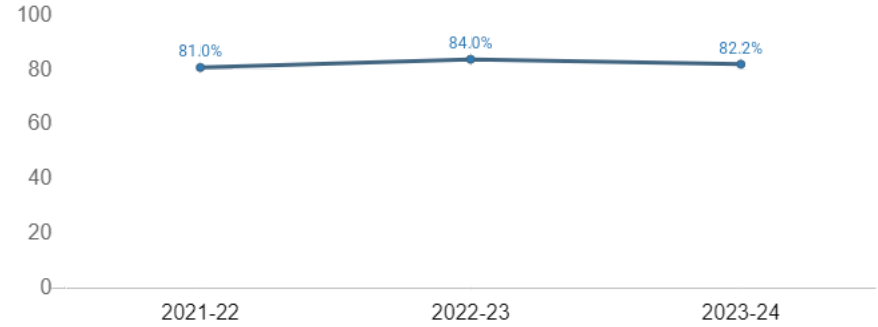
English Language Arts and Mathematics Performance Trends

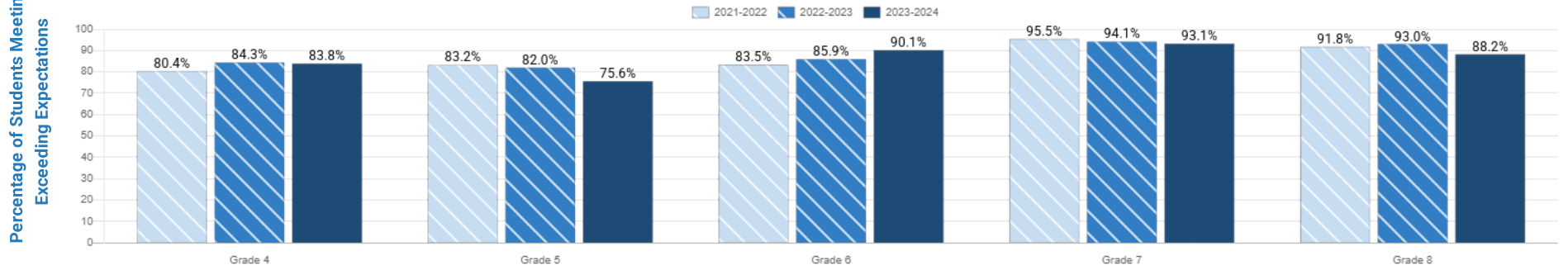

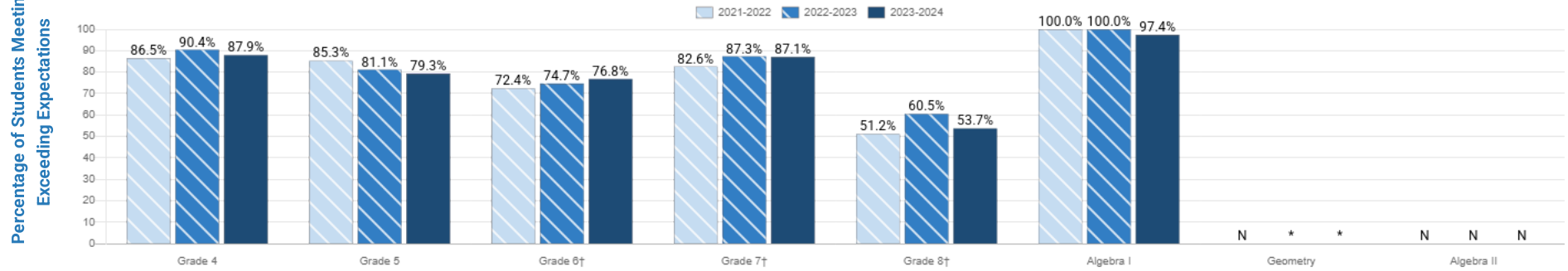

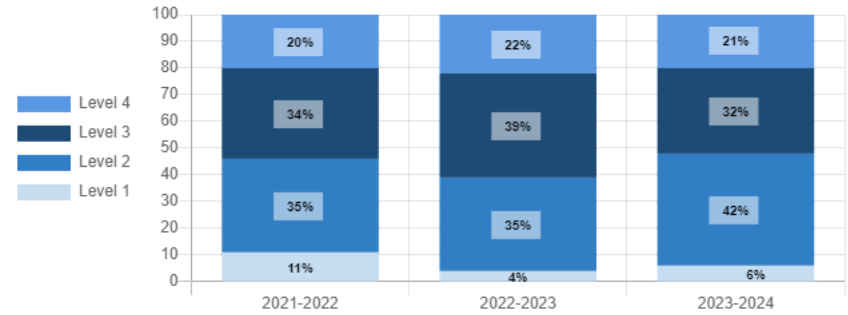

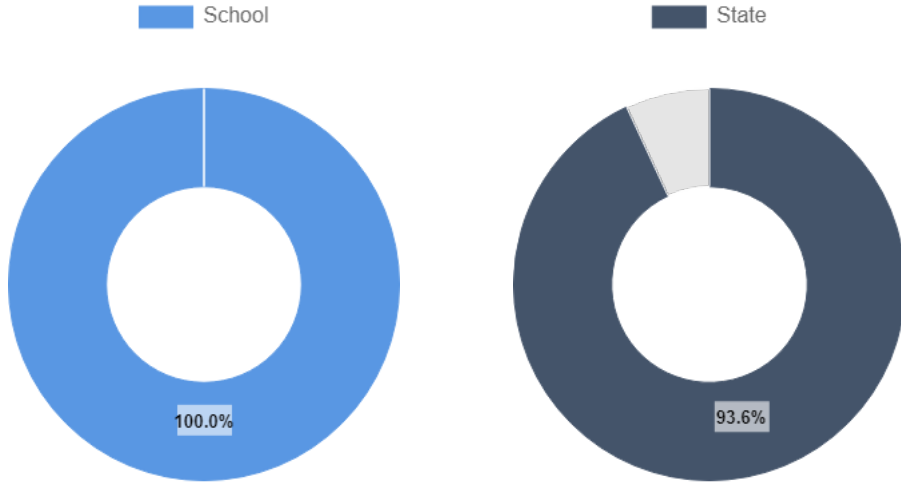

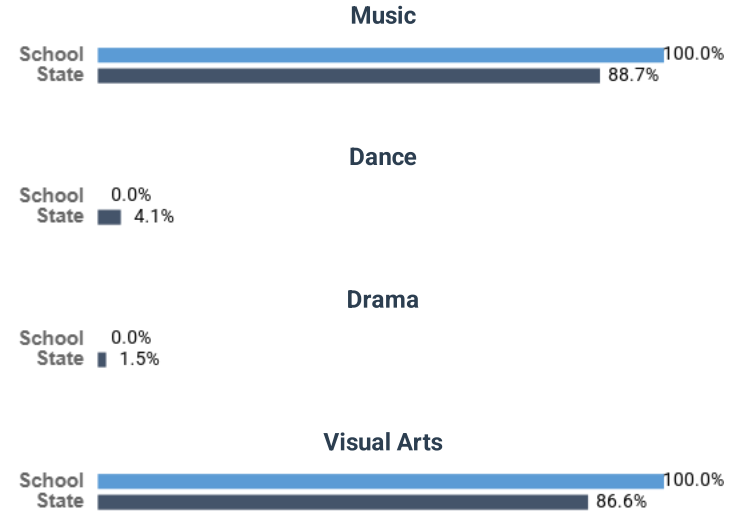

Students enrolled in one or more classes by discipline:



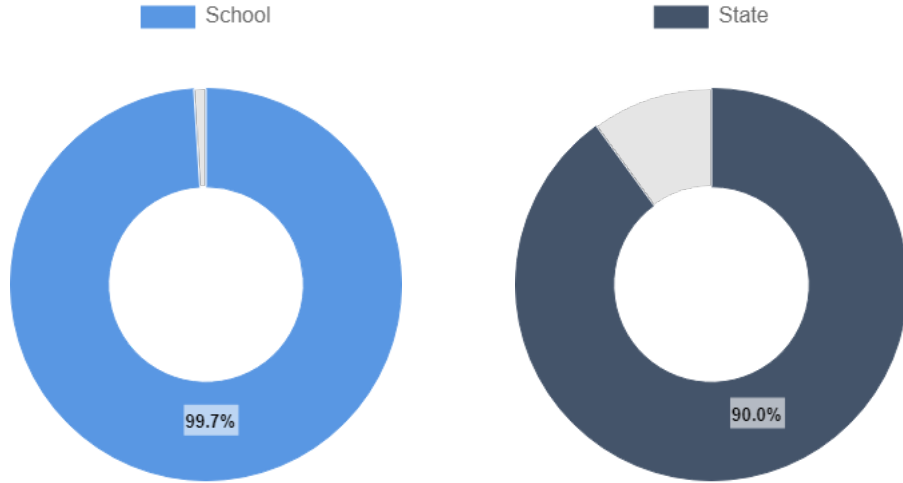

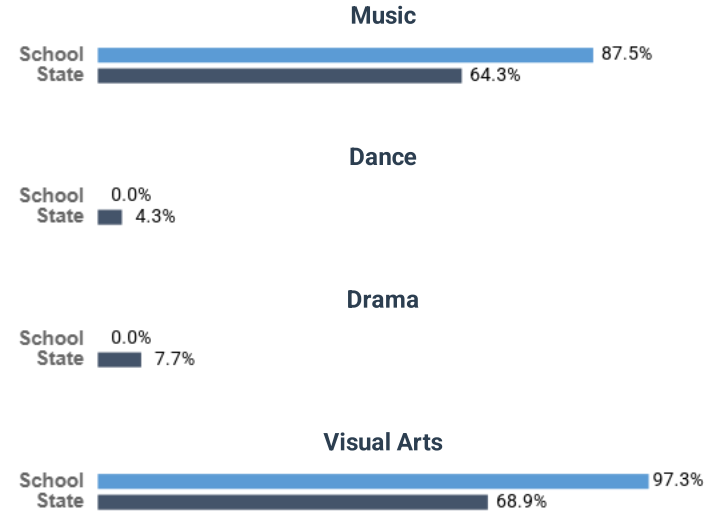

Students enrolled in one or more classes by discipline:



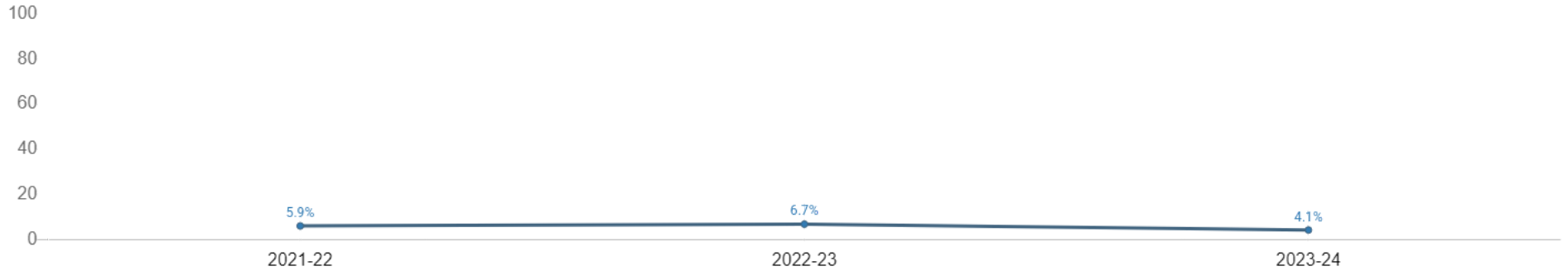

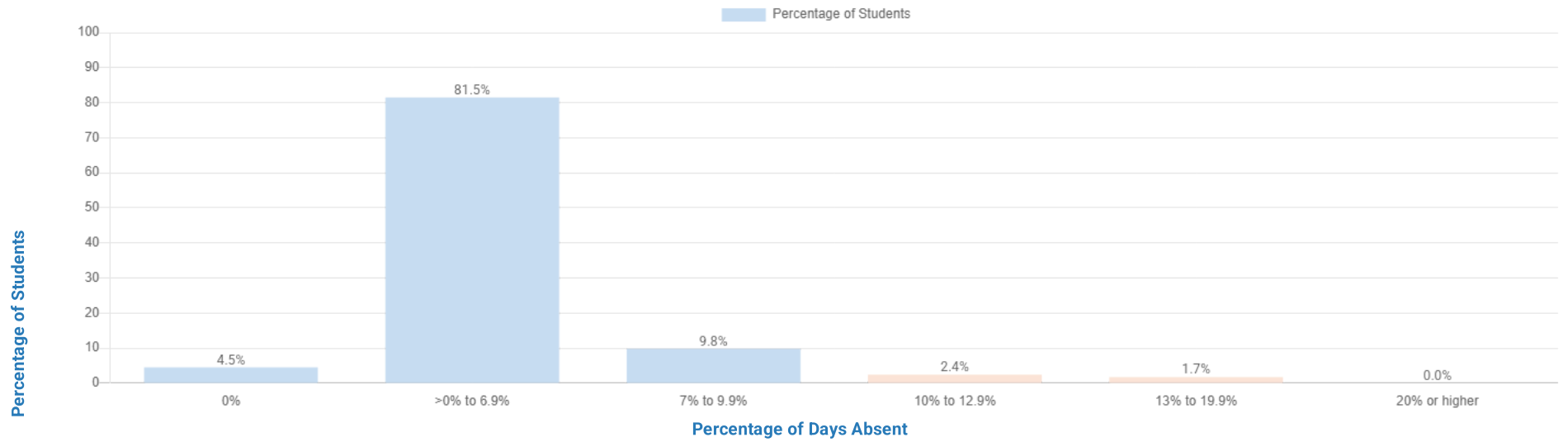

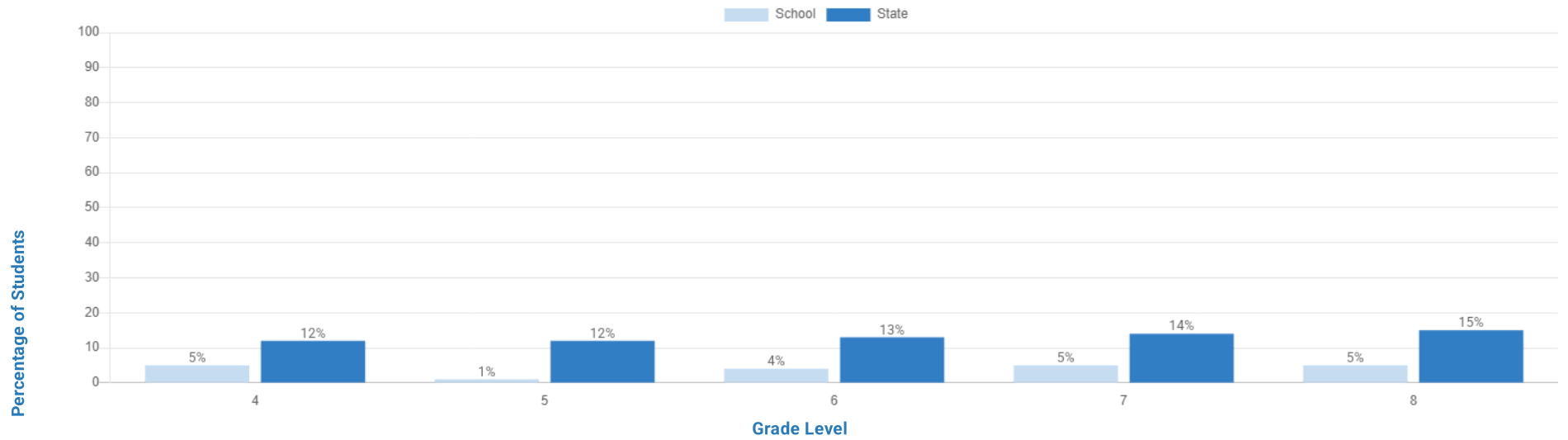

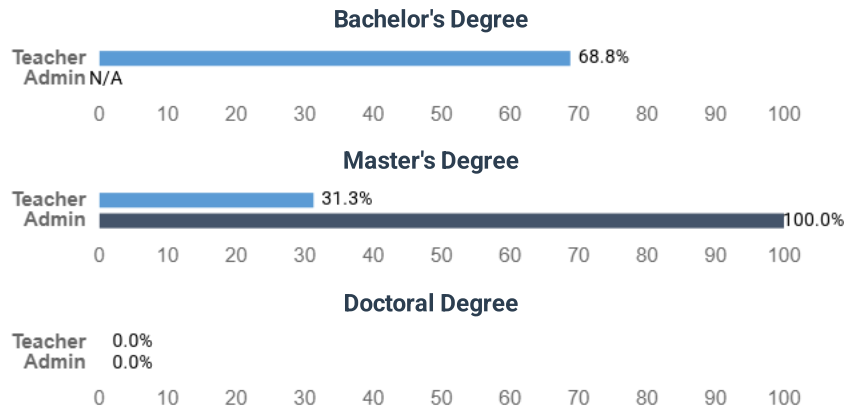

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Brookside focuses on developing the whole child. Academically, we are very successful. Brookside students consistently perform exceptionally well on objective assessments. This year, even though our scores continue to be very strong, we are revisiting the focus on reading and writing in the content areas. This signifies our desire to continue our strong performance and not to rest on our successes.



Awards, Recognition, Accomplishments:

One of the top performing schools in the state according to SchoolDigger.com. \$200,000 grant from Allendale Foundation for Educational Excellence used to design new primary school playground. The students at Brookside were a large part of creating the vision for the final project. Completion of two three new student designed spaces: the cafeteria, the outdoor eating area, and the new Student Center/eSports space.

Courses, Curriculum, Instruction:

In addition to the traditional required courses, Brookside offers a plethora of courses designed to expose children to different careers and ways of thinking. Over 80% of Brookside students are part of the music program (band, chorus or both). In addition, students get experience with art, computer science and engineering. As 8th graders, Brookside students are encouraged to explore their interests and choose multiple courses from up to 11 electives to develop those interests and talents. One area of significant strength is the infusion of traditional gifted and talented curricula throughout the curriculum for all students. 4th and 5th graders are exposed to robotics through Lego Robotics, which expands past the prescribed program into activities such as robot wars. 6th and 7th graders get to work in the Innovation Lab to create MagLev cars and Hydraulic Arms respectively. 8th graders have a myriad of choices for electives, including 8th grade project, an independent study course.



Sports and Athletics:

Sports Offered: Baseball (Boys), Basketball (Boys & Girls), Cross Country (Boys & Girls), Soccer (Boys & Girls), Softball (Girls), Track and Field - Spring (Boys & Girls), Volleyball (Girls), Wrestling (Boys & Girls)
A main tenant of Brookside is for students to be part of the community. Interscholastic sports provide a vehicle for this. Brookside students can be part of include soccer, basketball, volleyball, baseball, softball and track and Cross country. Many of Brookside's teams make the playoffs. This is especially laudatory given the relatively mall size of our school for the conference we are in.



Clubs and Activities:

Brookside offers close to 20 clubs designed to involve and engage students. We make a particular effort to offer a diversity of activities so that anyone can pursue an interest. Clubs range from music opportunities such as A Capella, Jazz Band, and Wind Ensemble, to academic competition opportunities including Math Counts and NJ Law Adventure. A few clubs extend past the school walls, including the Environmental Club and the School Store. Finally, there are also socially focused clubs, such as Ping Pong and the student created Games Club. Over the last couple of years, we have supported several student initiated activities including, but not limited to, our Games Club. On a different front, the Student Council is very active in school life. The Principal's Advisory Council meets regularly with the principal to discuss issues of student concern. In addition, Student Council runs sub committees, including School Climate, Fundraising, and Grant Writing.

Before and After School Programs:

Allendale Enrichment Opportunity Program (ALEOOP) offers exciting and fun classes after school and a summer program for any child eligible for enrollment in the Allendale School District. In addition, the WycKoff YMCA offers an after school program for students who need extended supervision.



Staff and Professional Learning:

Brookside staff actively engages in continual learning. Teachers work in grade level teams and collaborate on self-selected topics designed to help enhance and improve student learning. Initiatives this year included word study in 4th grade, 5th grade science curriculum development, and curriculum writing for the Learning Lab. On a weekly basis, grade level teams meet to collaboratively plan, review student work and develop action plans to address individual student needs. Twice a month, teachers participate in after school PD and often work in departments to analyze student work and collaboratively plan.



Student Supports and Services:

Special Education teachers and the Child Study Team work with each grade level team to provide support for students with special needs. Additional support is available for all students through extra help with regular classroom teachers, through focused groups with the school counselor, and with our ASP and Study Skills classes. The school counselors and the principal also work with students frequently to insure positive academic achievement and characteristics.

Student Health and Wellness:

With the increased prevalence of mental health challenges for students, Brookside's Health and PE Program is undergoing a redesign to further meet the needs of our students. The physical education program, which already emphasizes participation, physical fitness and a growth mindset to activity, will do a curriculum review to infuse more direct instruction and opportunities to practice healthy lifestyles and practices.



Parent and Community Involvement:

Brookside School parents and the Allendale Community have significant entry to, and participation within, the school. Students and parents have online access to calendars, grades and assignments to support each students' needs and interests. The PTO actively promotes events including Field Days, special nights and the Book Fair. Finally, Allendale has a very dynamic Foundation that funds learning and projects, the most recent of which was supporting the development of an updated cafeteria and a new student center.



Facilities:

As with many public schools, Brookside has undergone several renovations and additions in its lifetime. Despite this, the entire building exudes a child centered yet academic atmosphere. Throughout the building, student murals and paintings line the hallways and classrooms are all equipped with Smartboards. Our infrastructure supports our 1 to 1 Chromebook initiative. Finally, our students worked to design new cafeteria space, outdoor eating area, and a new Student Center/Esports room.

Brookside is a 1 to 1 environment. Students in the the 4th grade use the computers appropriately in the classroom, and students in grades 5-8 are responsible to use the devices in and out of school. In addition, STEM itself is incorporated into the curriculum daily. Students use Google Docs, Sheets, Slides and email on a daily basis, and the curriculum itself is designed to find connections between these tools and curricular learning objectives. Finally, we have a strong engineering-based program where students explore both by choice and by design projects related to computer science, robotics, mechanical engineering, electrical engineering and biomedical engineering.

Other Information:

Brookside is a Grade 4-8 school. From a community standpoint, the school functions very much as a single system and events such as our Holiday Sing-A-Long serve to reinforce the intimate nature of the school. Older students relish the opportunity to mentor and interact with the younger students. Despite this small community feel, Brookside hosts a schedule that is directly designed for the developmental level of the child. Fourth graders follow a traditional elementary model working with a single teacher for the majority of the day. Starting in fifth grade, students begin the slow transition towards independence. Fifth graders work in homeroom groups and rotate between teachers. This allows for the emotional support of a common homeroom group, but also get the children used to multiple teachers. It also allows for a higher level of academic discourse in our classrooms. In sixth grade, under the watchful eyes of very attentive teachers, students have their own wing in order to first experience a secondary model. This is also a big year for expanding learning outside the school doors, and 6th graders have the opportunity to go to Orlando Florida to engage in experiential learning at DisneyWorld. Seventh grade begins the transition towards high school level independence, and under the watchful eye of the staff, students are given more options to develop their own styles, interests and processes. This culminates in eighth grade where students experience more choices and diversity in their program, as well as have opportunities to try out some academic and learning experiences to prepare them for high school.
