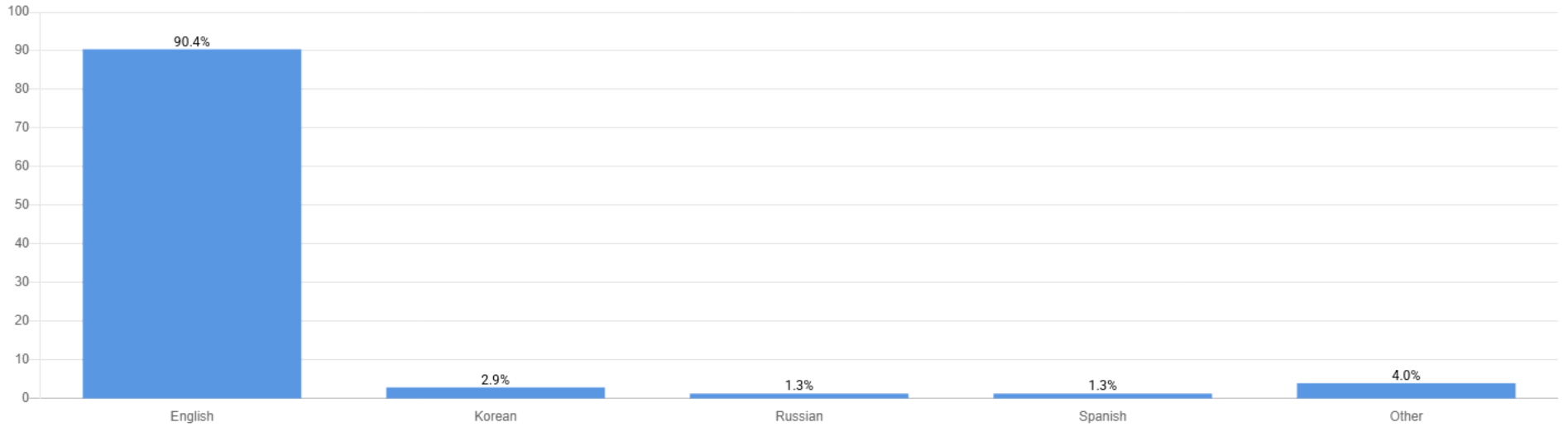

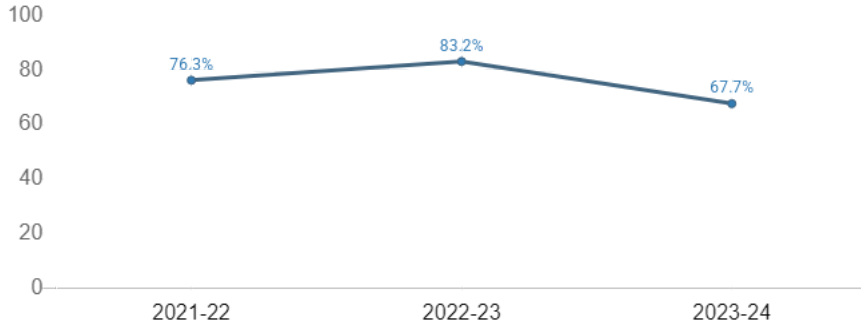

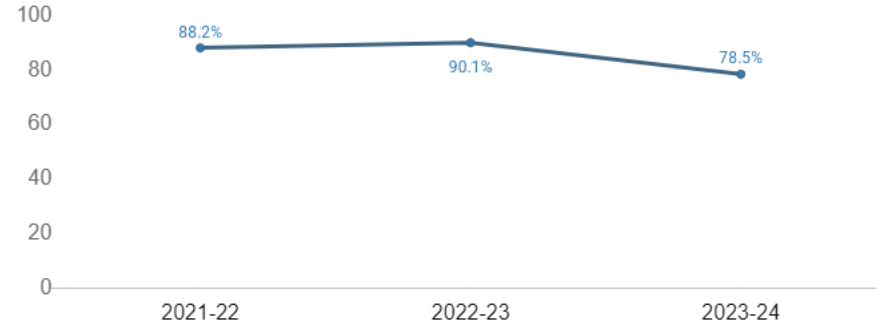
English Language Arts and Mathematics Performance Trends

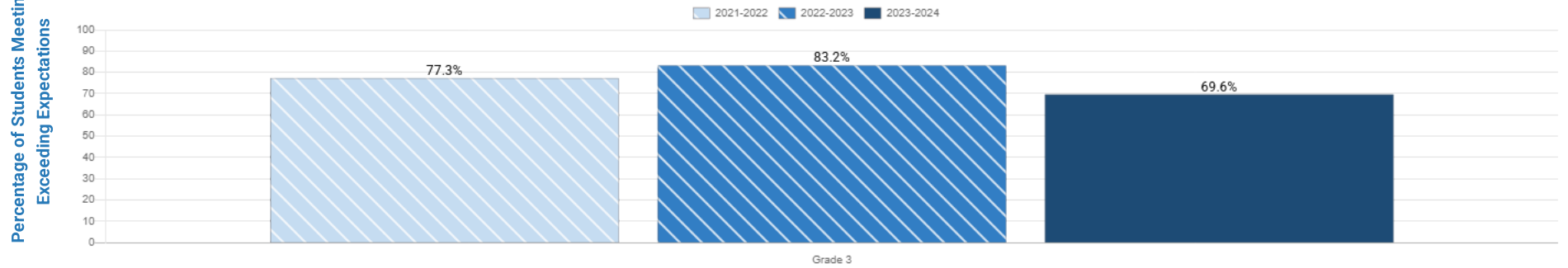

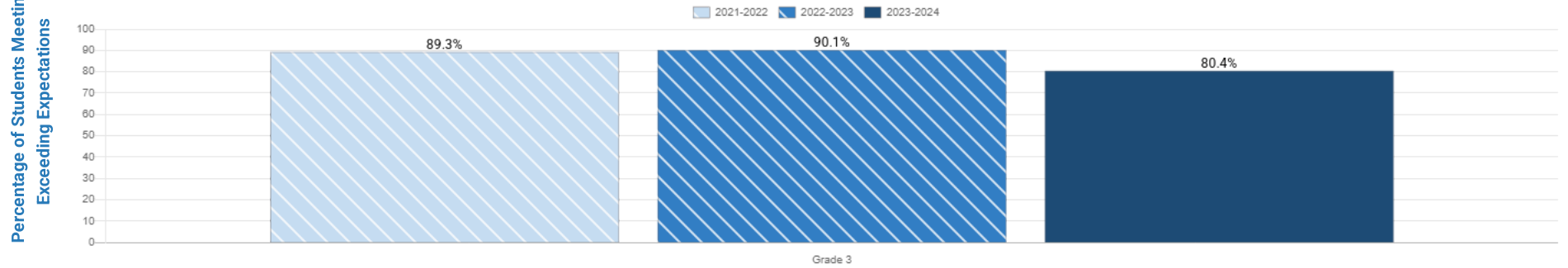

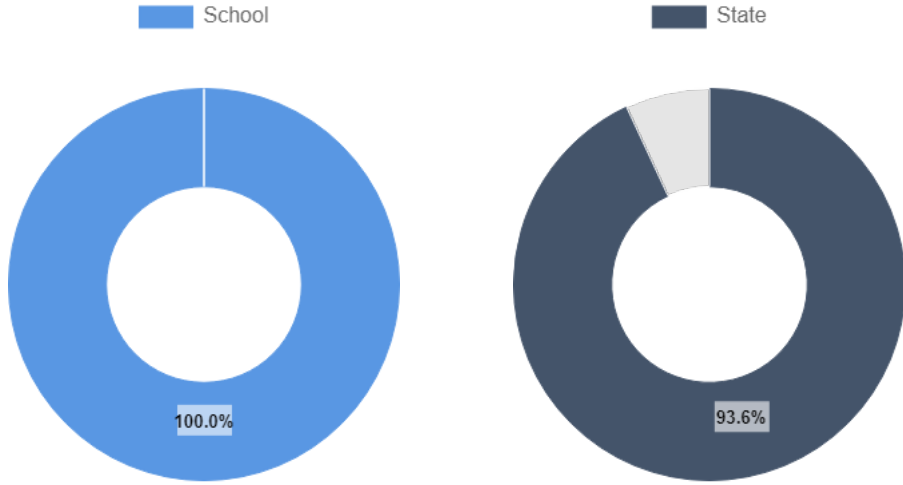

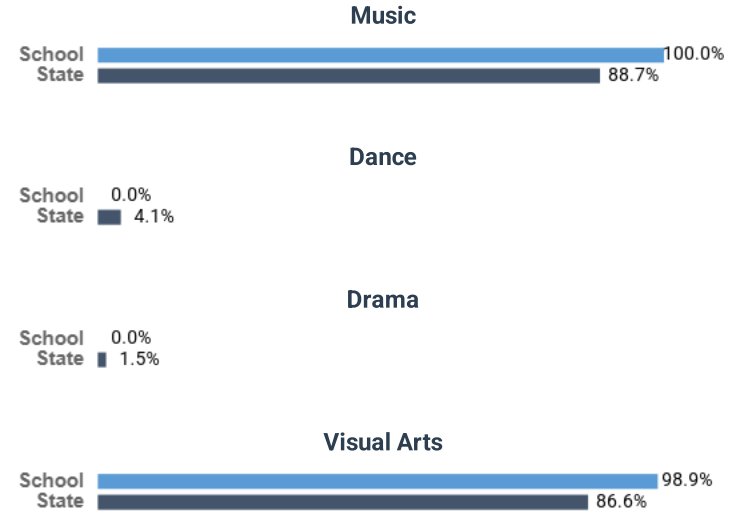

Students enrolled in one or more classes by discipline:



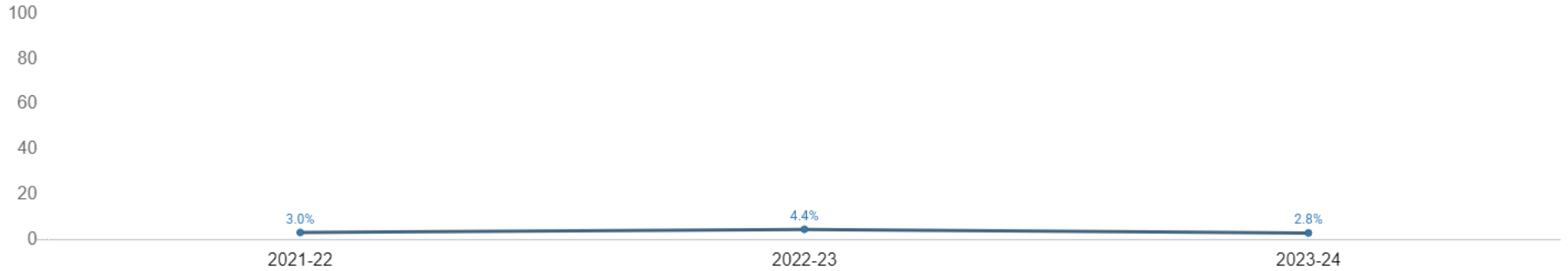
Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.

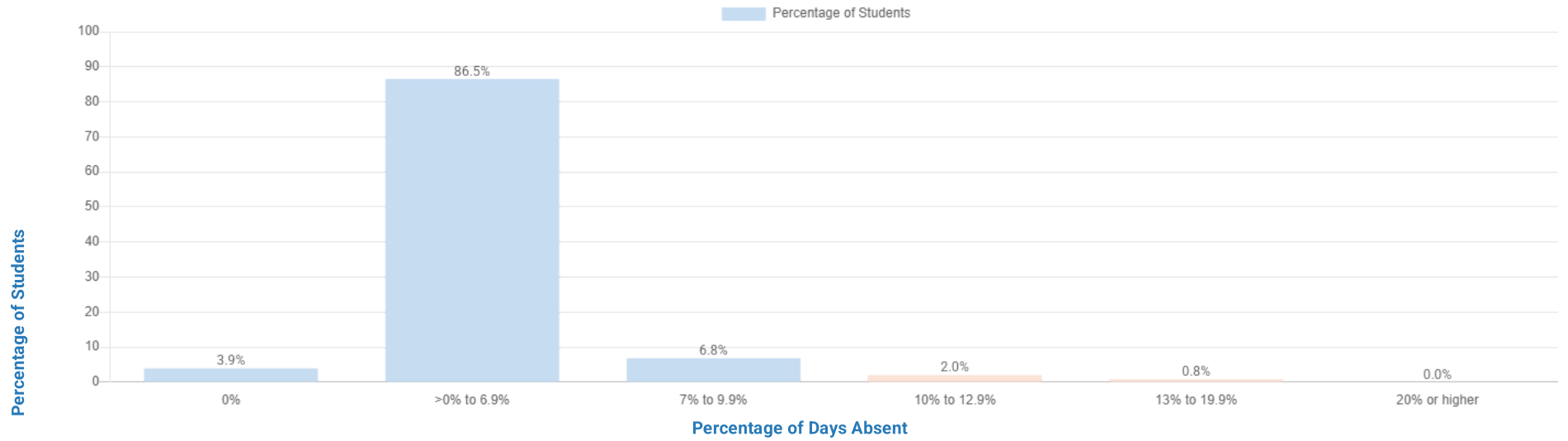

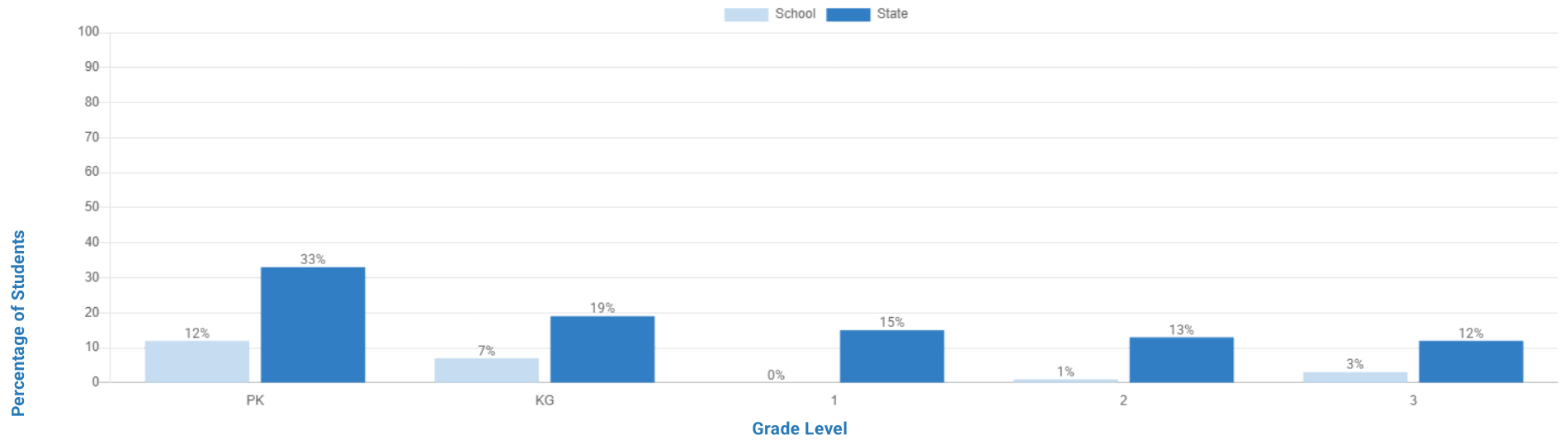

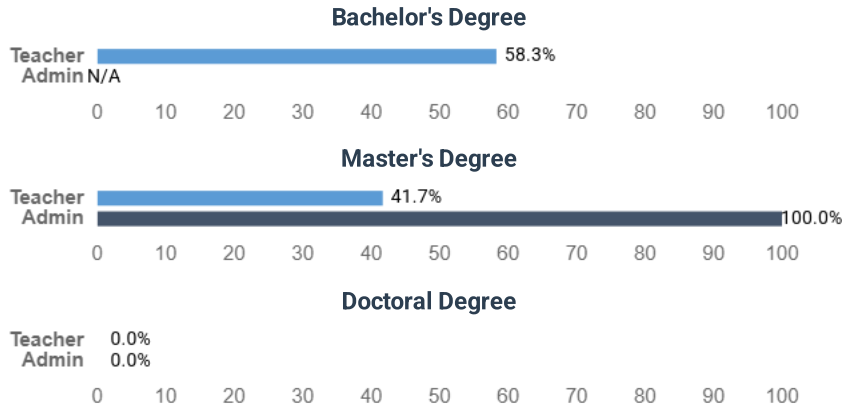

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Courses, Curriculum, Instruction:

The language arts curriculum focuses on developing reading, writing, listening, and speaking skills through a workshop approach, with an emphasis on phonemic awareness, vocabulary building, and comprehension. Our math program stands out for its open-ended, hands-on explorations and continuous practice opportunities. Social studies and science are explored through class discussions, hands-on experiments, and nonfiction reading and writing activities. STEM instruction is provided to all students, offering immersive, hands-on experiences, problem-solving challenges, and engaging experiments.

Staff and Professional Learning:

All staff members have access to diverse professional development opportunities at the school, district, and regional levels. Teachers actively participate in various curriculum committees, and our Professional Development (PD) Committee provides job-embedded training and tailored mini-courses to address staff needs. Many team members have attended the Teachers College Reading and Writing Institutes, and all BSI and special education teachers are trained in the Orton-Gillingham approach. Additionally, the majority of our staff have completed graduate studies in curriculum, learning, and instruction. Our instructional coach supports staff by introducing research-based strategies for enhancing literacy and assessment practices.



Student Supports and Services:

English as a Second Language program, Integrated Preschool Program, tiered Basic Skills Instruction in literacy and numeracy with rigorous benchmarks, multi-sensory reading services, a complete Response to Intervention (RTI) that includes I&RS, and a continuum of special education services. Enrichment instruction is provided to all pupils, and a pull-out Gifted and Talented (G&T) program commences in third grade. A range of special education programs are offered to meet the individualized needs of our students.
