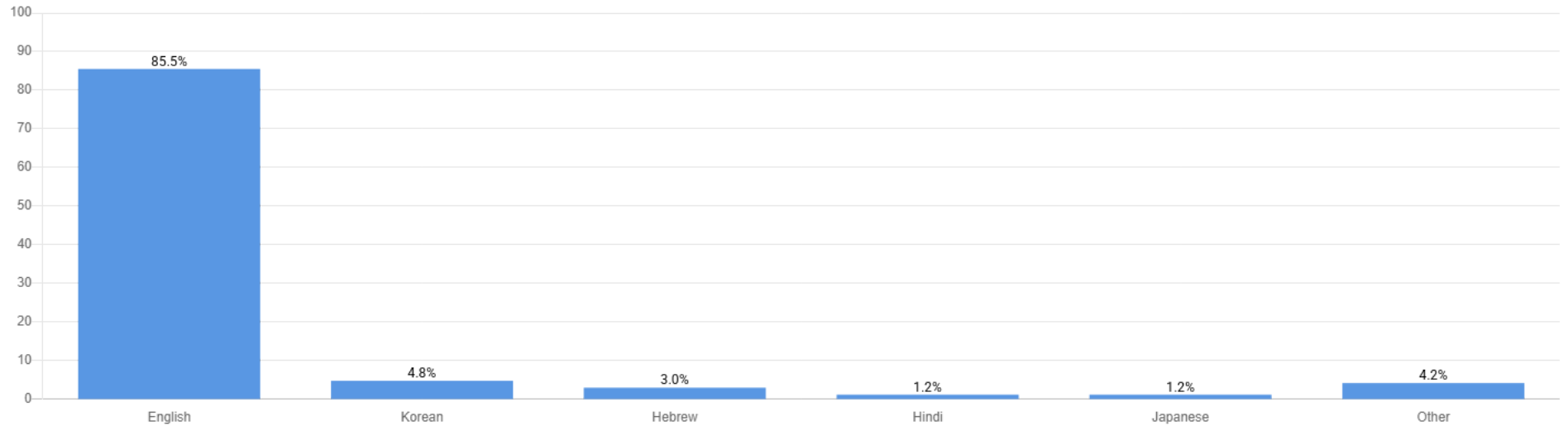

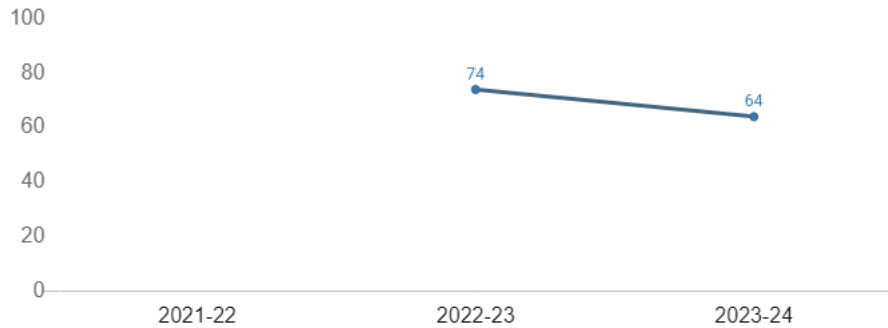

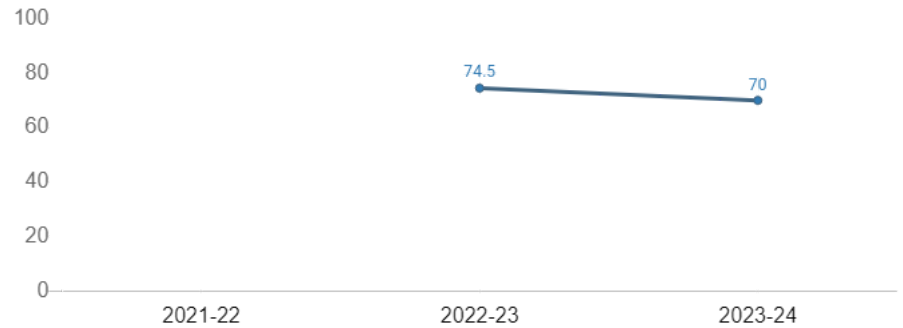

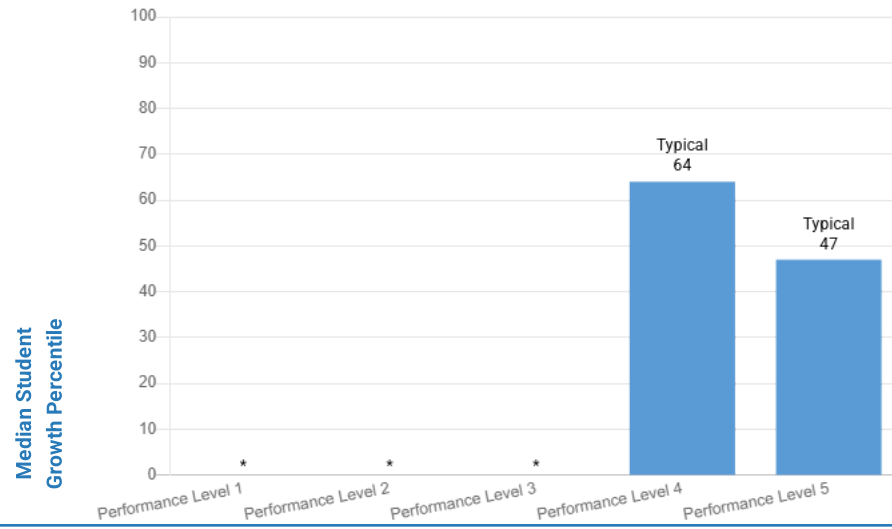

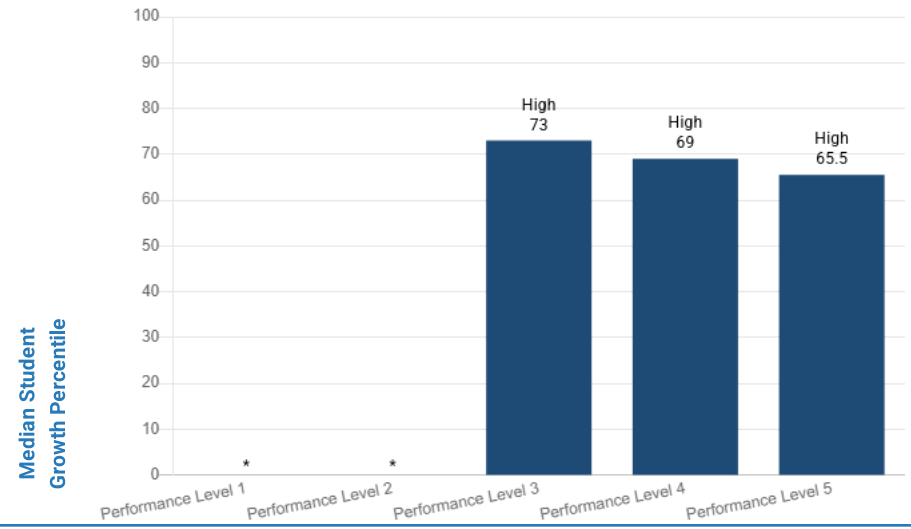

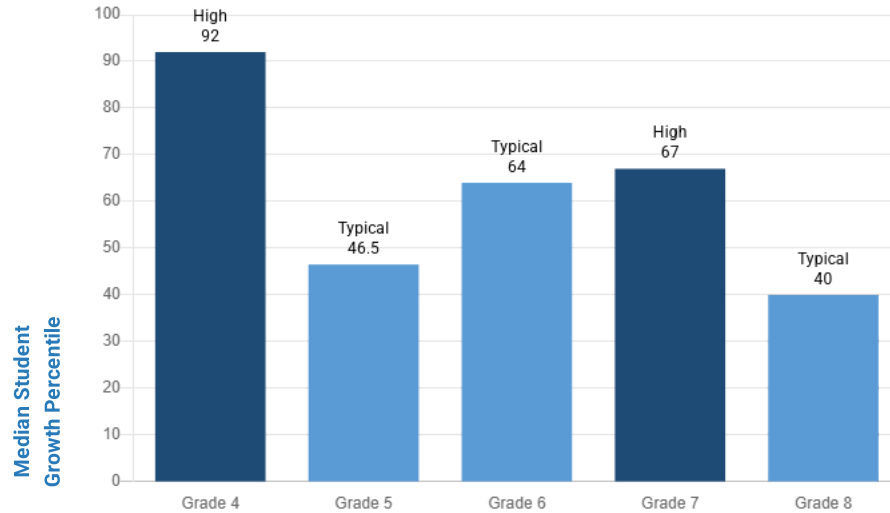

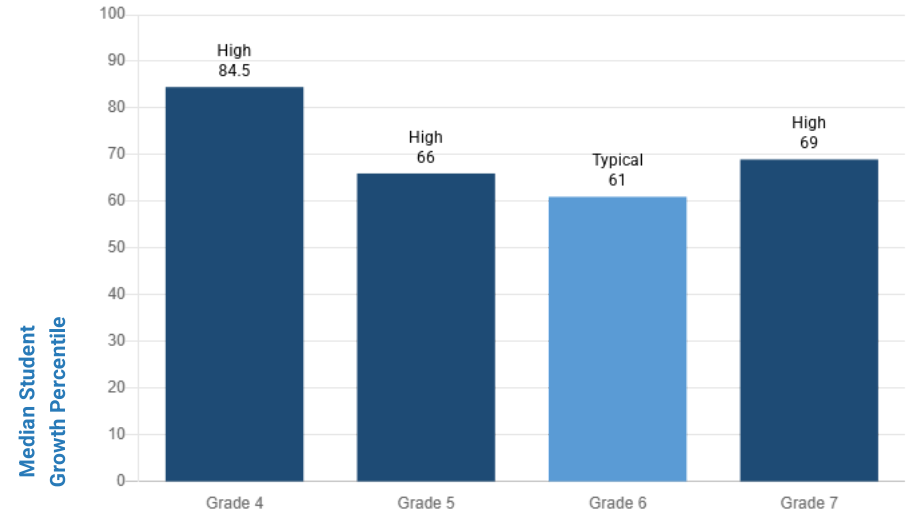

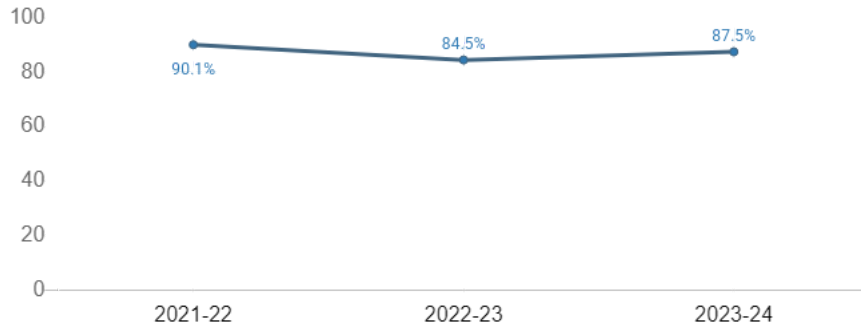

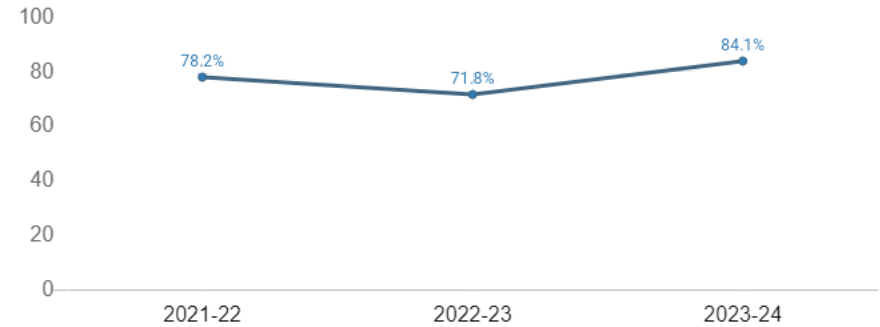
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 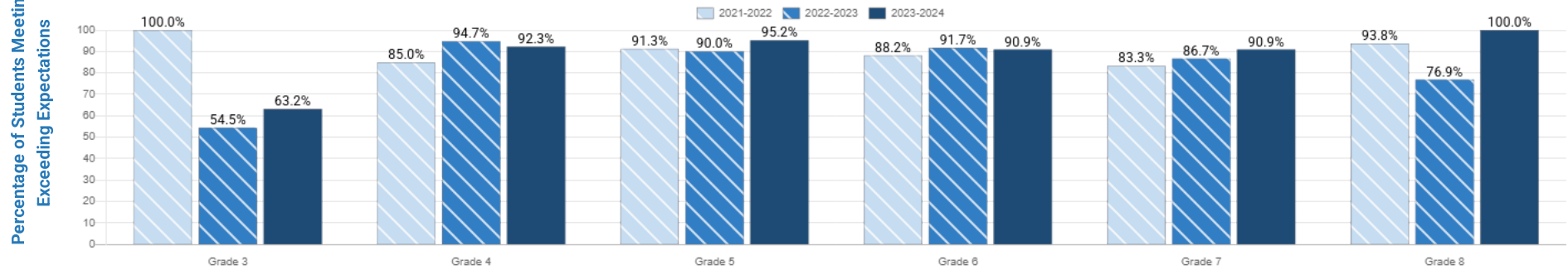

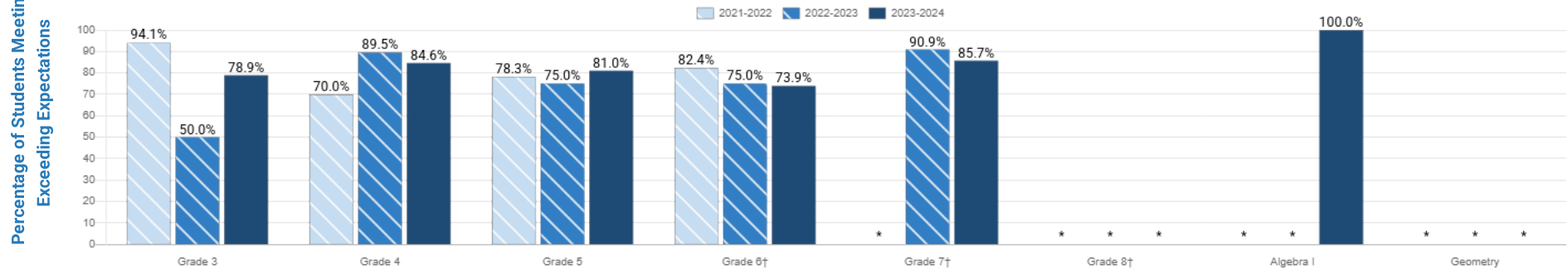

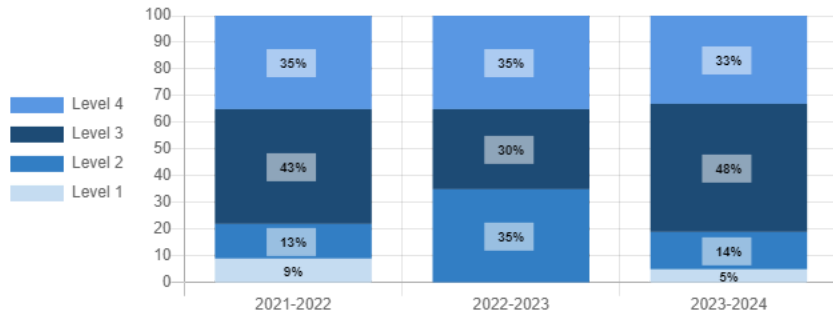

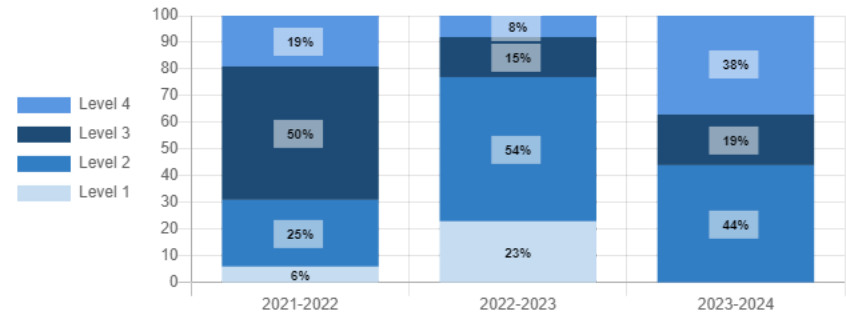
NJSLA Science Assessment: Grade 5 Summary

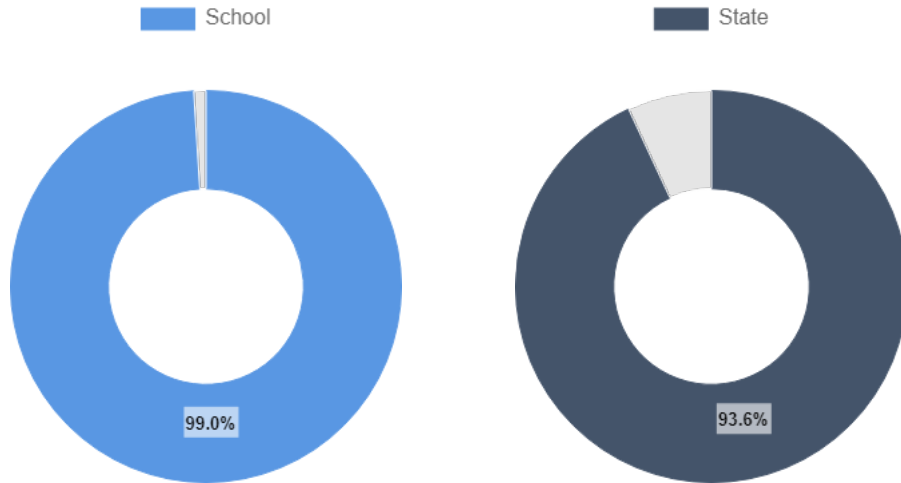

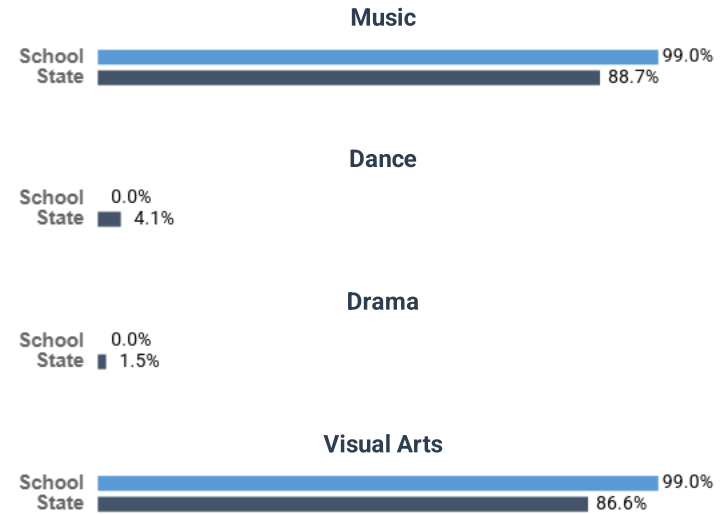

Students enrolled in one or more classes by discipline:



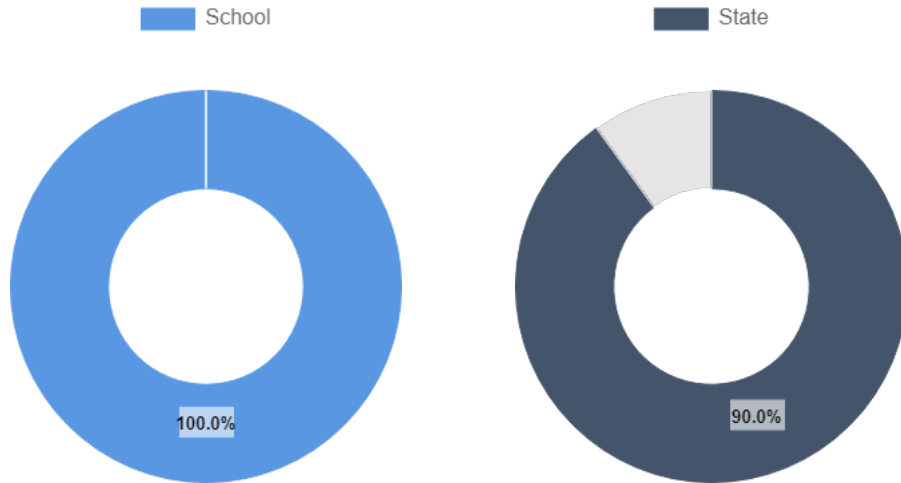

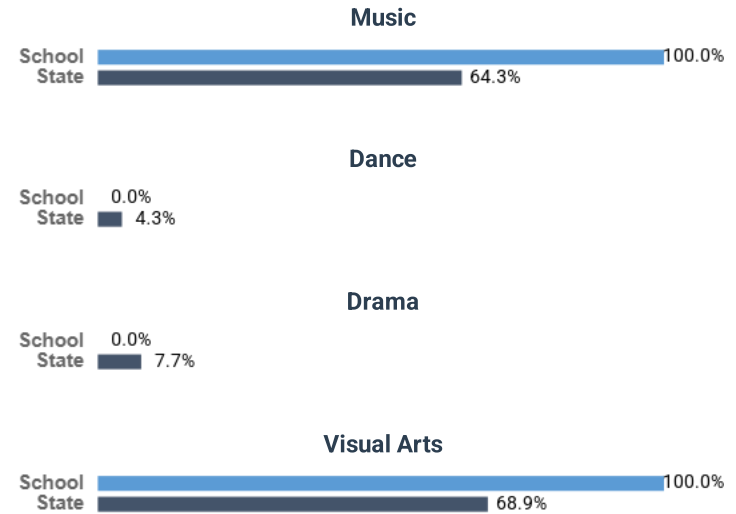

Students enrolled in one or more classes by discipline:



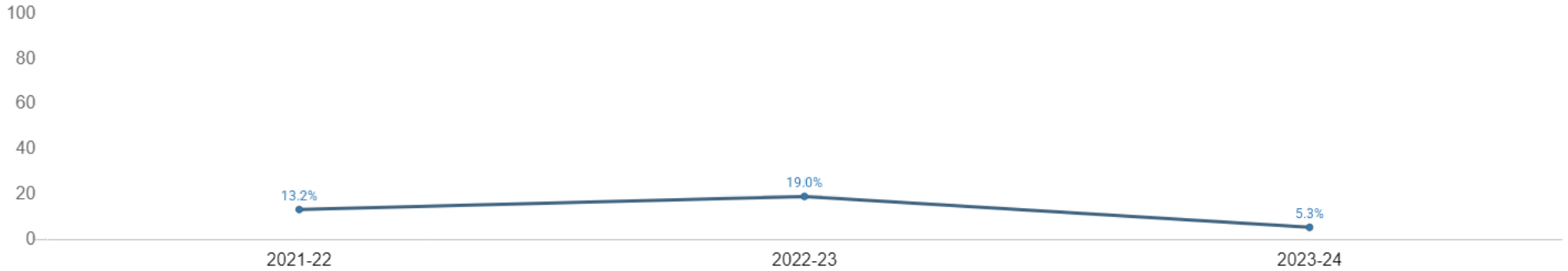
Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.

Chronic Absenteeism Trends

This table shows the number and percentage of students in grades K-12 both overall and by student group who were chronically absent during the school year. Pursuant to N.J.S.A. 18A:38-25.1, any school where 10 percent or more of the students enrolled are chronically absent must develop a corrective action plan to improve chronic absenteeism rates. The Requires Corrective Action Plan column in the table indicates whether the school's chronic absenteeism rate is 10% or higher, meaning that the school must complete a corrective action plan. 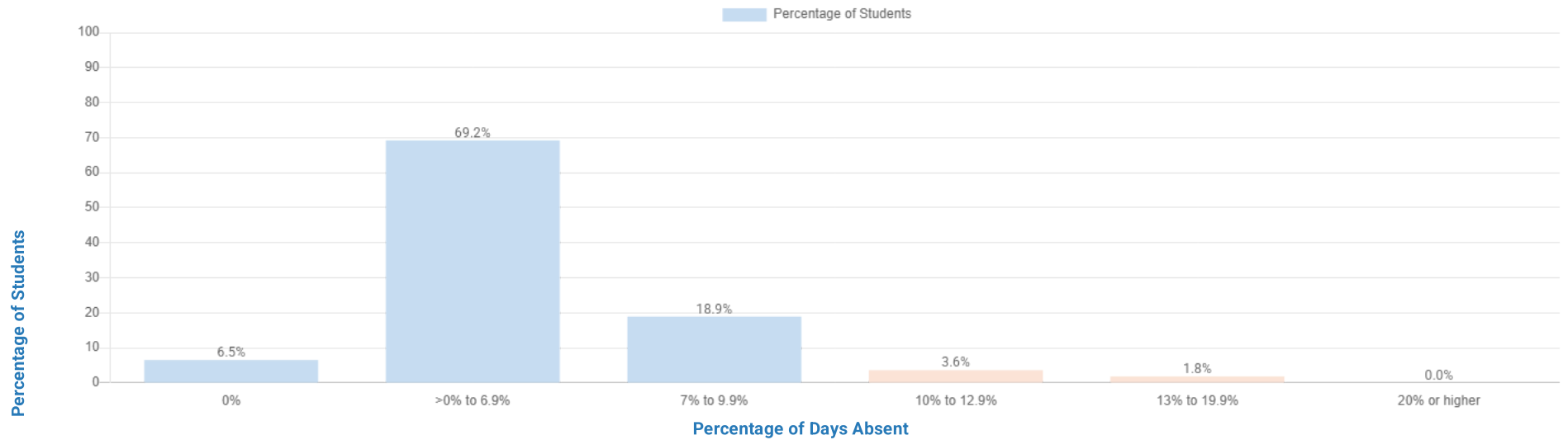

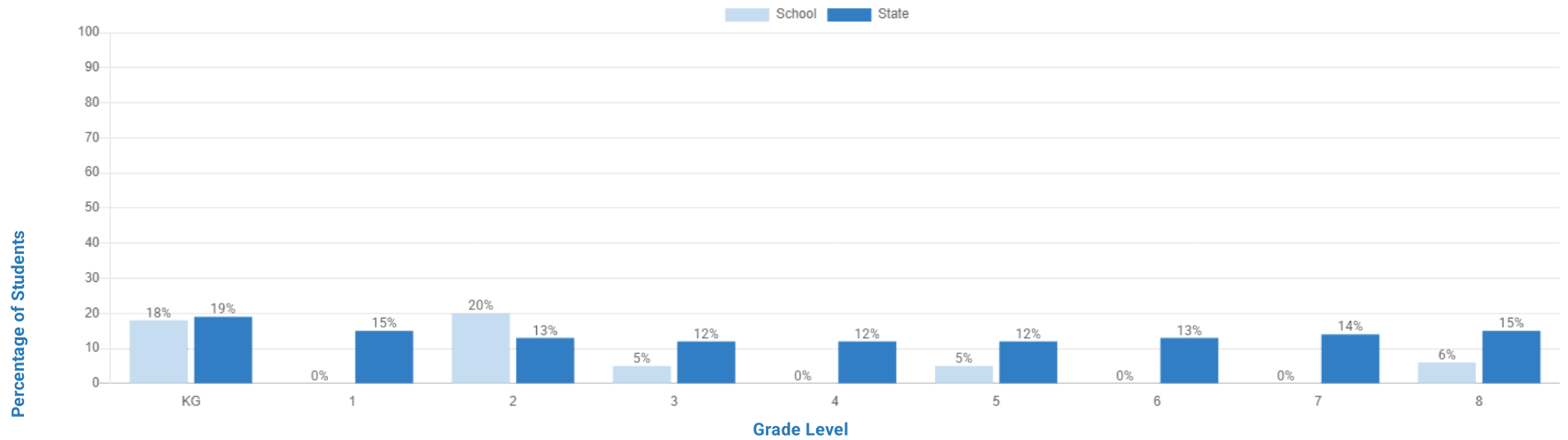

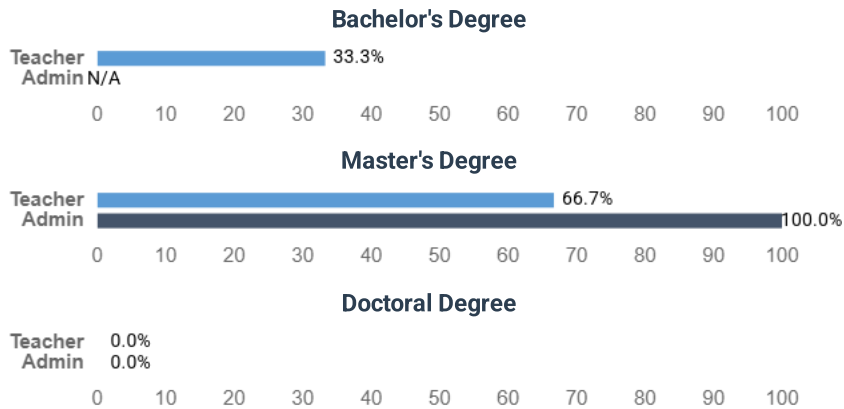

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Students participate in many outside programs such as Math Counts, Bergen Brain Busters, Bergen County MS Golf Tournament, Law Adventure, and TREPS. This year, our teams are actively participating in these competitions and programs in real time as well as in house competitions. Students have been selected to participate in the County and State Band Orchestra.



Courses, Curriculum, Instruction:

Alpine, being a small school, has an extensive math program where all eighth graders complete Algebra and some HS Geometry. In MS there are 3 levels of Math are taught at each grade level. Included in our curriculum choices offered for gifted and talented classes with participation in various teams such as Brain Busters, Law Review, and Alpine's philosophy is that we have enrichment opportunities for all students. Middle School has an enrichment period everyday where all students select their choices for offered electives. Every grade level has an enrichment period at a minimum of once a week, weekly social skills classes, and either a STEAM or Maker Space period depending on the grade level. Alpine has a new state of the art STEAM Lab that is offered to all students.

For the Fall season we have Co-Ed Soccer for grades 5-8. In Winter we have both a Girls and Boys basketball teams for grades 5-8. In the Spring we have a Co-Ed Golf team for grades 5-8.



Clubs and Activities:

We have a musical every year with our 4th-8th grade students participating. Alpine offers musical instrument instruction, Chorus, a full band, and a jazz band. Students in grades 4-8 may join by choice. We have a school newspaper where students are involved weekly. We have the Alpine Cares Club which is a community service club. Our student council offers opportunities for students to volunteer at school functions and outside community events. The News Club is where students film and give the daily and monthly news updates. Also there is a Student Council, a Math Counts Team, Brain Busters (a quiz bowl team), Law Adventure, and Homework Club. Enrichment classes are offered after school by the AHSA with classes offered by a variety of outside vendors.



Before and After School Programs:

This year we adjusted our programs to meet the needs of our students. Before school we have Homework club for our Middle School students from 8:00-8:25 AM depending on either student or teacher requests. After school we have HOMEWORK CLUB from 3:15- 4:00, Wednesday and Thursday. Enrichment classes were offered daily for all students from 12:20-12:50 for middle school students. The K-4 students have one period of enrichment a week. The Alpine Home and School Association offers enrichment classes to all students with in-house instructors and outside vendors after school. We offer many family nights throughout the year.

Staff and Professional Learning:

Our staff participates in workshops sponsored by the Northern Valley Educational Center. Alpine has an in-house Professional Development Academy run by teachers who deliver relevant learning to the staff. Alpine supports professional learning in all aspects of a teacher's professional responsibilities. We have had three in service days besides our 2 Faculty meetings a month dedicated to Professional Development.



Student Supports and Services:

At risk students are exposed to: Dyslexia trained teachers and screening, I&RS actions plans, basic skills instruction in class, basic skills instruction out of class, and classroom aides. The BSI teacher is Orton-Gillingham certified as are two other teachers in the district. For students with Disabilities there is a full continuum of program options are offered. A general education program with modifications (academic/behavioral); a general education program with a teachers and paraprofessionals; in-class resource; pull-out resource with increased mainstreaming. ELL: Apine School District has a certified Teacher of Second Language Learners. We offer homework club with tutoring for struggling learners.



Student Health and Wellness:

Health and Wellness remained a district goal for 2022 -2023 school year. Every grade level has a Health period and a Social Skills class, which concentrates on every students' social and emotional well being We have Partnerships with West Bergen Mental Healthcare. A mental health clinician supports our counseling department with 16 hours per week to address social skills development, provide individual counseling, drop in services, training fo faculty, students and parents to support emotional well-being and ultimately student achievement. We have added a School therapist who meets with small groups and individual students as needed. Finally, all students receive instruction in Health to include physical as well as mental health according to state standards. CPR training for select faculy and administration. Recess is 30 minutes everyday for all students. K-8.

Parent and Community Involvement:

Throughout the year we have community events which are aimed at bringing the community together. As restrictions have lifted we did have Two Virtual Family Reading Nights, Family Bingo Night, Monthly AHSA Meetings, Alpine Cares Club did community service in the surrounding area. We resumed our annual spring musical and held two concerts which had choral and instrumental elements. We had an inperson graduation ceremony and party afterwards. We have a parent portal where parents can view grades and attendance. We use this as our mass information system. Knowing that communication is key to creating community bonds the Superintendent sends a weekly news update out weekly to the Alpine Community. In September we hosted a welcome back barbecue for all students and their families it was a great way to reconnect socially.



Climate Surveys:

School Safety:

School Safety Specialist-four full day training with ongoing training for additional staff. Meeting with police department regarding safety procedures. Training for faculty on safety presented by the police chief. Update to MOA with police department. Police are outside the school at the beginning and the end of each day as well as touring the building internally and externally throughout the day. Updated the Emergency Operations Manual. Regular scheduled drills as per state mandate each month. Digital mapping of the school. Added to our Camera network to cover inside and outside activity. We have 37 active cameras that can be viewed by 6 offices in school and by the police department. This allows people at the entrances to be seen and talked to before entrance is allowed through dual locking. Only the main entrance is used for entering and exiting the building which has keyless entry system.



Technology and STEM:

Each classroom has either a full set of MacBooks, Chromebooks, or Ipads. Every staff member is issued a Macbook PRO. Every class in middle school 5-8 has one STEAM class and K-4 has one Maker Space Class. Every student is assigned their own district device.



Attendance:

Alpine for the 2022-2023 SY materials were purchased to make the transitions between home and school happen efficiently. Our wellness/ social skills classes were conducted. Our Partnership with West Bergen Mental Health Facilities was strengthened and an additional therapist was added. Alpine offered a combination enrichment and academic programs during summer to address unfinished learning and emotional/social programs were extended. Tutoring was provided to students that were struggling on a one to one ratio.

We have a LEAD program run by our local police officers who come in to our 5th-8th grade classrooms to teach students about making positive life choices. Additionally, for the last 30 years we have housed a private preschool in our building which participates with our students in physical education and music programs. Every class K-8 has at least one Enrichment class per week. Alpine does take tuition students if they meet our enrollment standards.
