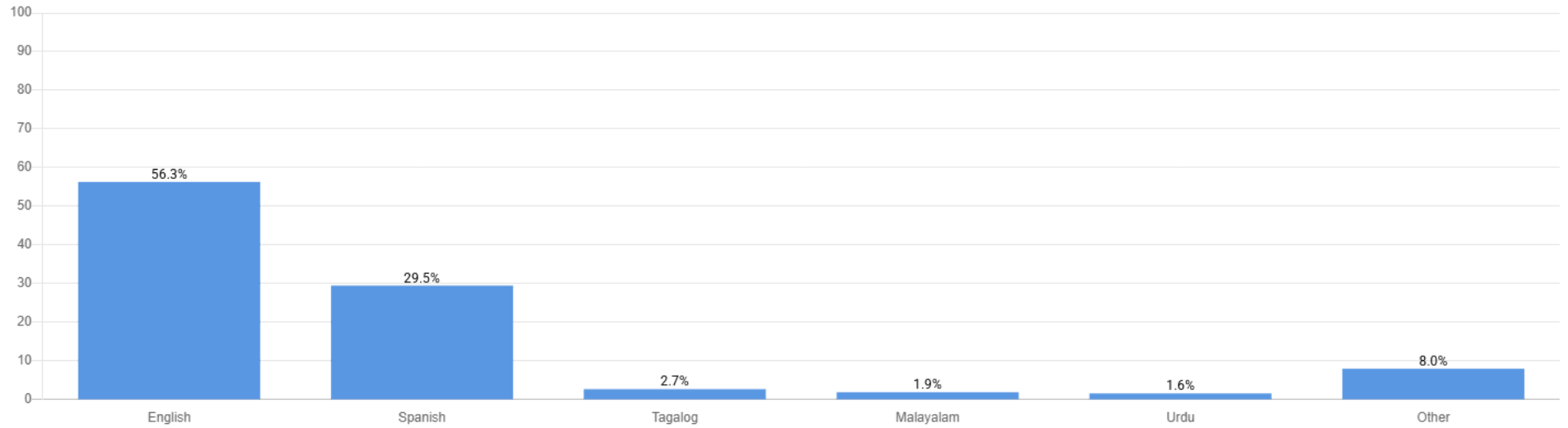

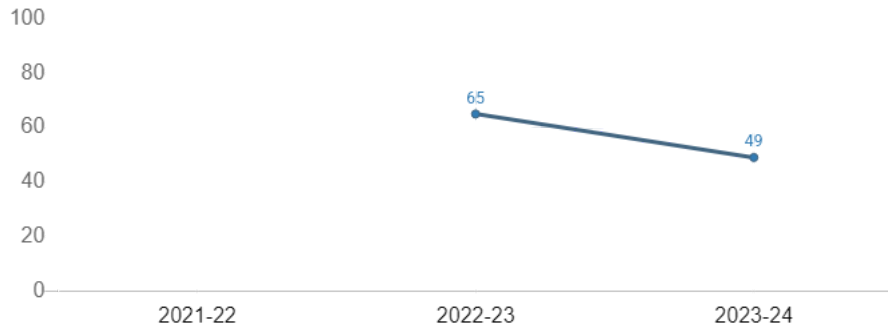

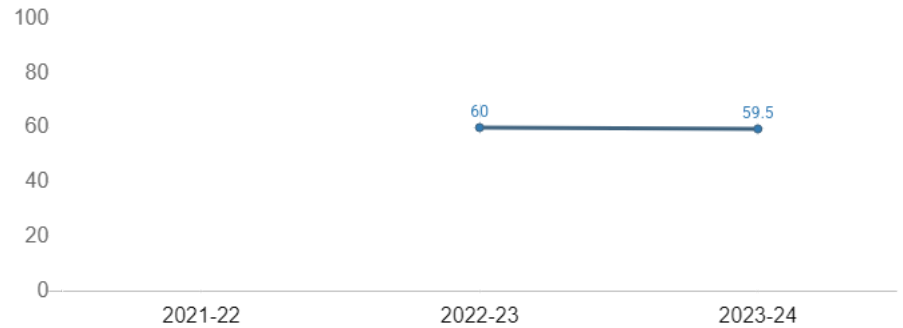

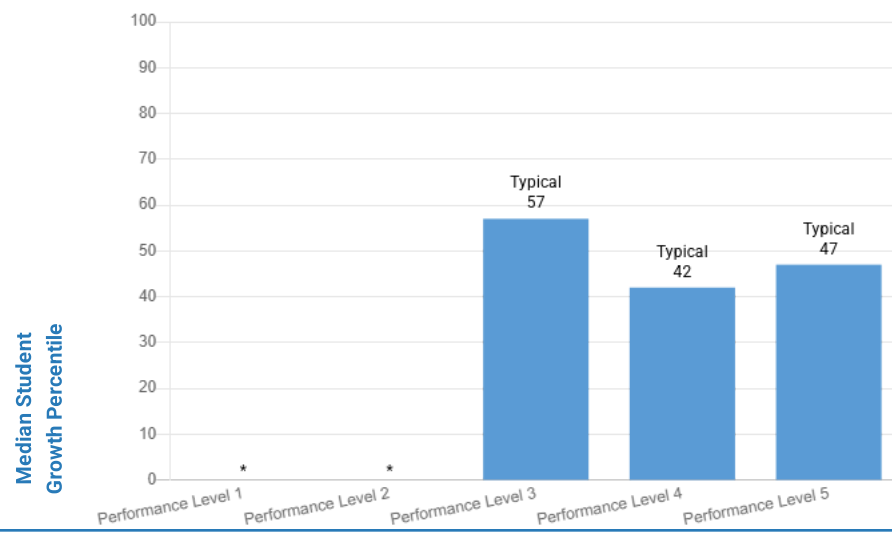

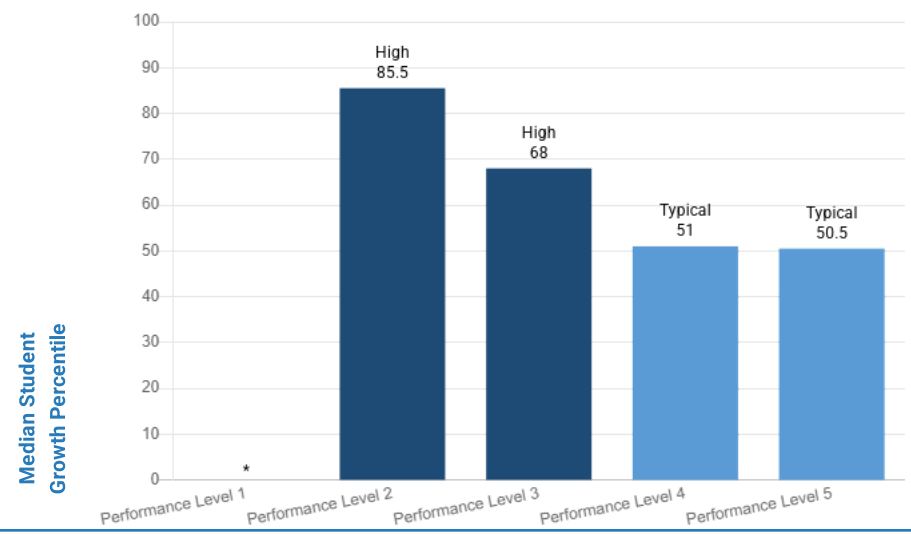

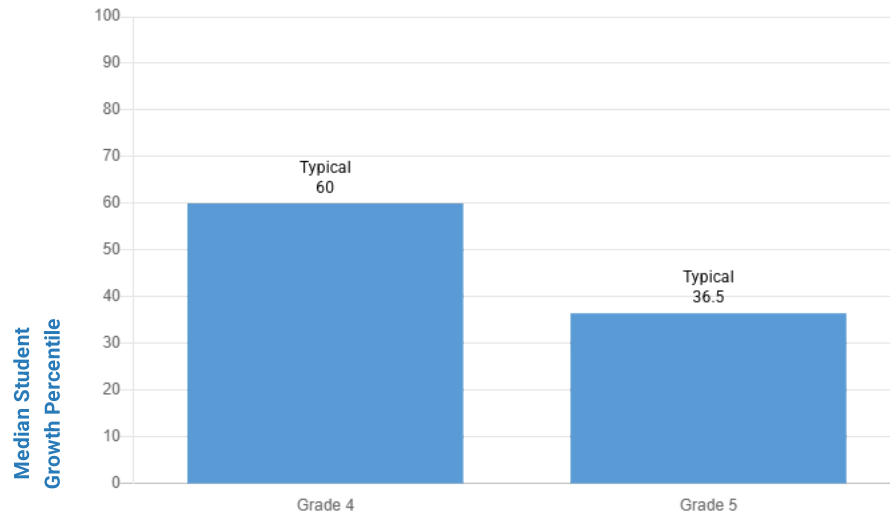

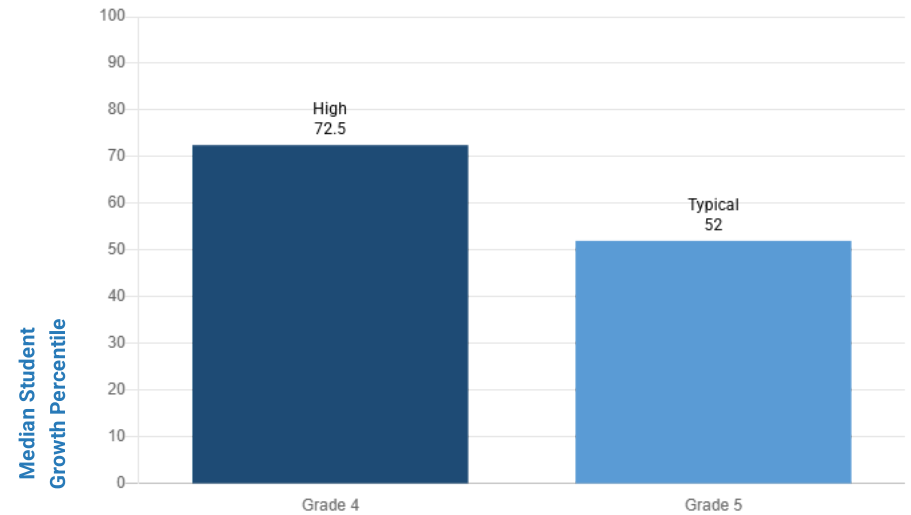

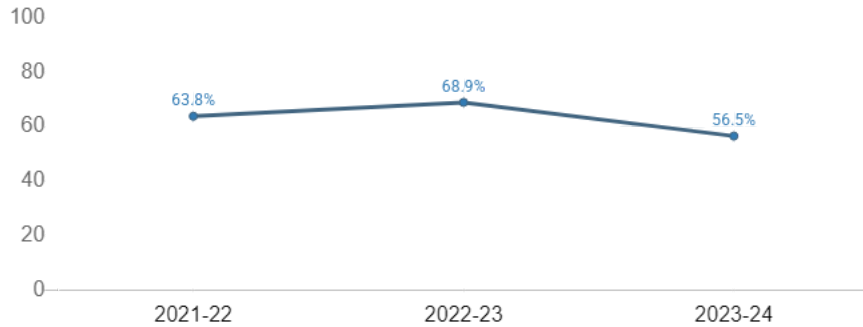

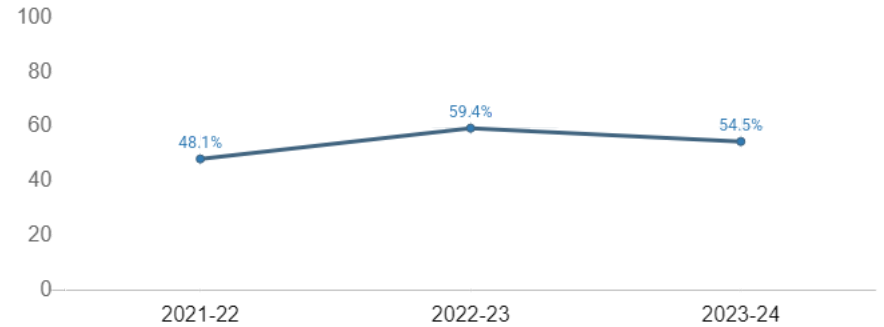
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 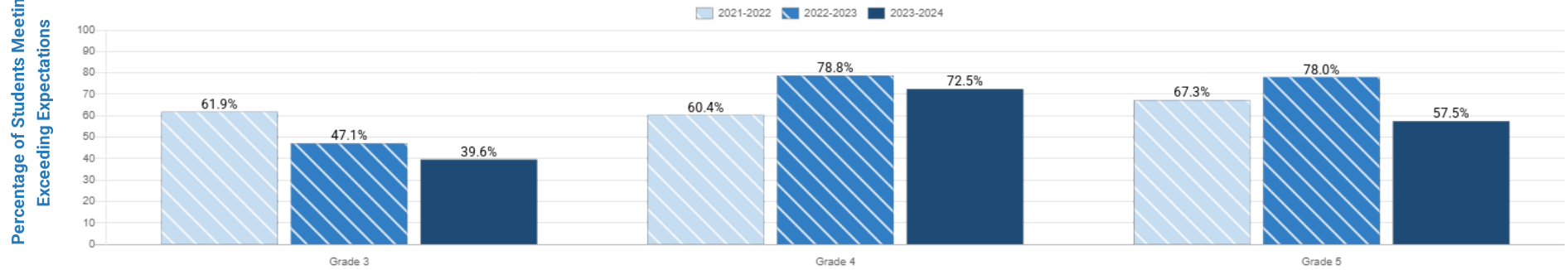

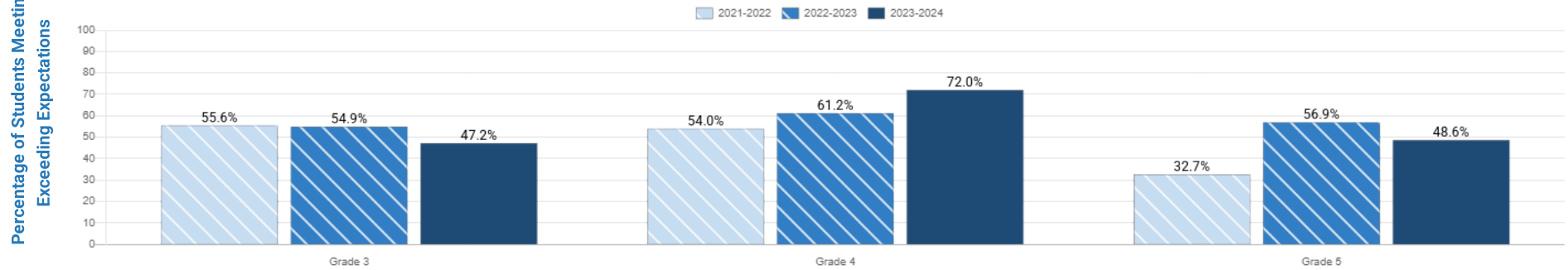

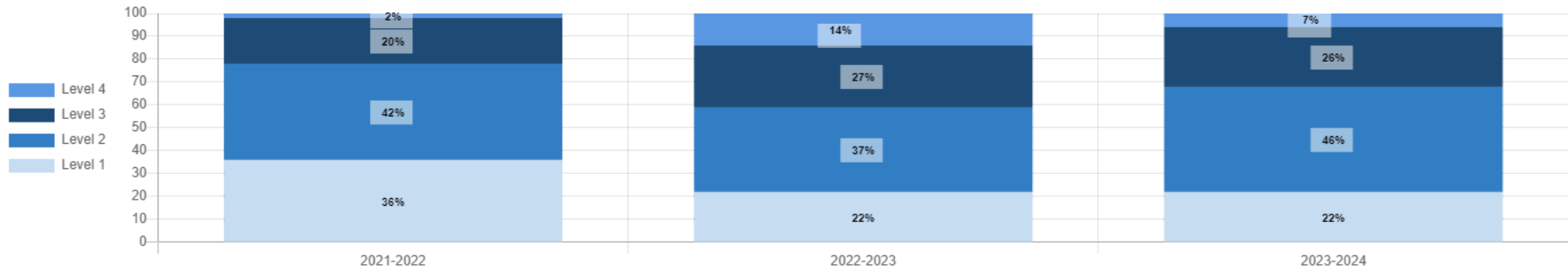

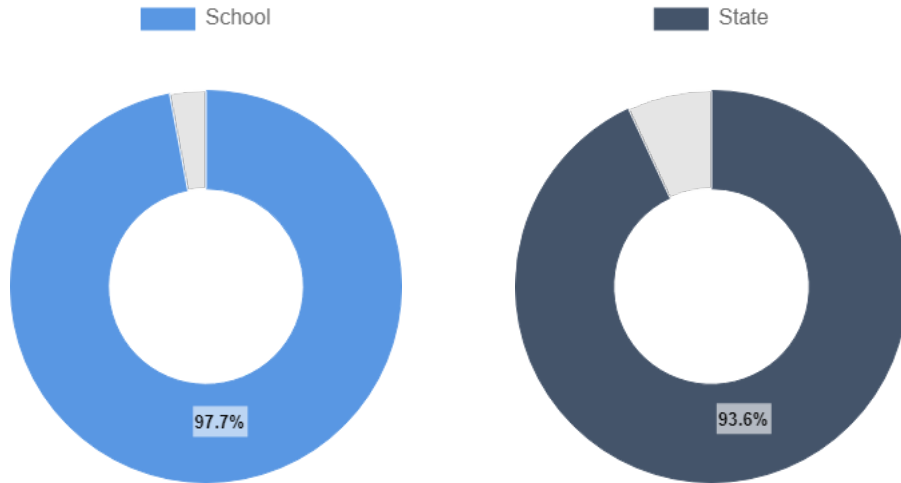

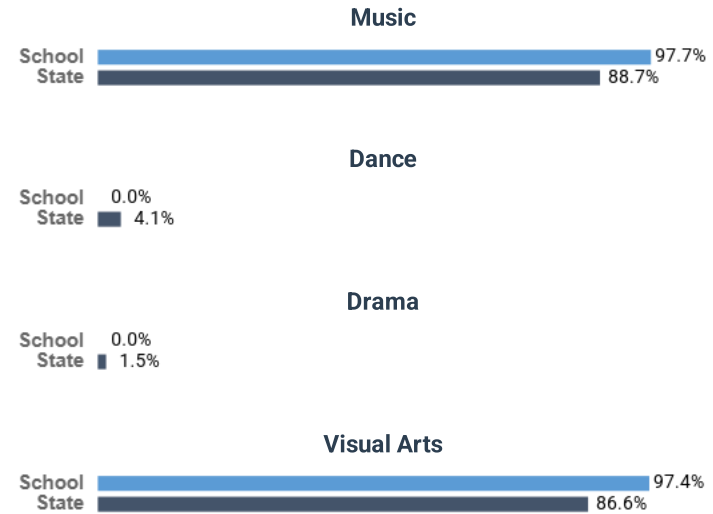

Students enrolled in one or more classes by discipline:



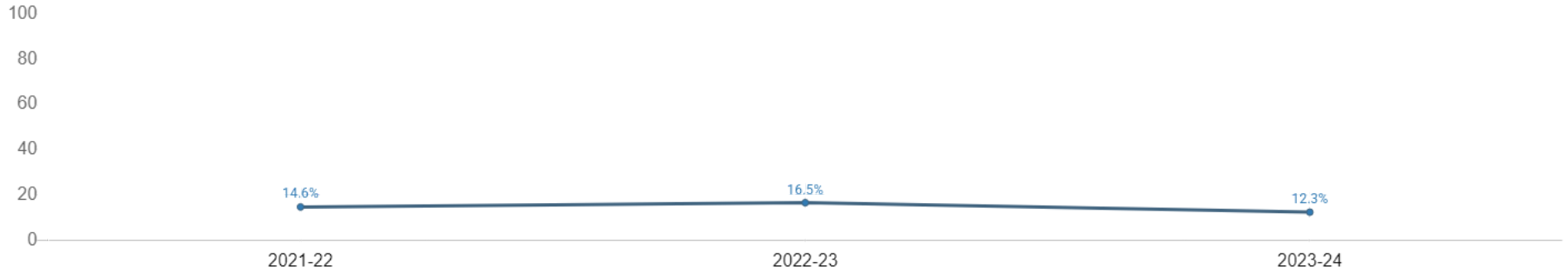

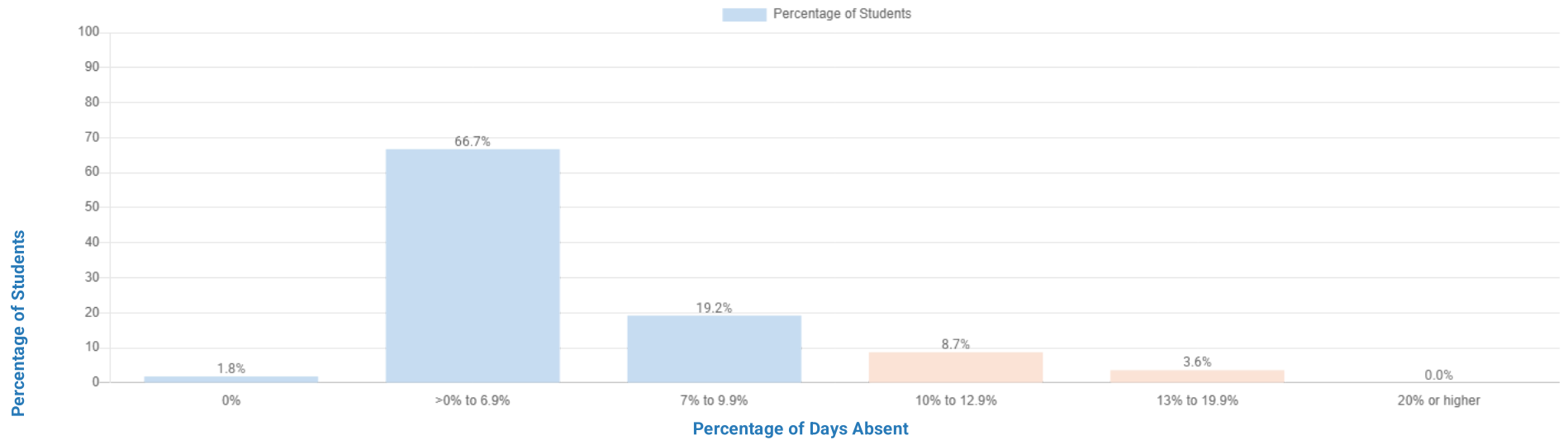

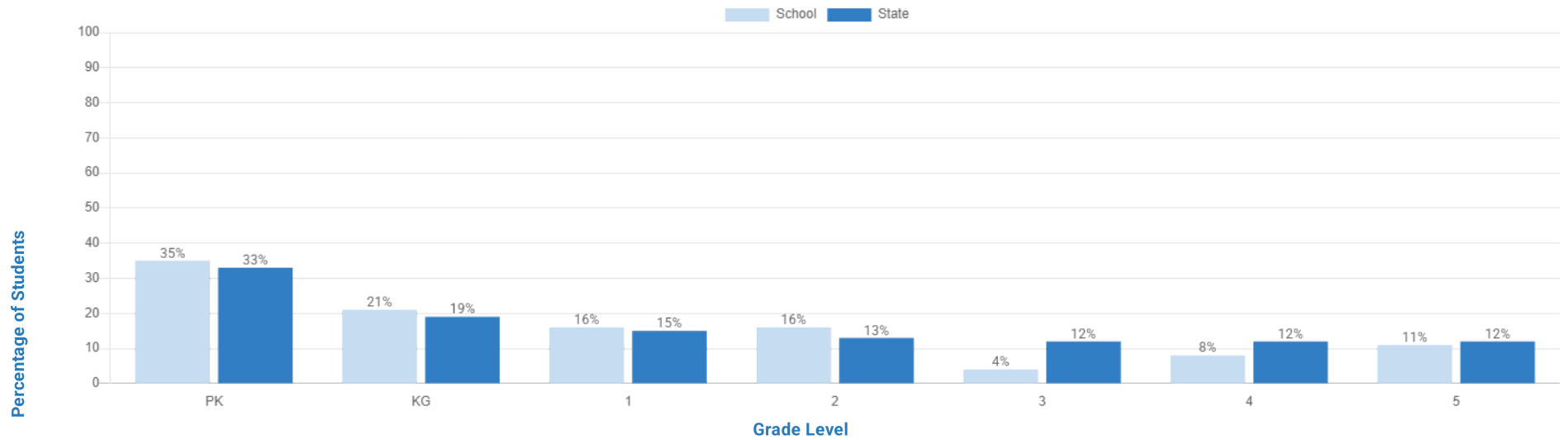

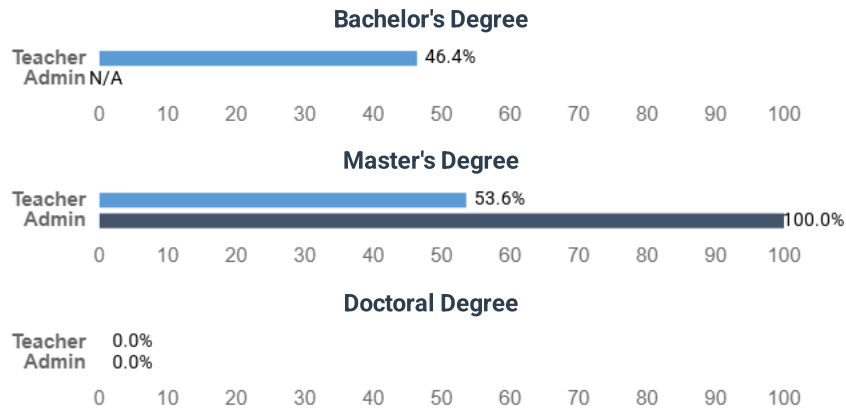

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Staff and Professional Learning:

We offer teachers professional development with differentiated professional learning via Safe Schools an online educational program. New teachers attend the New Teacher Academy, Administrators received Professional Development in evaluations, I&RS process, HIB , ESL training for administrators and faculty. We use an online tool to assist in capturing student data called Panorama and for our ESL students, an online program called Ellevation is used to provide data and teacher annotated notes on the success of students that recently left the ESL program. Teachers have Common Planning Time We also participated in SEL PD, Equity and Diversity PD and Teacher led/implemented PD on various topics.



Student Supports and Services:

We offer support and services for all English Language Learners, Students with disabilities and students with a 504 plan. We have a Tri Valley Autistic Program with three classes that are supported by different teachers throughout the day. We also offer Basic Skills and Concentrated Literacy for struggling students in Math and Reading, as well as Gifted and Talented classes for students in grades K-5. We work with an I & RS team for students that have experienced learning difficulty during the school year and counseling services for students as needed. Our 5th graders participate in the D.A.R.E. program given by the local Bergenfield Police Department.



Student Health and Wellness:

We have a Morning Breakfast program. Types of physical activities include daily Recess and Physical Education classes, Hygiene instruction for students by the school nurse, fire safety, Anti-Bullying Programs and Peer Group meetings. Assemblies for social learning. and cultural awareness We recognize and honor all cultures throughout the school year with materials on our hallway walls and in our classes through Social Studies and teacher lessons.

School Safety:

The safety of our students and staff continues to be a priority in our schools. We practice two safety drills each month. Franklin School has a lightning detection system to warn of threats. The district employs a School Security Specialist who oversees our security staff and helps to implement protocols, procedures, manuals and training of staff for emergency preparedness. Our outside doors are locked and alarmed, with security guards stationed at our main entrances. Visiting adults must provide valid identifications which are input into a system that generates a visitor's pass, they must also return to be screen-out.



Technology and STEM:

Technology is incorporated throughout the day in each classroom. We provide opportunities for afterschool STEM programs for students in different grades. Google classroom, smartboards and online programs are available for every student in all academic areas in all classrooms. Teachers use online programs to enhance lessons.



Early Childhood Education:

Franklin has two full day PEA Grant Pre-K integrated classes in the building. One is an integrated ages 3/4 class and the other is an integrated age 4 class. Students participate in various activities to support healthy learning. We use Creative Curriculum to assist with student development

Academic excellence is occurring at Franklin School. The statistical data paints only a numerical portrait of our success. These numbers represent enthusiastic, successful students, involved parents, and an outstanding group of teachers and support staff. These individuals, coupled with a solid, well-balanced academic program, create a positive and productive environment in which to work and learn. The implementation of our Balanced Literacy program has further shaped the learning culture of our school and has shifted the focus from teaching to student evidenced-based learning. All grades from K-5 are using an online program called iREADY for math and reading enhancements as well as Running records assessments to assist in identifying our children's instructional levels. The data from the iREADY program is used to assist student learning but pinpointing gaps in their learning for individual instructional focus. The Franklin School staff is using data to differentiate instruction at all grade levels with formative and summative assessments. Our focus on individual needs allows early diagnosis and prompts interventions so that all students continue to thrive in their educational setting. We seek parent input as to their children needs for additional support from Basic Skills and Concentrated Literacy teachers throughout the school year.
