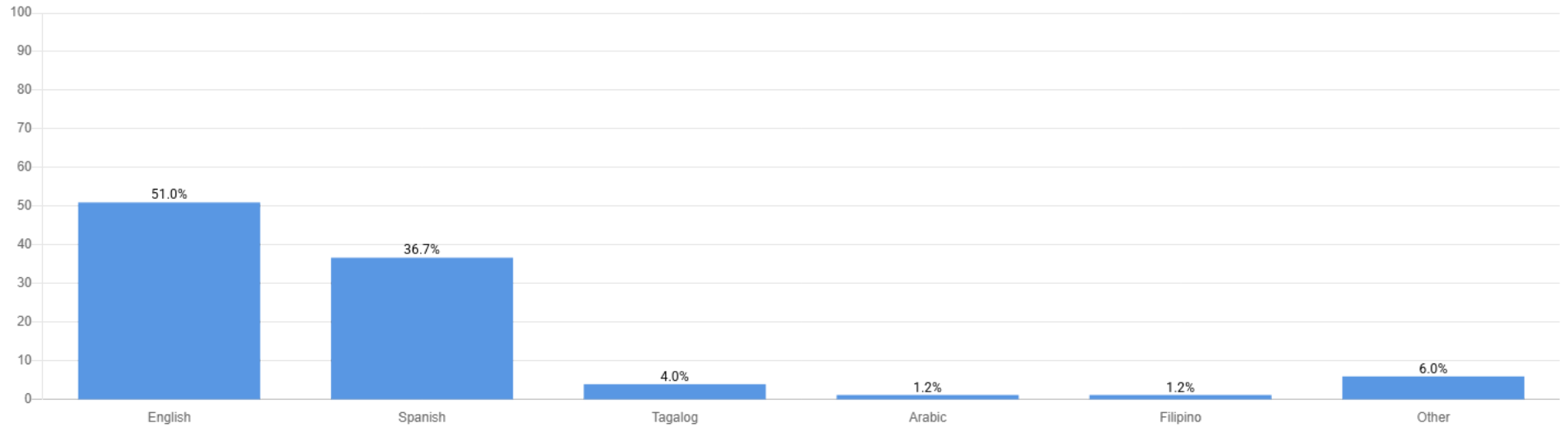

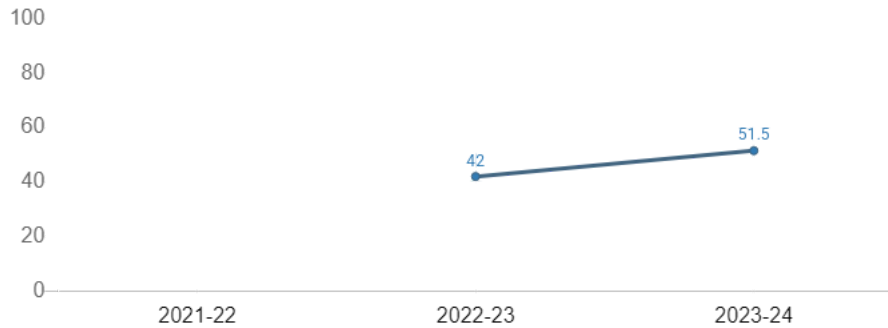

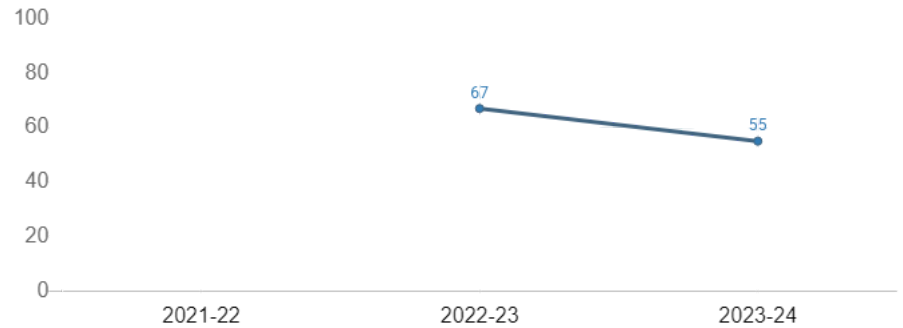

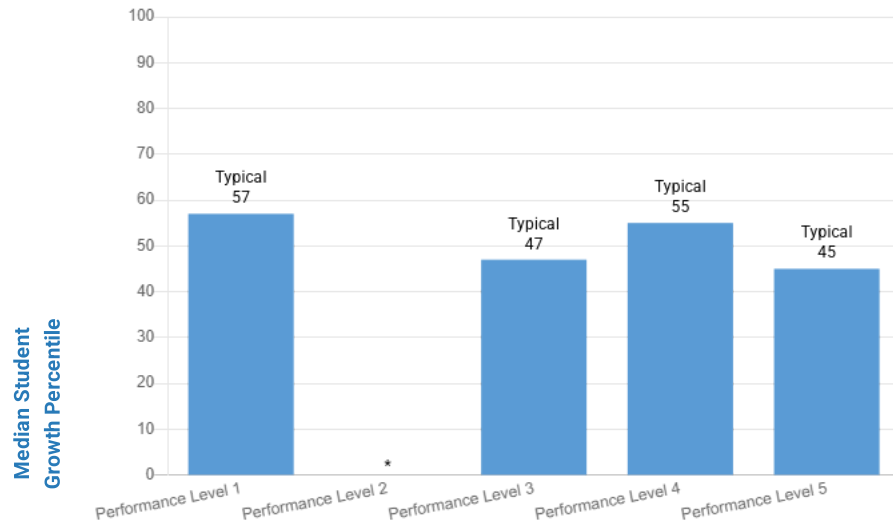

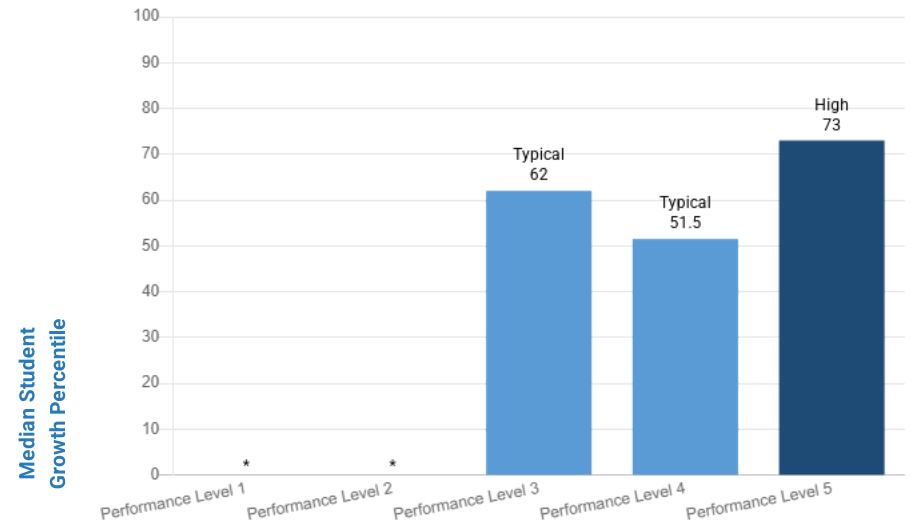

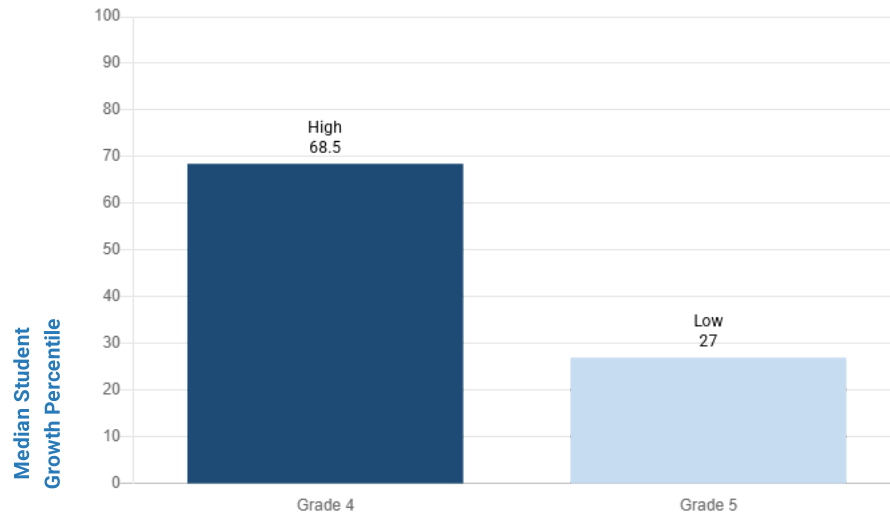

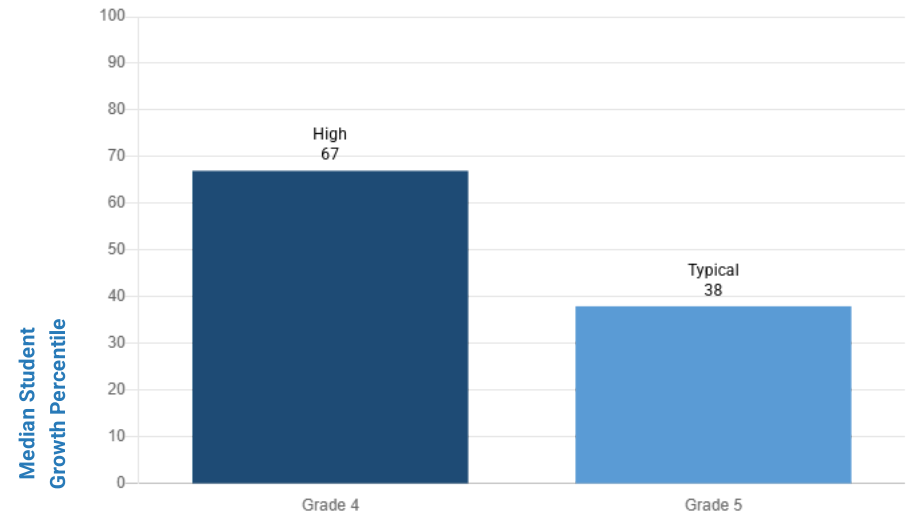

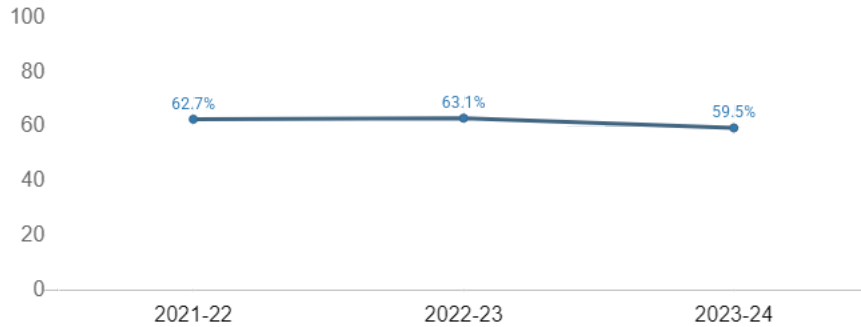

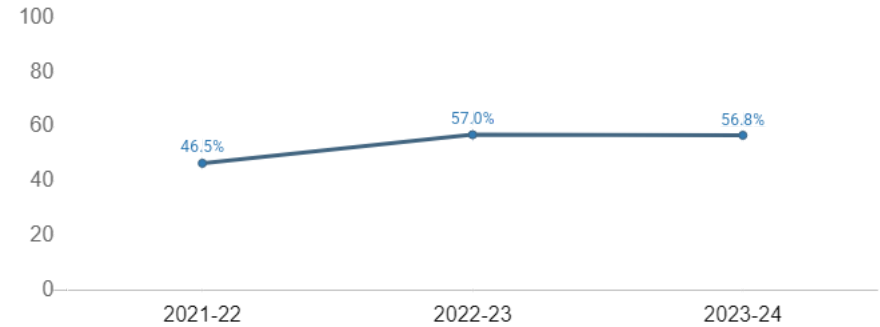
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 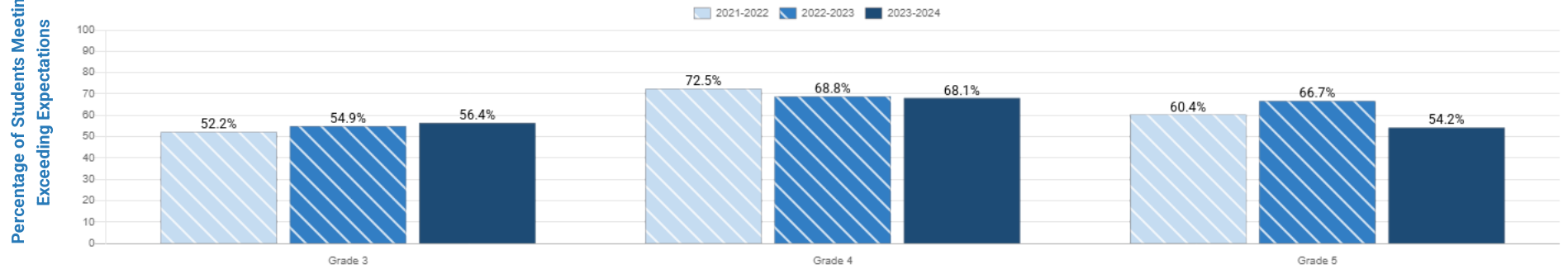

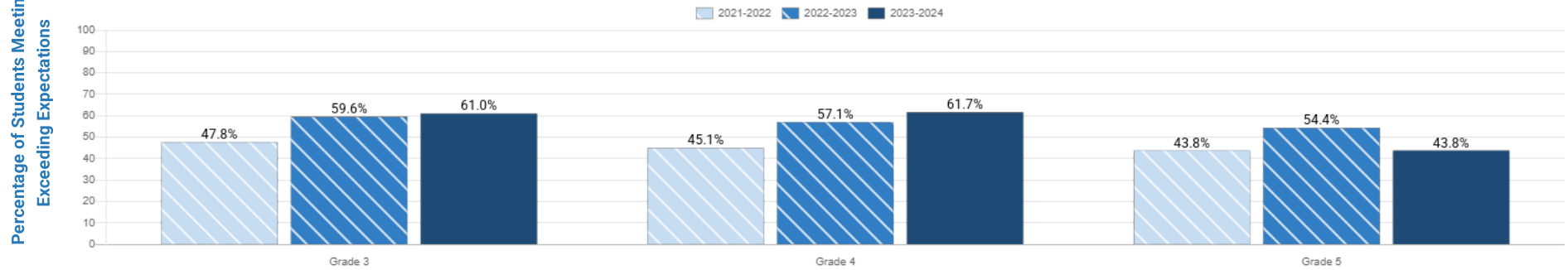

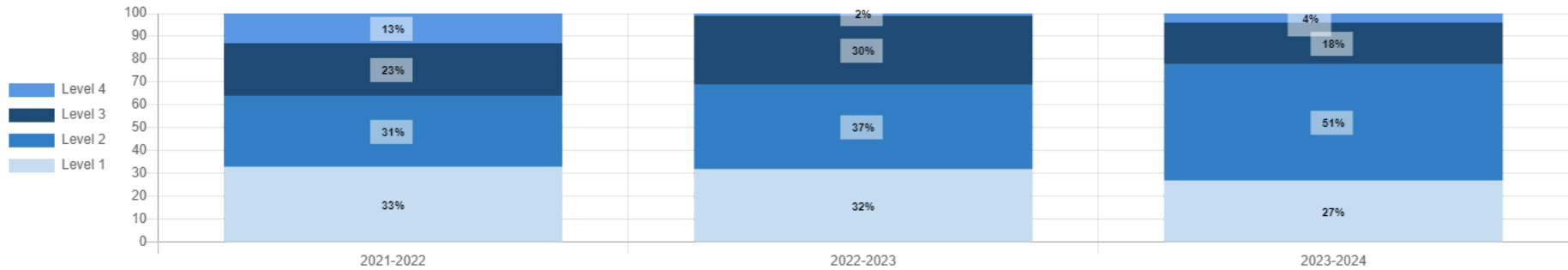

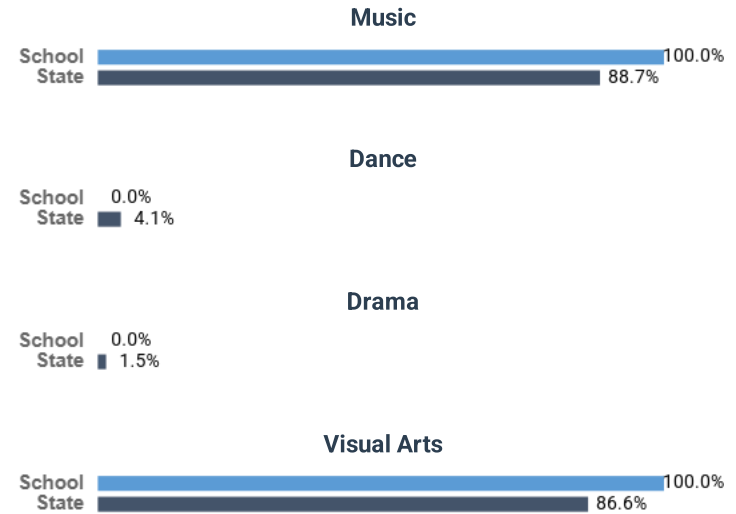

Students enrolled in one or more classes by discipline:



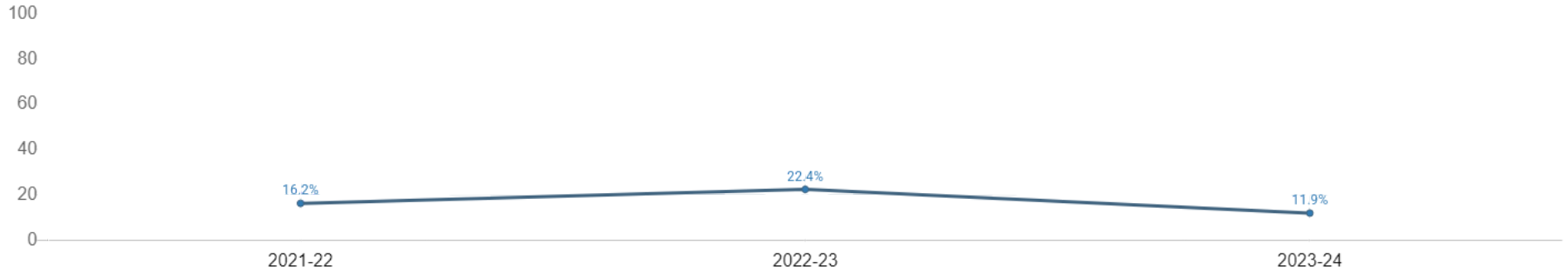

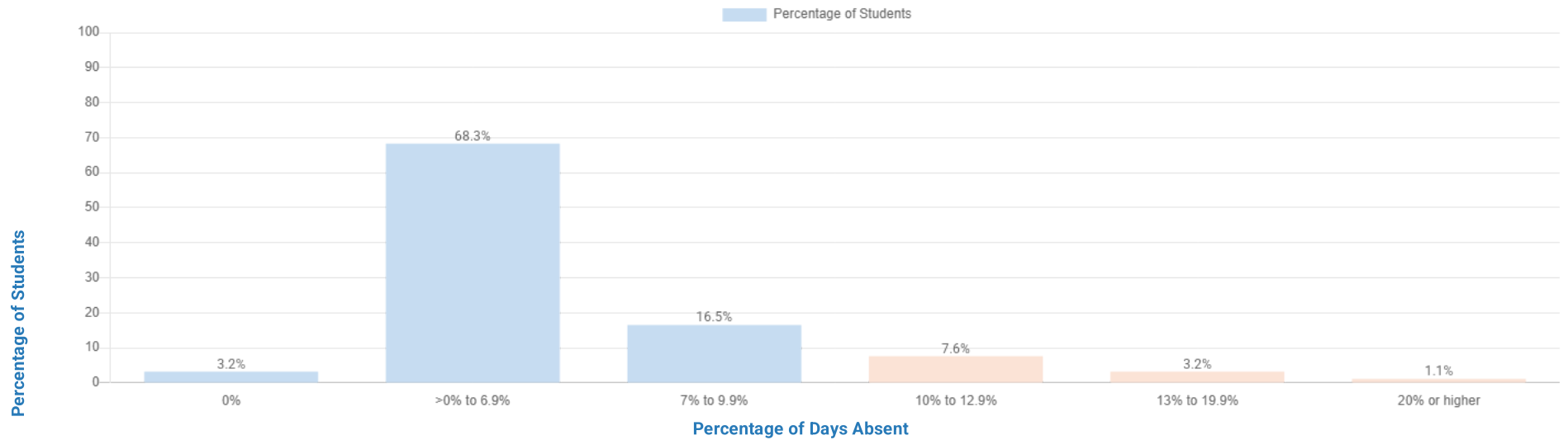

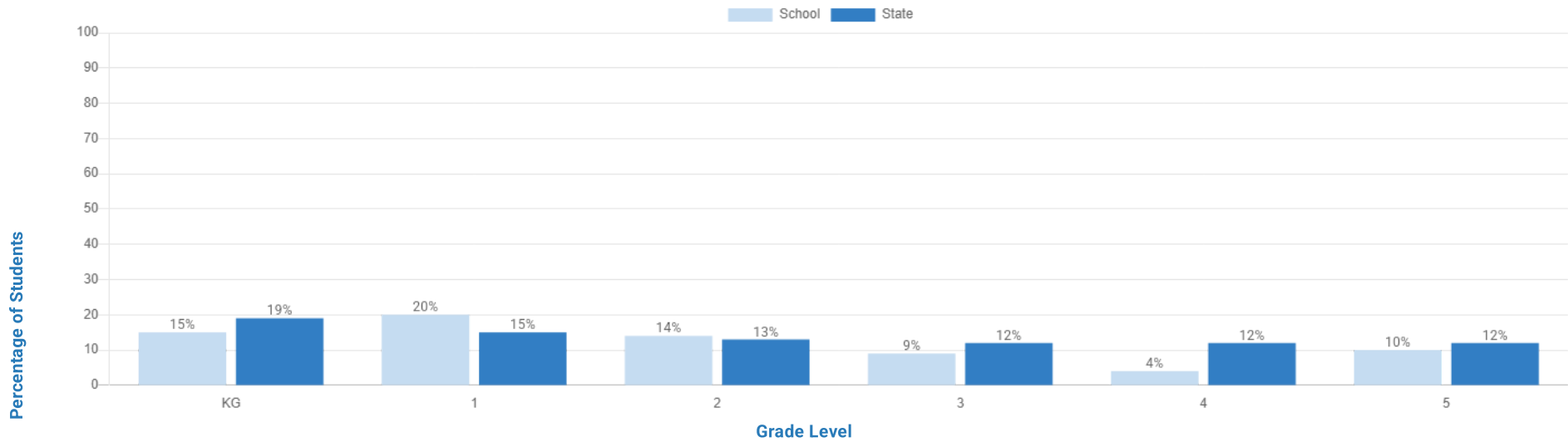

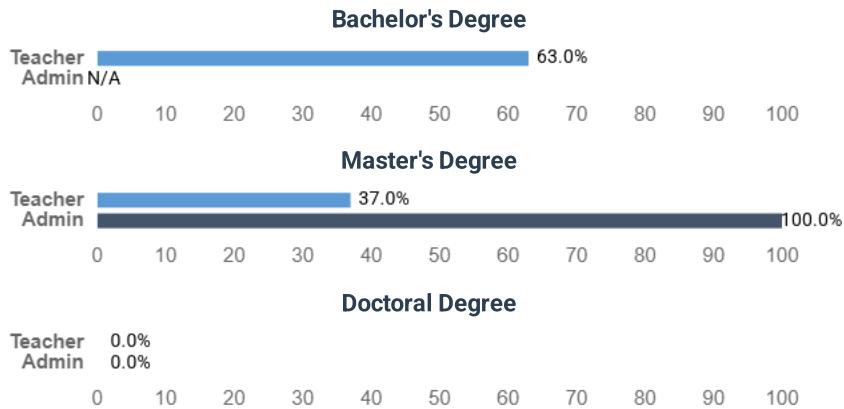

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. School Safety:

The safety of our students and staff continues to be a priority in our schools. All schools practice safety drills every month. Schools have lightning detection systems to warn of threats. The district employs School Security Specialists who oversee our security staff and helps to implement protocols, procedures, manuals and training of staff for emergency preparedness.



Technology and STEM:

Each room is equipped with a SmartBoard and each student has access to a chromebook to assist with research and other online resources such as their Everyday Math assignments. We also offered students in grades 2 and 4 an afterschool STEM program that met for 10 sessions.



Attendance:

For the fall of 2023, fourth and fifth grade students who were identified as in need of support through iReady and NJSLA were offered after-school sessions to improve skills. In the spring of 2024, kindergarten and first grade students were invited to participate in after-school social groups. These were non-academic in nature and focused on socializing and character traits.
